(57) **CLAIM**

The ornamental design for a bottle, as shown.

DESCRIPTION

FIG. 1 is a front and top isometric view of a bottle that has the design.

FIG. 2 is back and bottom isometric view of the bottle.

FIG. 3 is a right side elevation of the bottle.

FIG. 4 is a rear elevation of the bottle.

FIG. 5 is a left side elevation of the bottle.

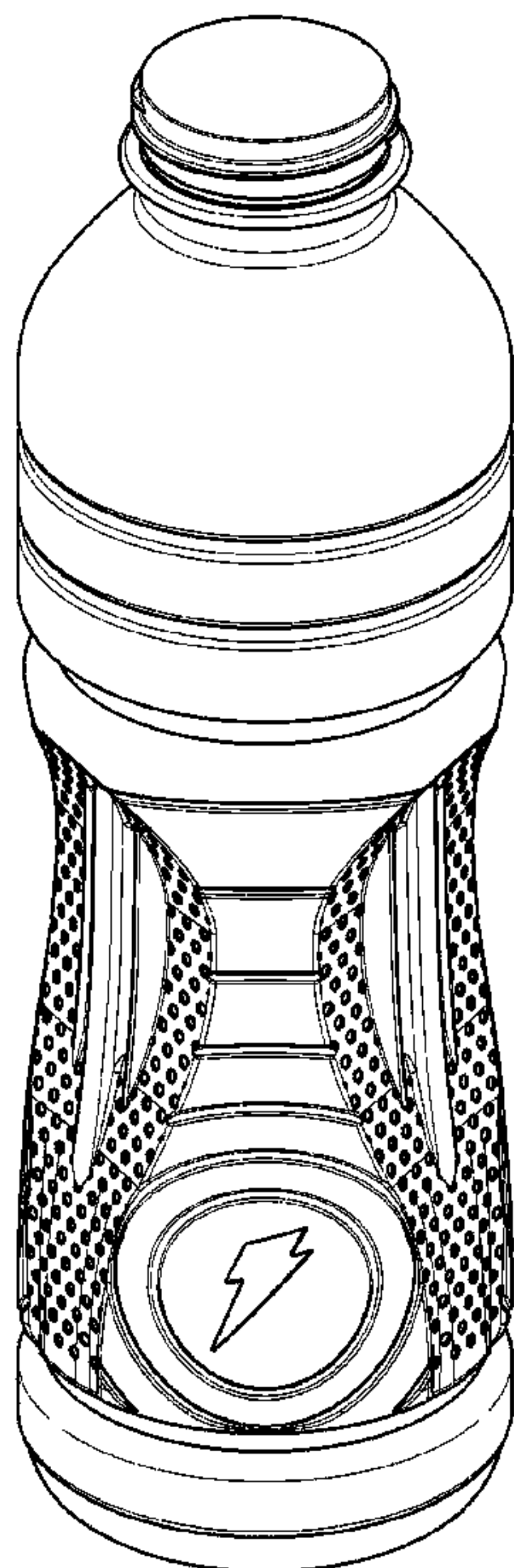
FIG. 6 is a front elevation of the bottle; and,

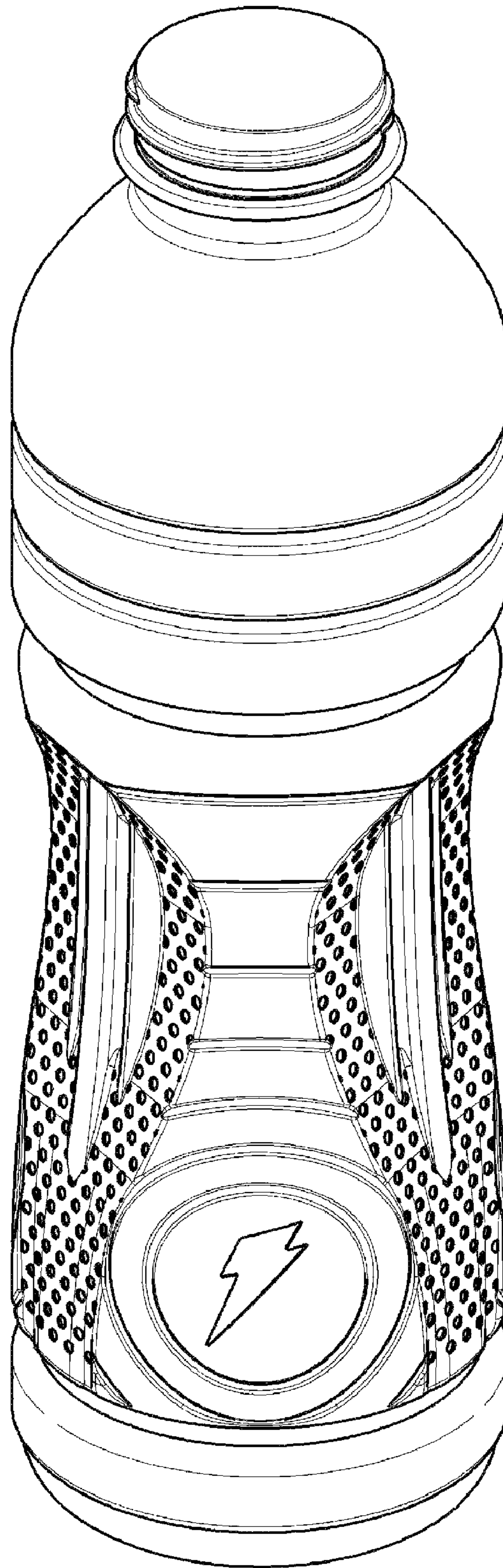

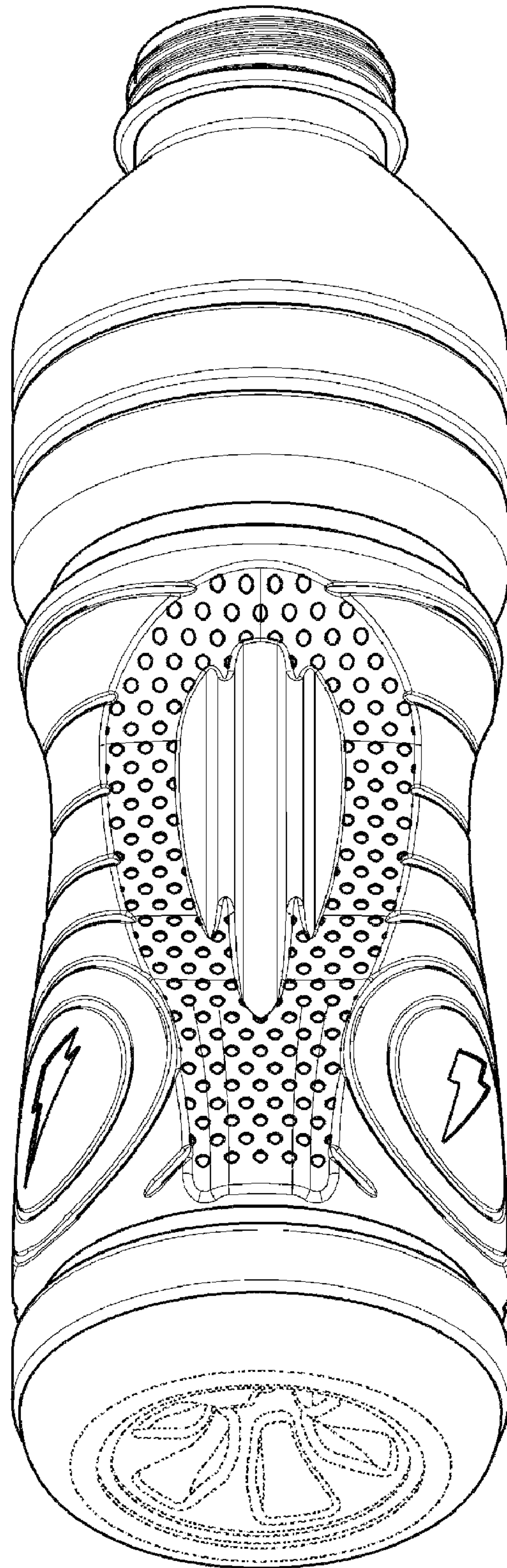

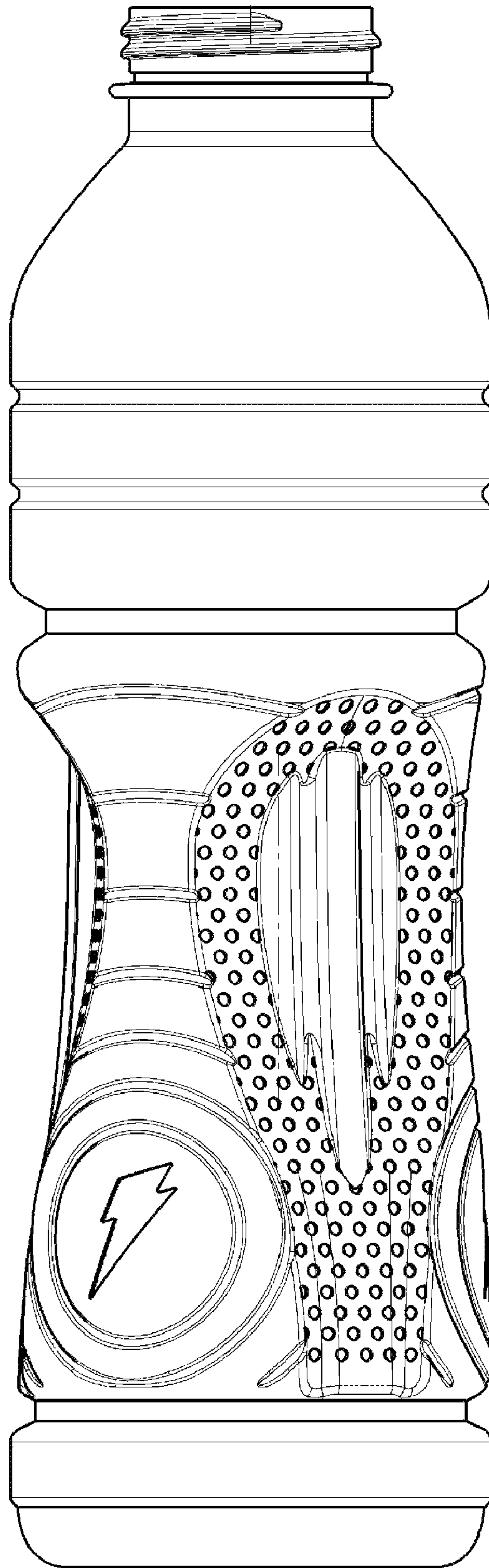

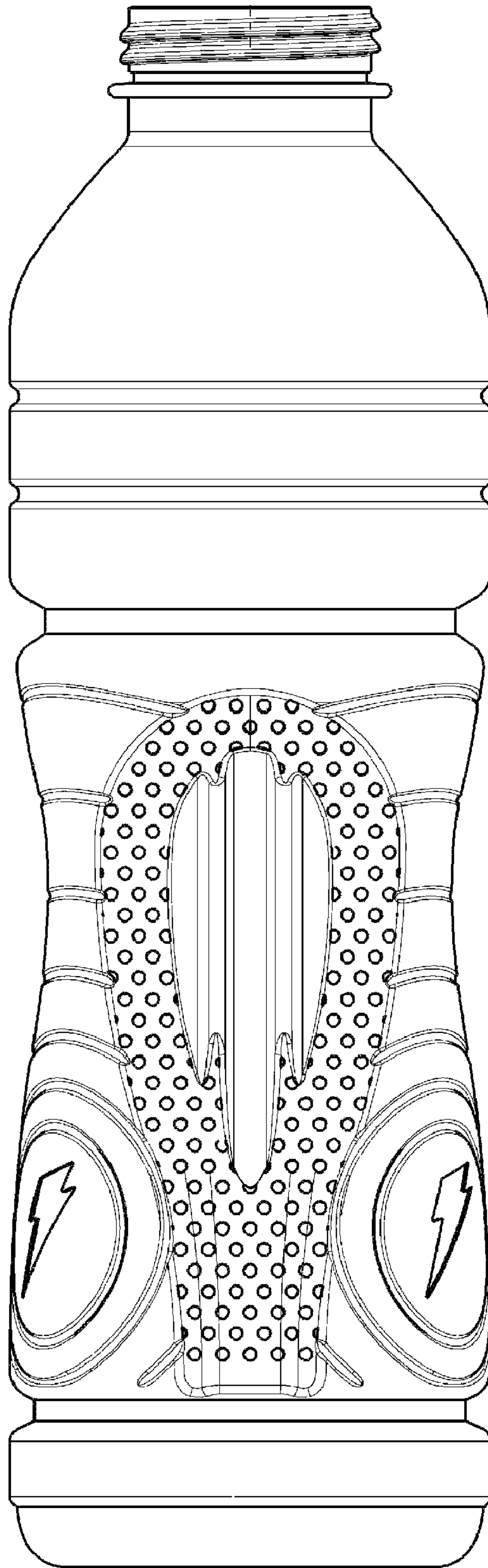

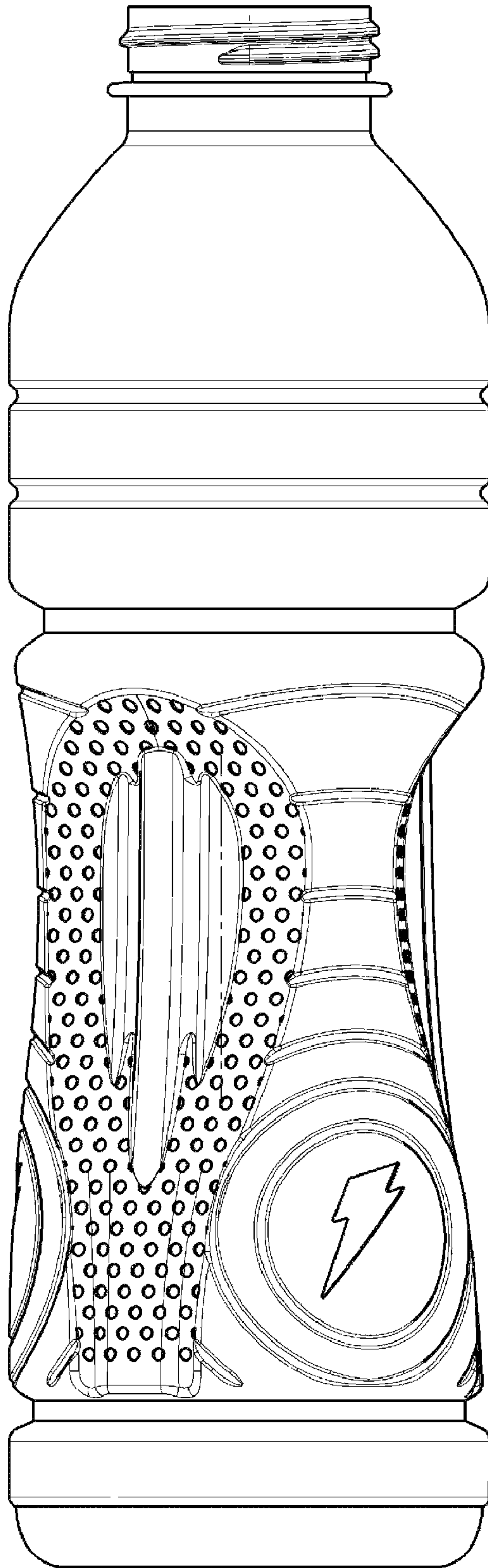

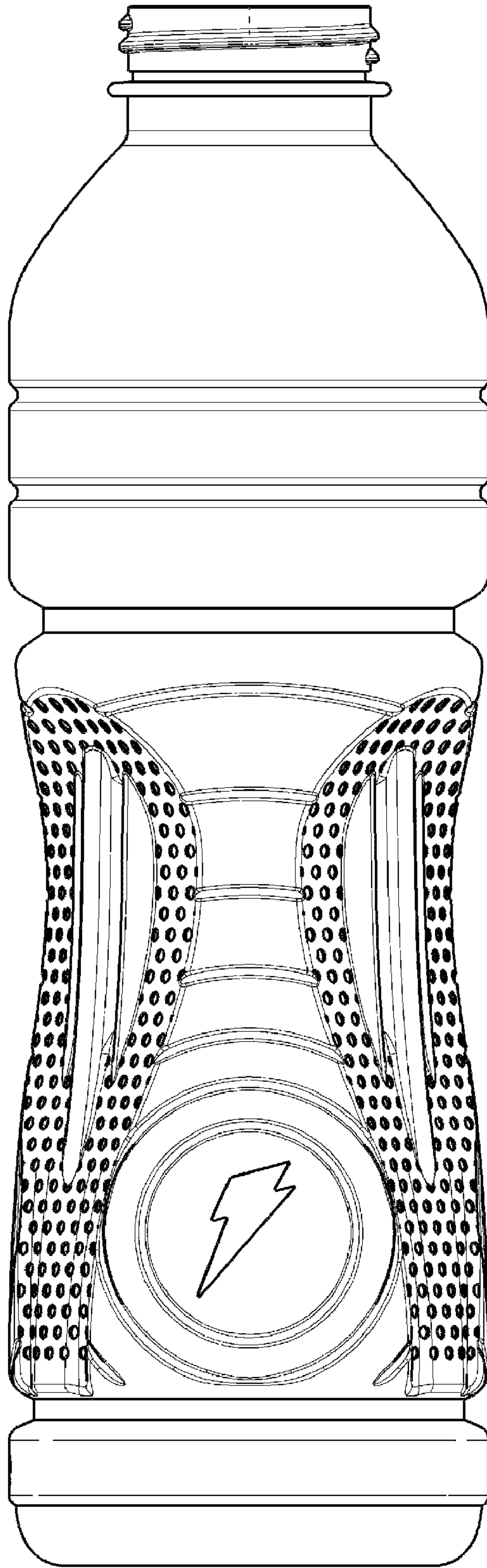

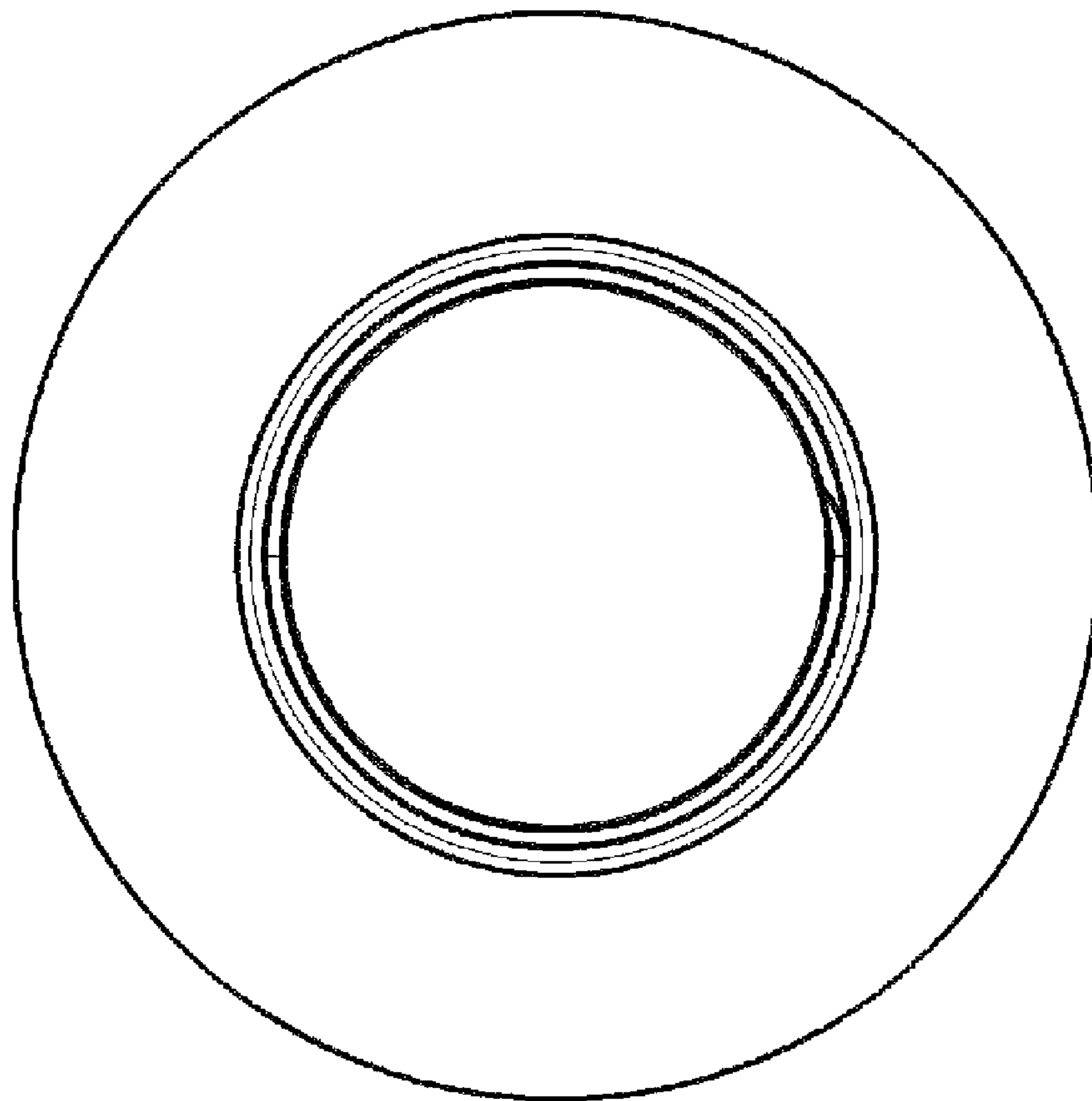
