**DESCRIPTION**

FIG. 1 is a perspective view of a score counting accessory showing my new design;

FIG. 2 is an enlarged scale fragmentary front perspective view of the spherical beads;

FIG. 3 is a front elevational view of FIG. 2; and,

FIG. 4 is a perspective view thereof, shown the claimed article in it's environmental use.

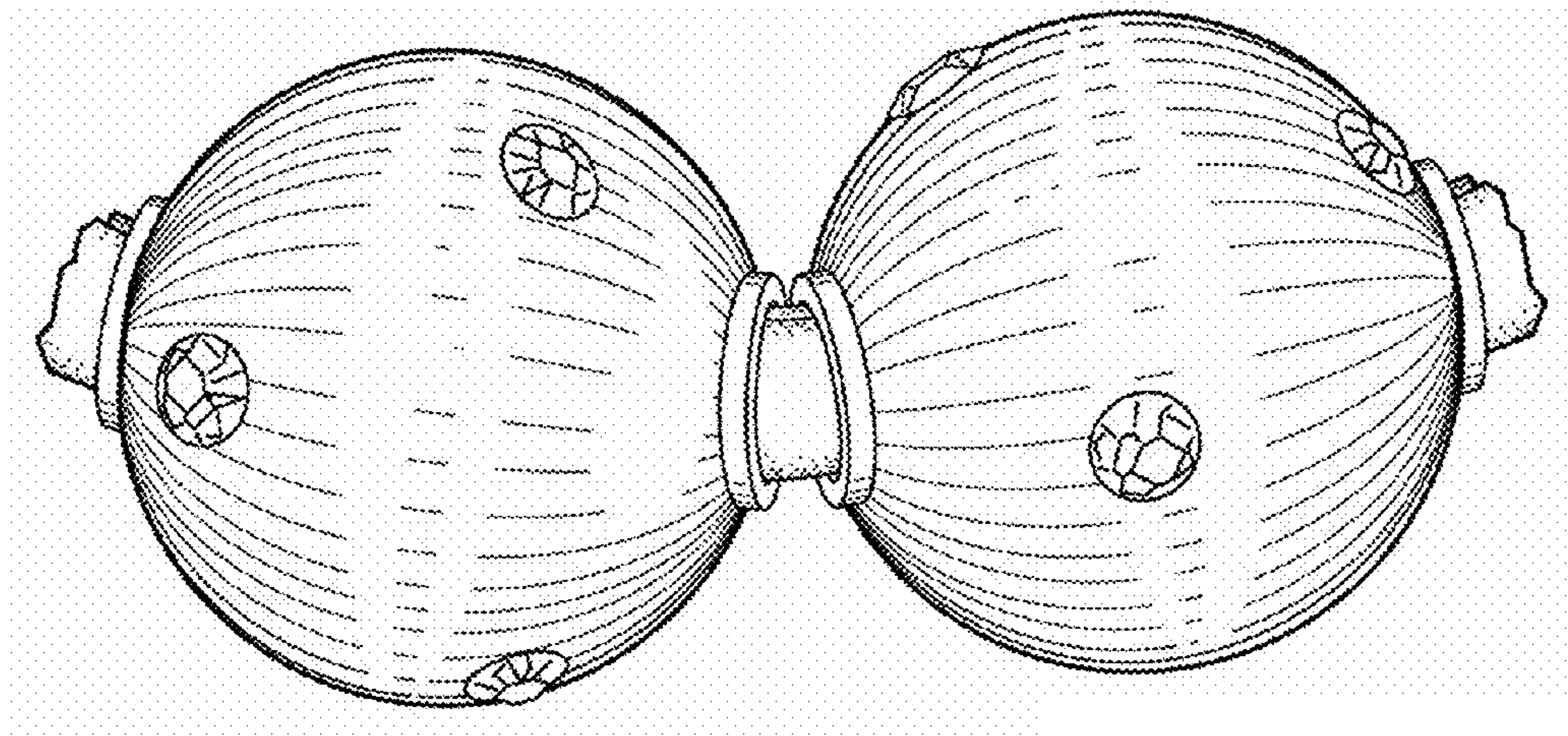

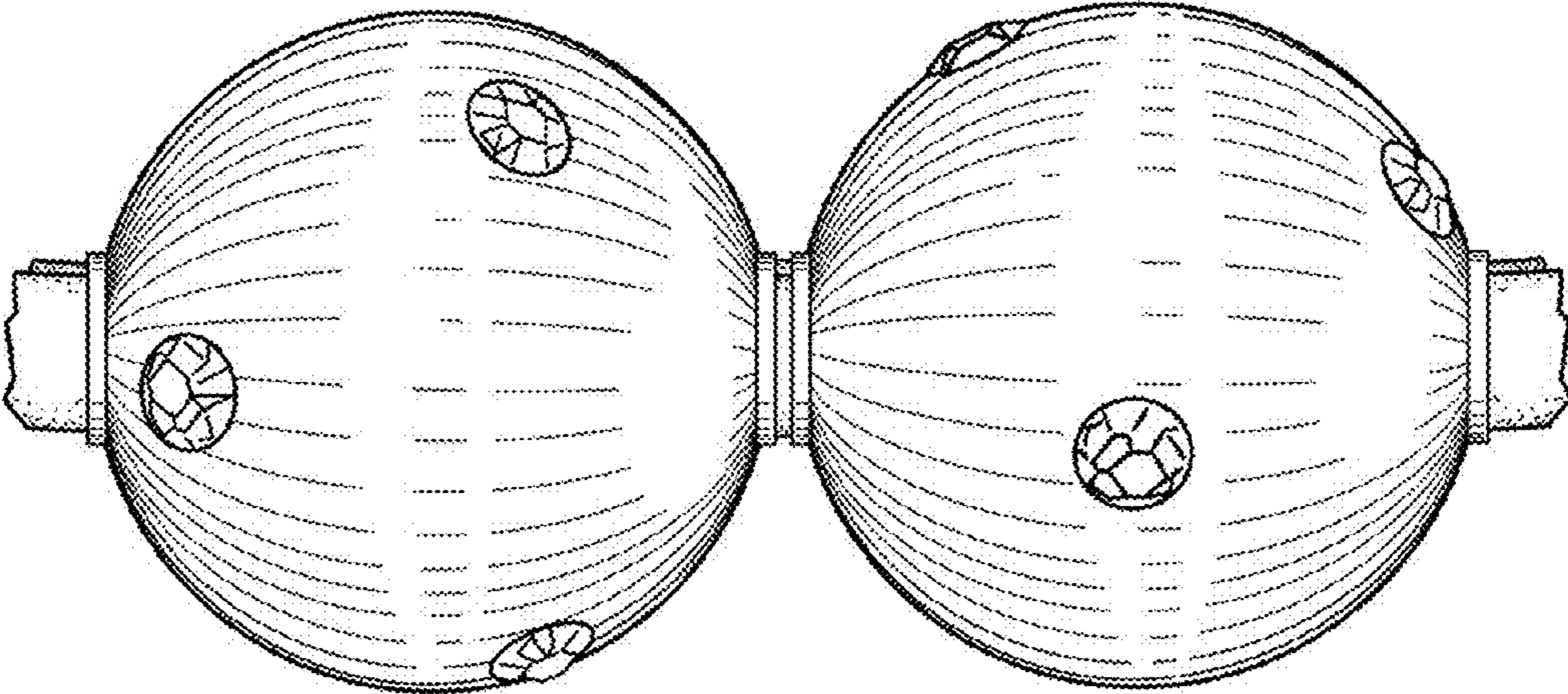

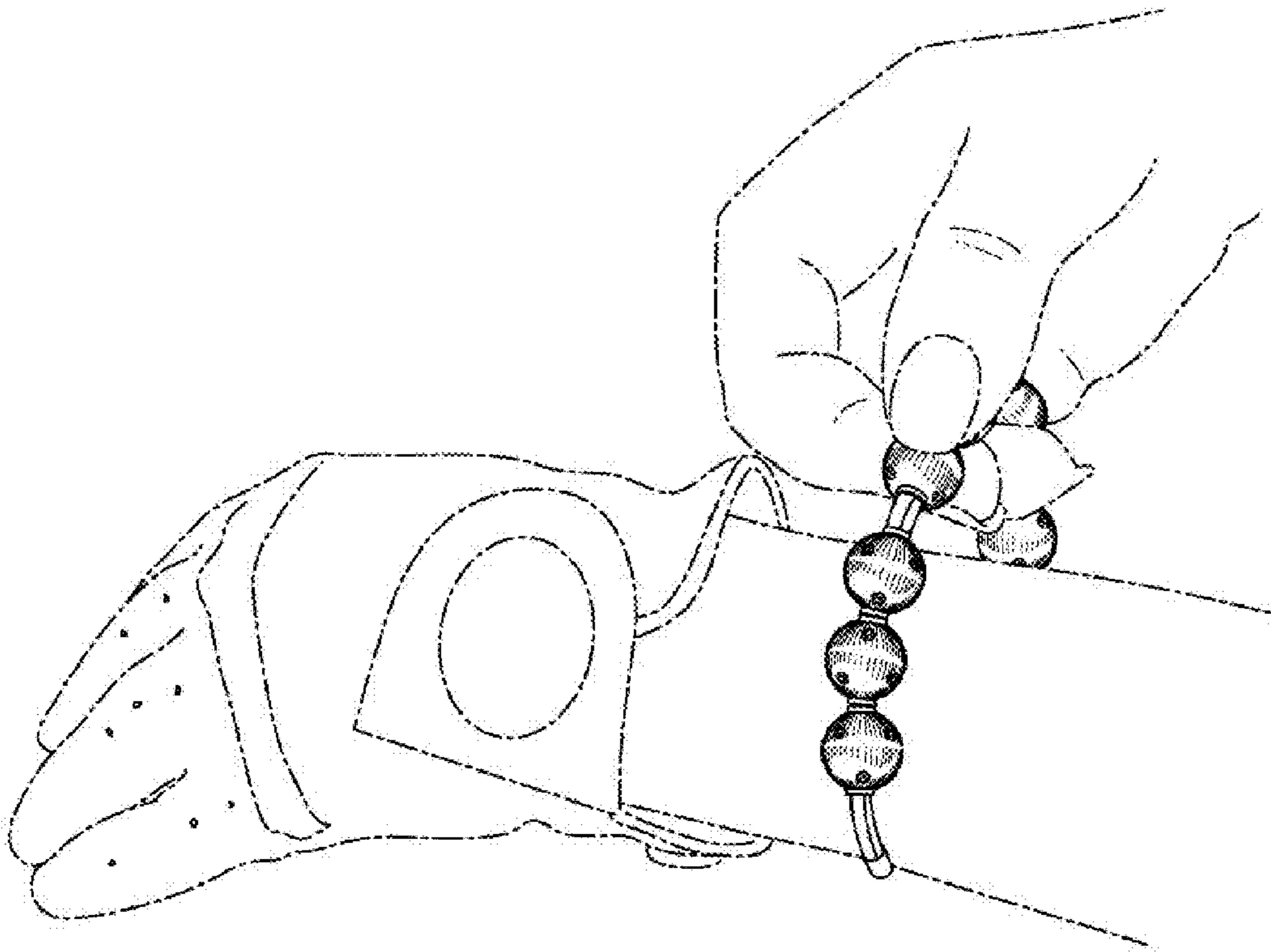
