The ornamental design for the display for a fire alarm, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the display for a fire alarm according to the present invention;

FIG. 3 is a rear elevation view of the display of FIG. 1;

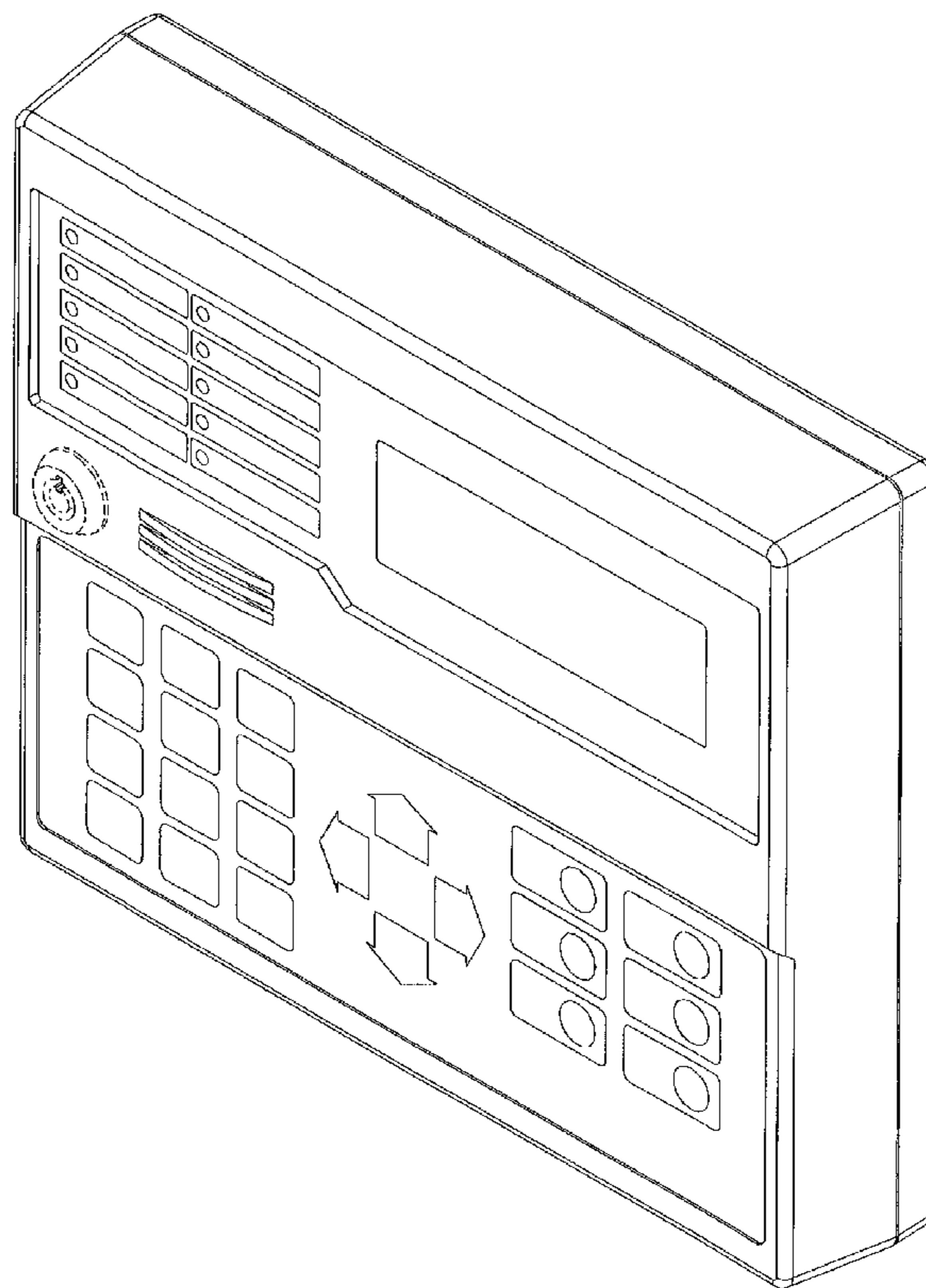
FIG. 4 is a right-side elevation view of the display of FIG. 1;

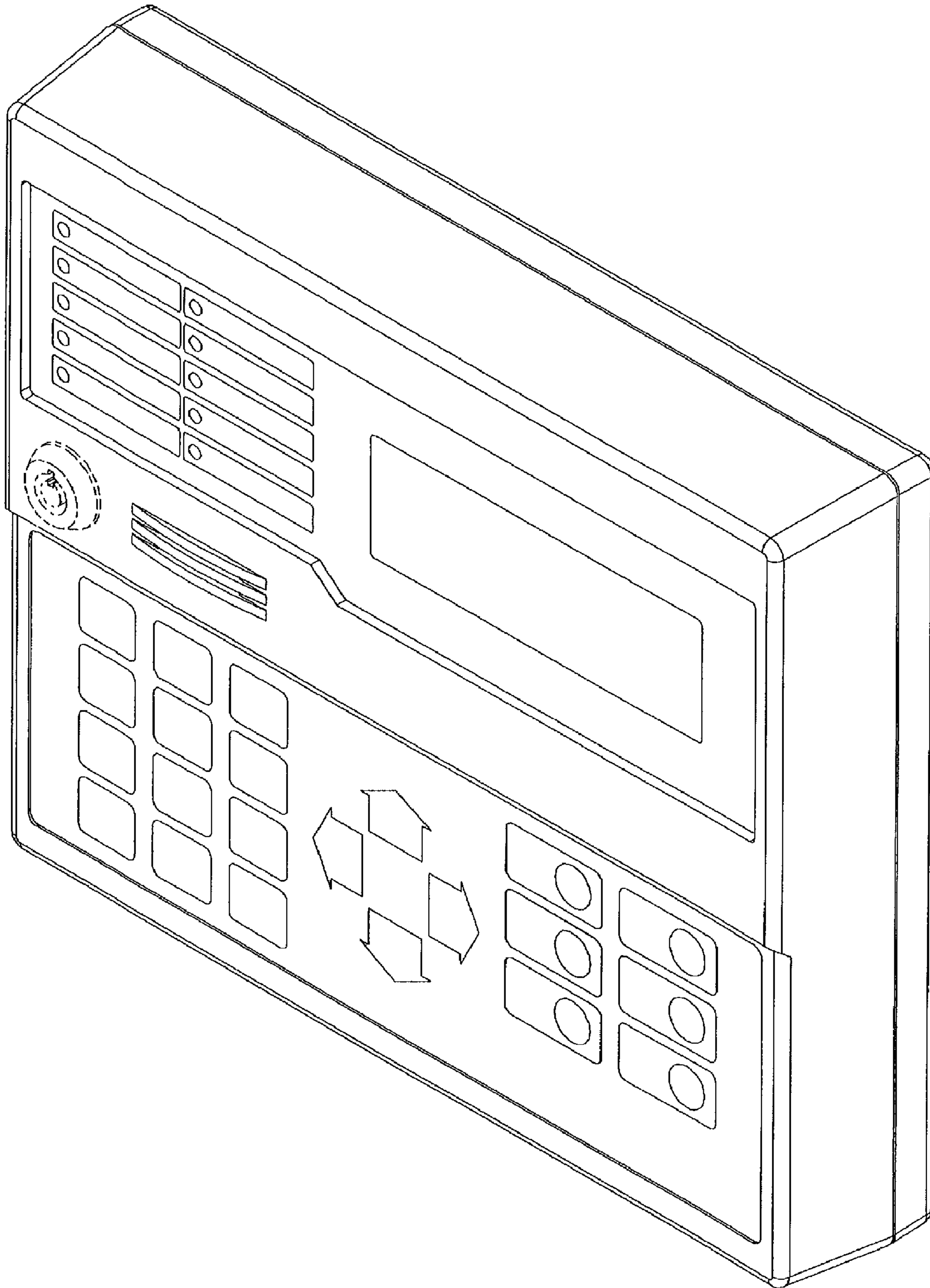

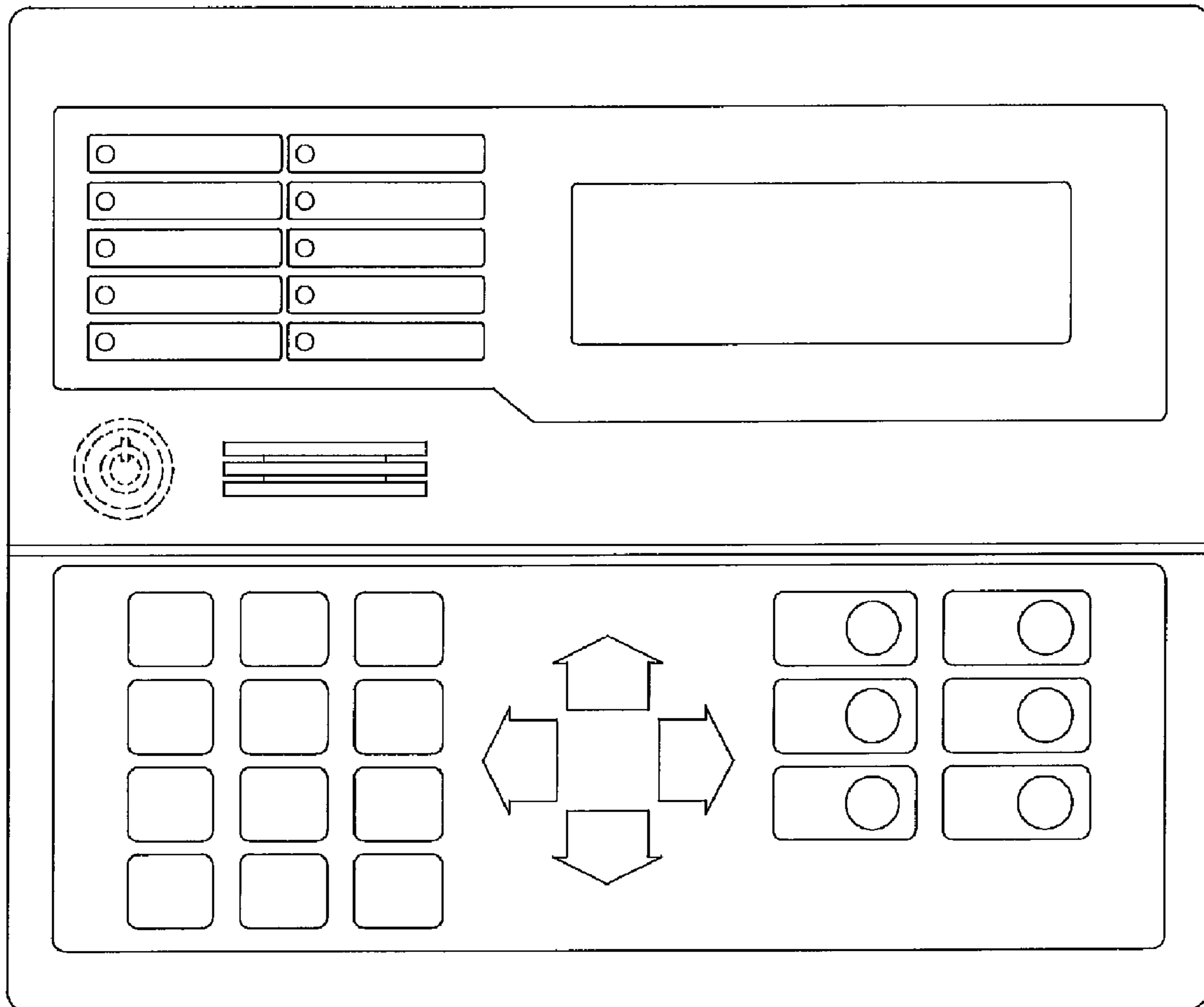

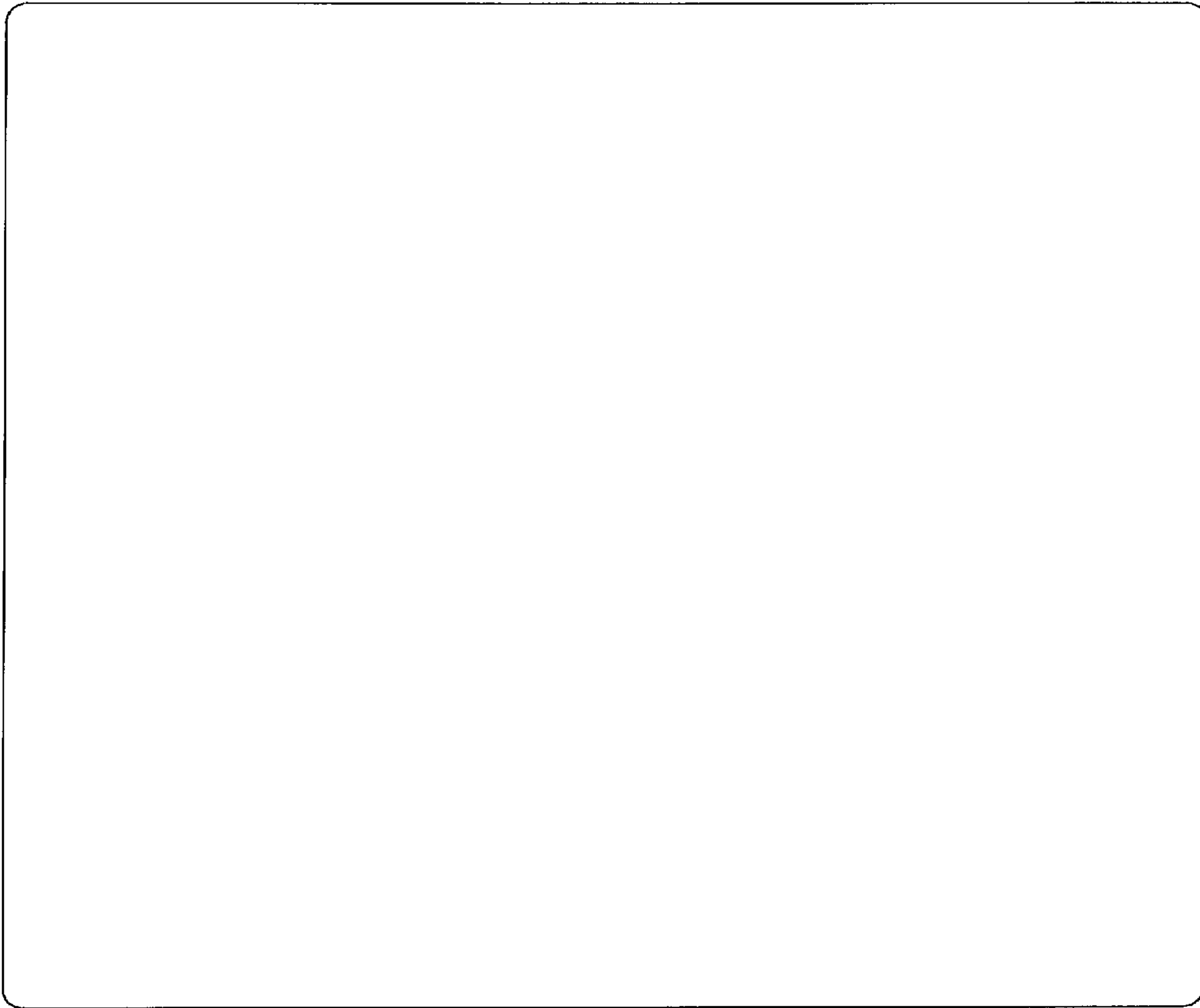

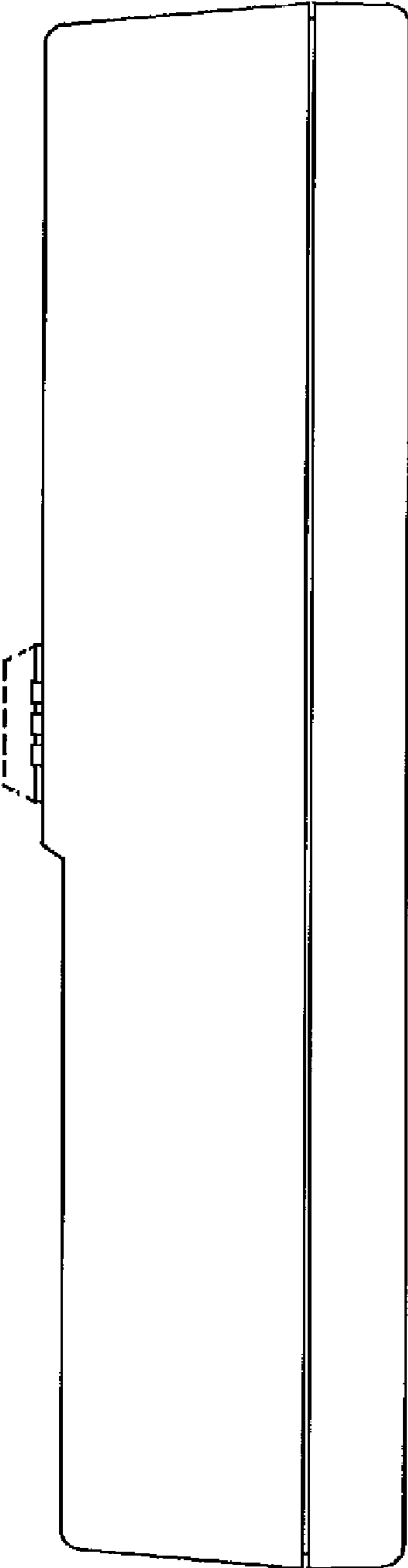

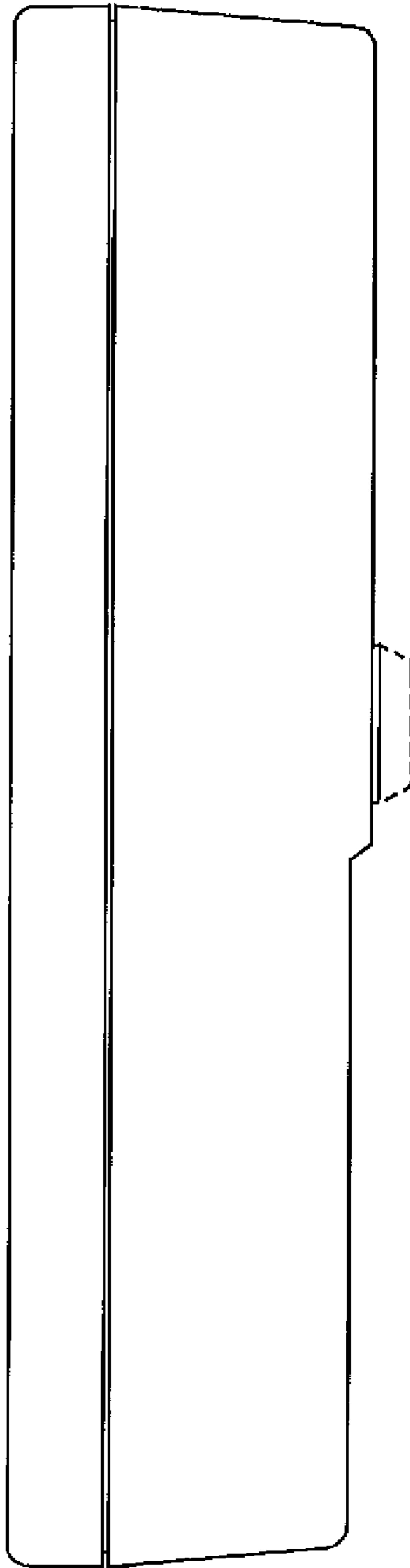

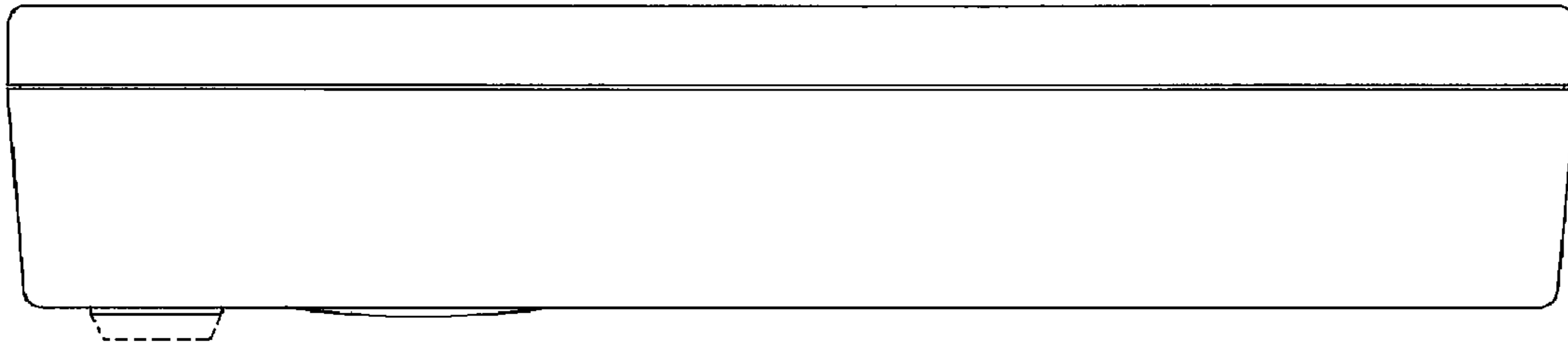

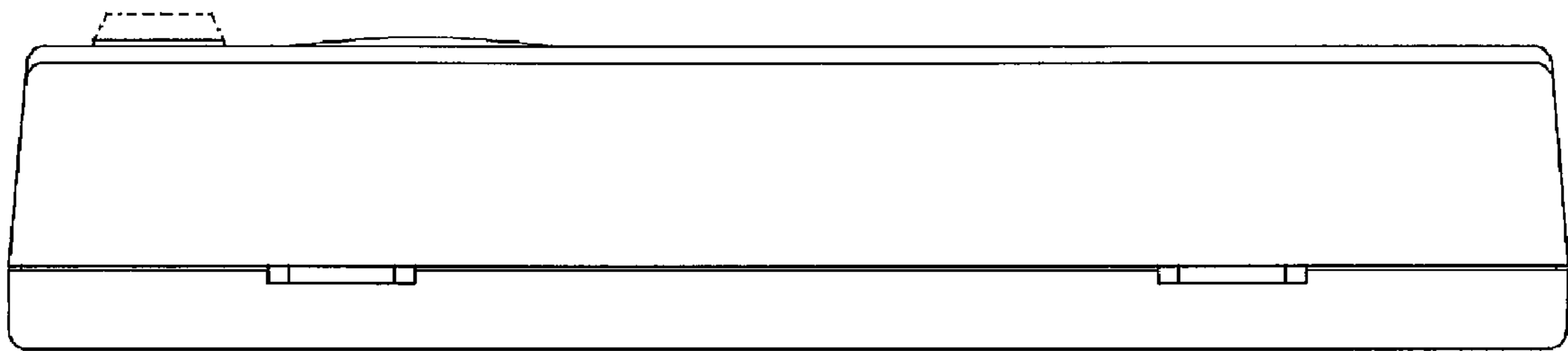
