FIG. 6 is a left-side elevational view thereof;

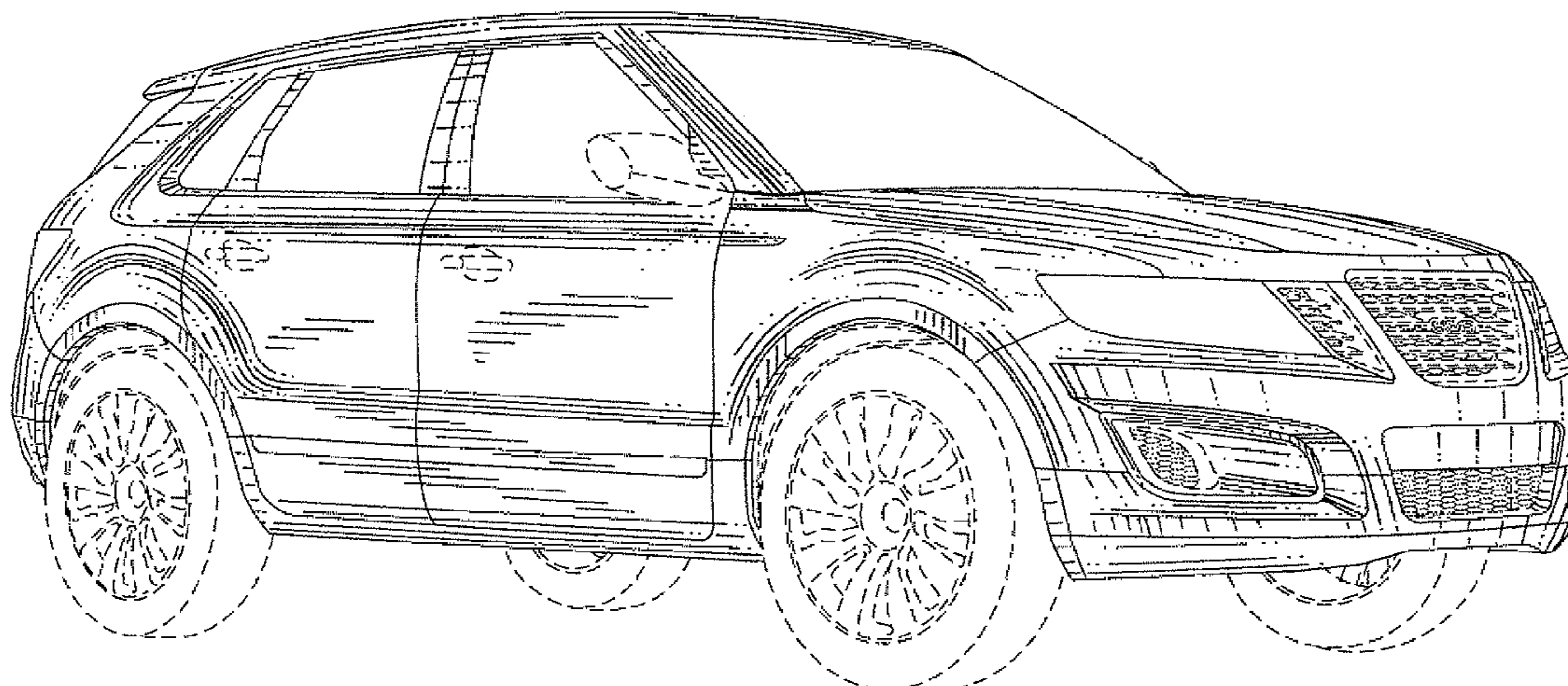
FIG. 7 is a rear elevational view thereof;

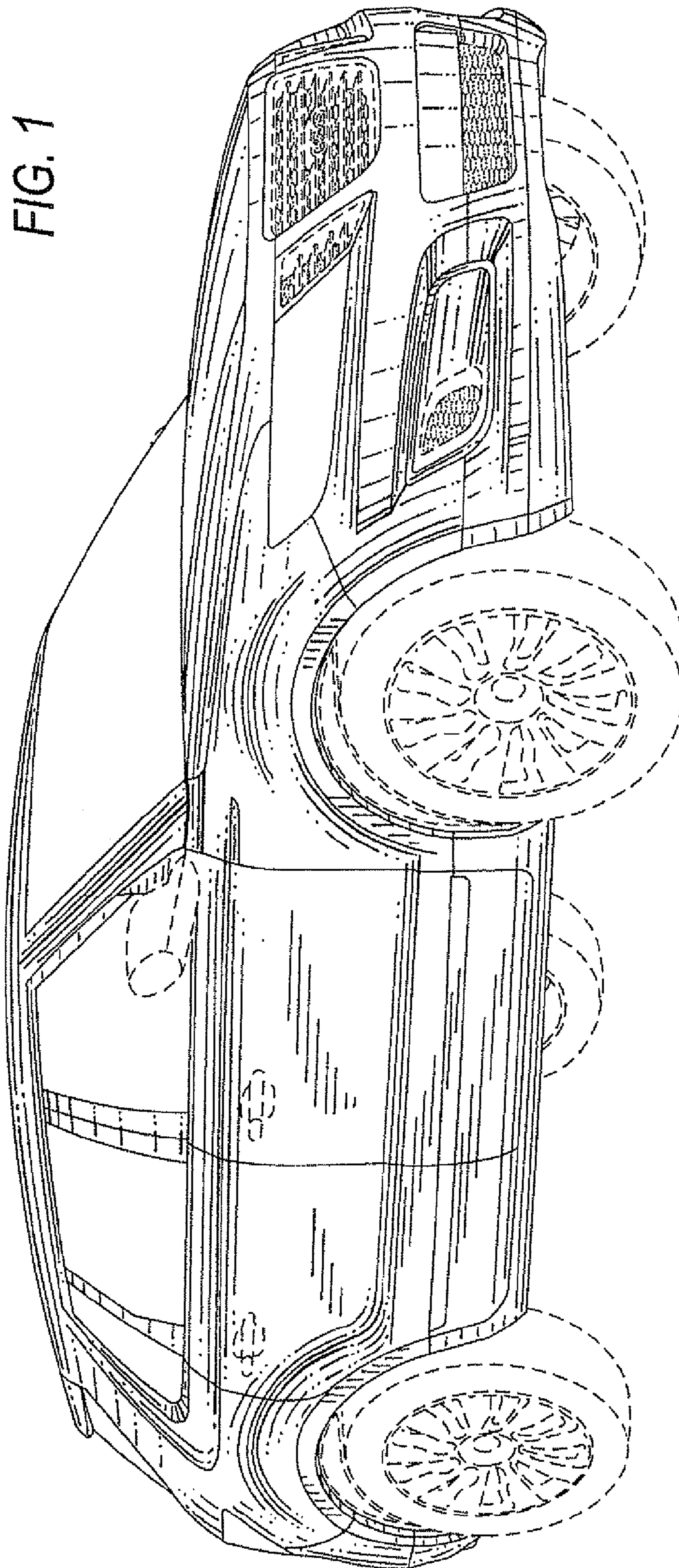

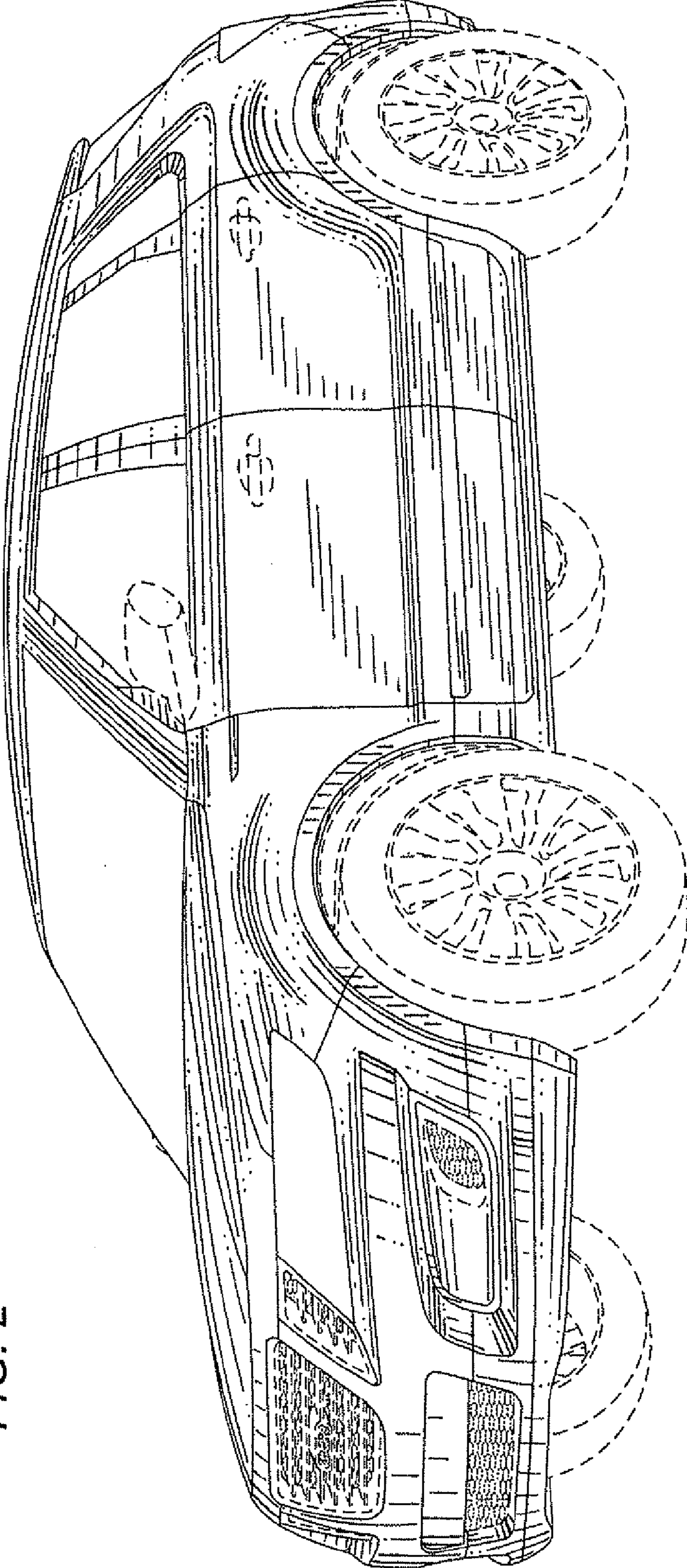
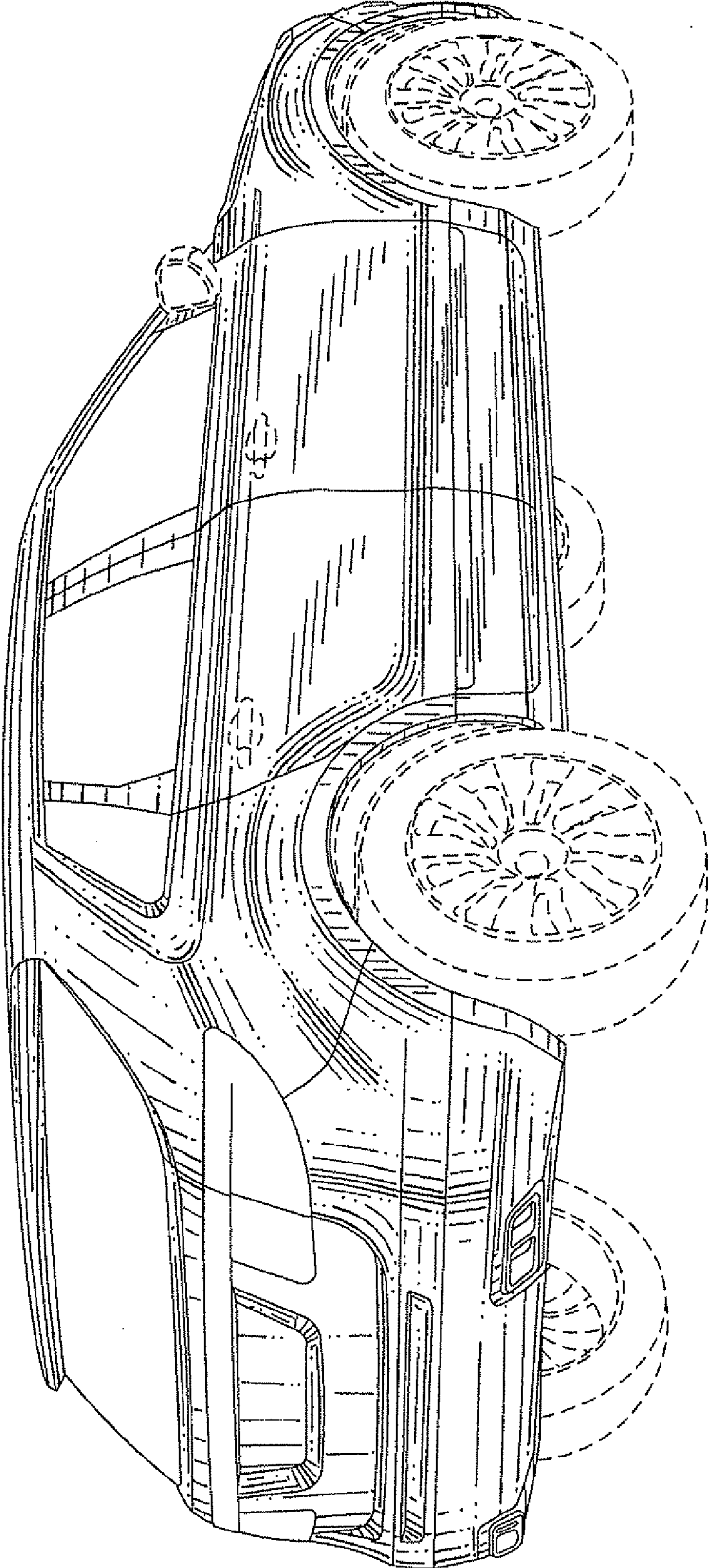

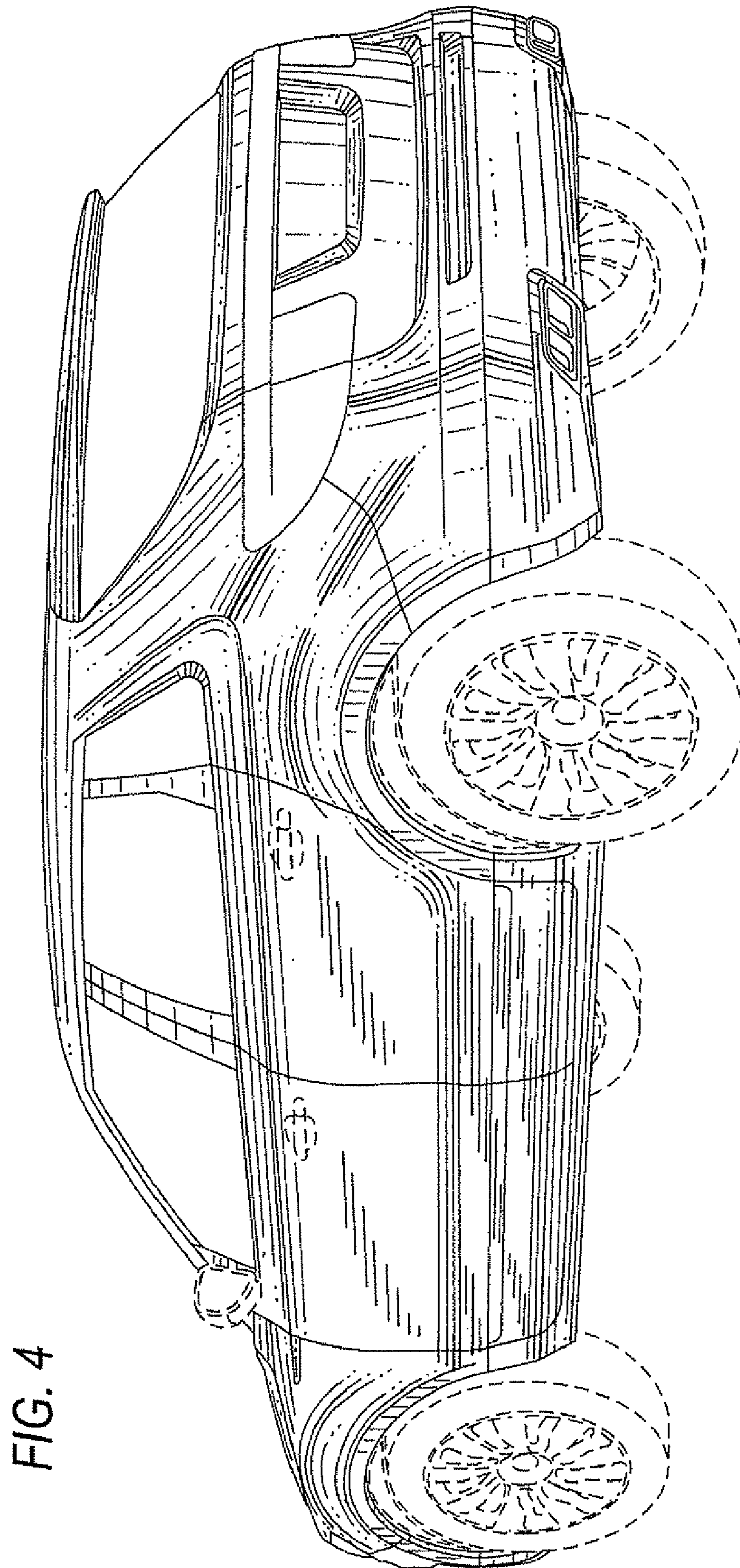

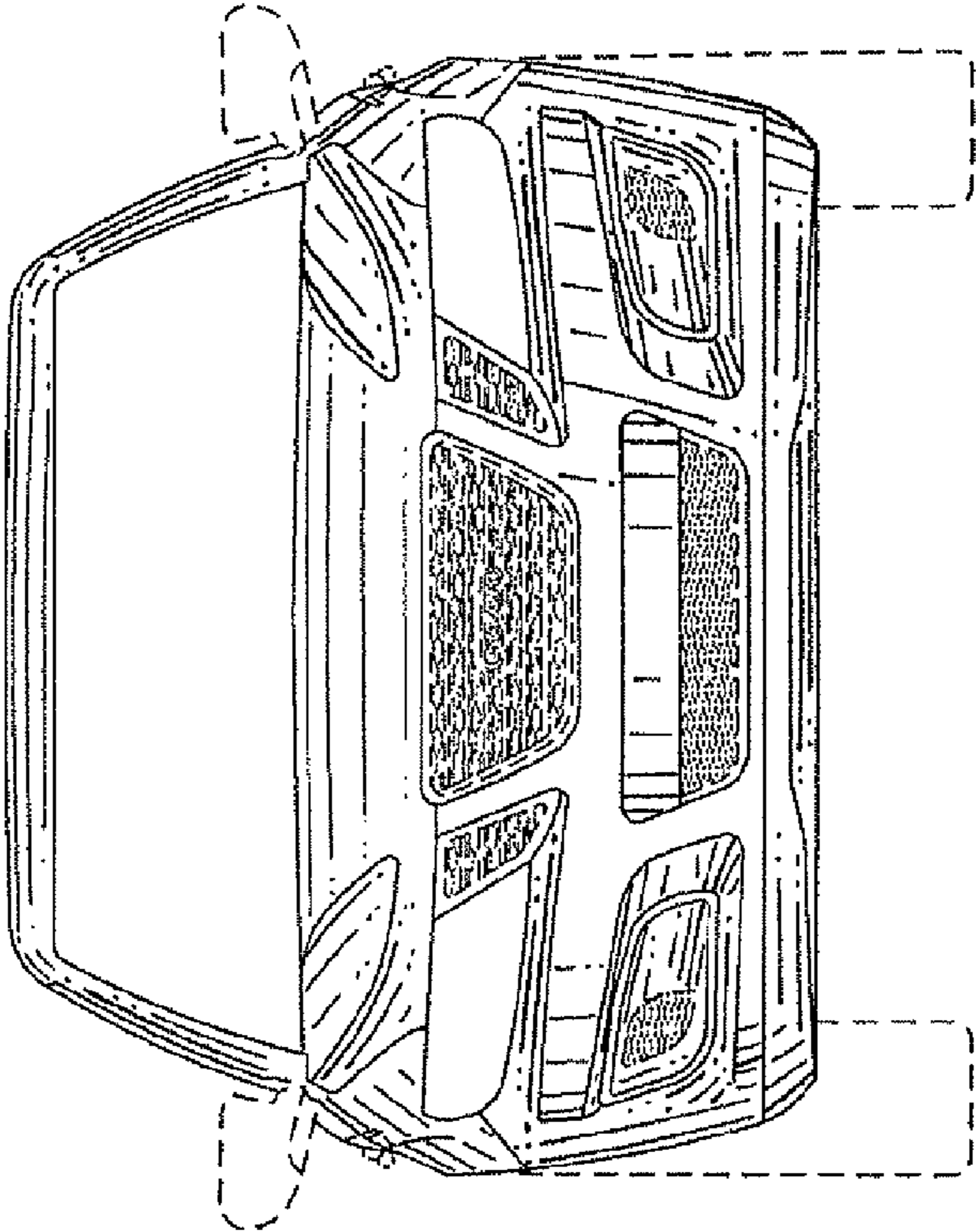

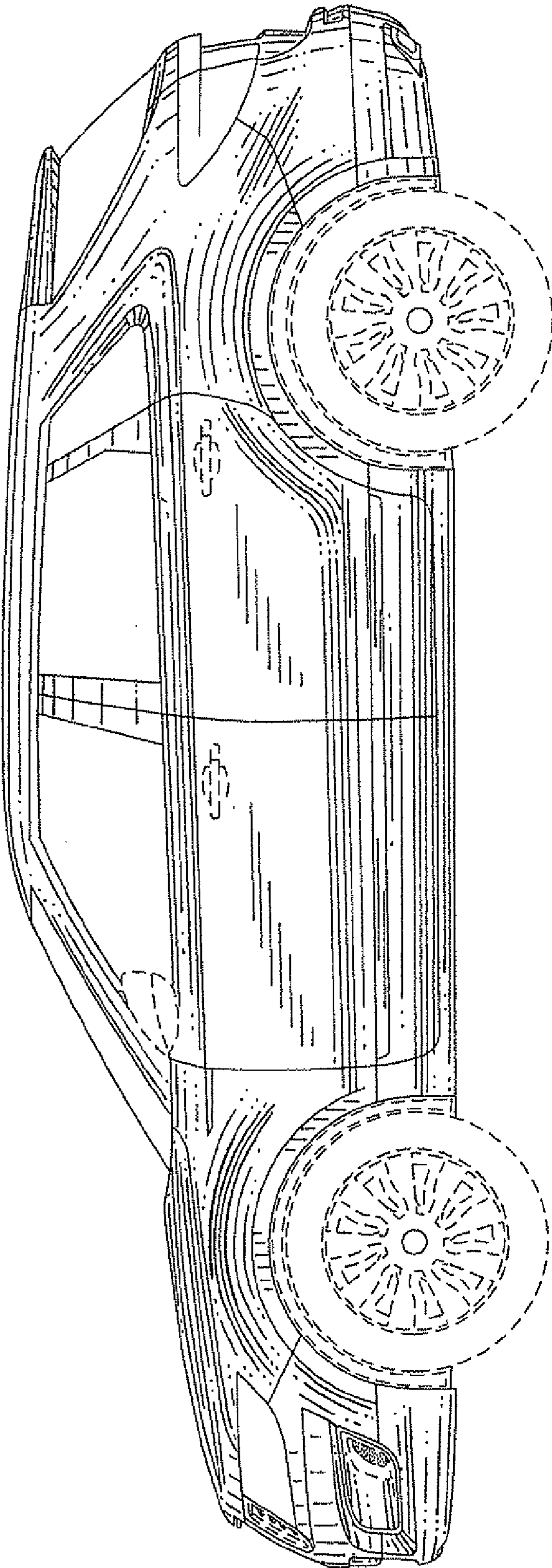

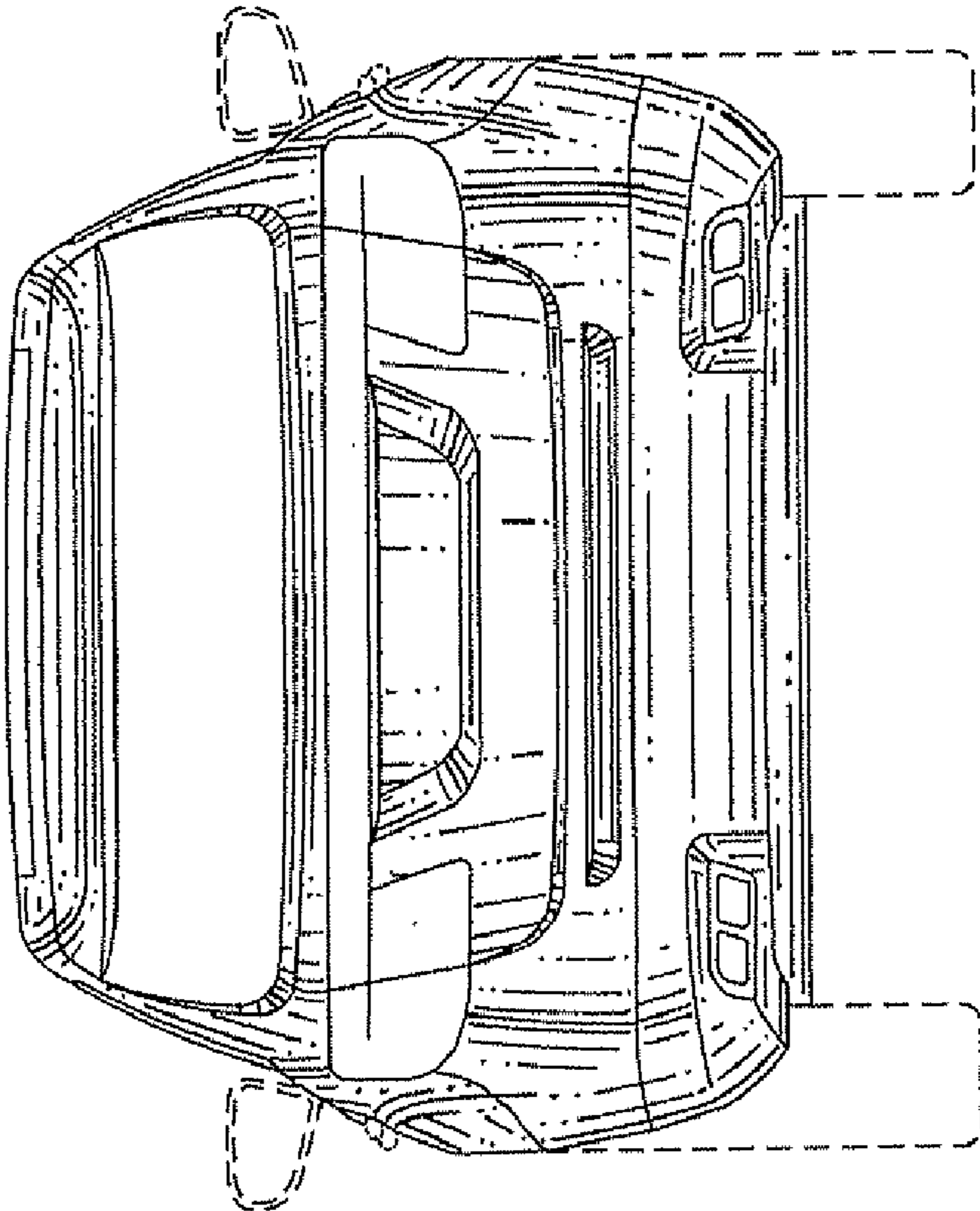

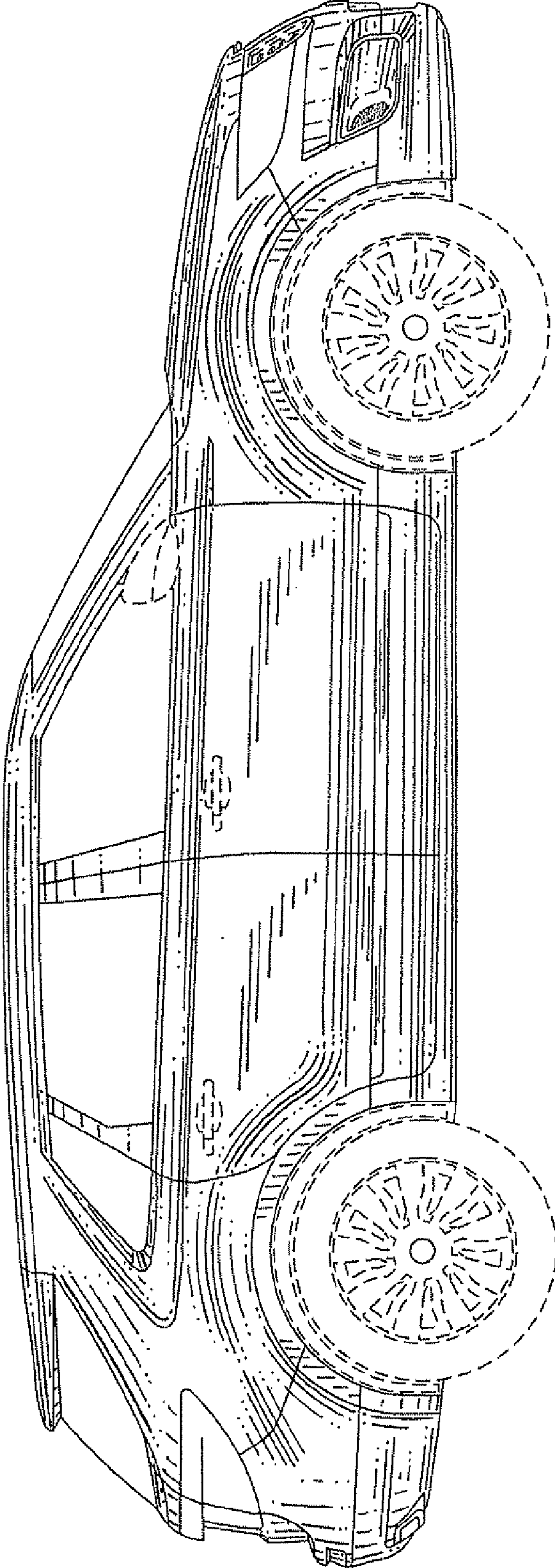

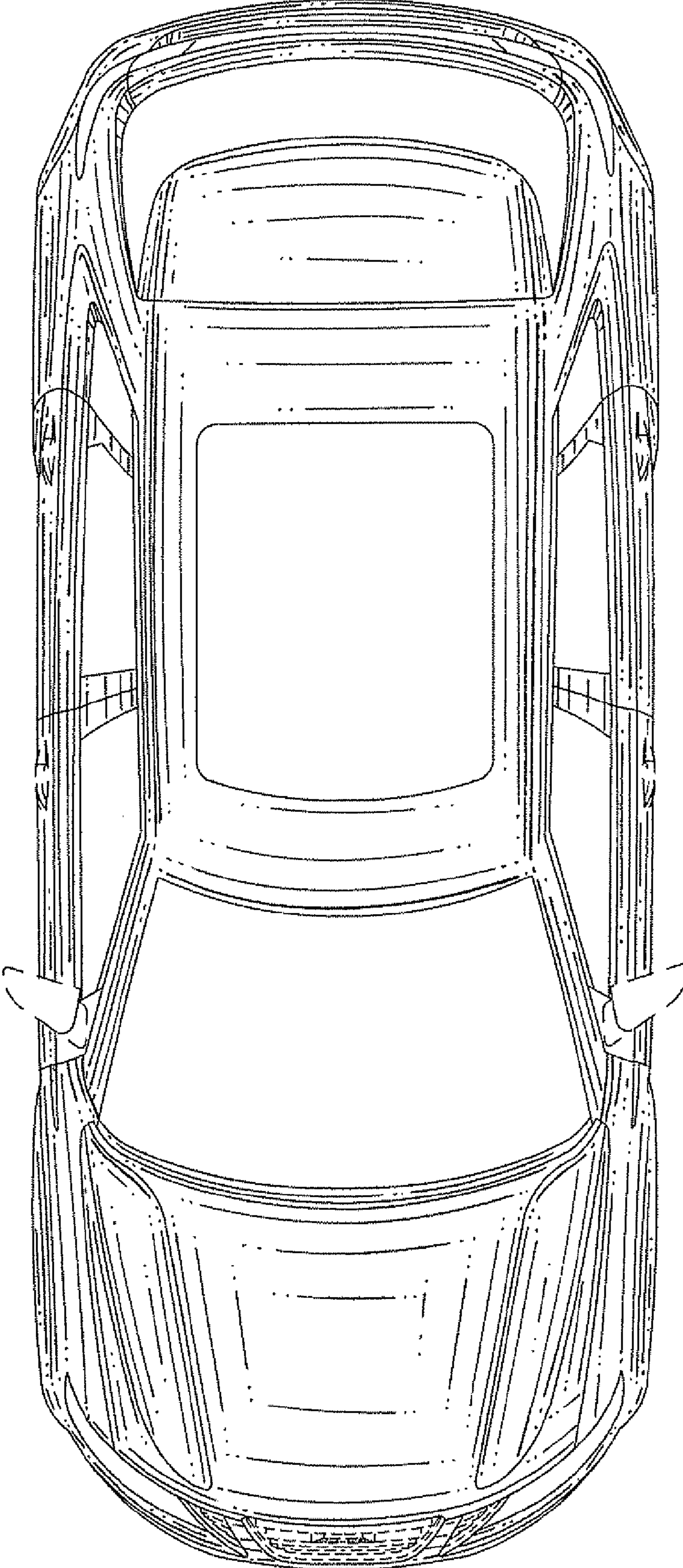
