**DESCRIPTION**

FIG. 1 is a perspective view of the water wrecker of the invention.

FIG. 2 is another perspective view of the water wrecker of the invention showing the floor everted to receive a V shaped hull boat.

FIG. 3 is a top plan view of the water wrecker shown in FIG. 2.

FIG. 4 is a rear end elevational view of the water wrecker shown in FIG. 2.

FIG. 5 is a side elevational view of the water wrecker shown in FIGS. 1 and 2, the opposite side view being a mirror image thereof; and,

FIG. 6 is a bottom plan view of the water wrecker shown in FIGS. 1, and 2.

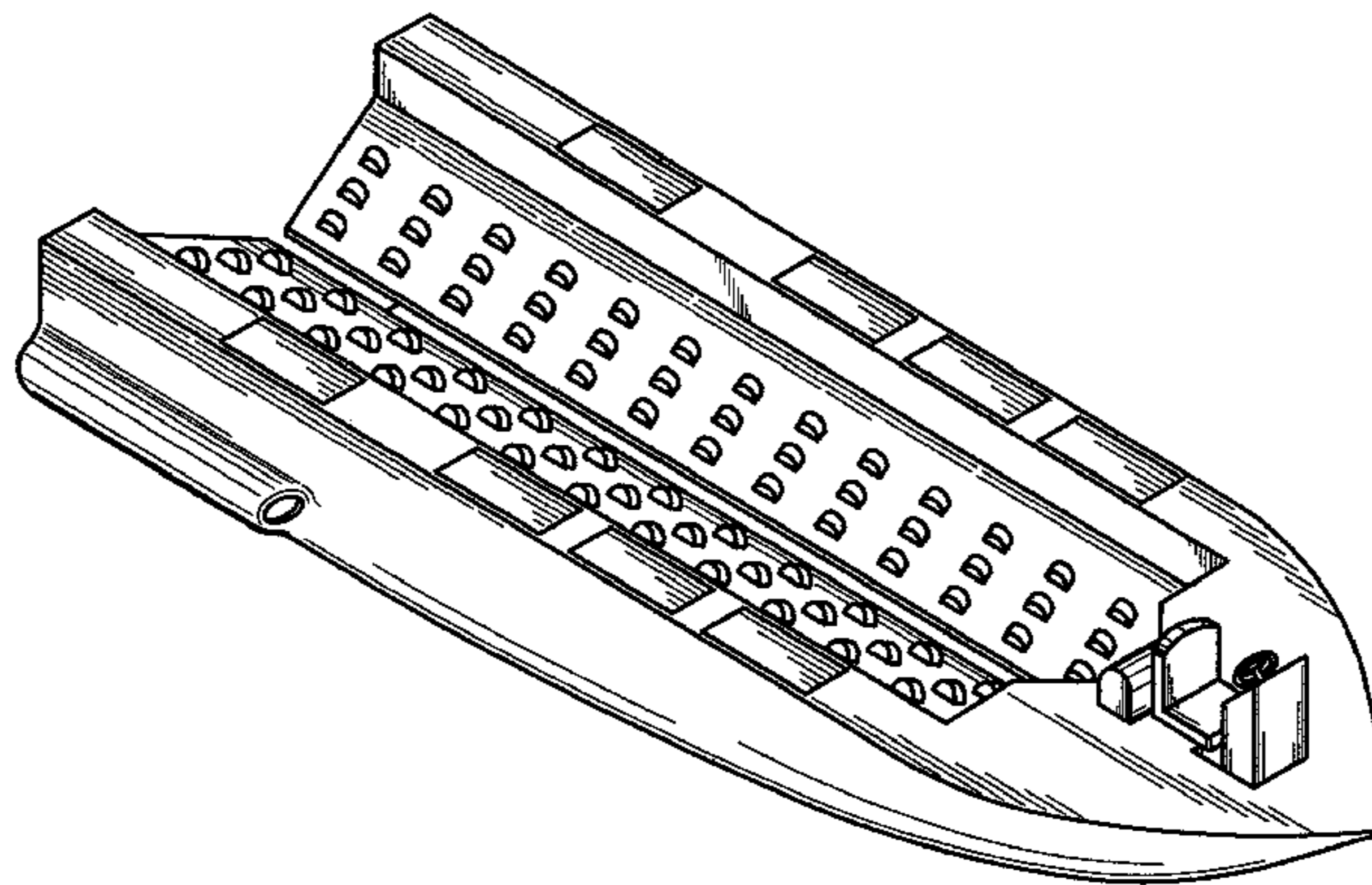
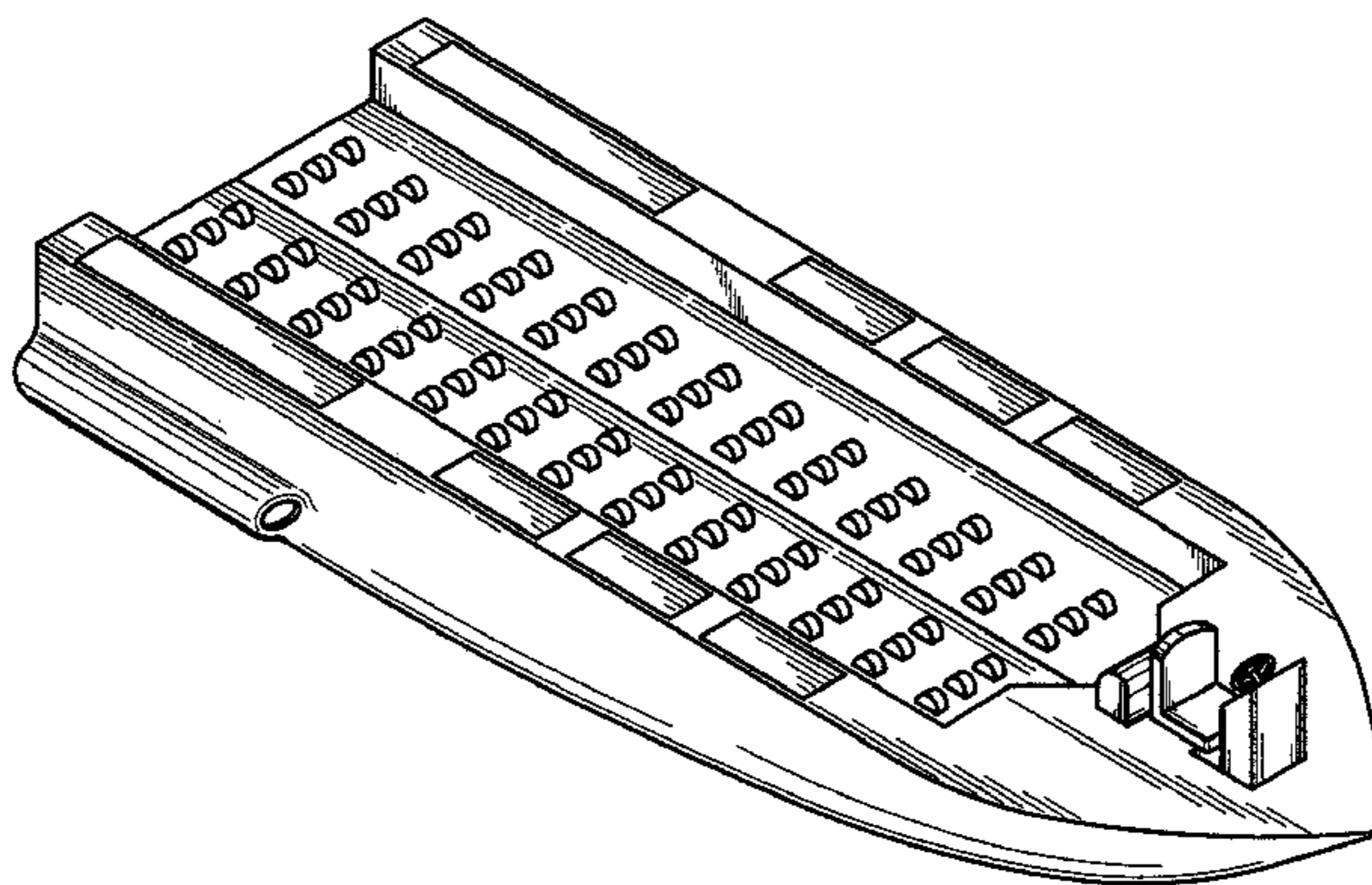
The broken lines shown in FIG. 4 represent portions of the design that form no part of the claim.

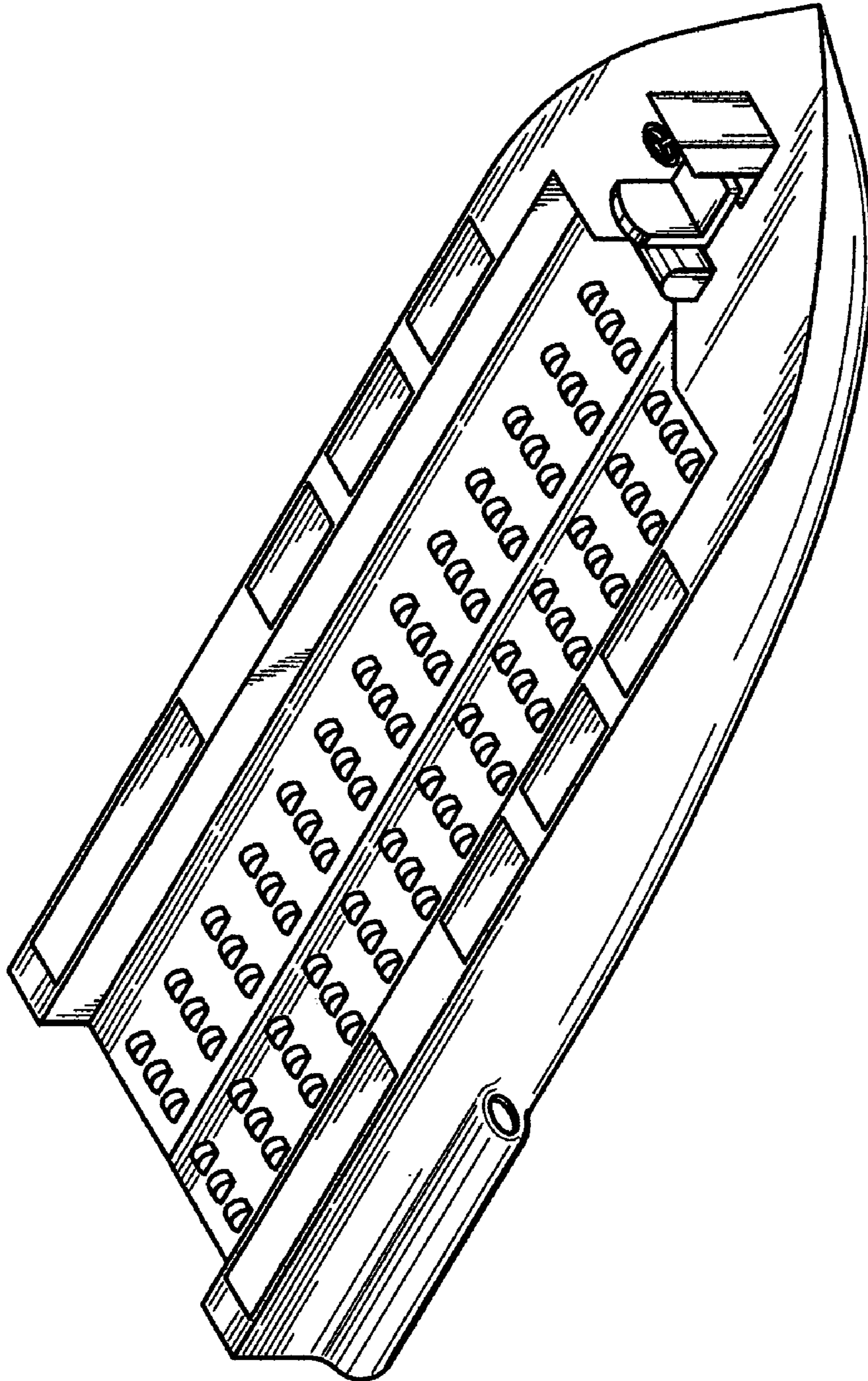

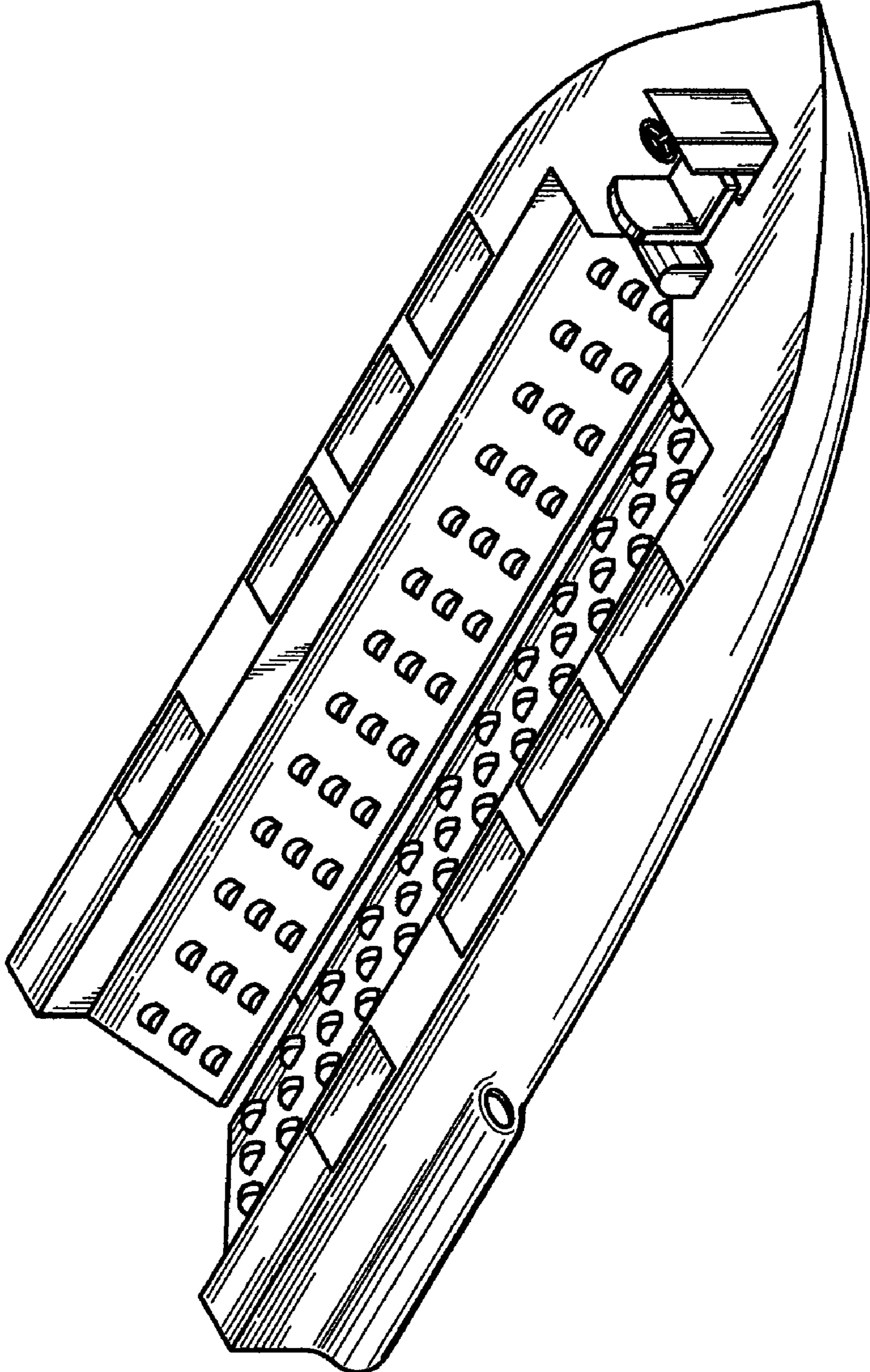

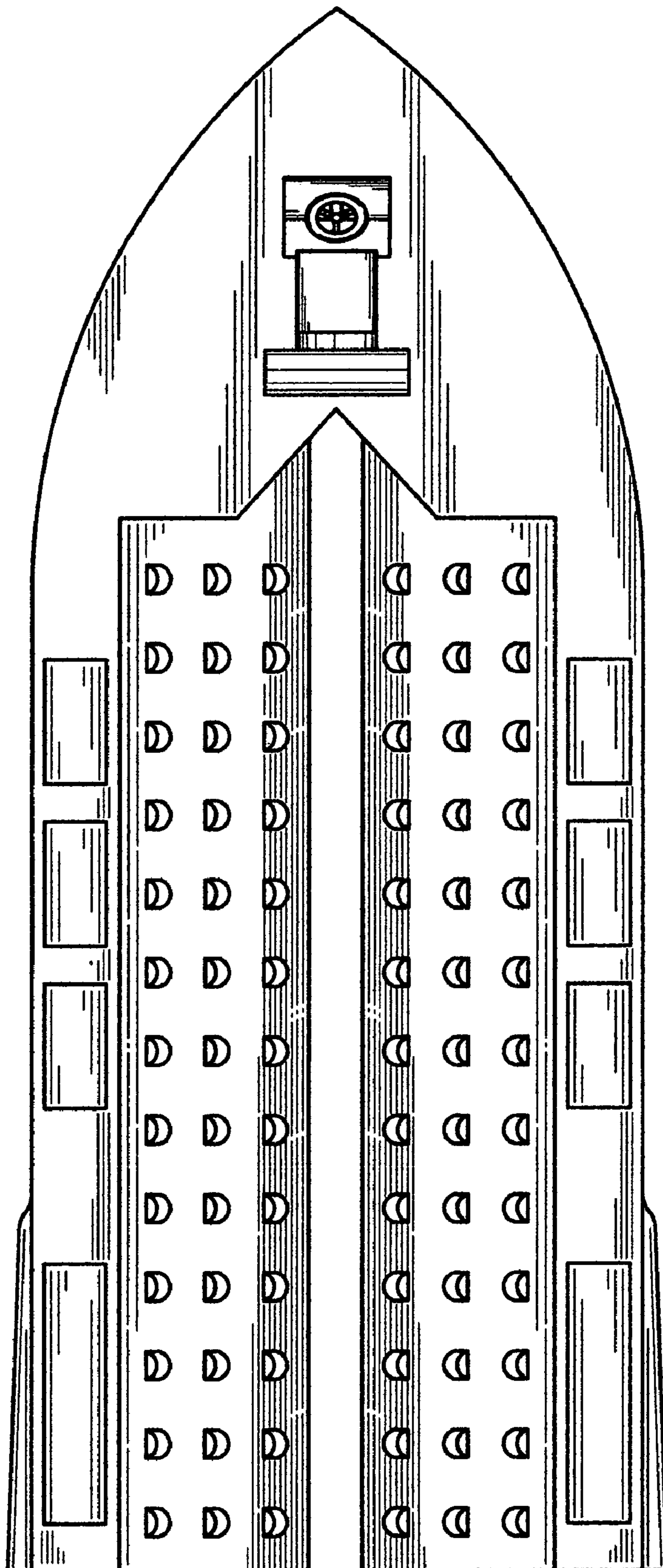
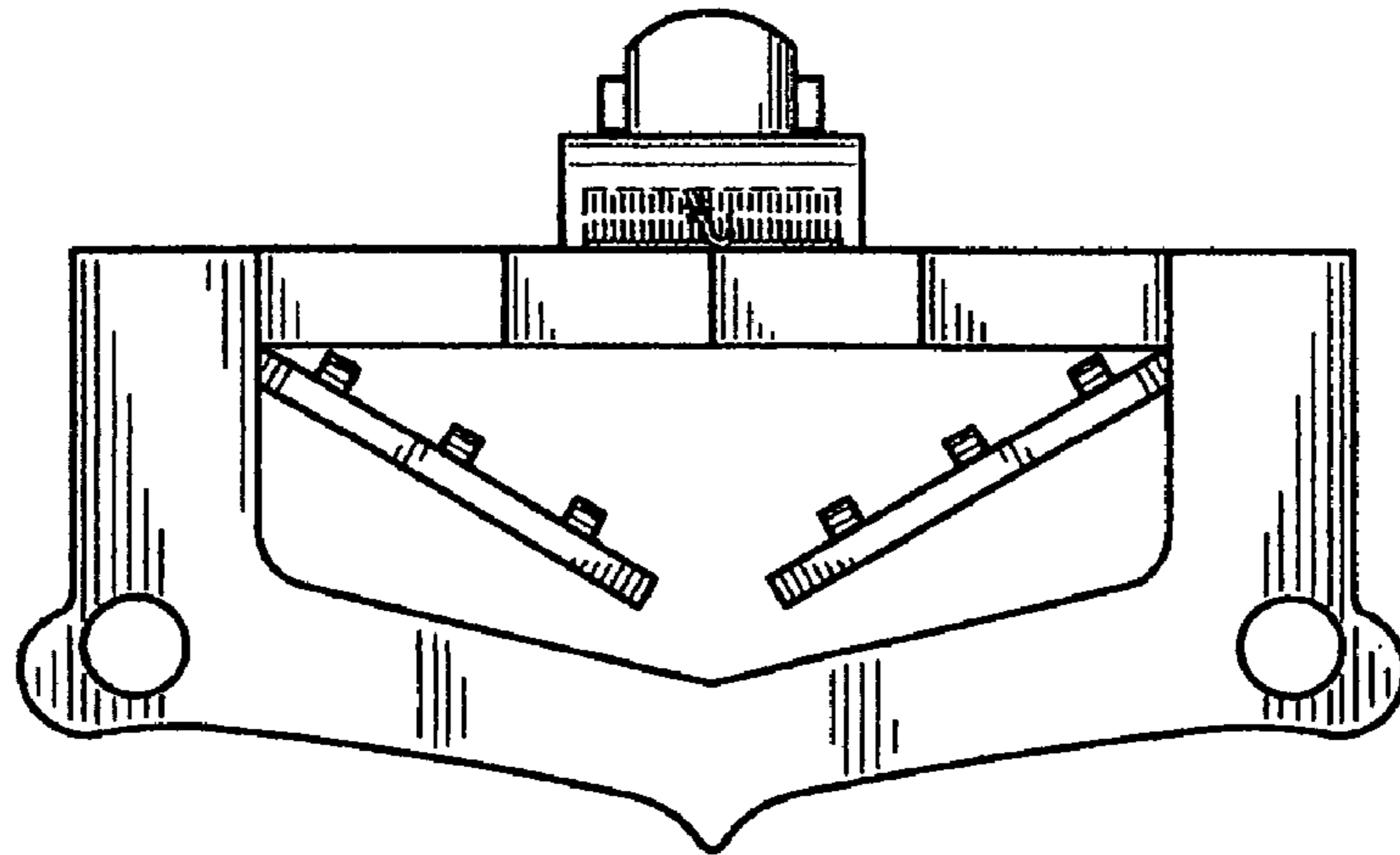

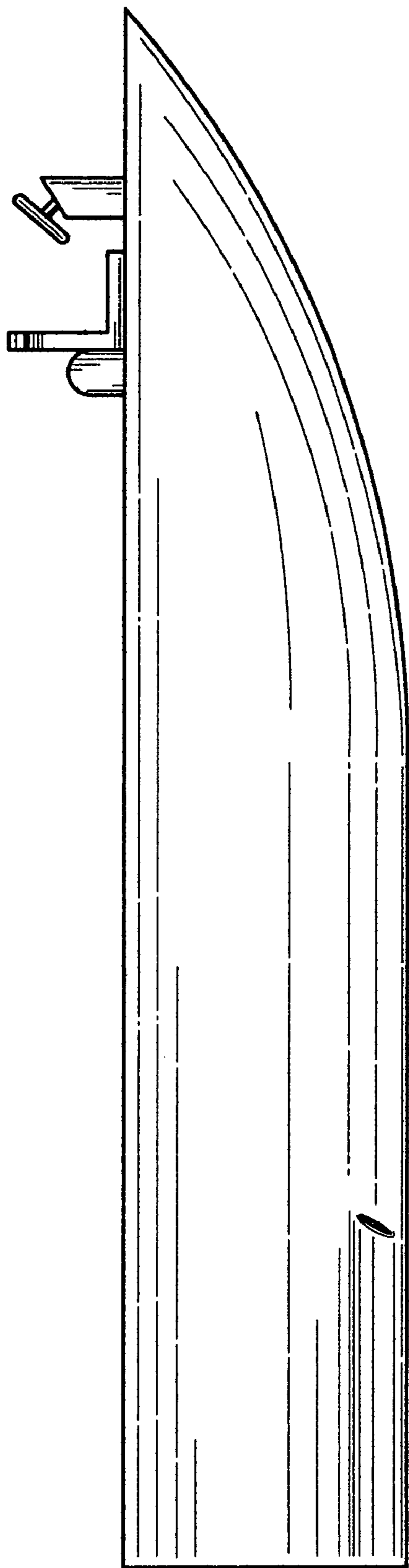

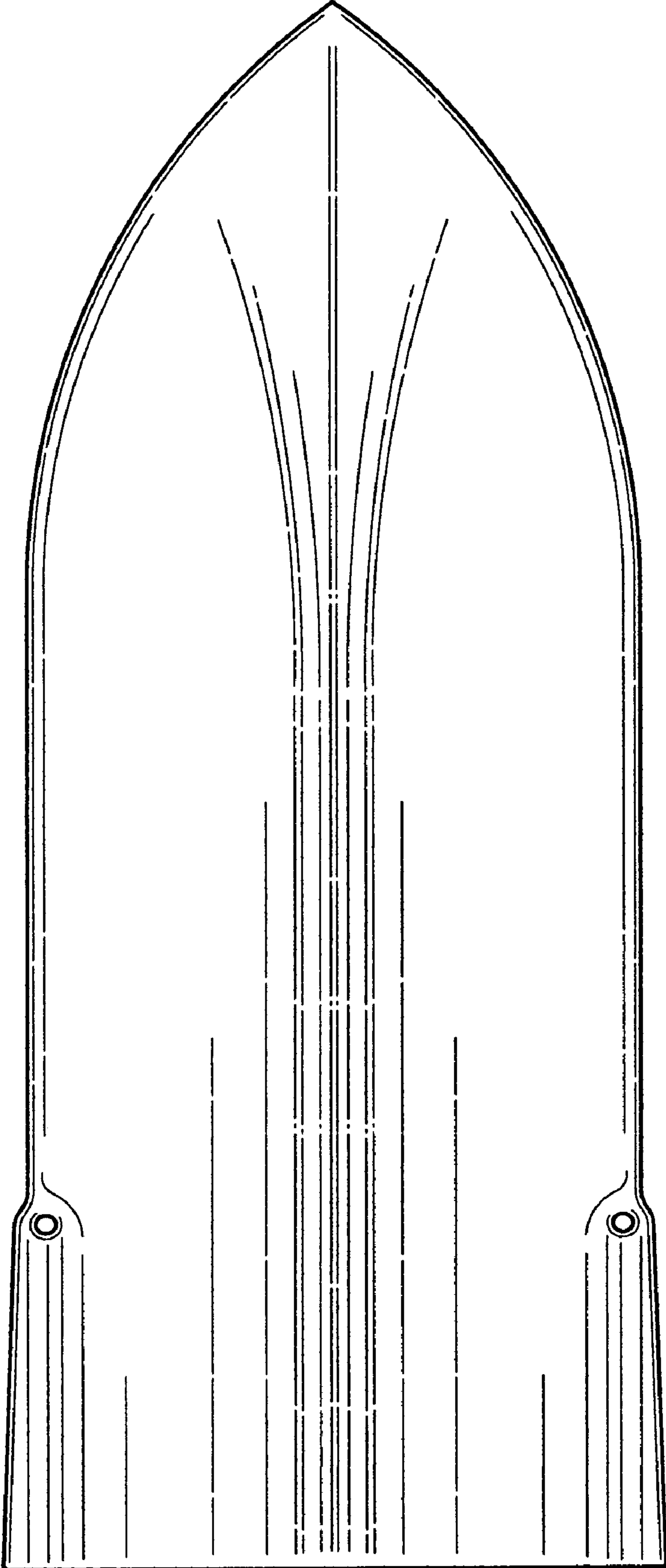
