(57) **CLAIM**

The ornamental designs for a personal watercraft rear handle, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view showing a personal watercraft rear handle according to our new design;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a front left perspective view thereof on a personal watercraft, with the personal watercraft shown in broken lines;

FIG. 9 is a rear bottom right perspective view of the personal watercraft rear handle of FIG. 1;

FIG. 10 is a front left perspective view showing the personal watercraft rear handle of FIG. 1 with select broken-lined elements removed for the clarity of illustration;

FIG. 11 is a rear elevation view thereof;

FIG. 12 is a front elevation view thereof;

FIG. 13 is a left side elevation view thereof;

FIG. 14 is a right side elevation view thereof;

FIG. 15 is a bottom plan view thereof;

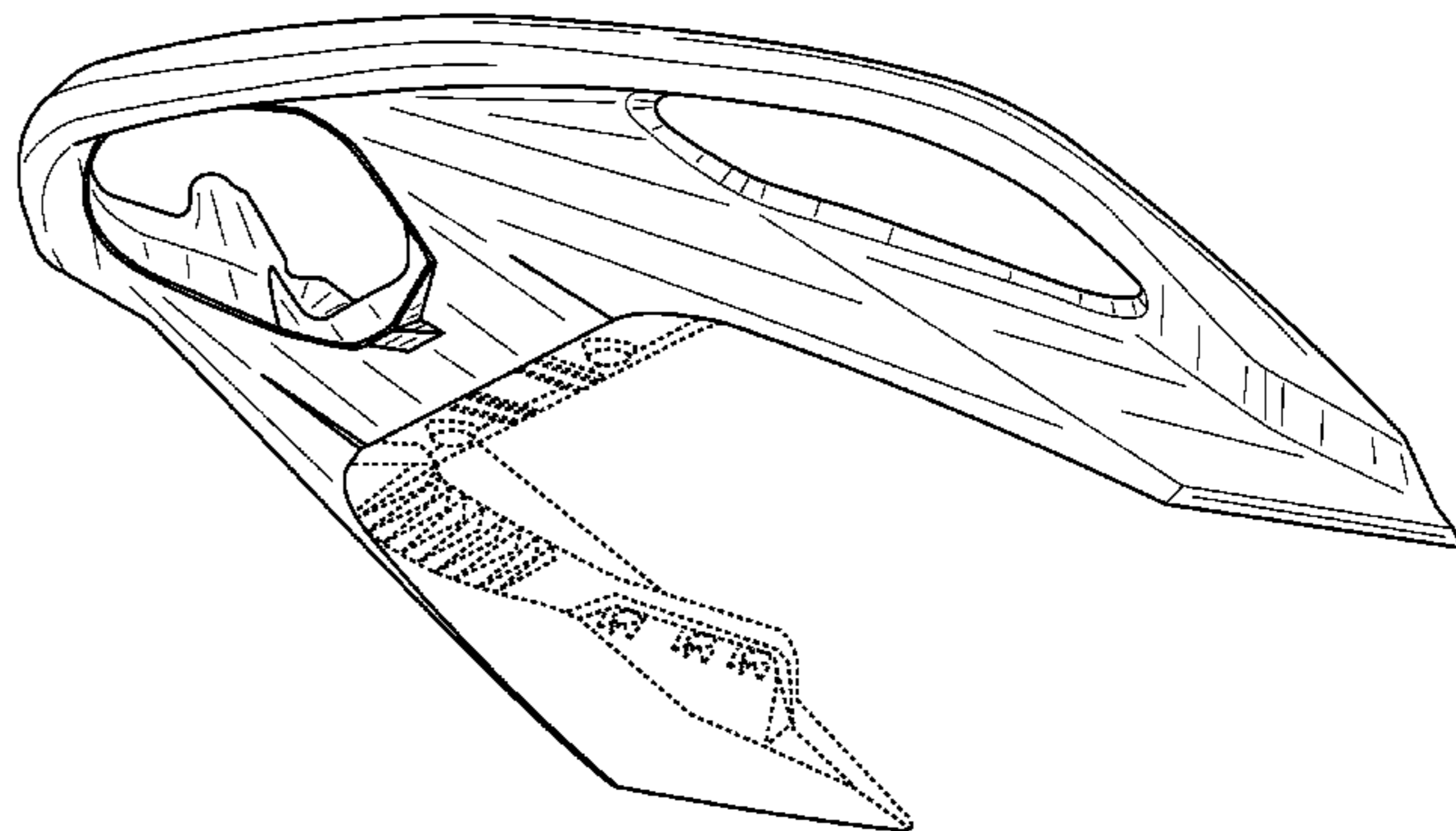
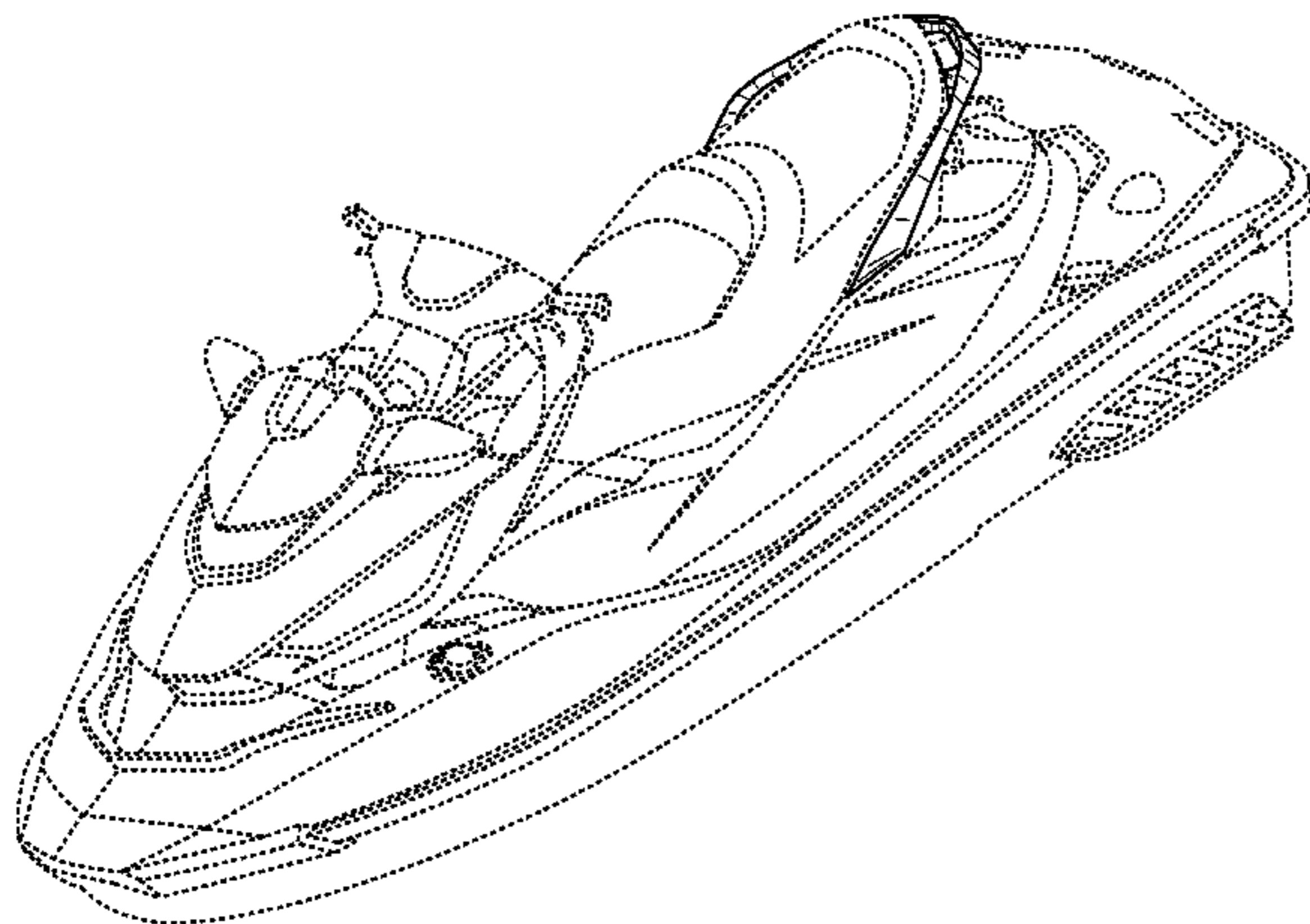
FIG. 16 is a top plan view thereof;

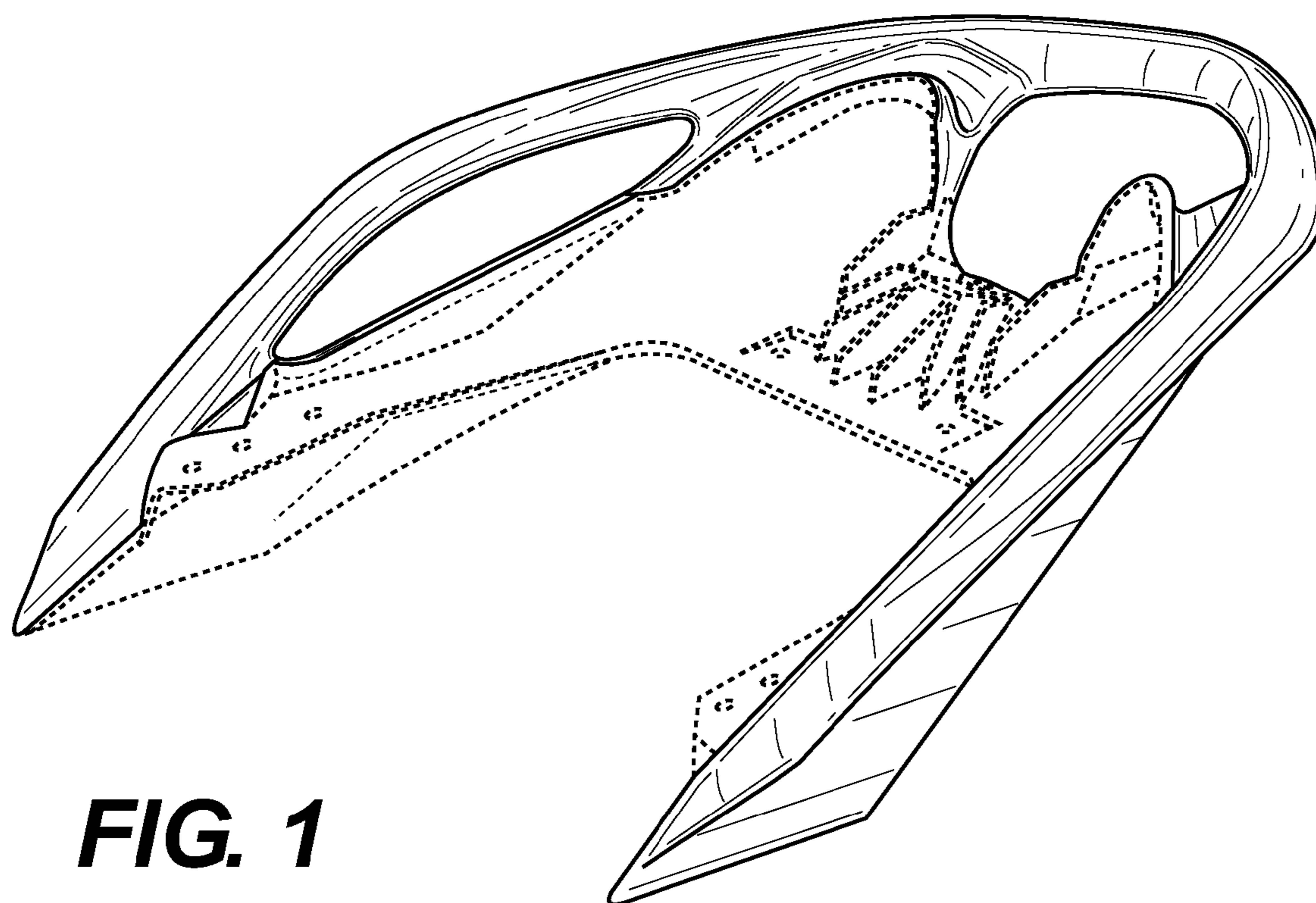

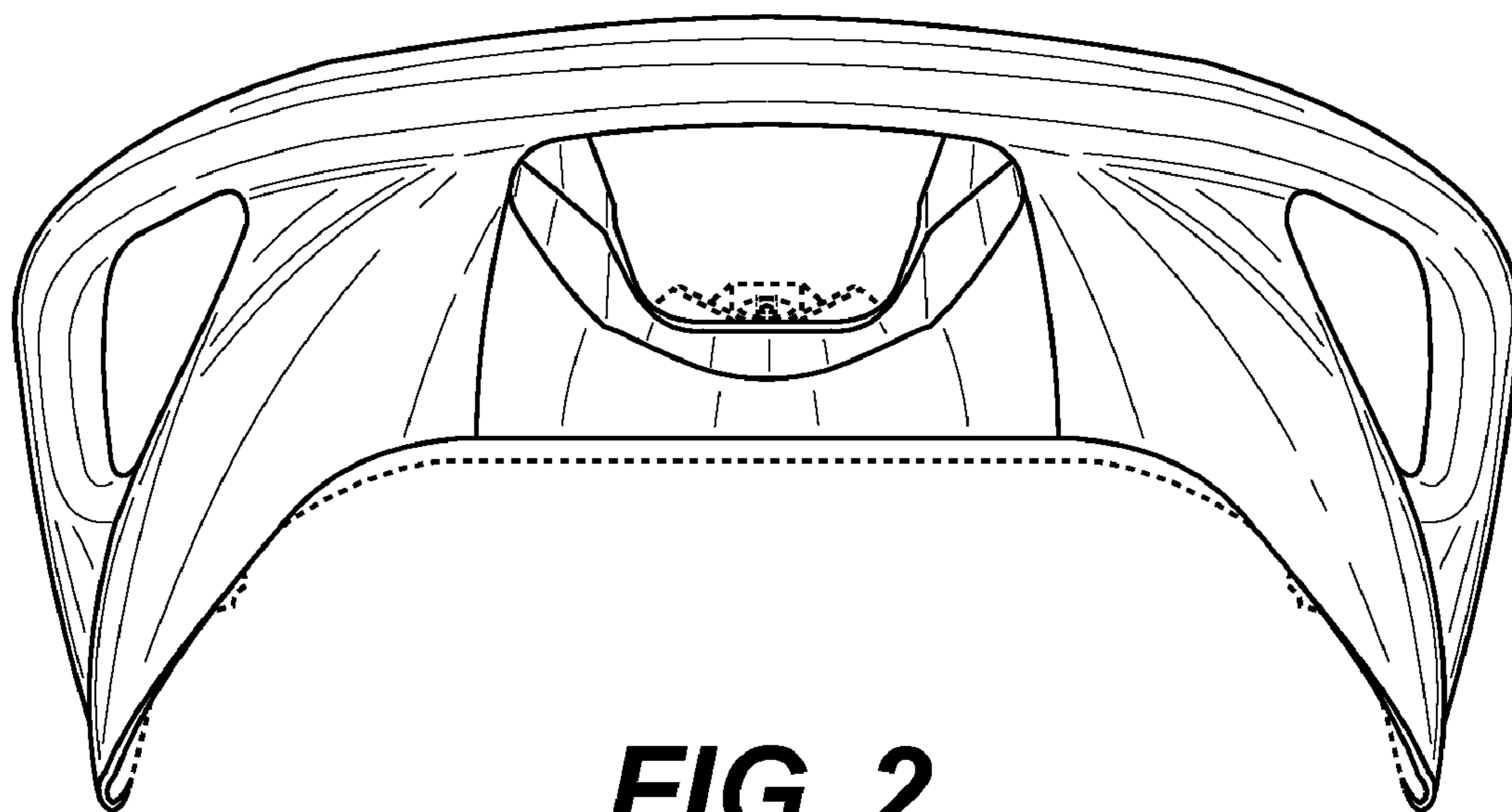

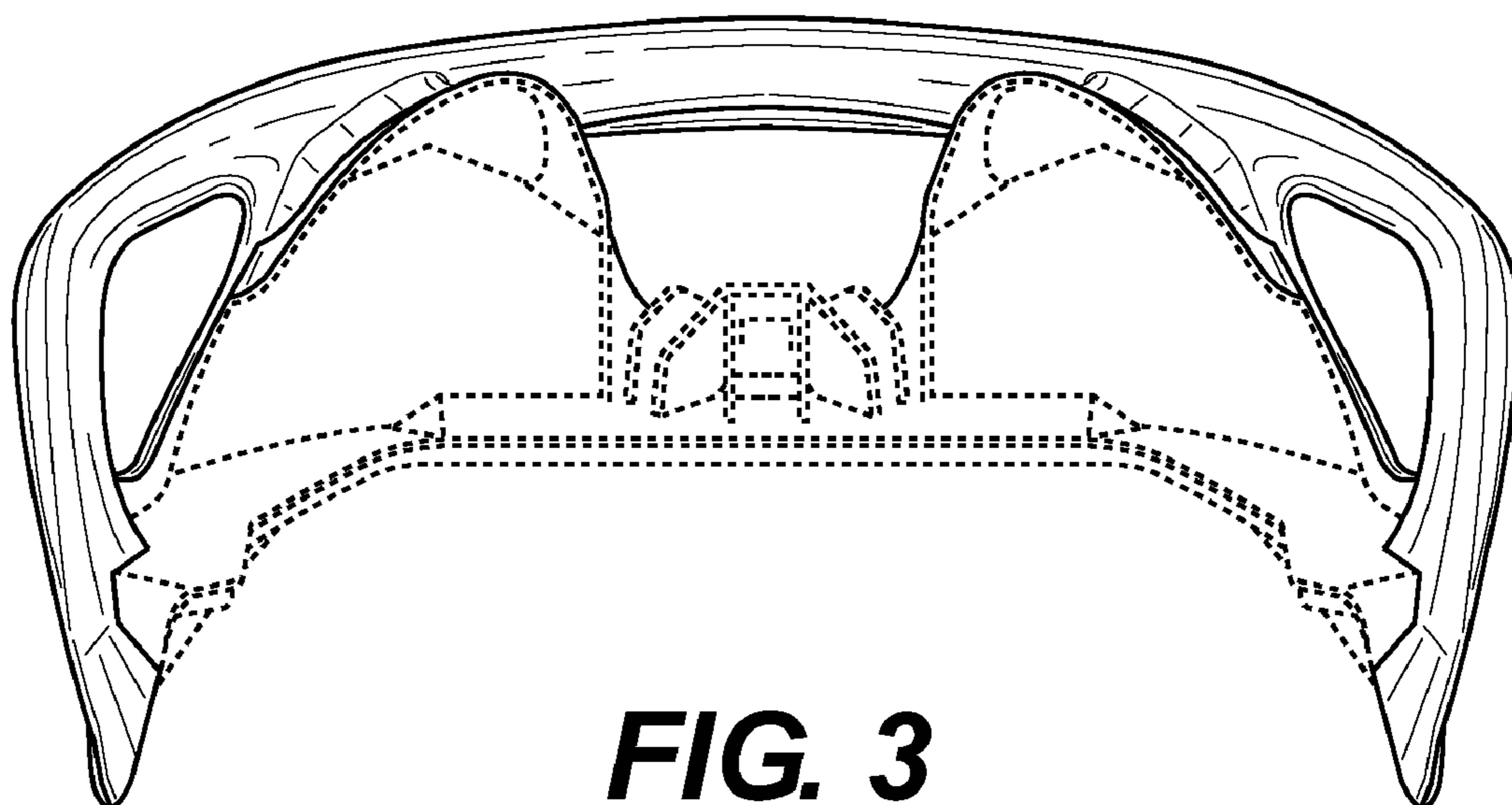

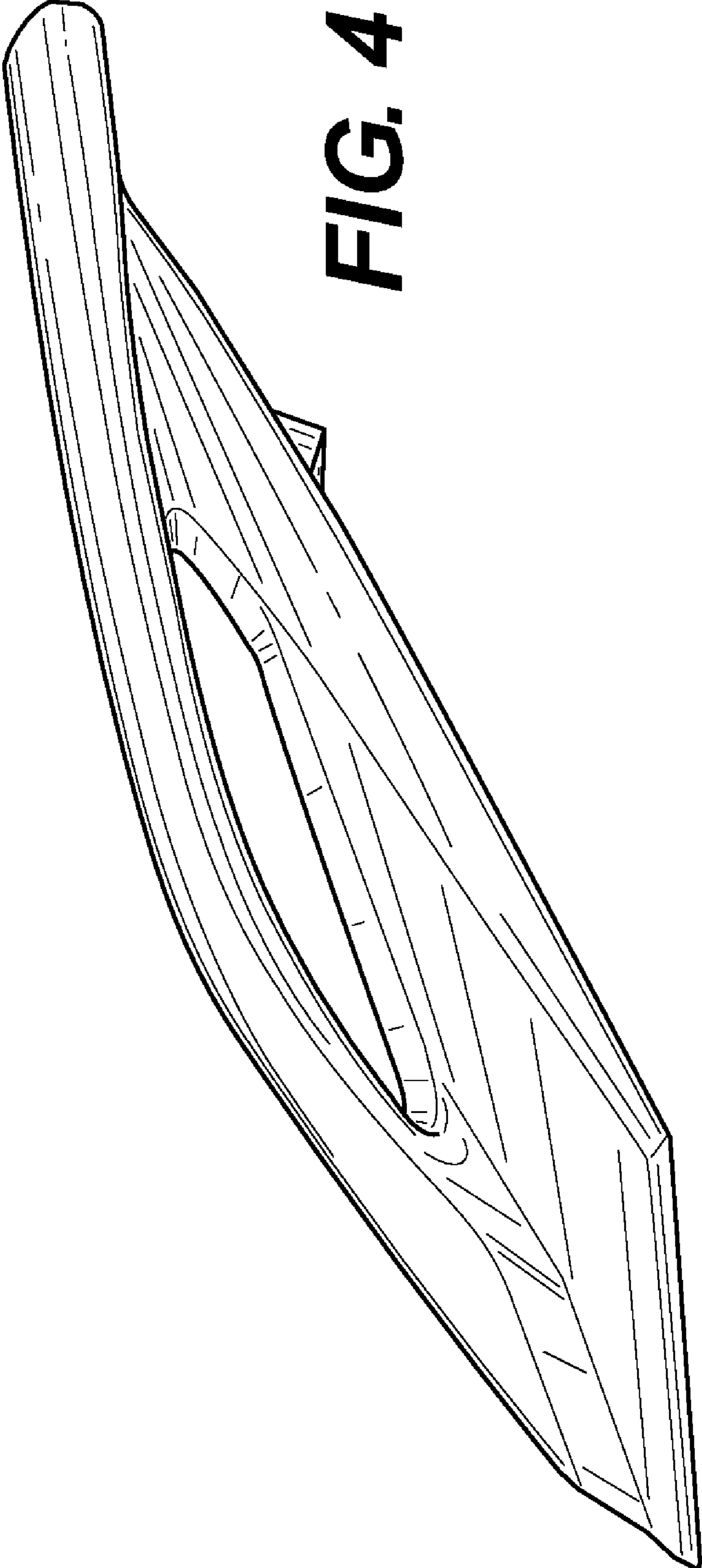

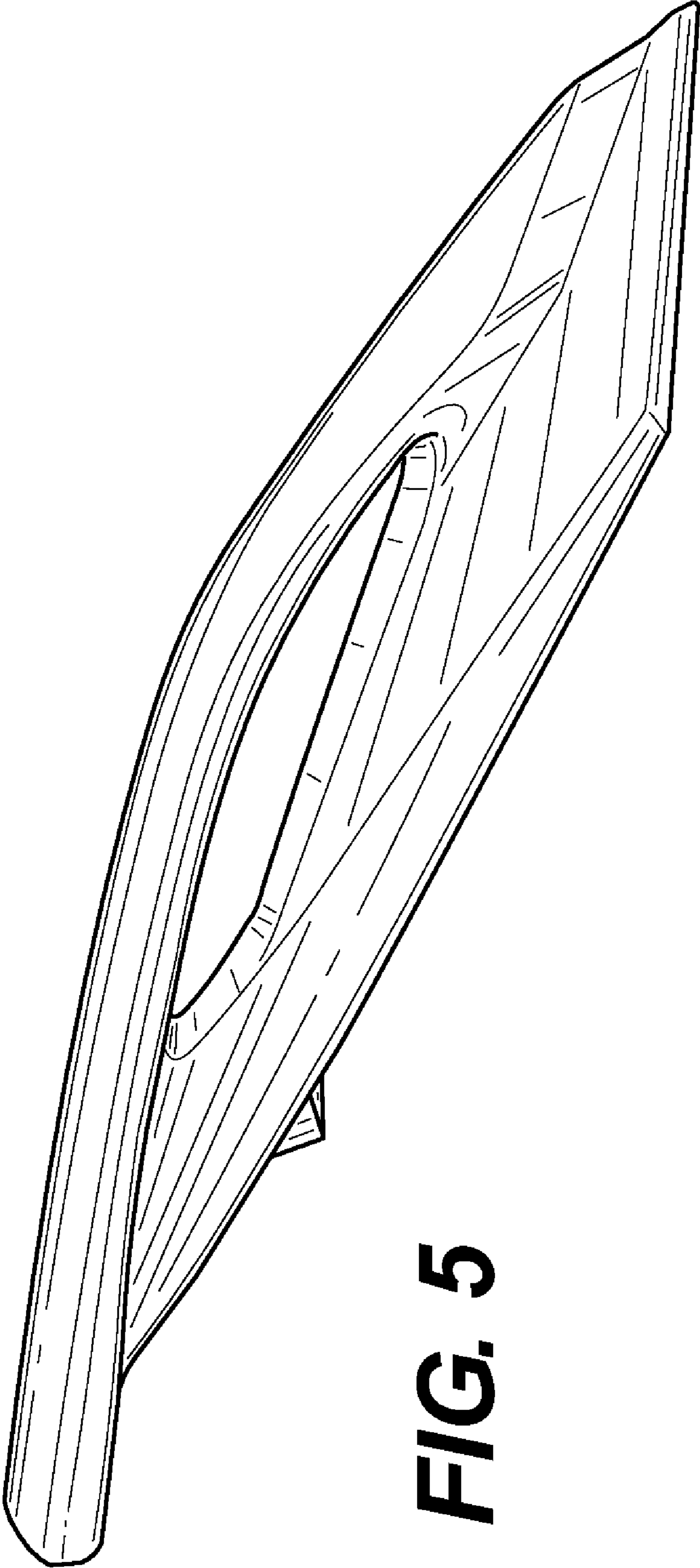

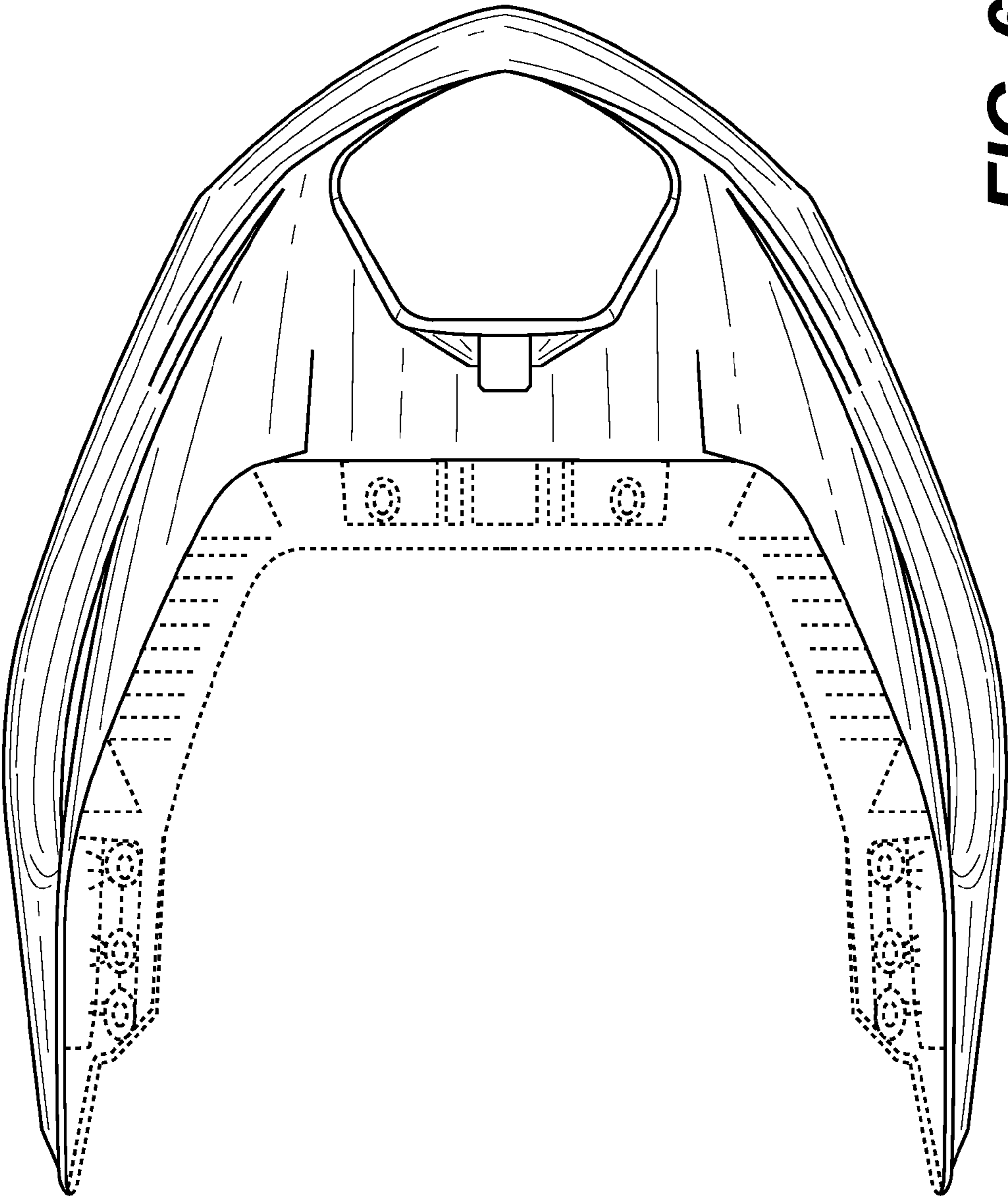

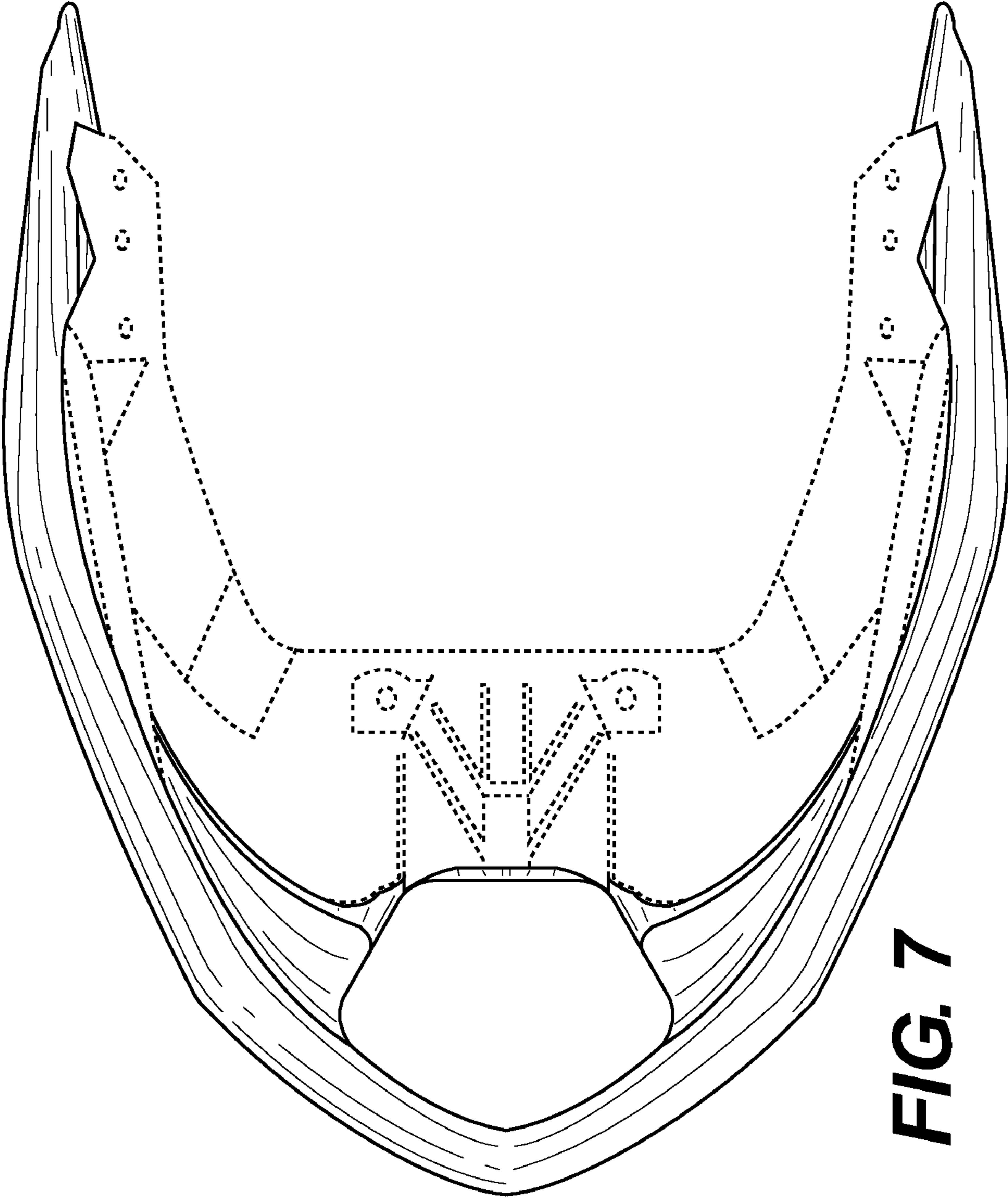

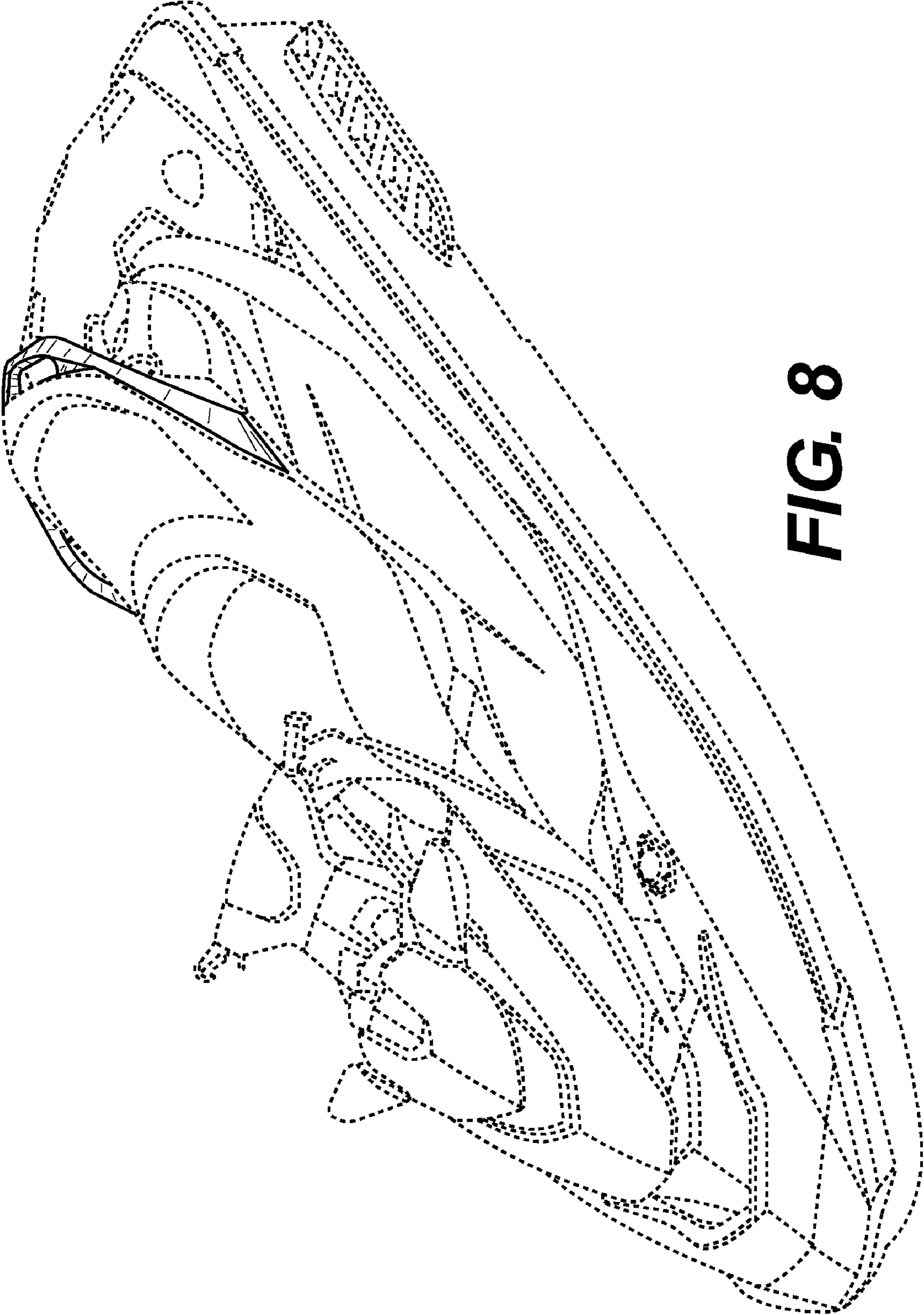

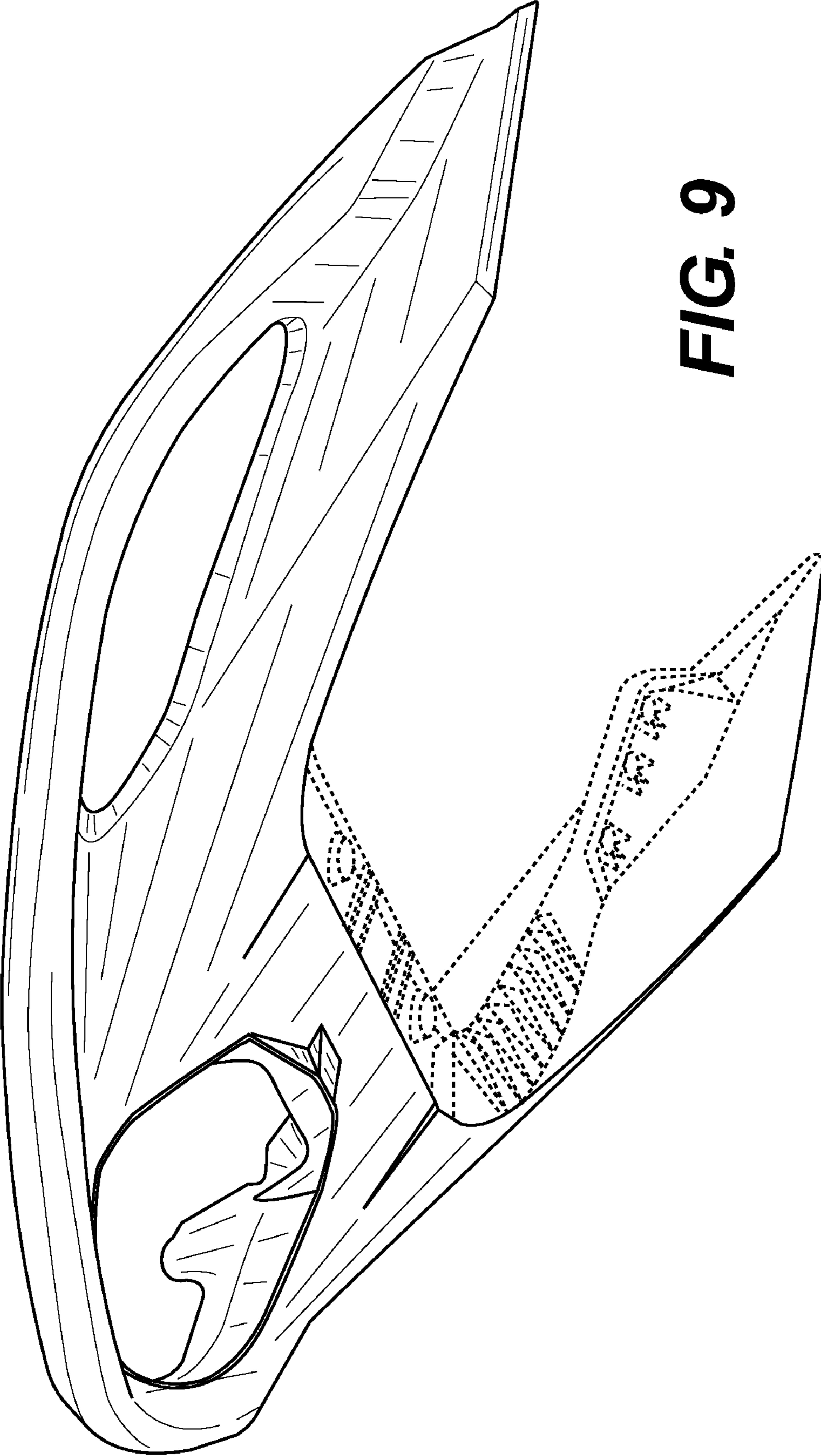

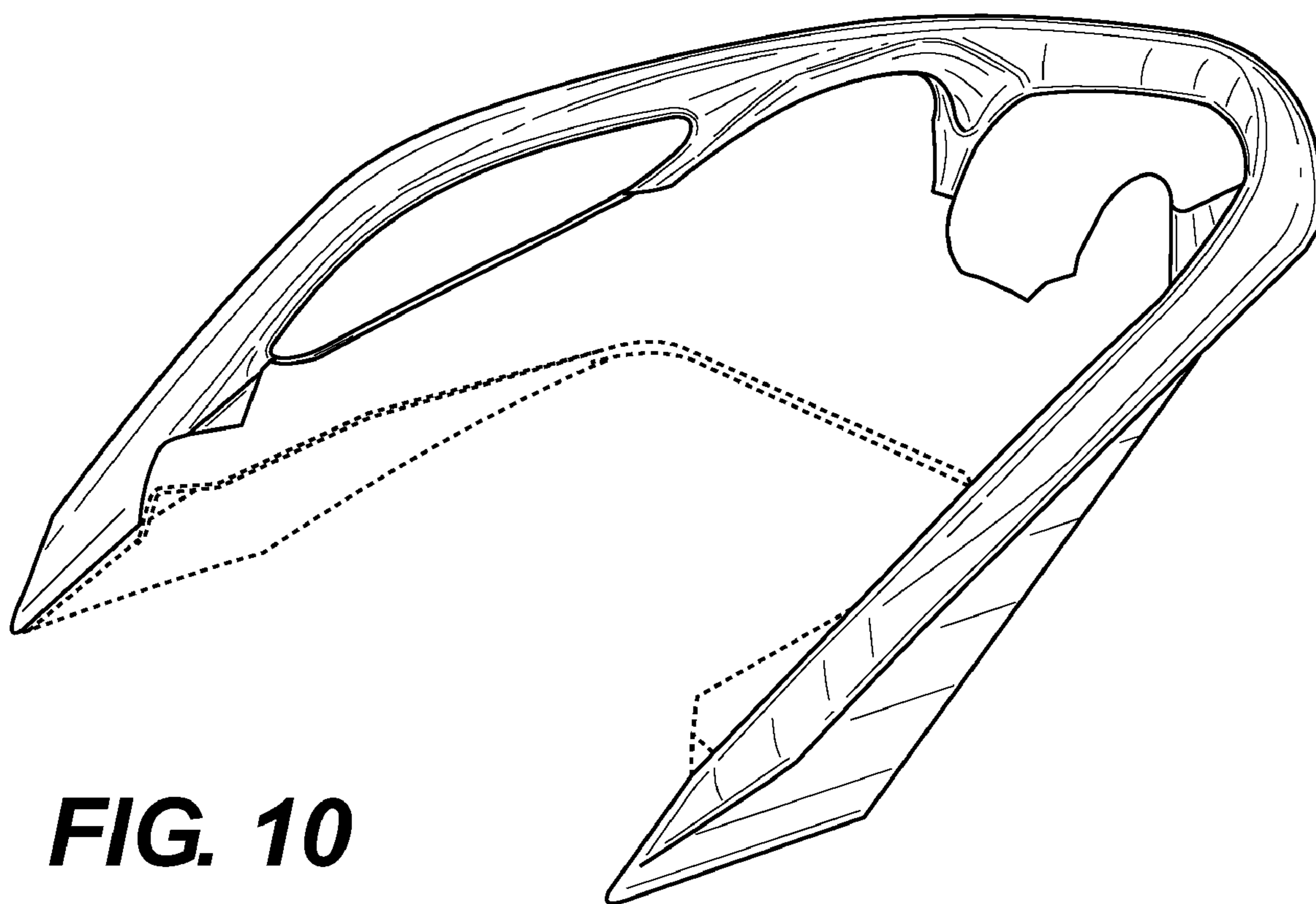

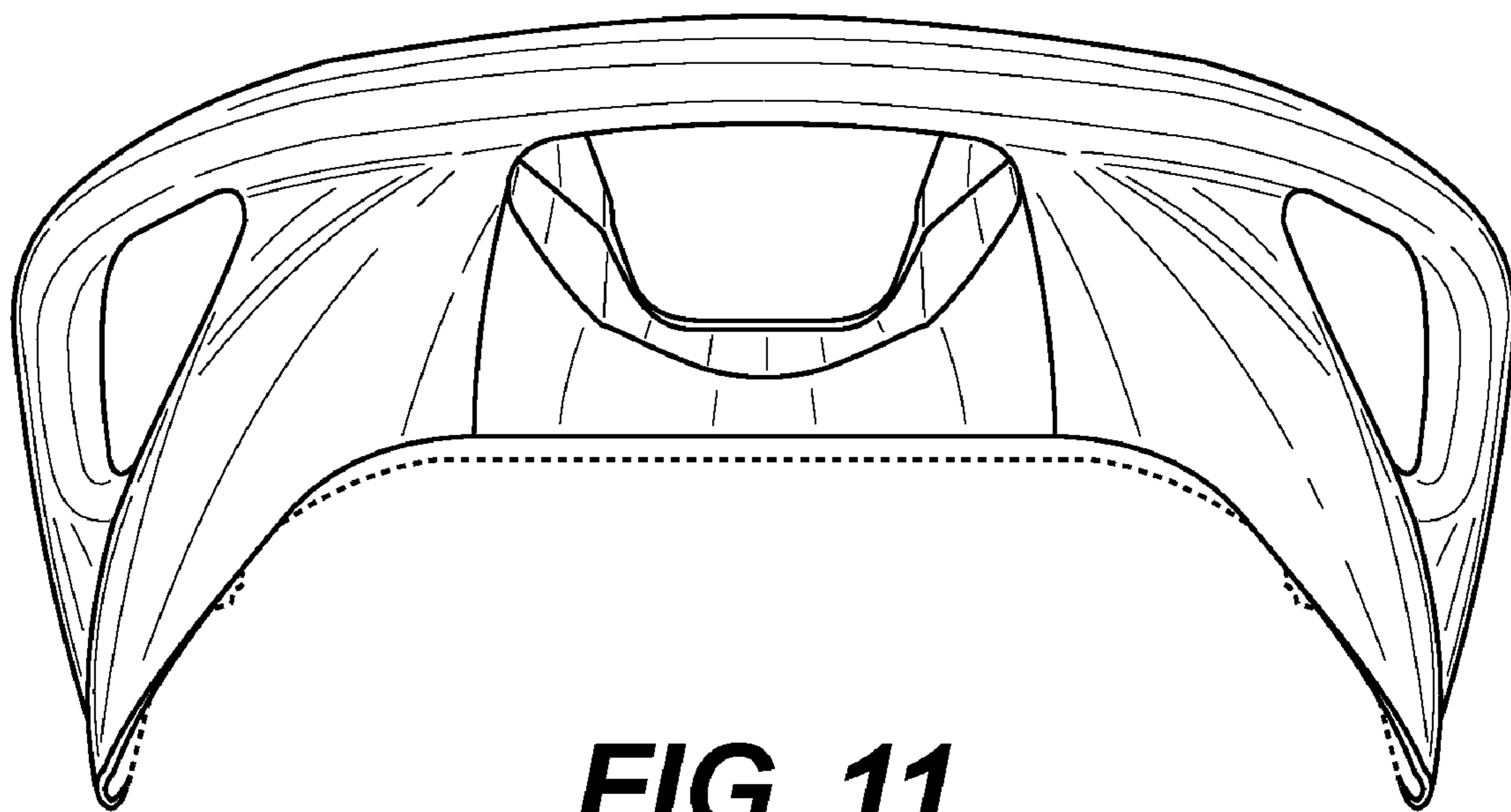

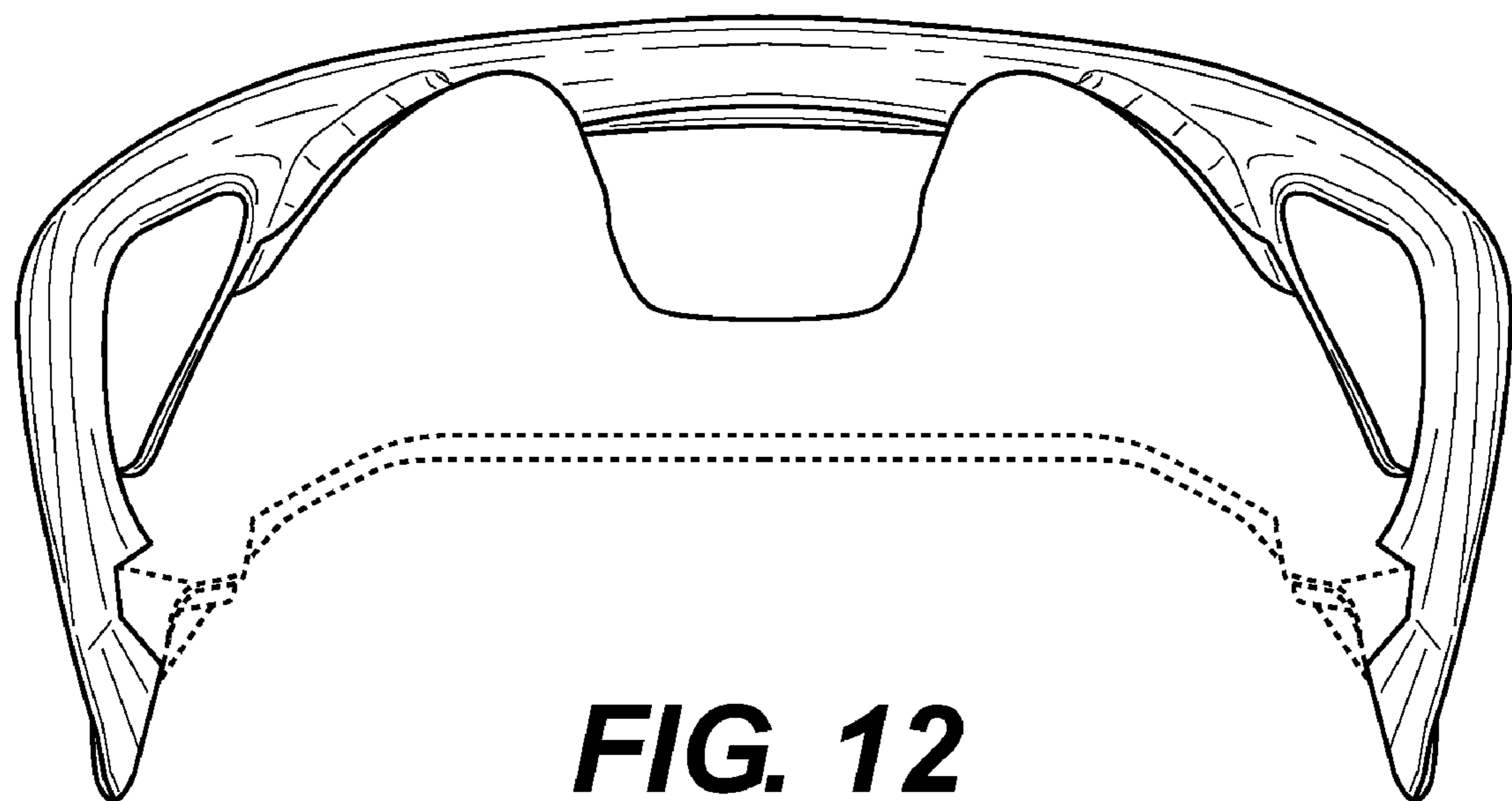

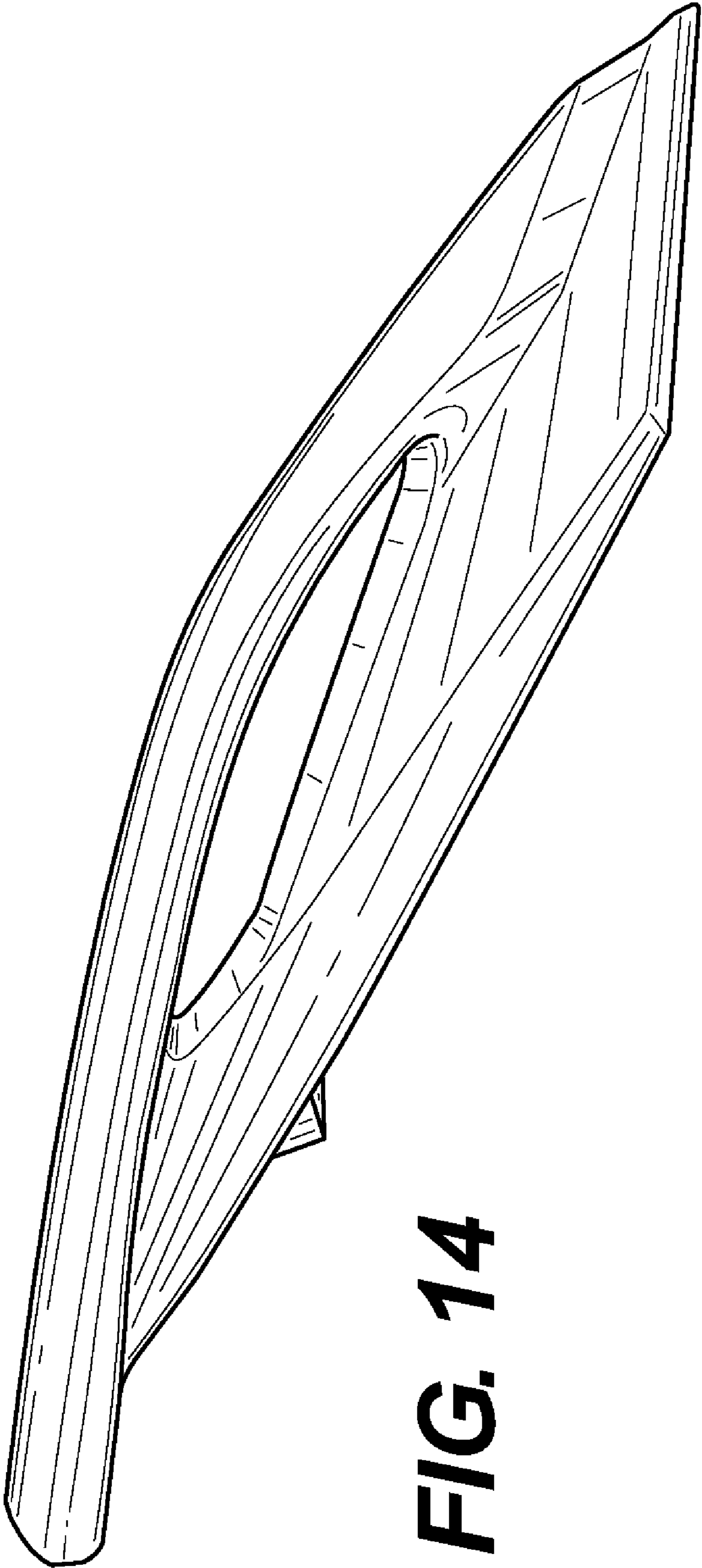

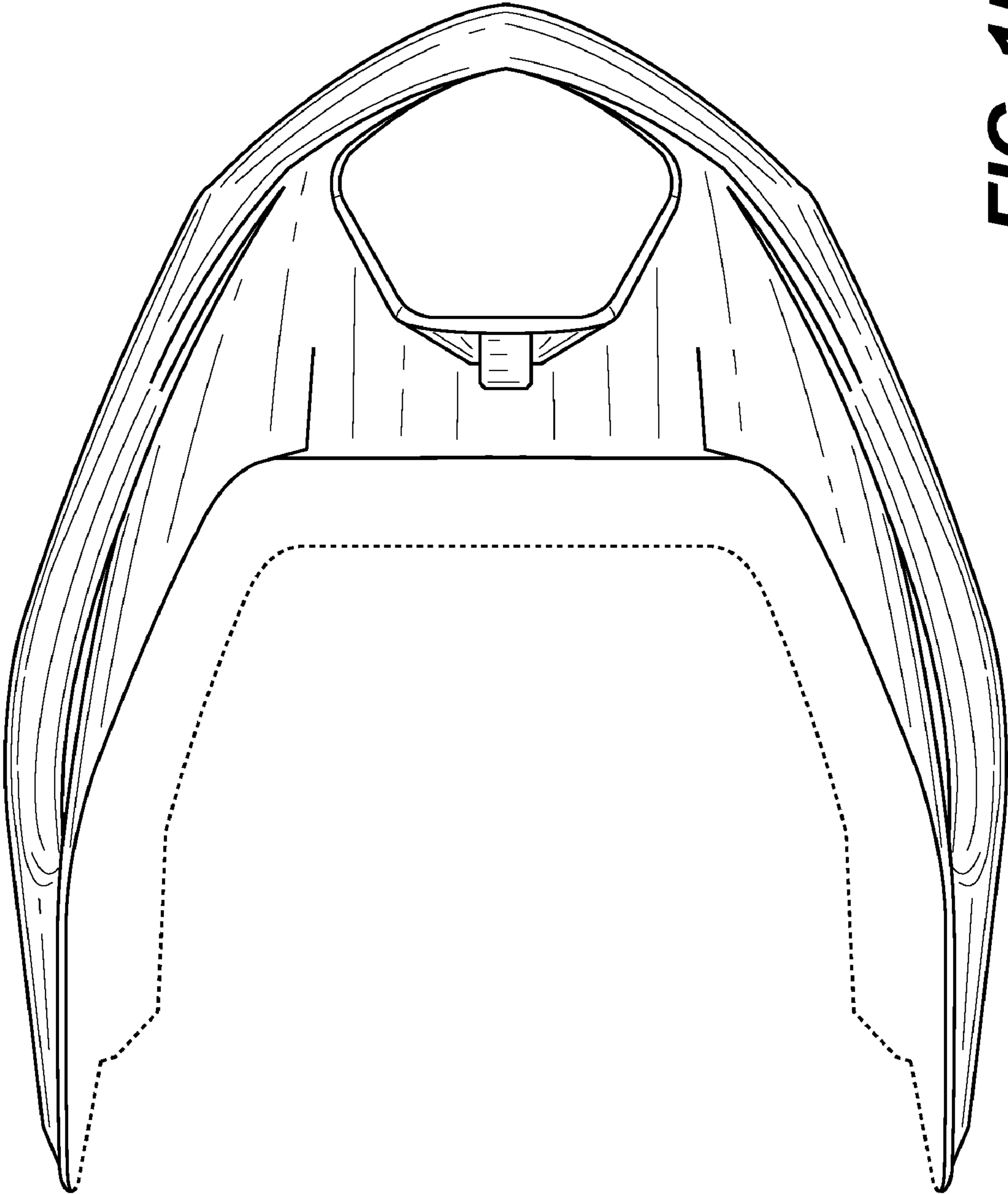

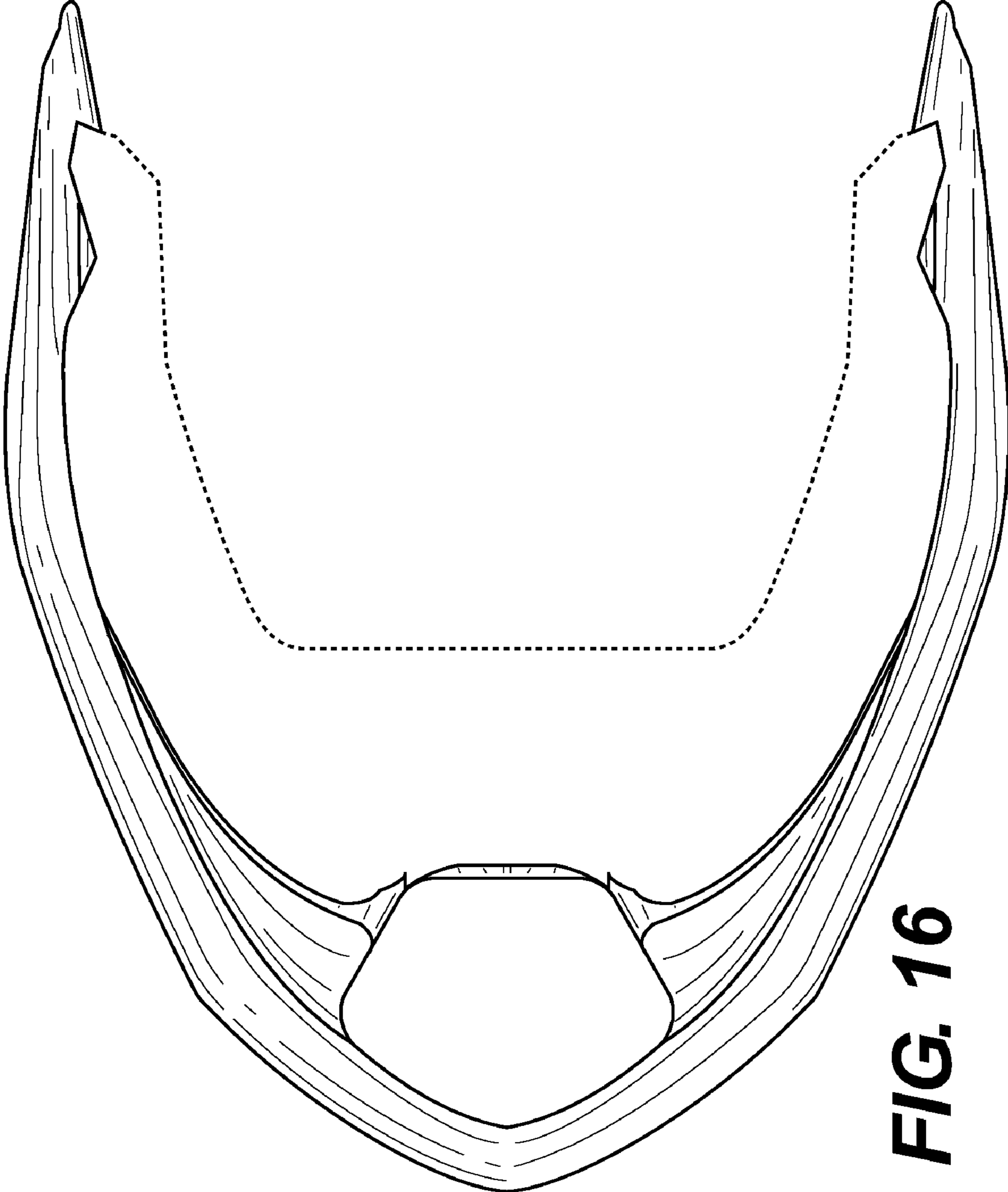

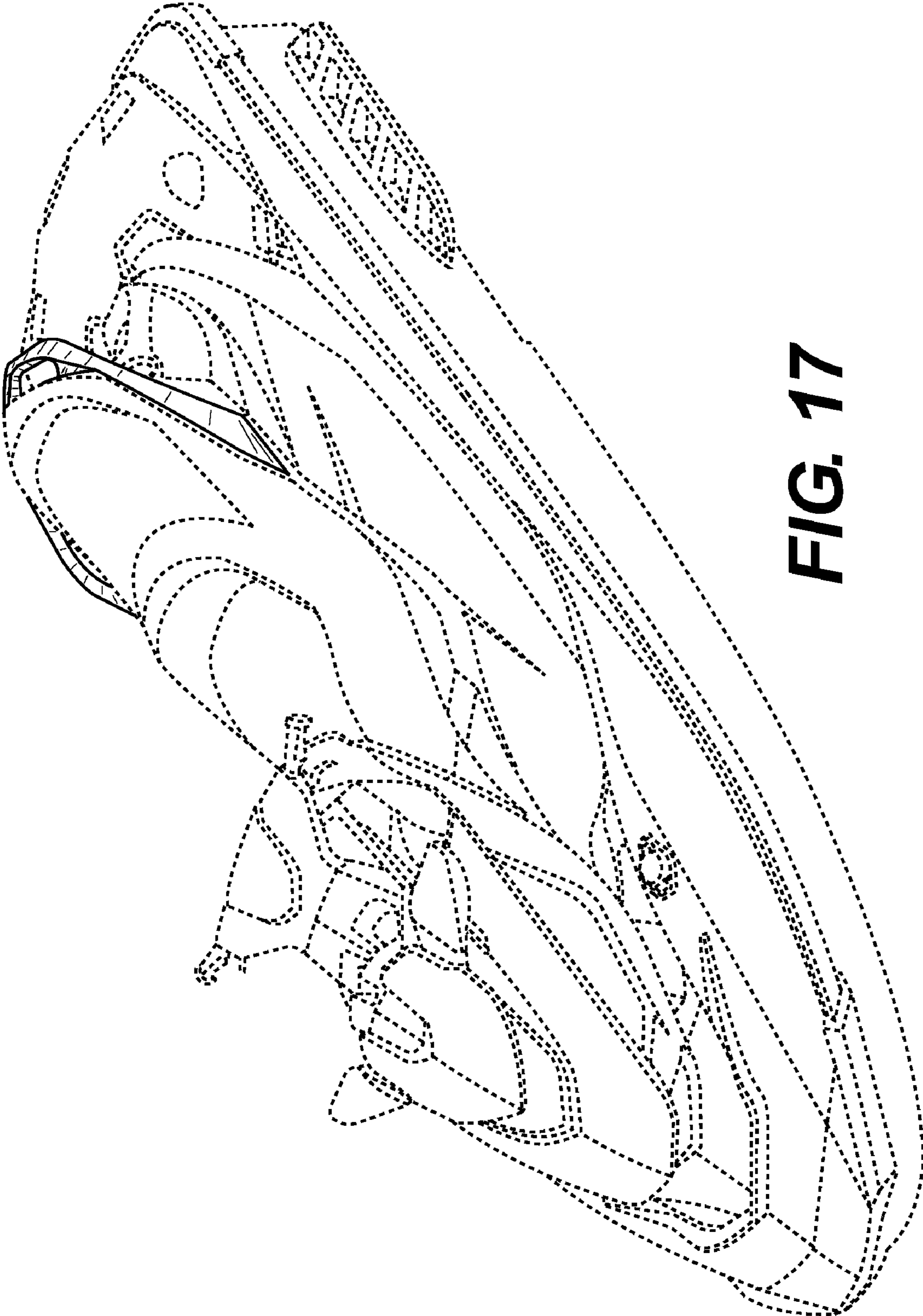

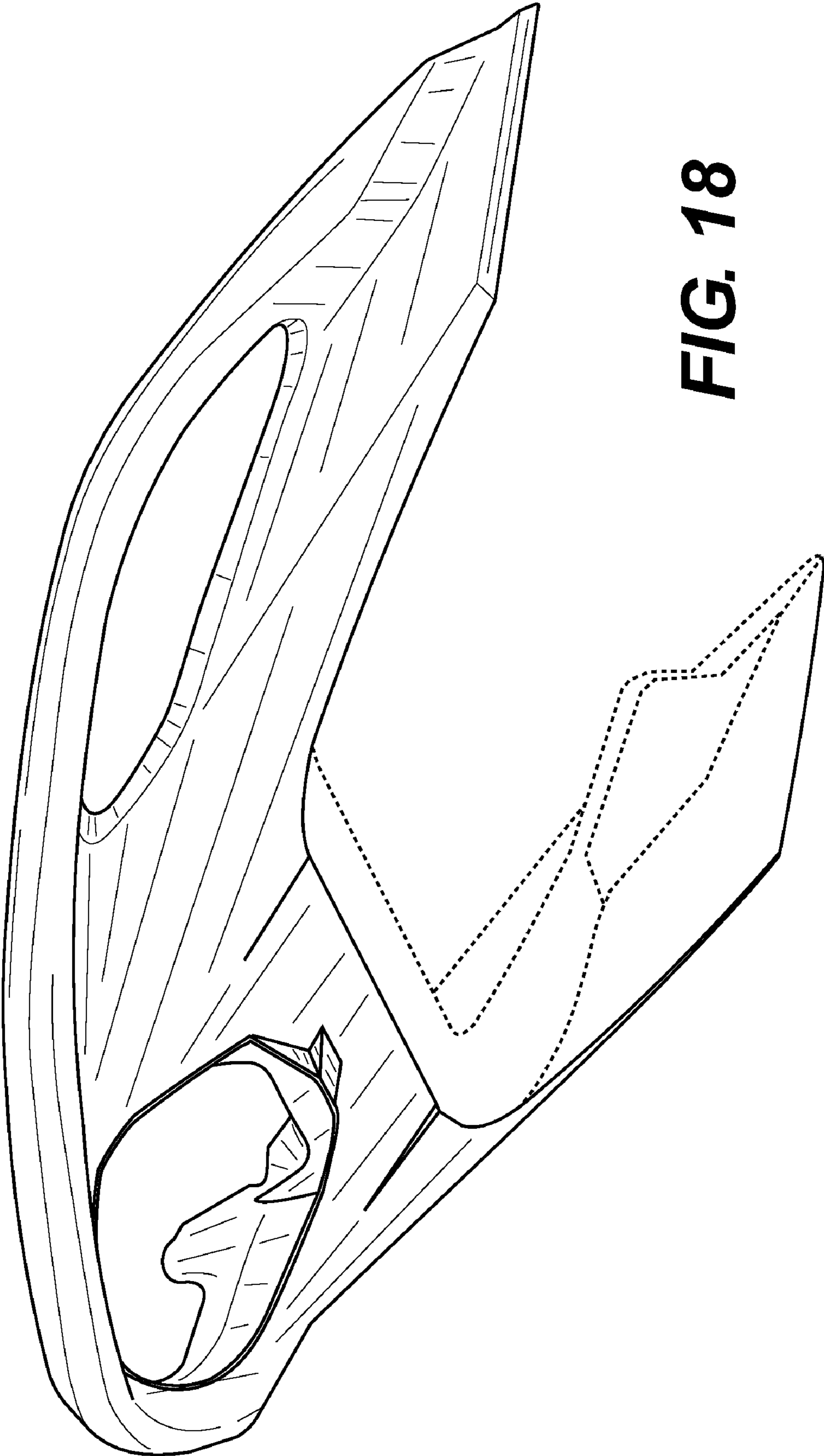
