(57) **CLAIM**

I claim the ornamental design for the inflatable toy hammer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the inflatable toy hammer of my new design;

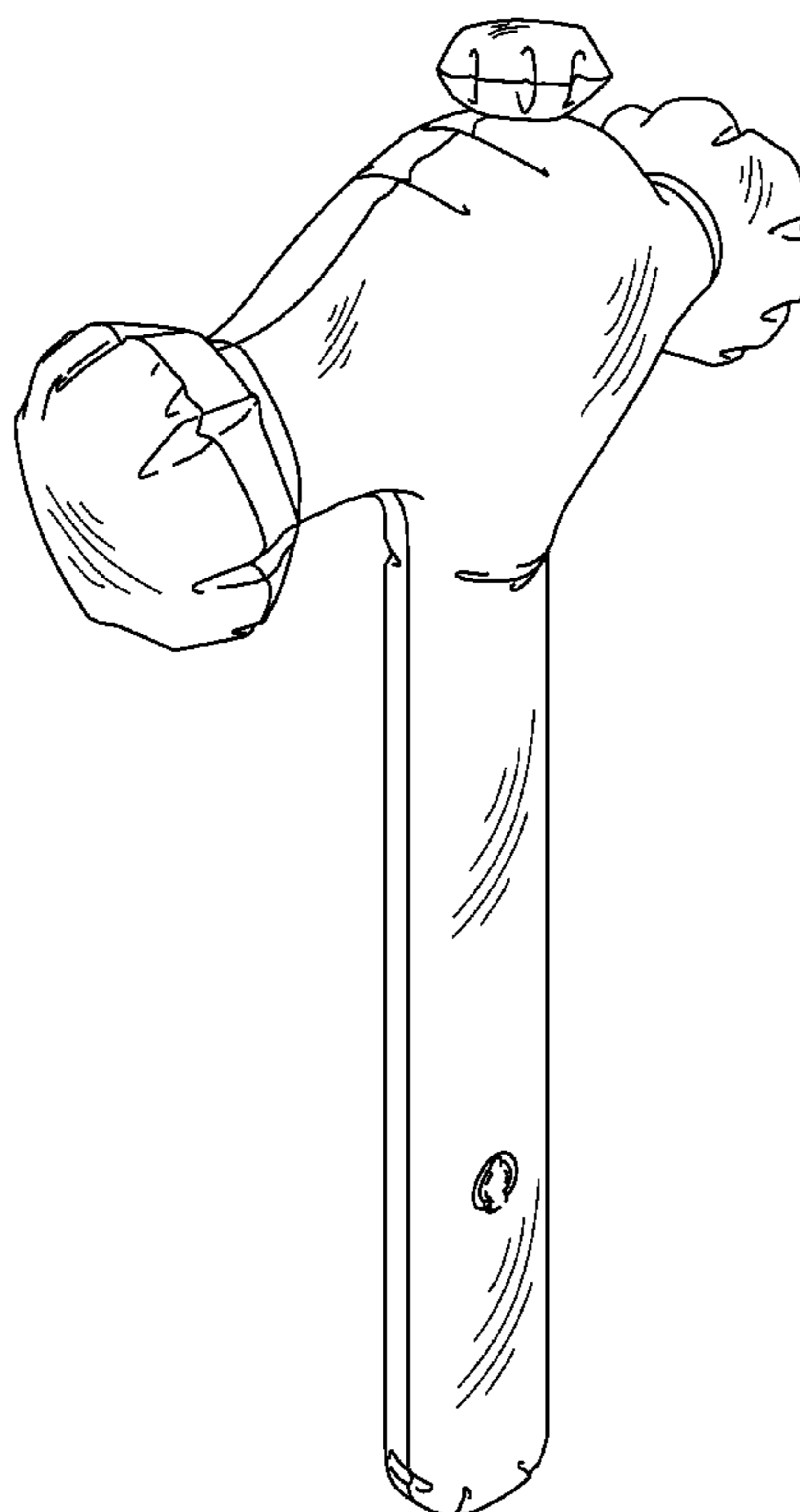

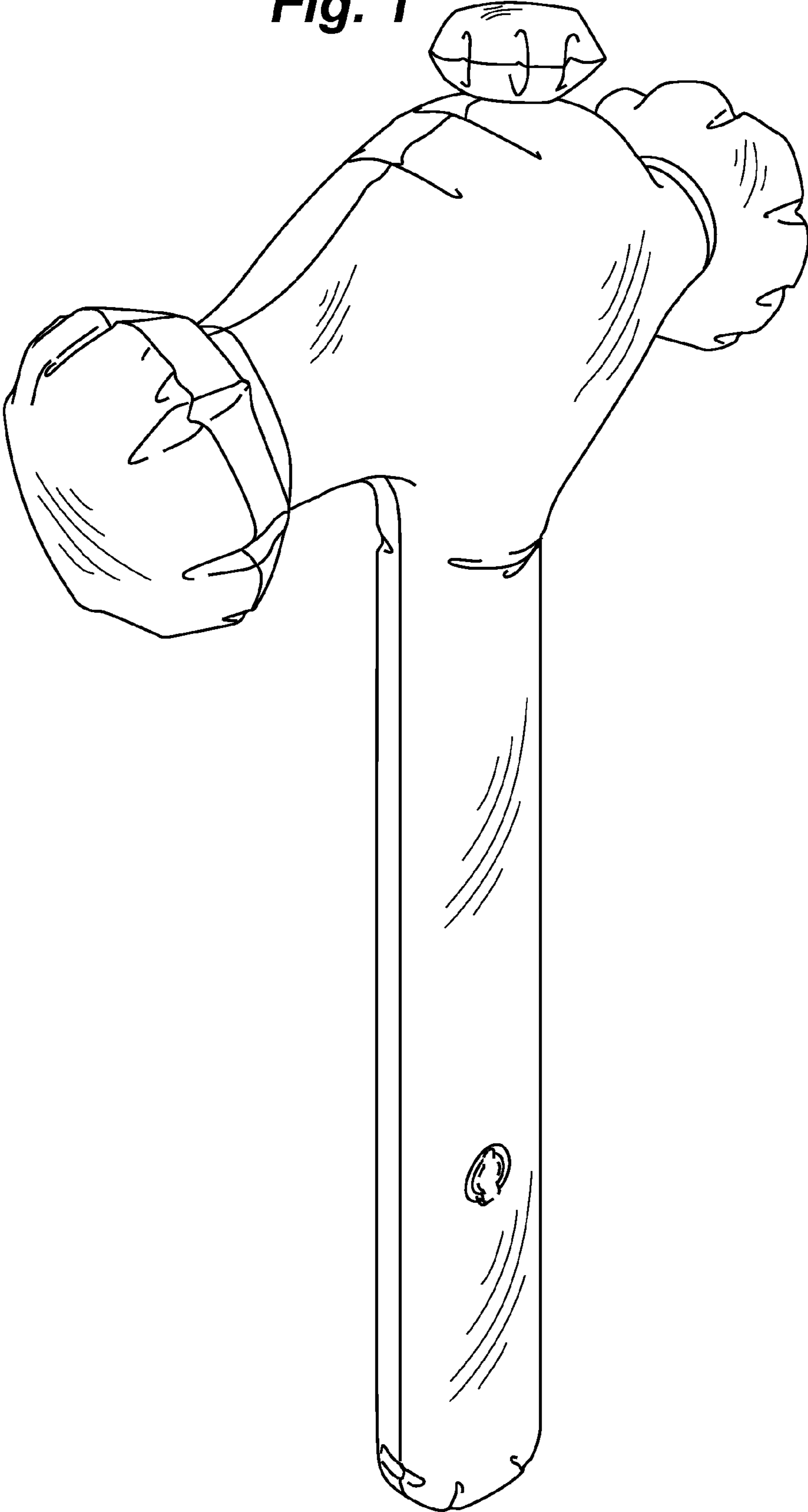

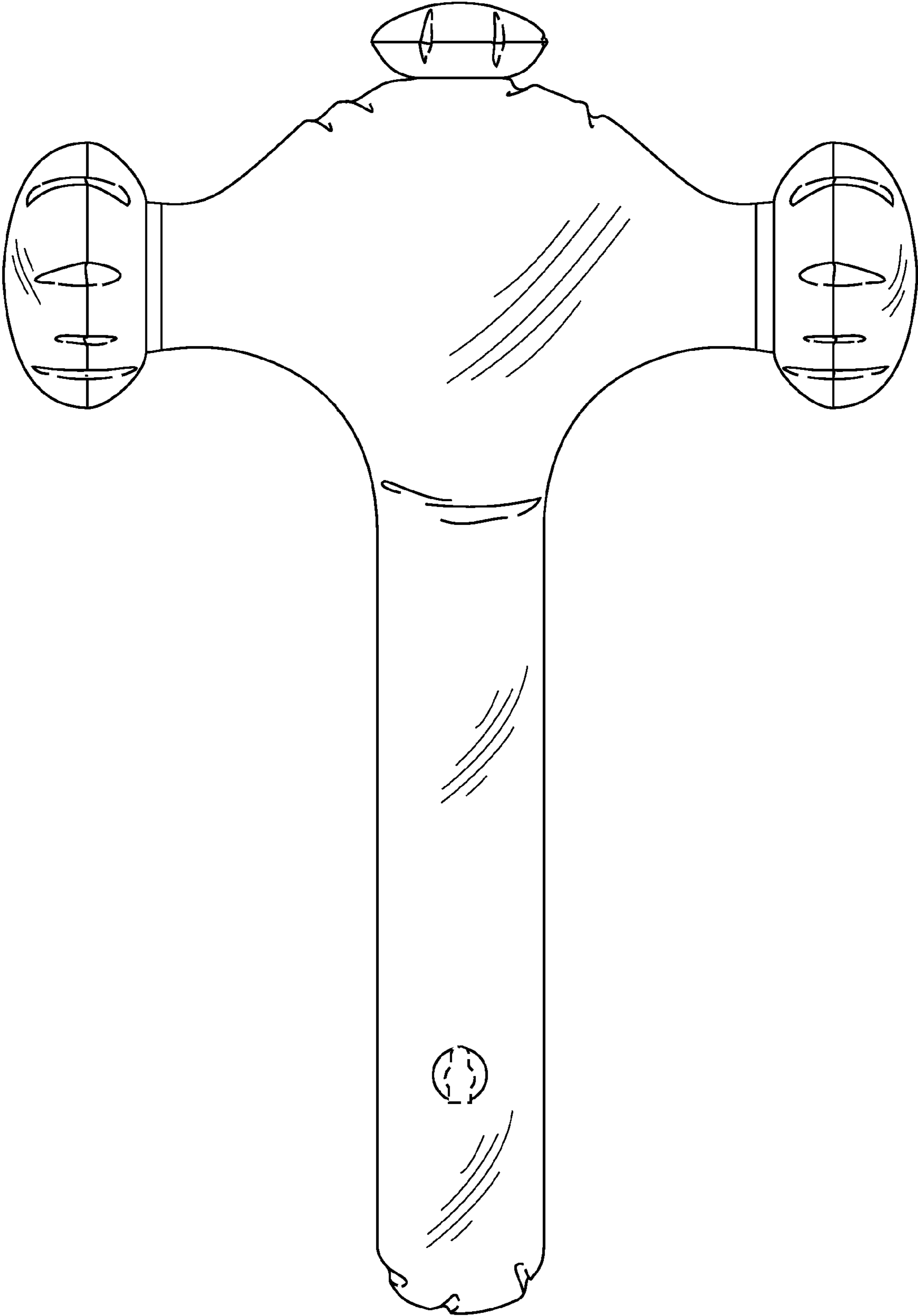

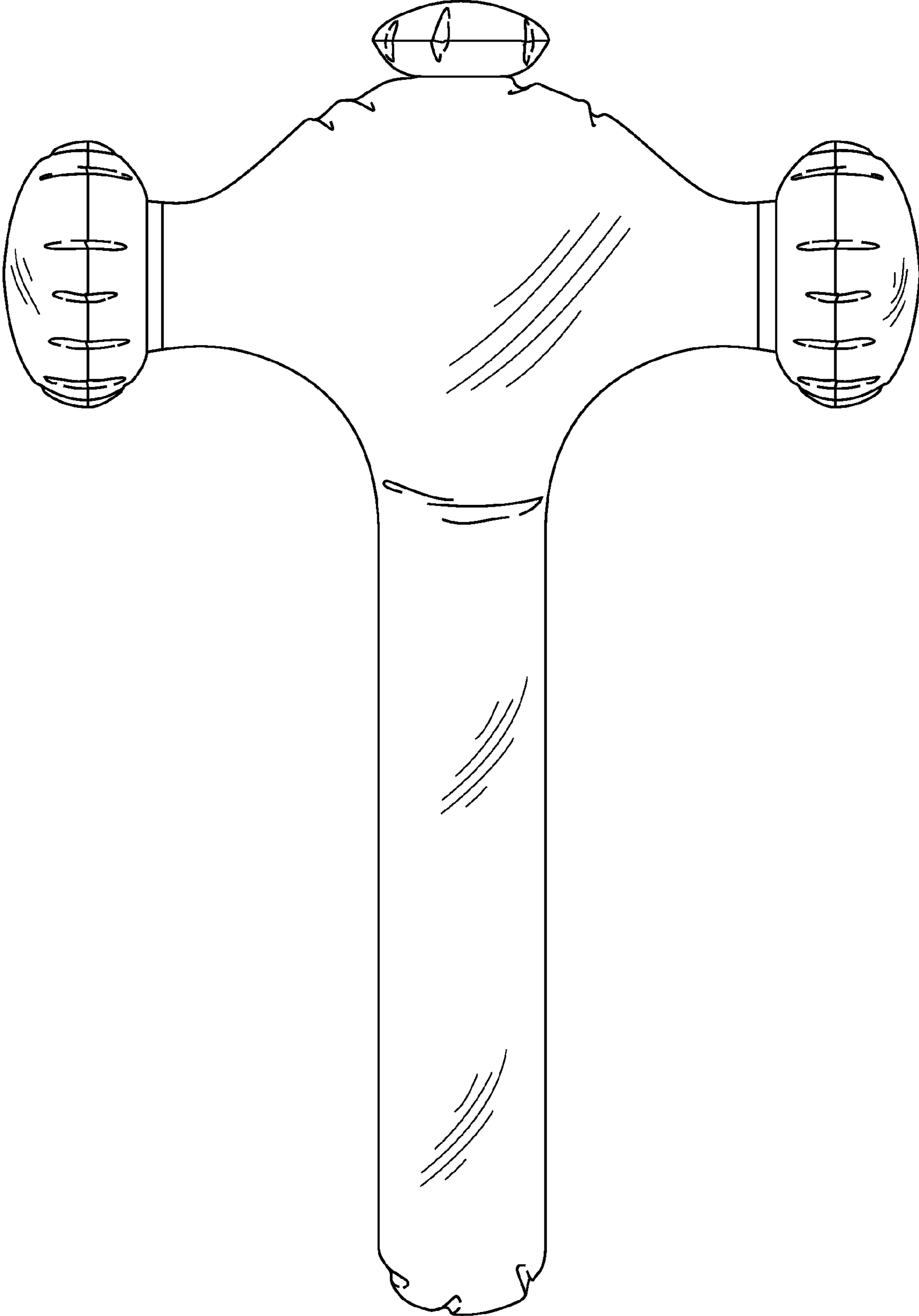

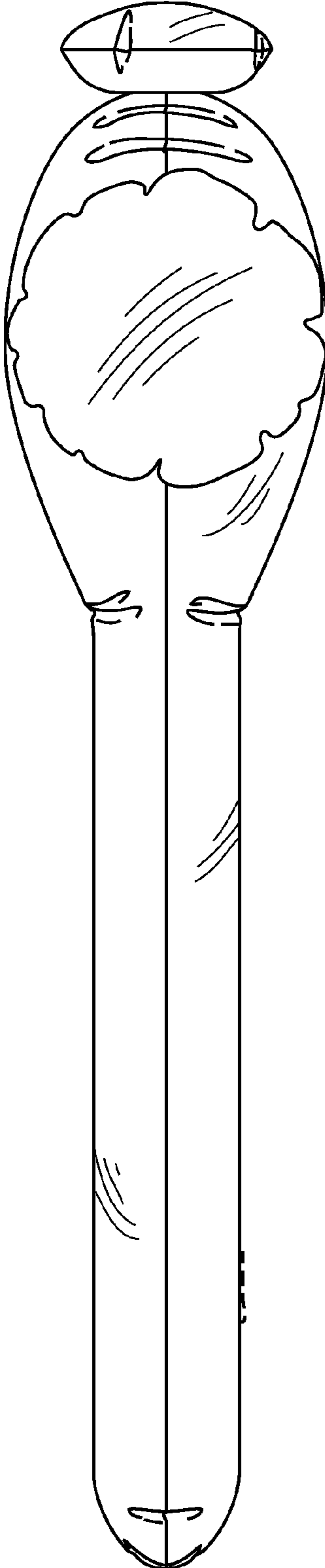

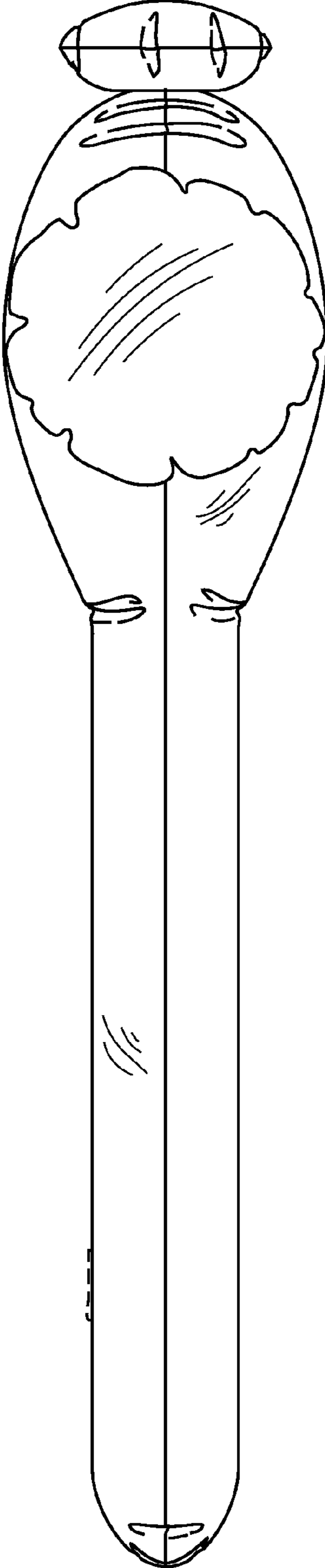

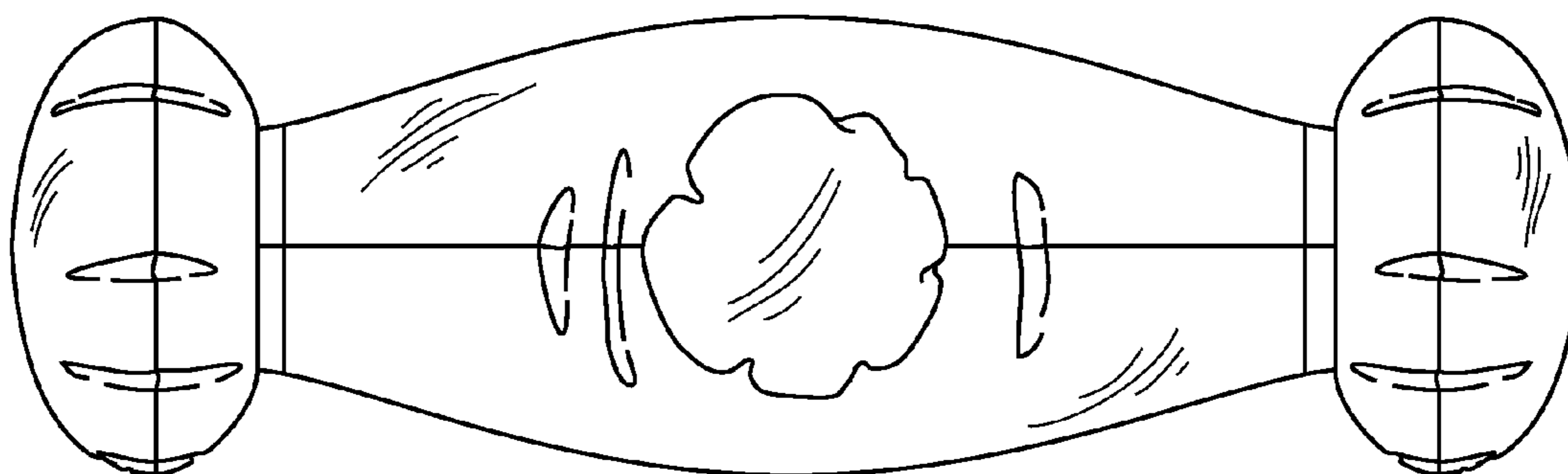
