FIG. 1 is a perspective view of the handlebar cover, showing my new design;

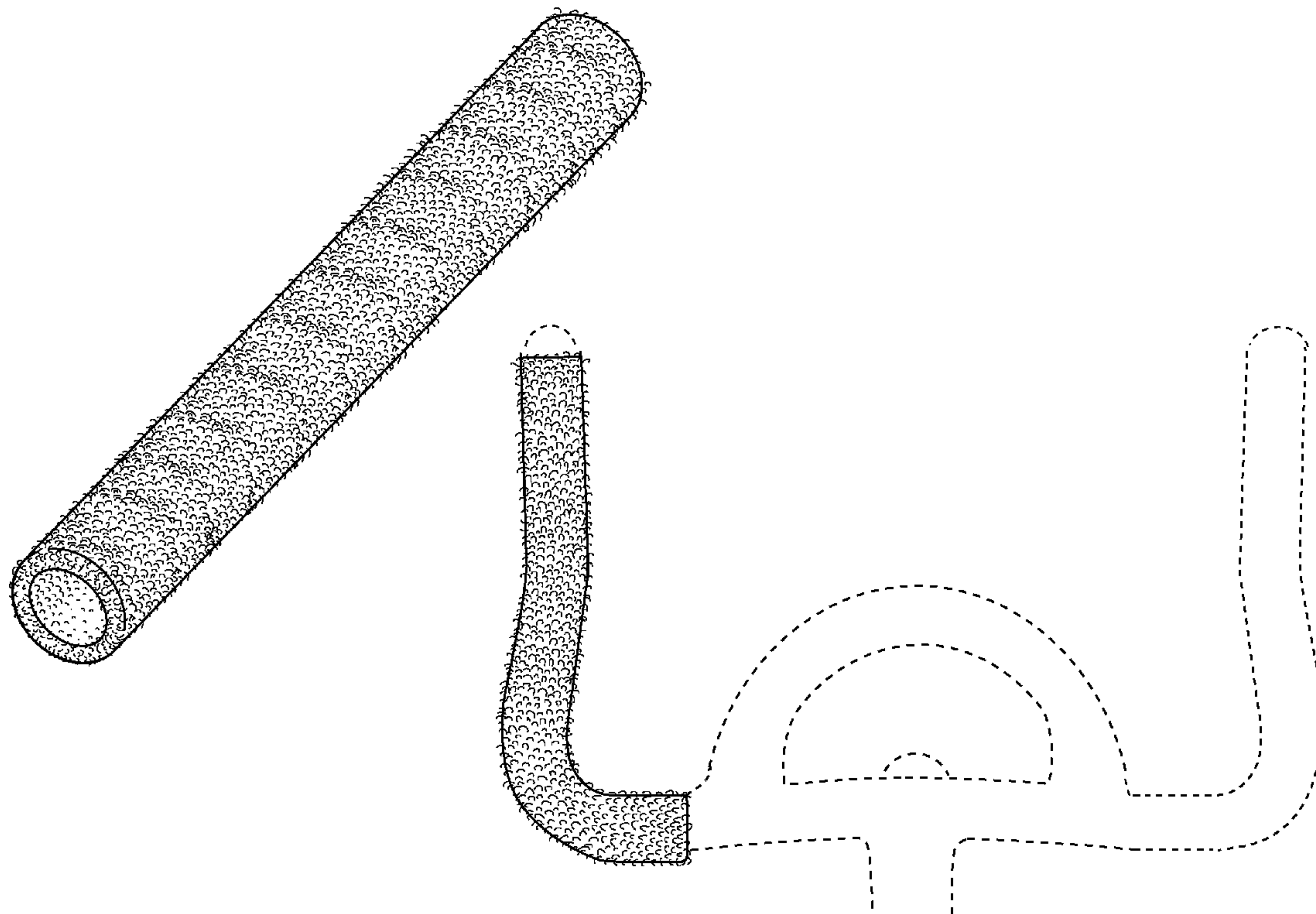
FIG. 2 is a side elevational view thereof;

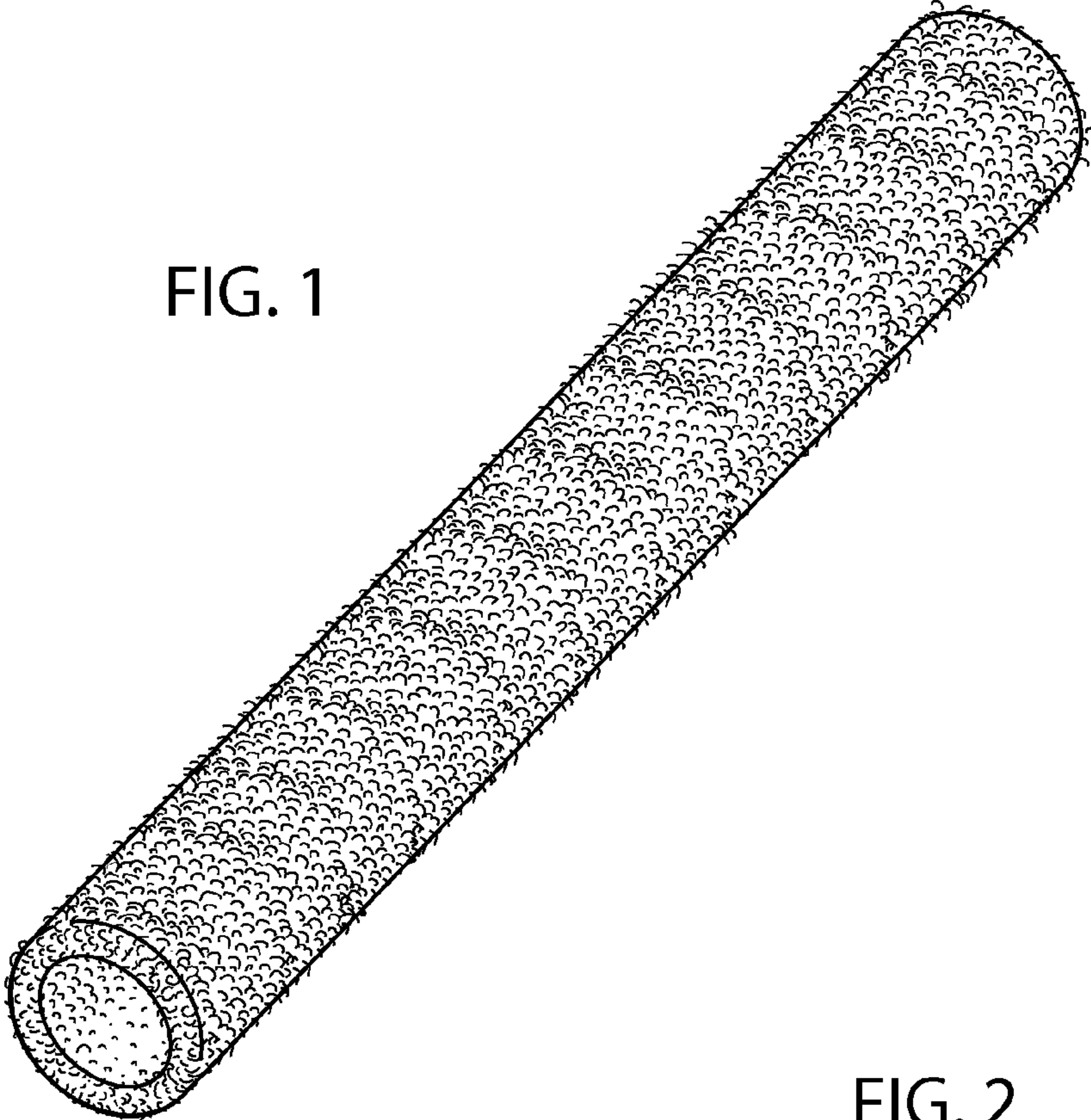

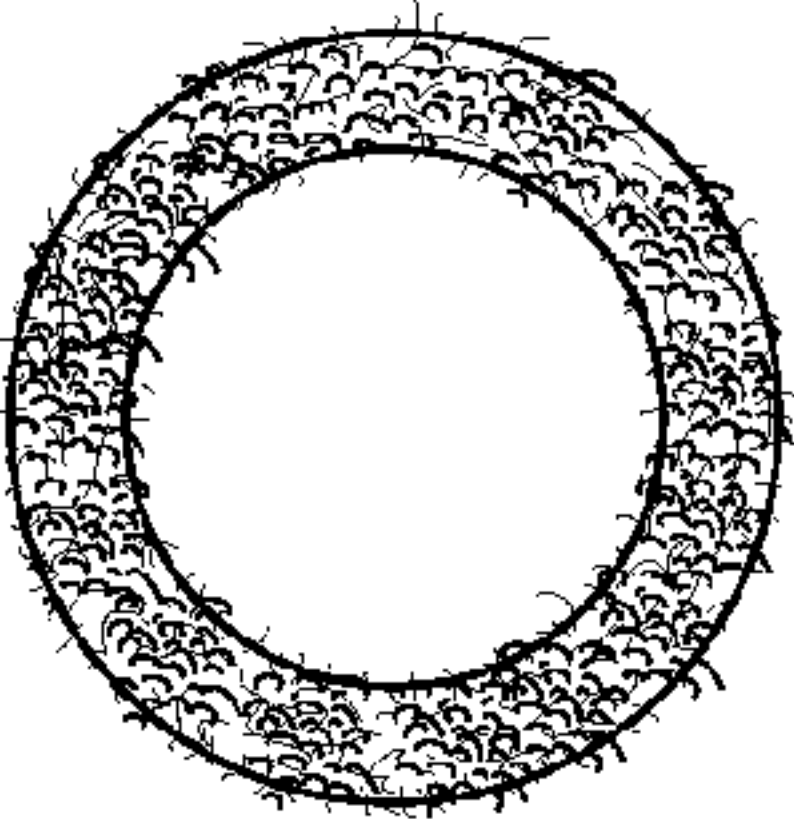
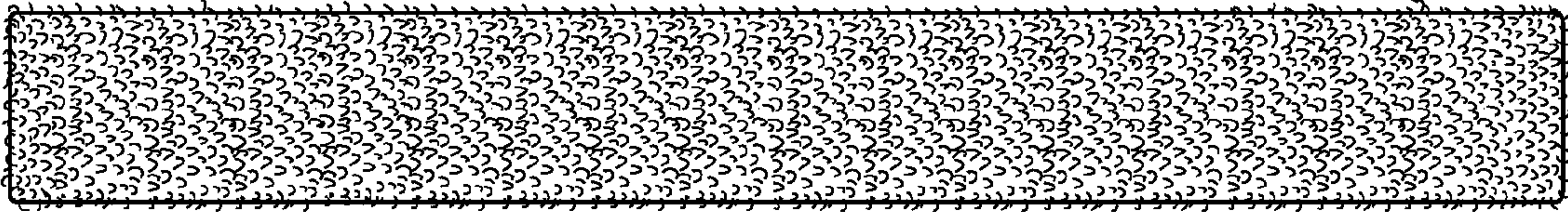

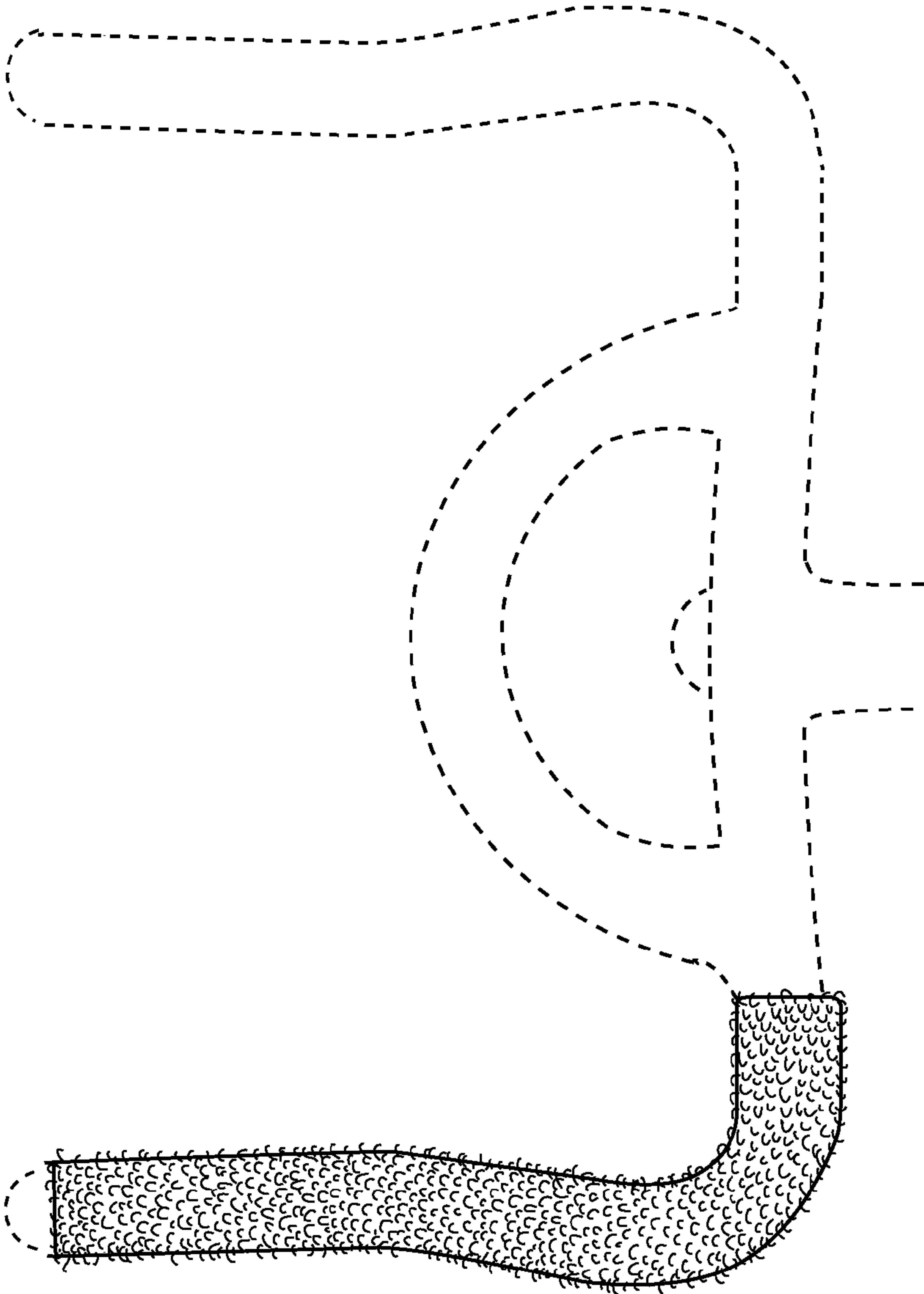
