(57) **CLAIM**

The ornamental design for an alignment golf ball marker, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the alignment golf ball marker;

FIG. 2 is a top plan view of a second embodiment of the alignment golf ball marker;

FIG. 3 is a top view of FIG. 1;

FIG. 4 is a side view of FIG. 1, all other undisclosed sides being identical; and

FIG. 5 is a side view of a third embodiment of the golf ball marker of FIG. 1 all other undisclosed sides being identical; and,

FIG. 6 is a perspective view of FIG. 5. All undisclosed sides of the second and third embodiments are indential to the first embodiment.

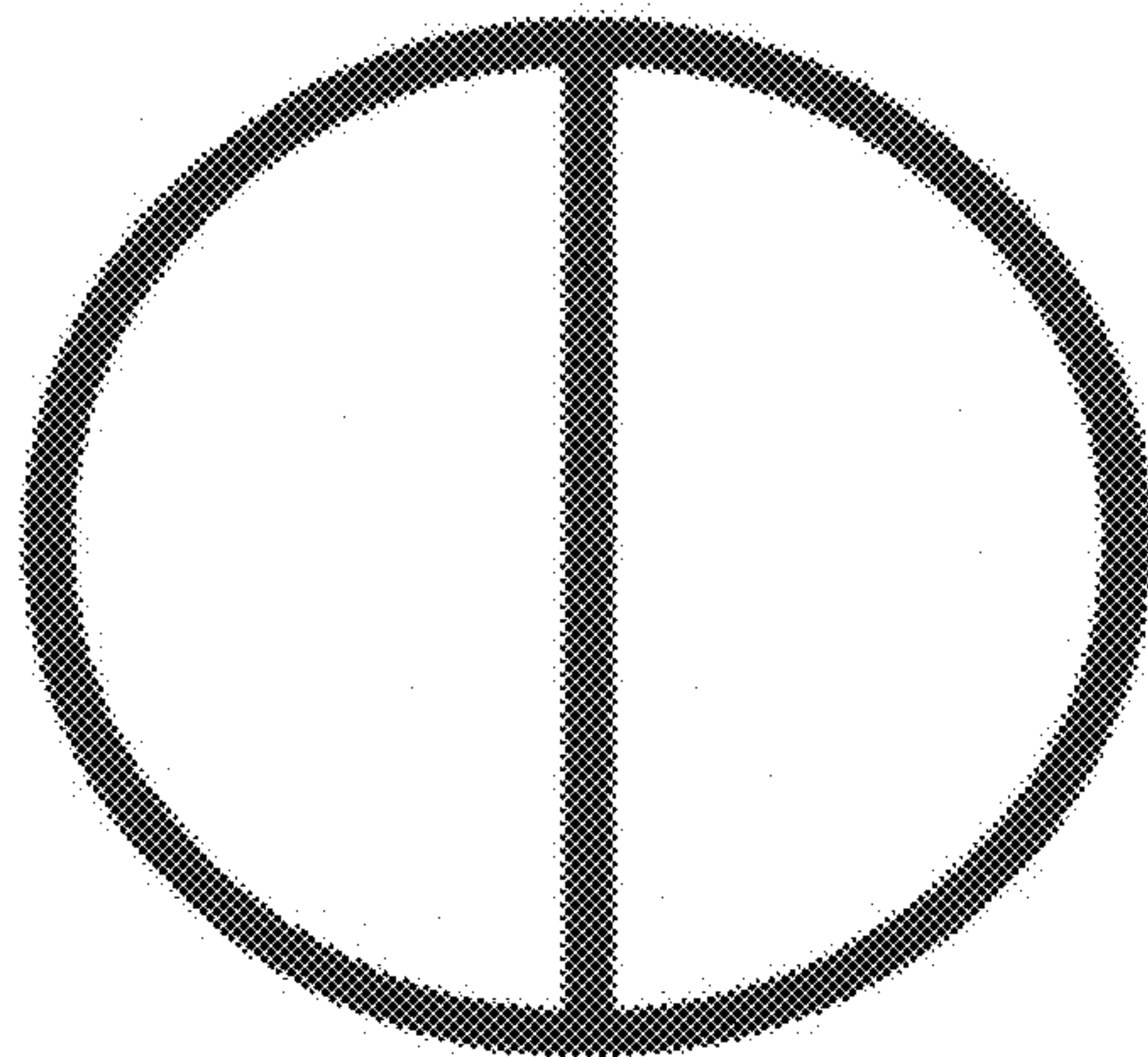

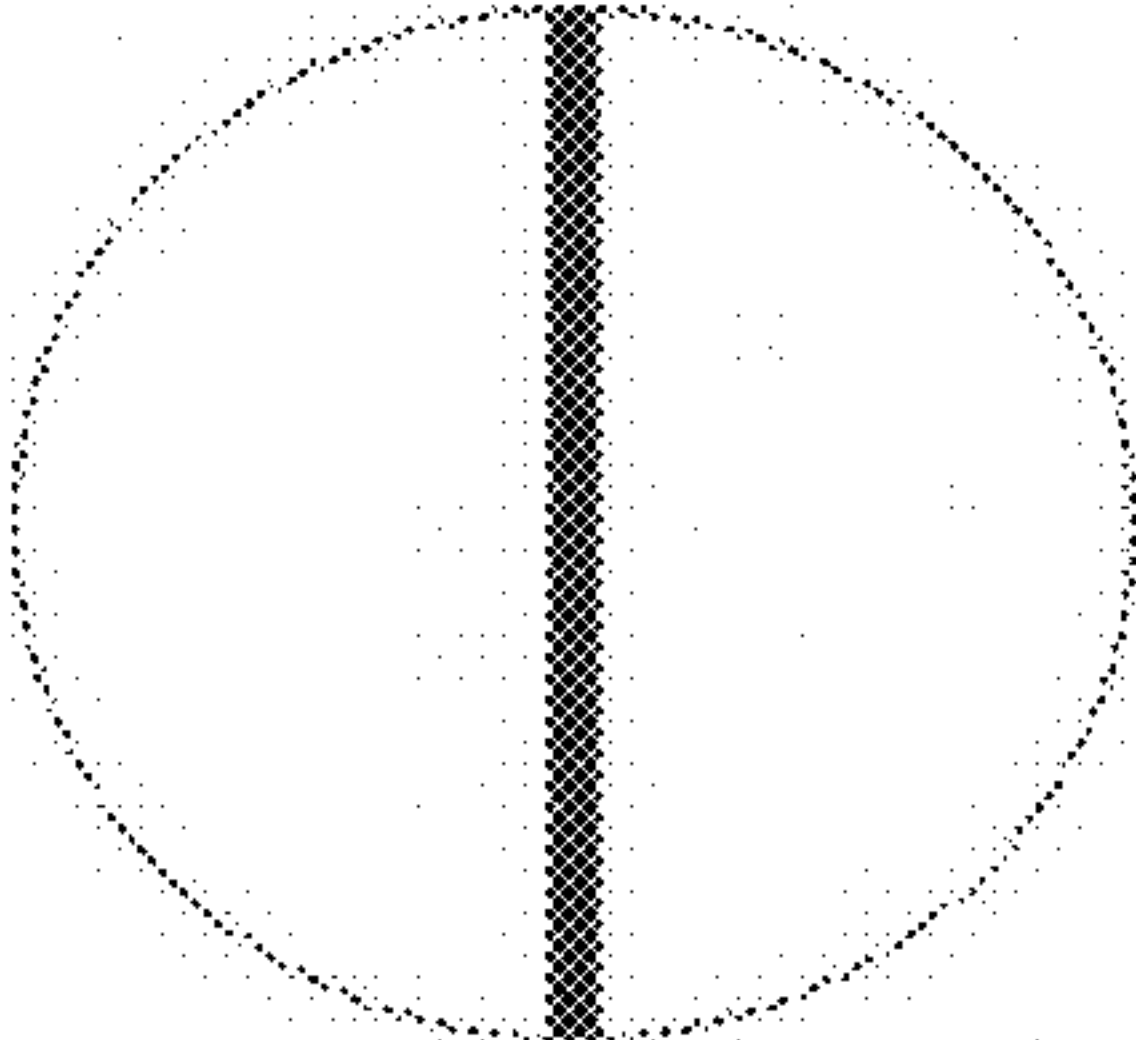

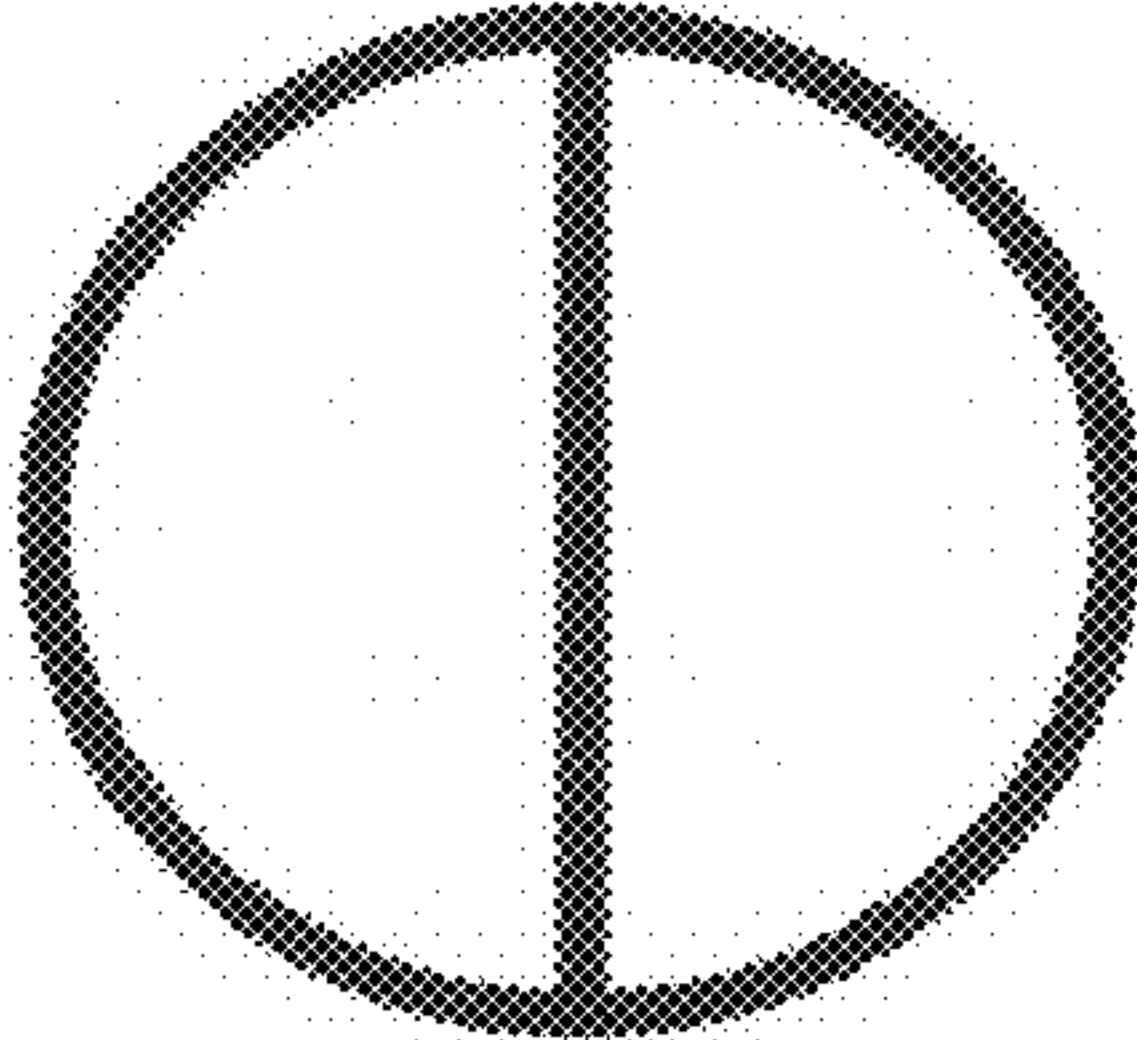

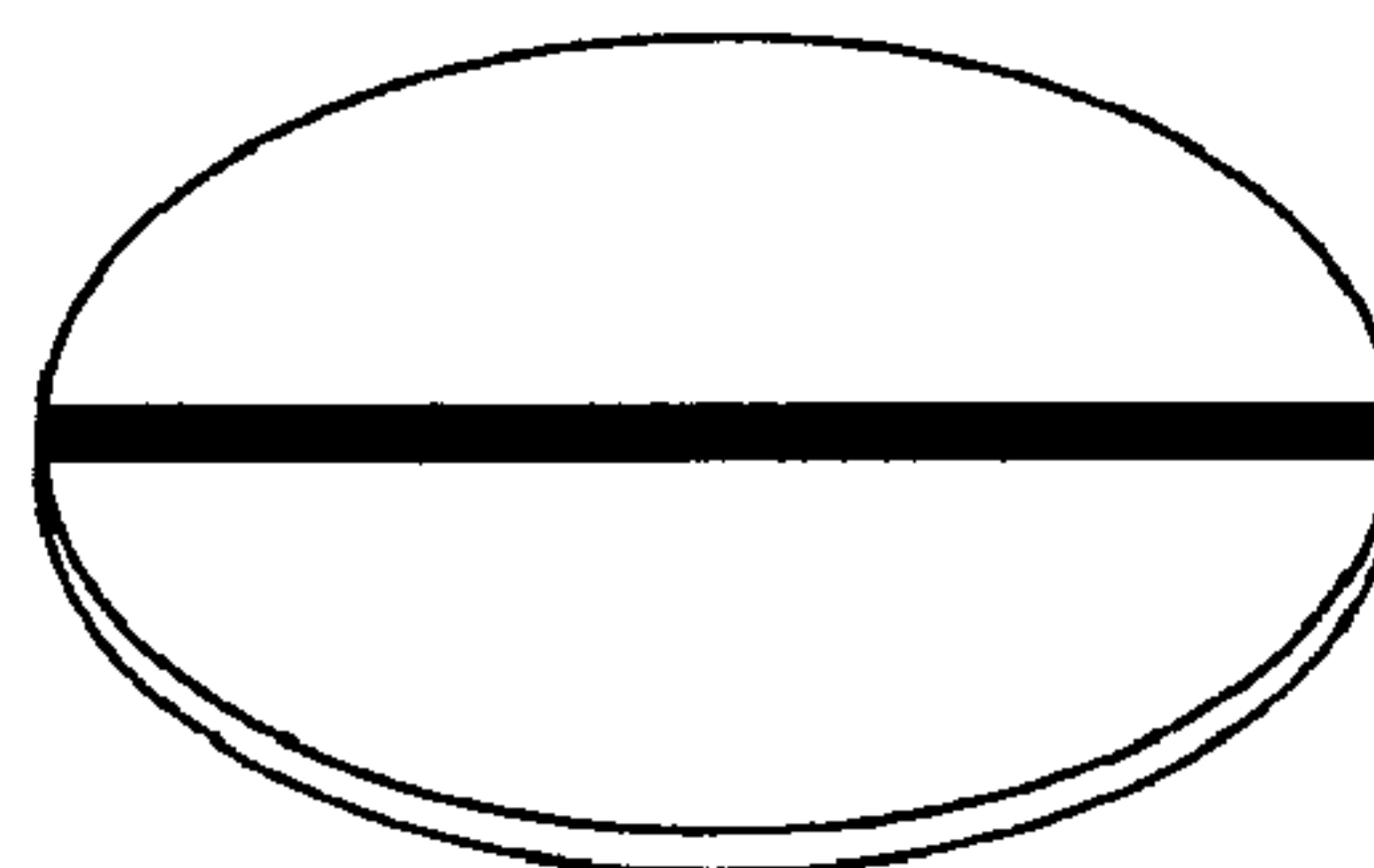

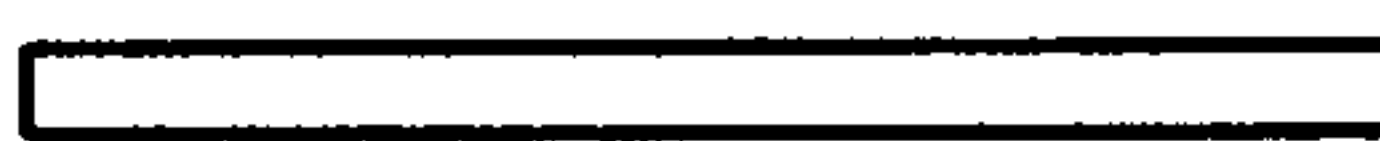

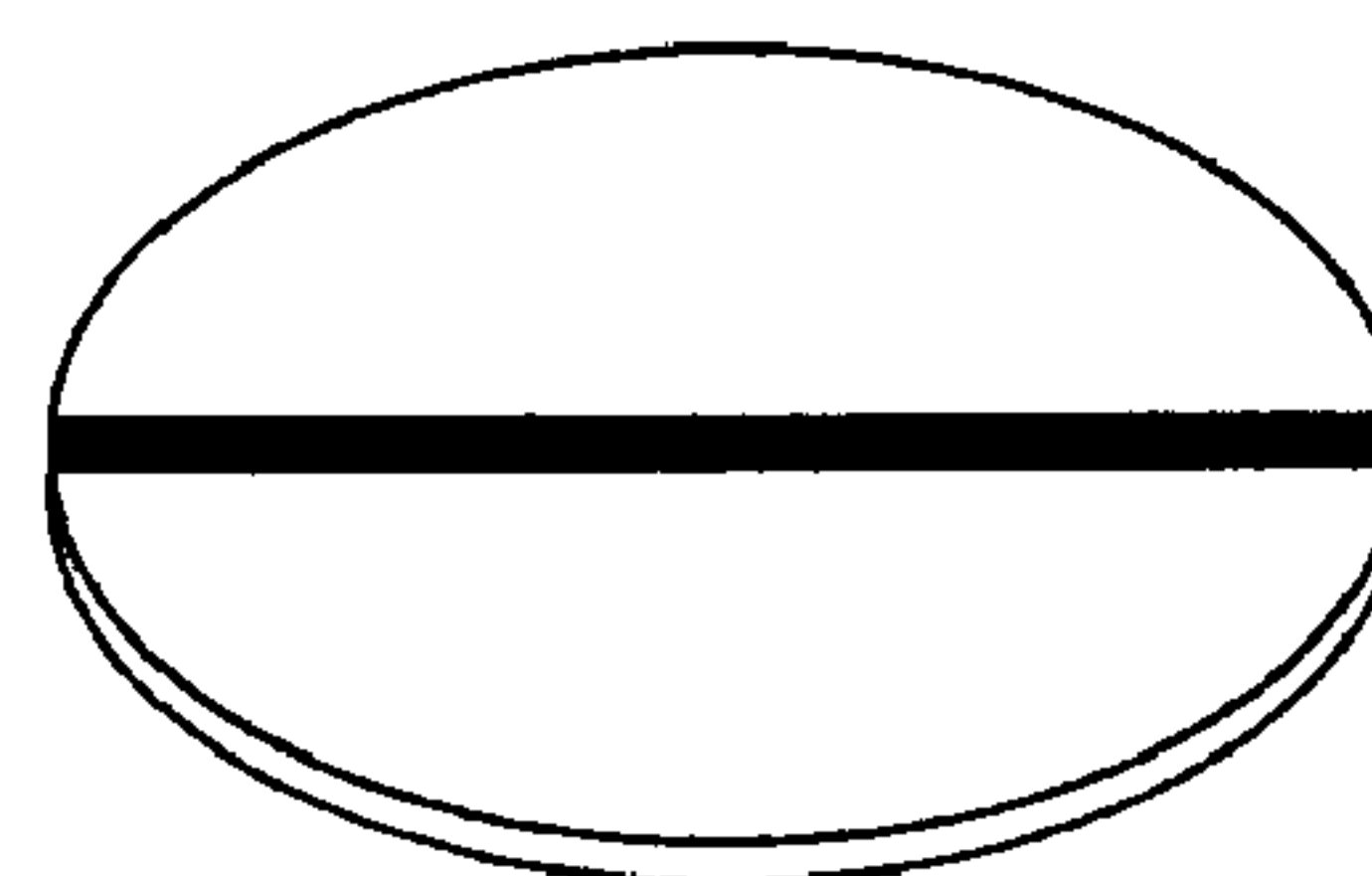
