(57) **CLAIM**

The ornamental design for a foot massage instrument, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a foot massage instrument according to my new design;

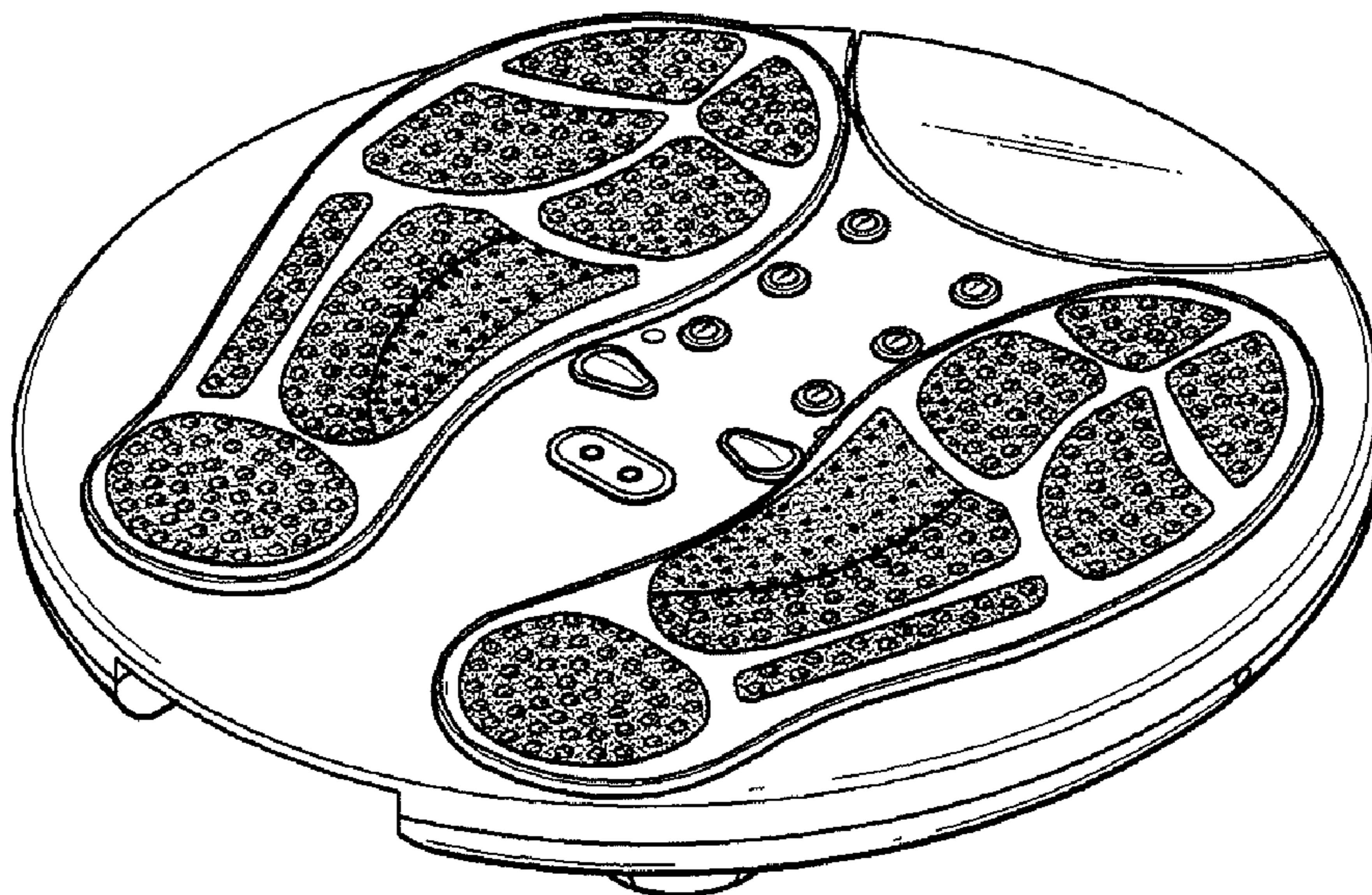

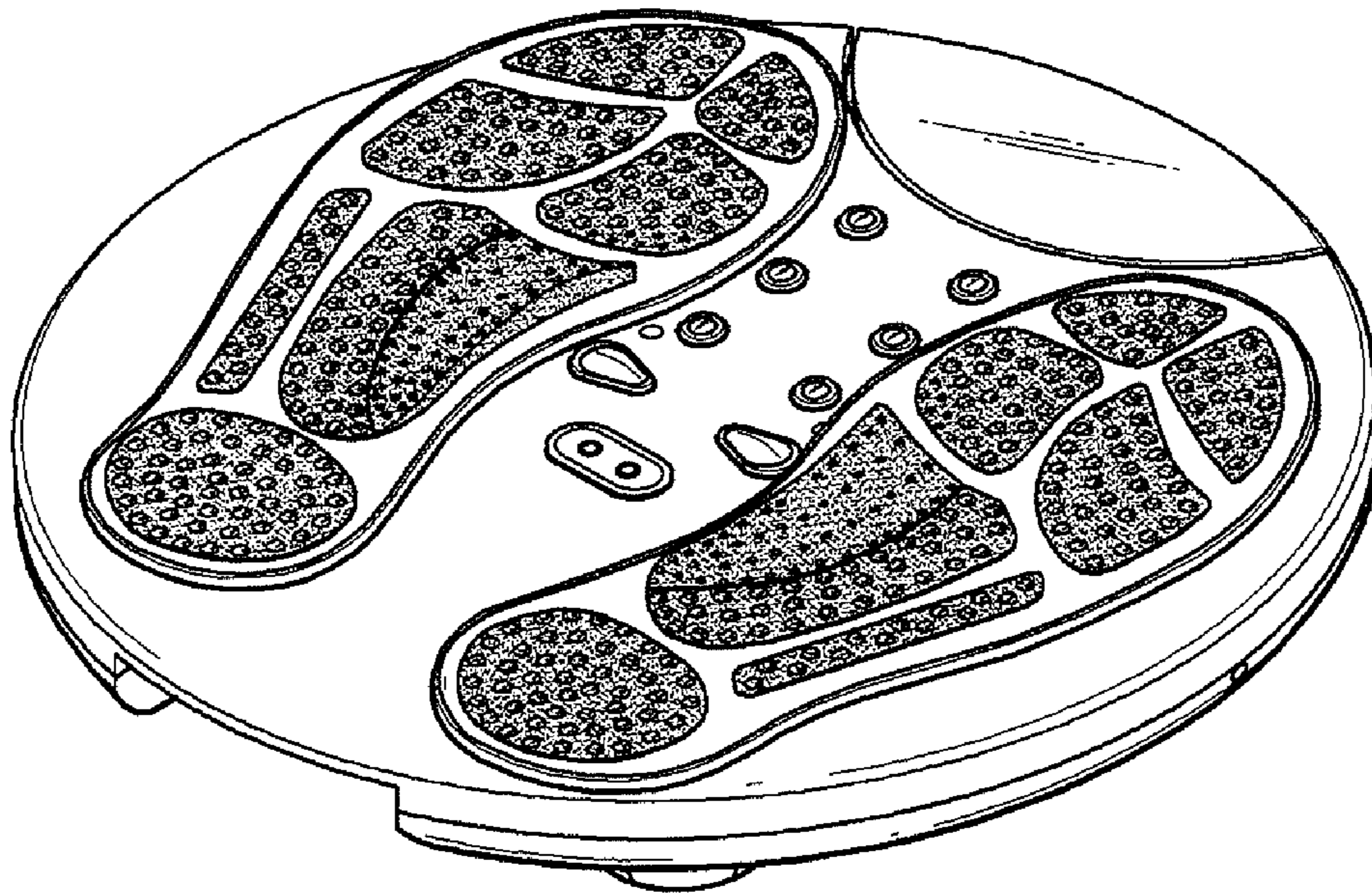

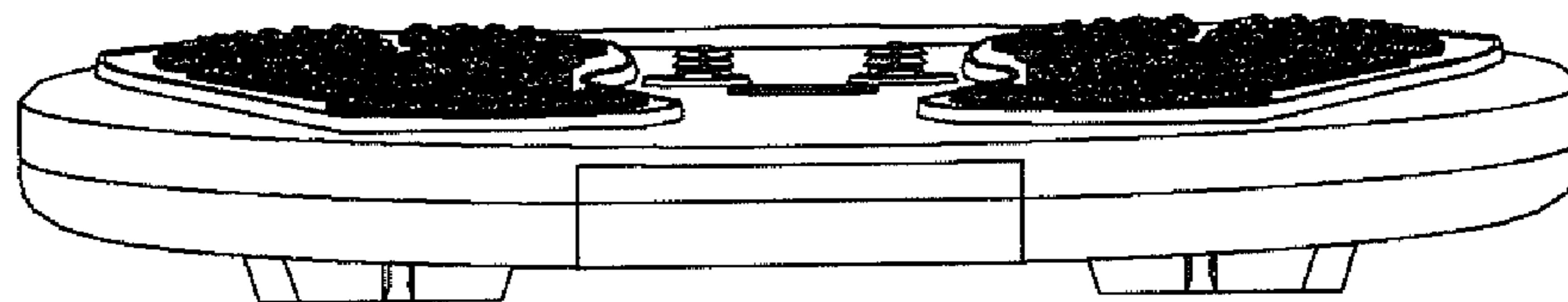

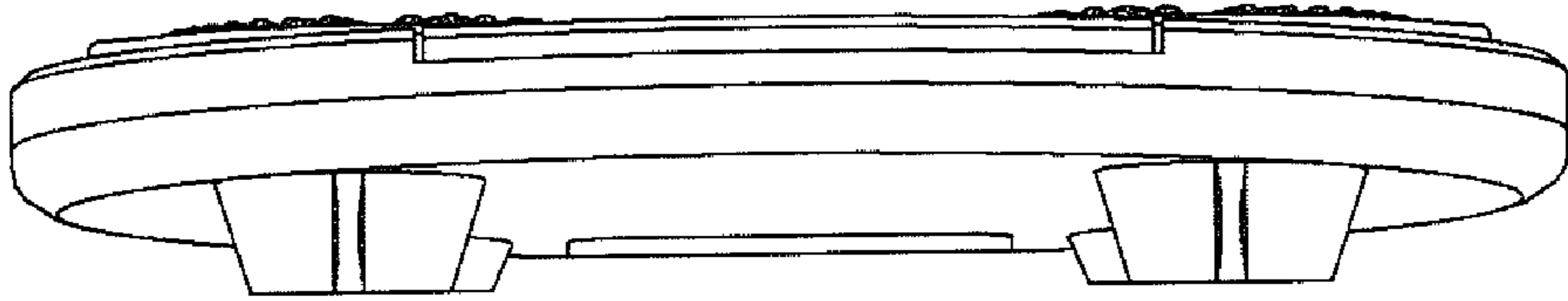

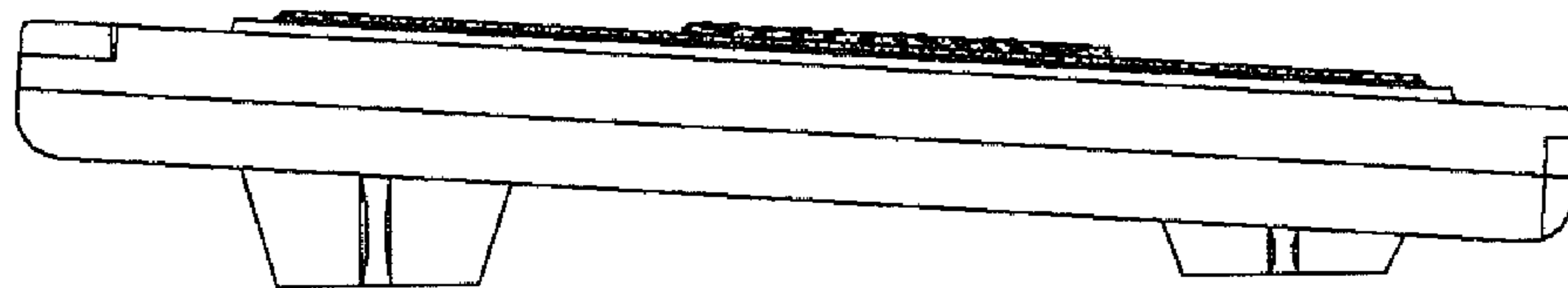

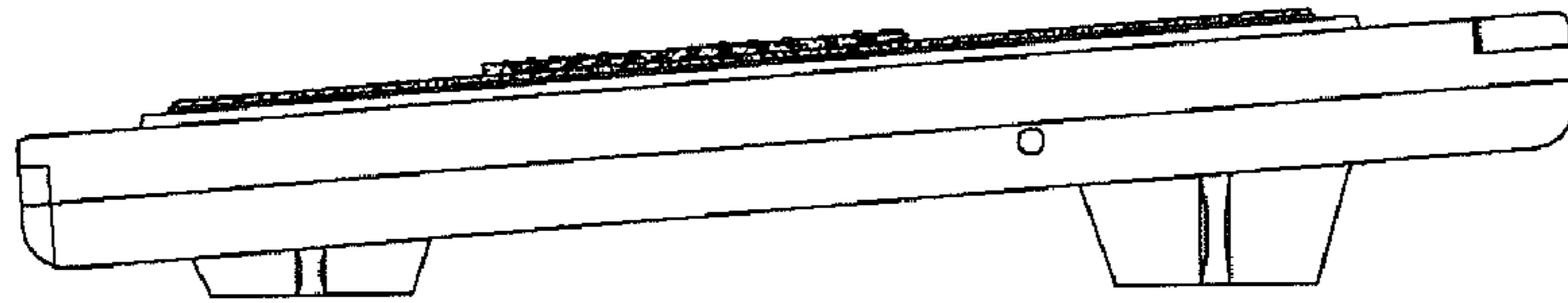

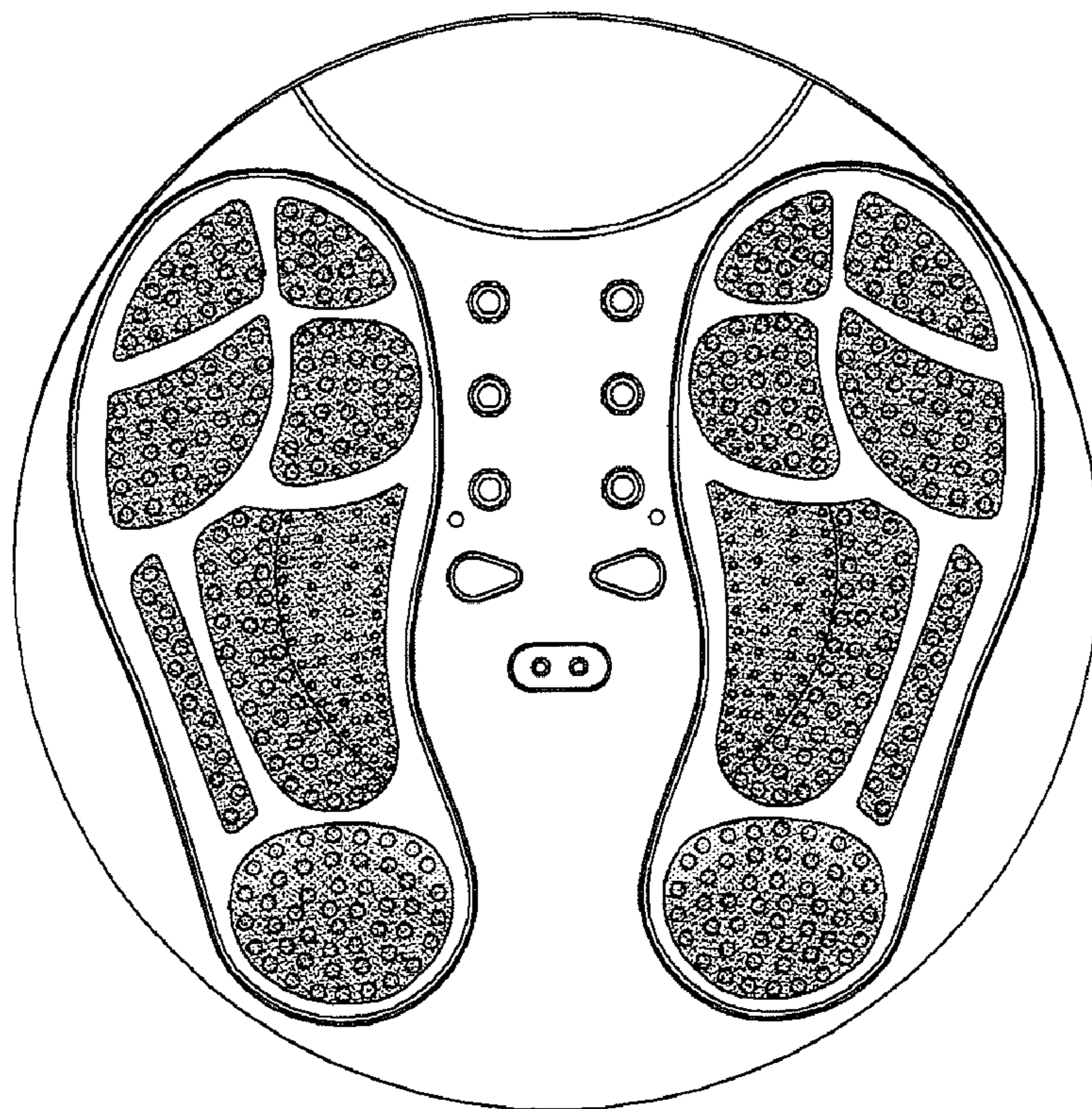
