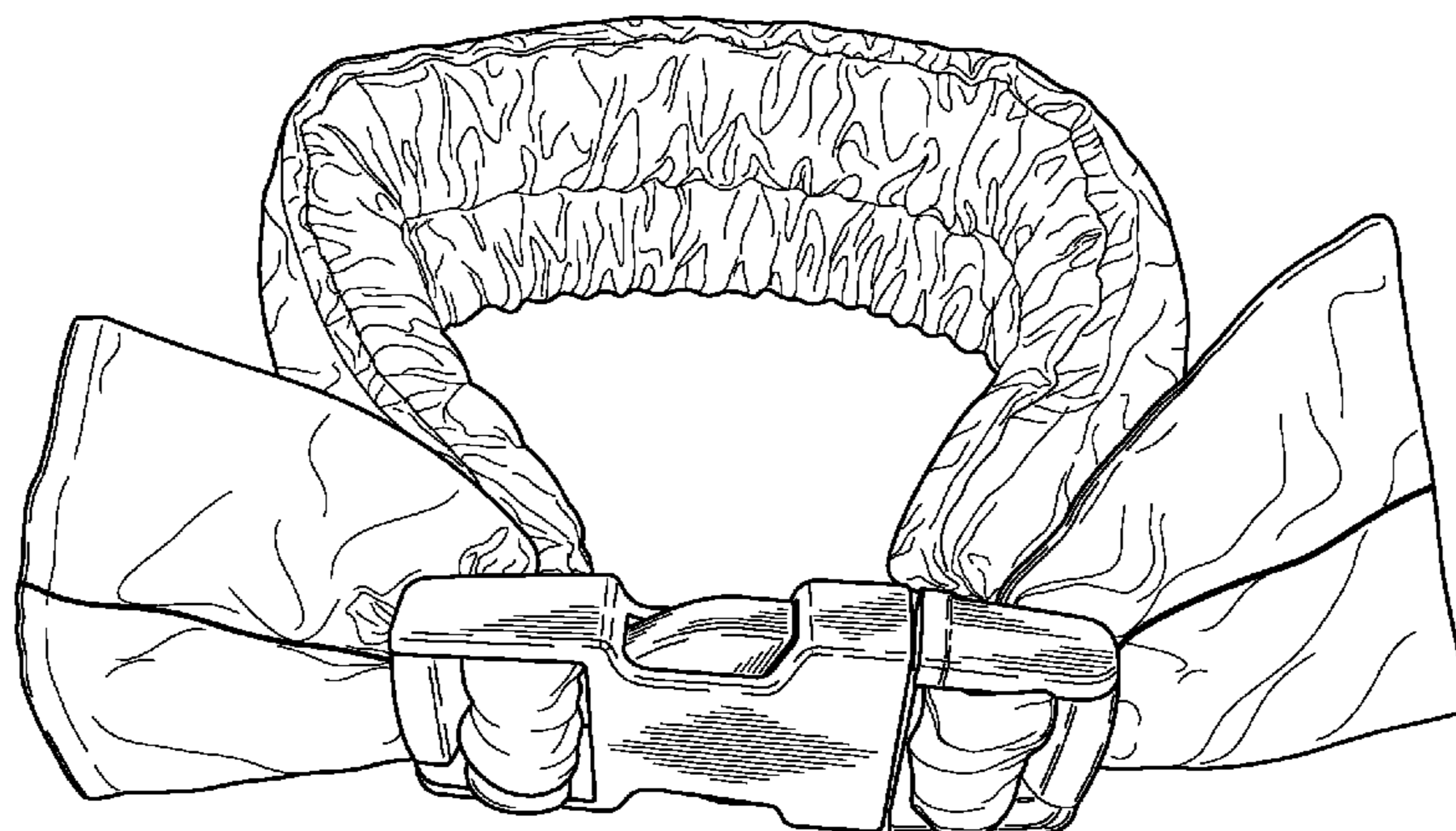
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an herbal filled calming collar for pets, showing my new design;
FIG. 2 is a front elevational view of the invention;
FIG. 3 is a rear elevational view of the invention;
FIG. 4 is a left-side elevational view of the invention;
FIG. 5 is a right-side elevational view of the invention; and,
FIG. 6 is a top plan view of the invention, the bottom plan view being a mirror image.

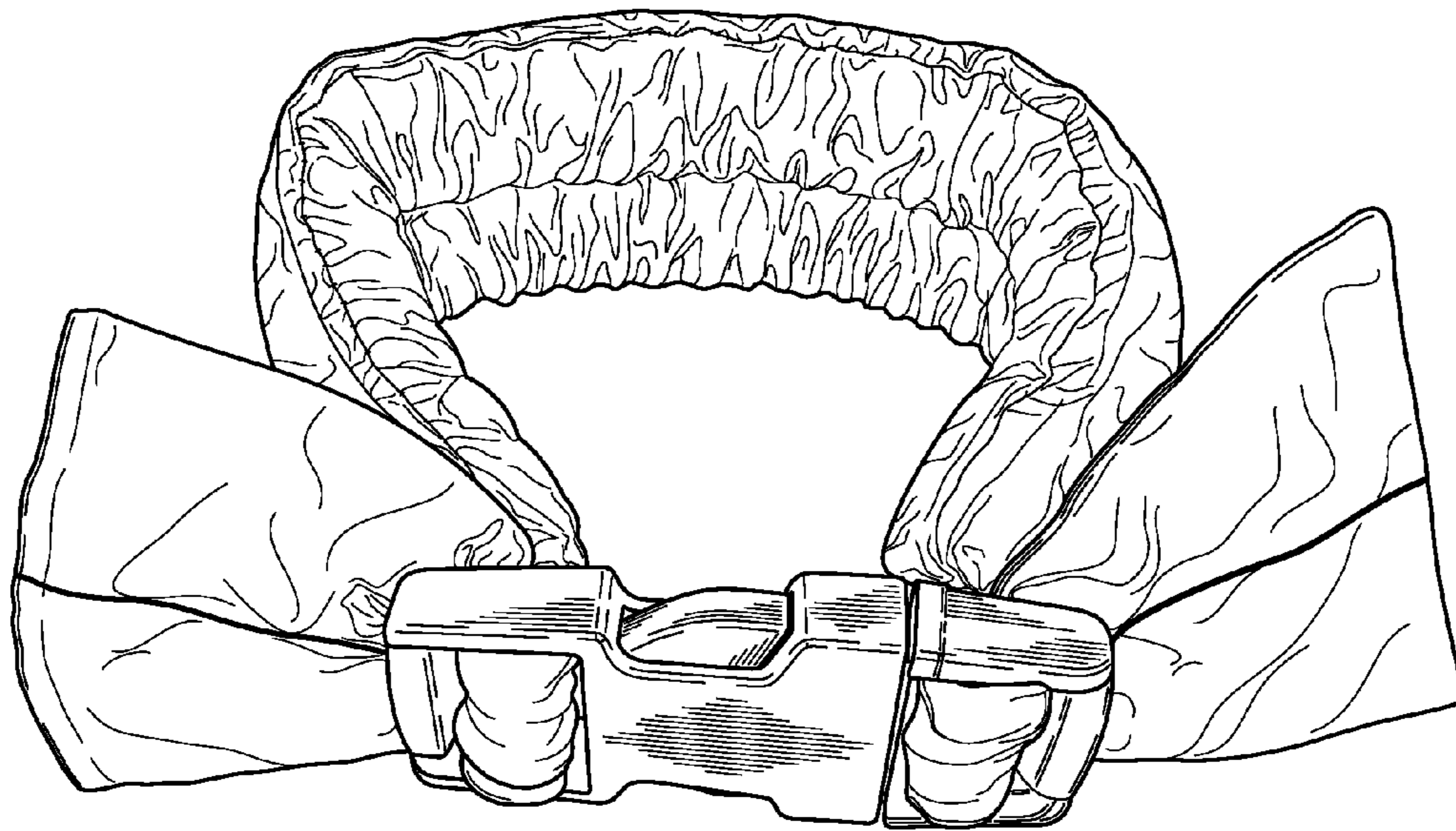

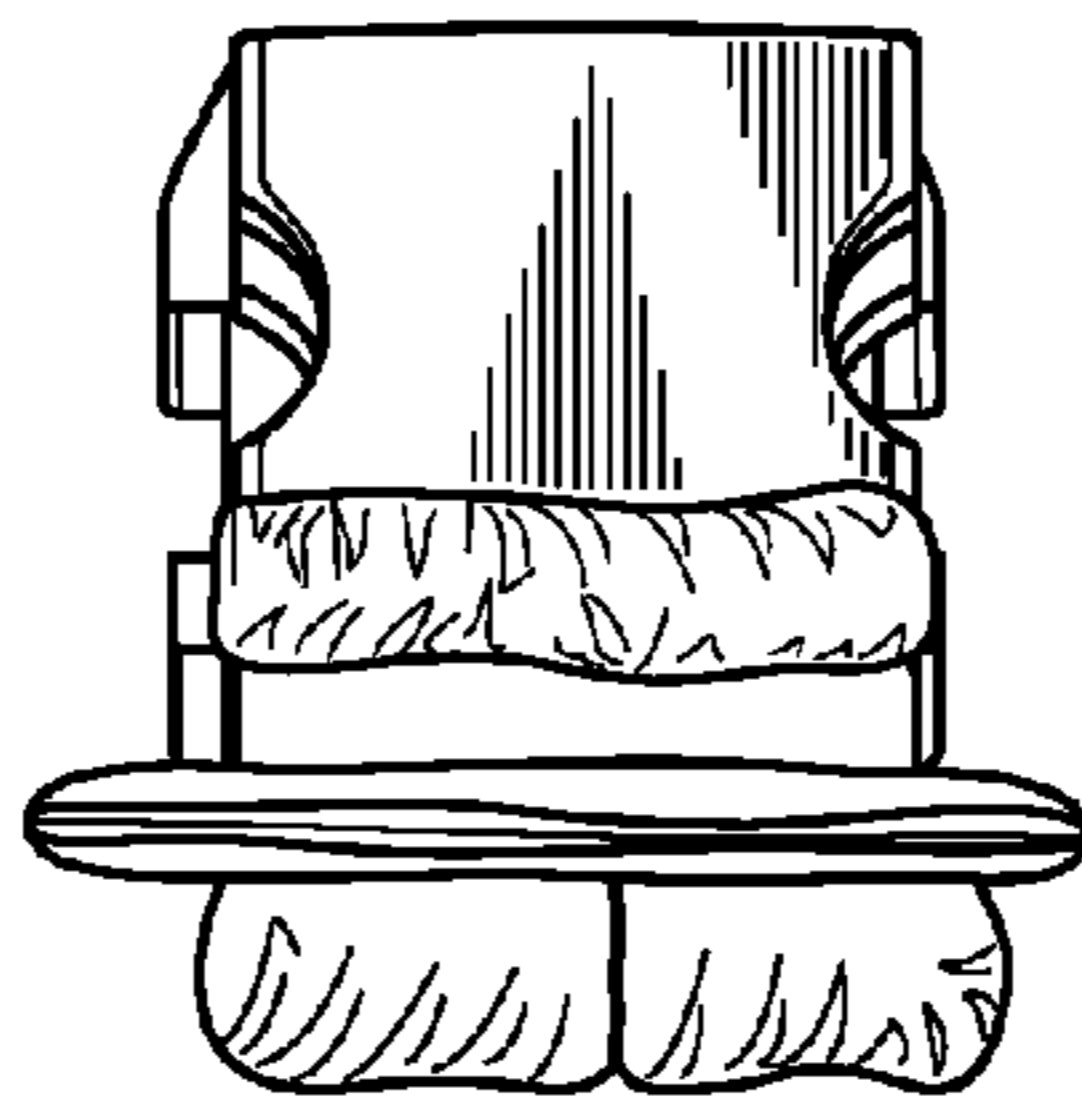

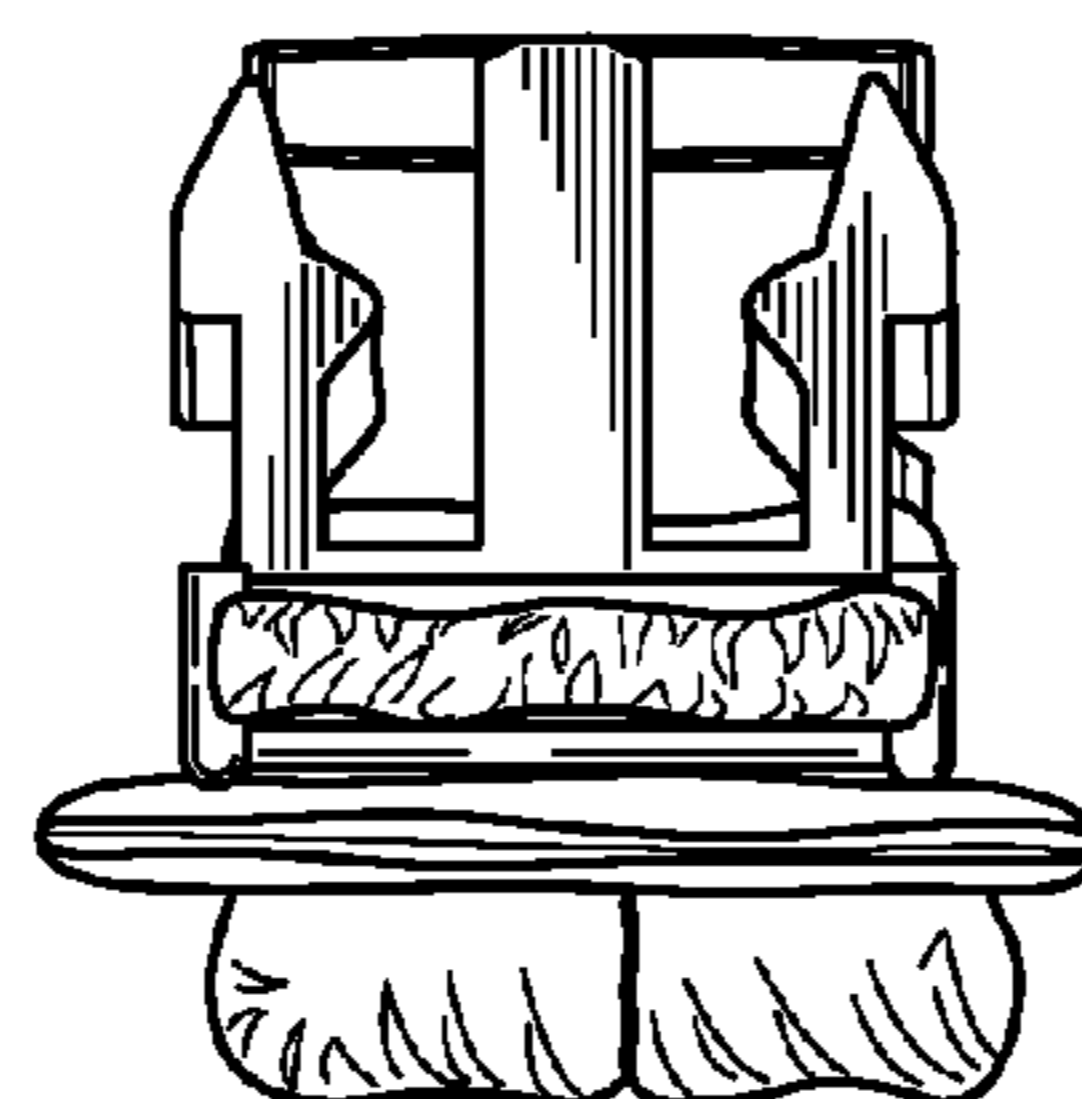

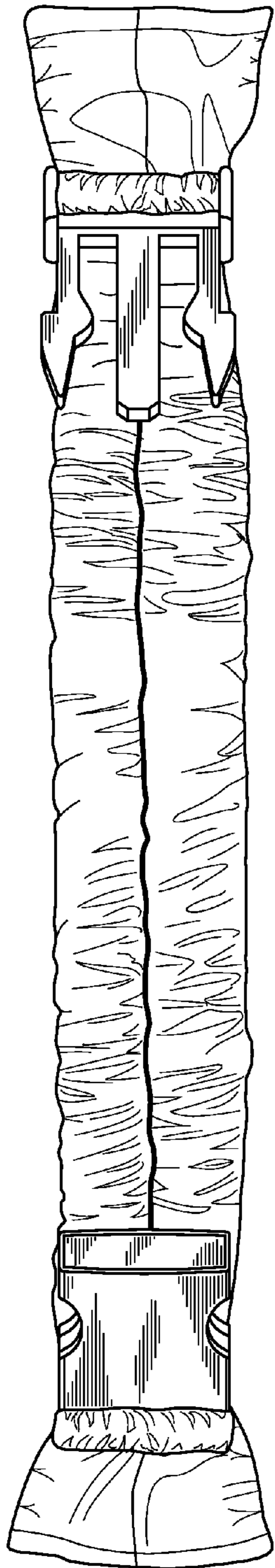

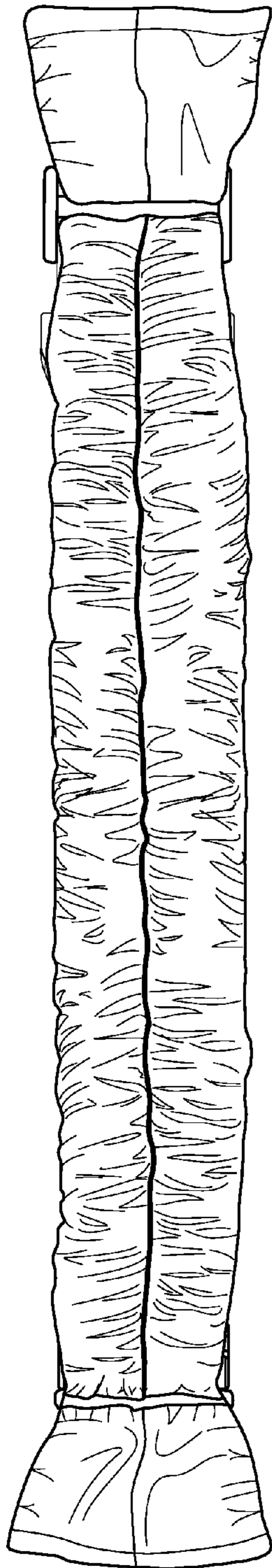
