DESCRIPTION

FIG. 1 is a right perspective view of an ice pop holder showing my new design;

FIG. 5 is a front elevational view thereof;

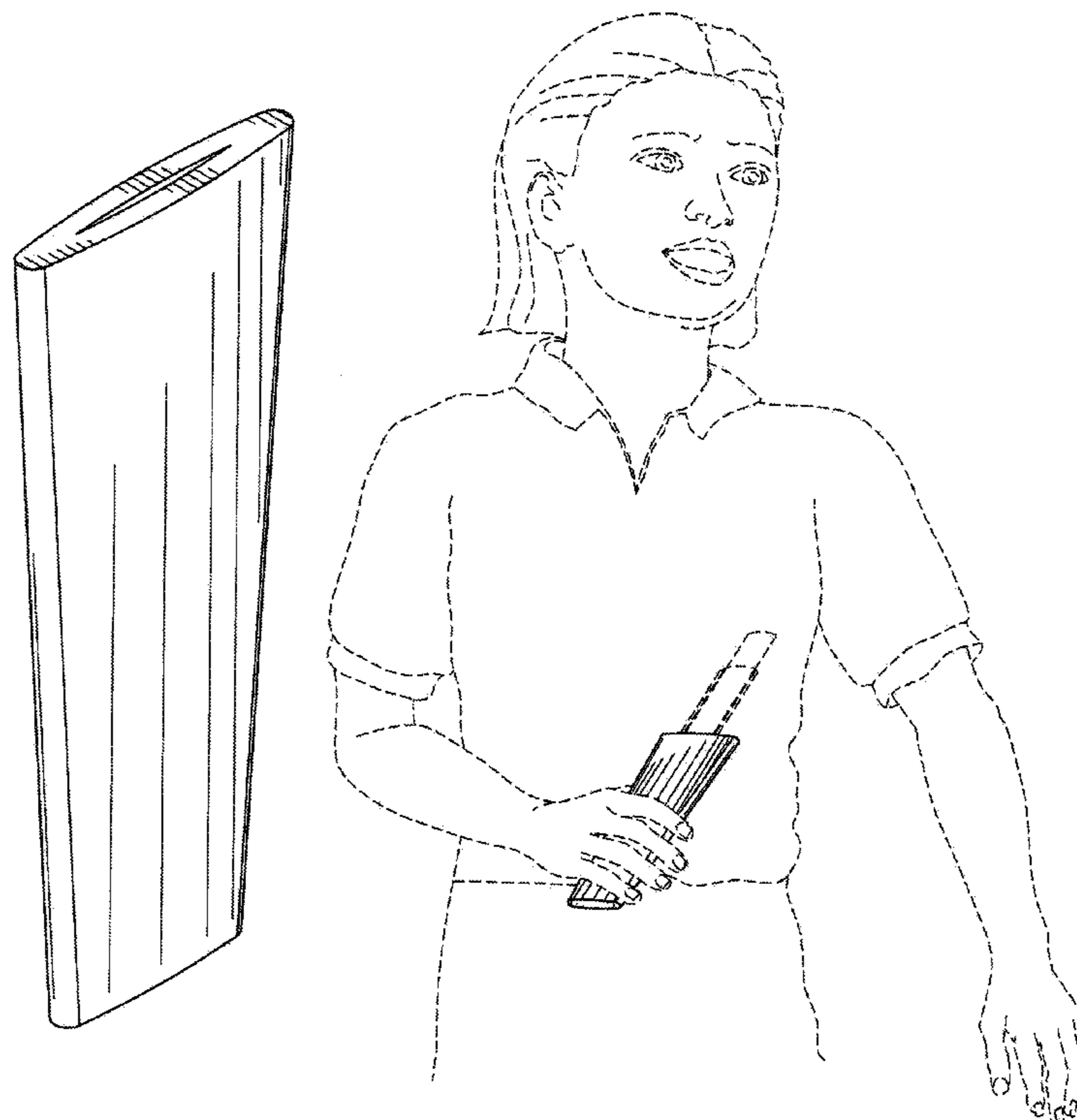
FIG. 6 is a side elevational view thereof;

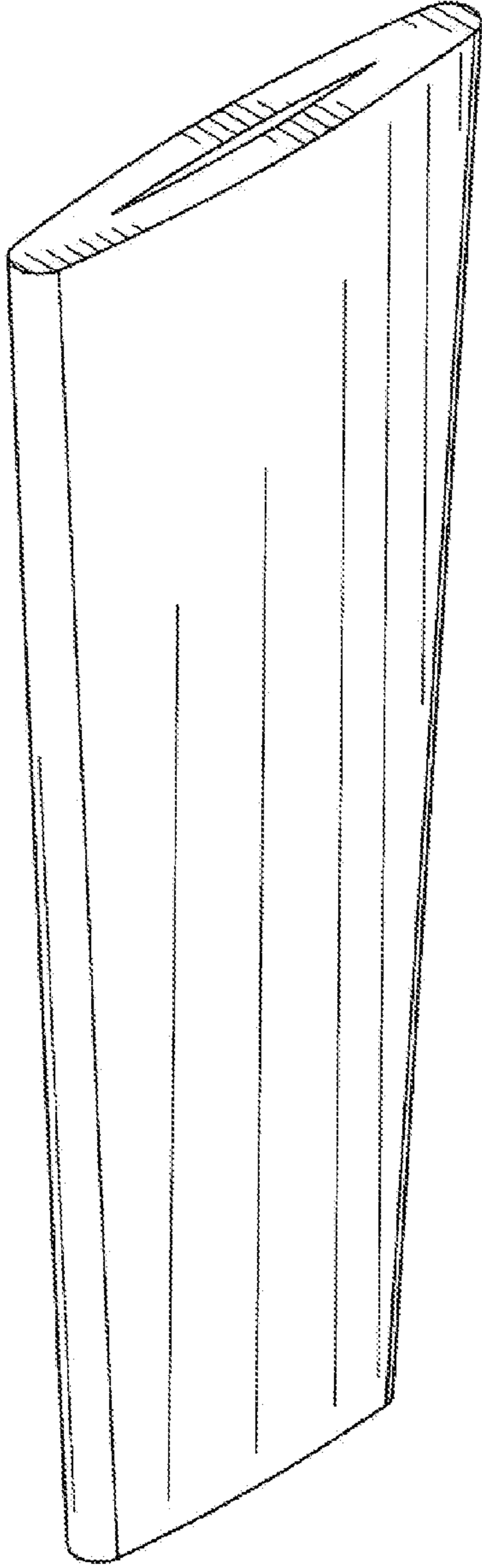

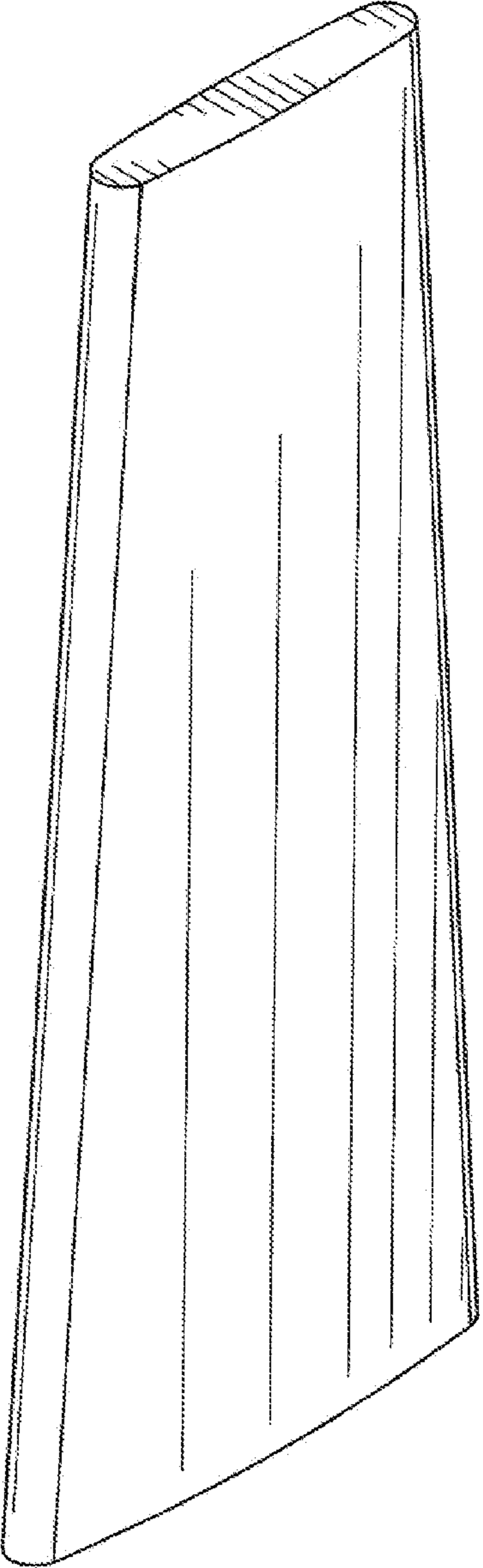

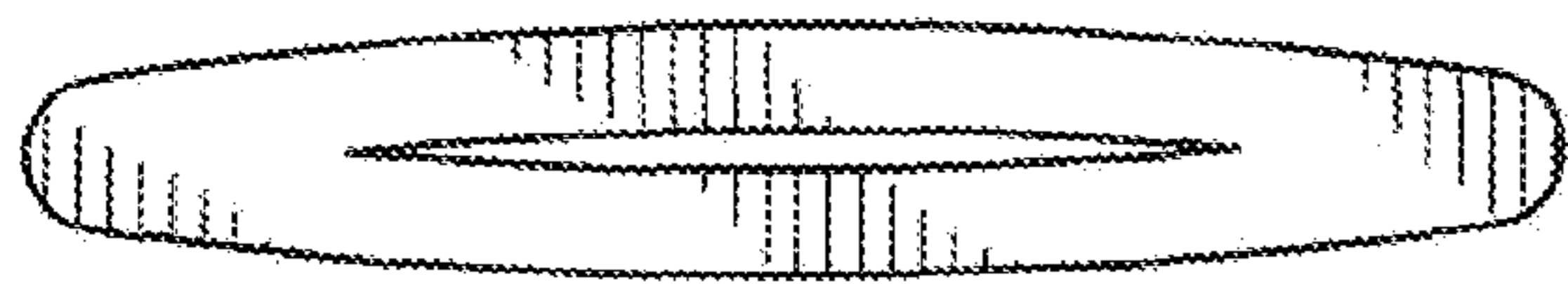

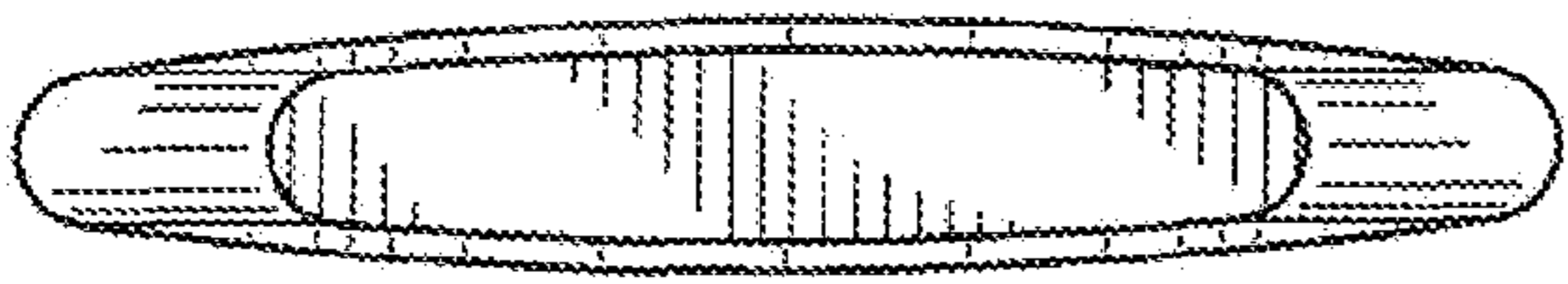

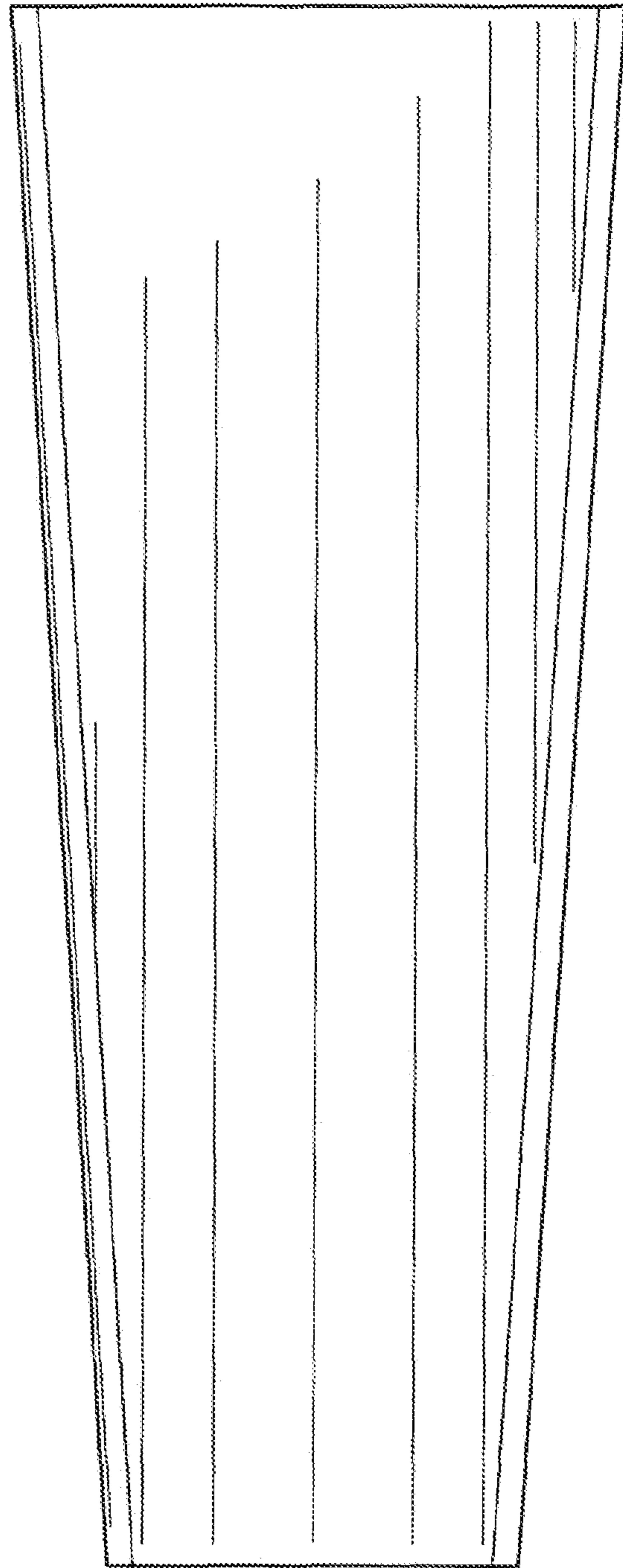

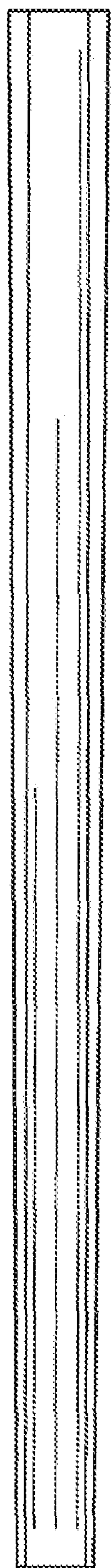

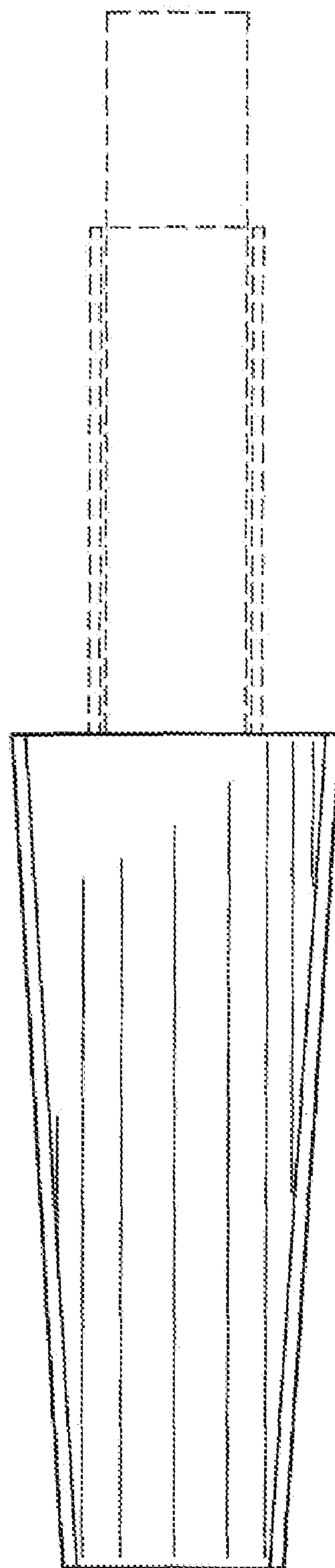

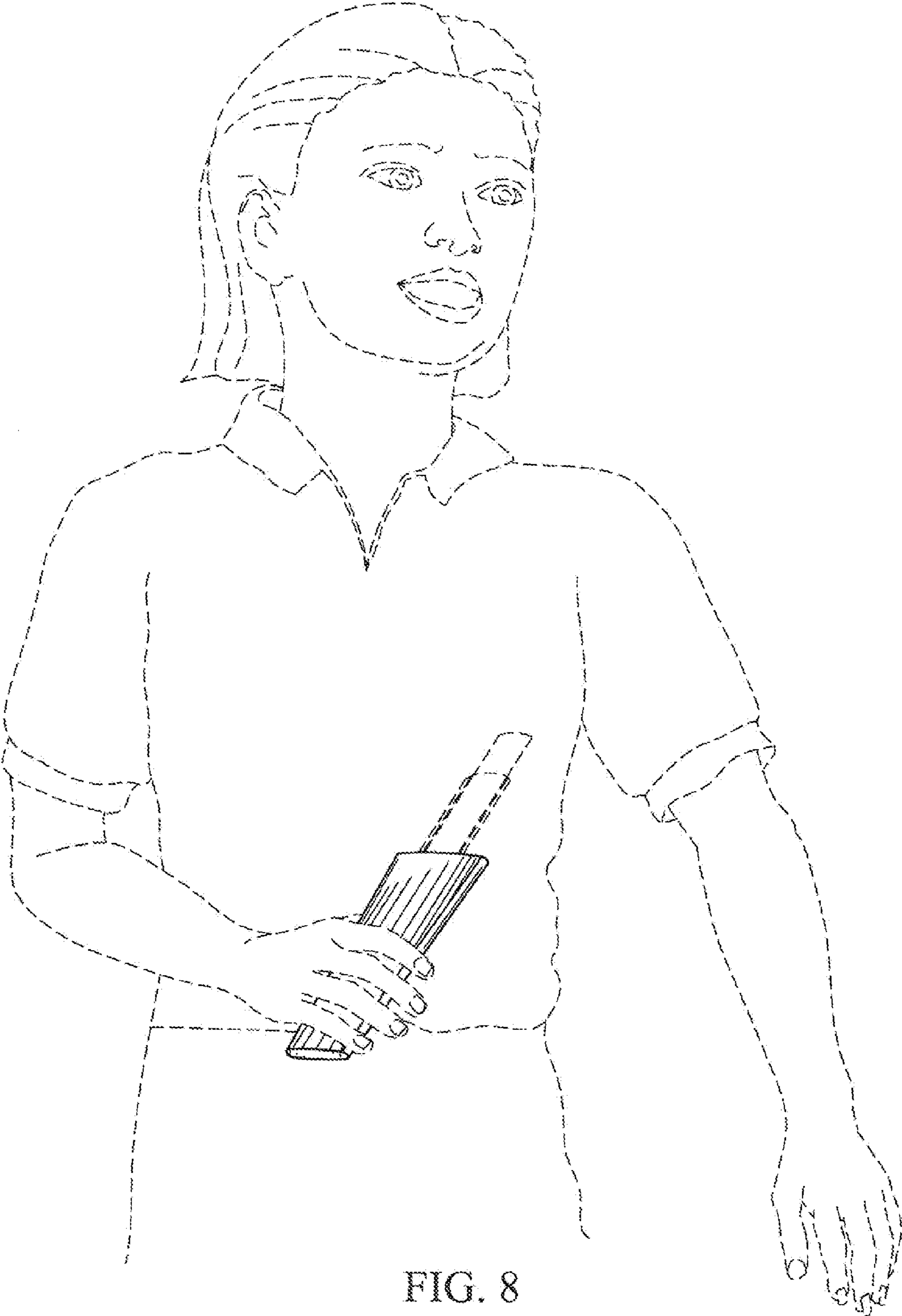
