The ornamental design for a multiangle operating wrench, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multiangle operating wrench showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

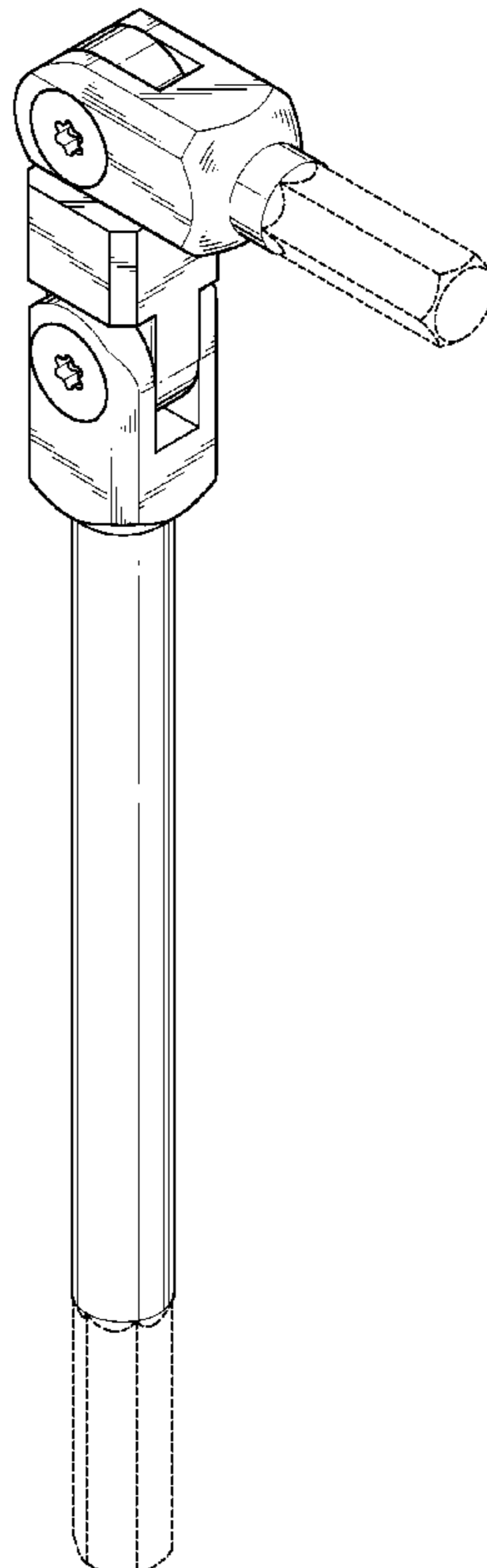
FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is an another perspective view of multiangle operating wrench, showing that the wrench head of FIG. 1 is switched to a position in line with the wrench handle.

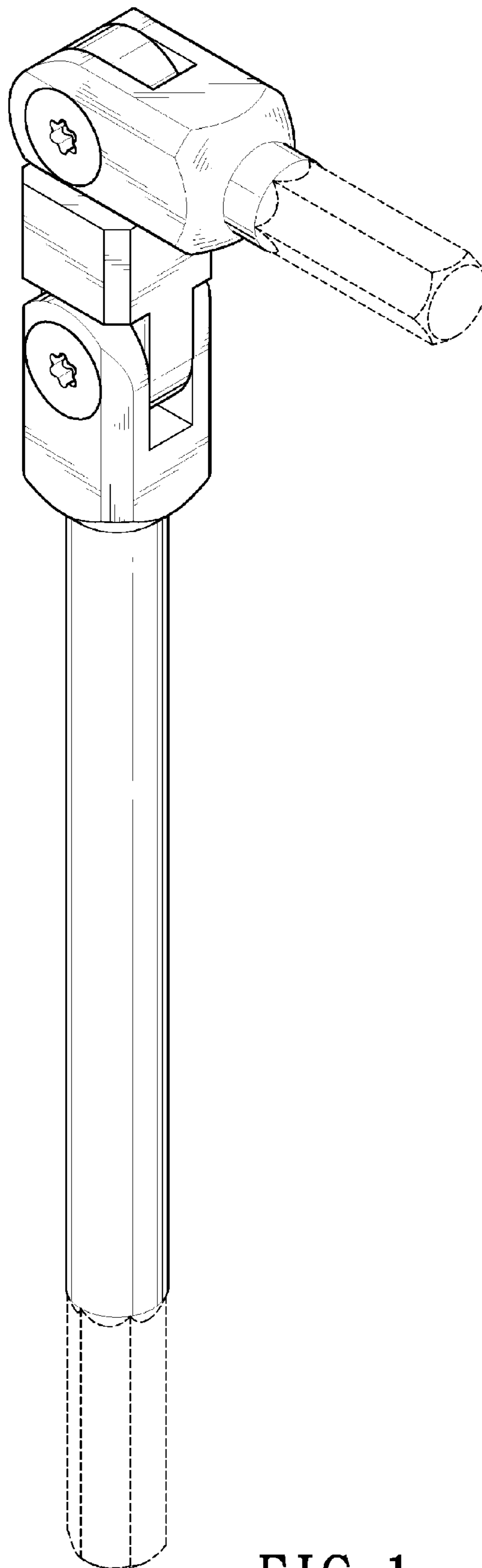

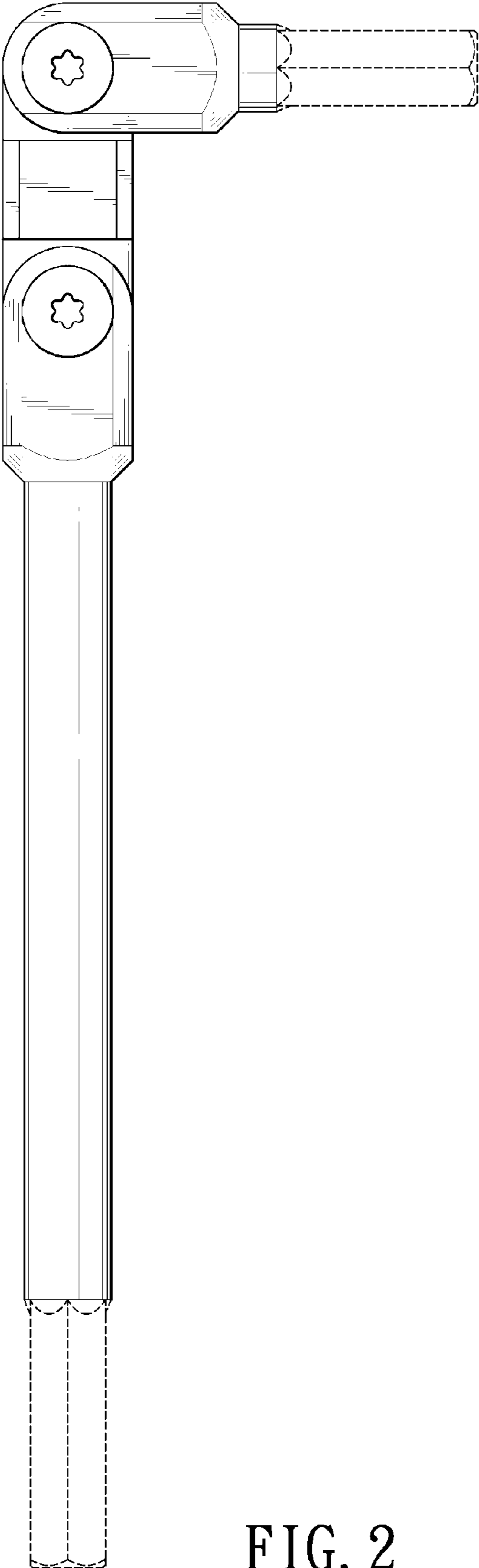

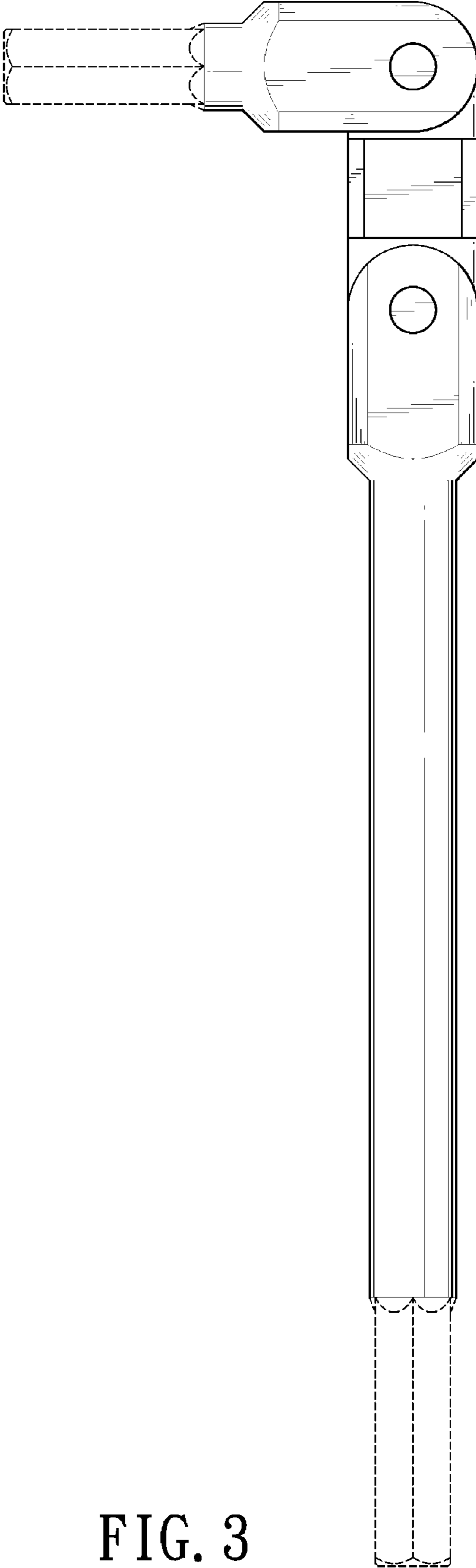

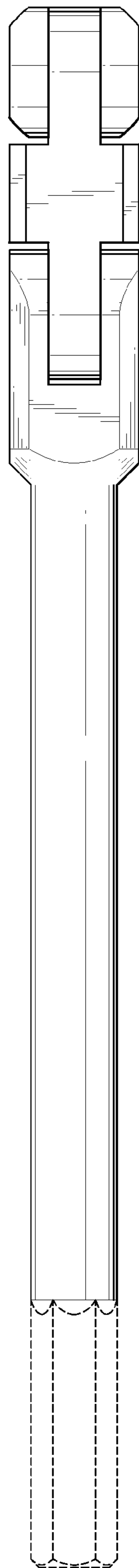

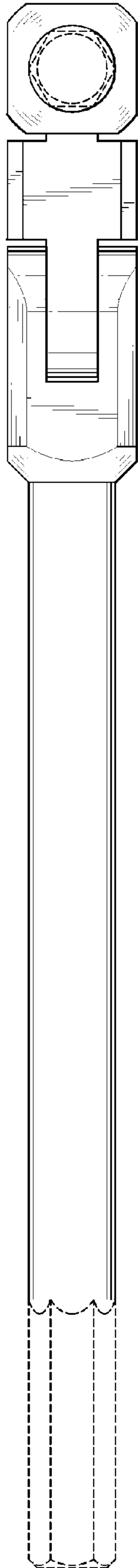

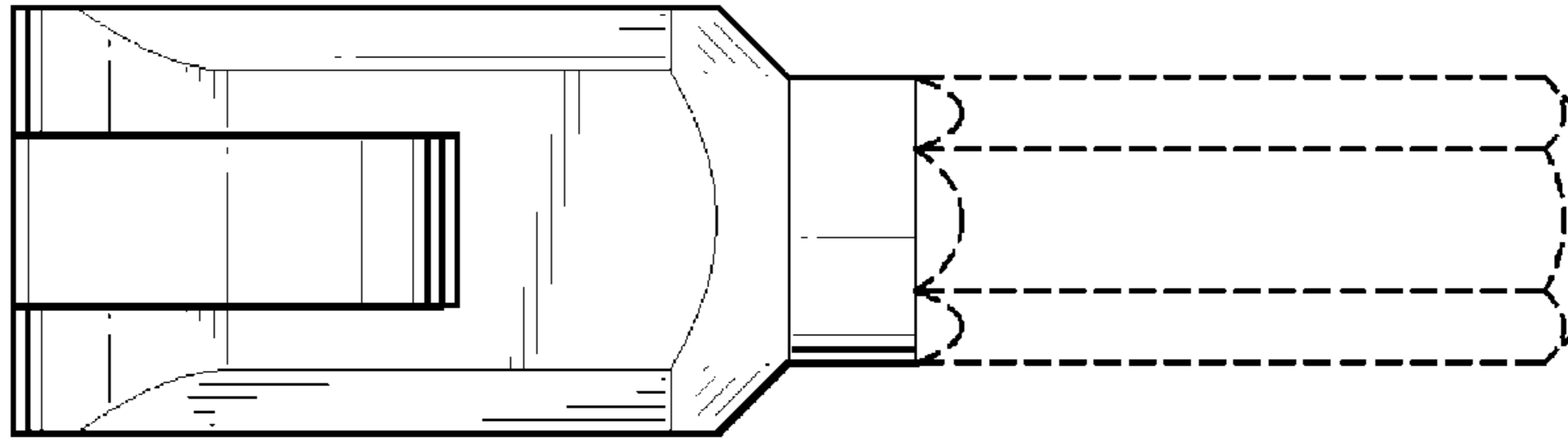

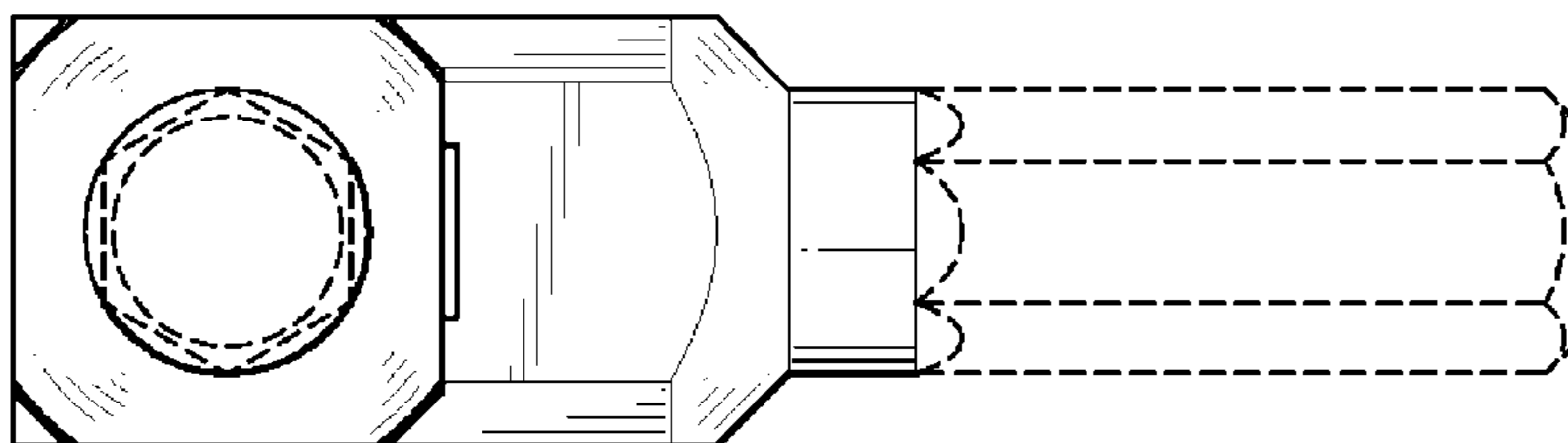

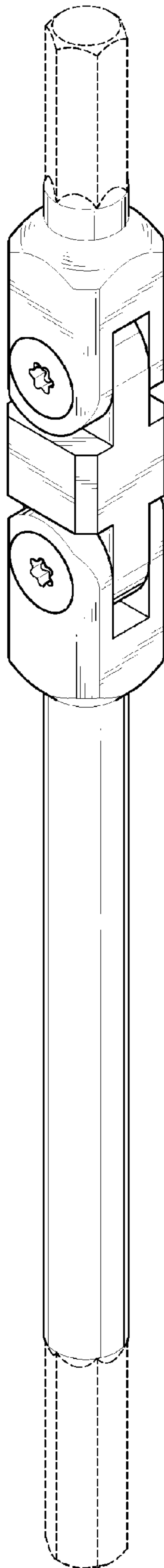
