DESCRIPTION

FIG. 1 is a front, perspective view of a portable tool set of the present invention;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right side, elevational view thereof with one tool extended;

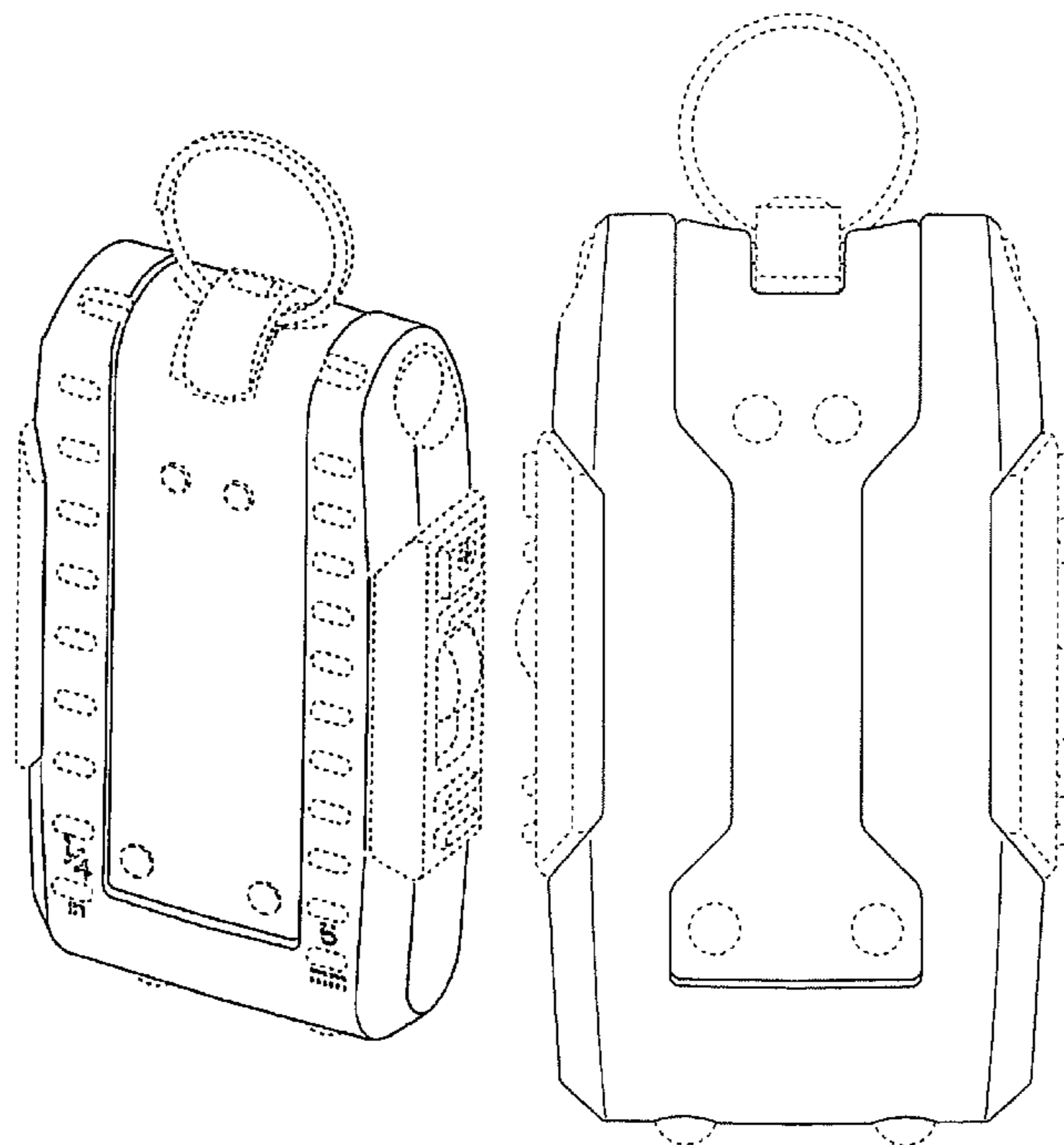
FIG. 5 is a left side, elevational view thereof with one tool extended;

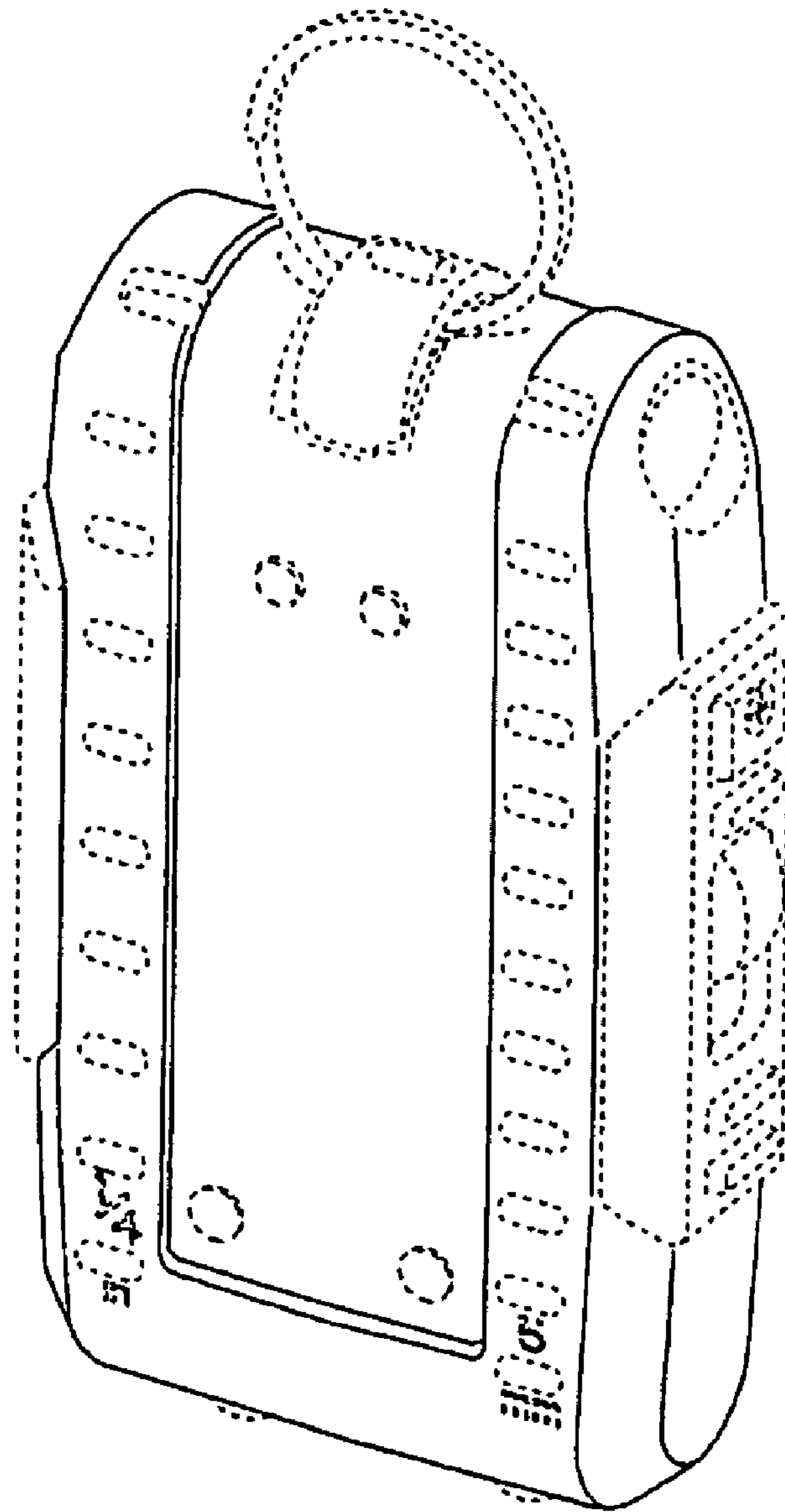

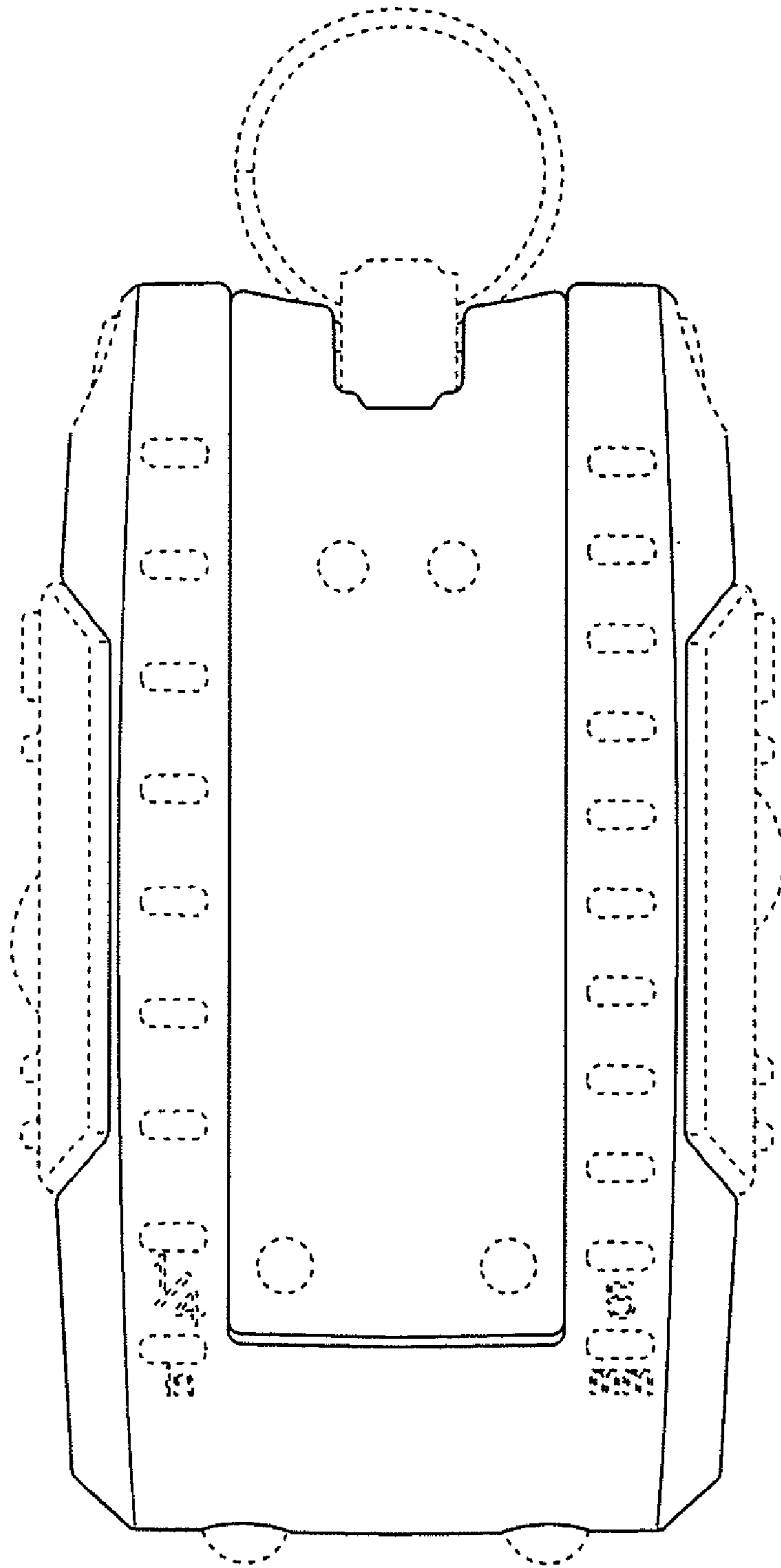

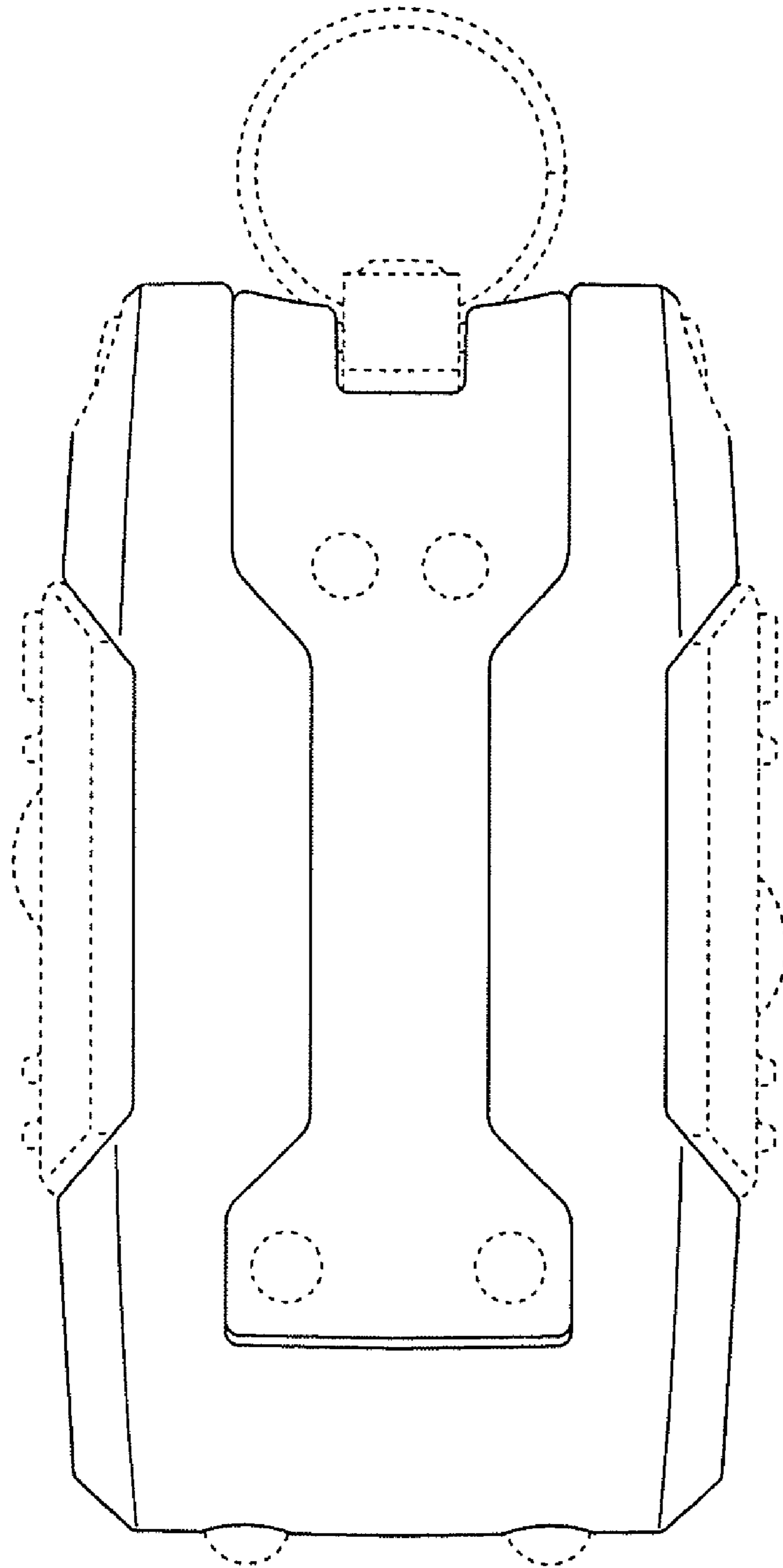

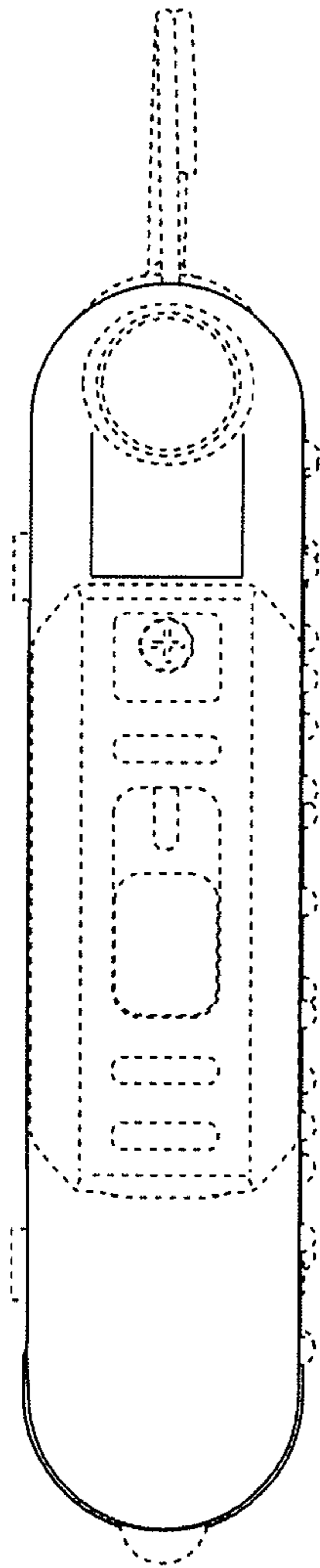

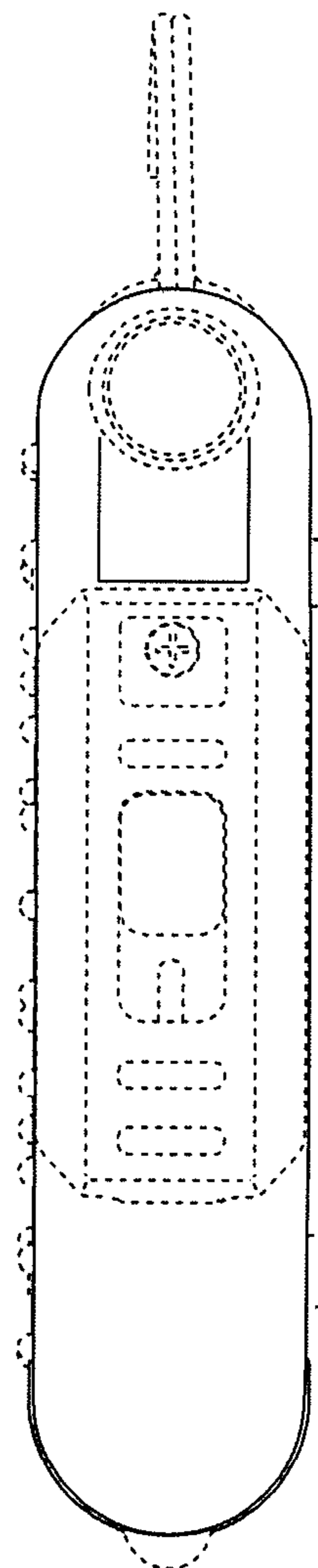

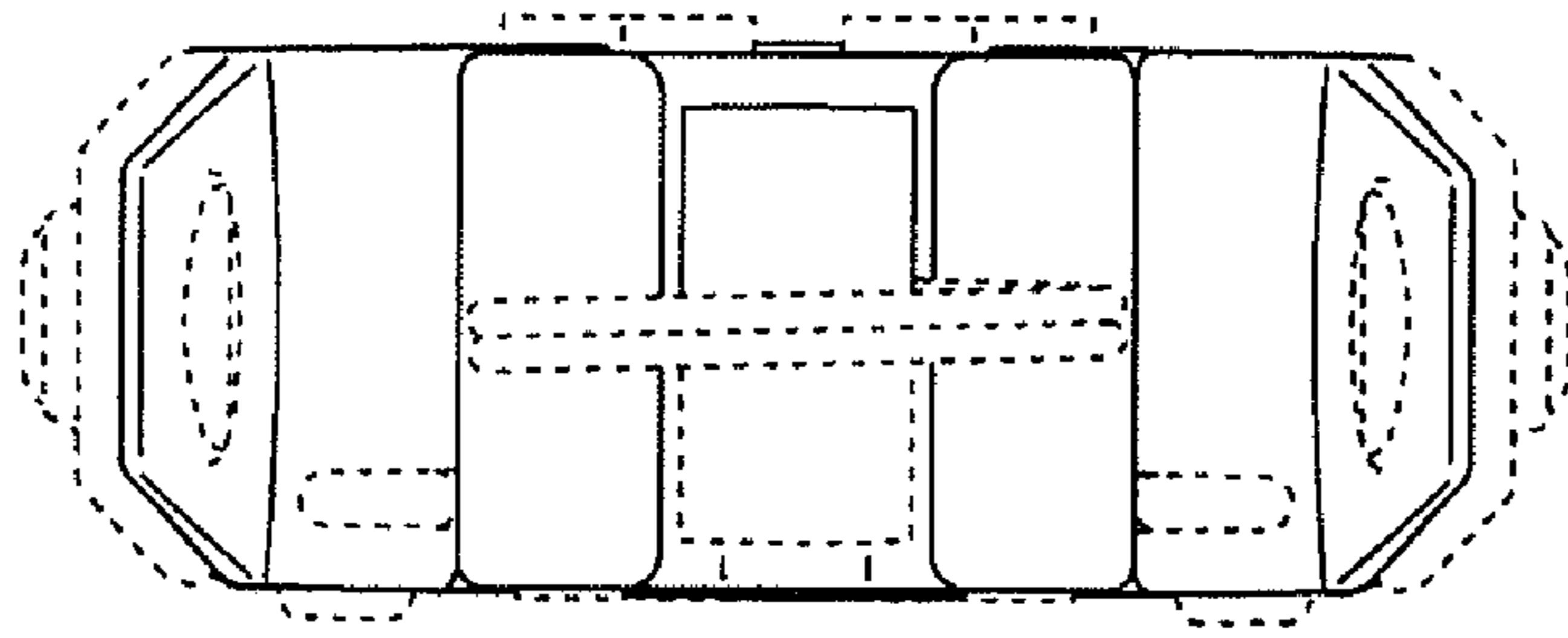

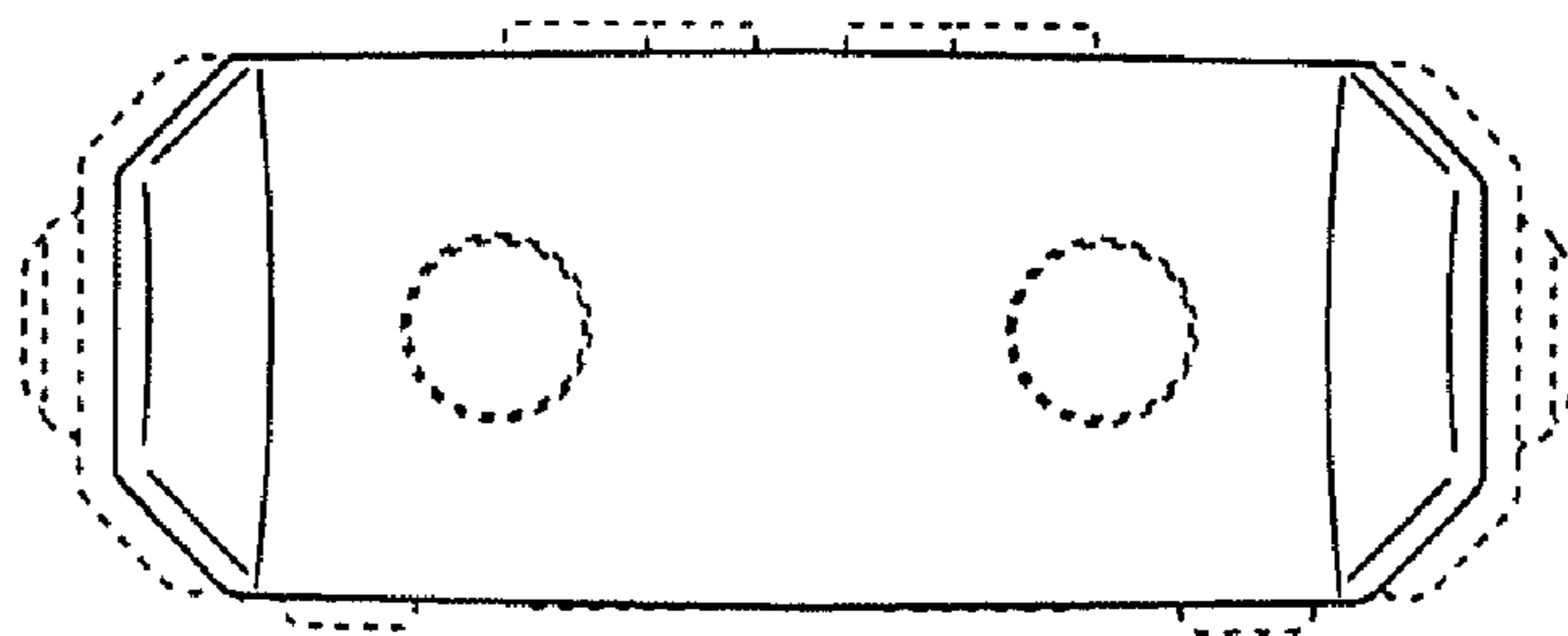
