FIG. 4 is a right side elevation thereof,

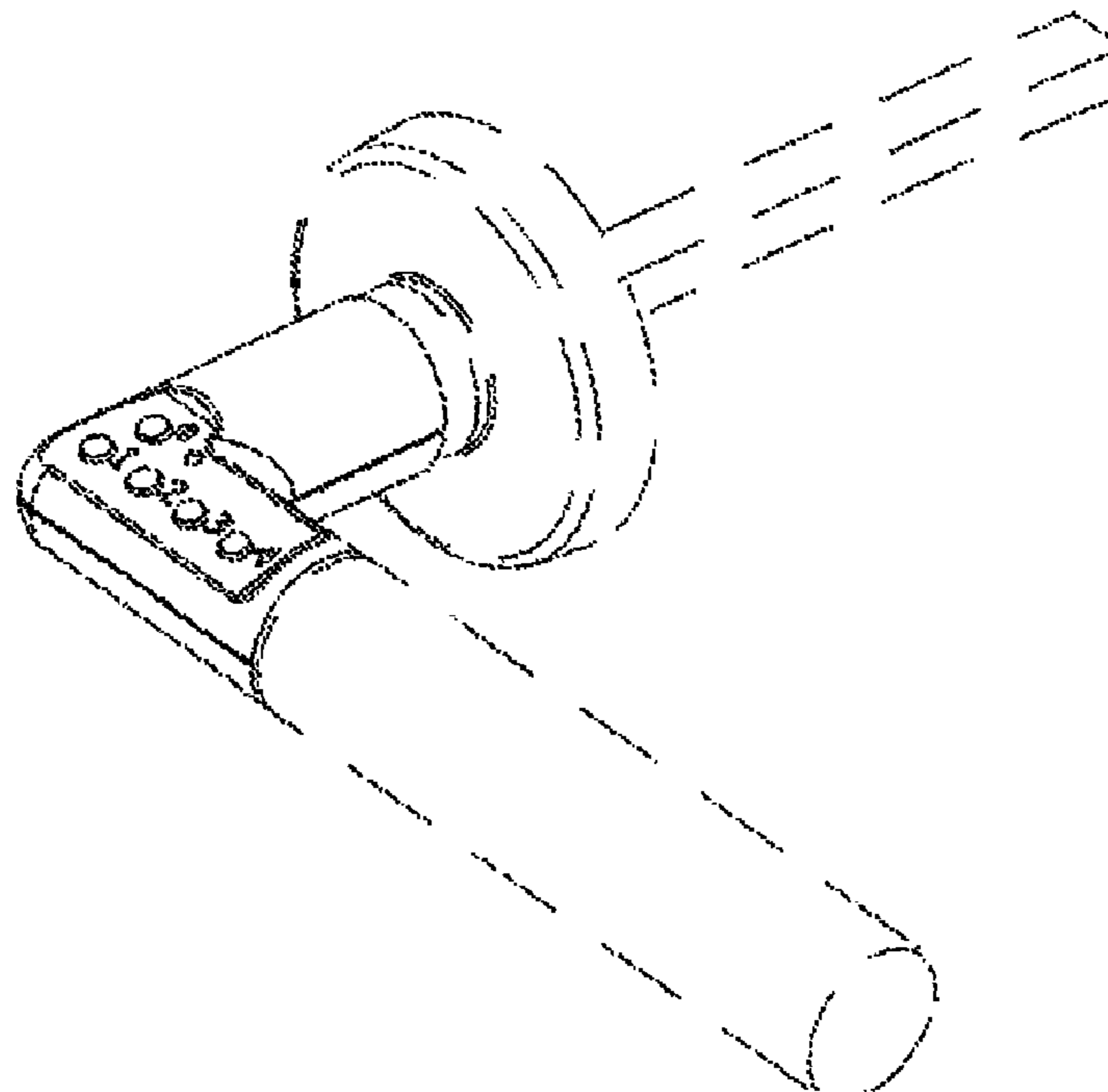
FIG. 5 is a front elevation view thereof,

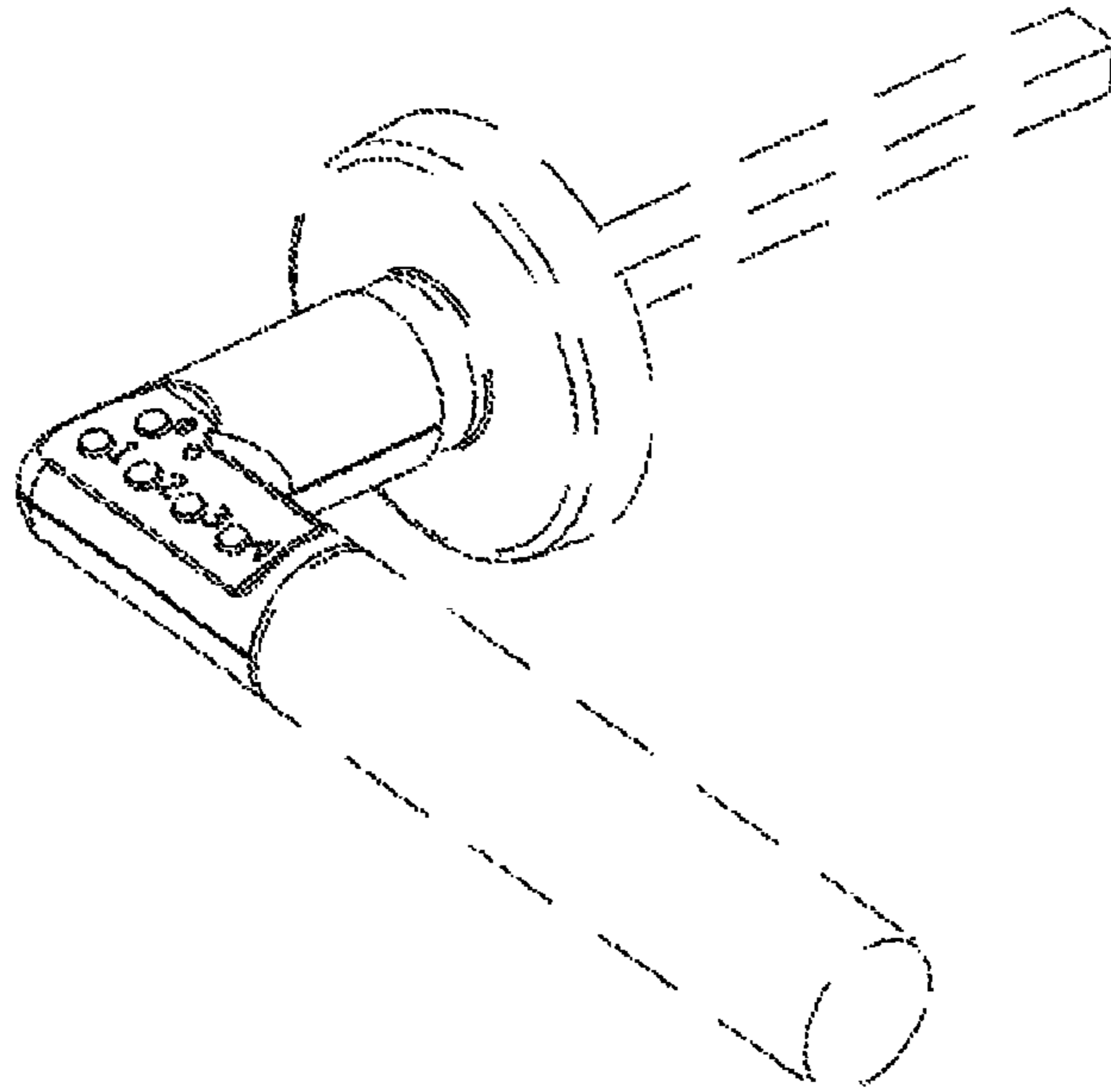

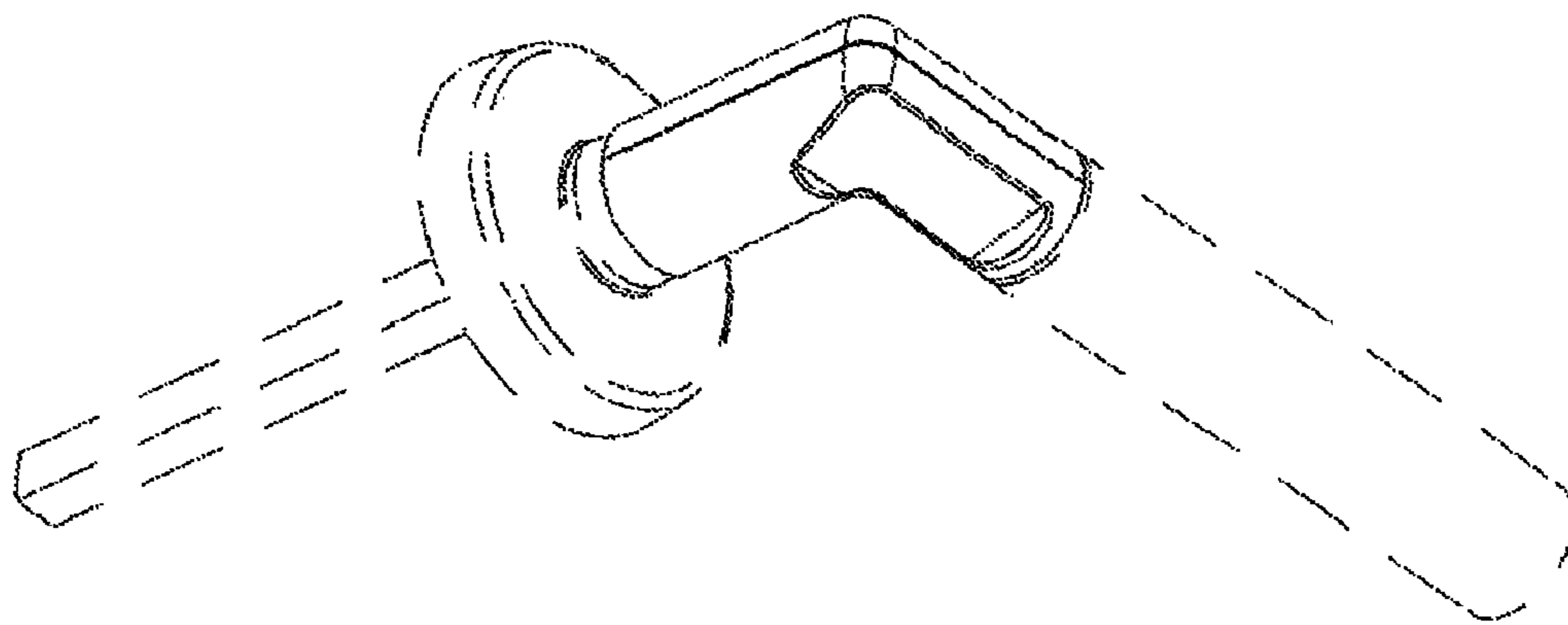

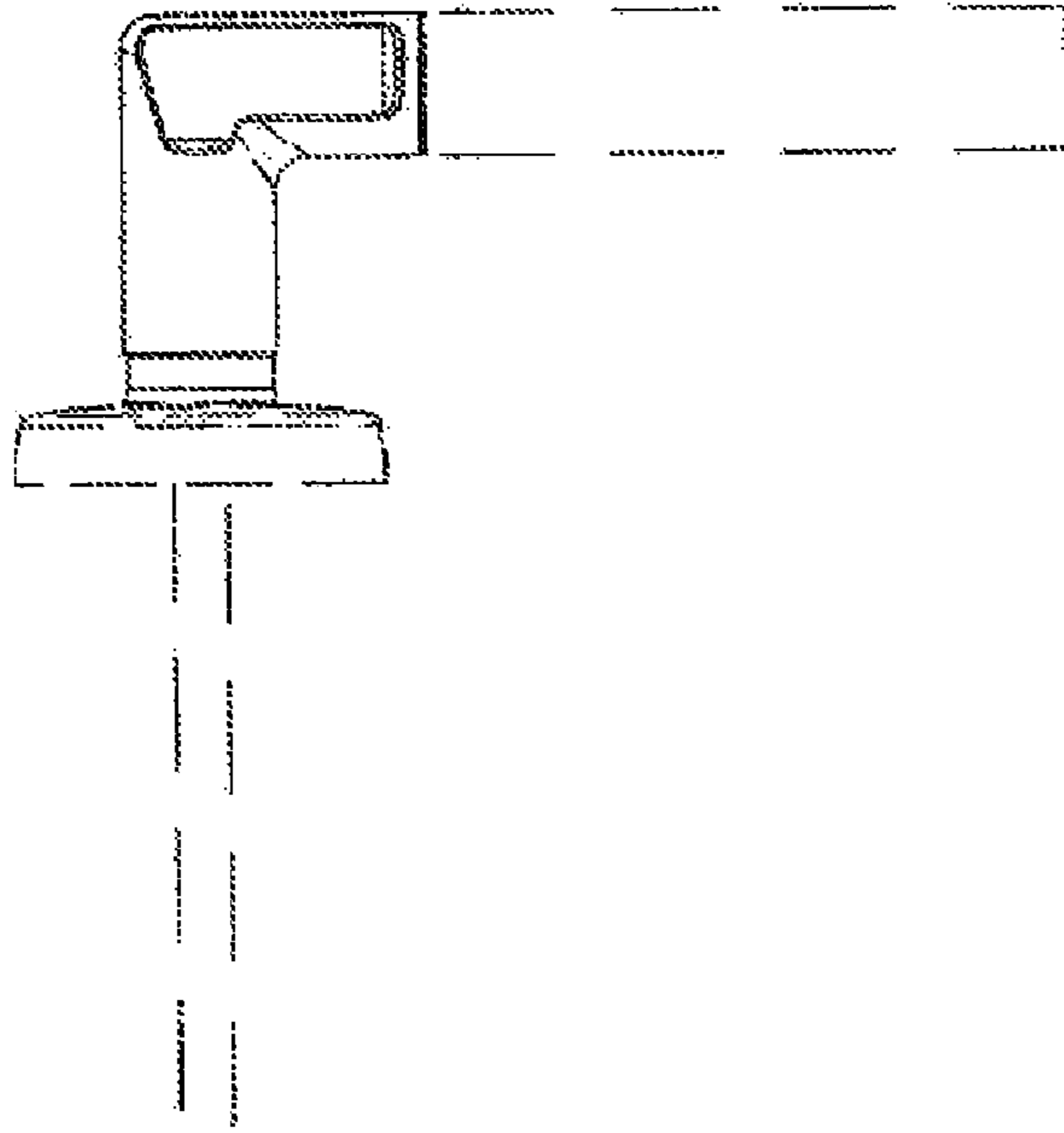

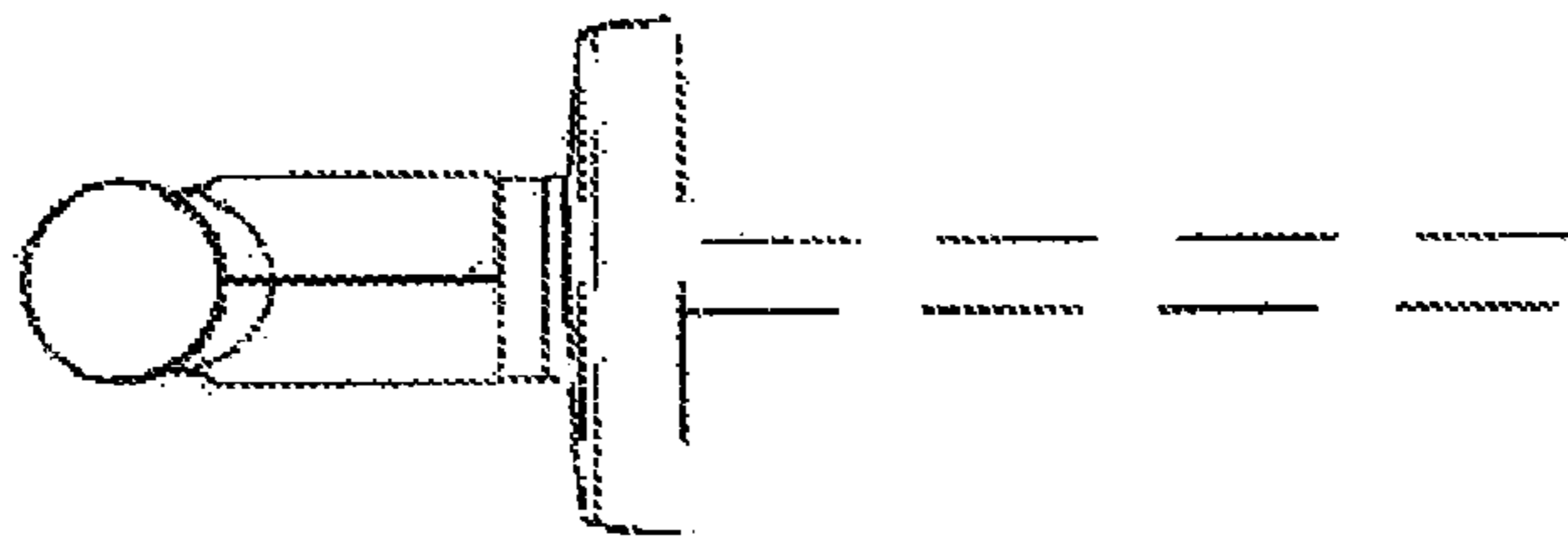

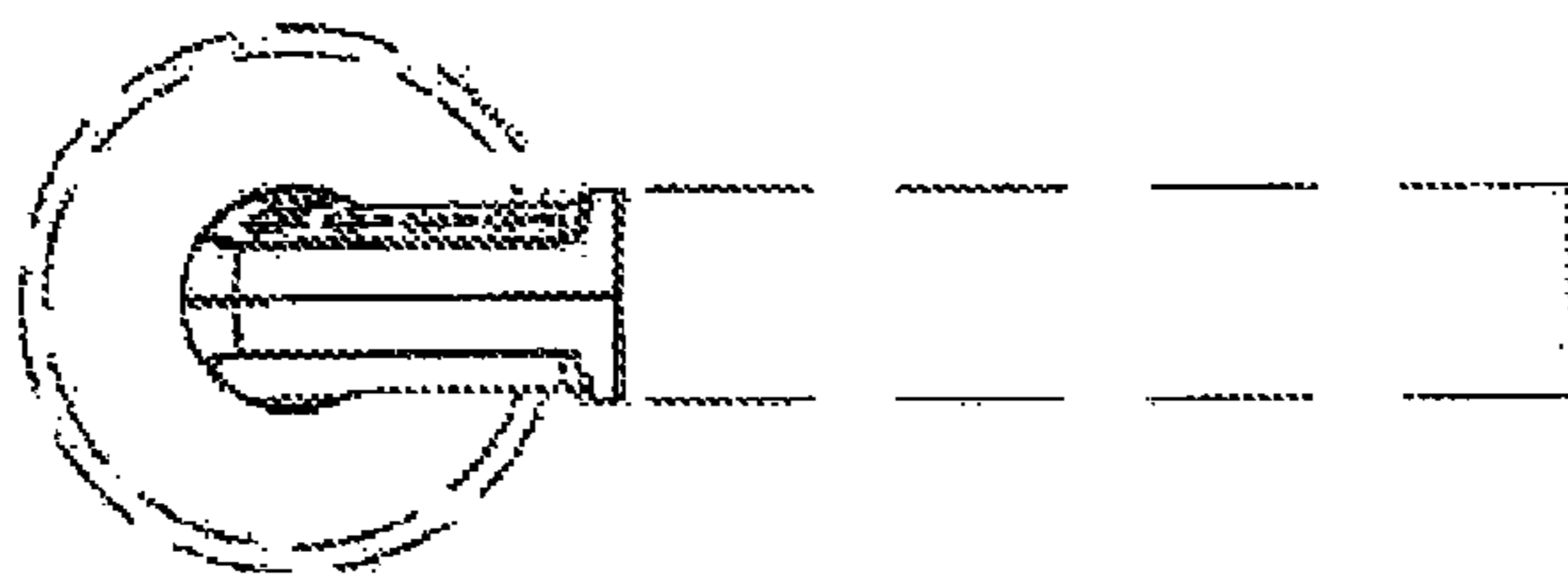

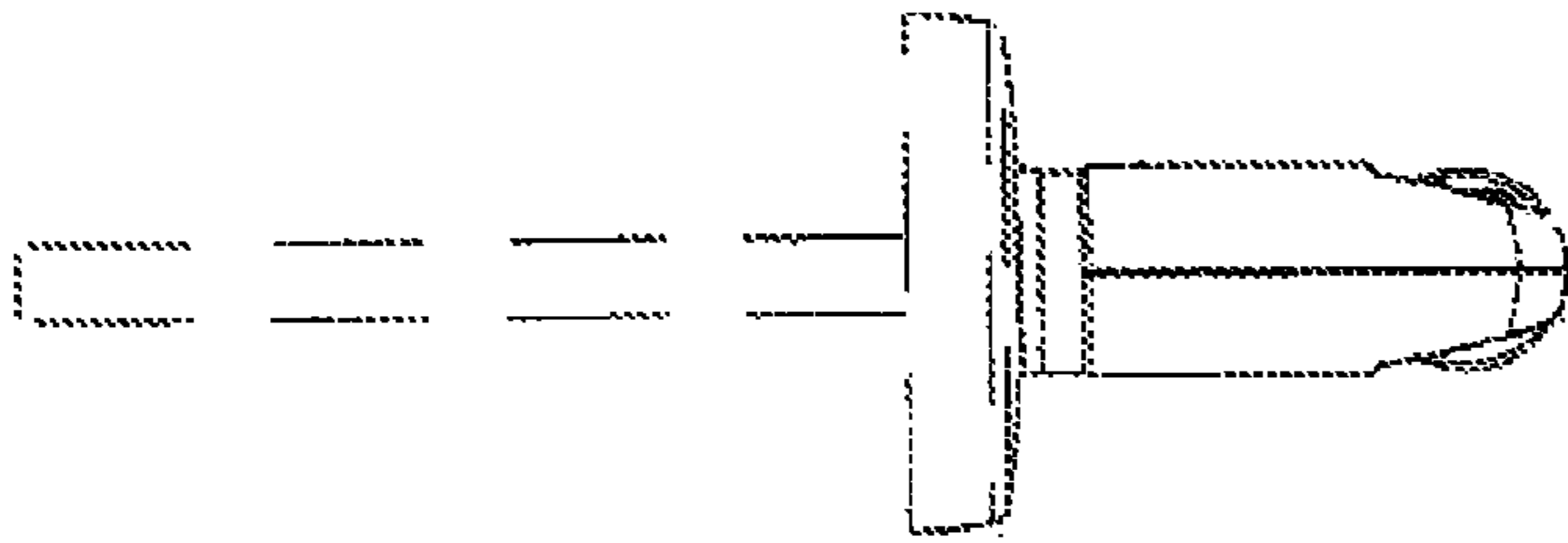

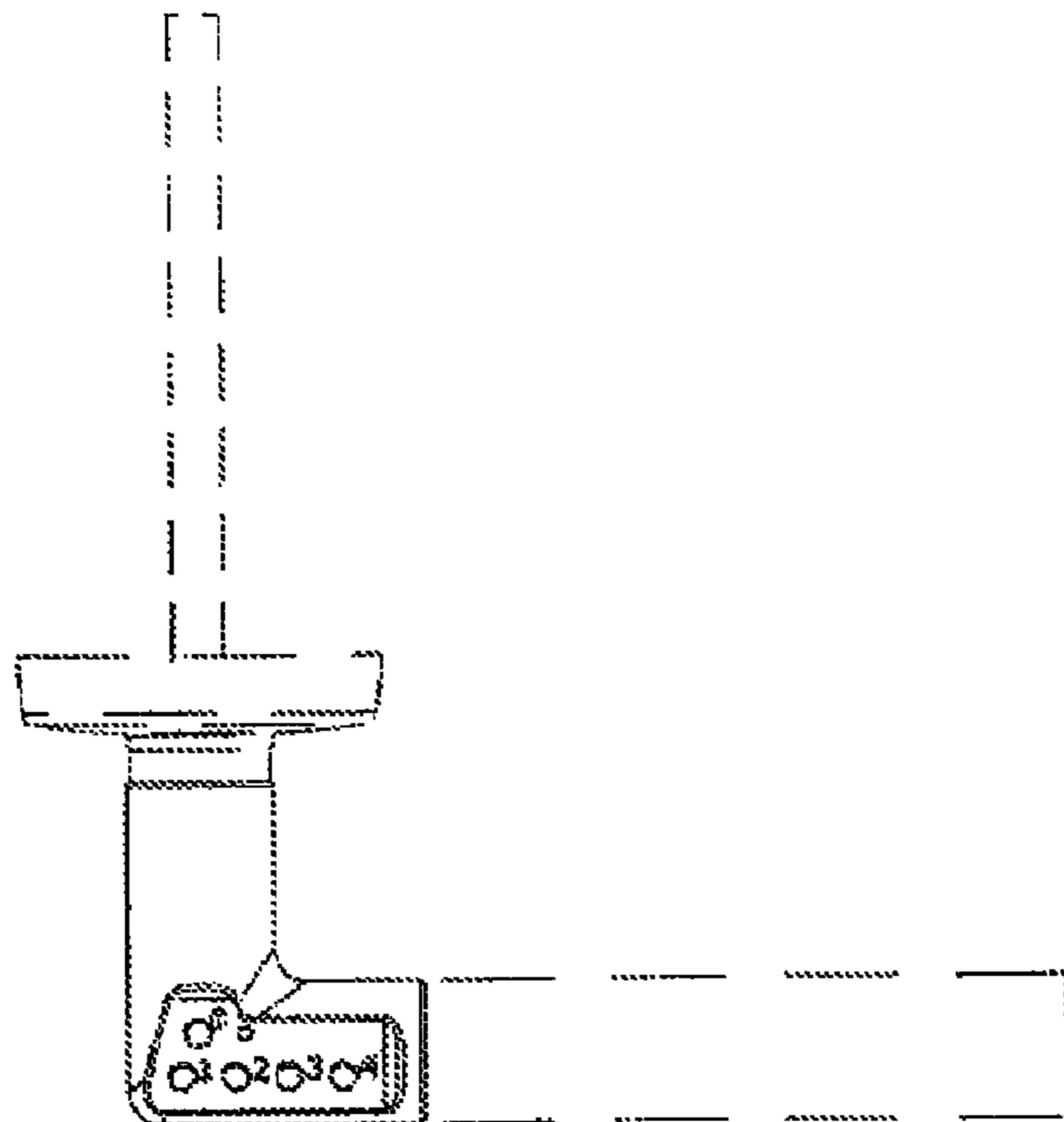
