The ornamental design for a produce container and lid assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a produce container and lid assembly according to our new design;

FIG. 3 is a left side elevation view thereof, the right side view being a mirror image of the left side view;

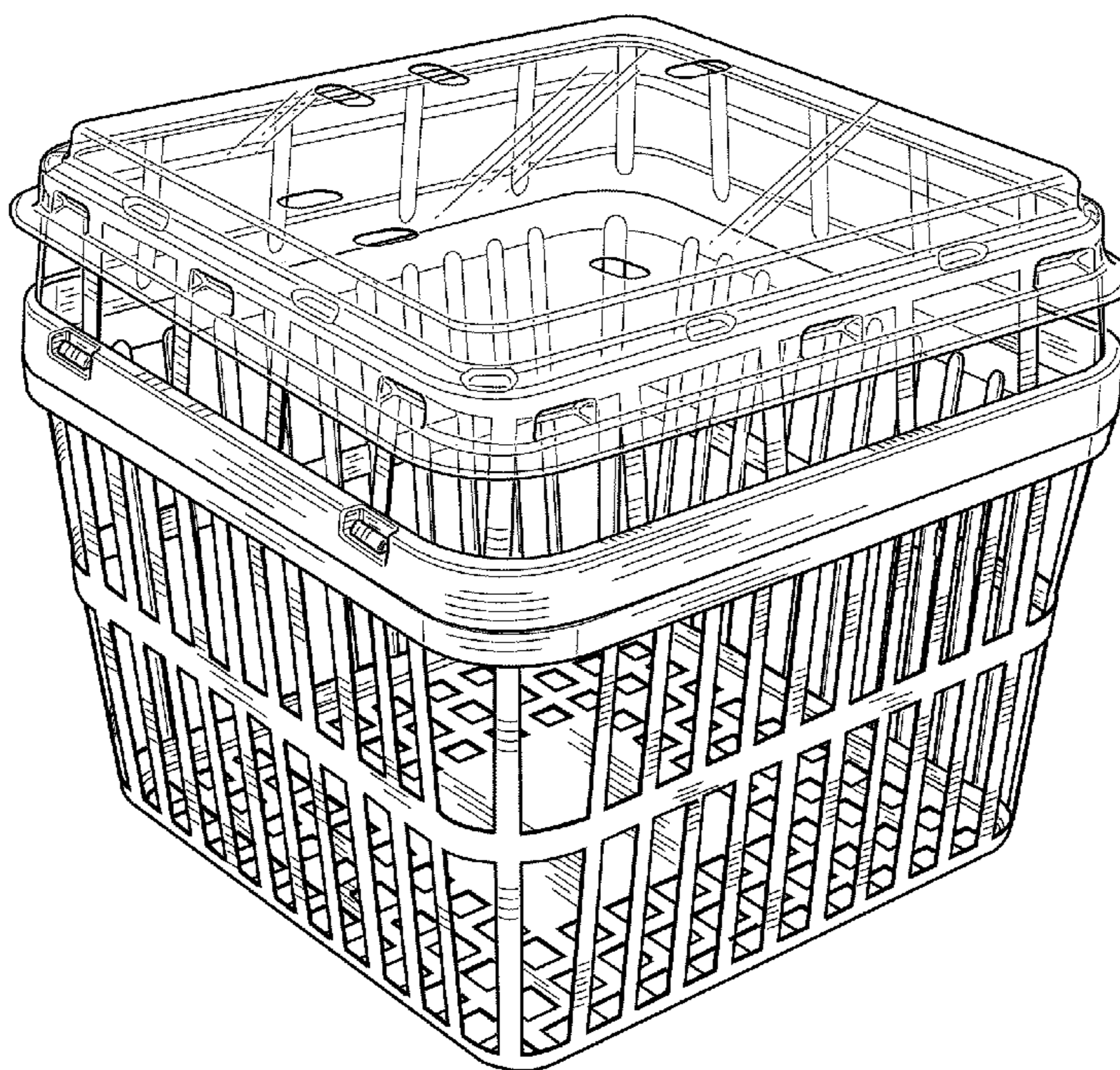
FIG. 4 is a front elevation view thereof;

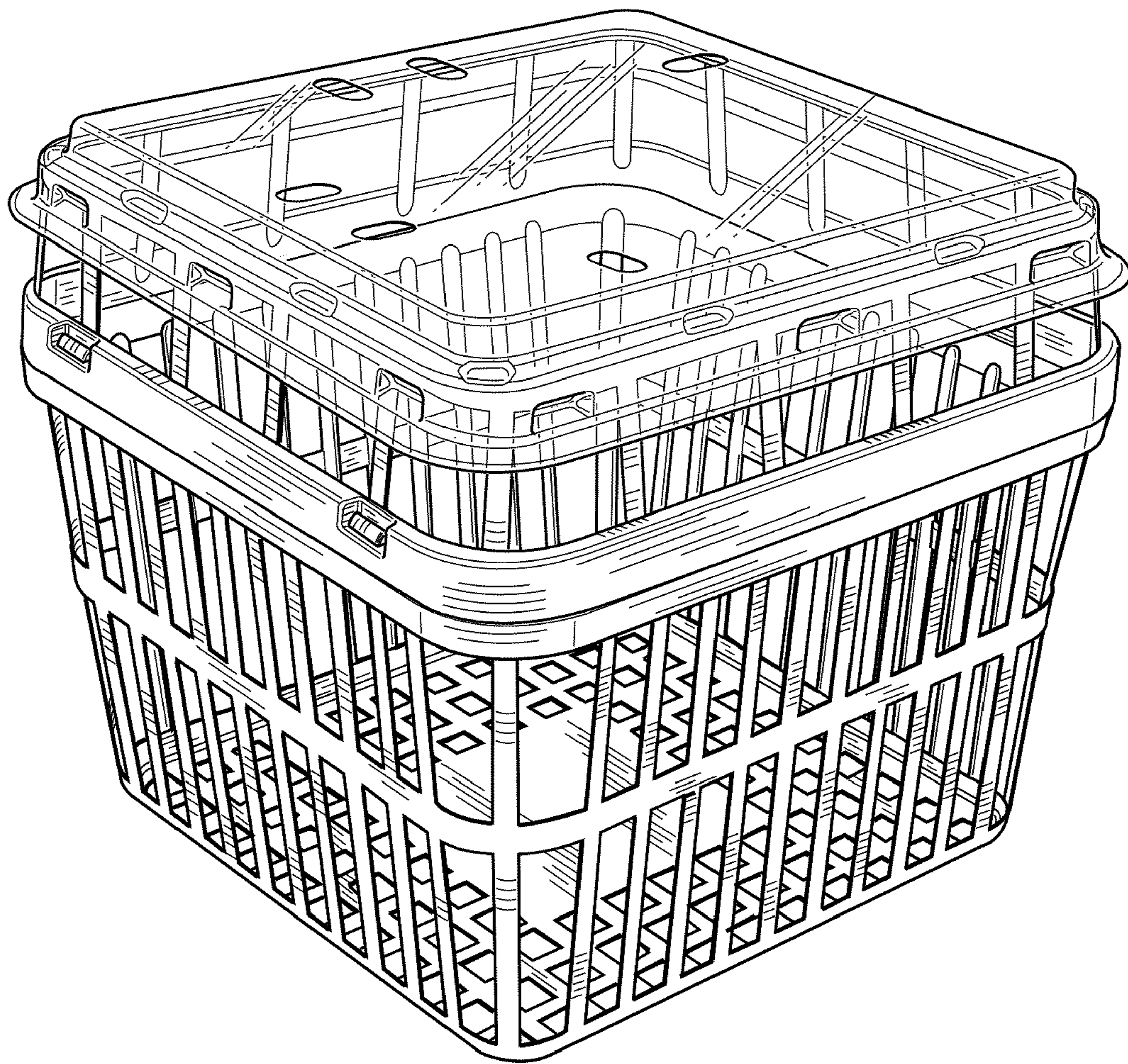

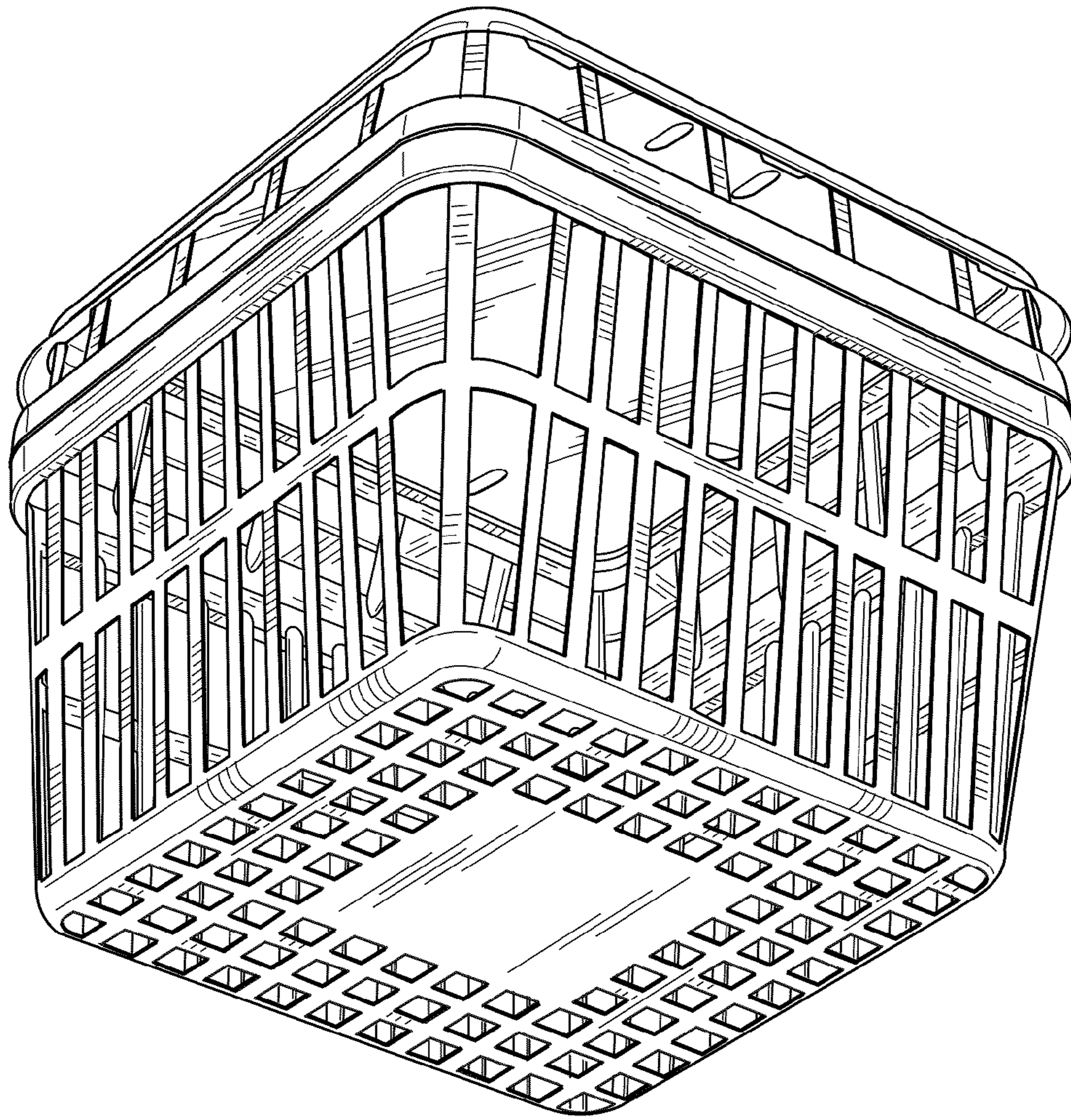
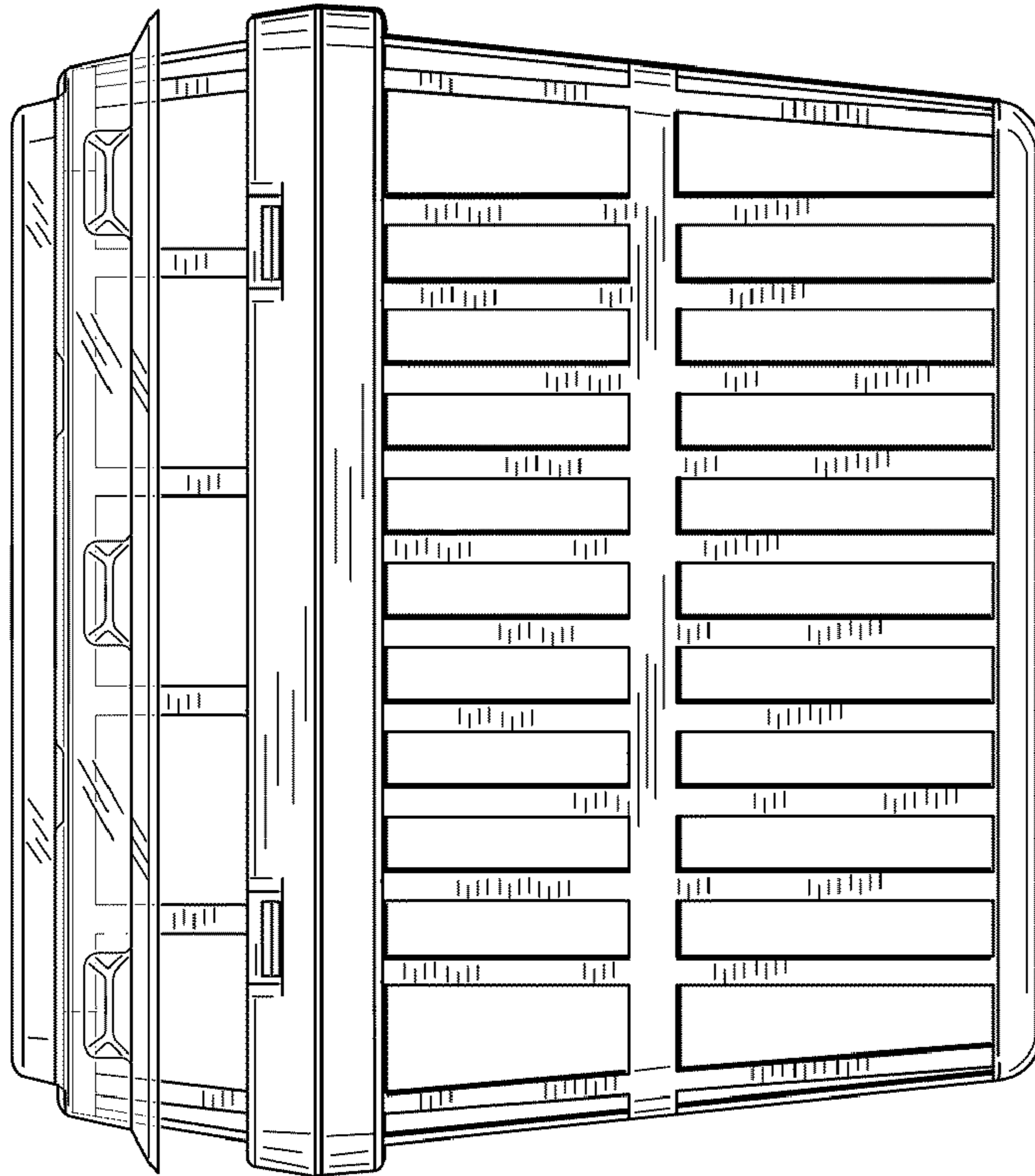
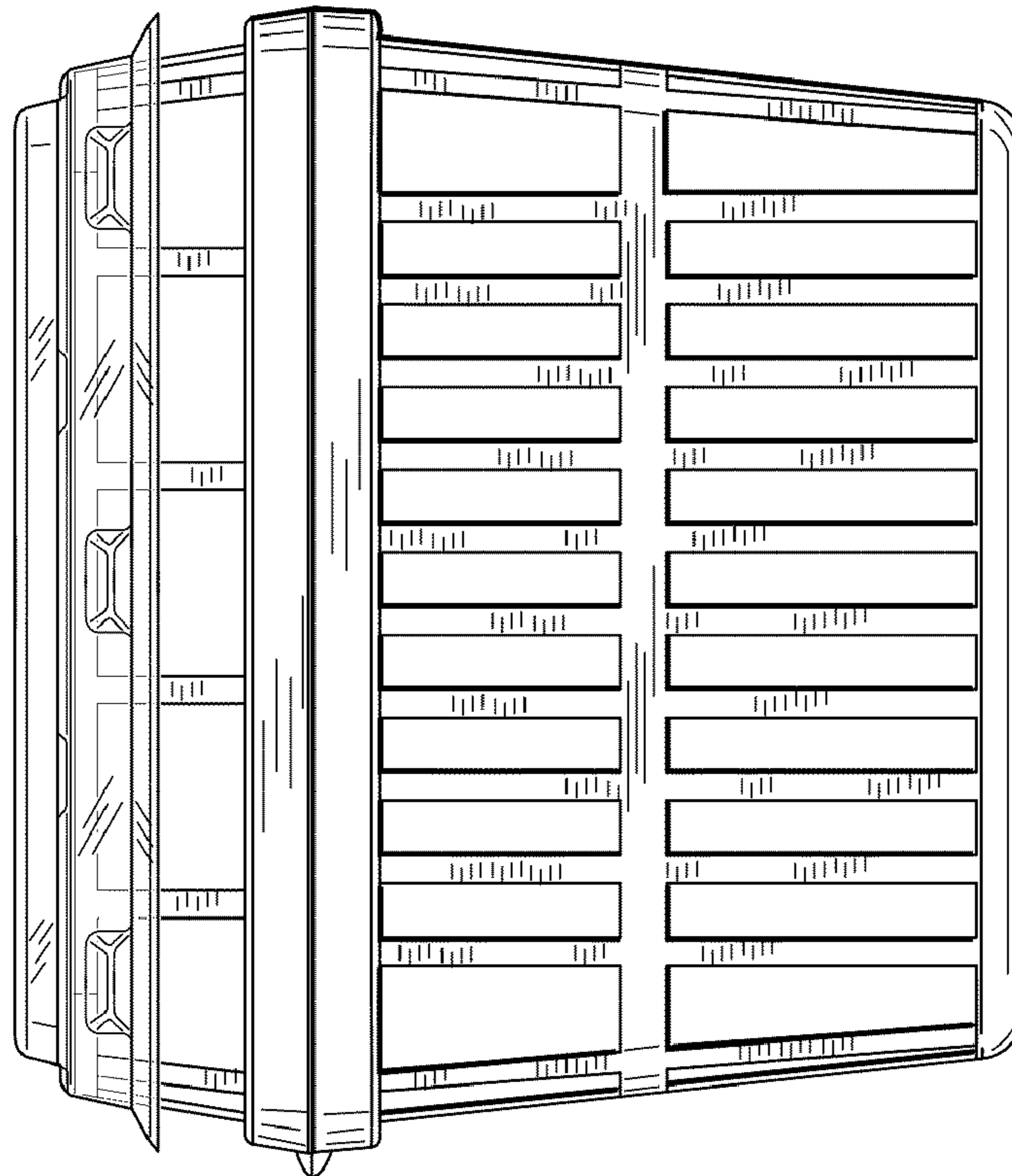


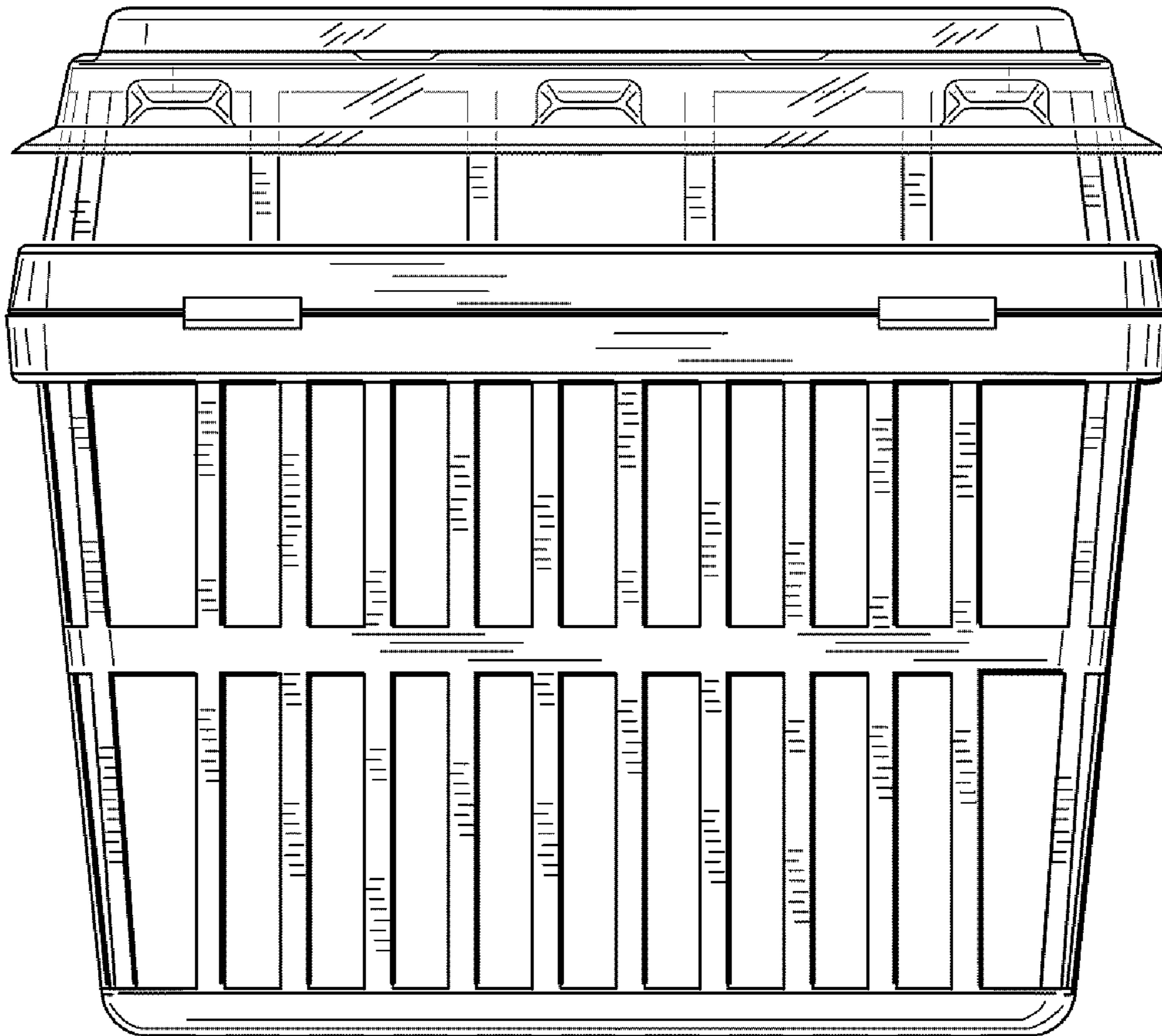

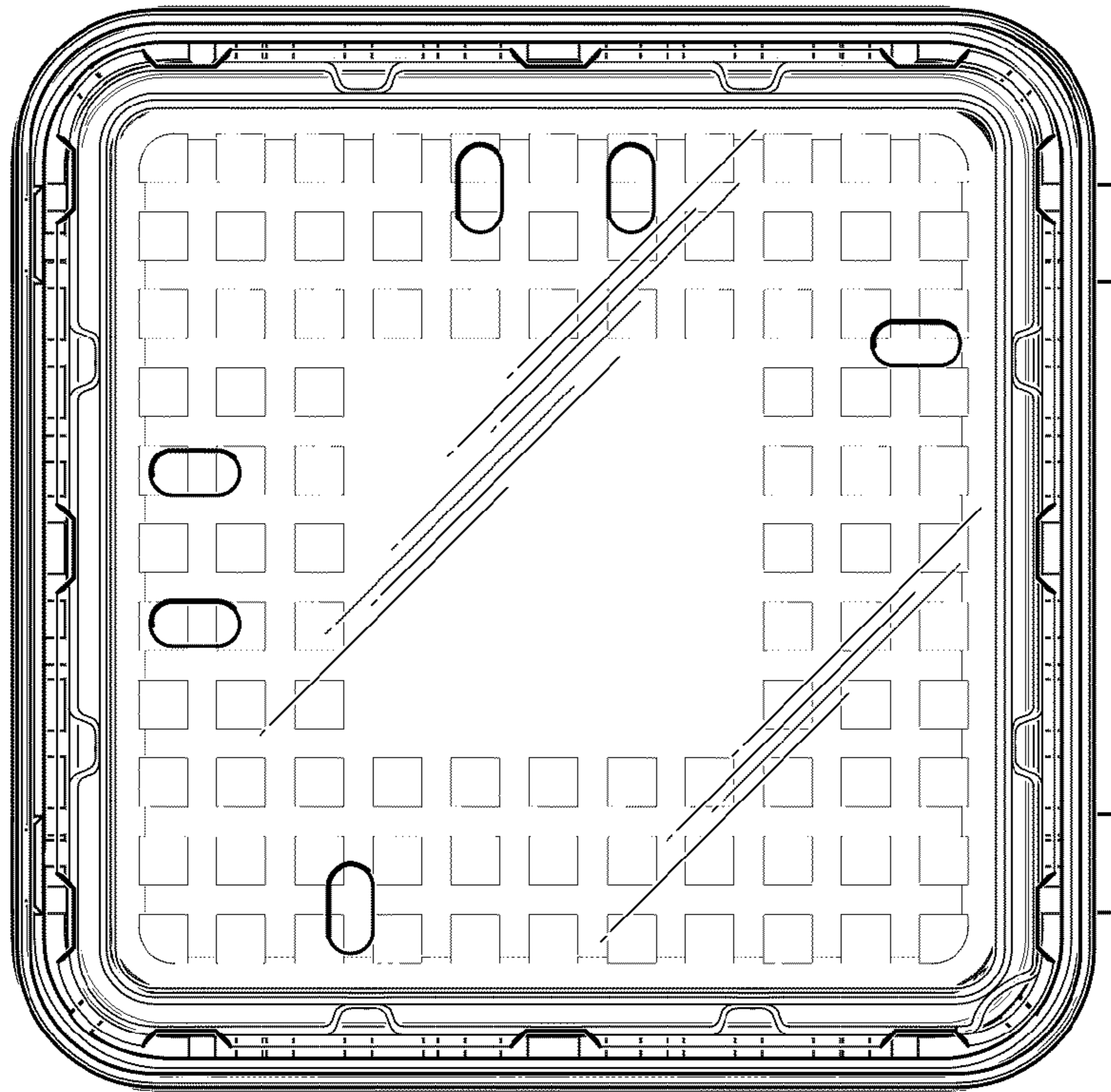

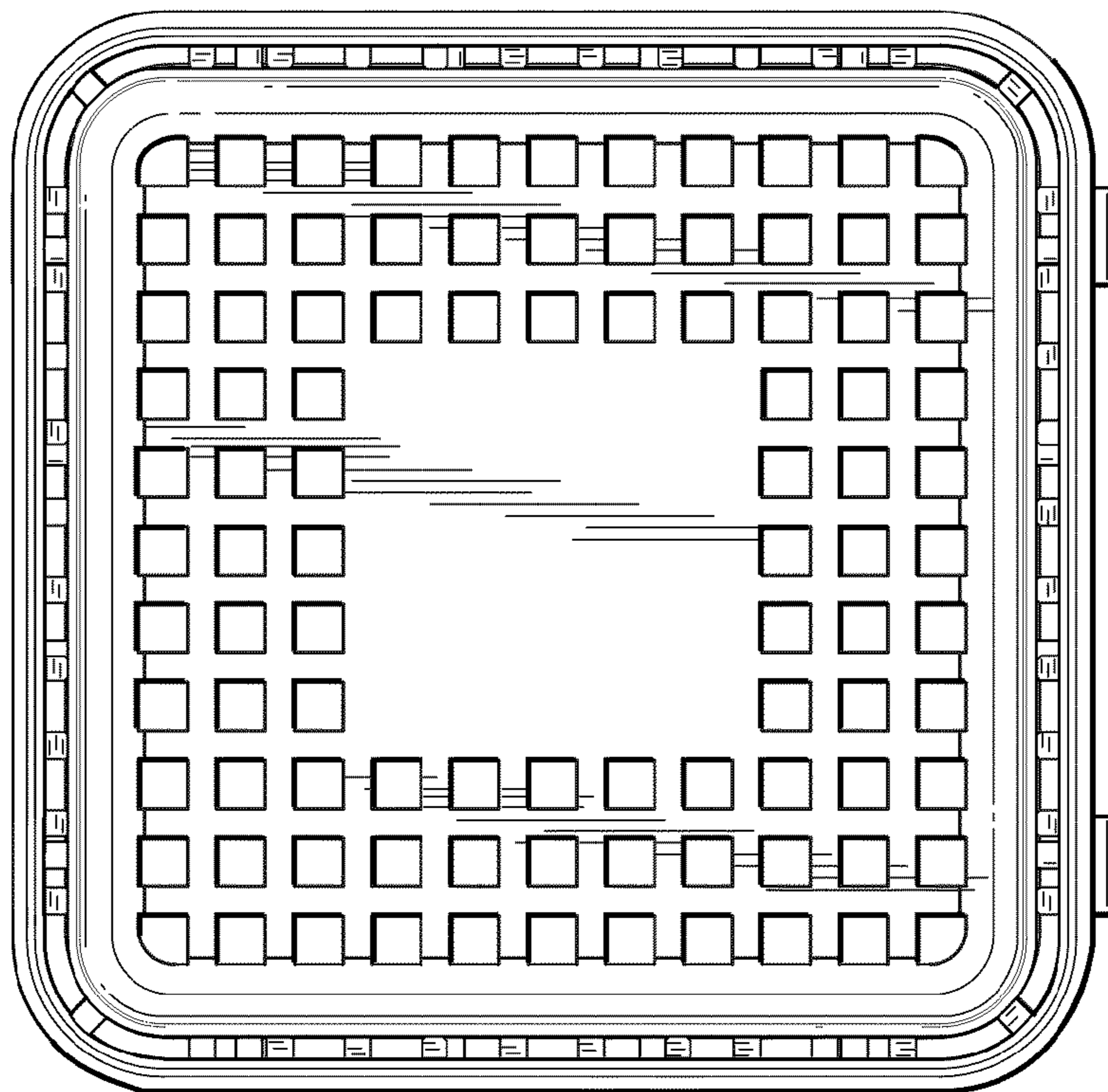
