DESCRIPTION

FIG. 1 is a top and right side perspective view of a watch casing showing my new design;

FIG. 2 is a top plan view thereof;

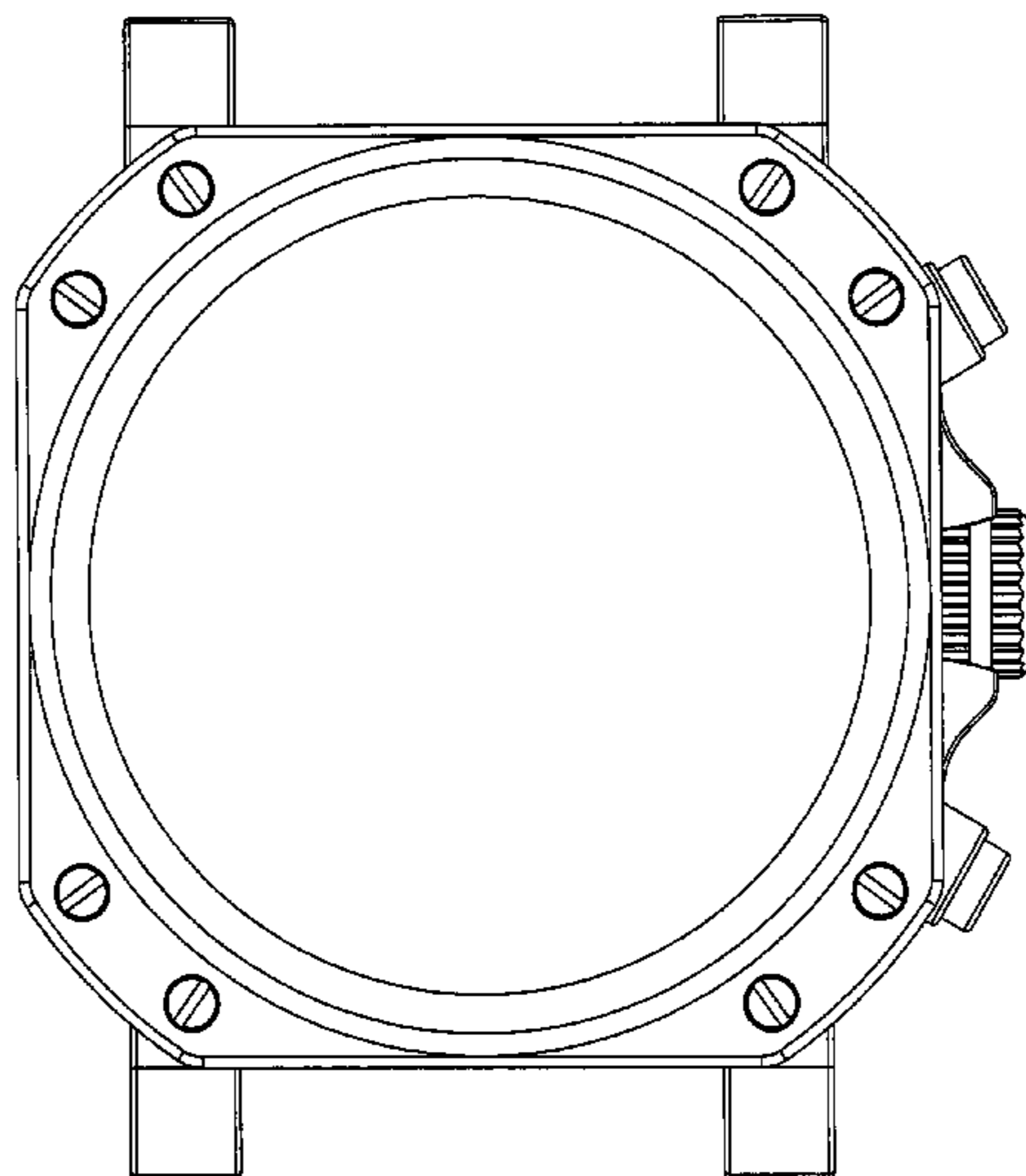
FIG. 3 is a front elevational view thereof with the rear elevation view a mirror image;

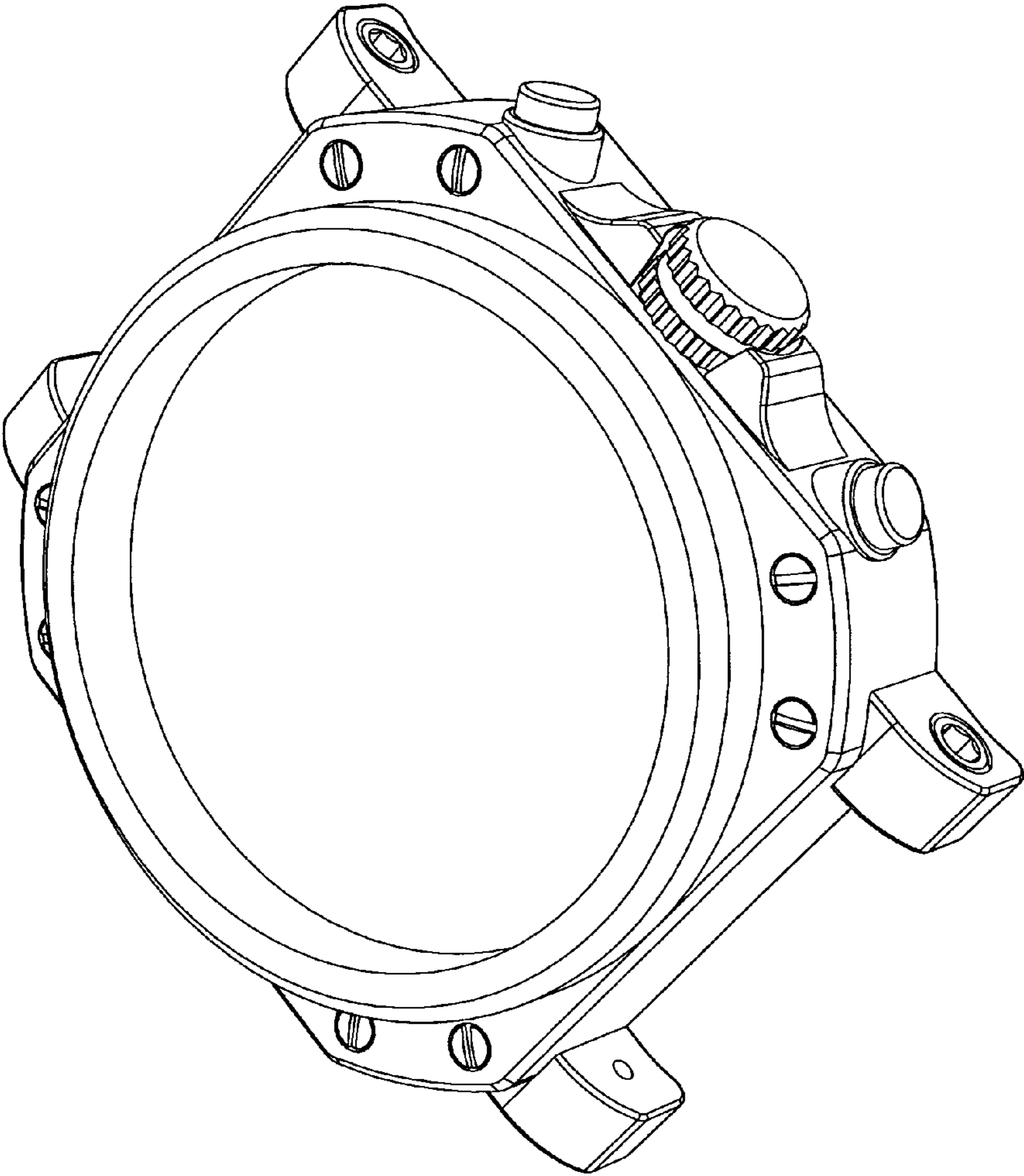

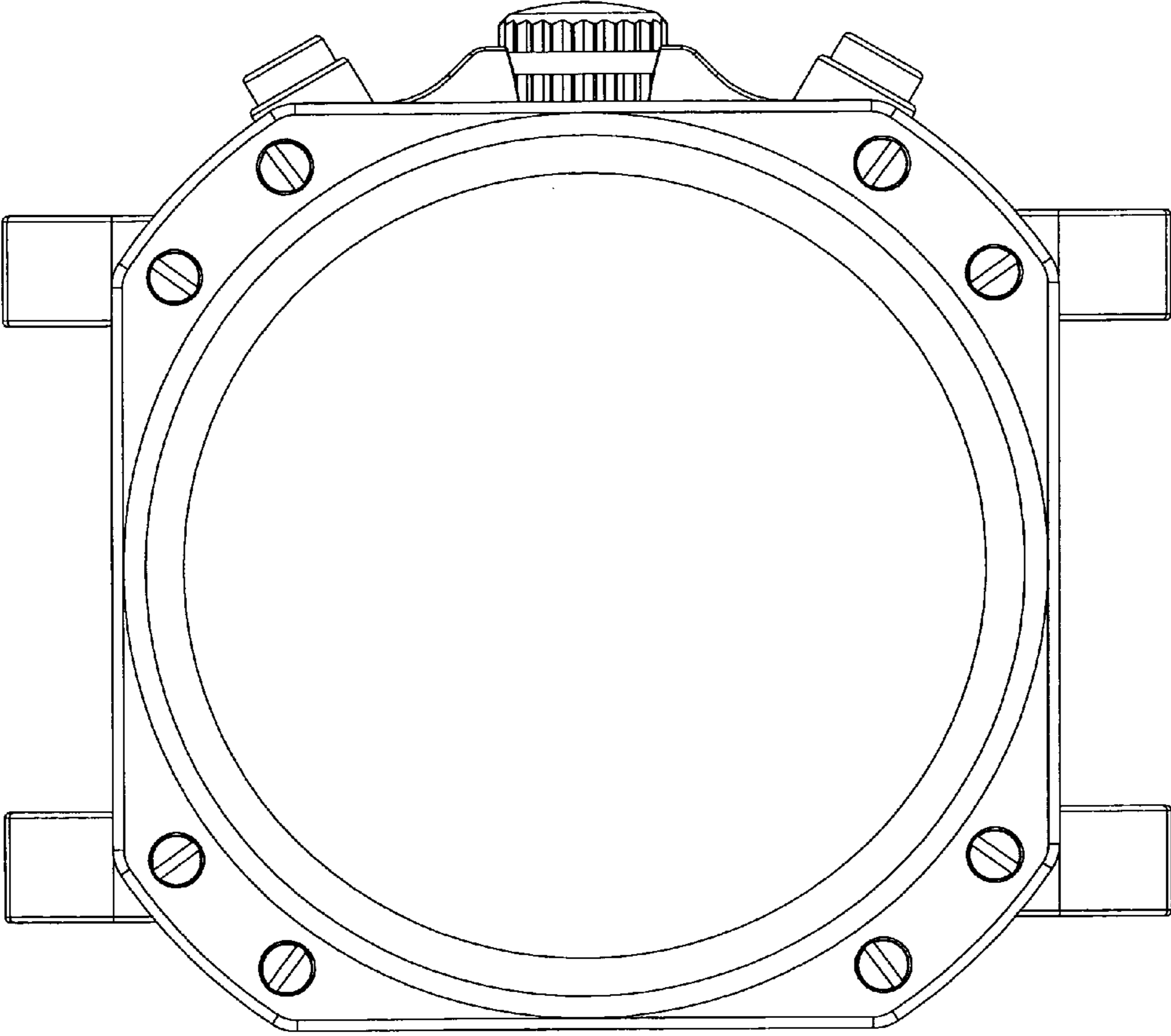

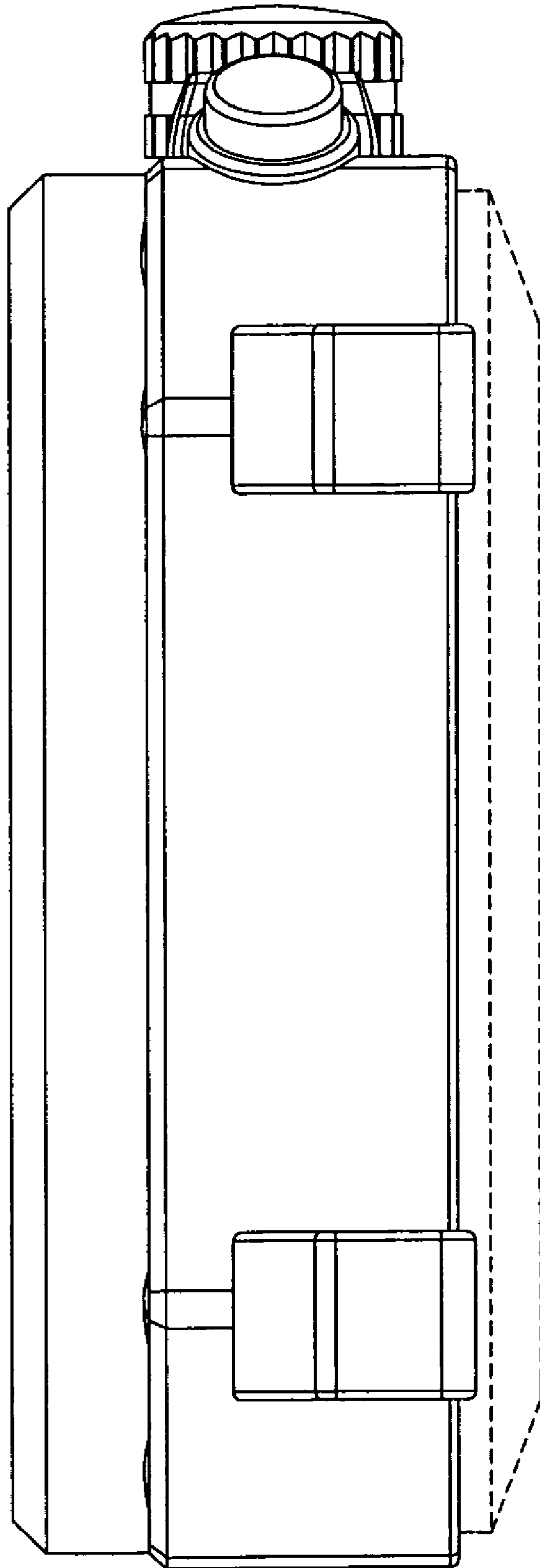

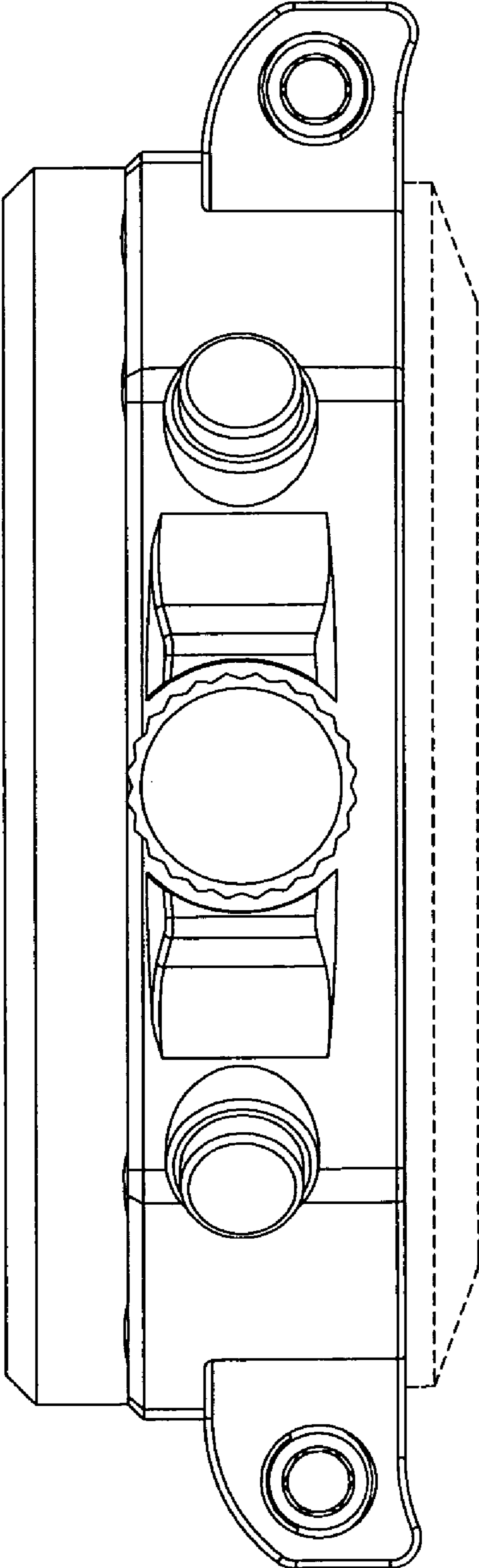

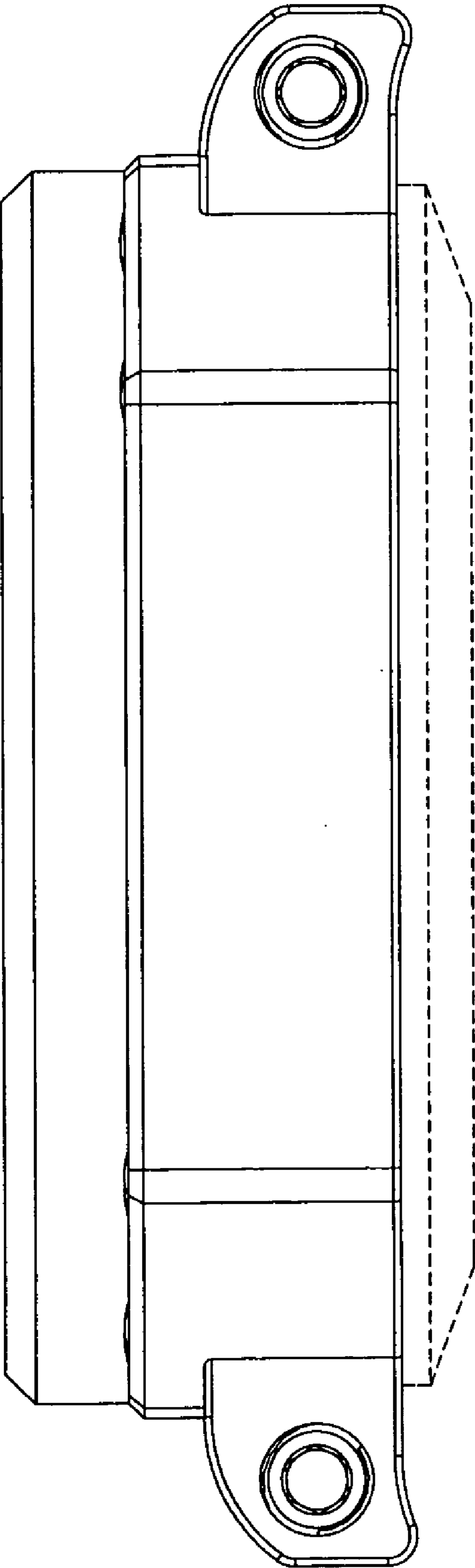
