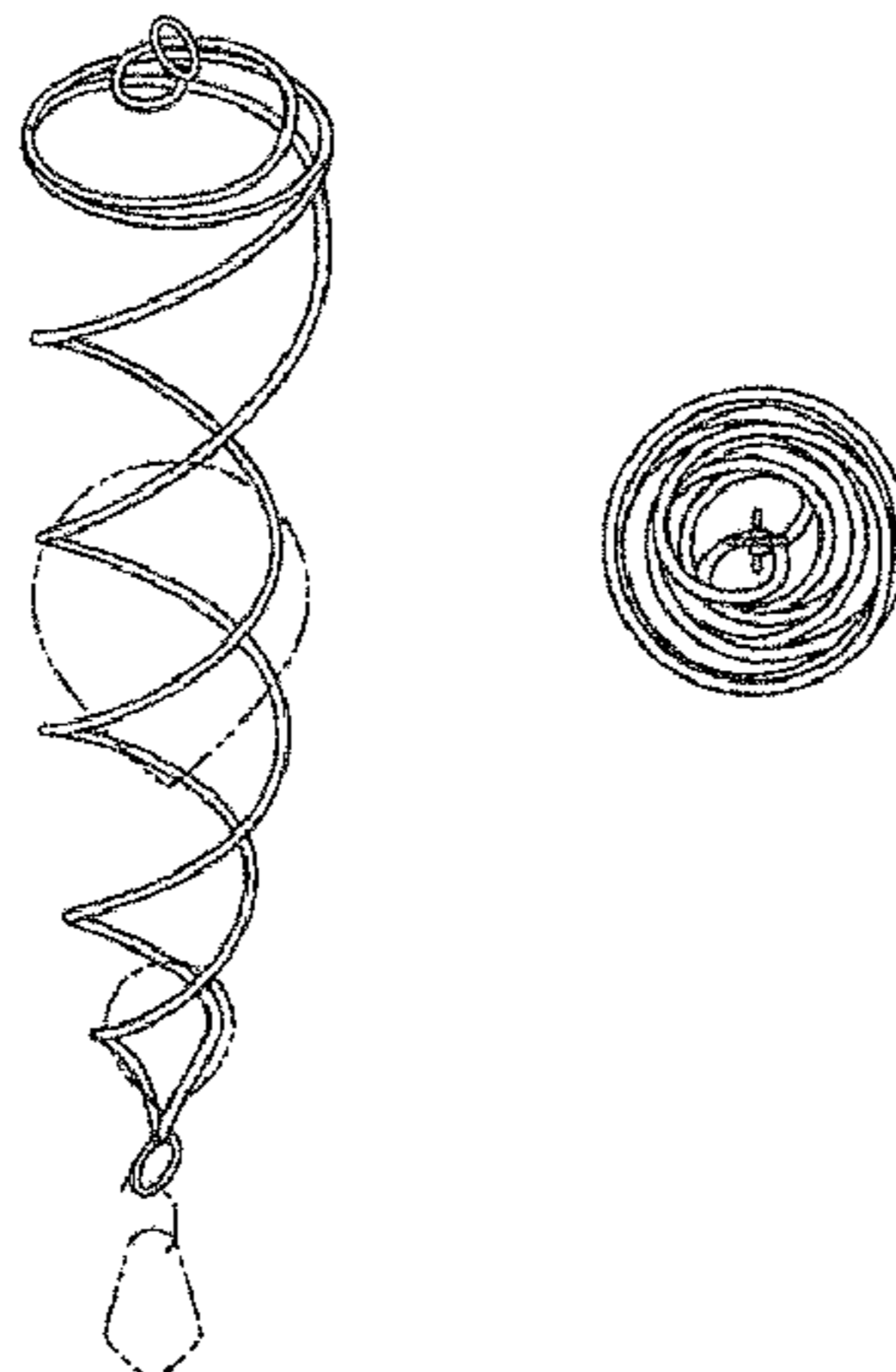
The ornamental design for a hanging ornament, as shown and described.

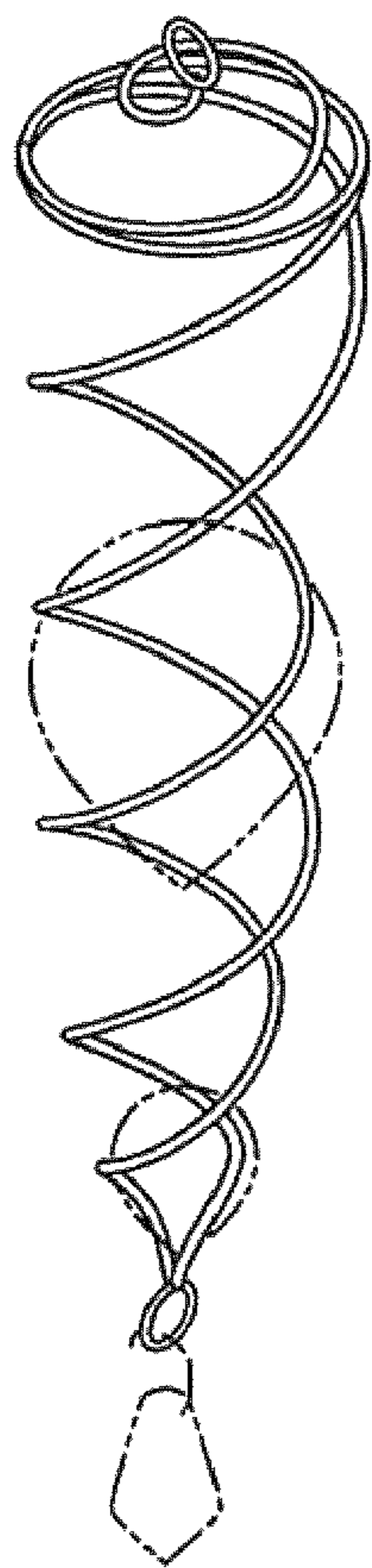

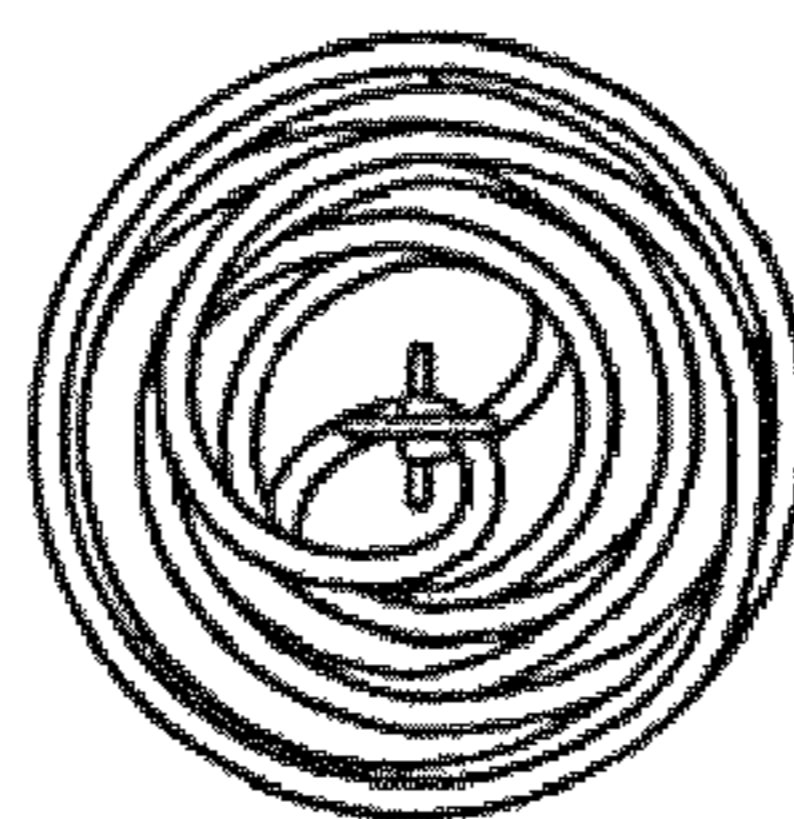

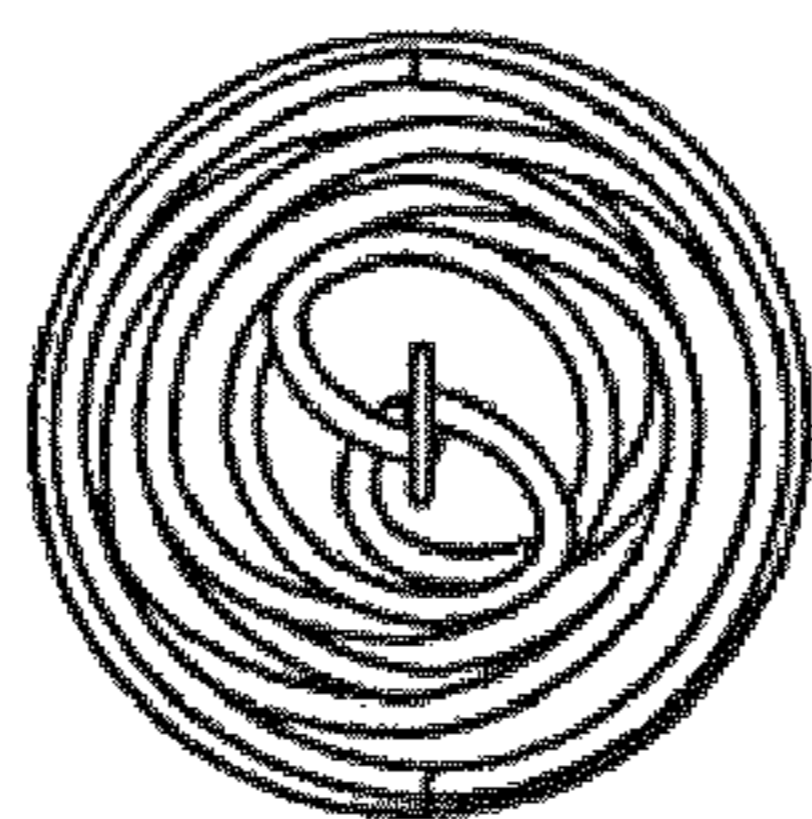

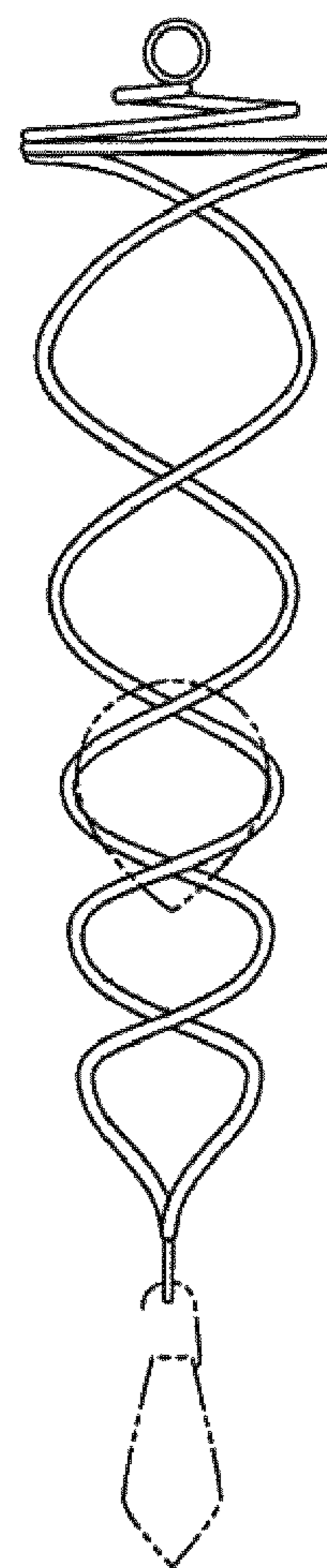

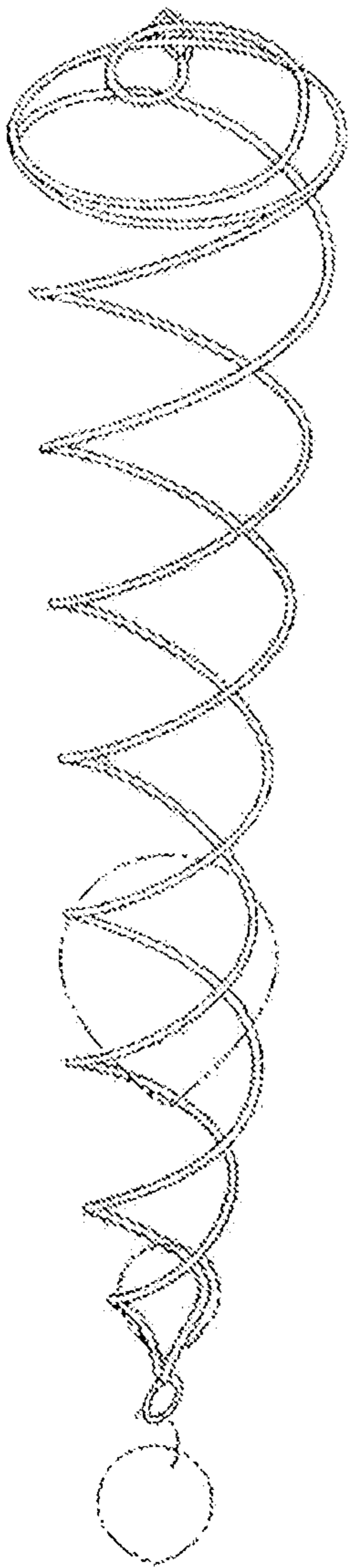

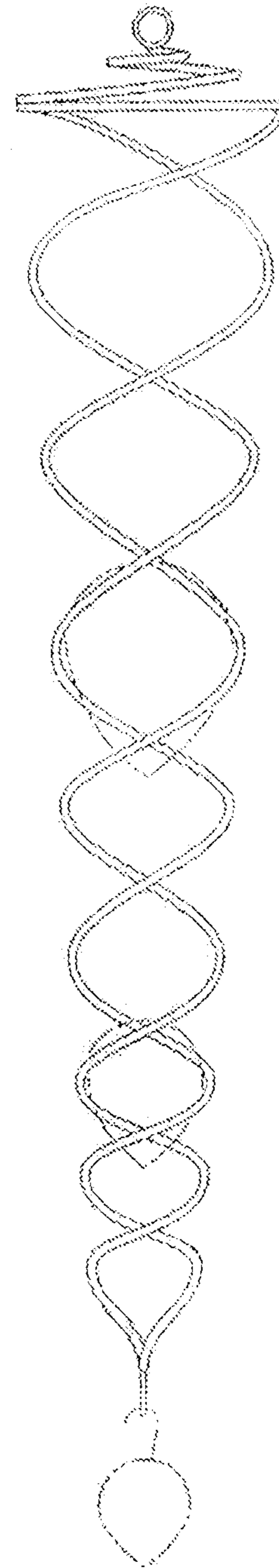
