FIG. 3 is a bottom view of the wall hanging;

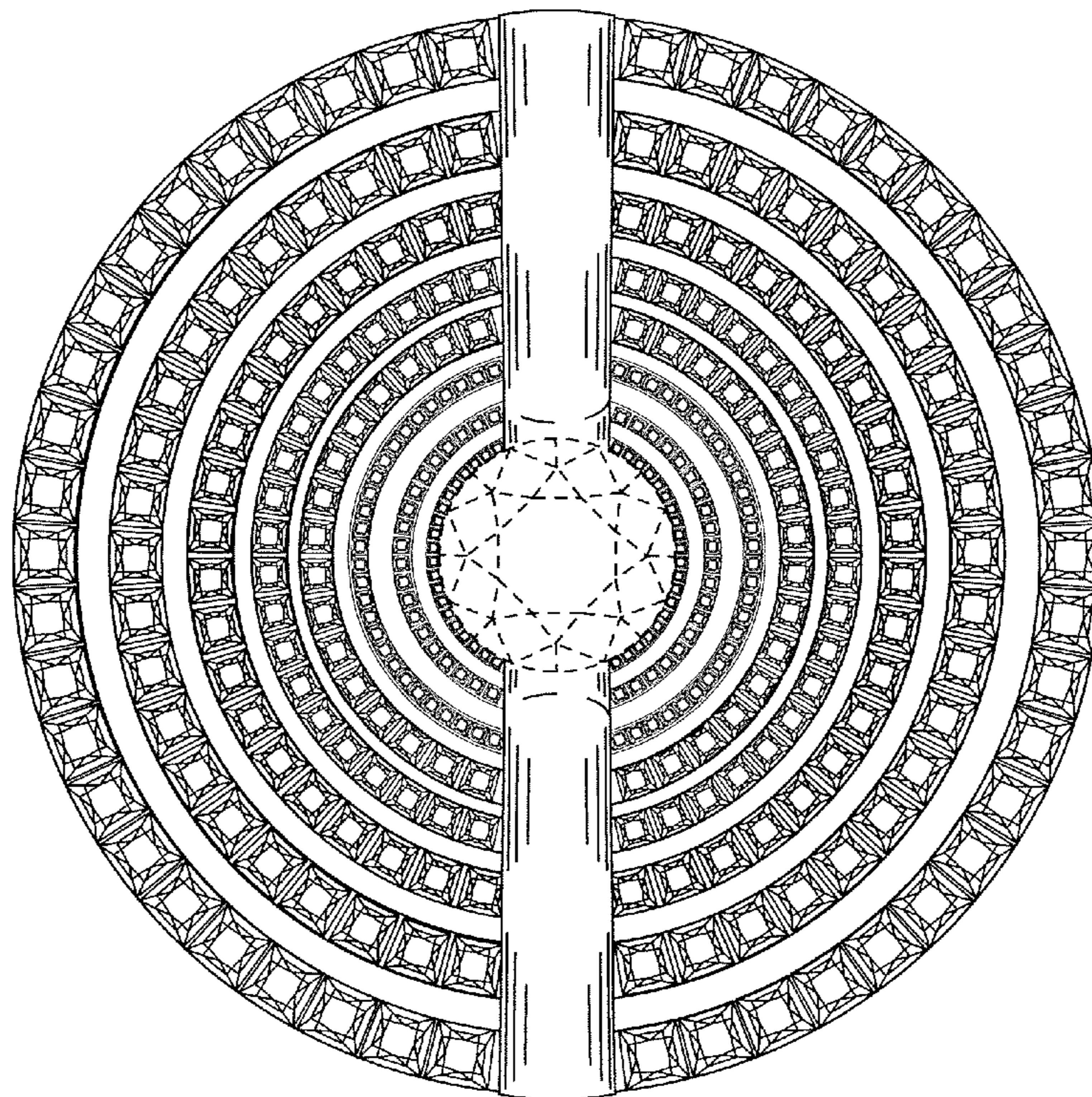
FIG. 4 is a right side view of the wall hanging;

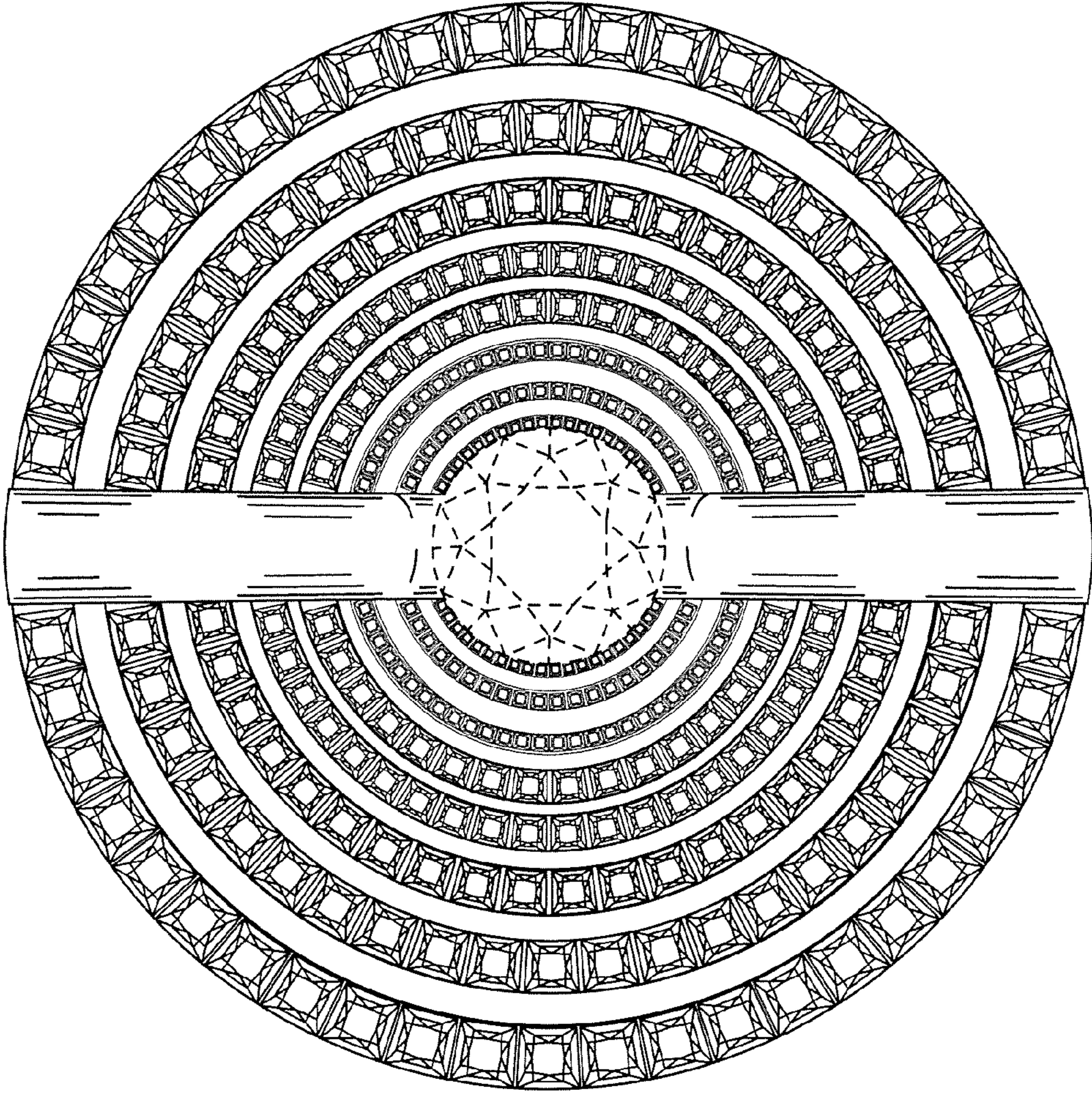

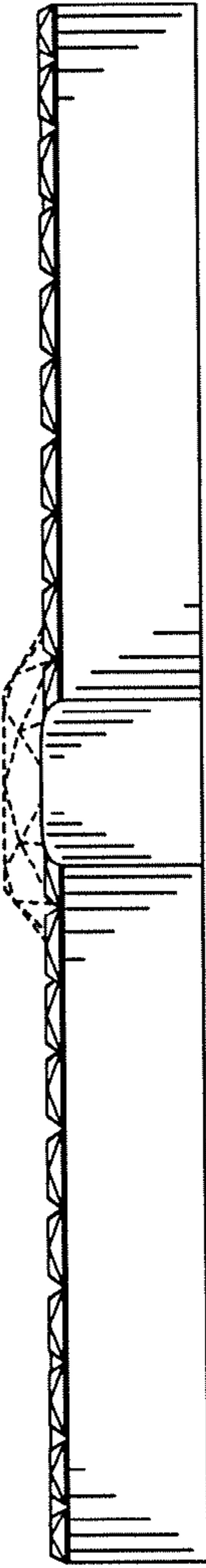

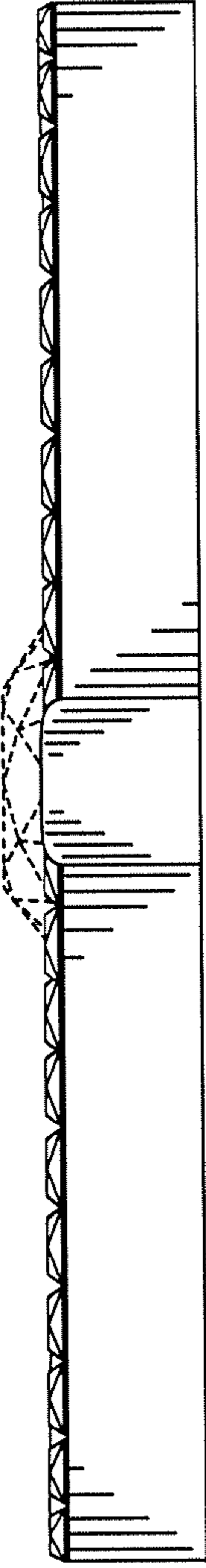

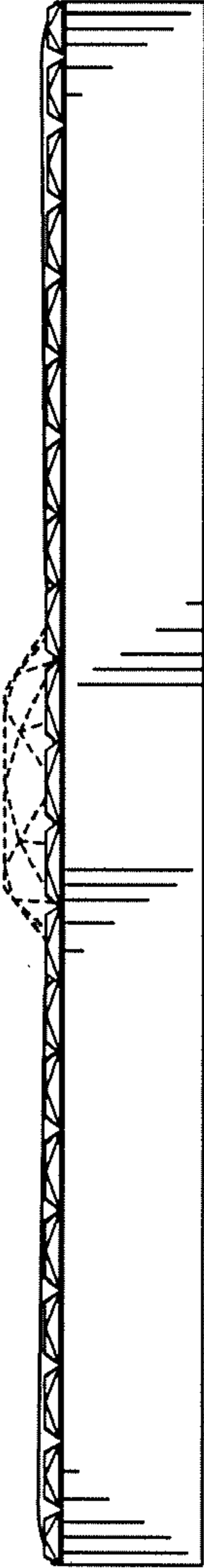

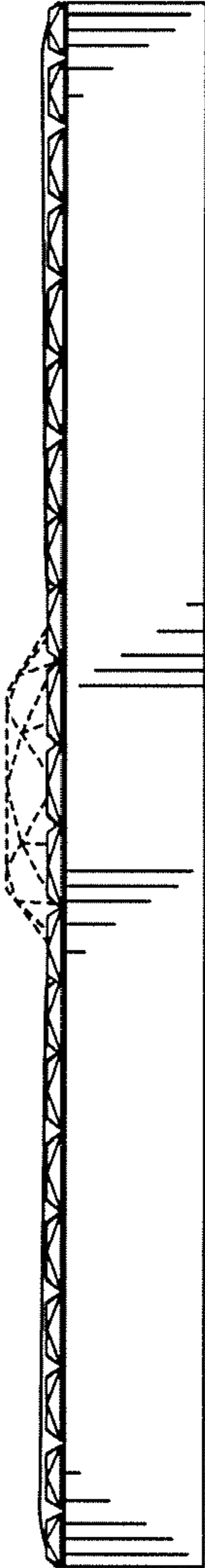

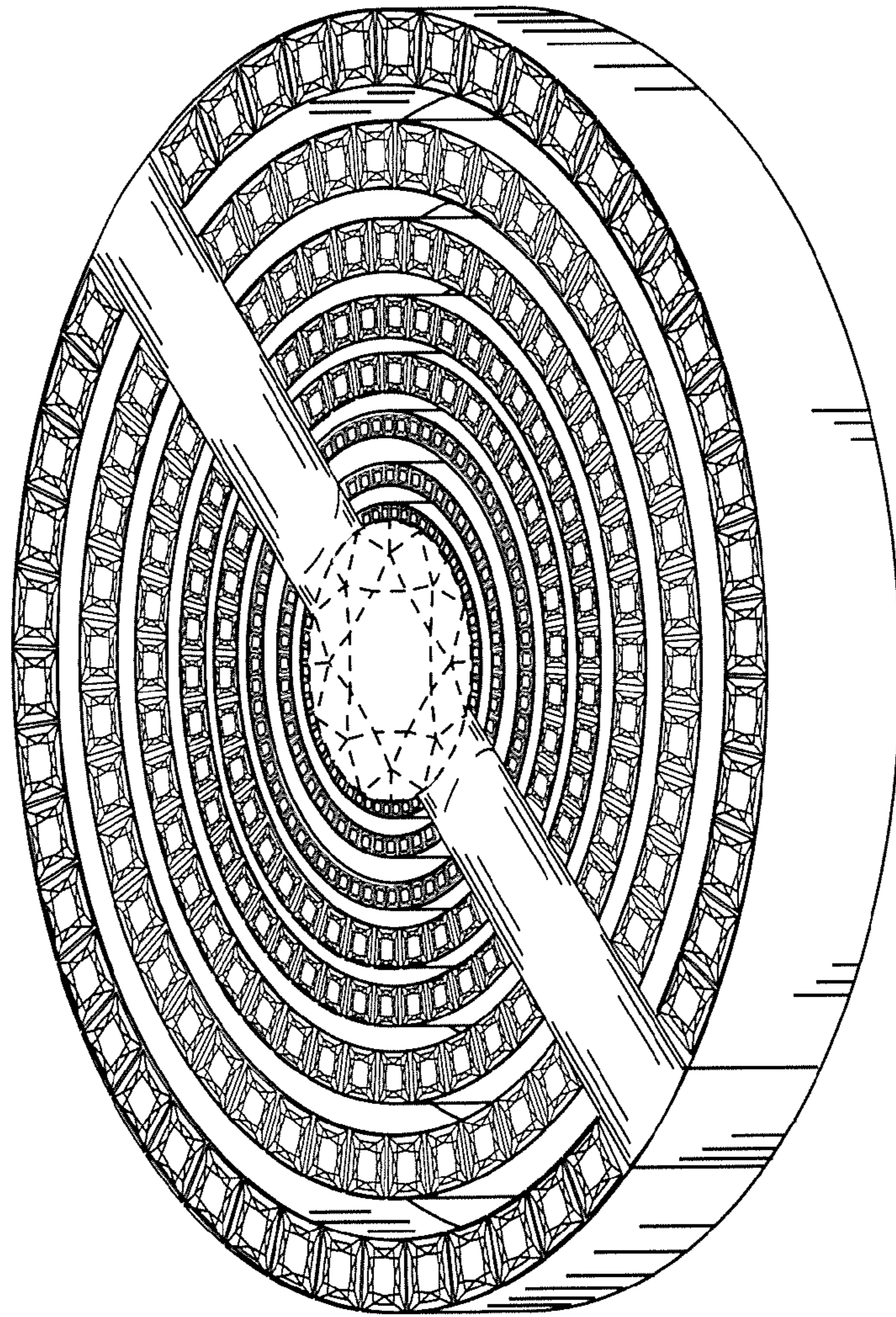
