FIG. 3 is a top view of the zipper pull ornament shown in FIG. 1; and,

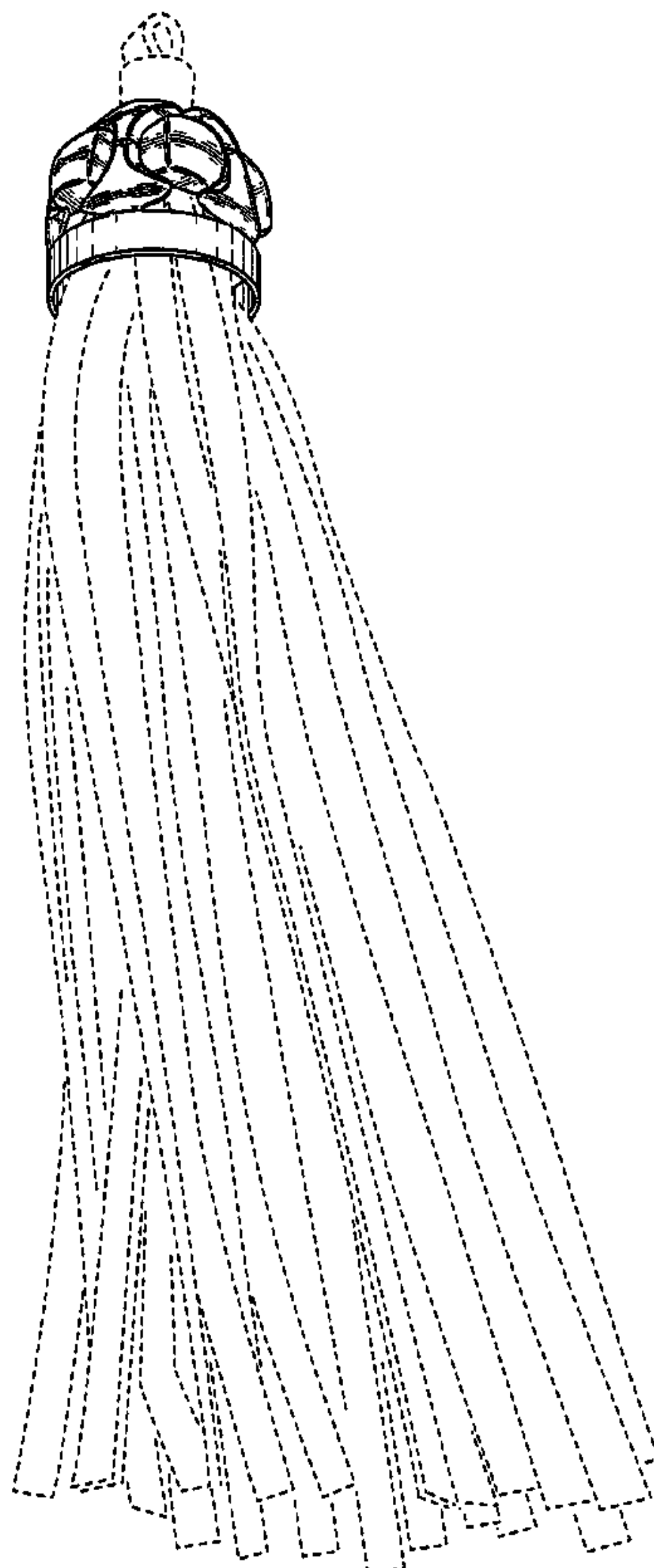

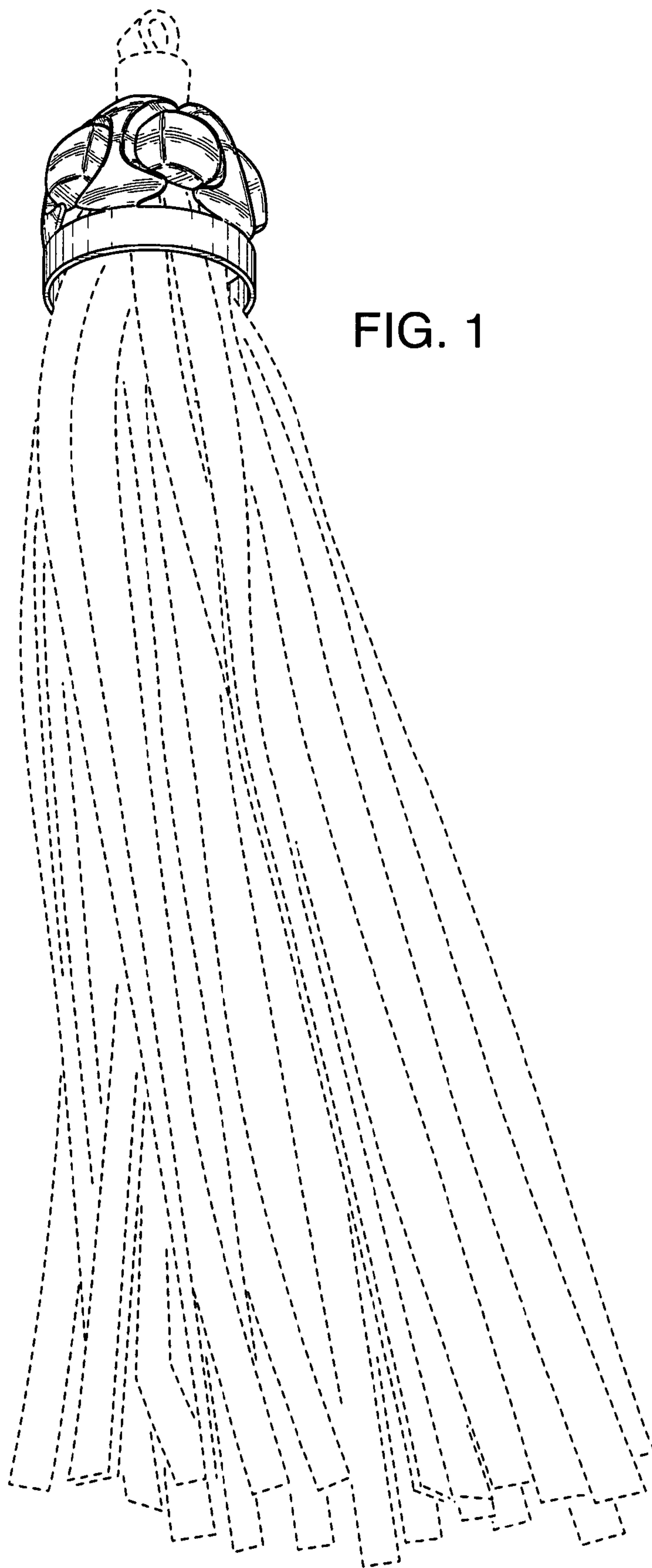

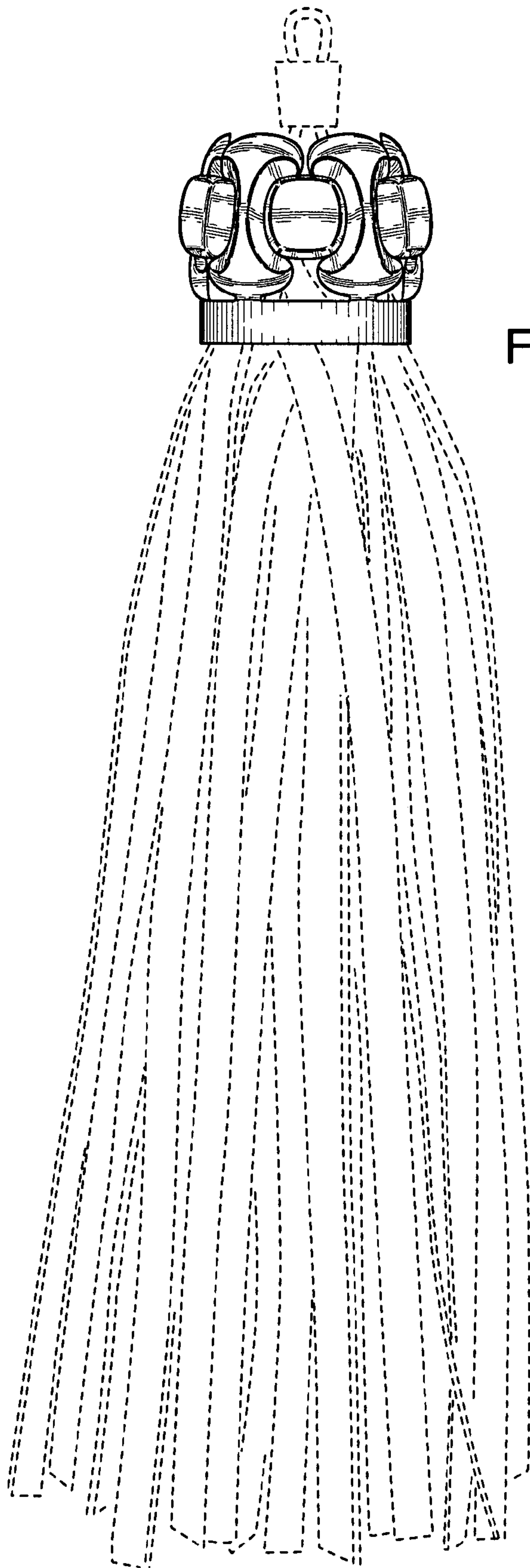

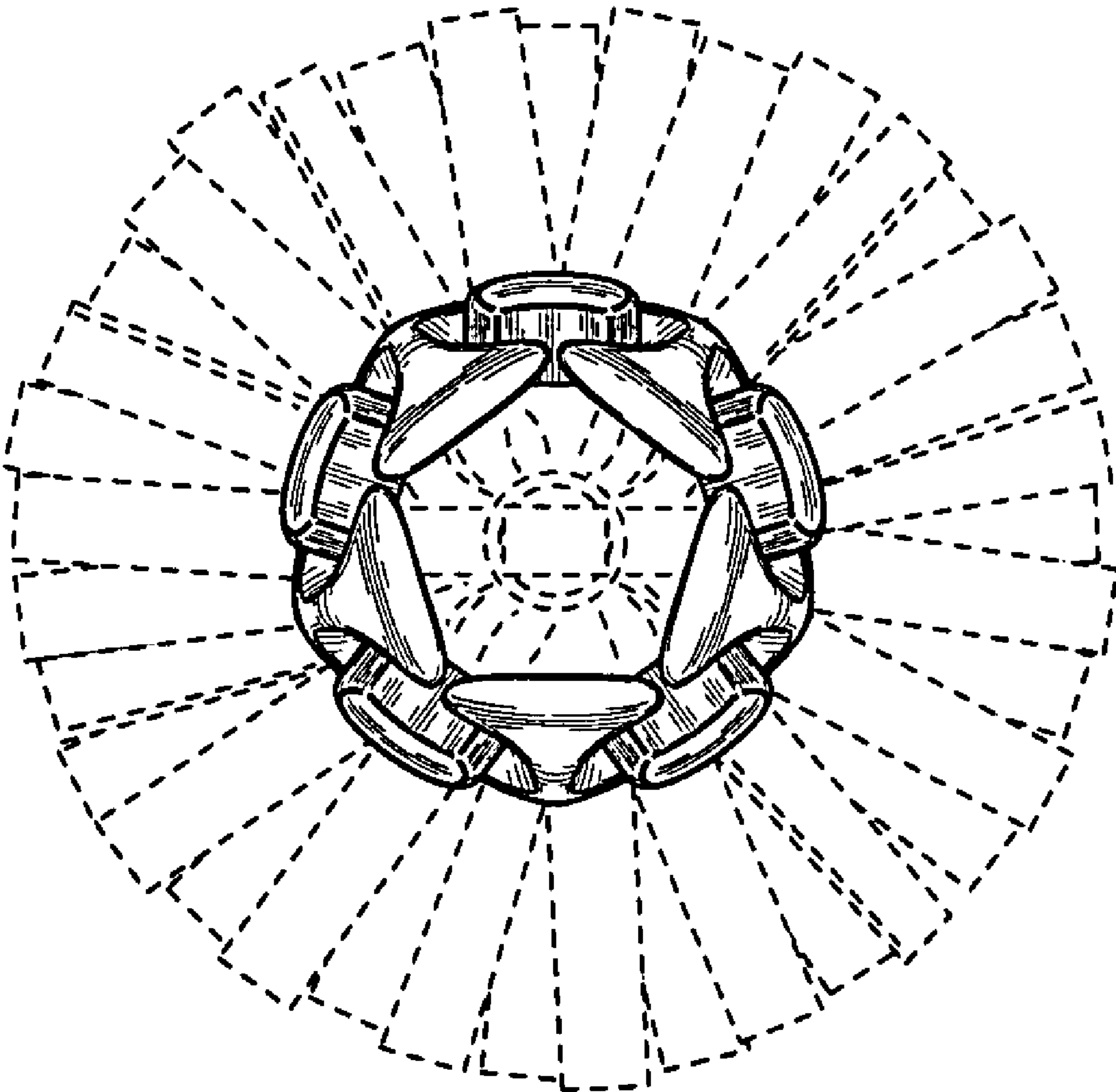

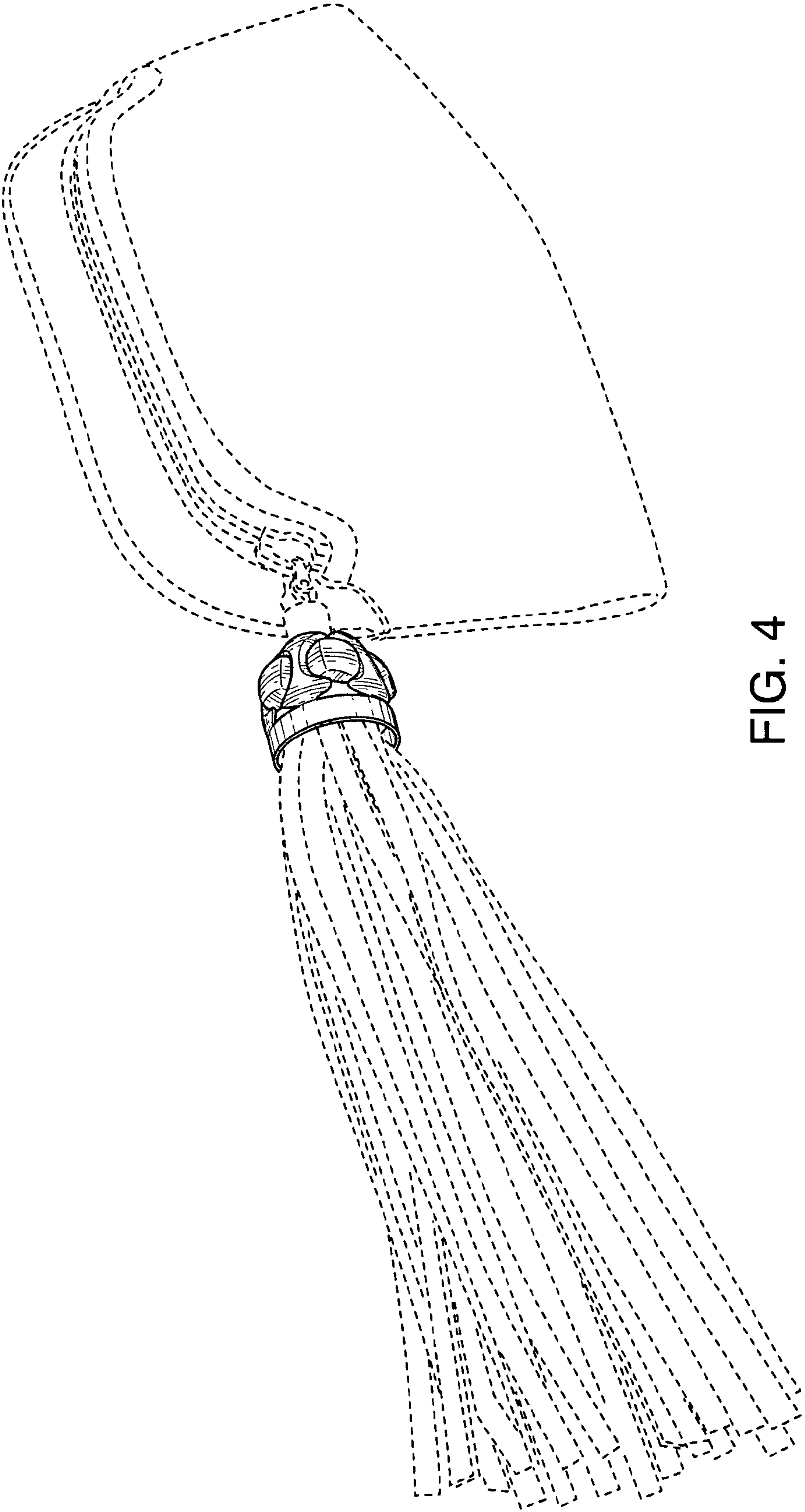
