- FIG. 8 is a rear elevational view of the sled showing the design.

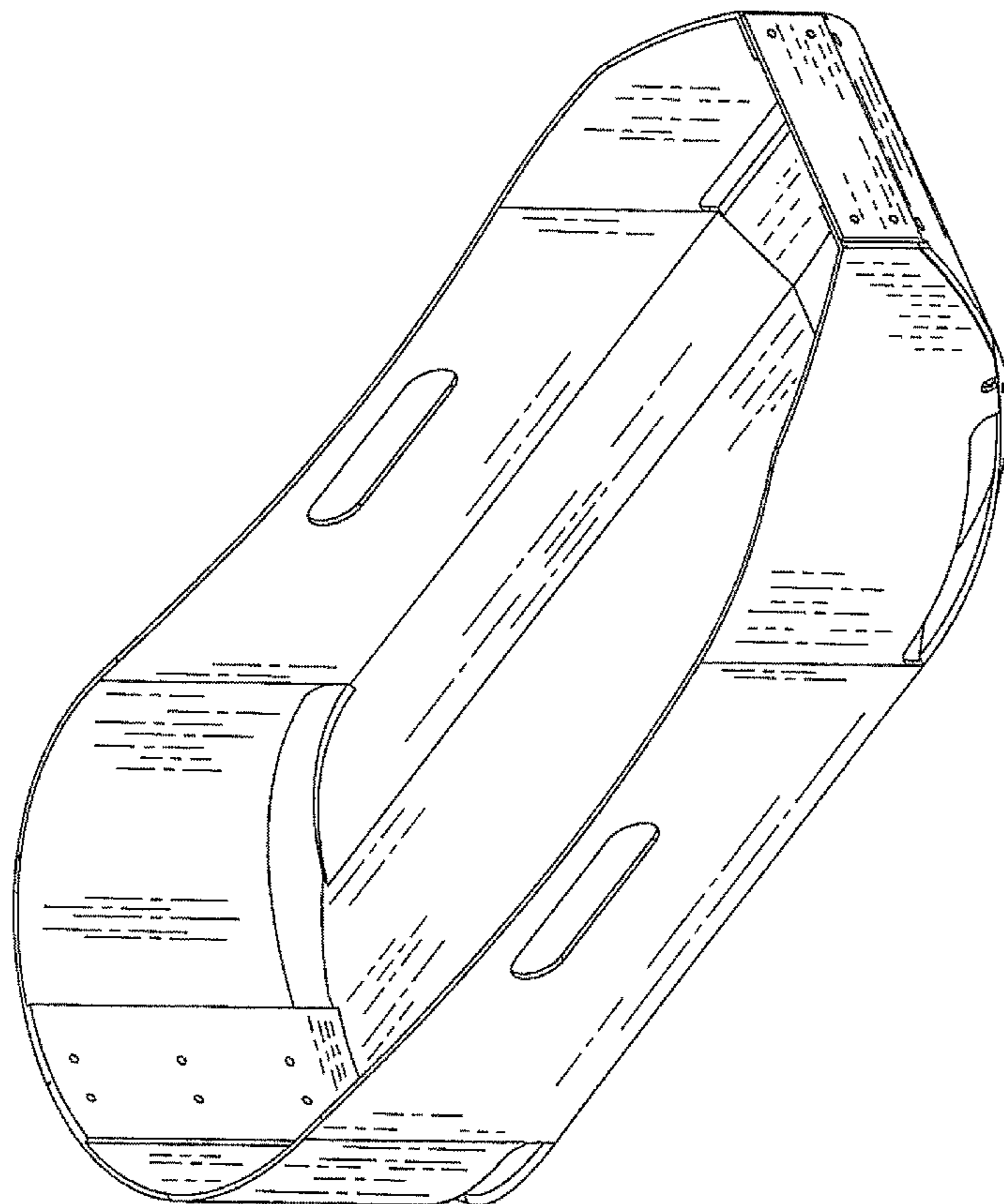

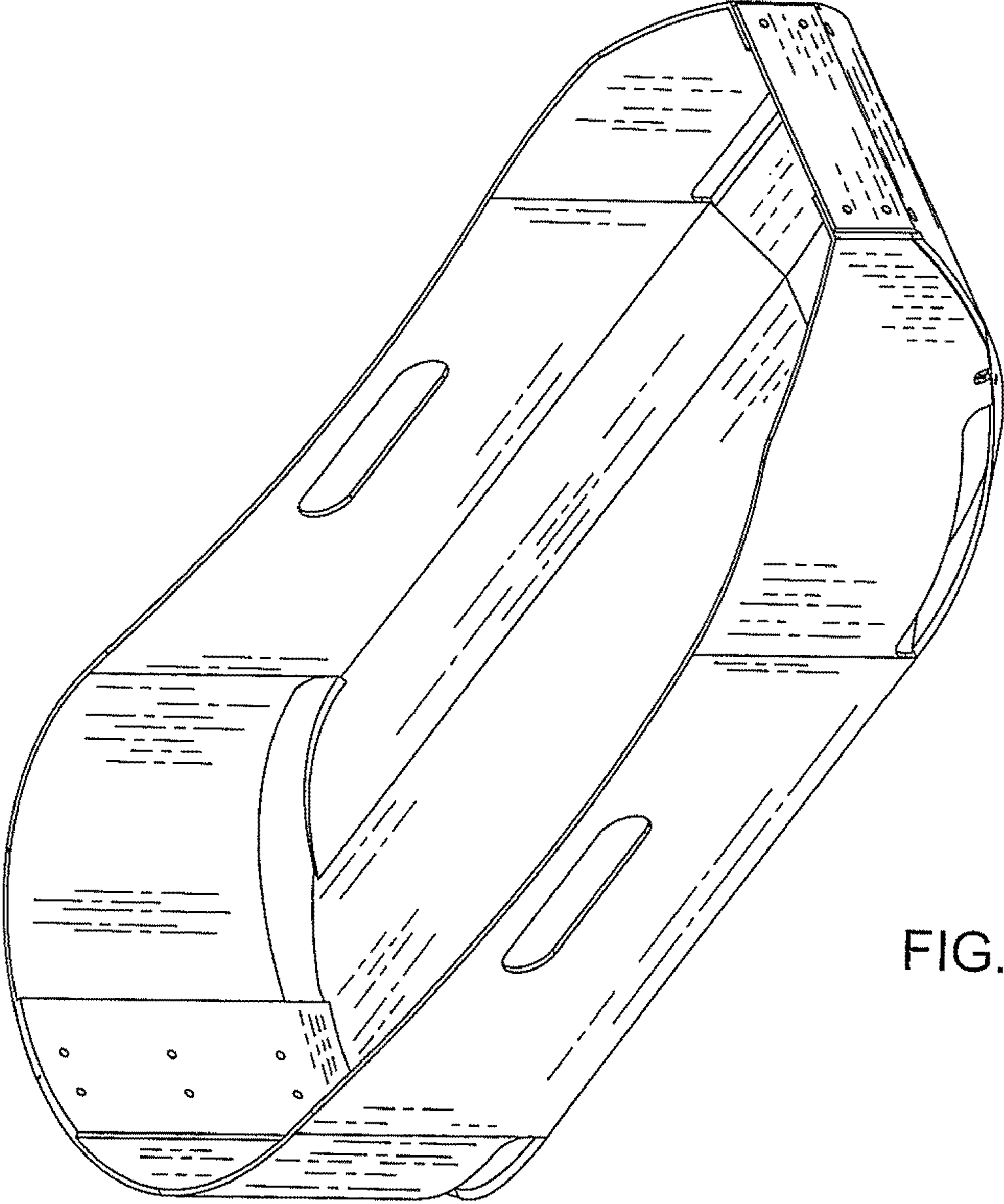

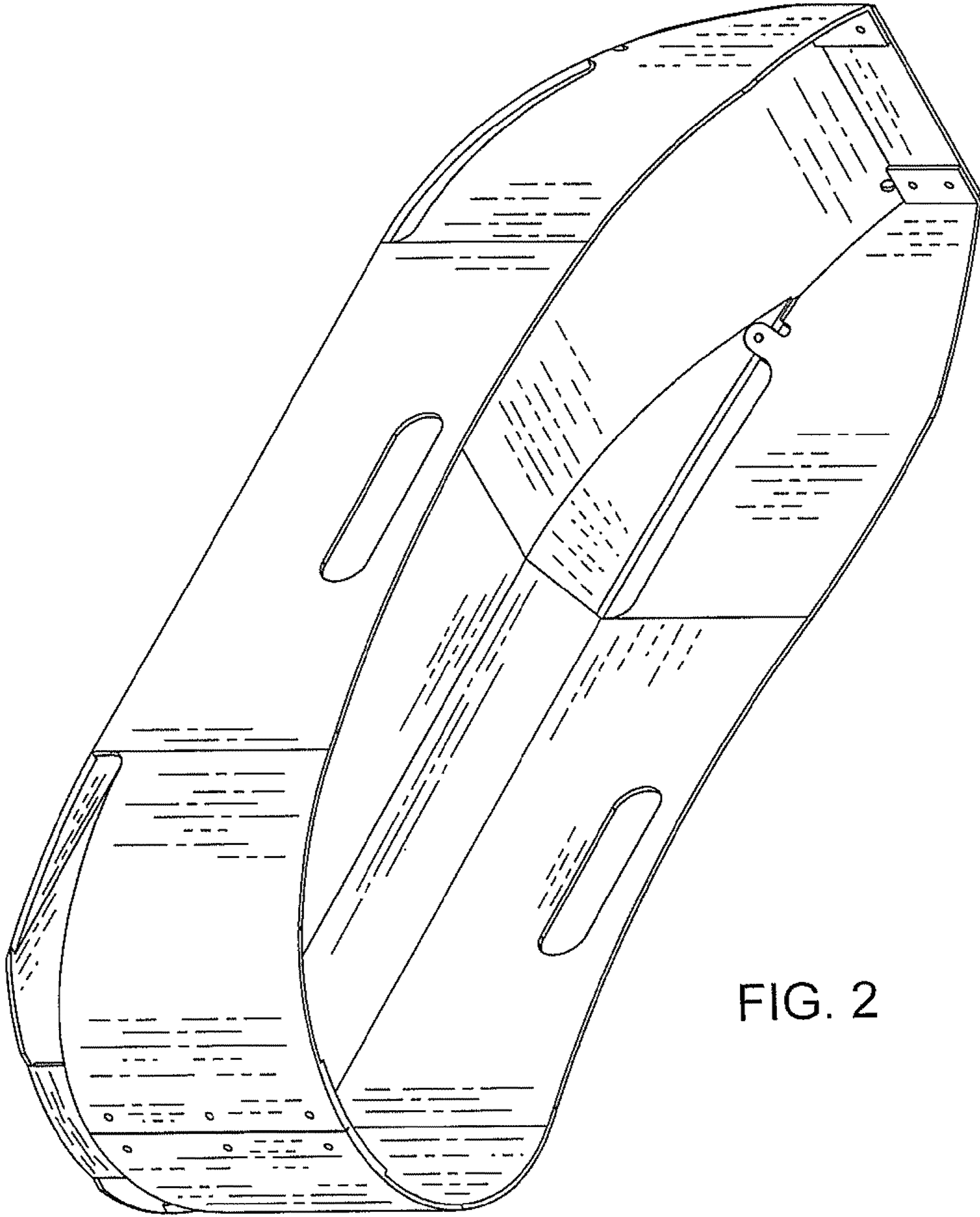

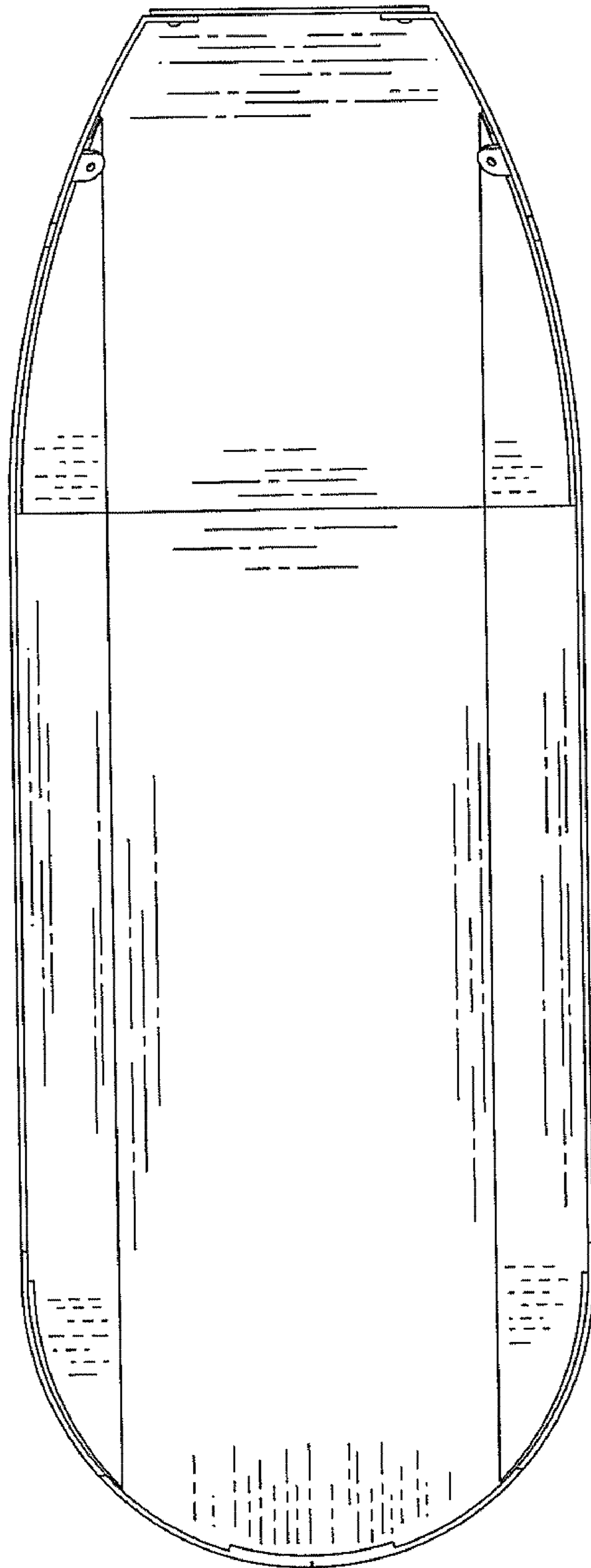

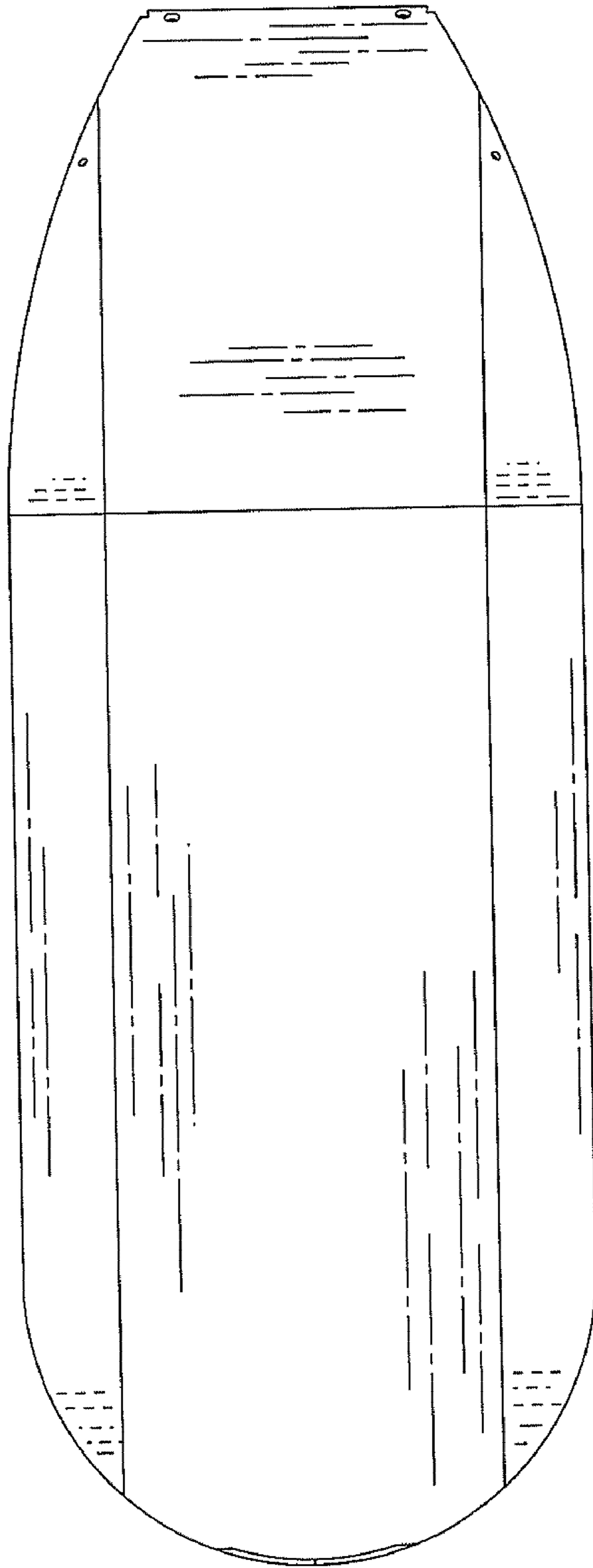

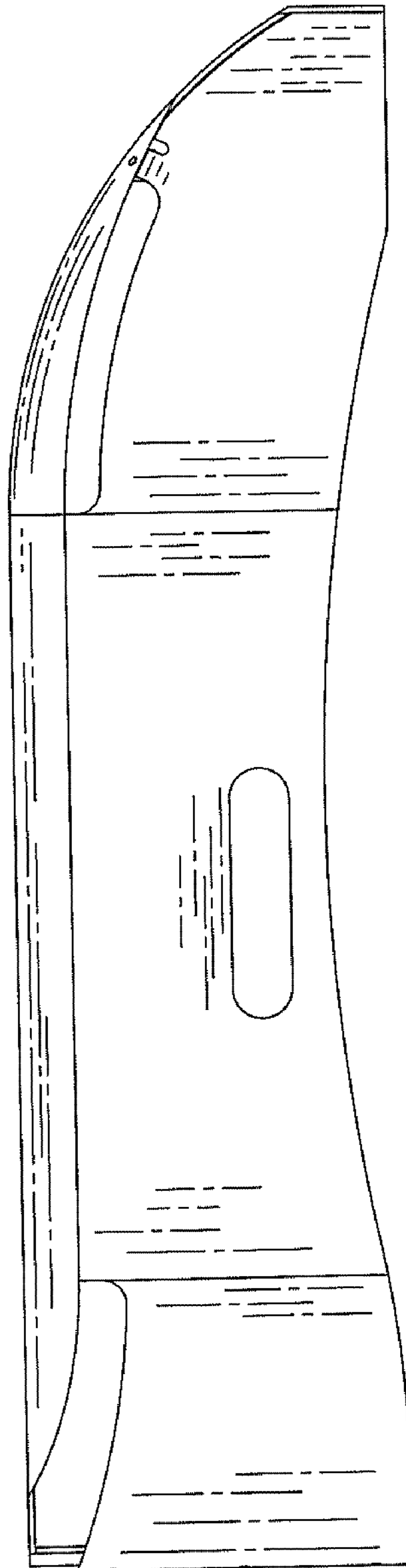

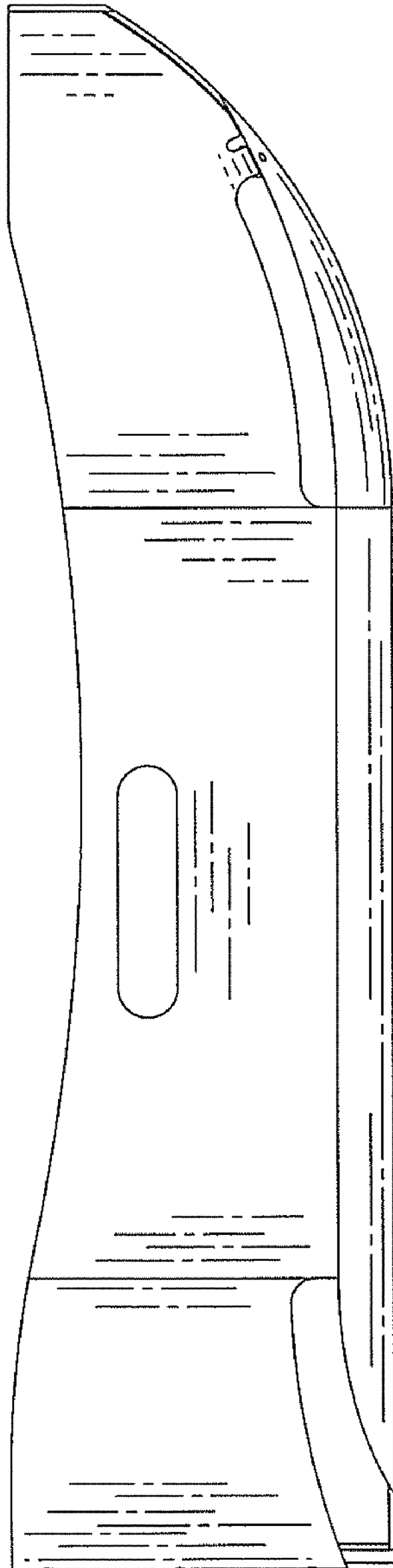

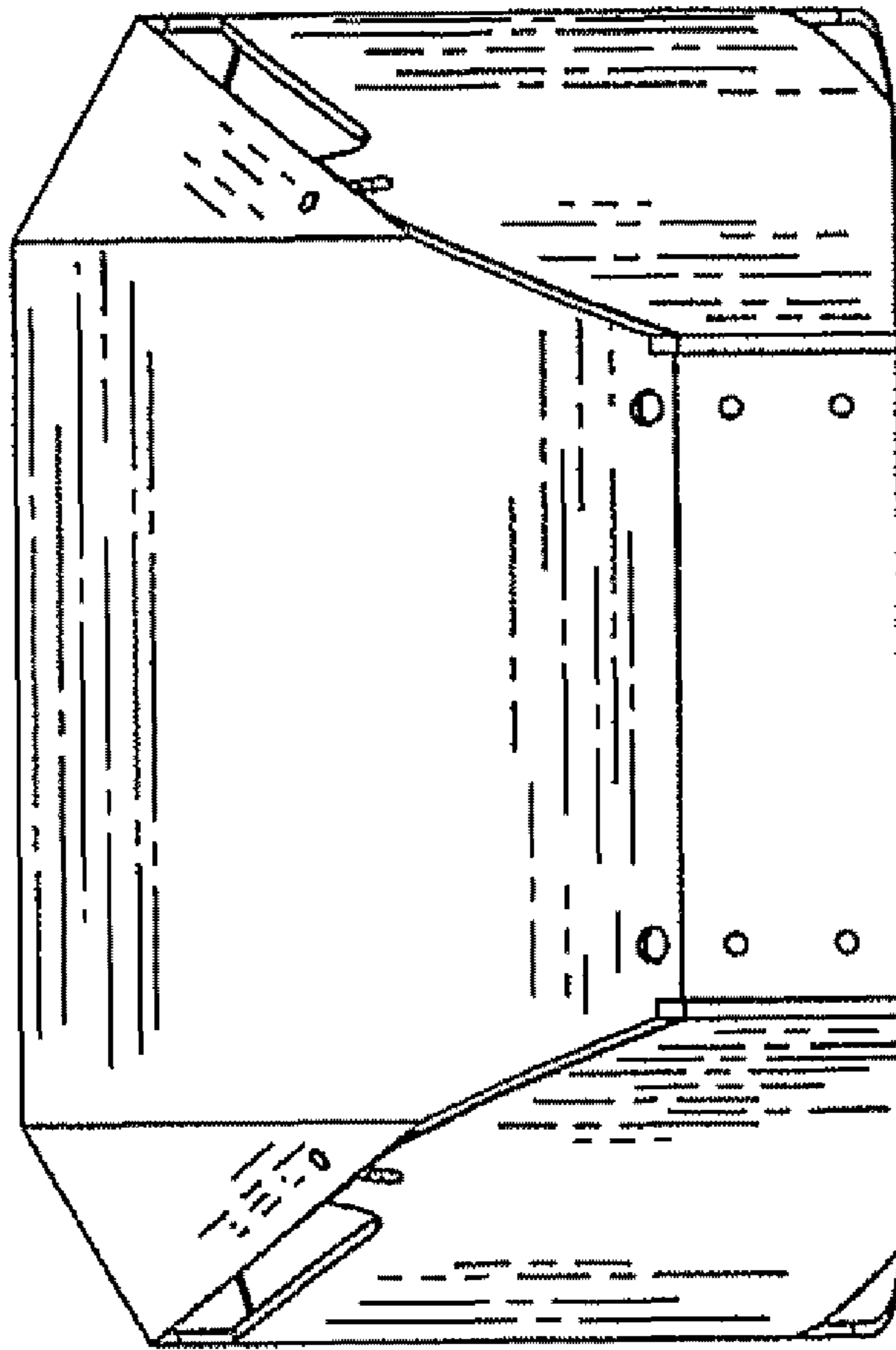

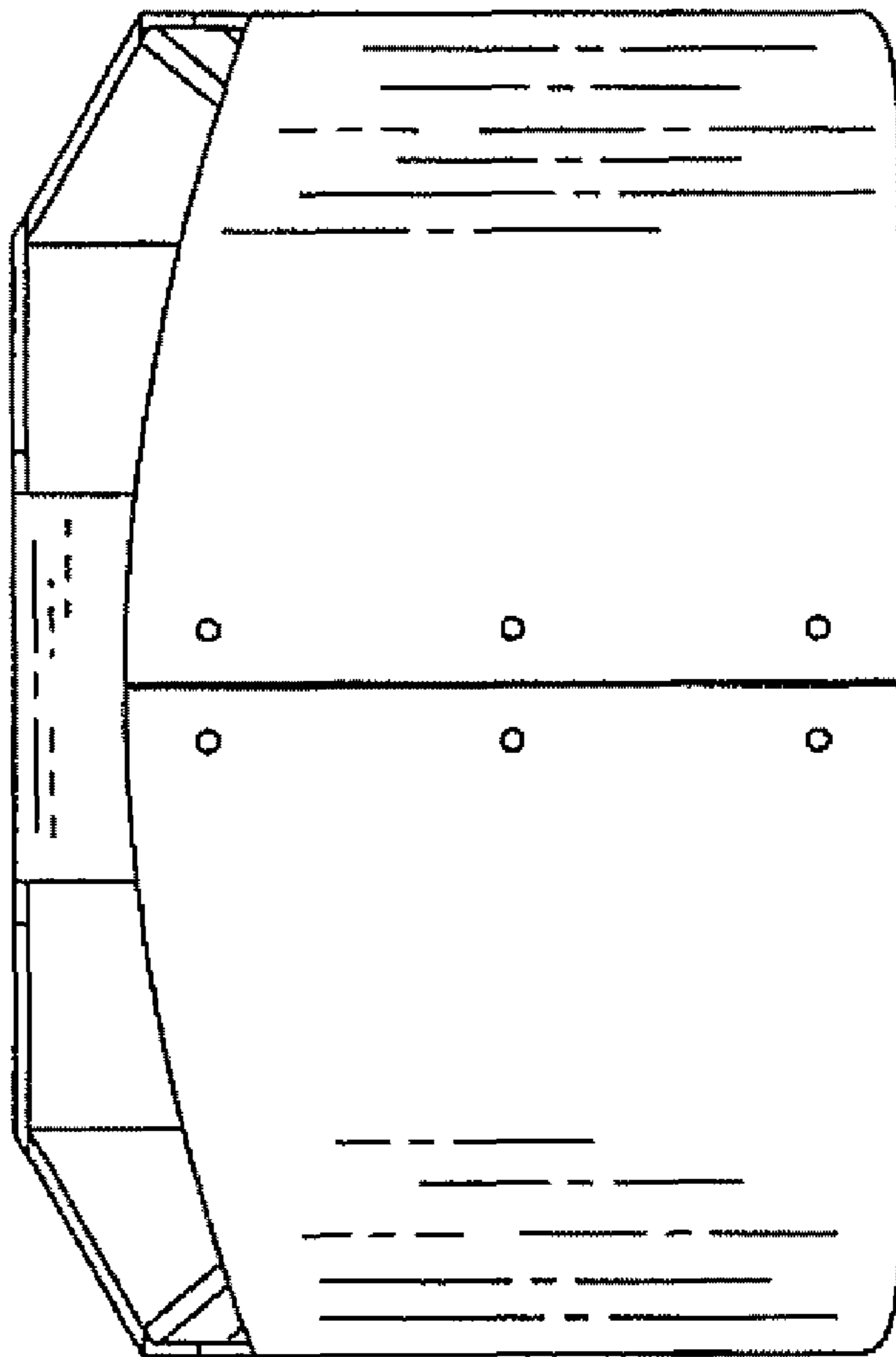
