**DESCRIPTION**

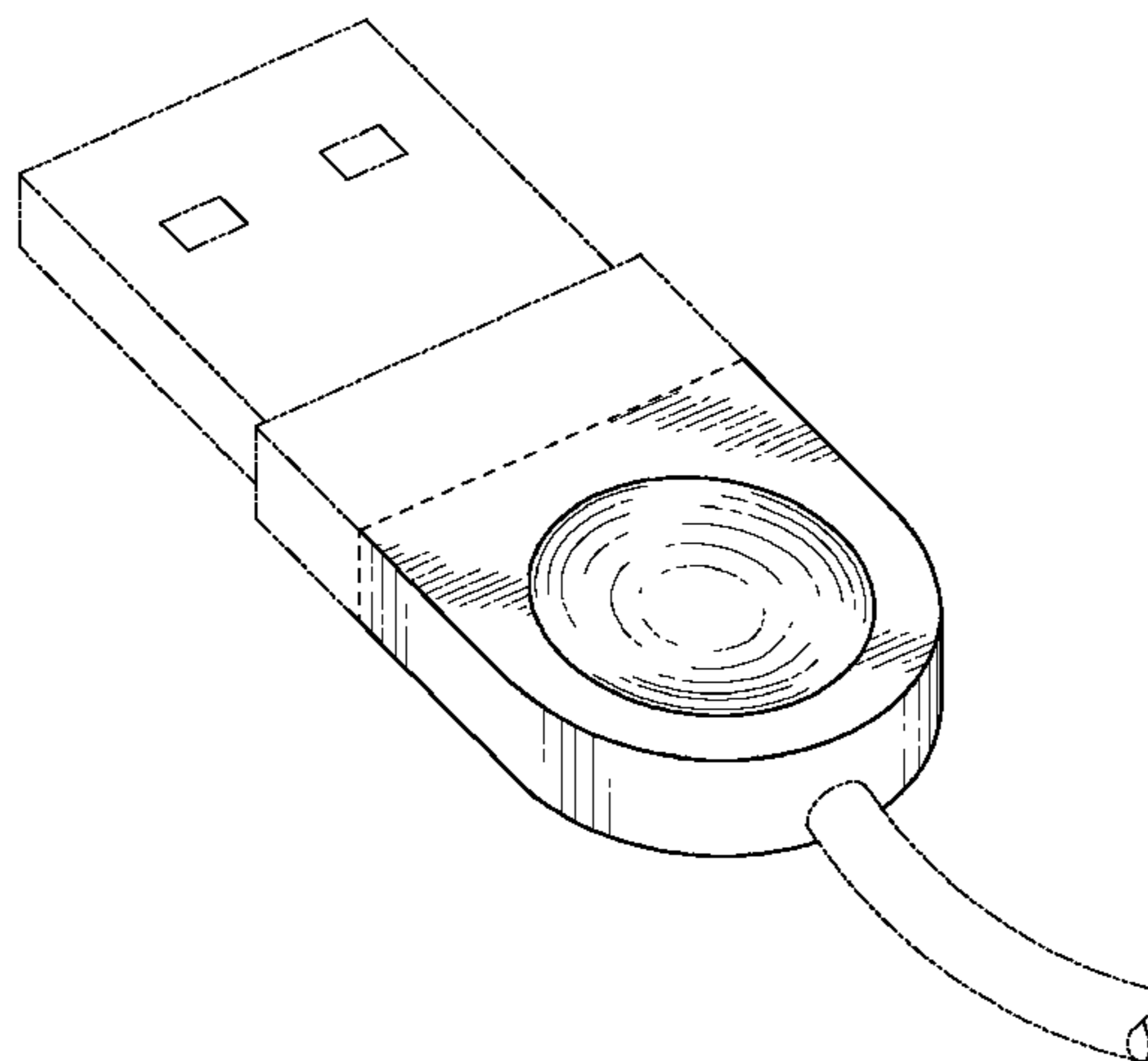
FIG. 1 is a top and side perspective view of a connector device with surface feature showing my new design;

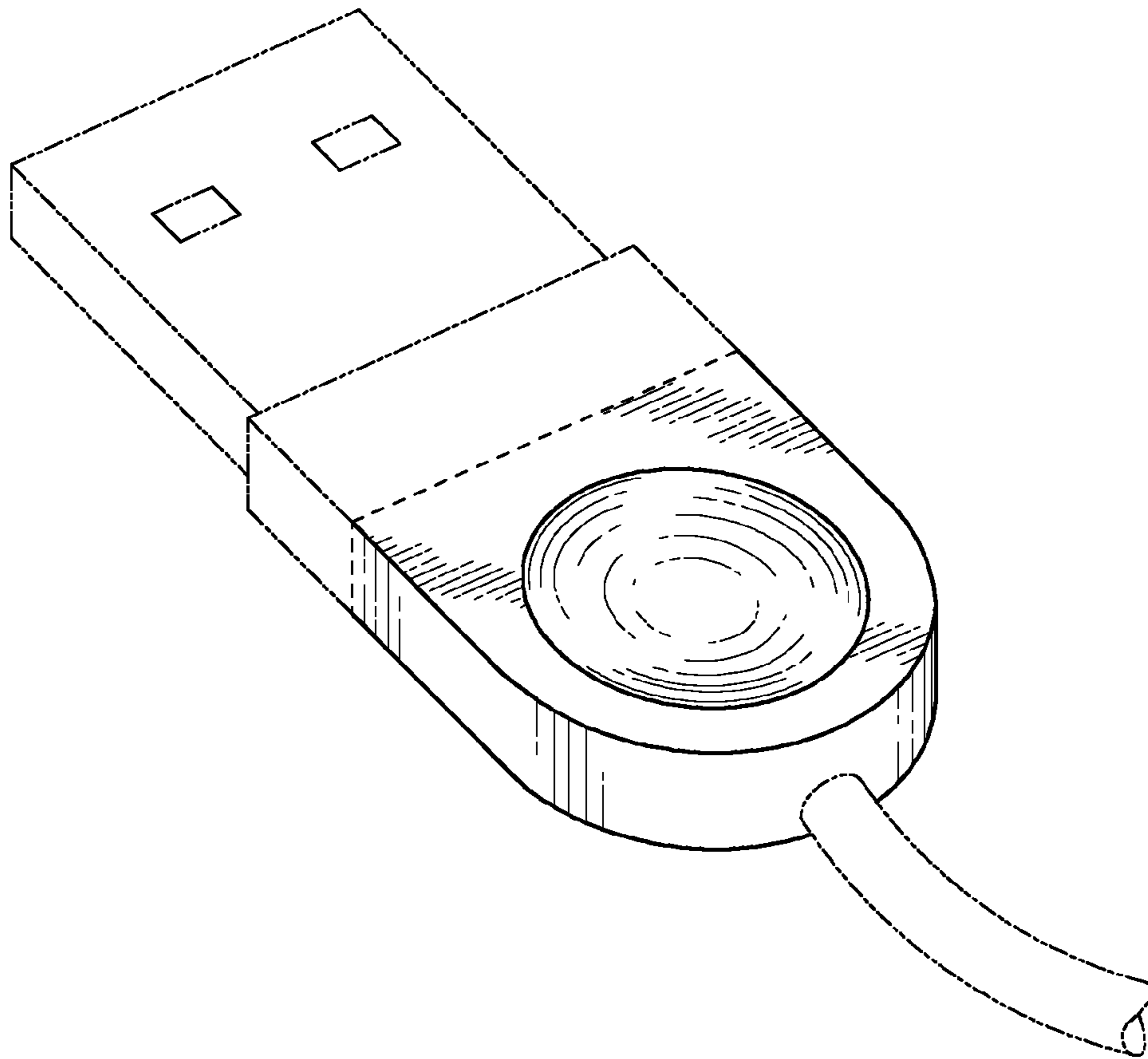

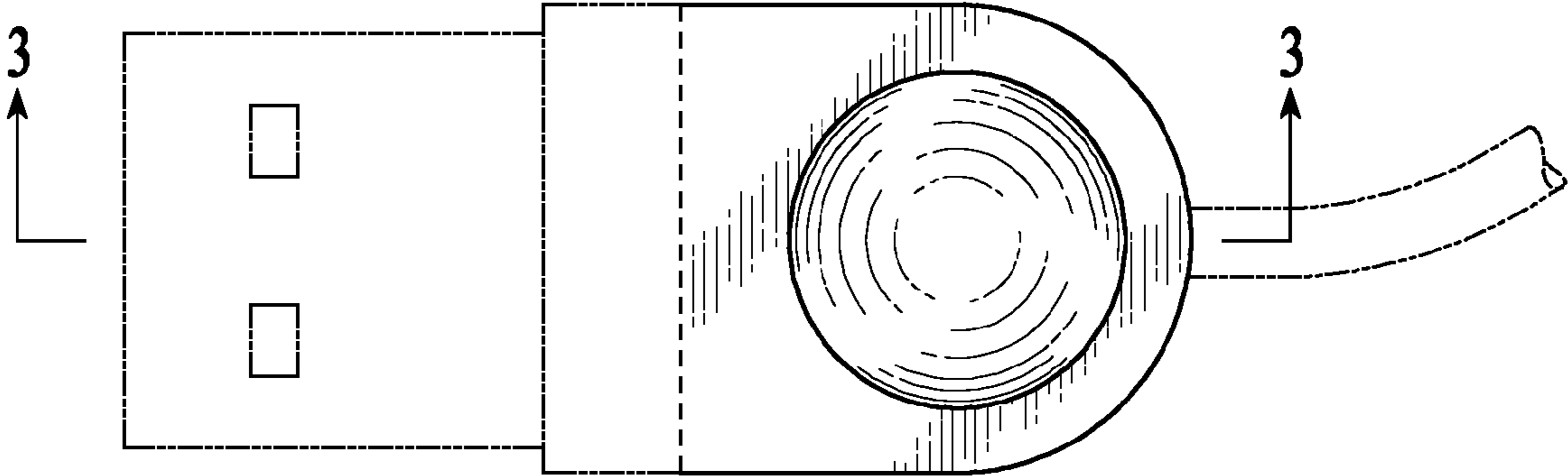

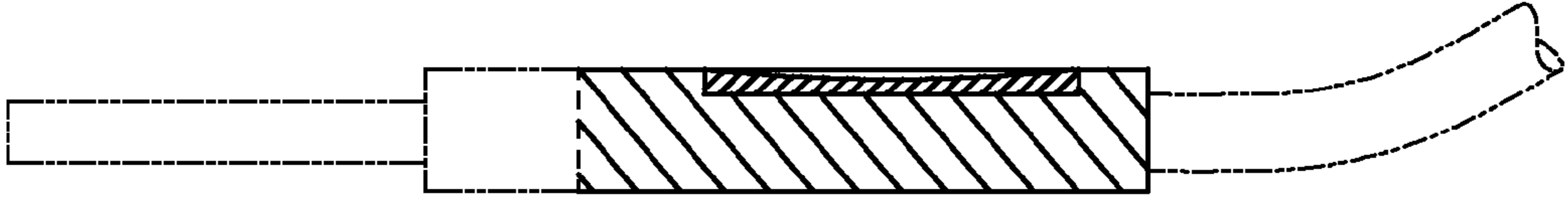
