(57) **CLAIM**

I claim the ornamental design for a pest-control device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pest-control device showing my new design, as viewed from the bottom and one side.

FIG. 2 is a front elevation view of the pest-control device of FIG. 1.

FIG. 3 is a side elevation view of the pest-control device of FIG. 1, the opposite side elevation view being identical.

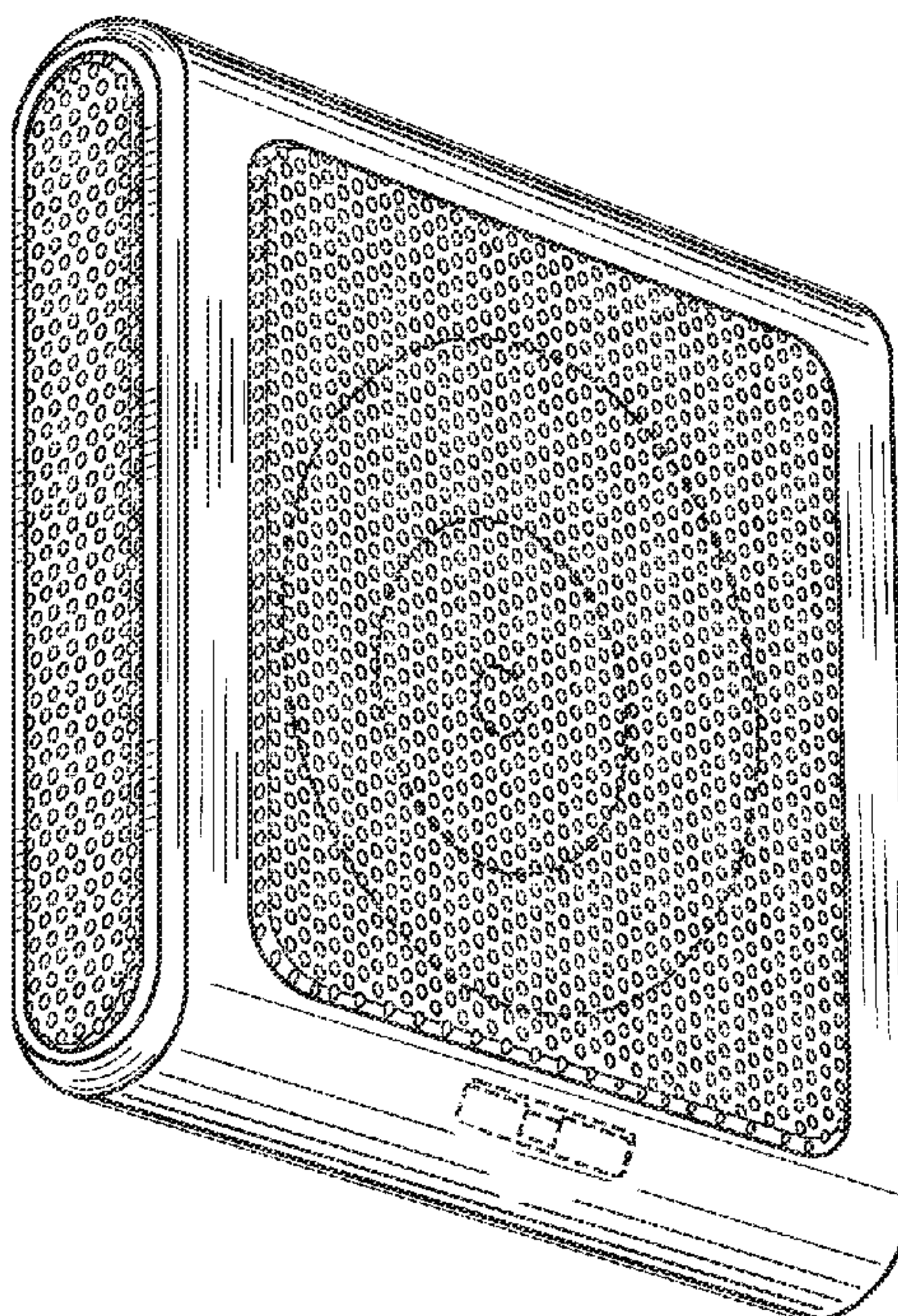
FIG. 4 is a bottom plan view of the pest-control device of FIG. 1.

FIG. 5 is a rear elevation view of the pest-control device of FIG. 1; and,

FIG. 6 is a top plan view of the pest-control device of FIG. 1.

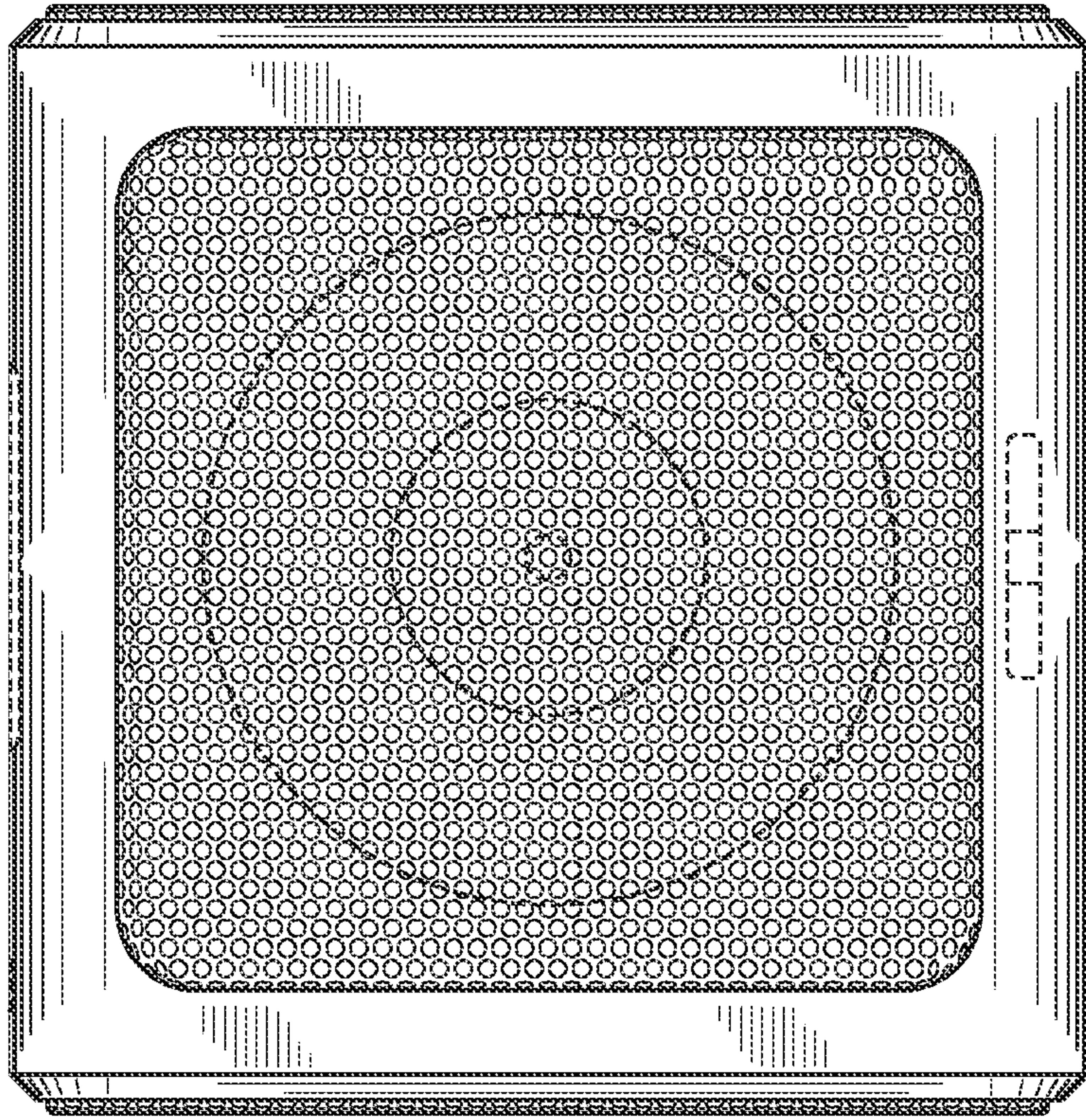

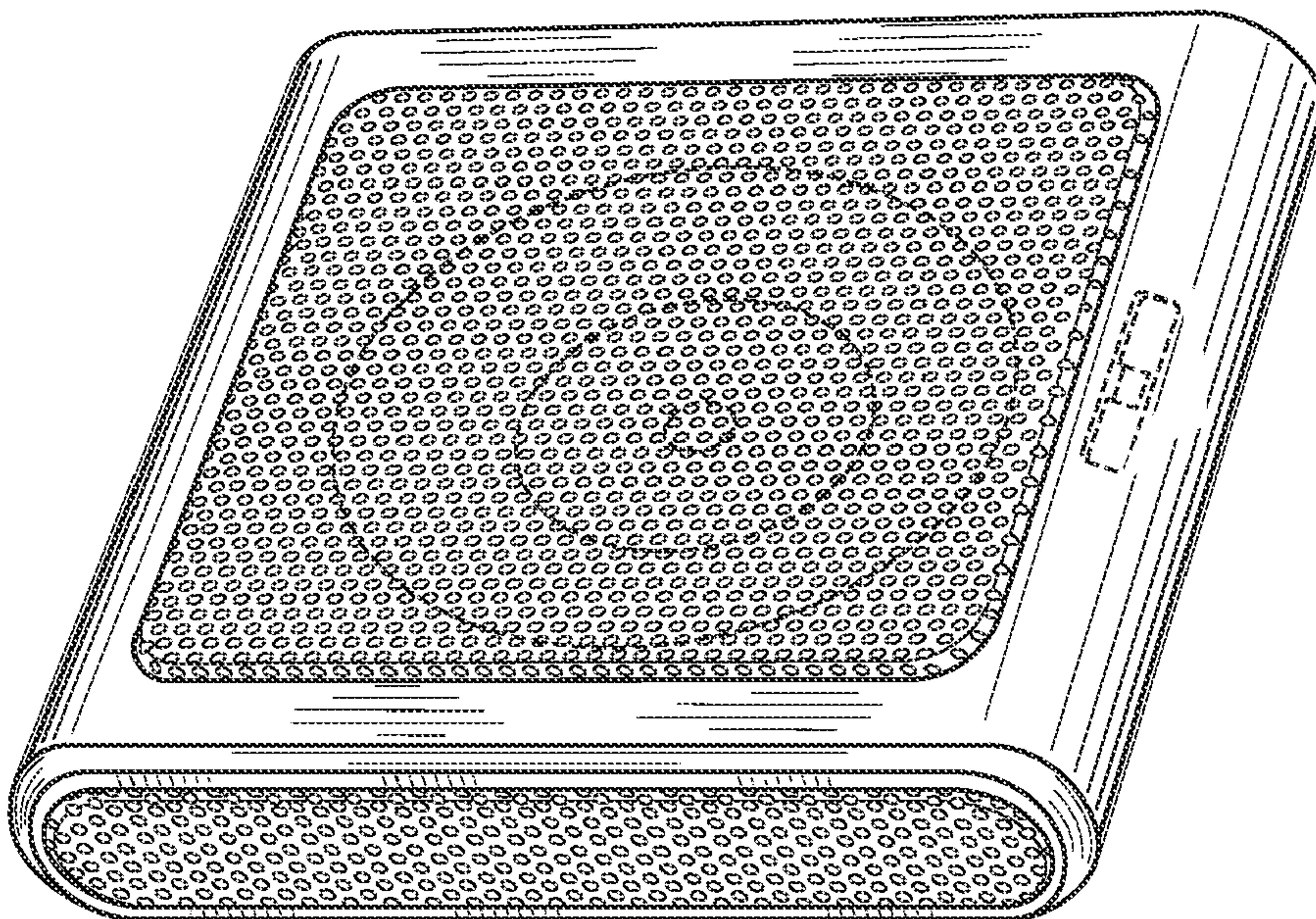

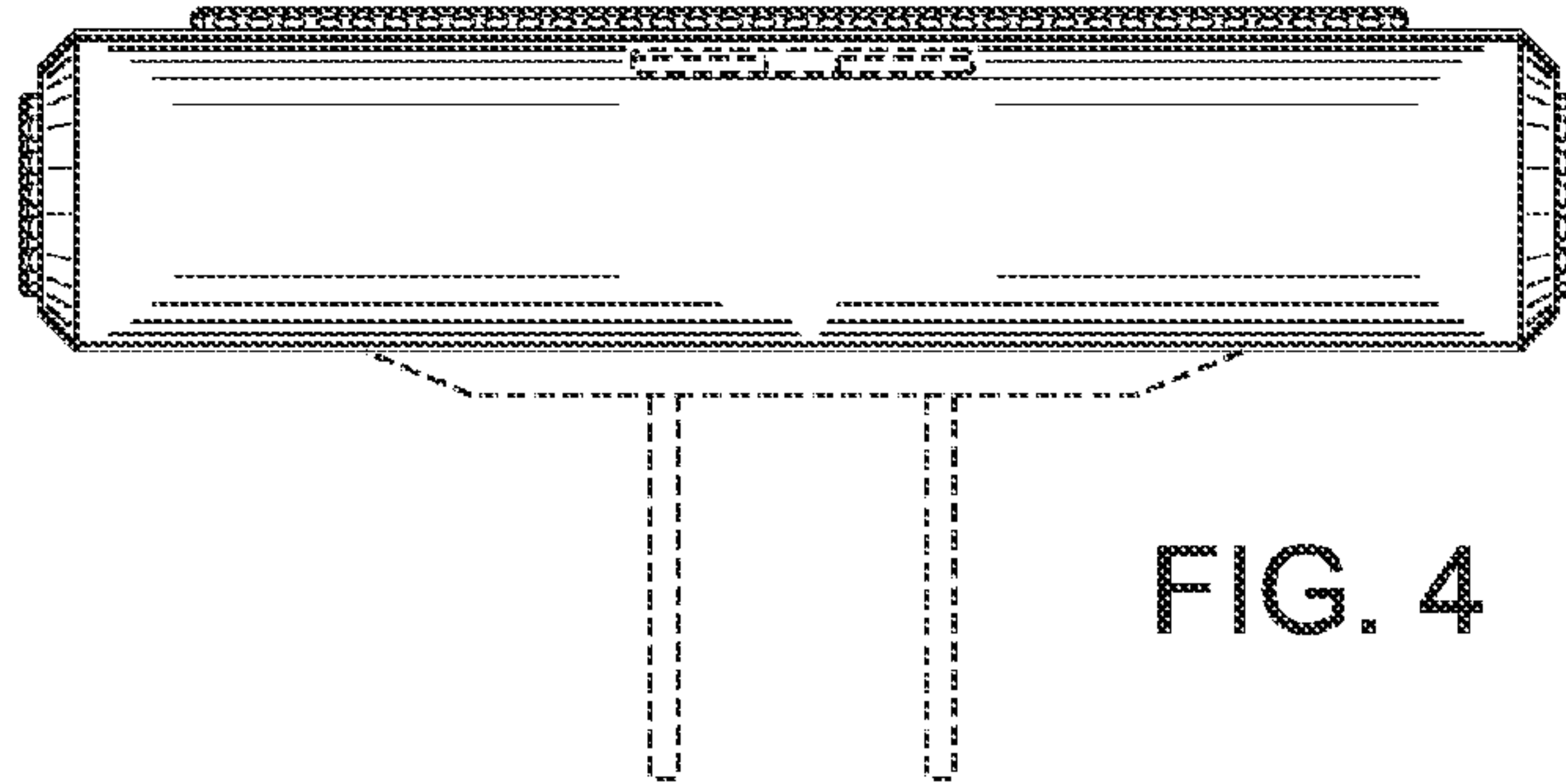

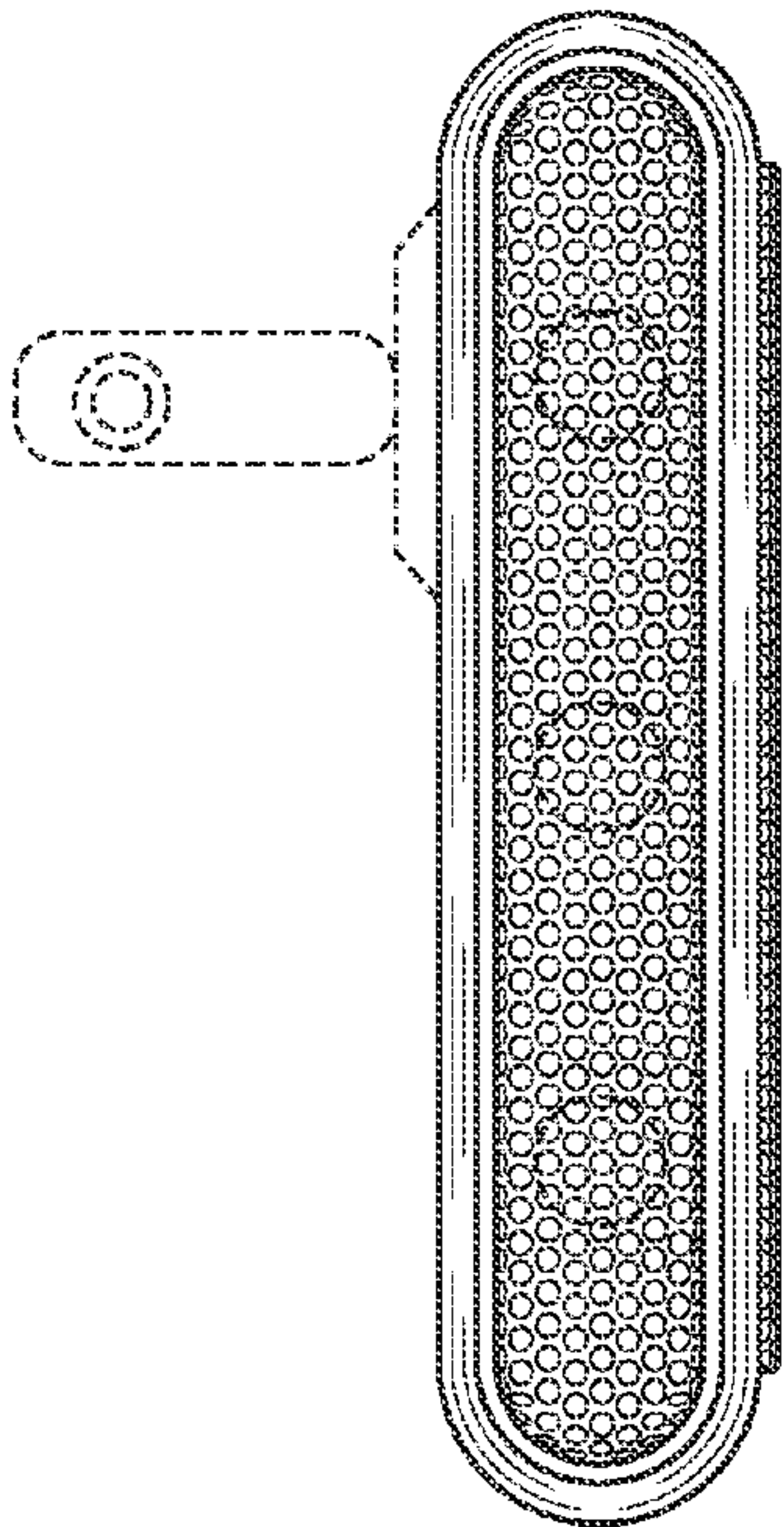

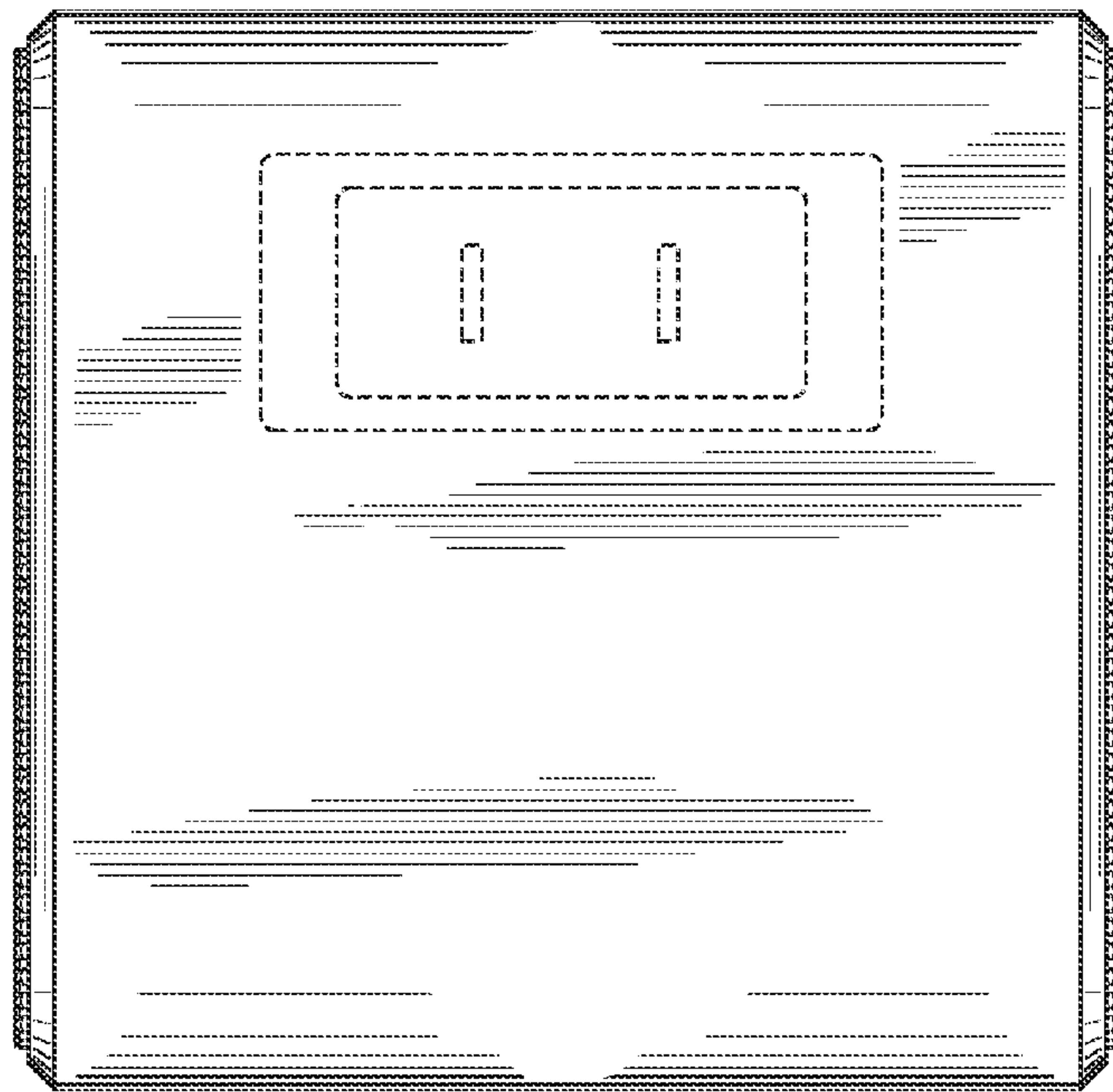

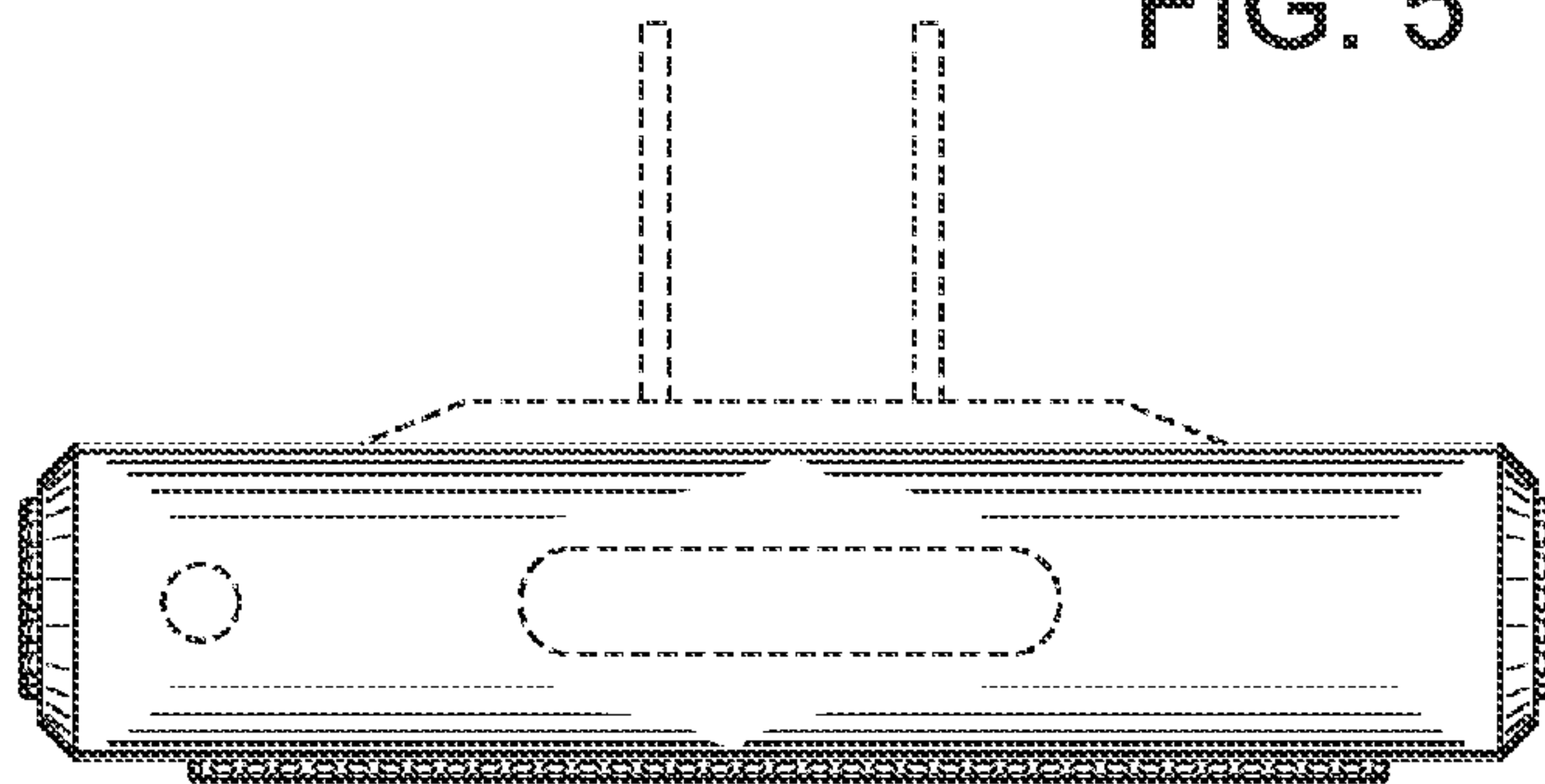
