FIG. 2 is a front perspective view thereof;

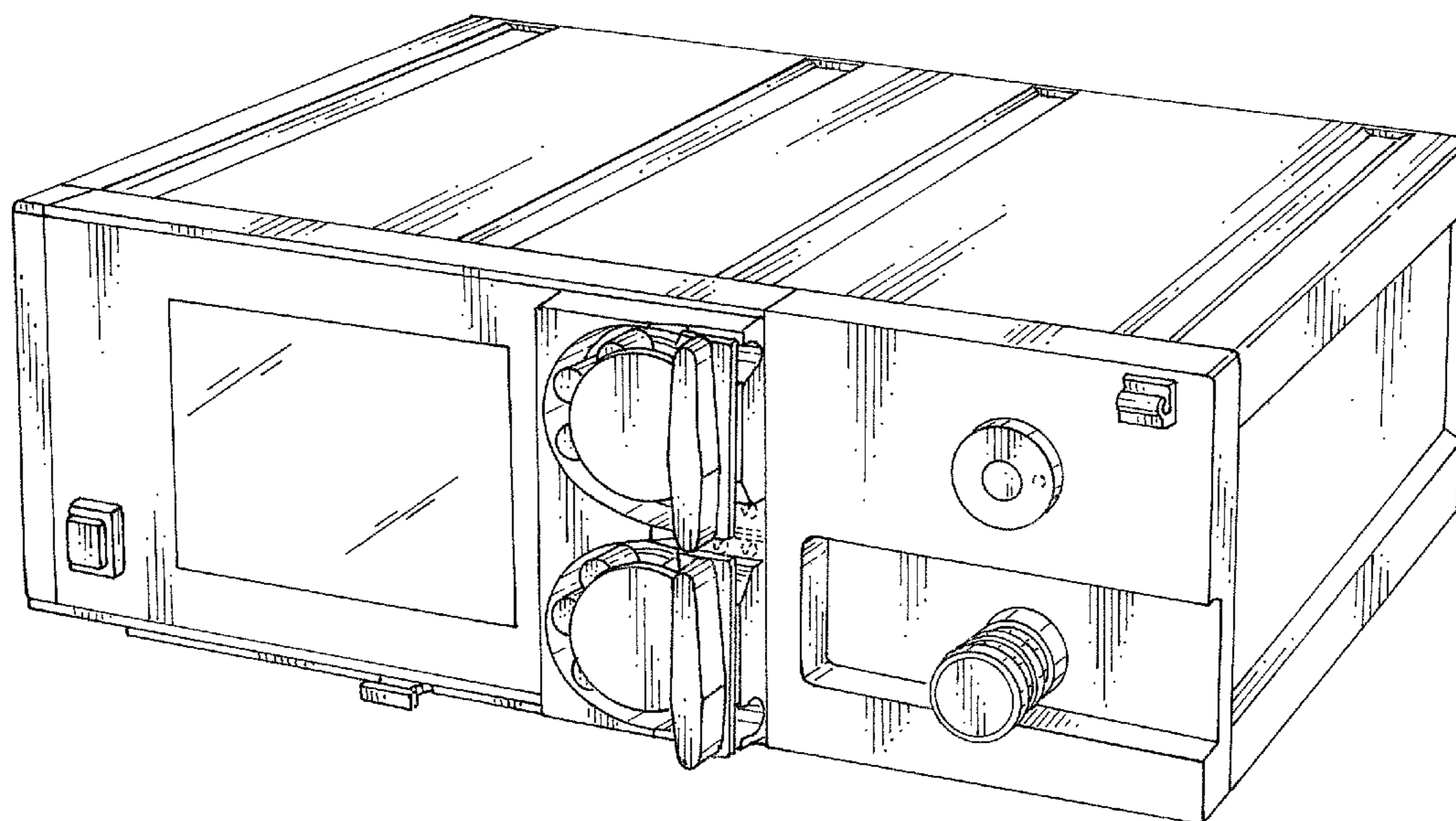
FIG. 3 is a right side perspective view thereof;

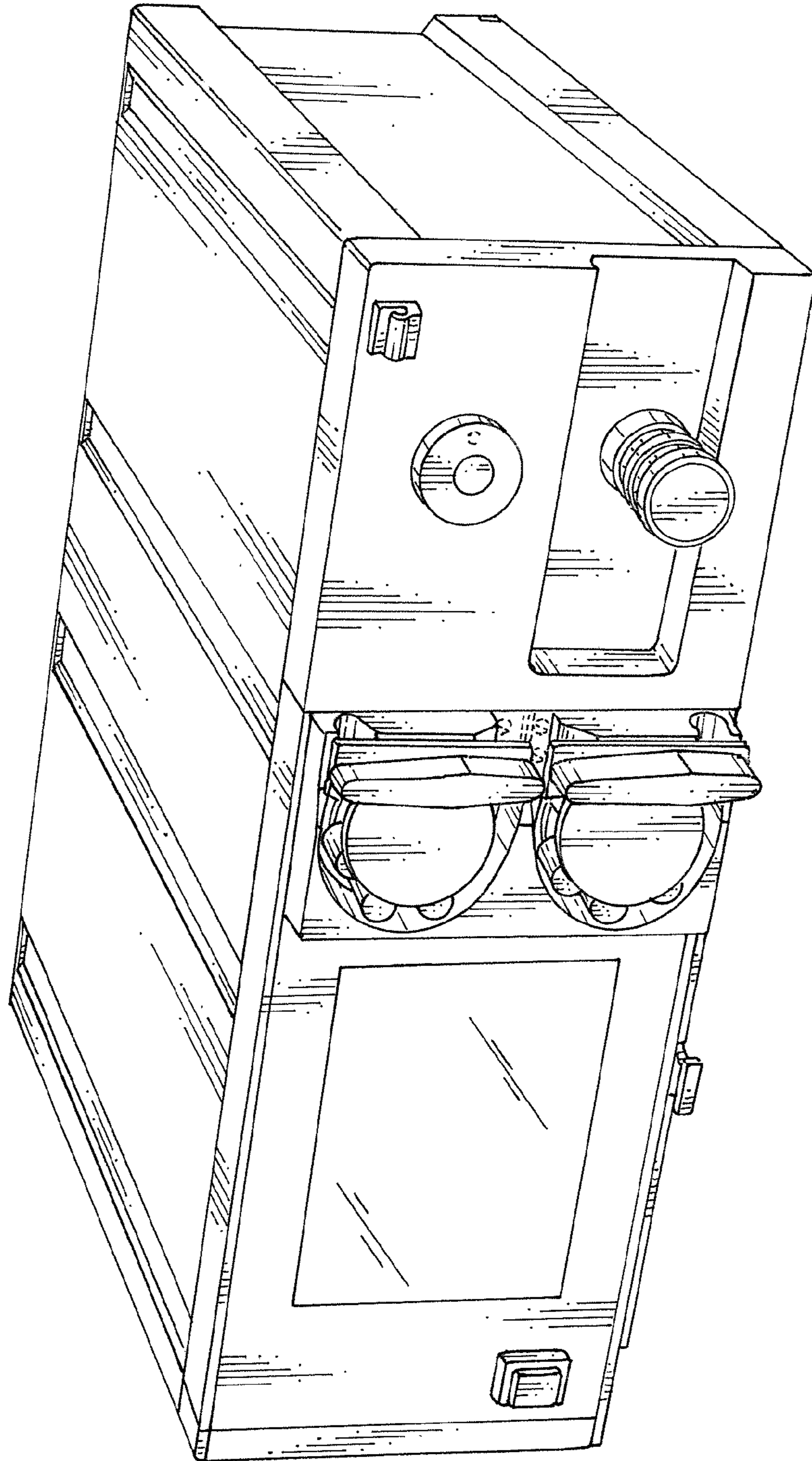

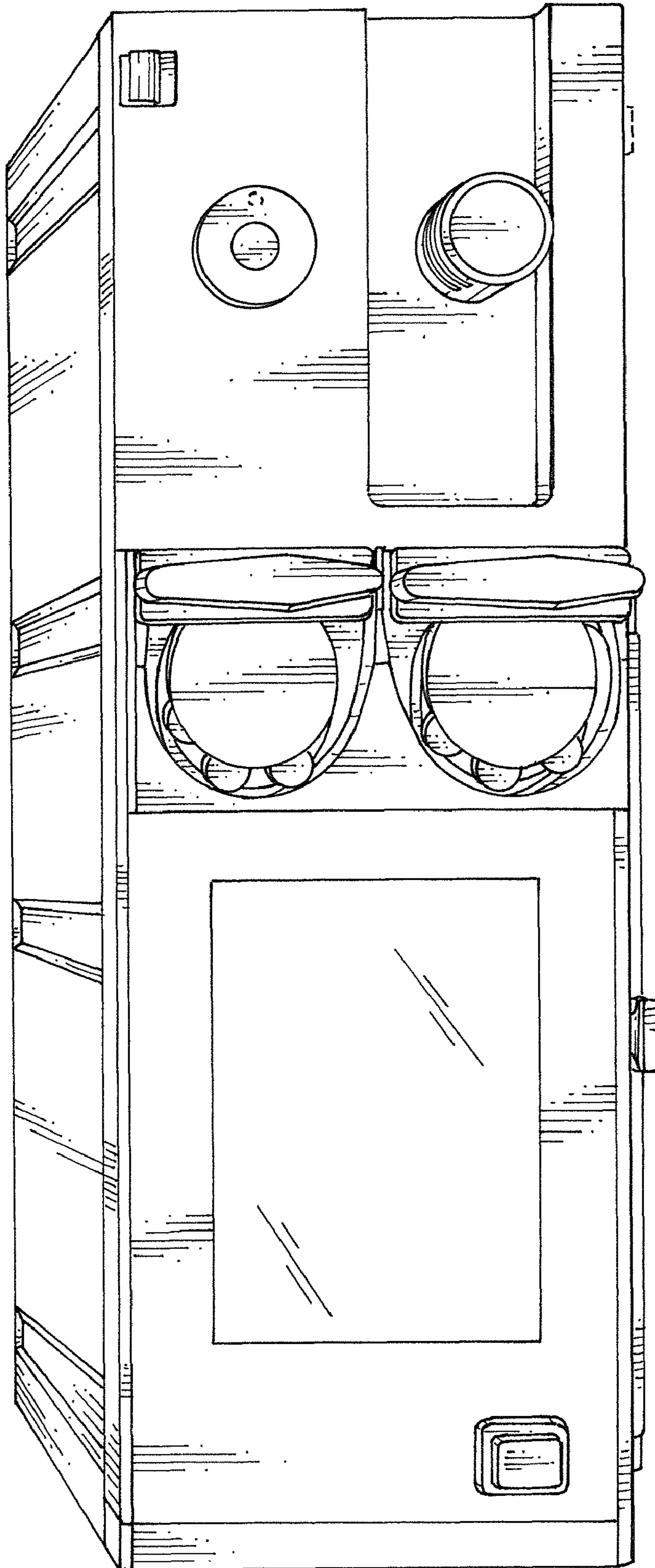
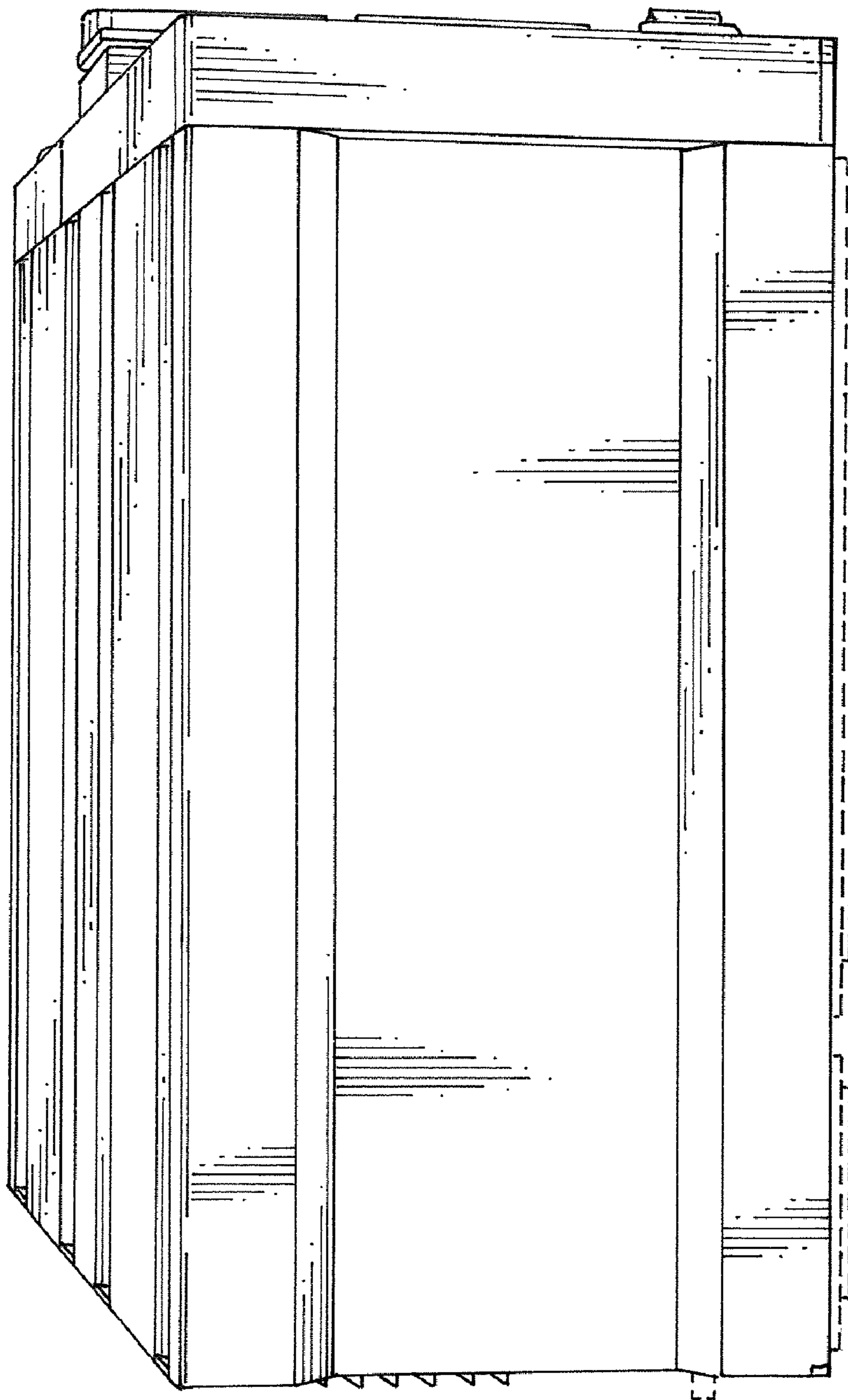
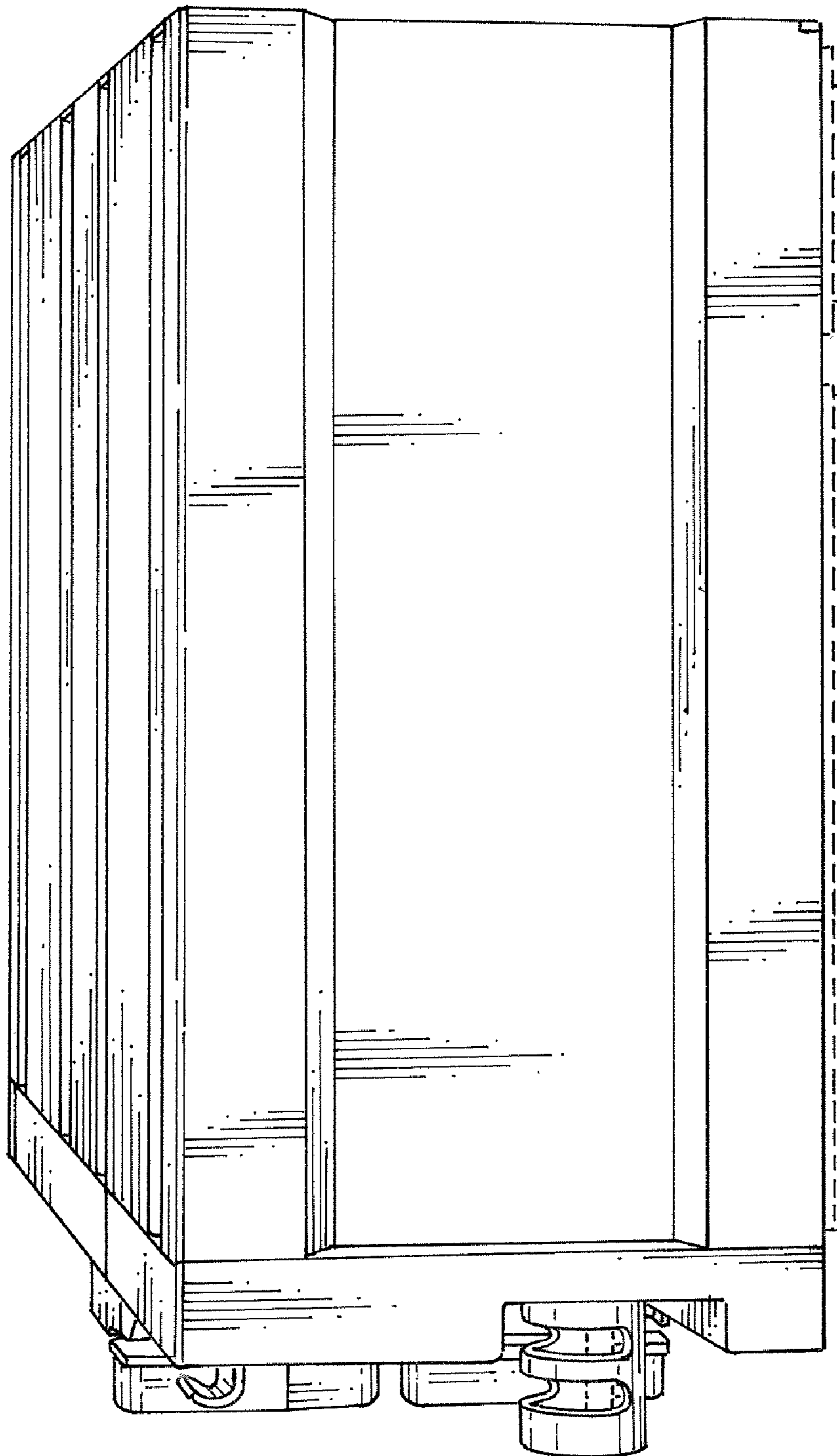

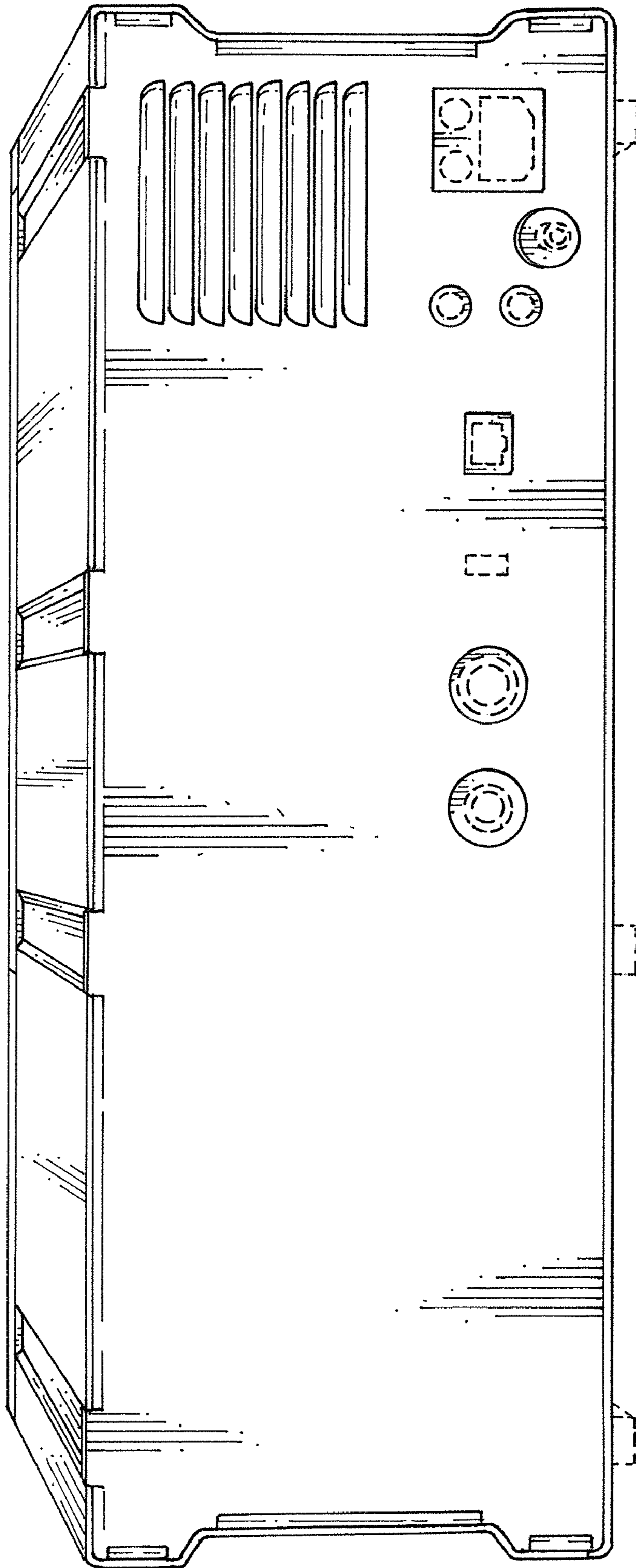
