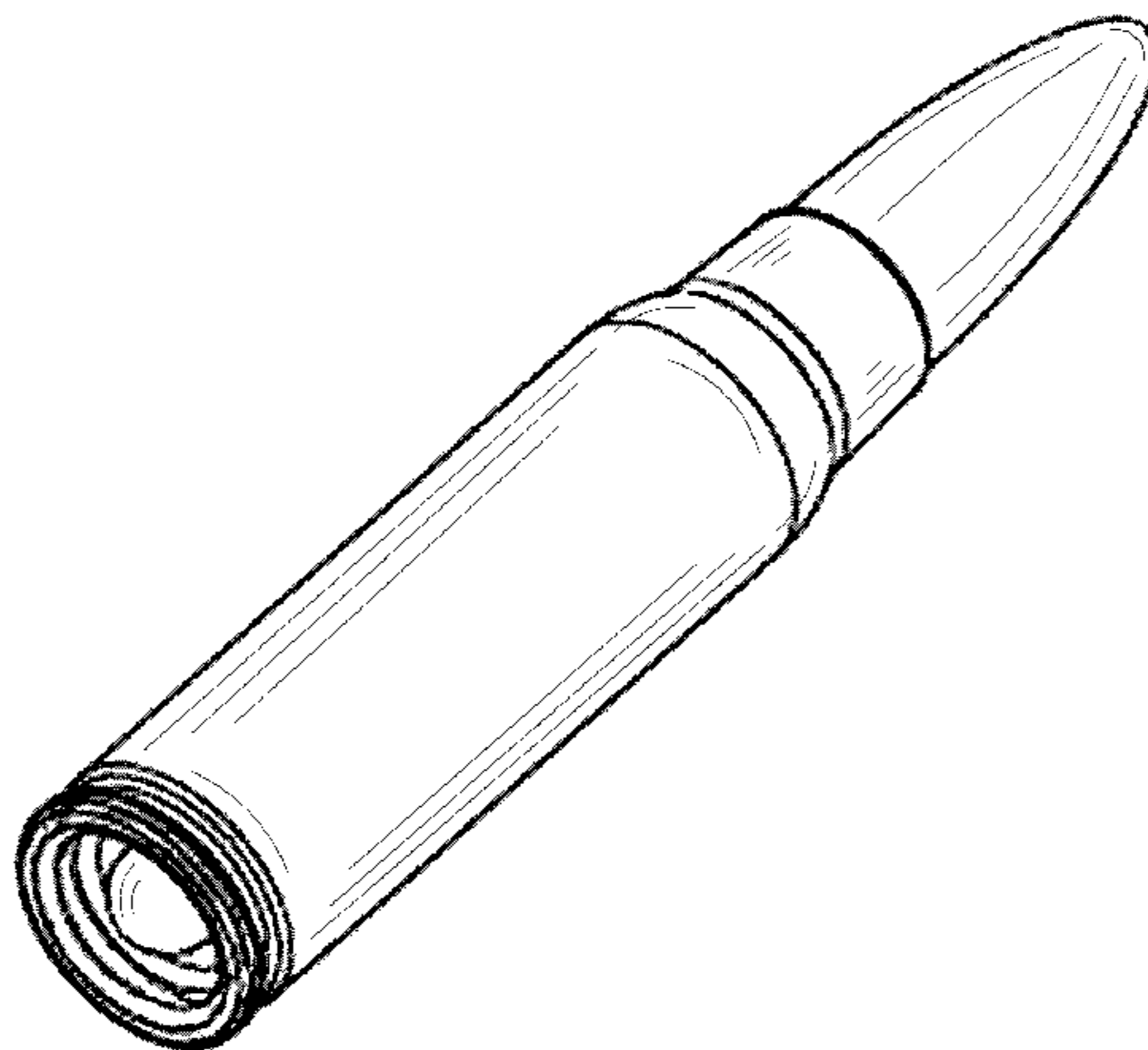
FIG. 1 is a perspective view of the vibrator of the present invention;

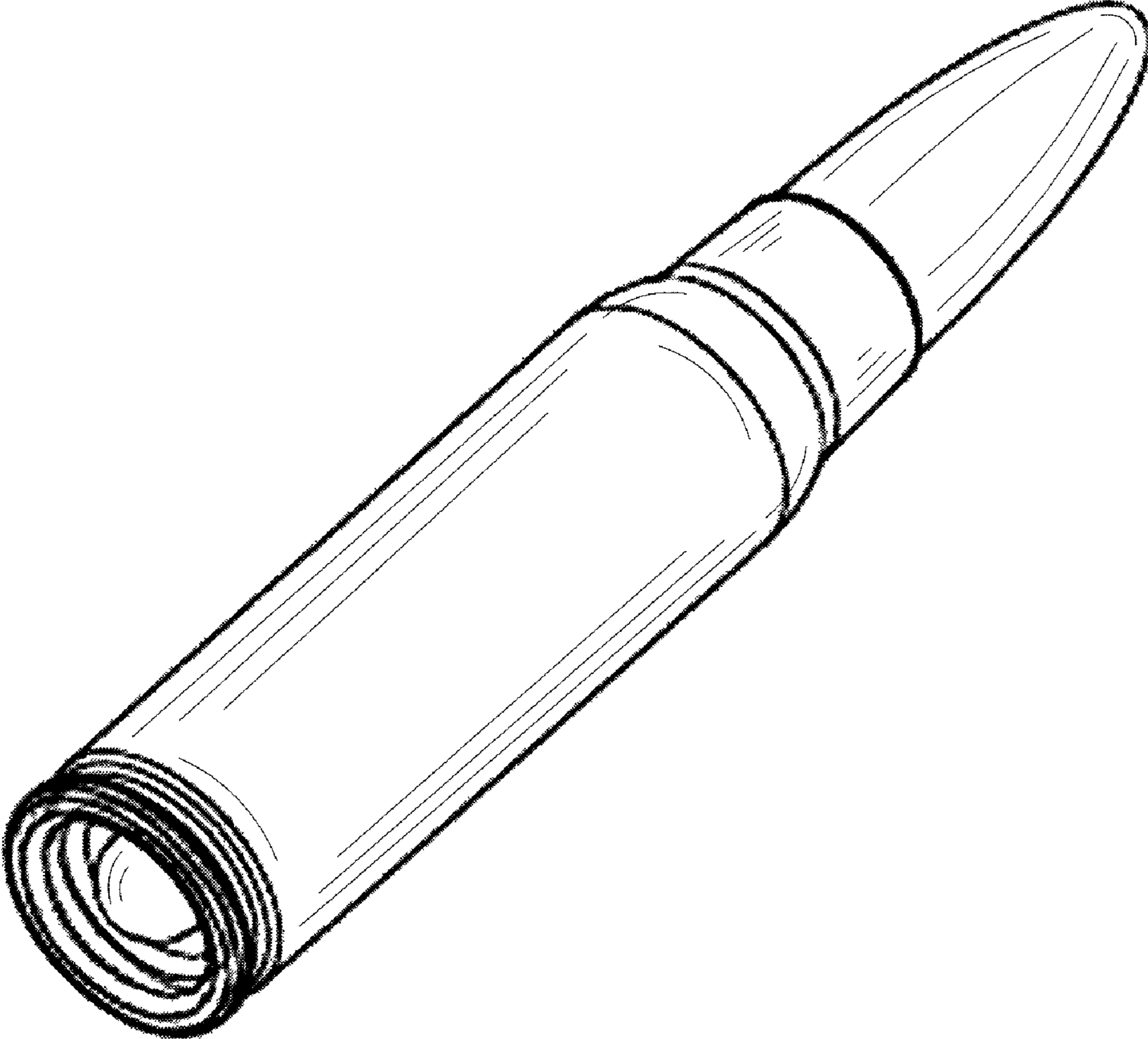

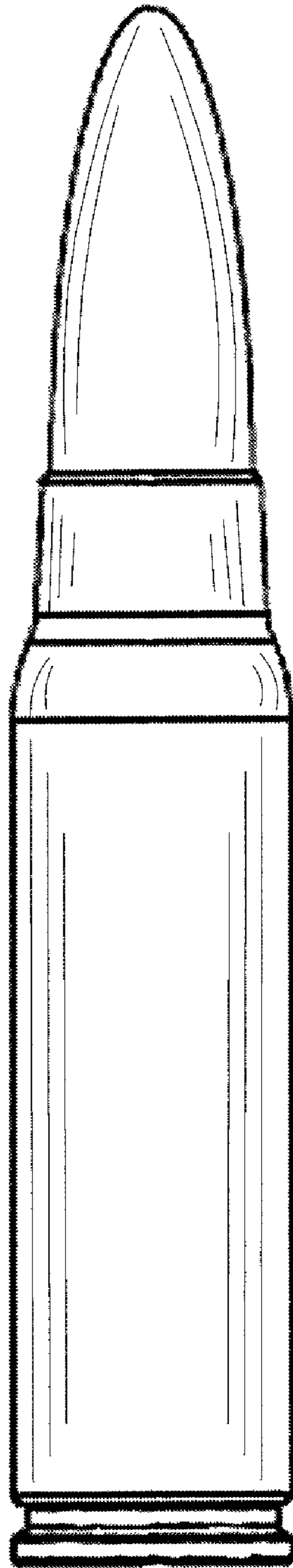
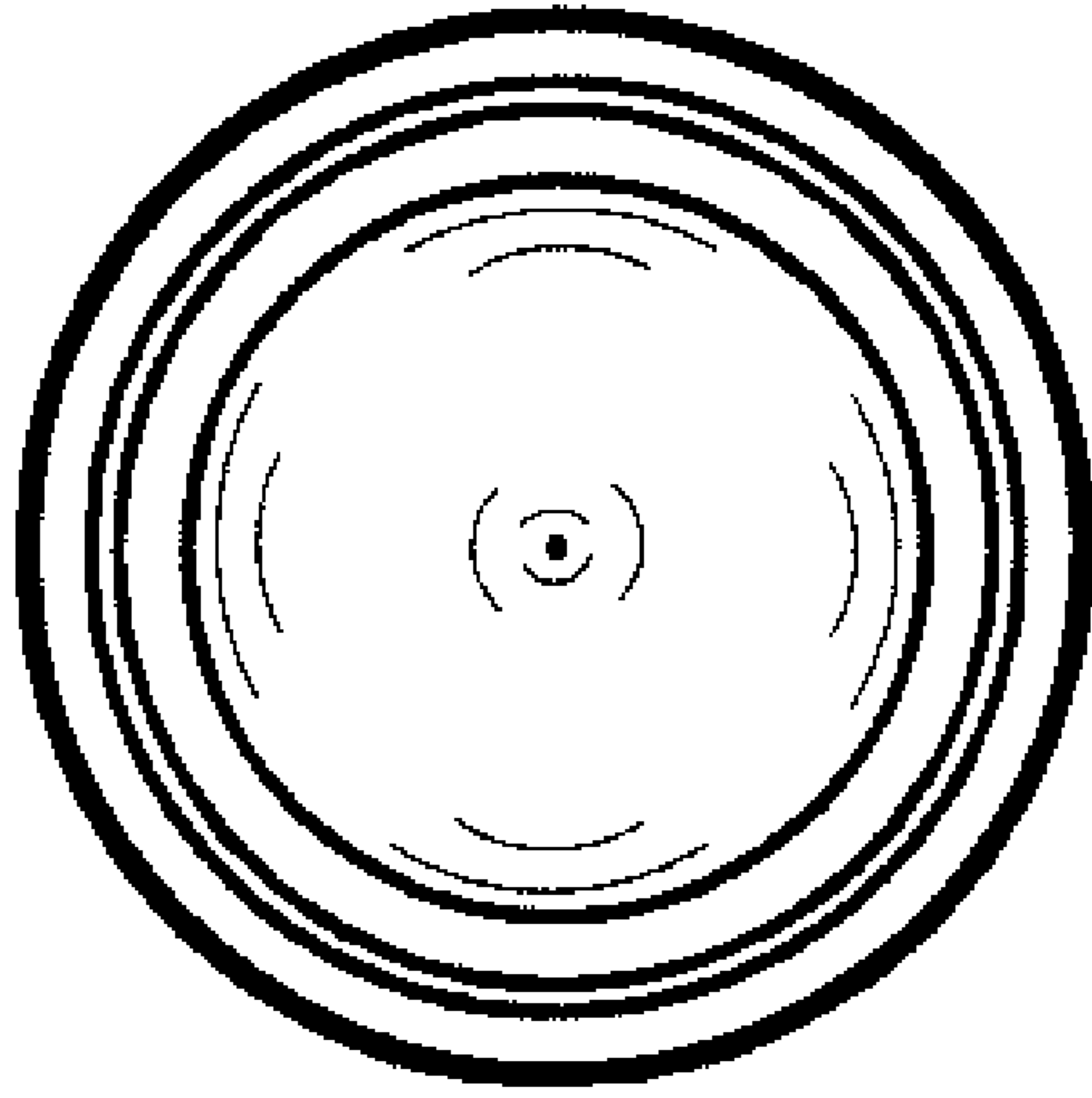
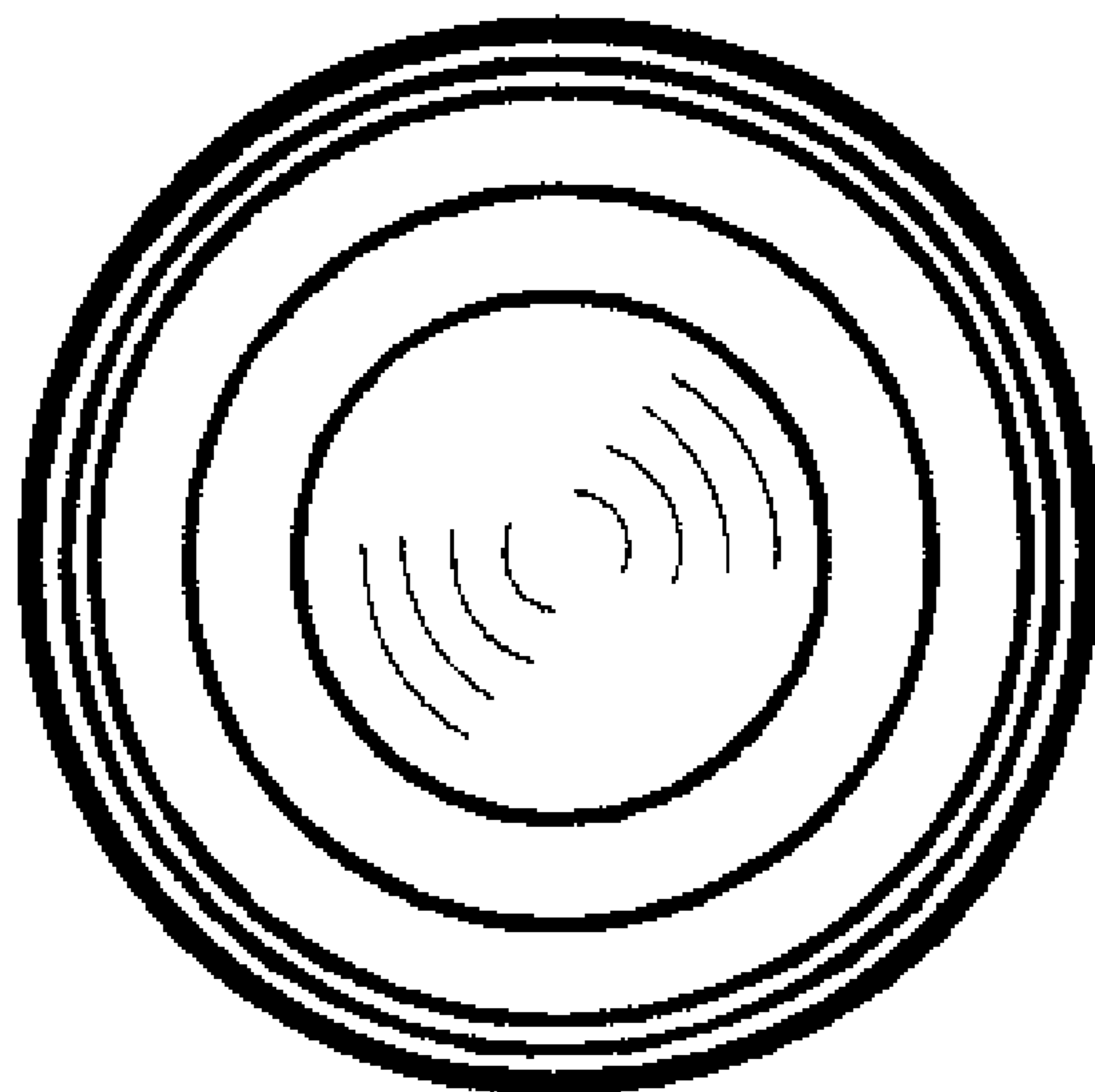
