The ornamental design for a vibrator, as shown and described.

DESCRIPTION

This application is related to commonly owned, concurrently filed U.S. applications Ser. No. 29/365,390, Ser. No. 29/365,392 and Ser. No. 29/365,394, the entire disclosure of all of which applications is hereby incorporated herein by reference.

FIG. 1 is a front and left side perspective view of the vibrator of the present invention;

FIG. 2 is a left side elevation view thereof, the right side elevation view being a mirror image thereto;

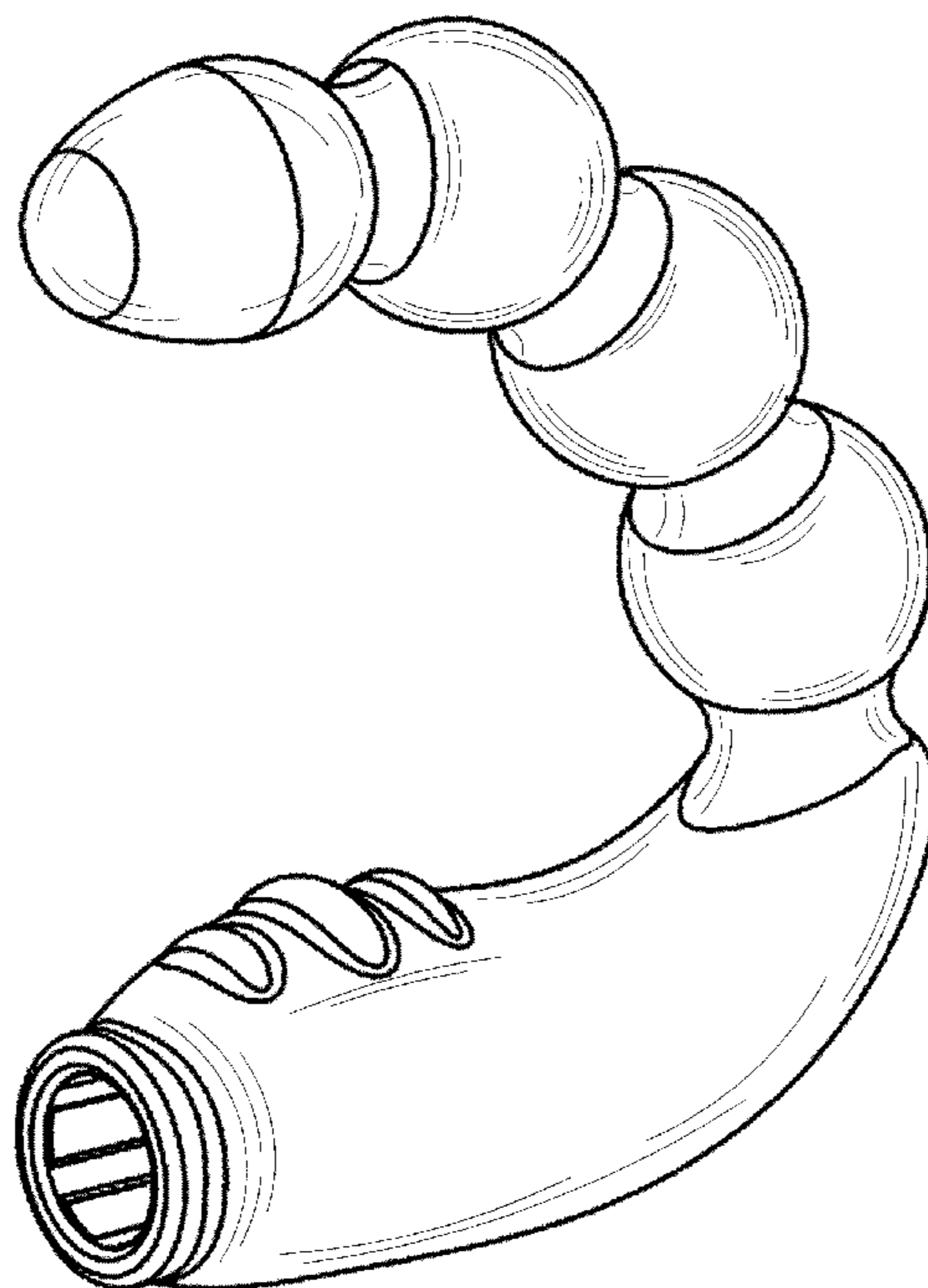
FIG. 3 is a front elevation view thereof;

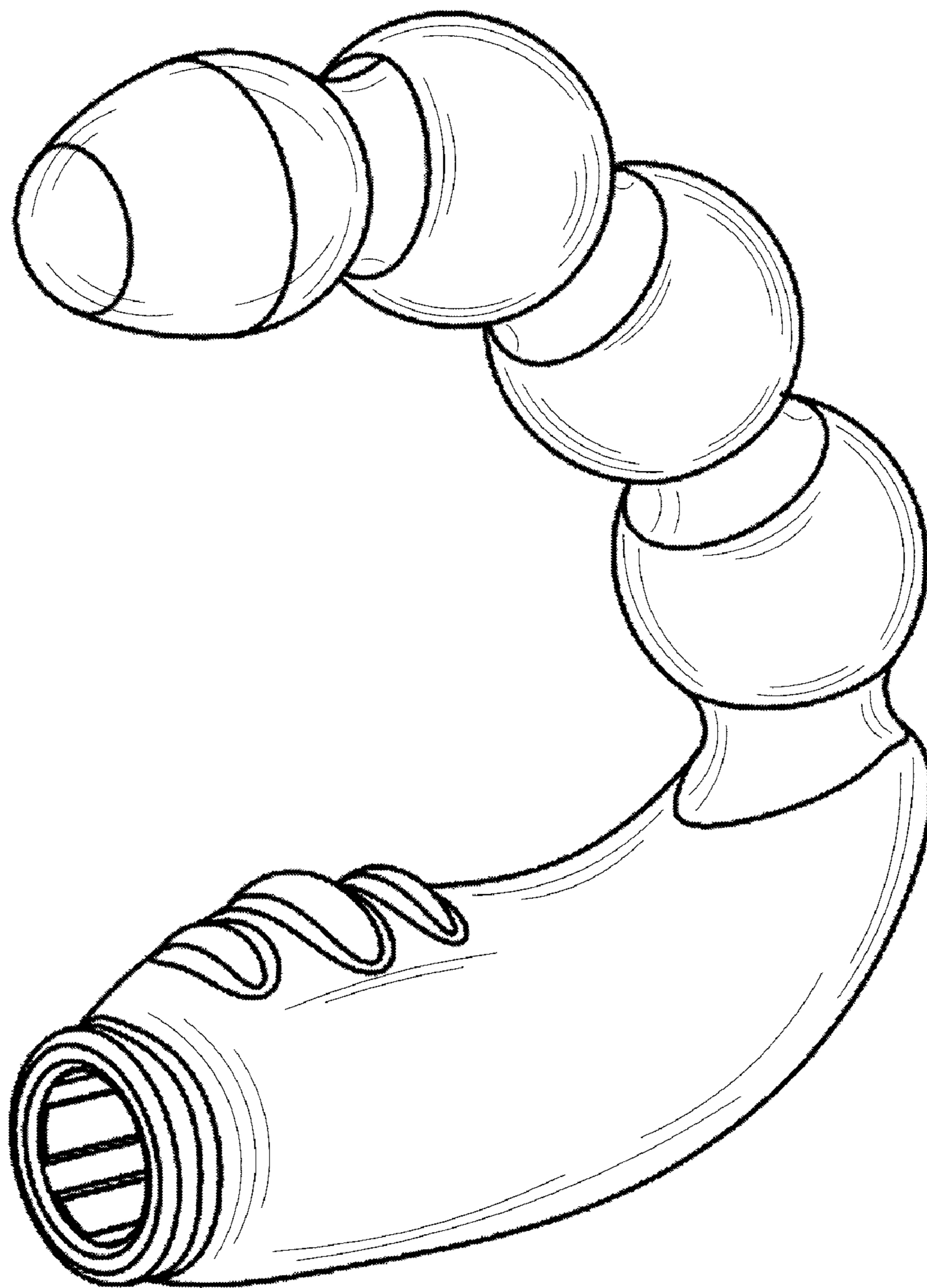

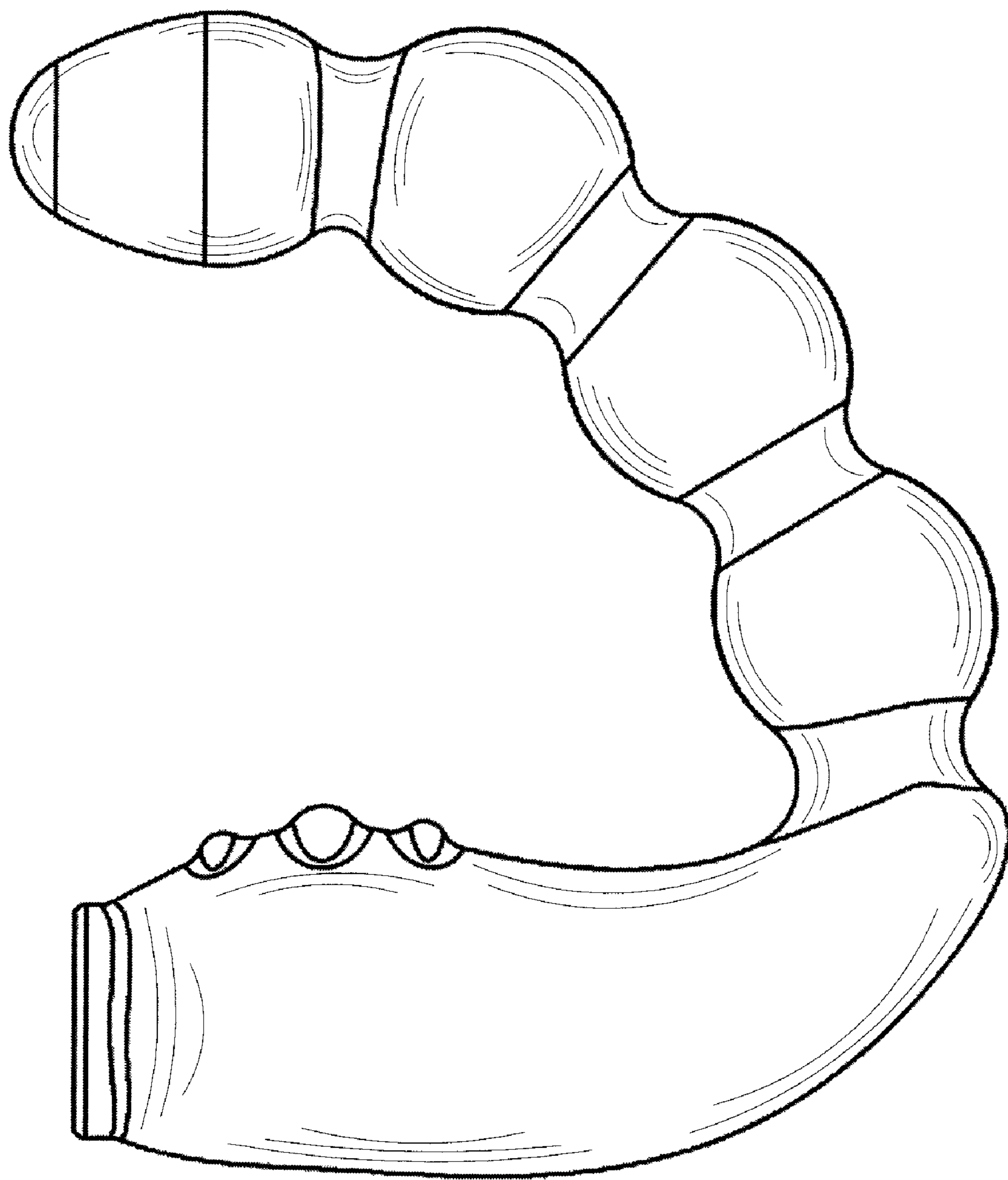

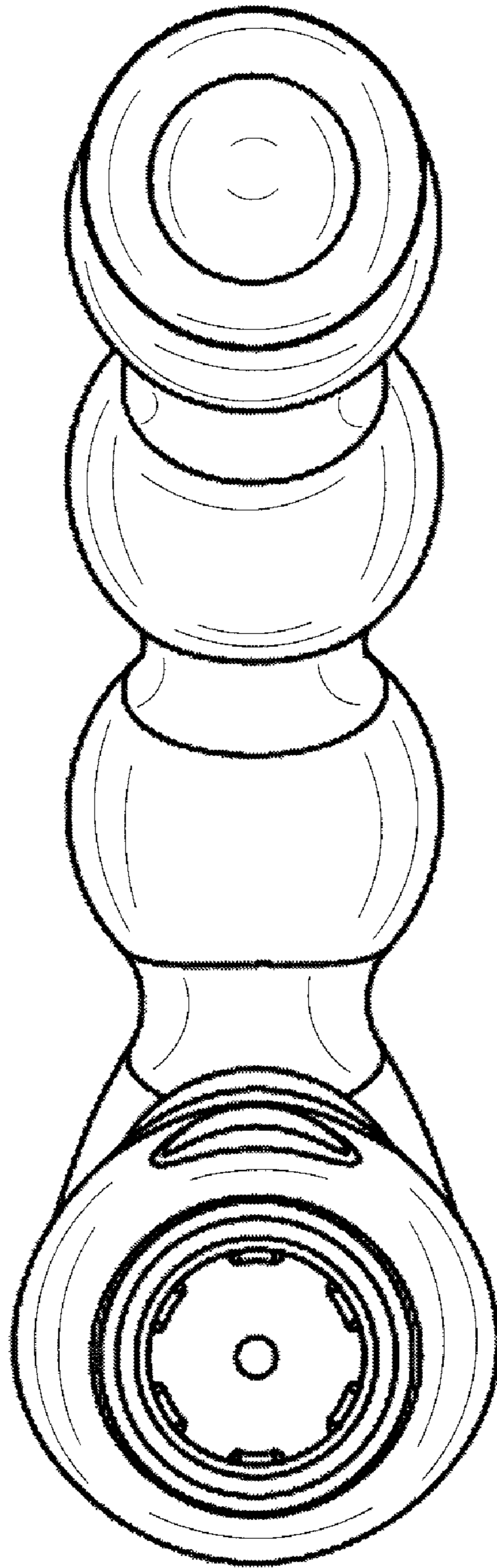

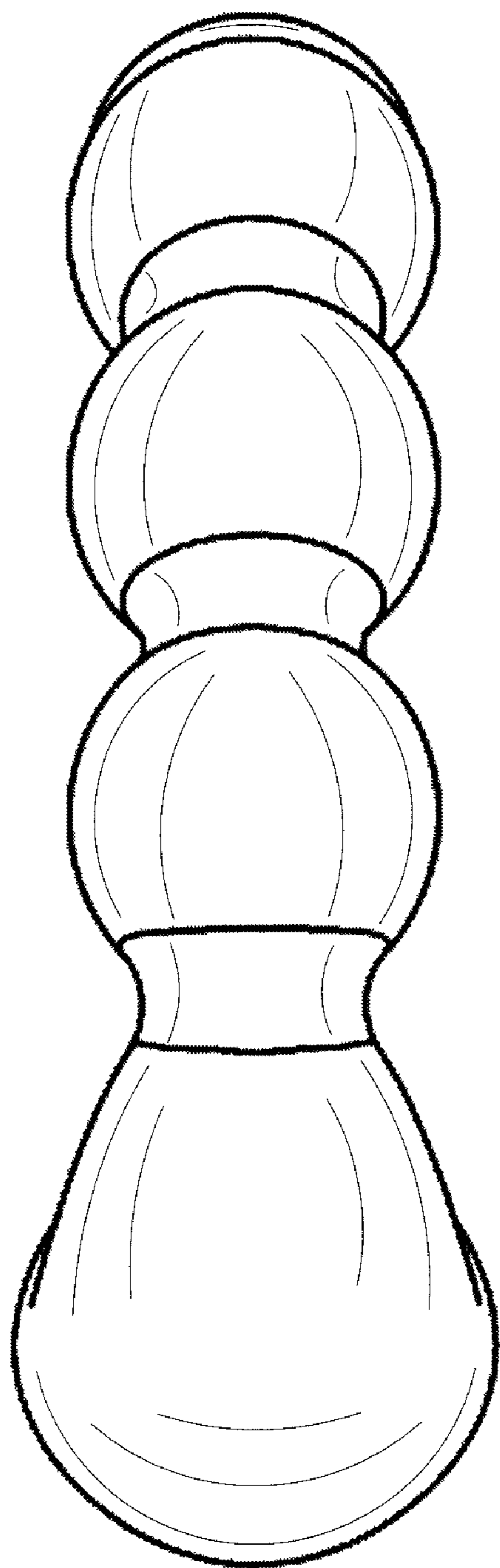

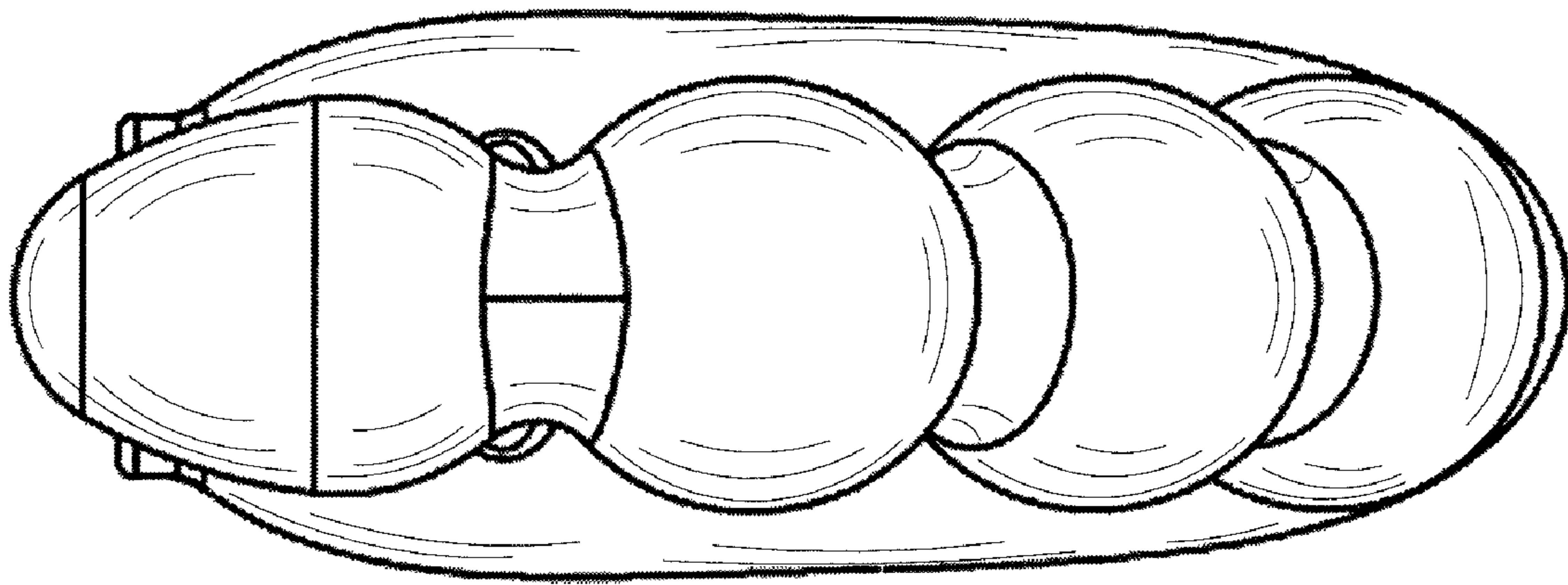

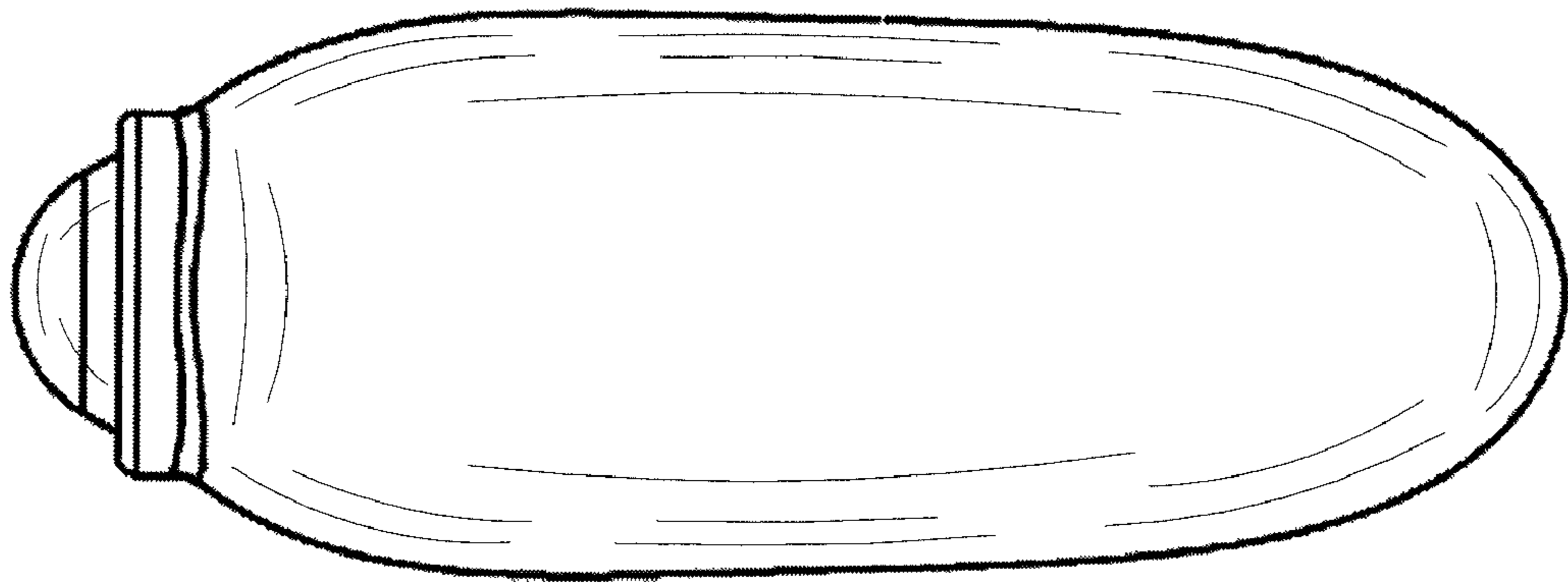
