The ornamental design for a display for a dishwasher, as shown and described.

FIG. 4 is a front view thereof;

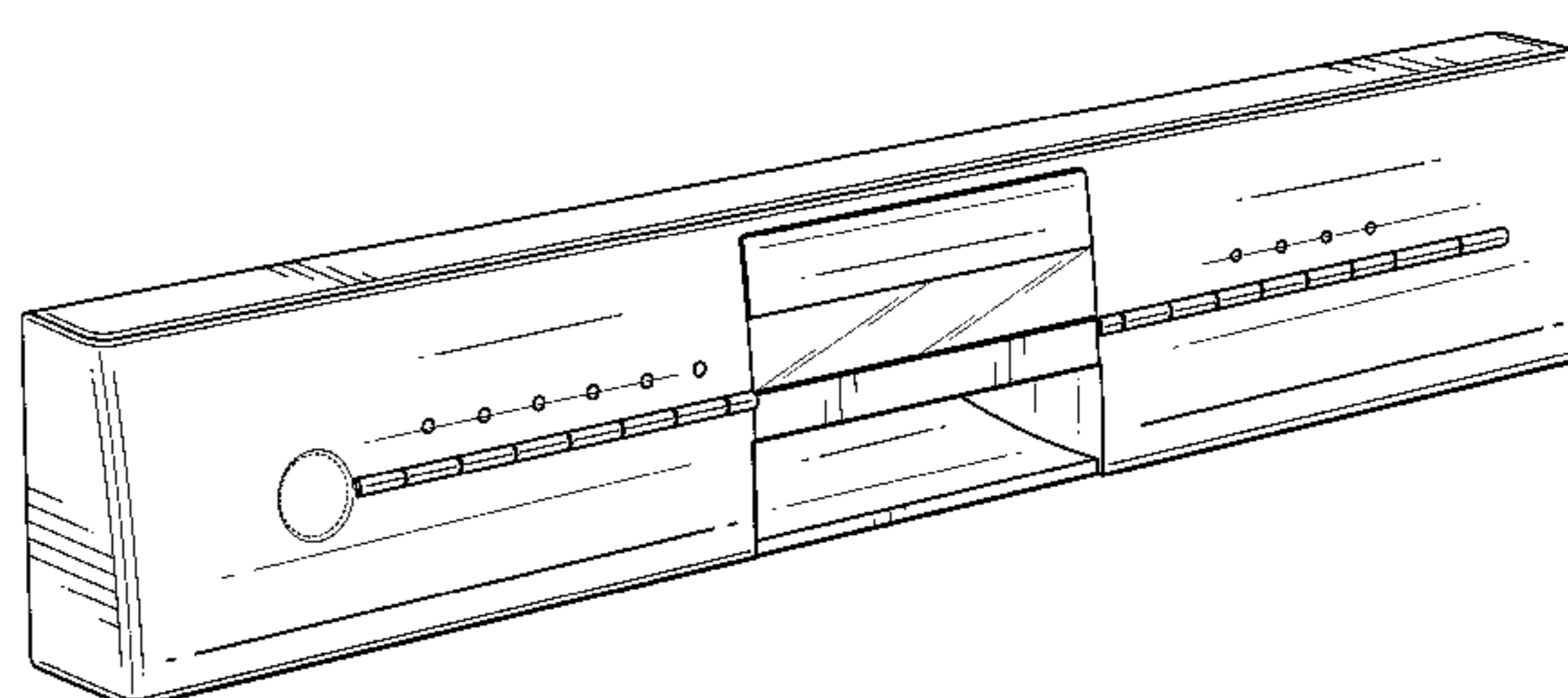
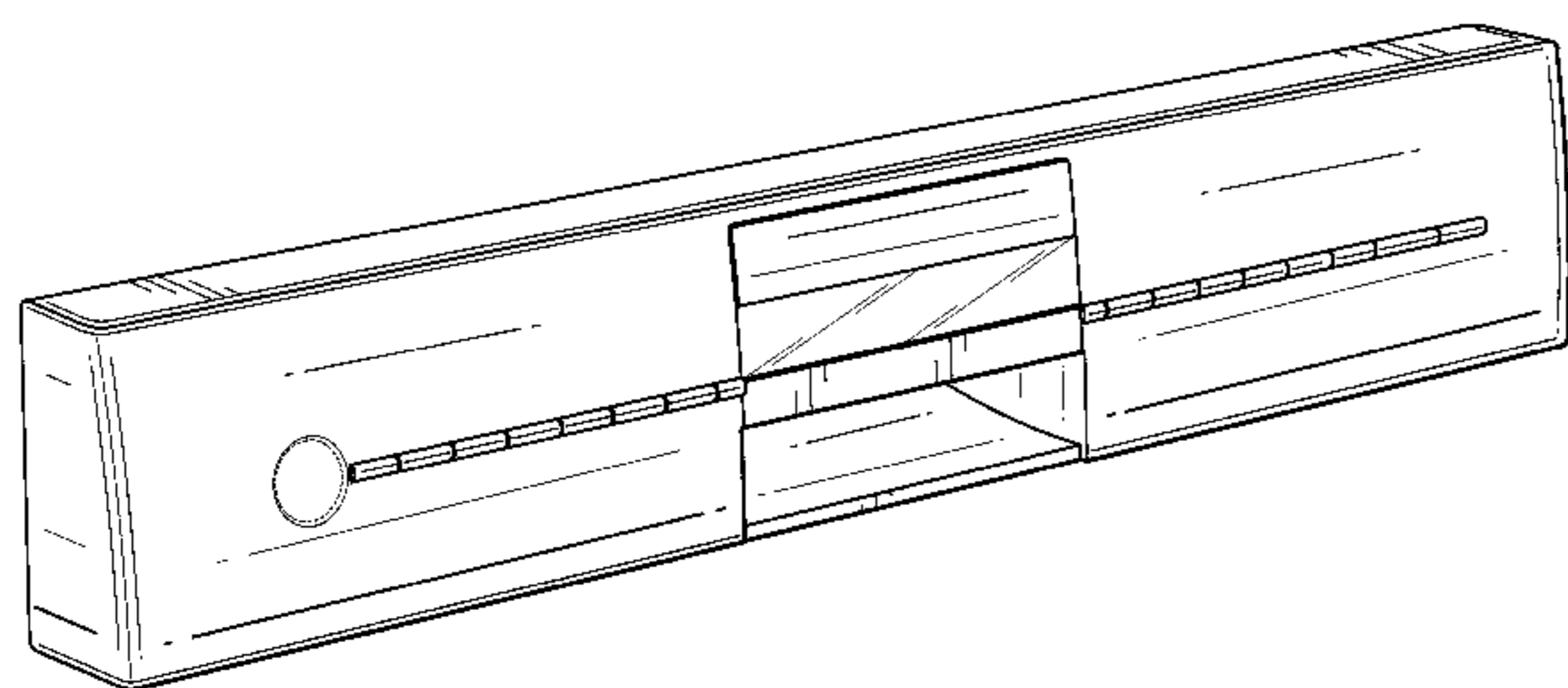
FIG. 5 is a perspective view of a third embodiment of a display for a dishwasher showing my new ornamental design; and,

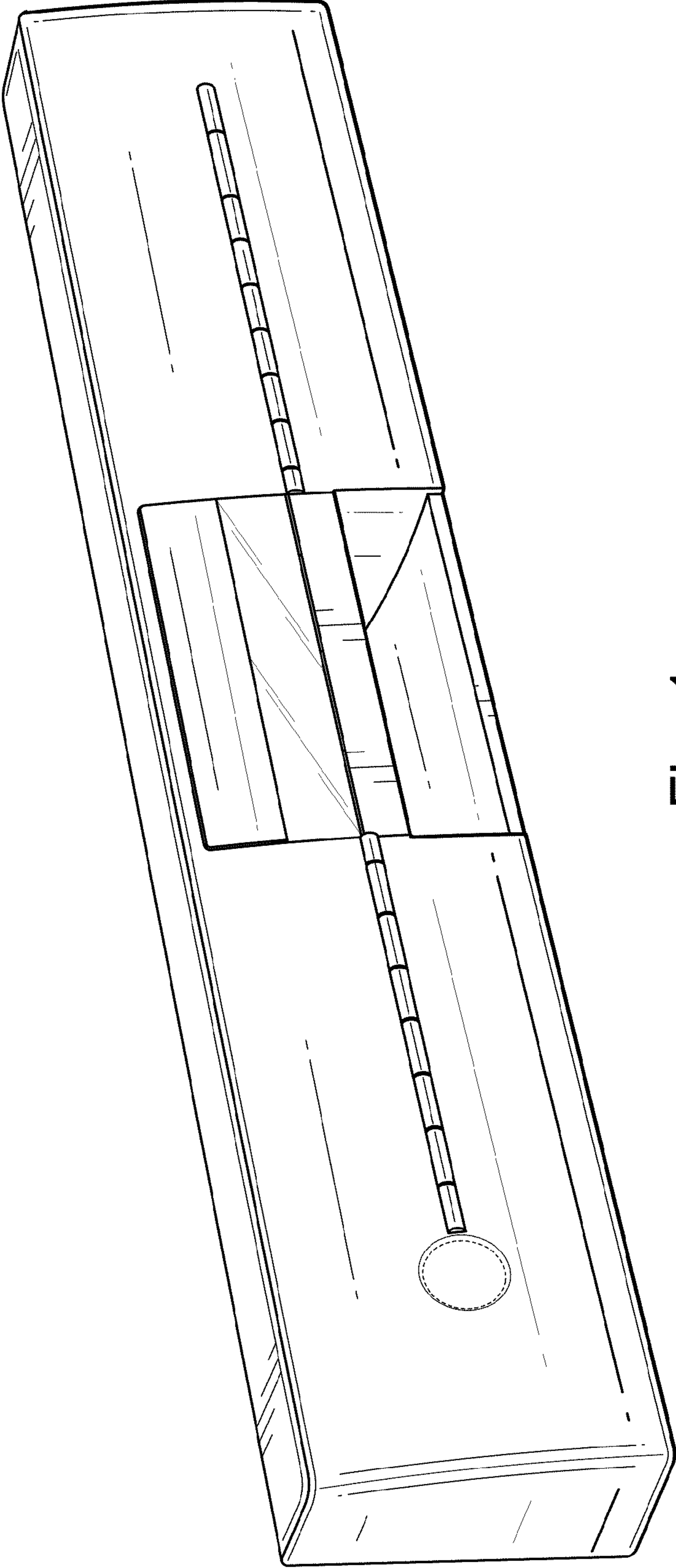

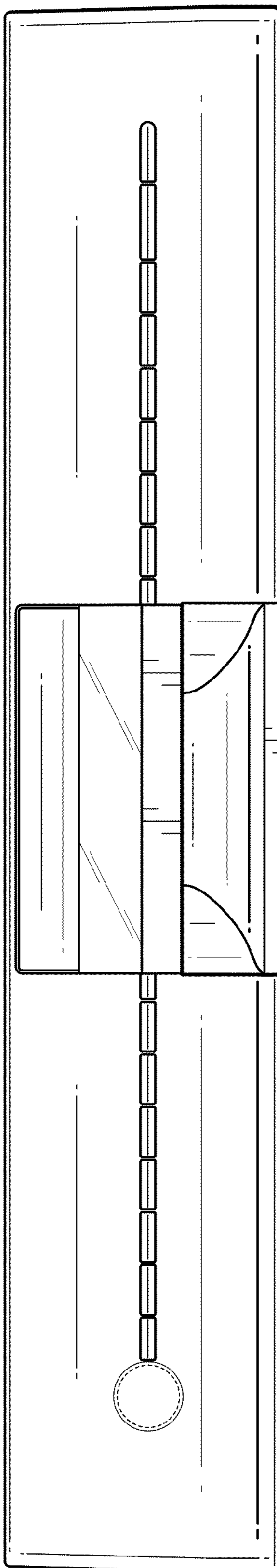

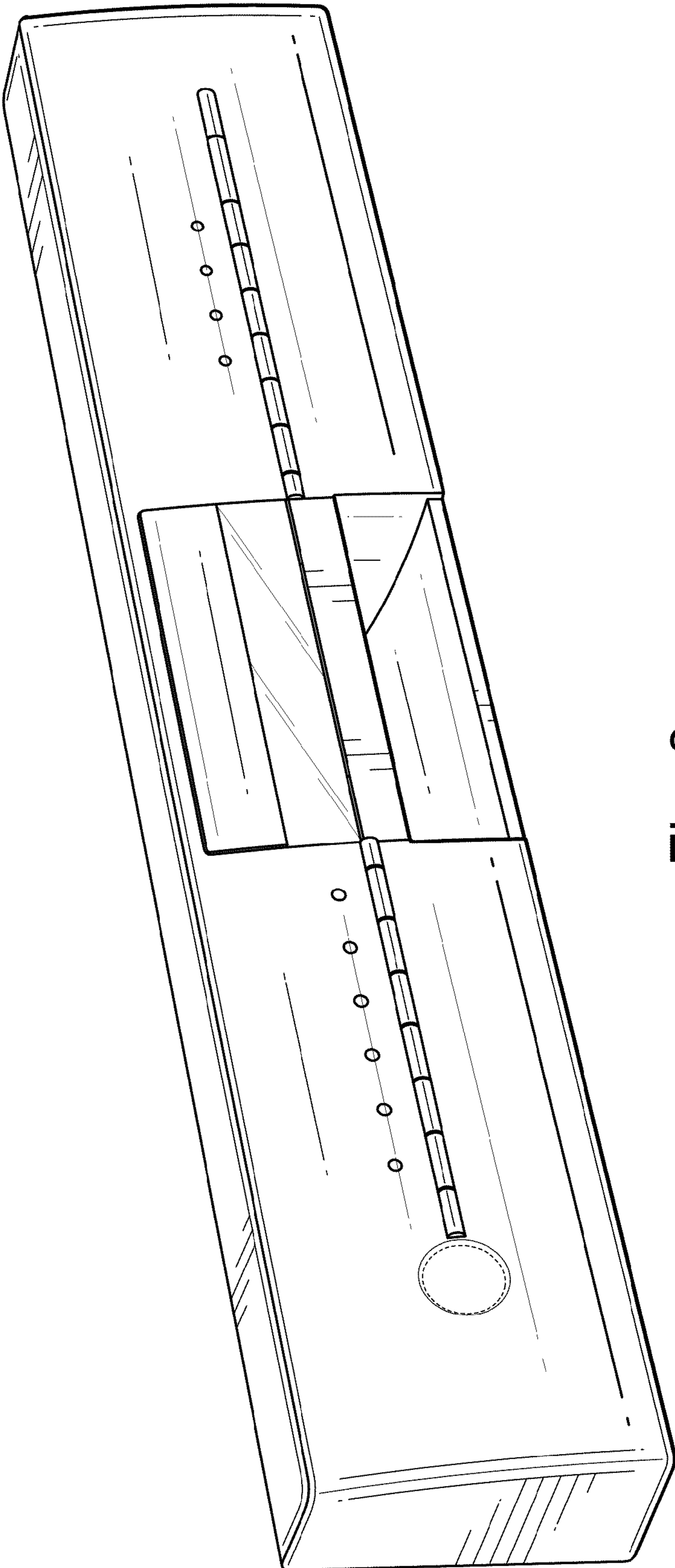

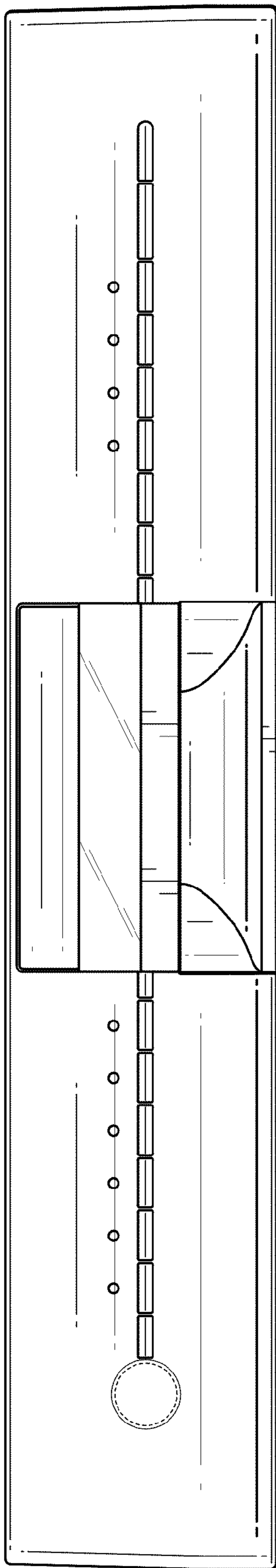

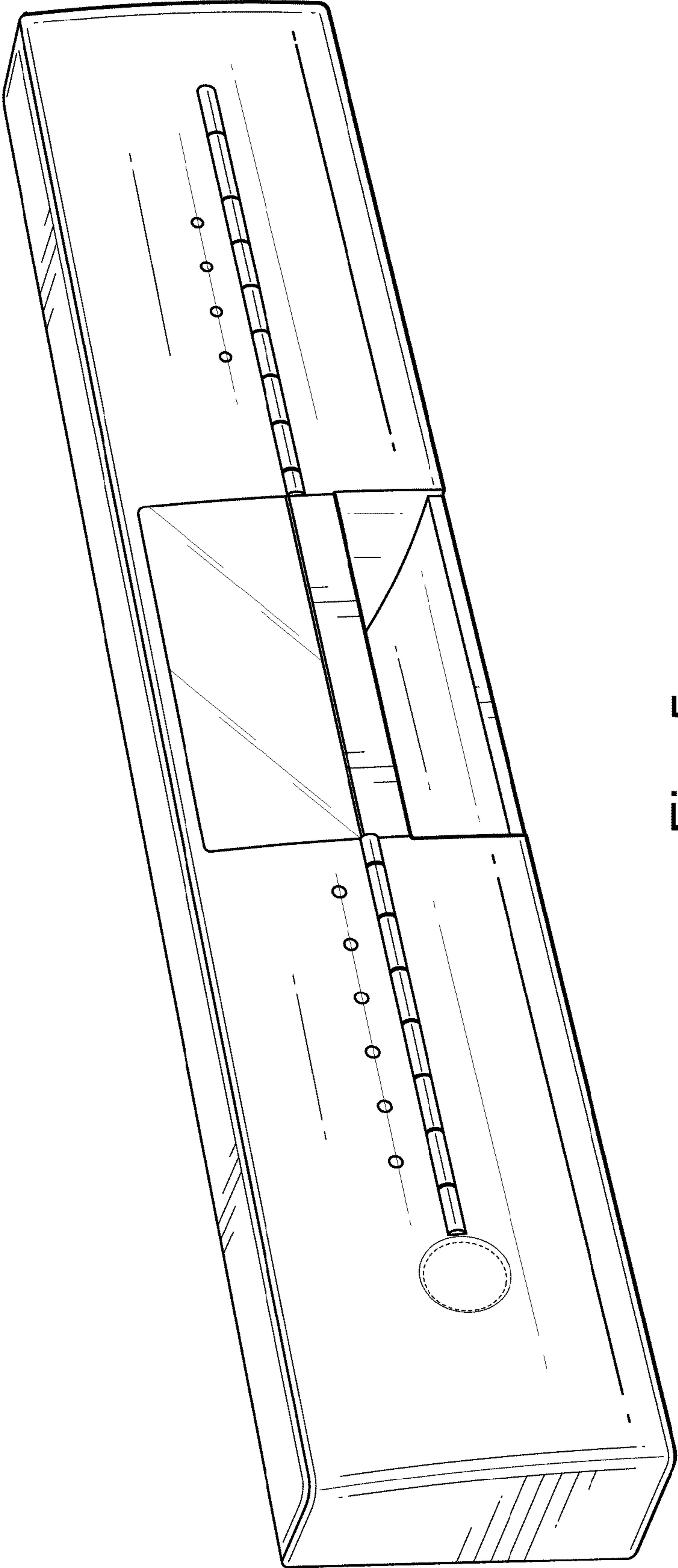

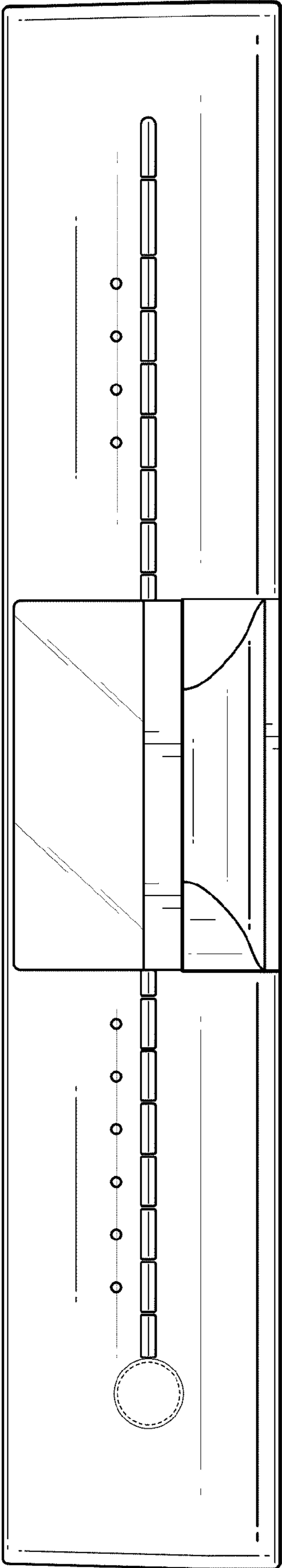
