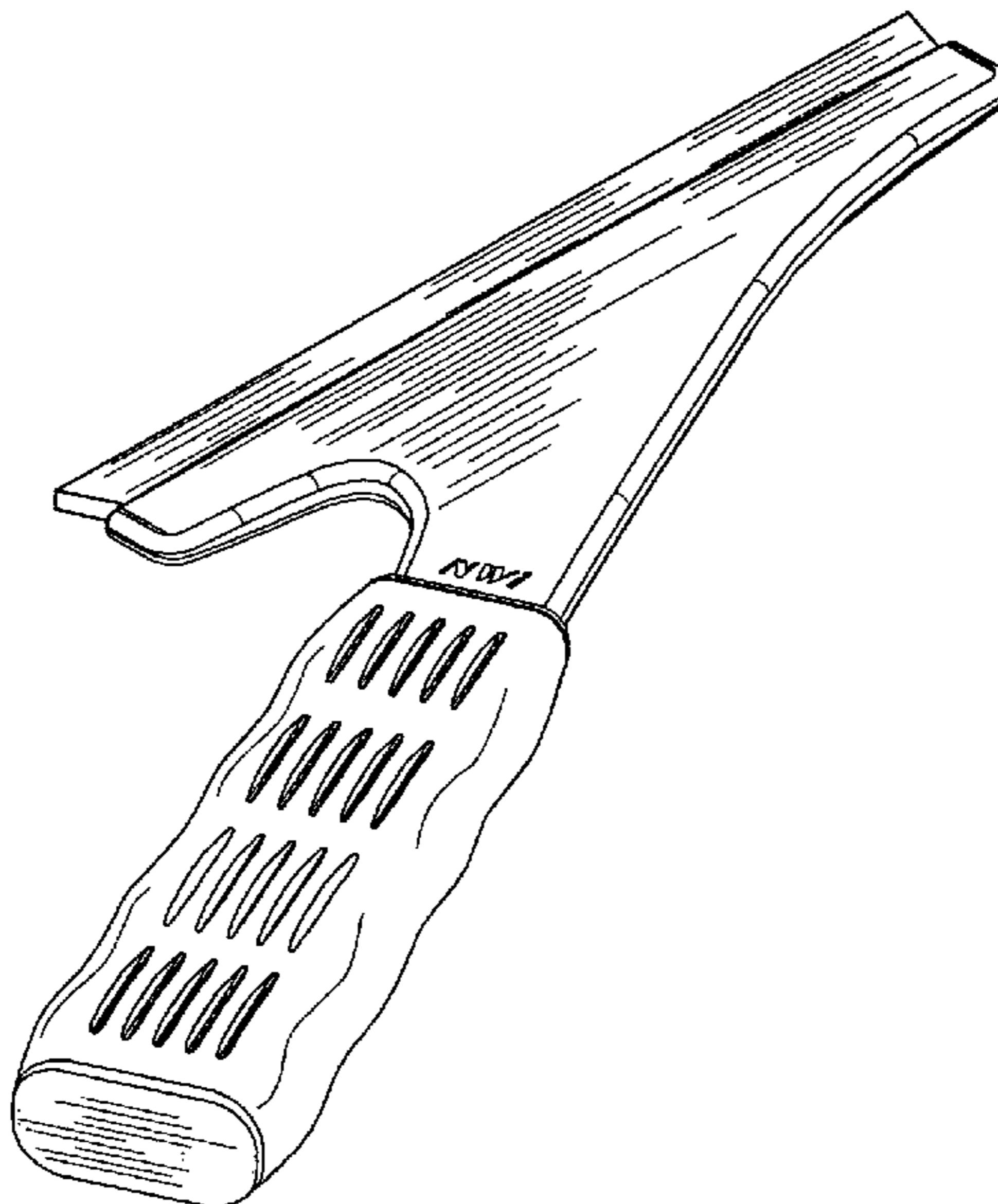
(57) **CLAIM**

The ornamental design for a squeegee with tapered handle, as shown and described.

**DESCRIPTION**

FIG. 1 is an end perspective view of an embodiment of my design for a squeegee with tapered handle;  
FIG. 2 is a front elevational view, with the rear elevational being a mirror image thereof;  
FIG. 3 is a handle end perspective view thereof;  
FIG. 4 is a blade end perspective view thereof;

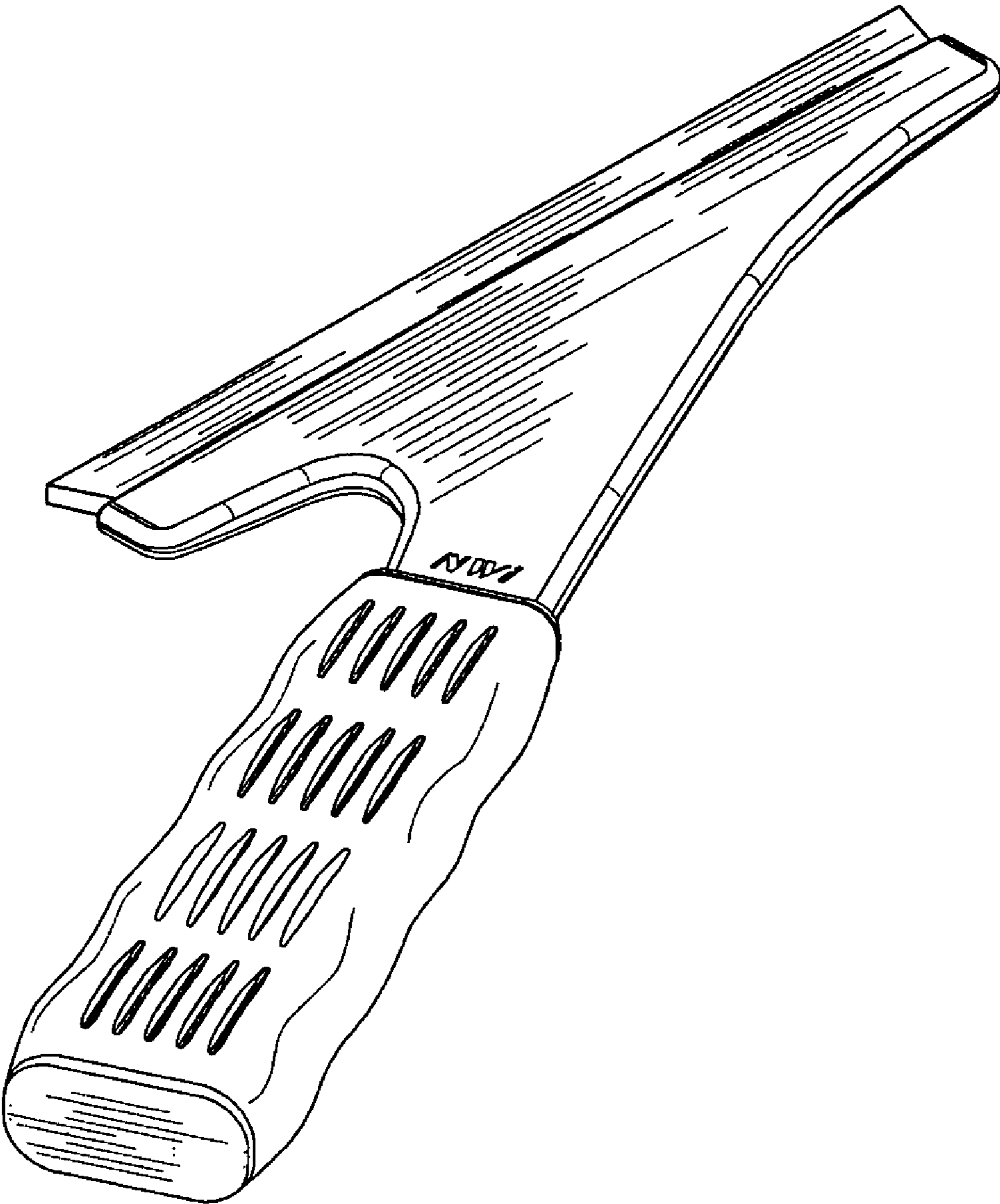

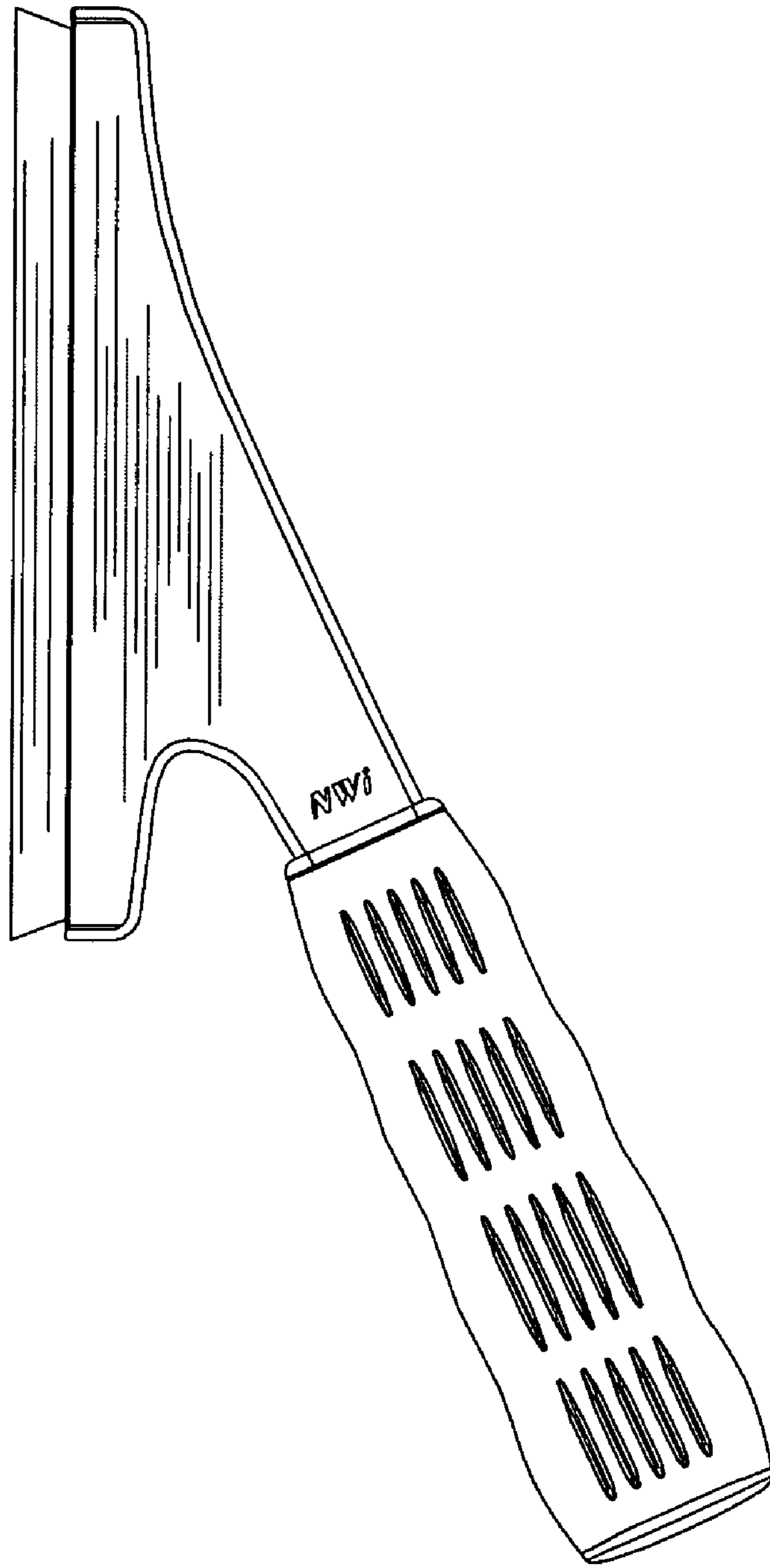

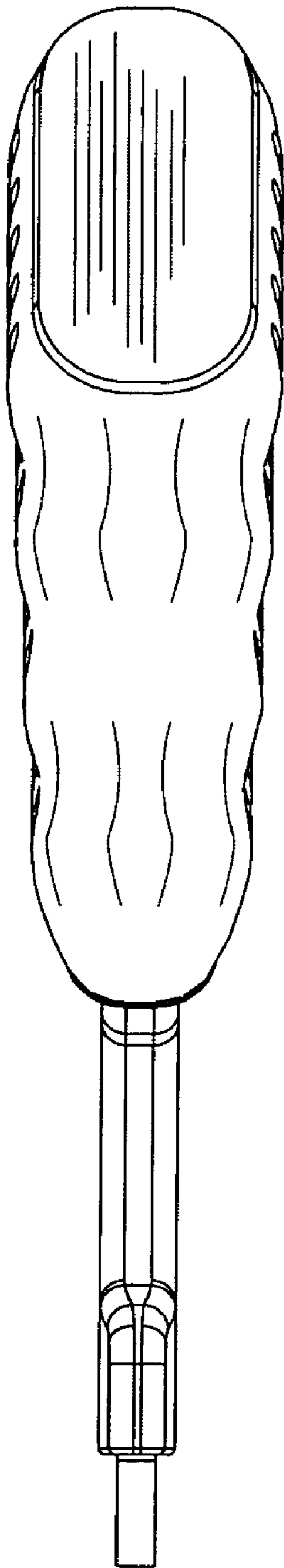

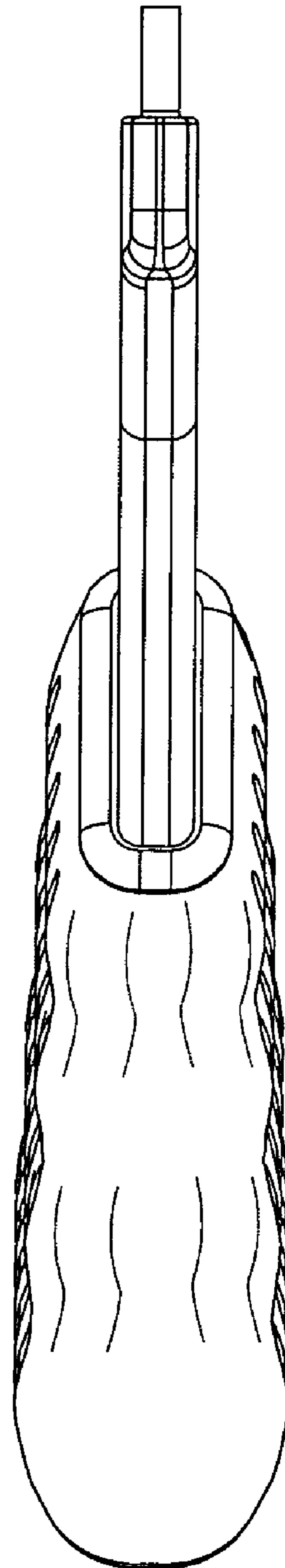

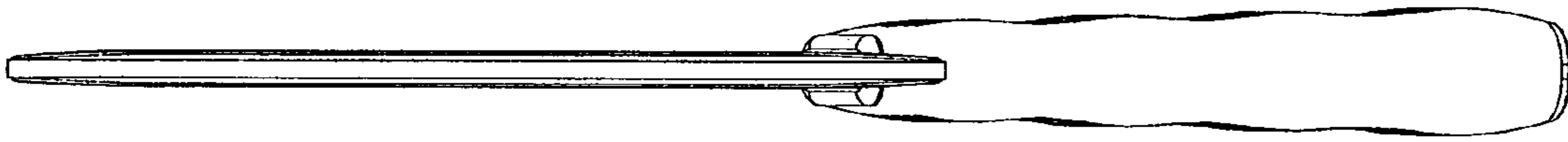

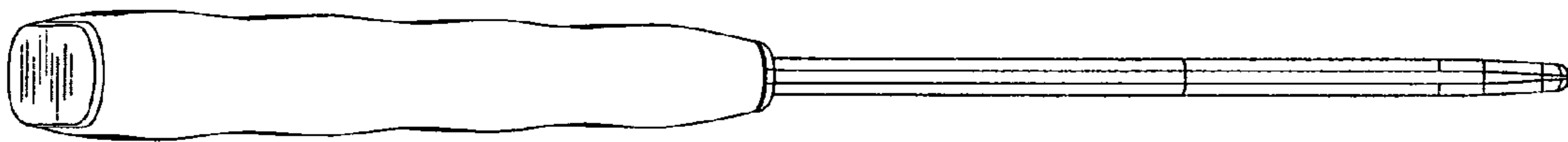
