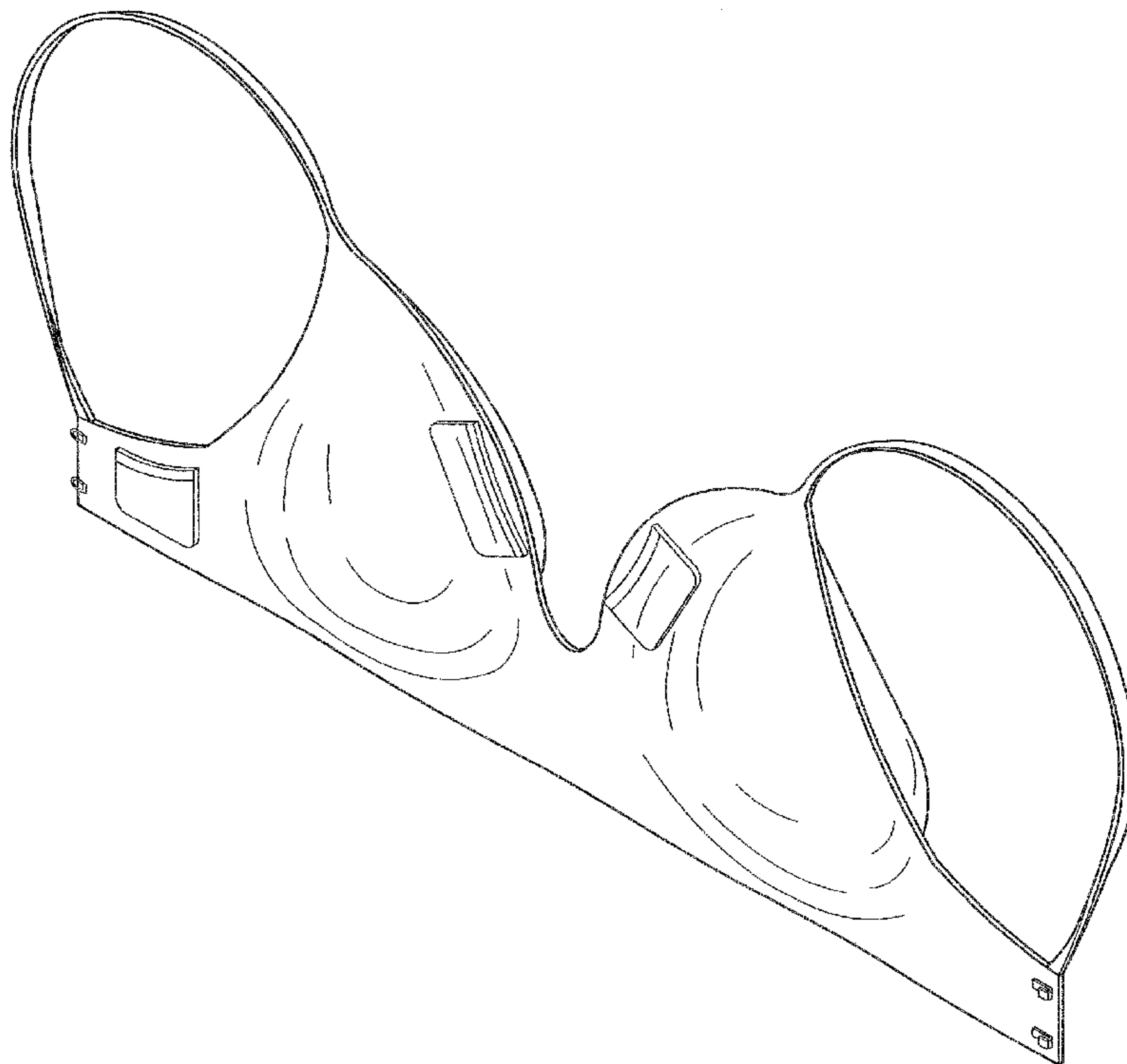
(57) **CLAIM**

The ornamental design for a bra with closeable concealed pockets, as shown and described.

DESCRIPTION

FIG. 1 is a rear elevational view of a bra with closeable concealed pockets, showing my new design;

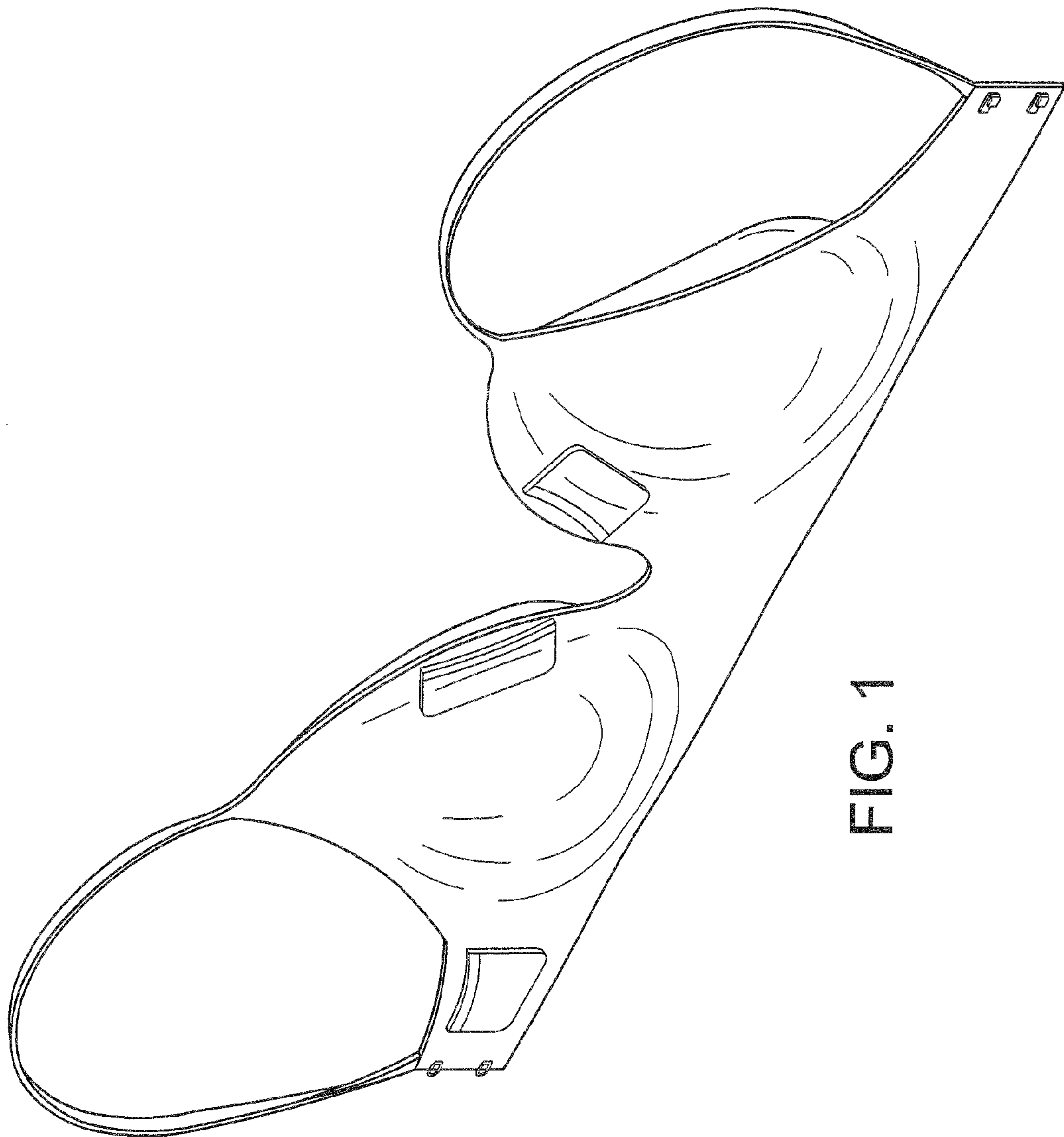

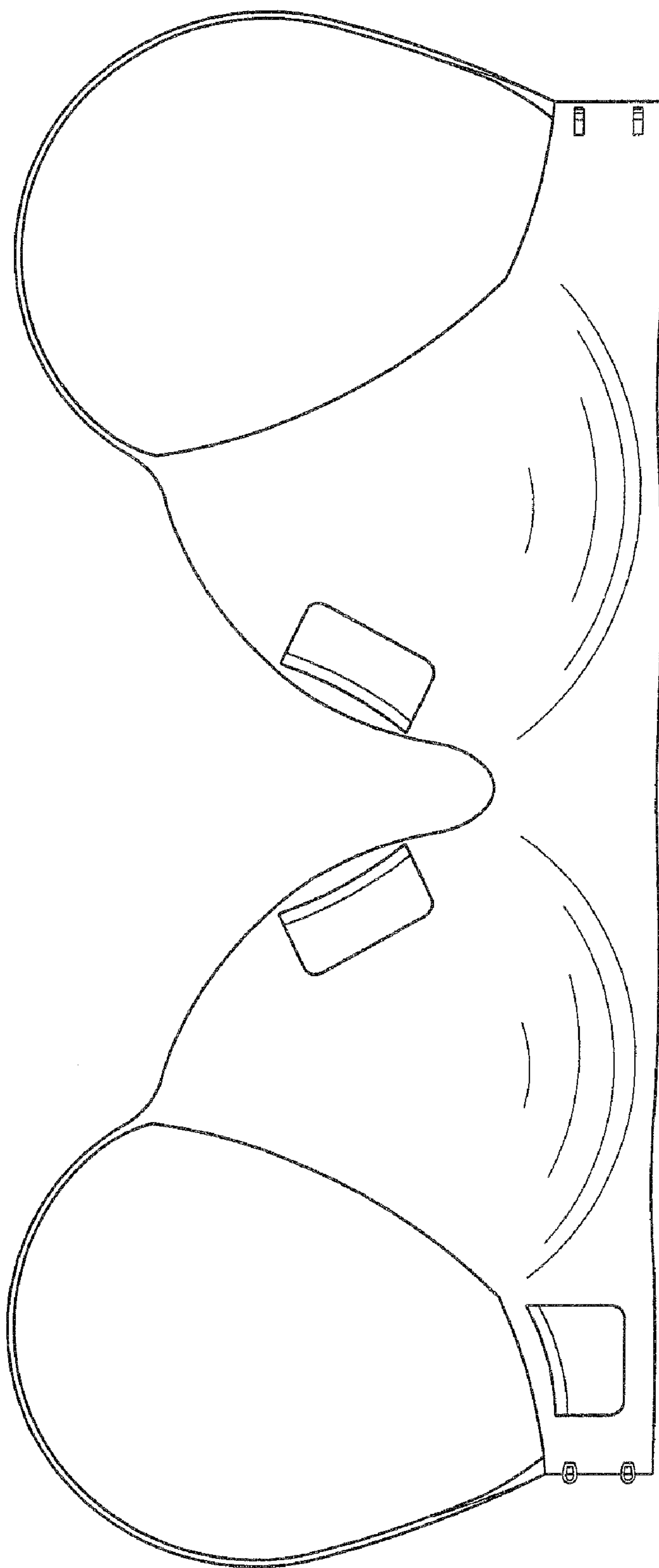

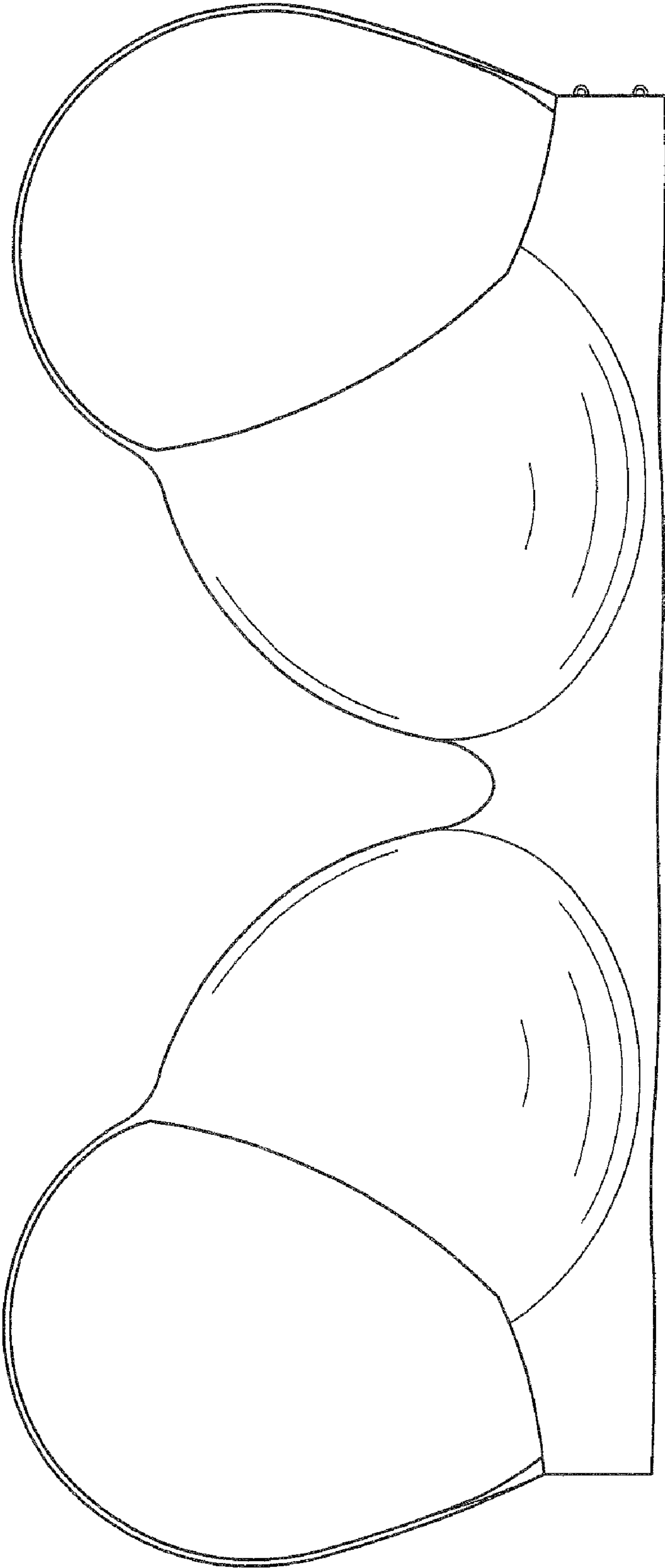

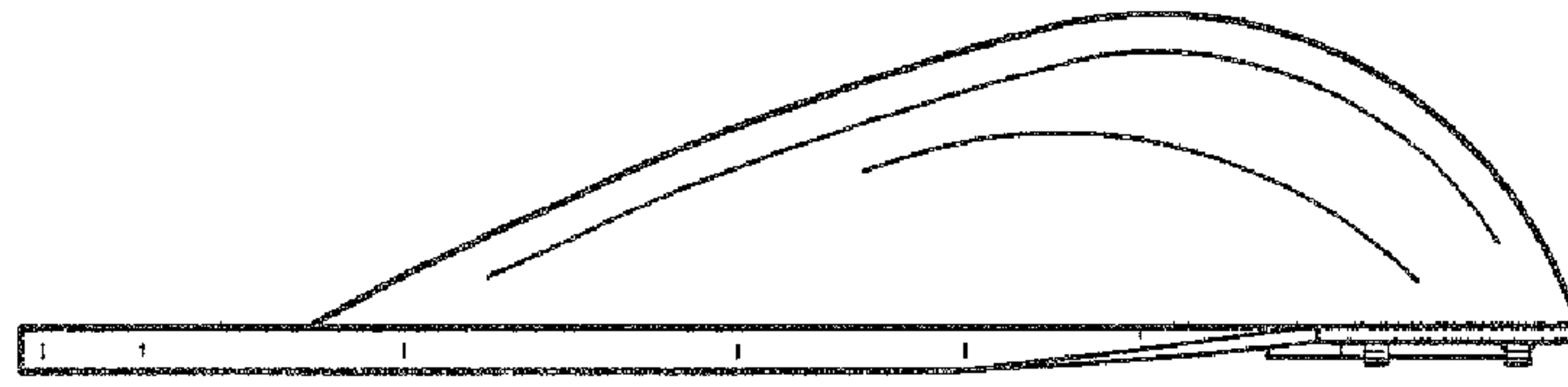

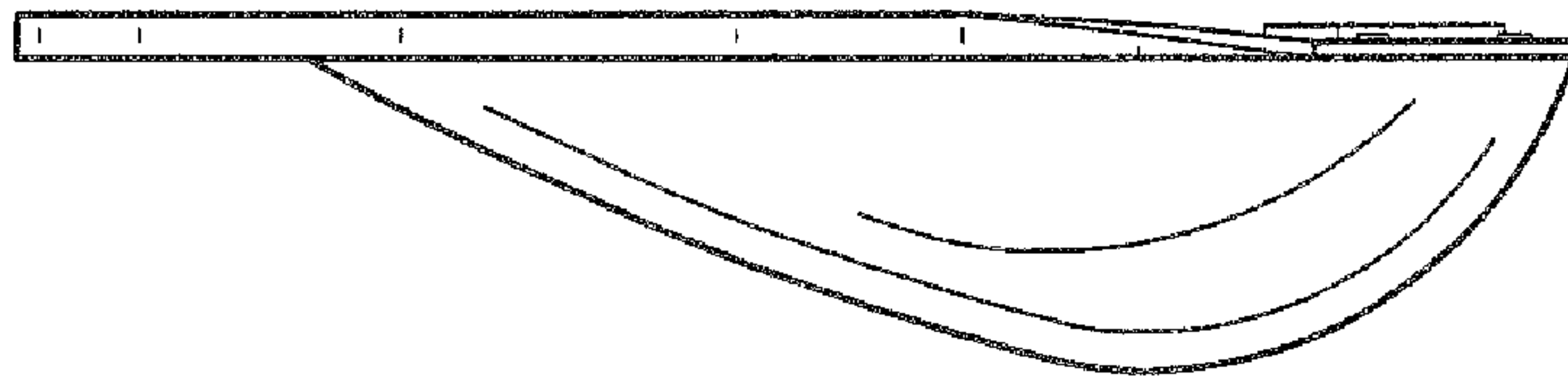

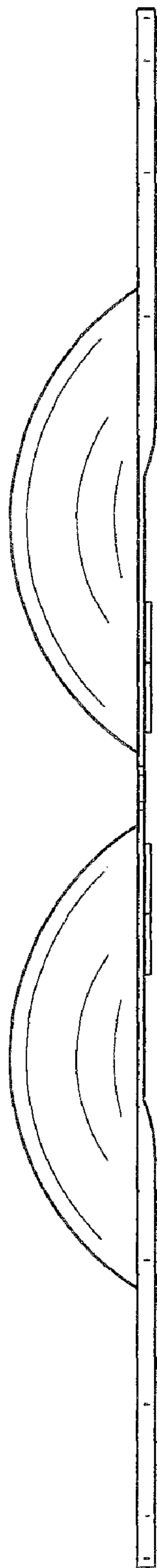

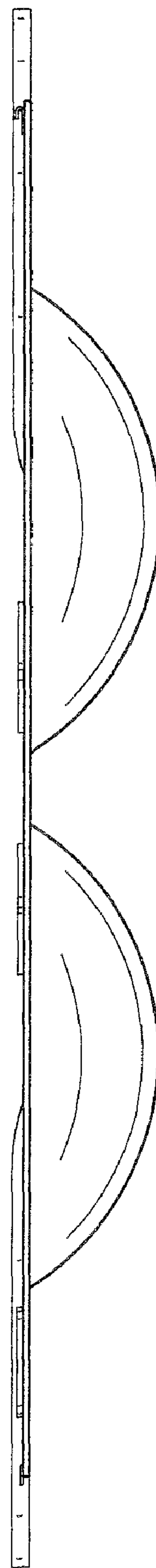
