FIG. 3 is a rear view thereof;

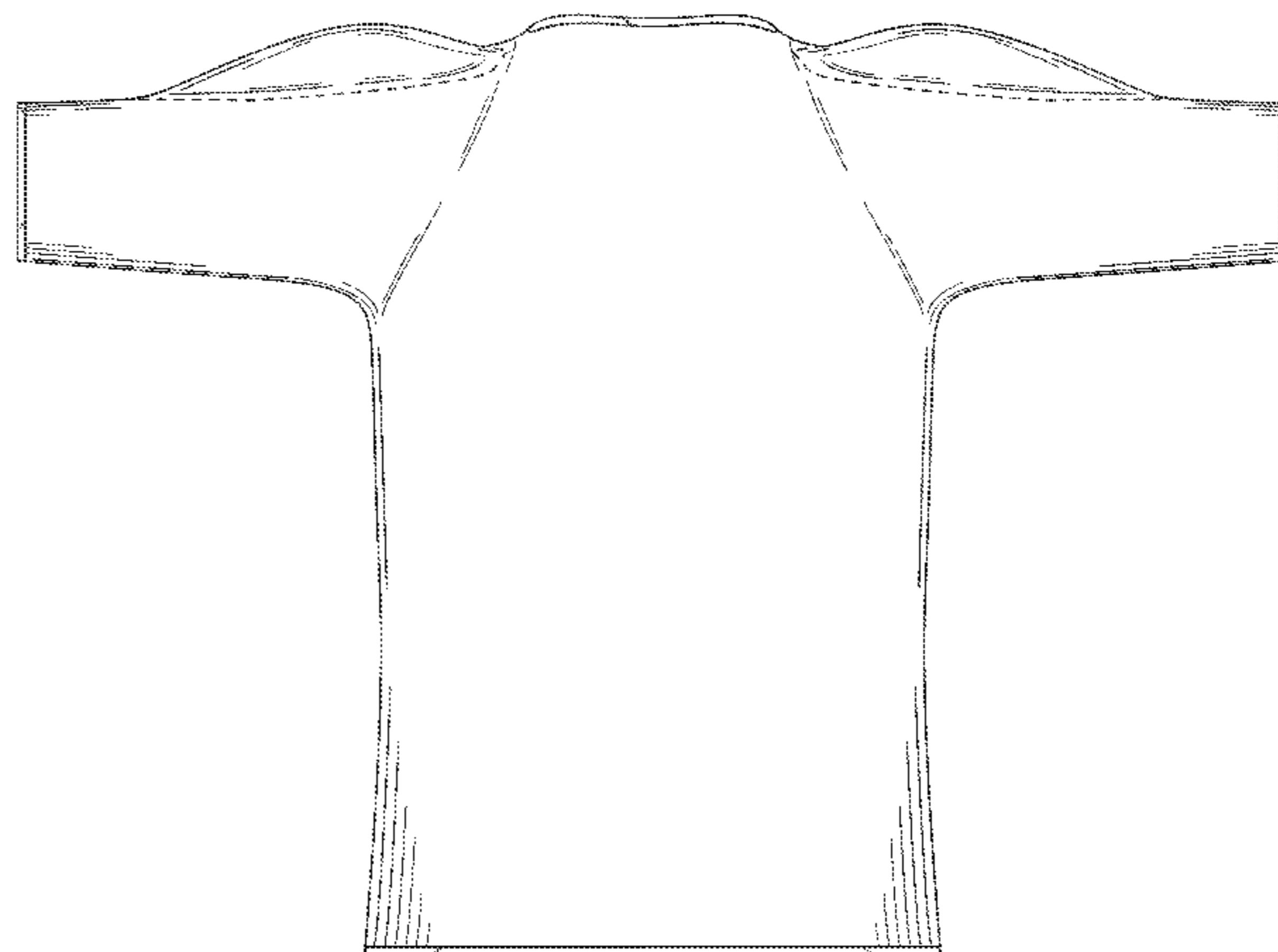
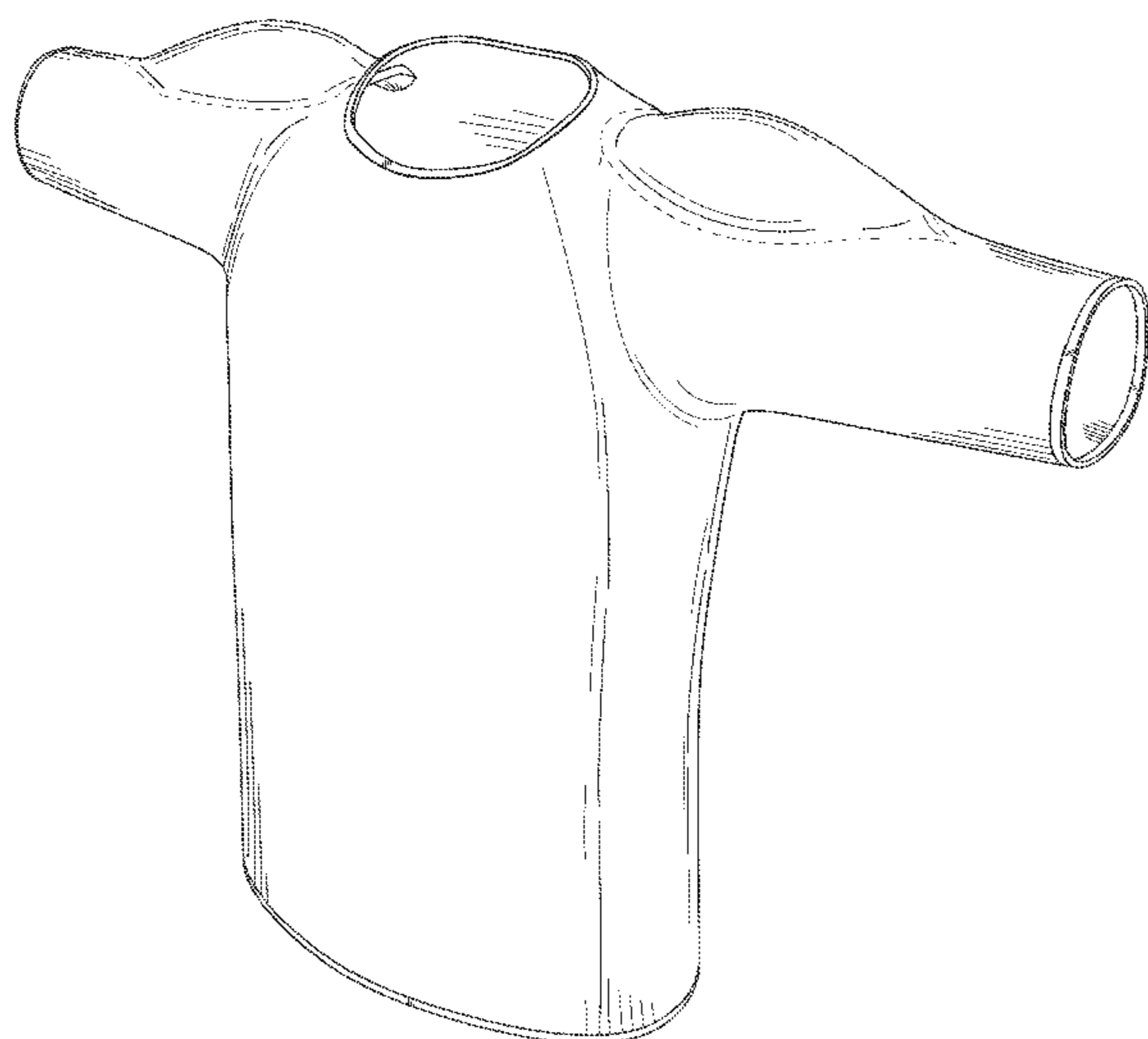
FIG. 4 is a left side view thereof with a right side view being the mirror image;

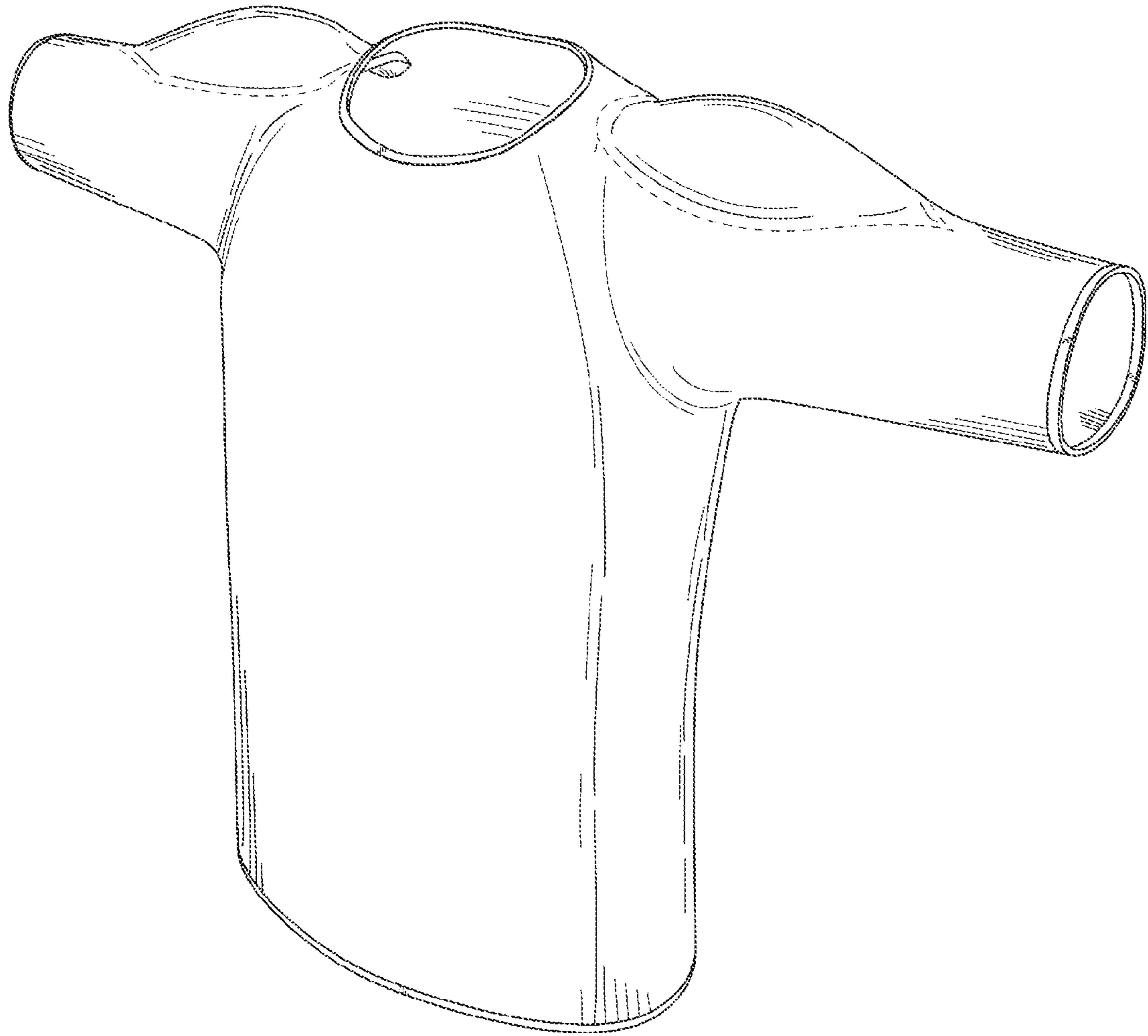

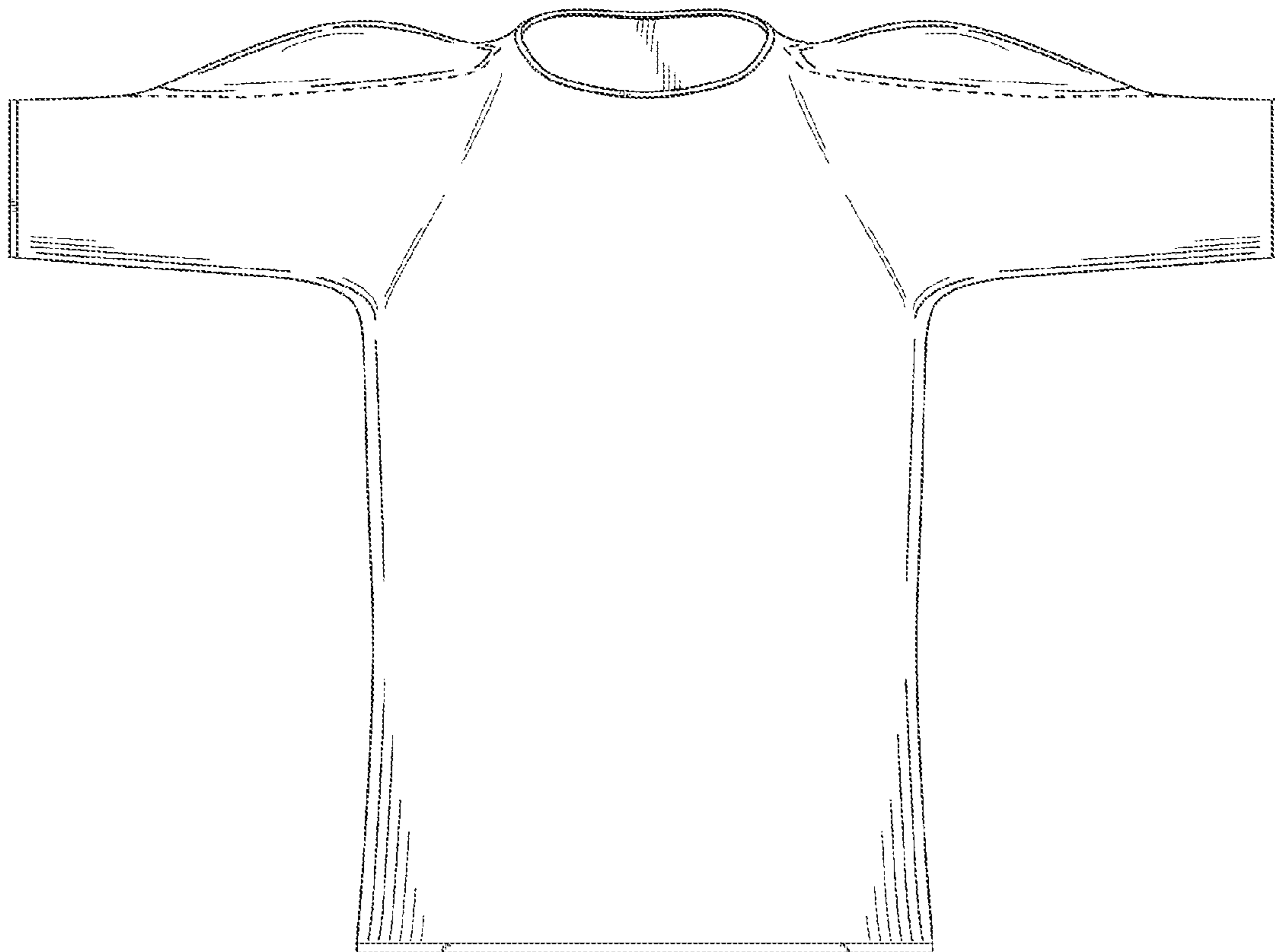

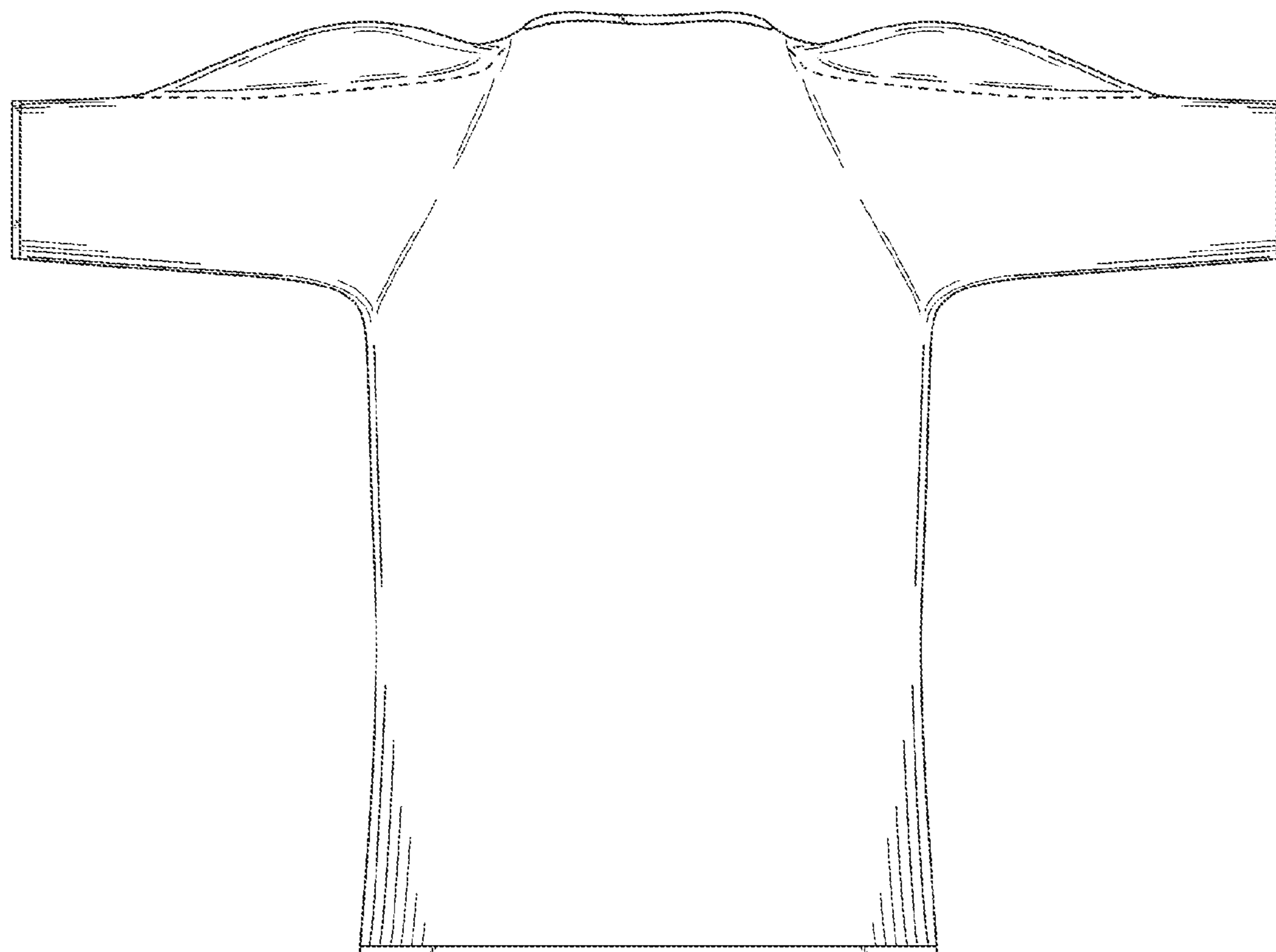

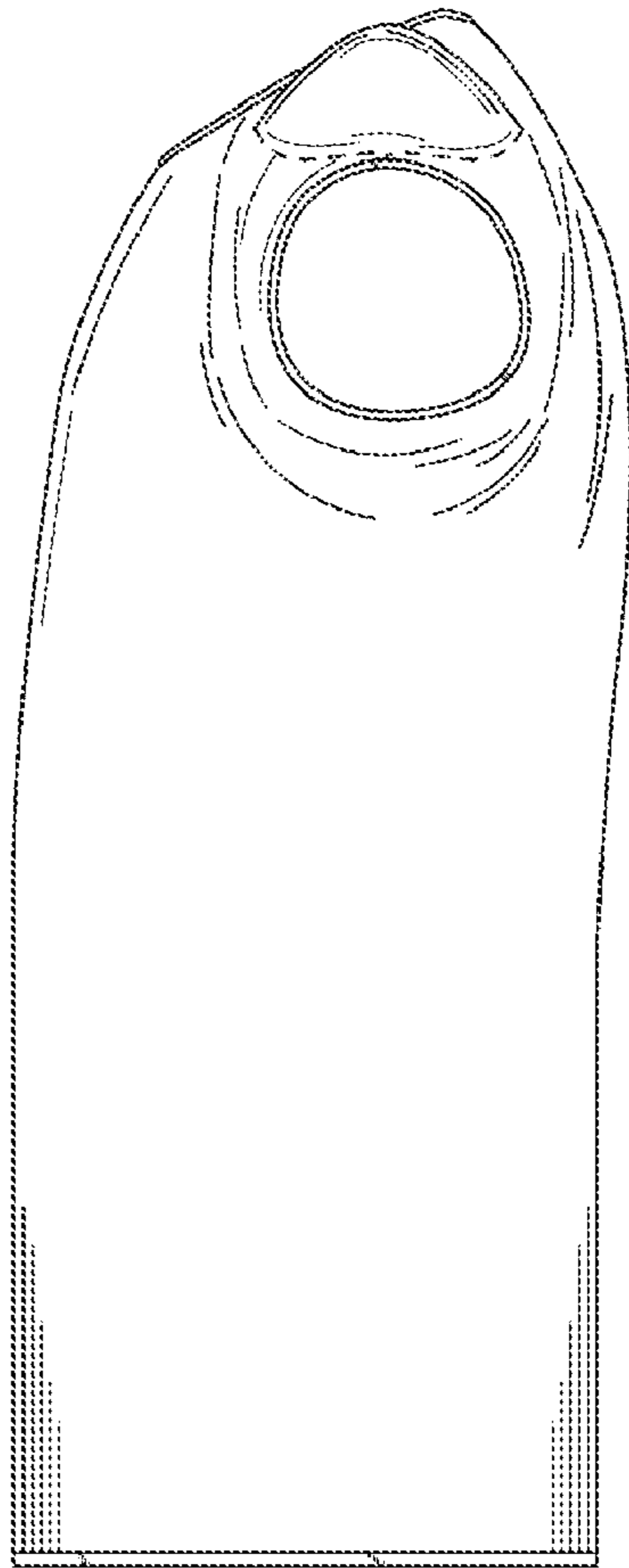

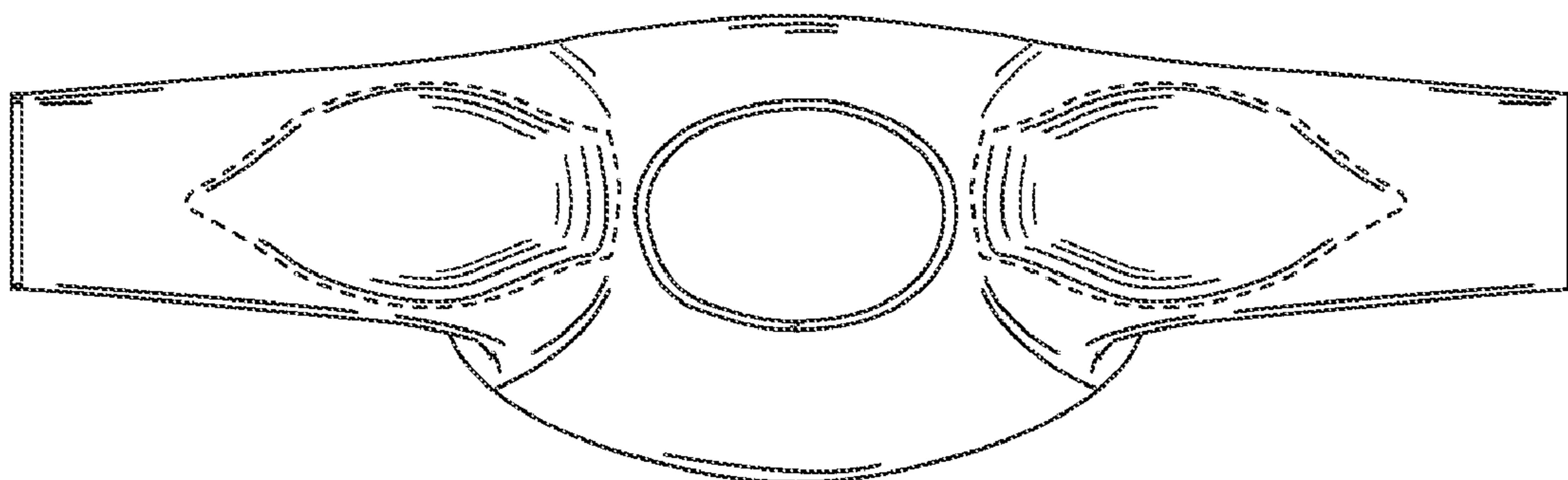

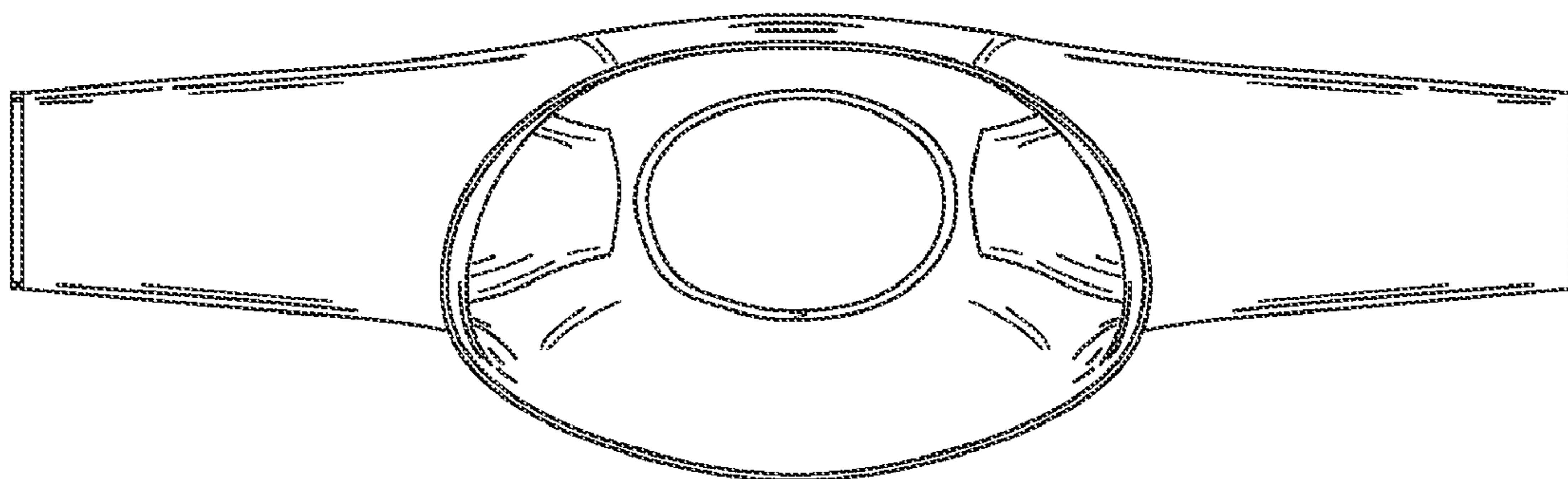
