DESCRIPTION

FIG. 1 is a front perspective view of the boot of my new design;

FIG. 2 is a front perspective view of a boot, with the leg portion in a folded position;

FIG. 3 is a back perspective view of the boot;

FIG. 4 is another back perspective view of a boot with the leg portion in a folded position;

FIG. 5 is a side view of the boot;

FIG. 6 is another side view of a boot with the leg portion in a folded position; and,

FIG. 7 is a front view of the boot.
