FIG. 12 is a right elevational side view thereof.

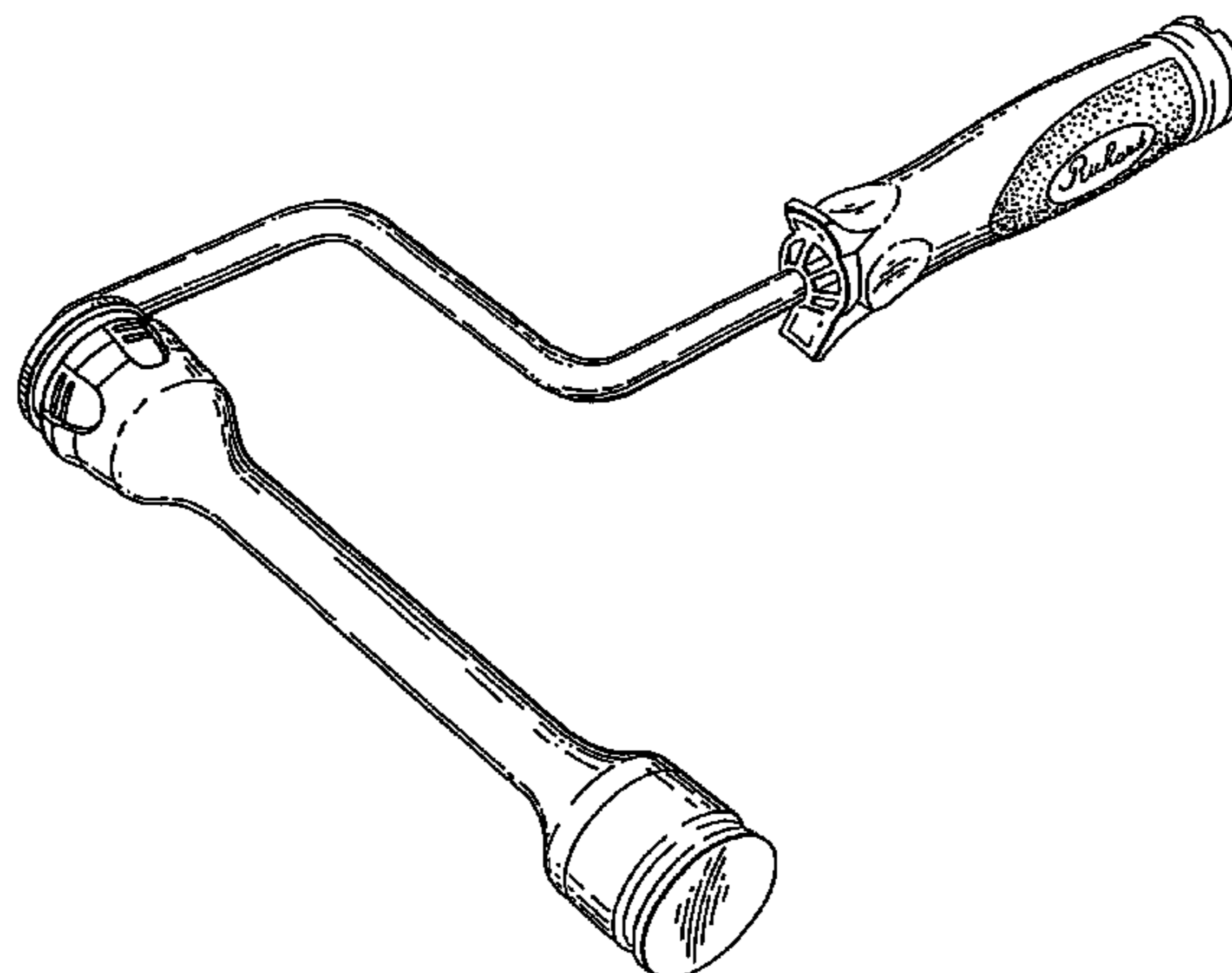
FIG. 13 is a left elevational side view thereof.

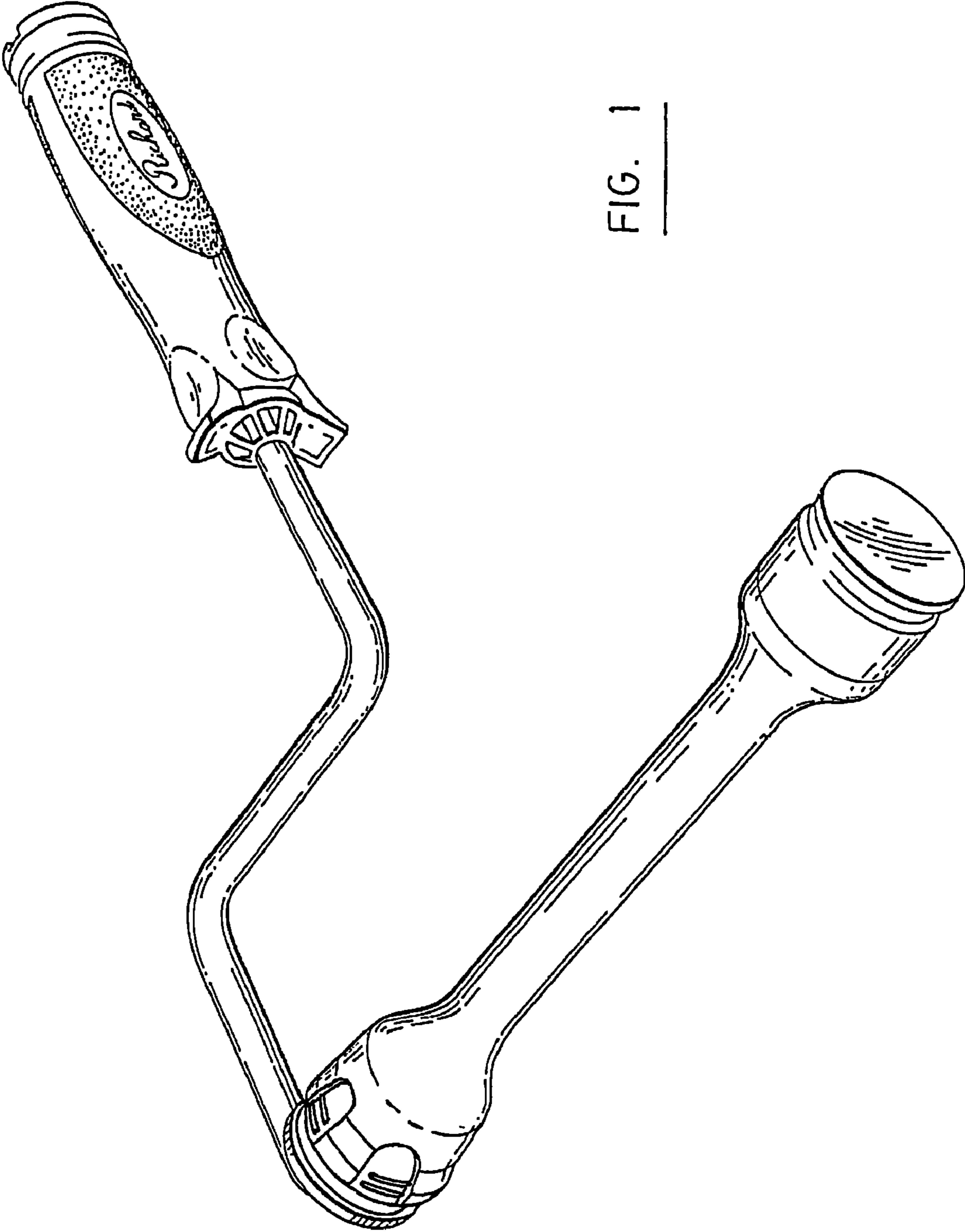

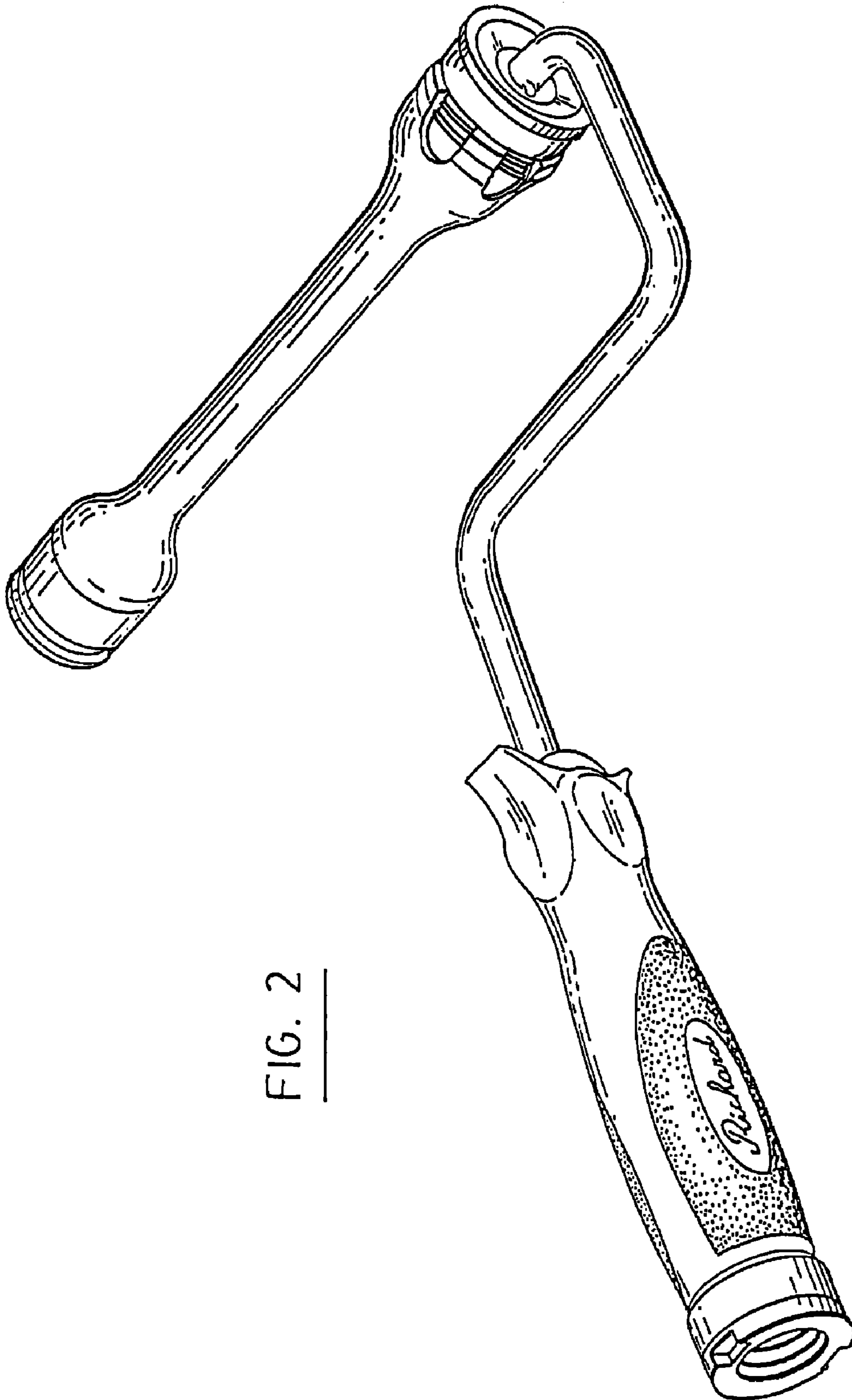

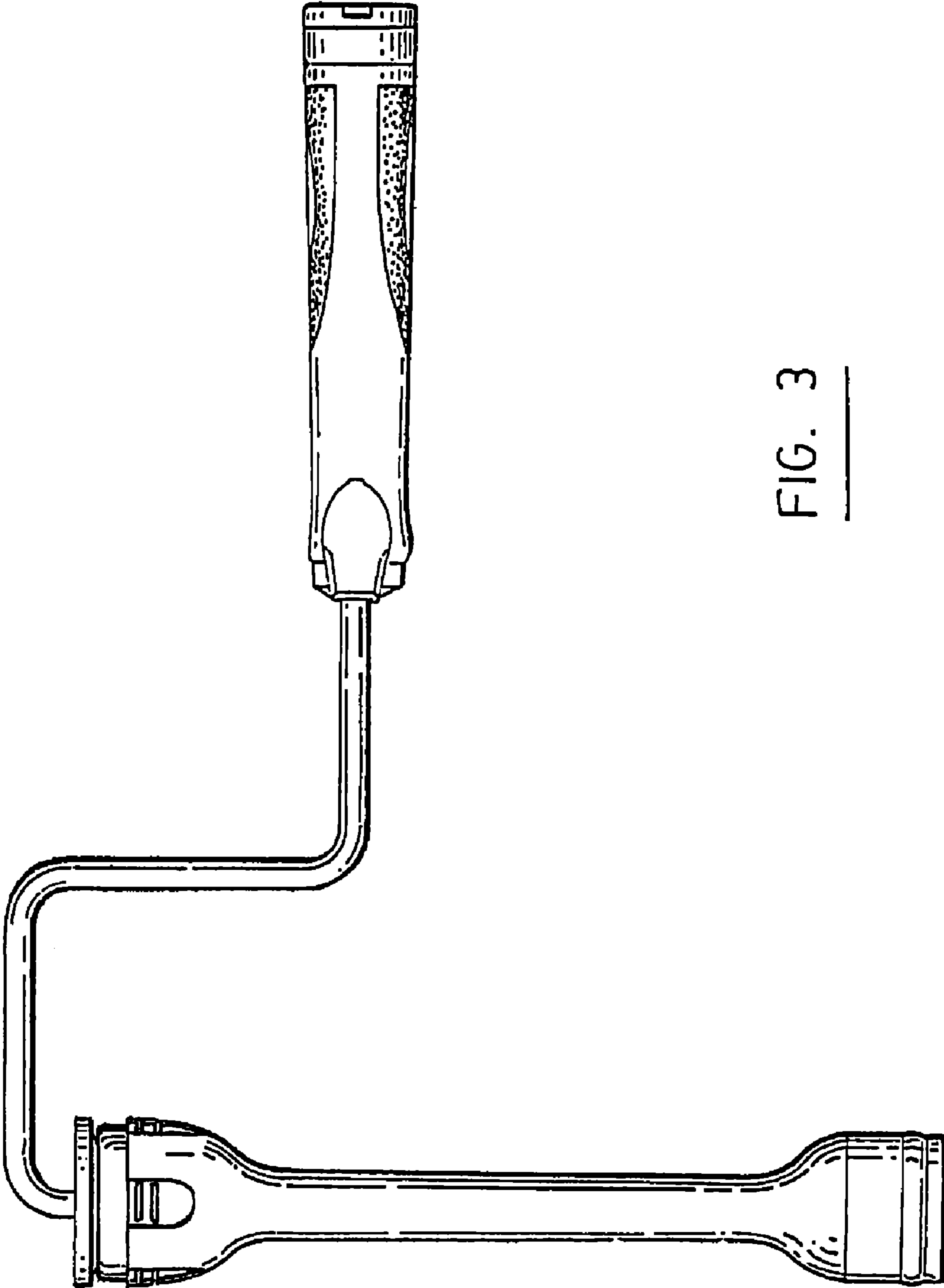

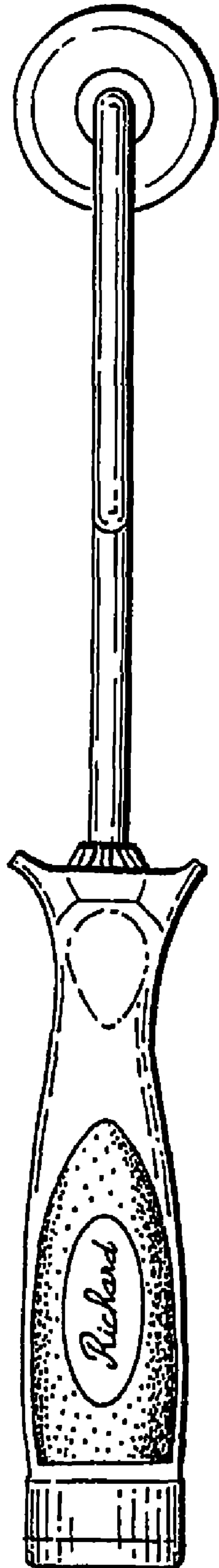

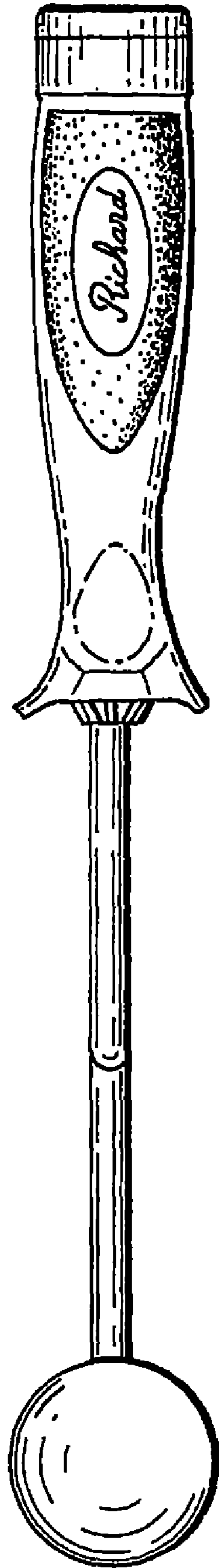

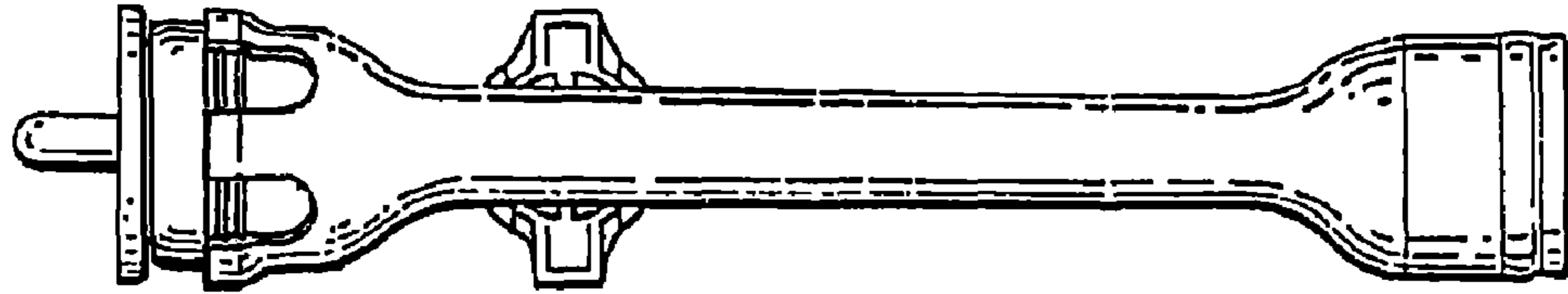

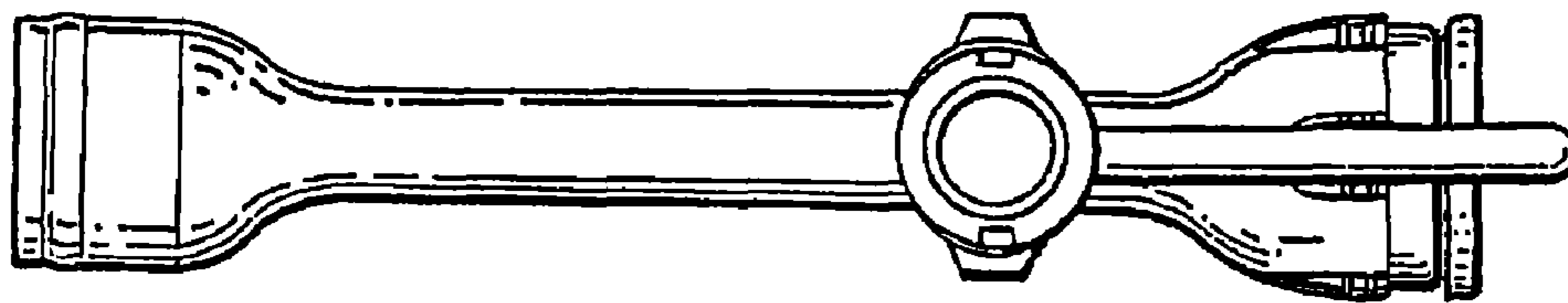

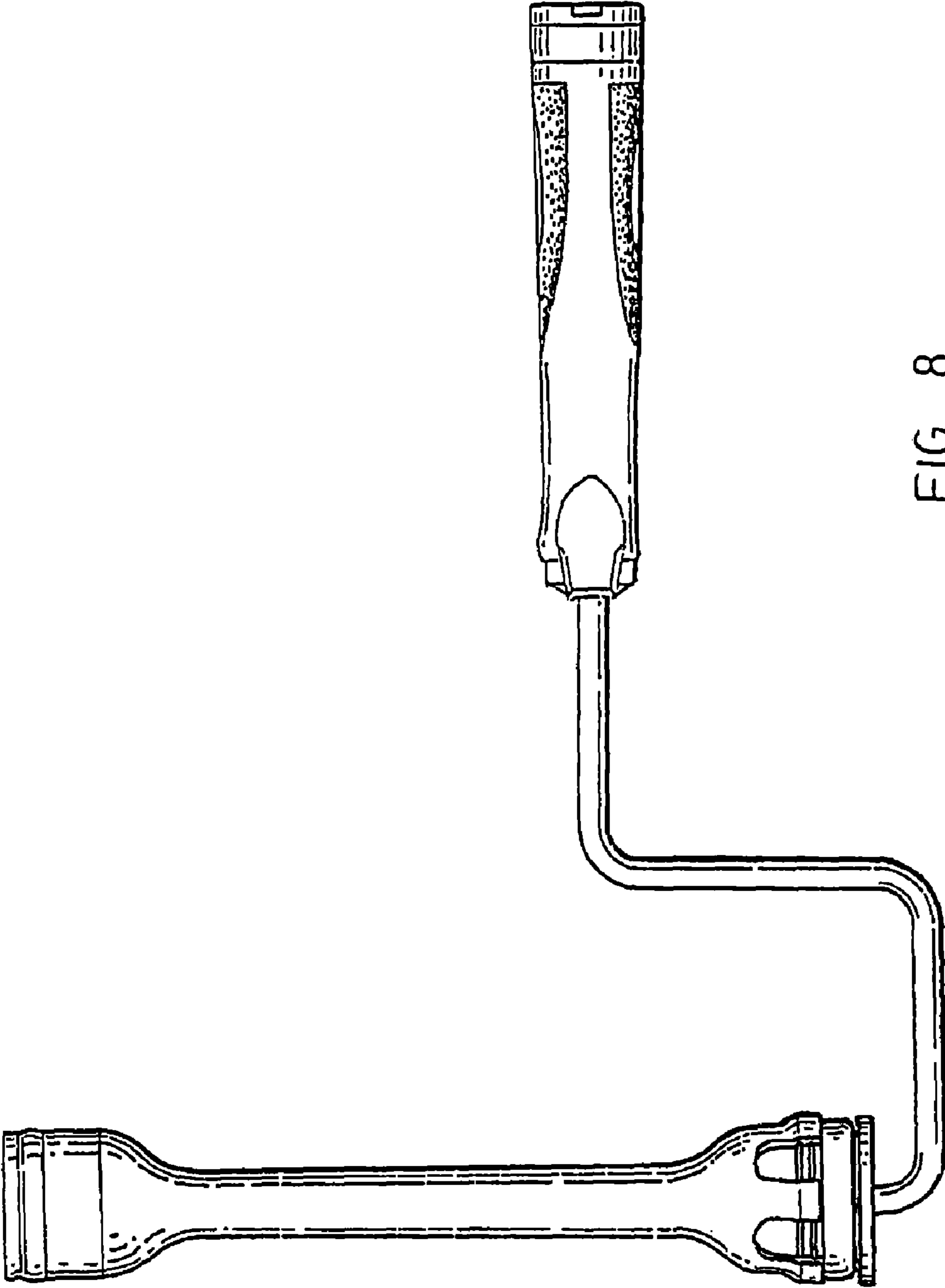

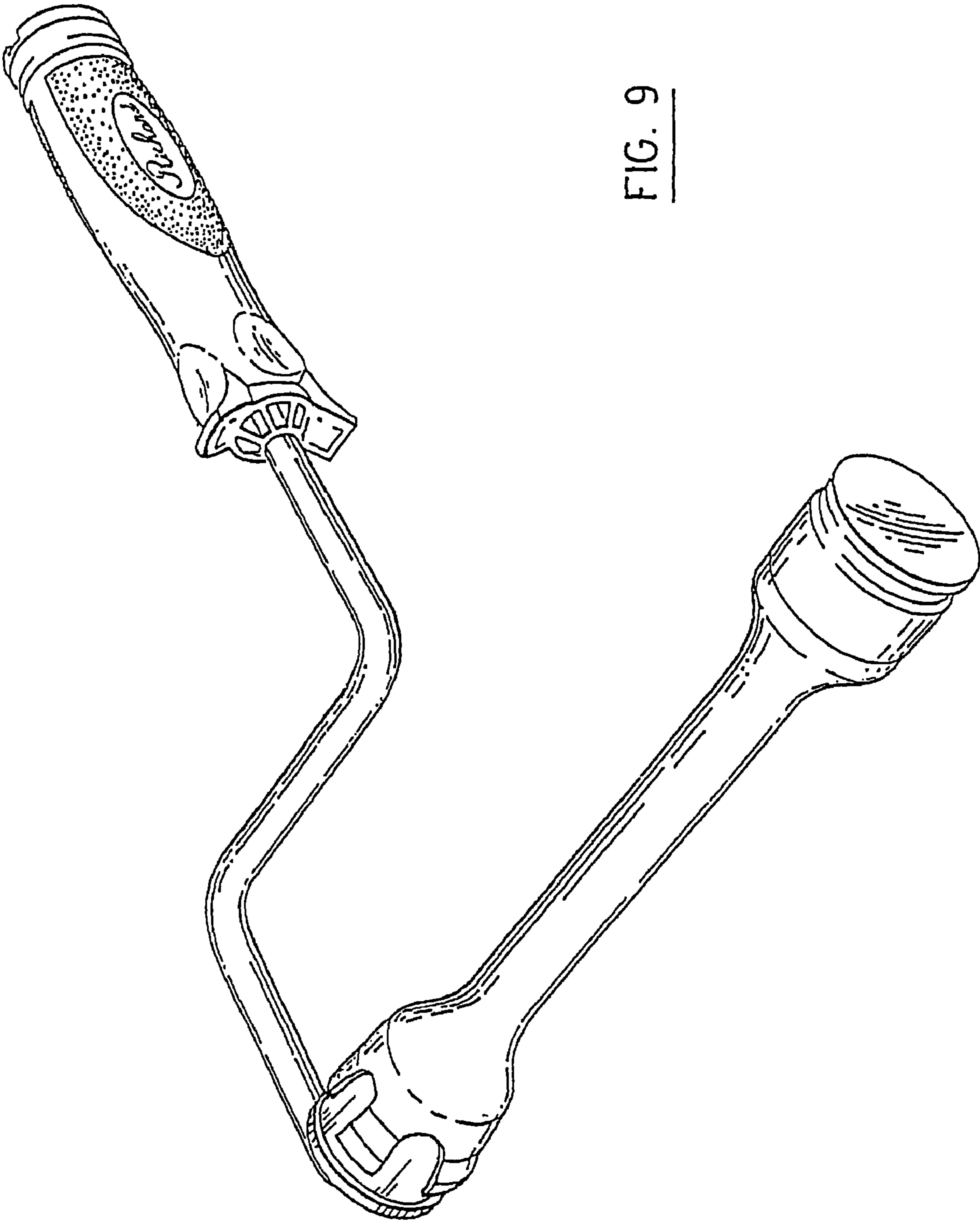

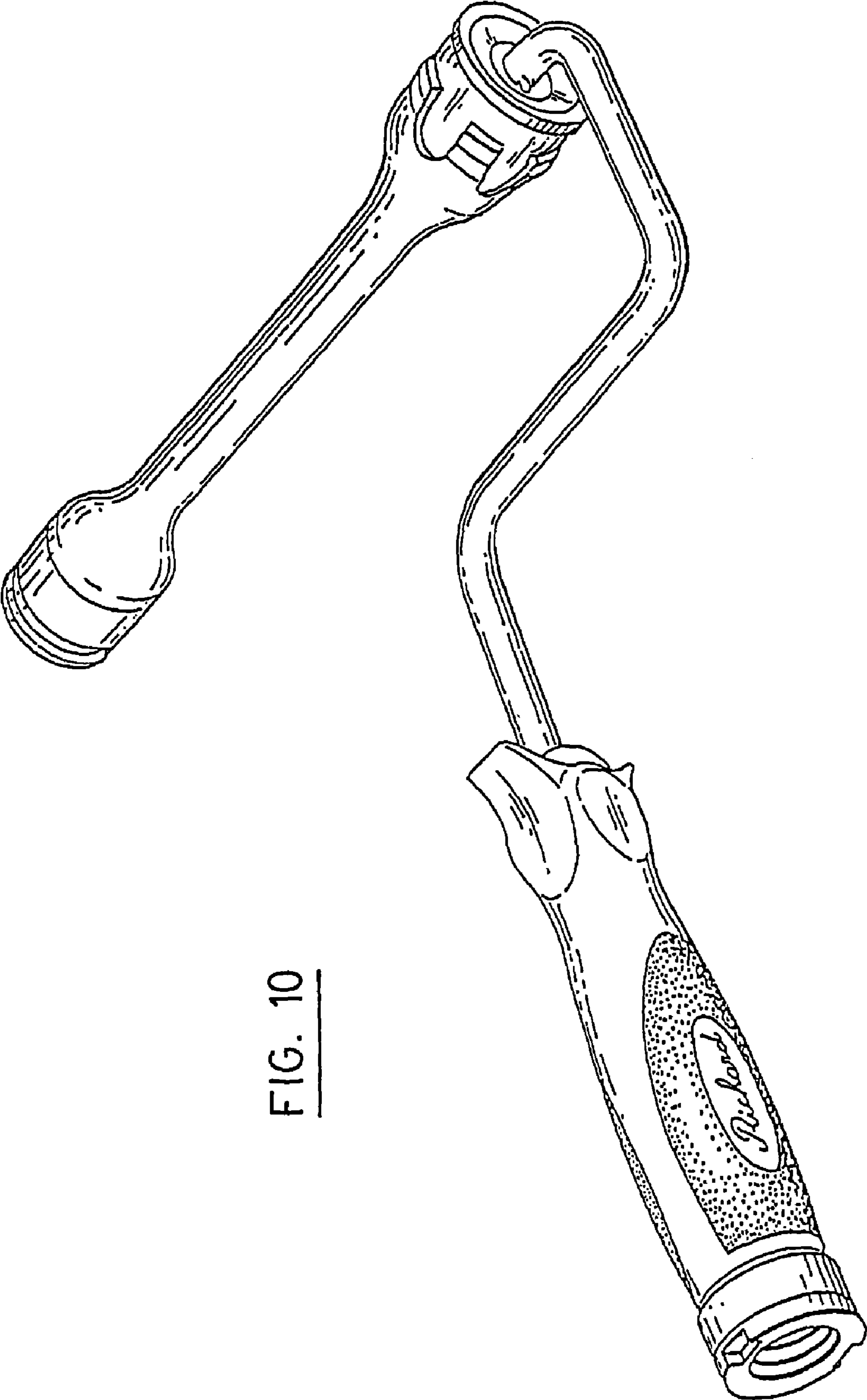

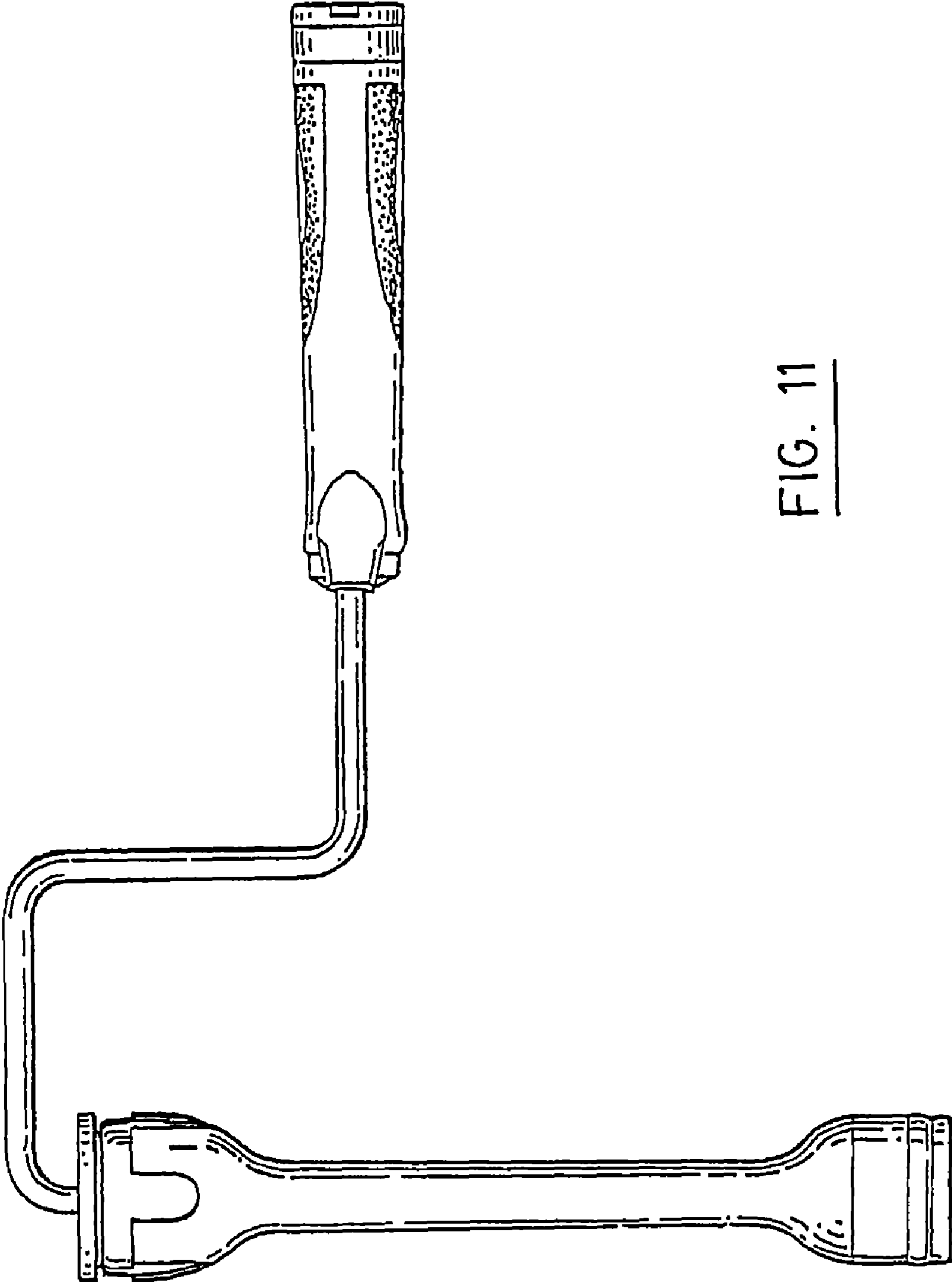

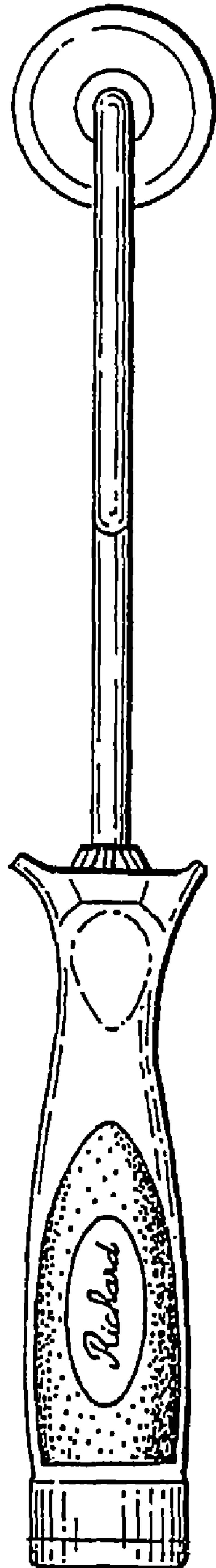

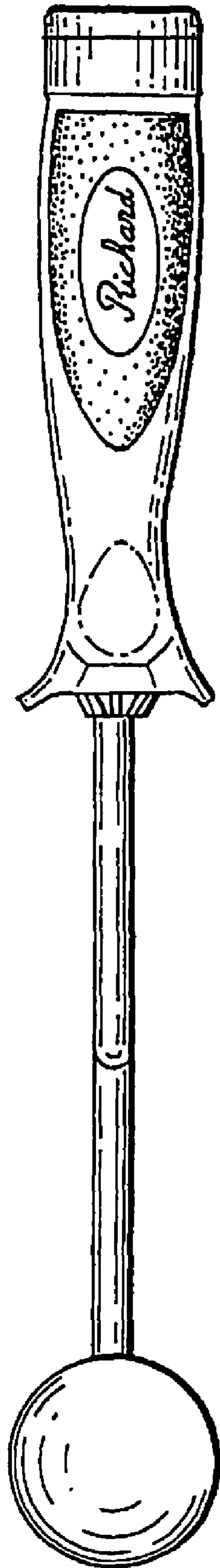

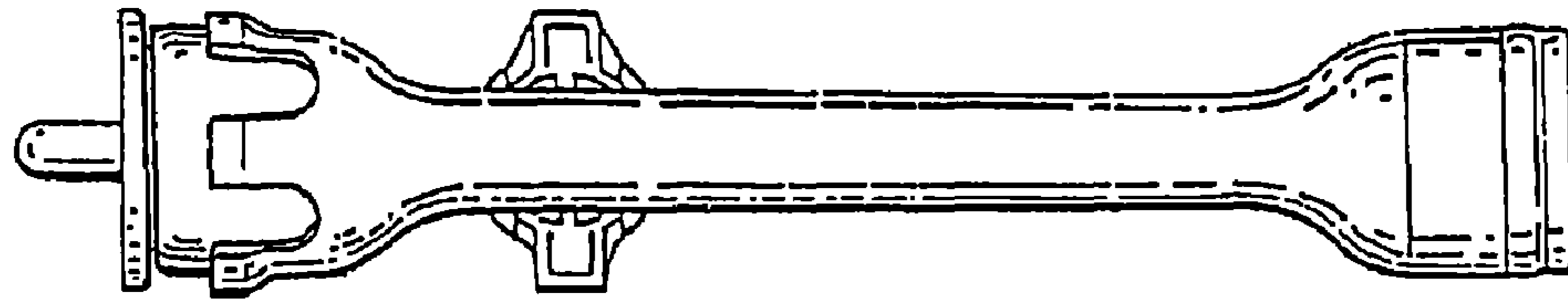

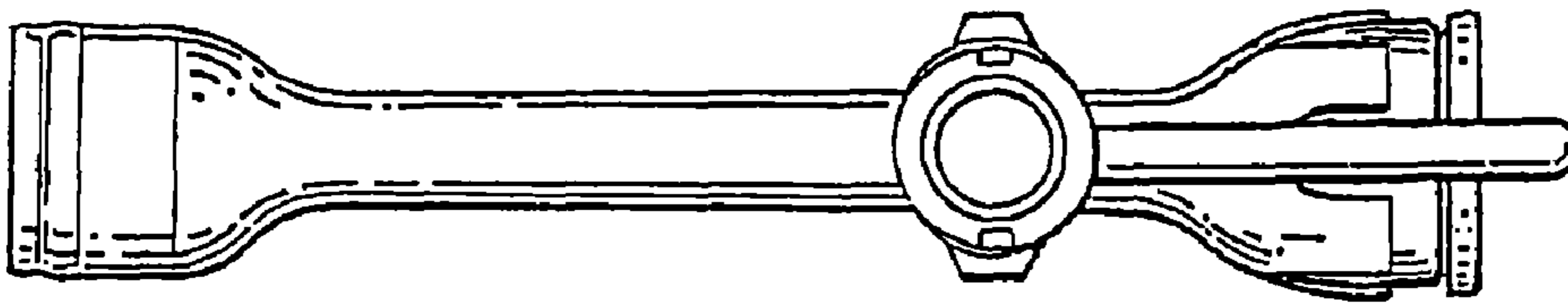

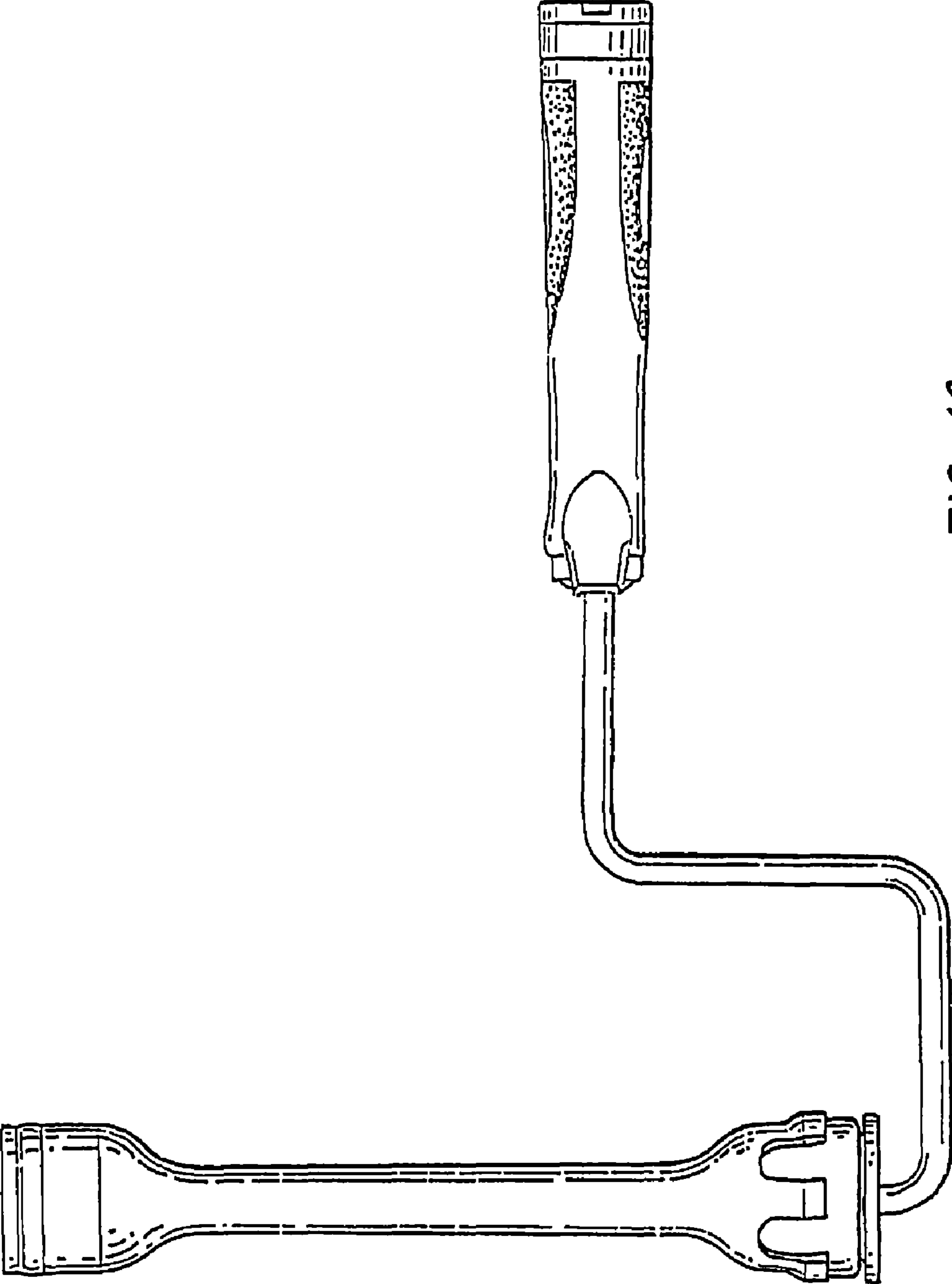
