FIG. 7 is a back side view of a cleansing cloth with pattern design as shown in FIG. 1;

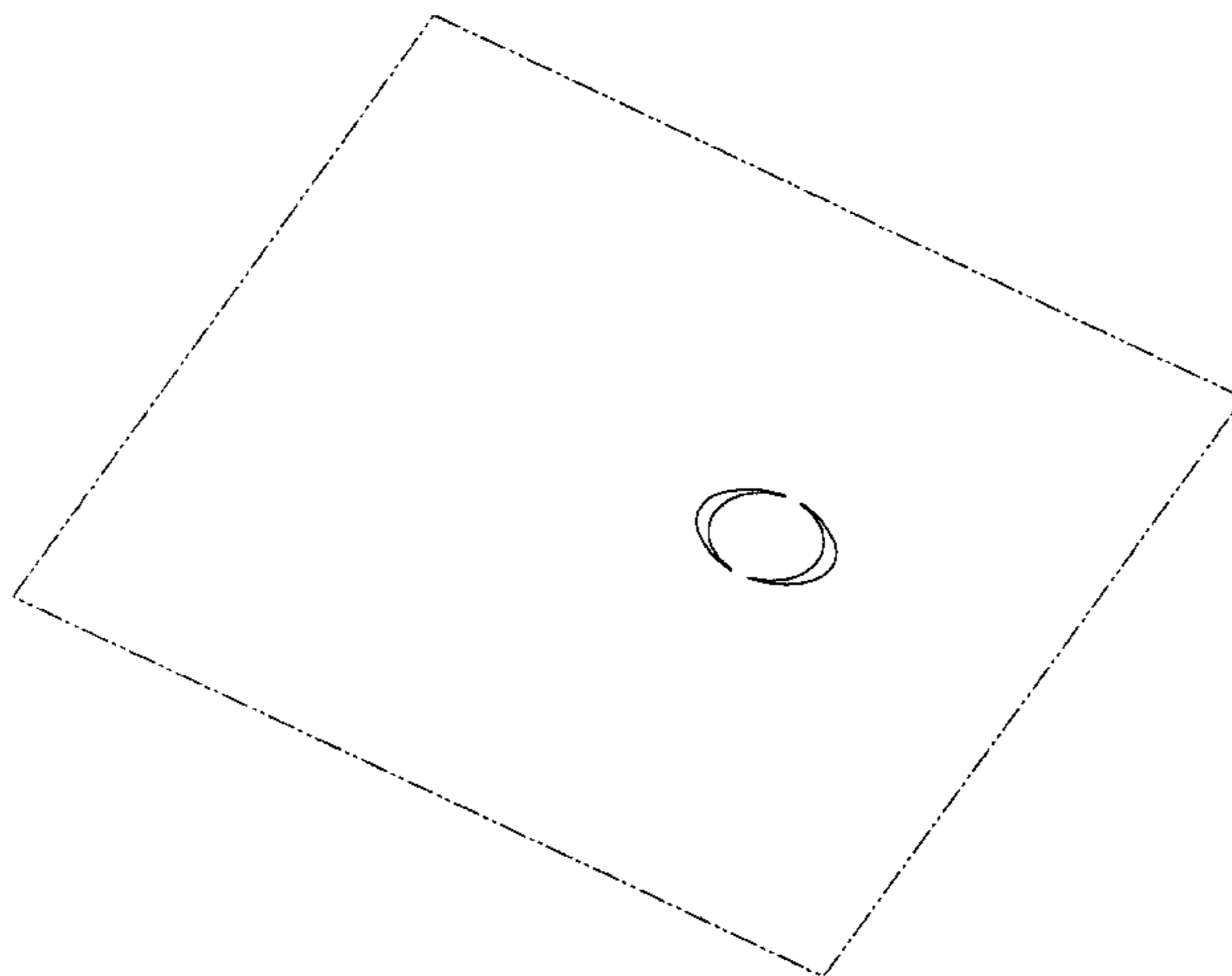

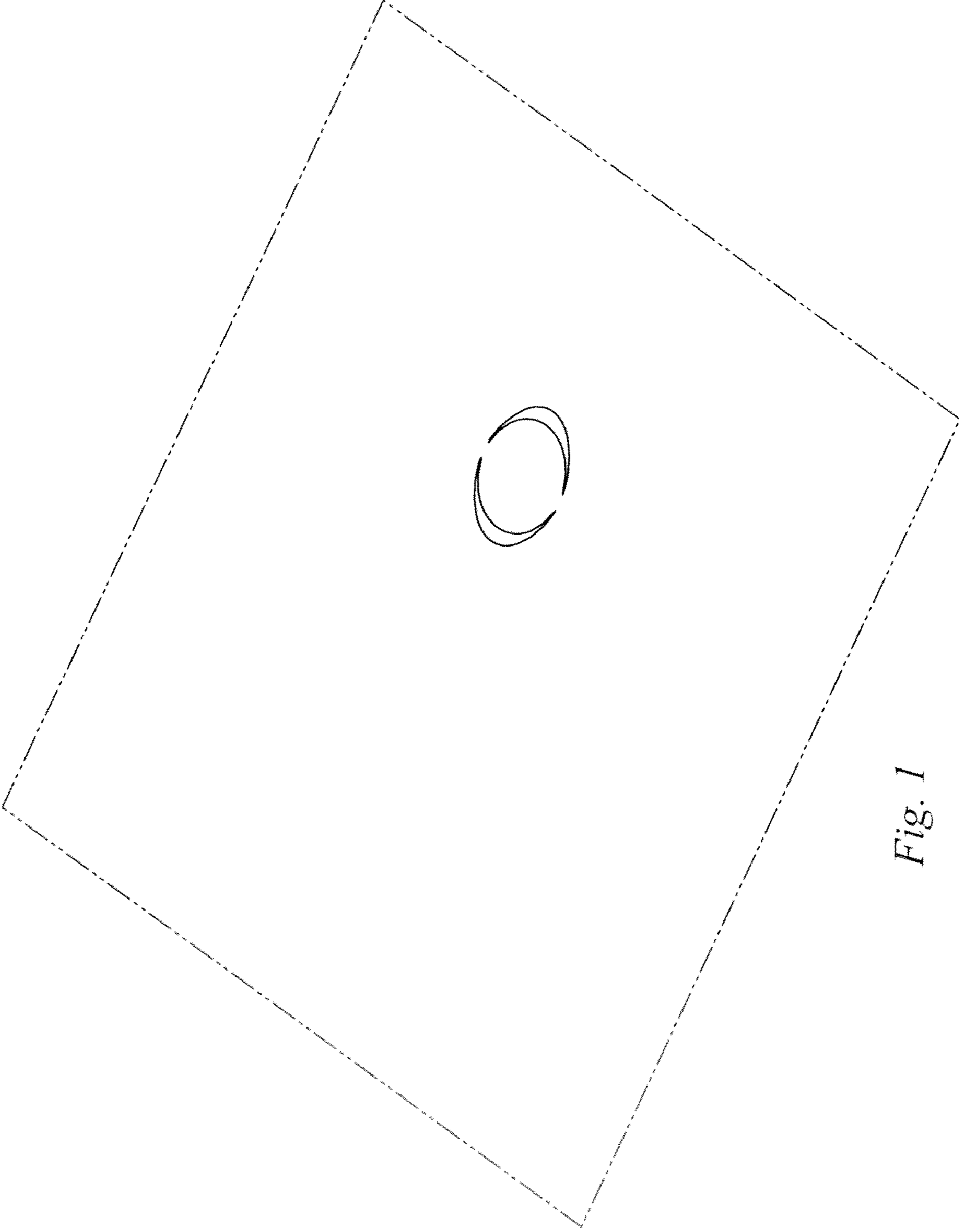

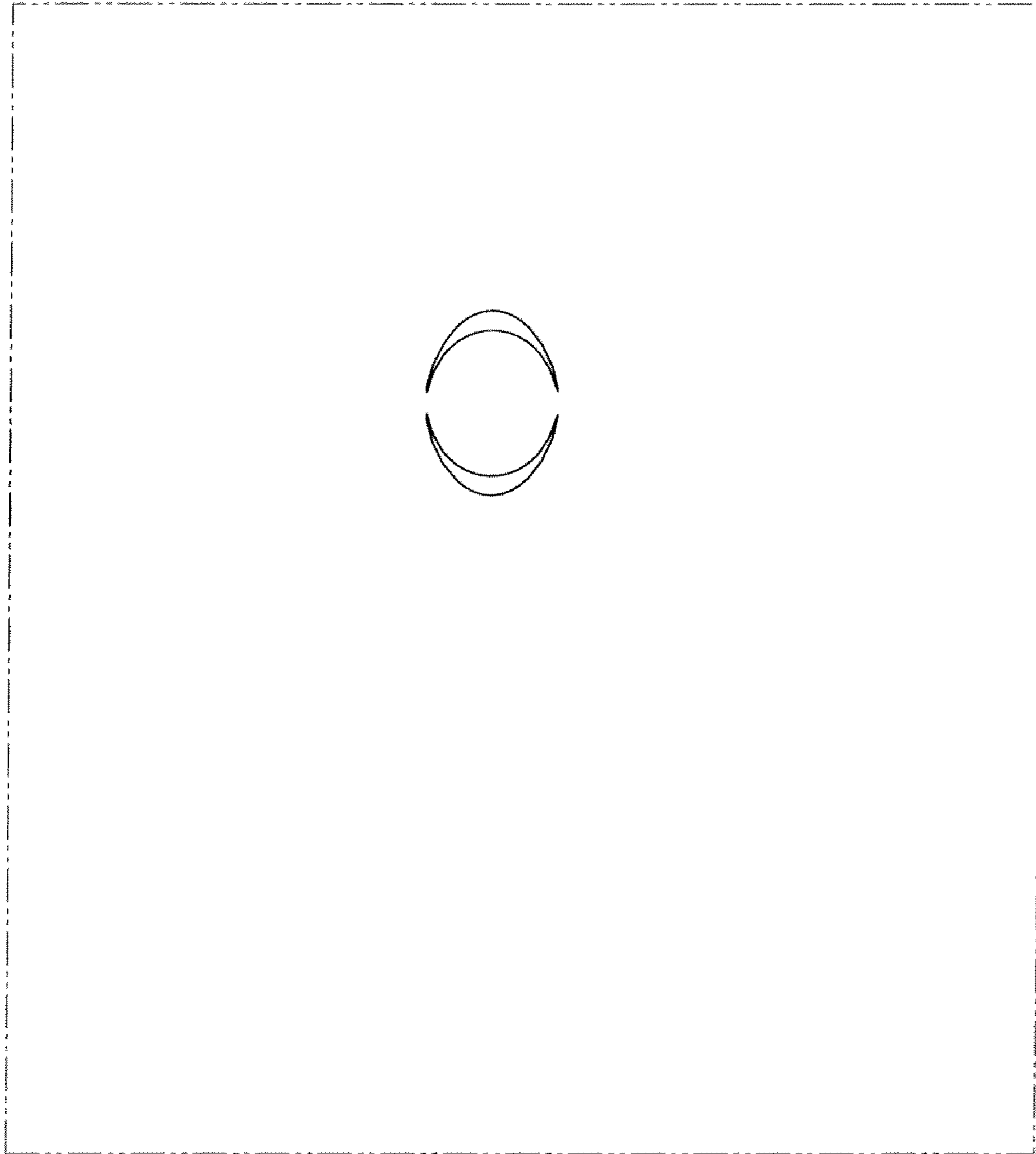

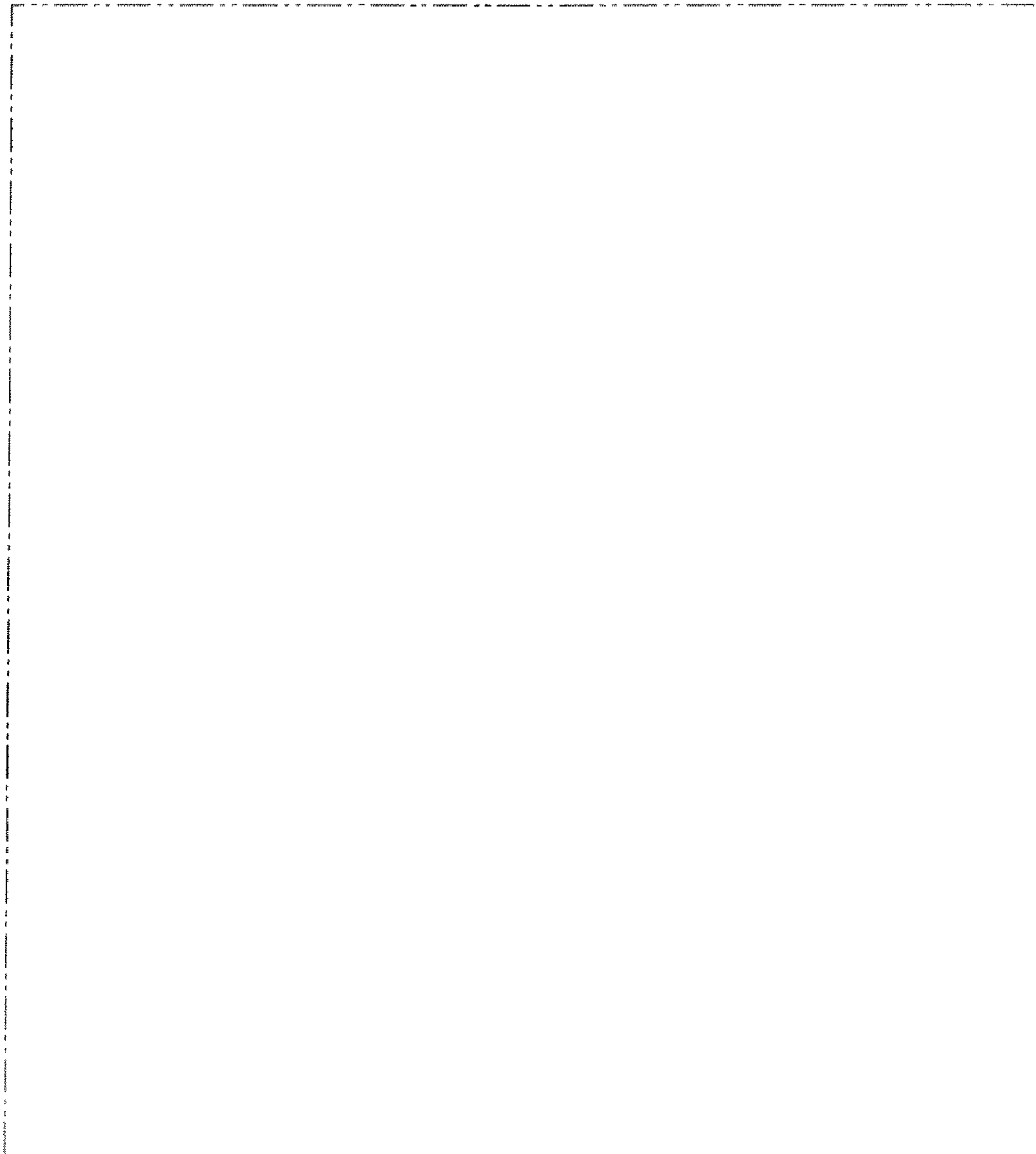
