We claim, the ornamental design for a paper product dispenser, as shown and described:

DESCRIPTION

FIG. 1 is a front perspective view of a paper product dispenser, showing our new design;

FIG. 17 is a side elevation view thereof taken from the right of FIG. 16;

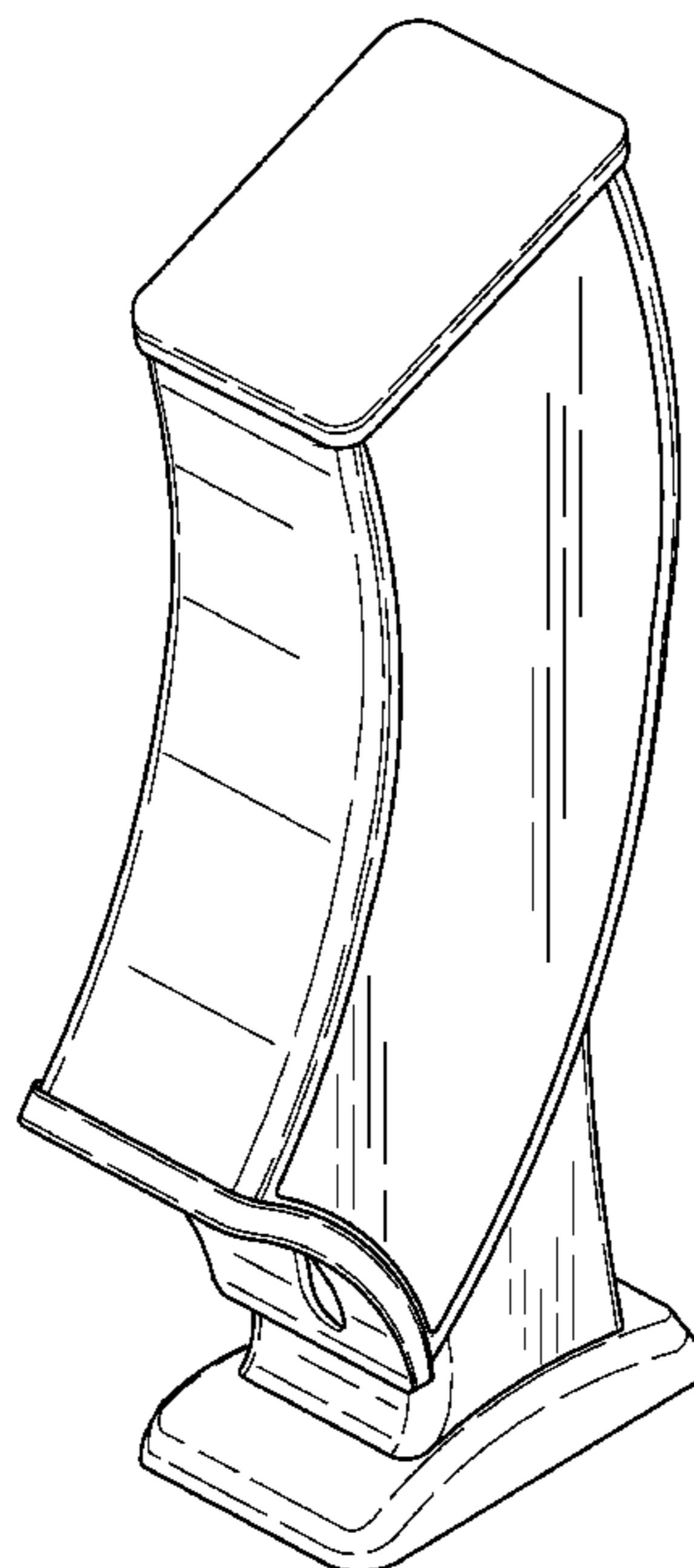
FIG. 18 is a top plan view thereof;

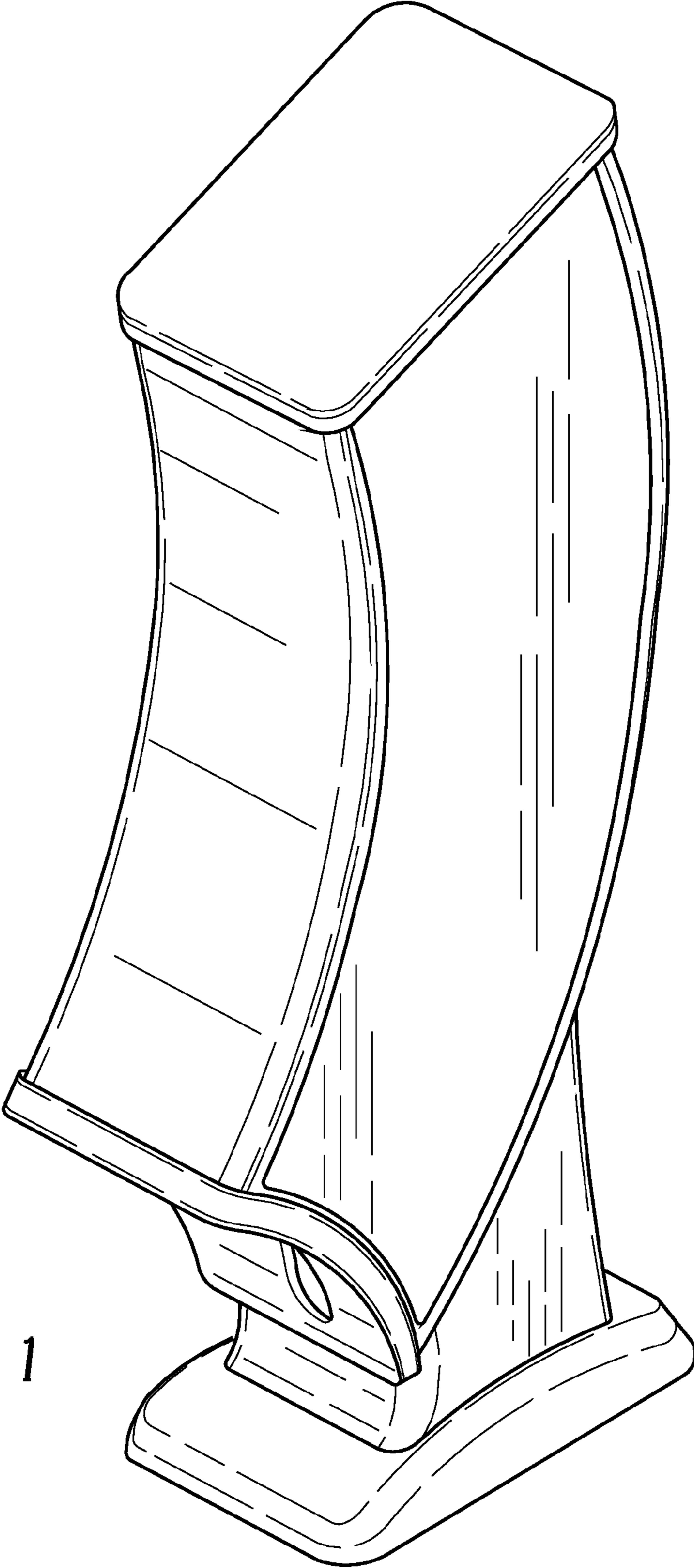

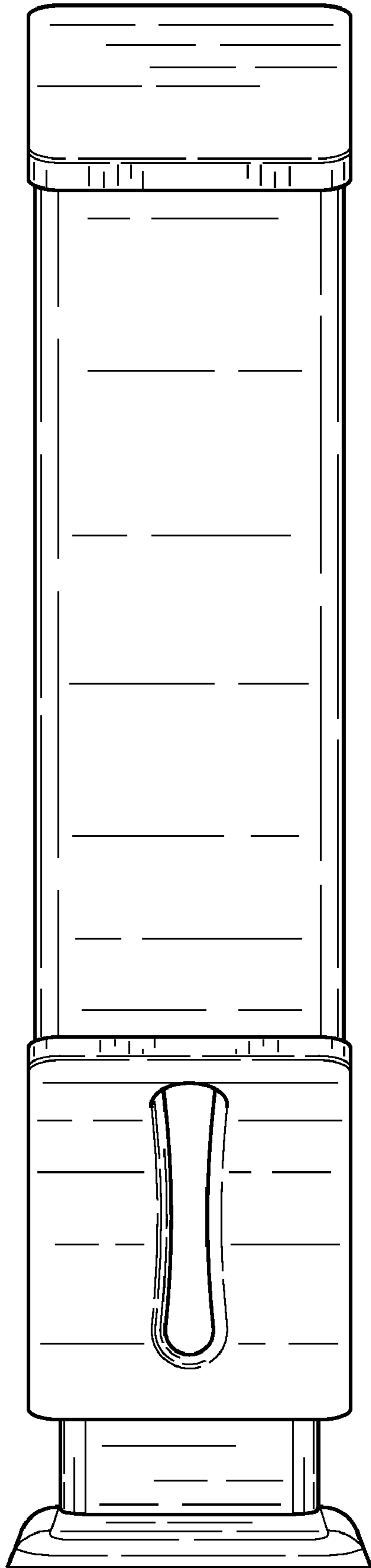

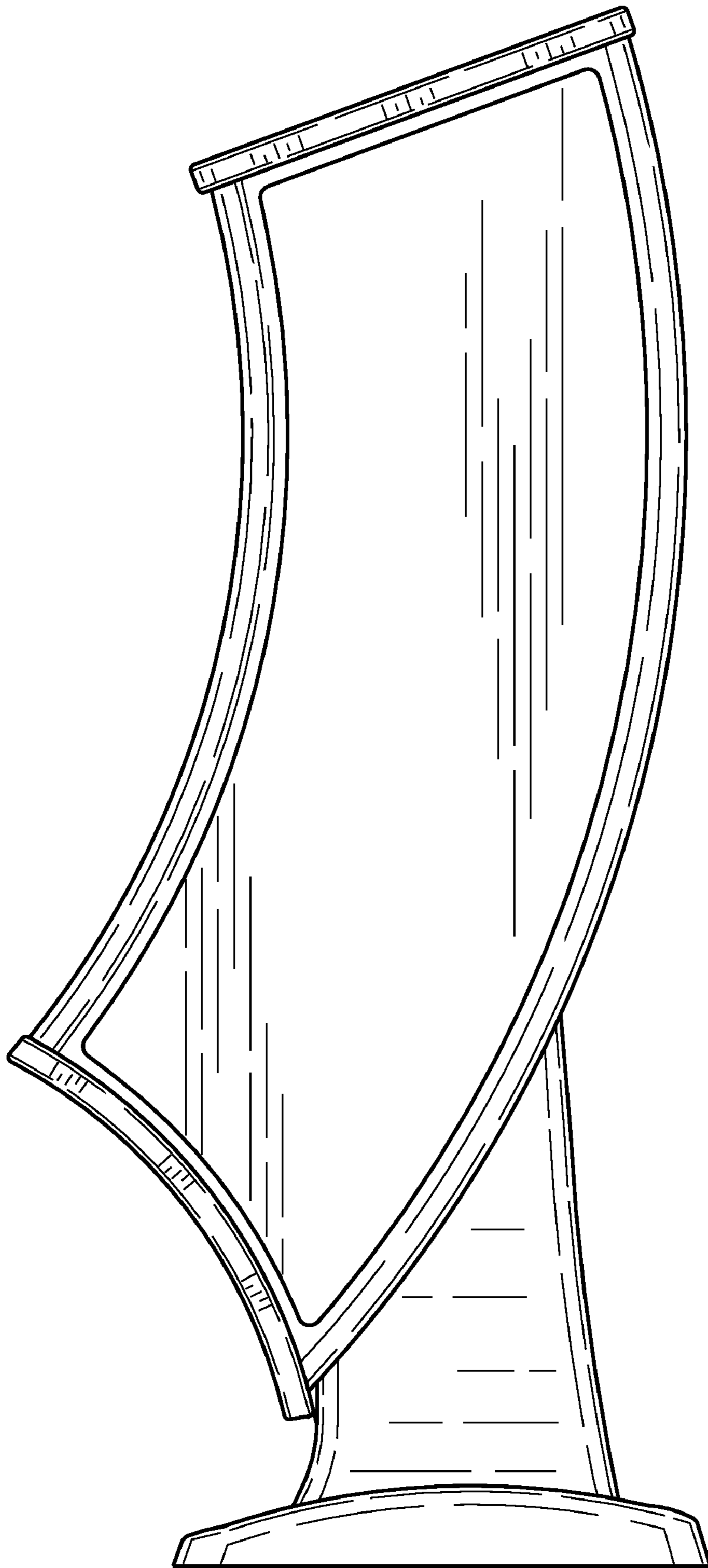

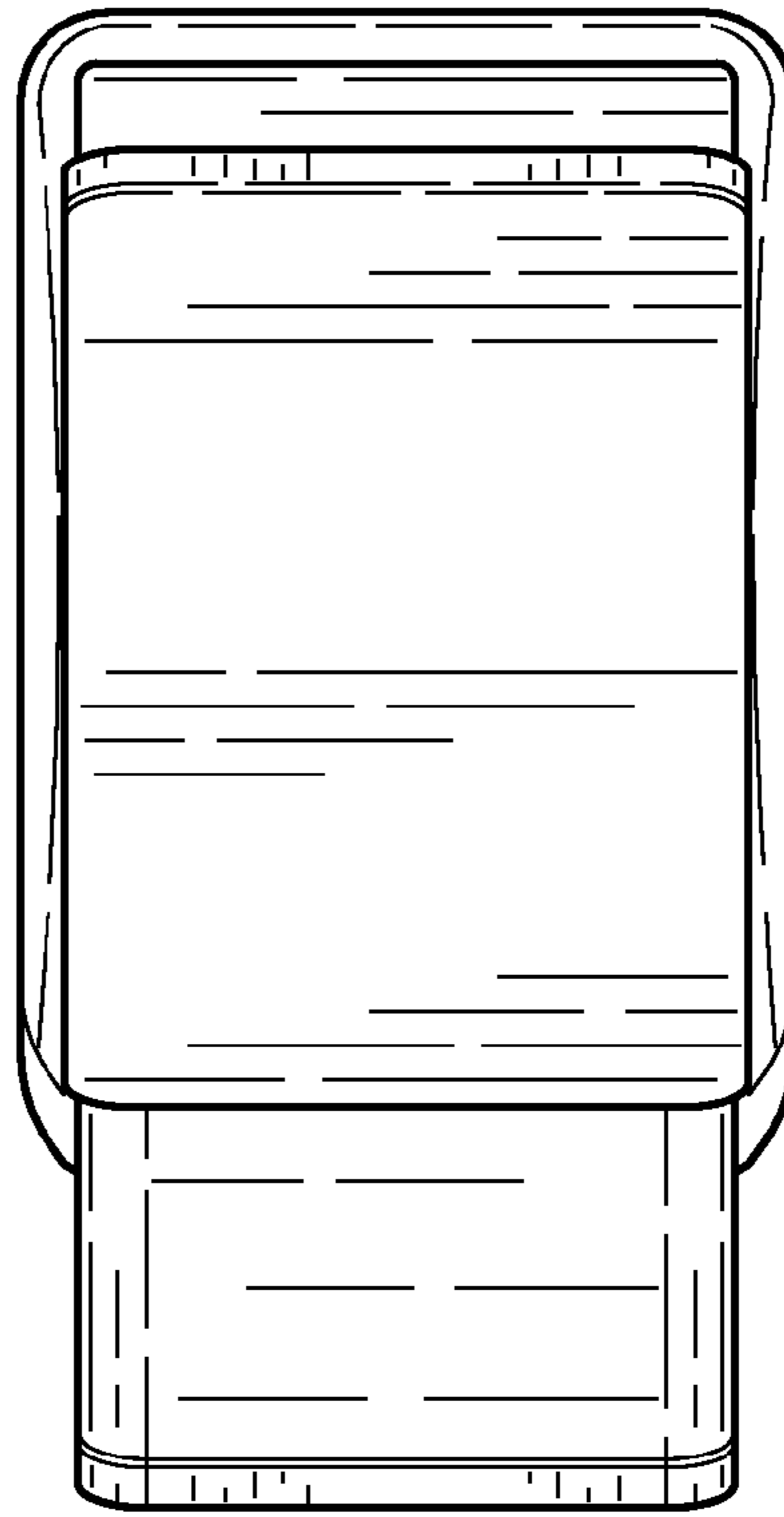

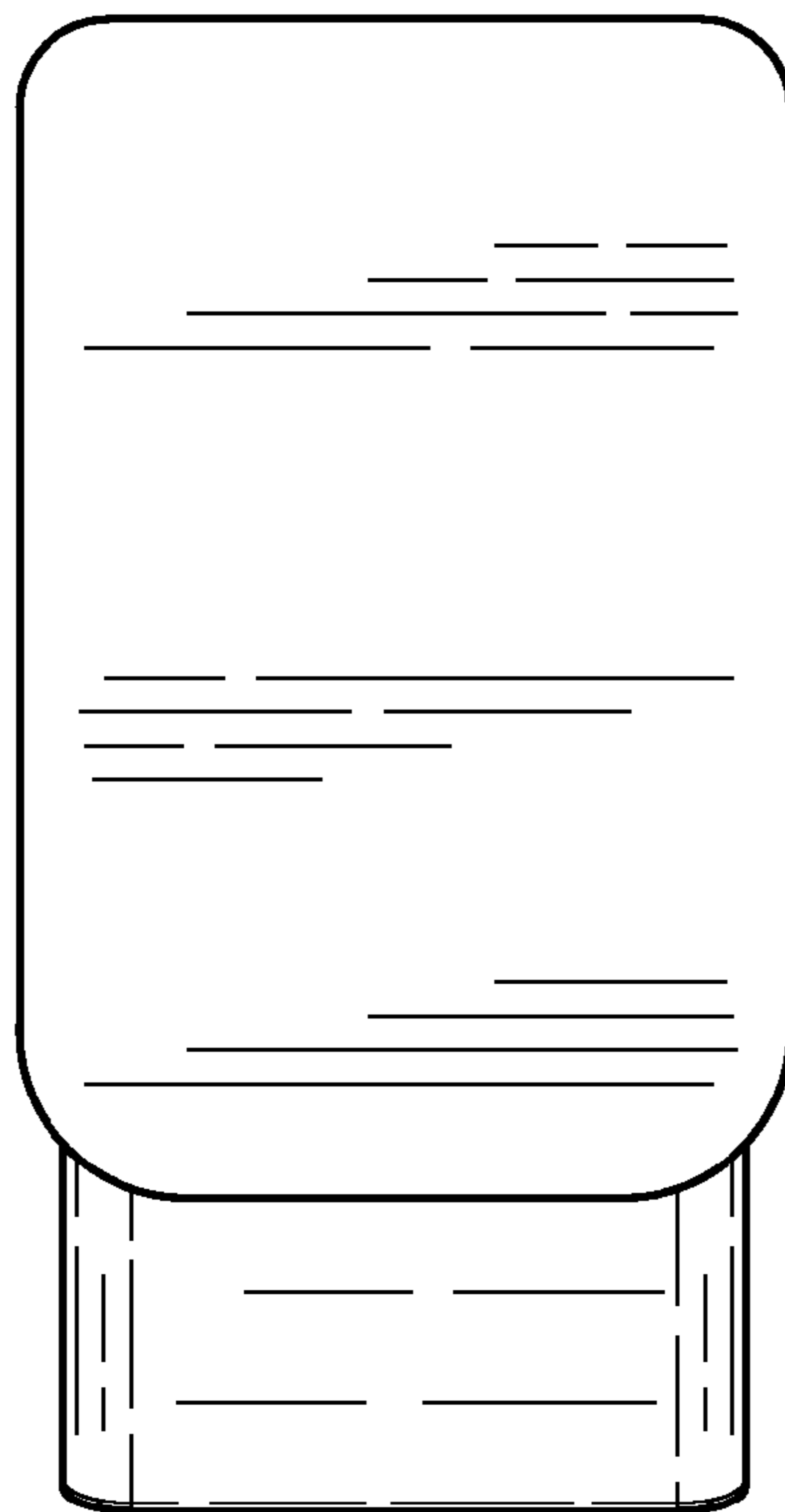

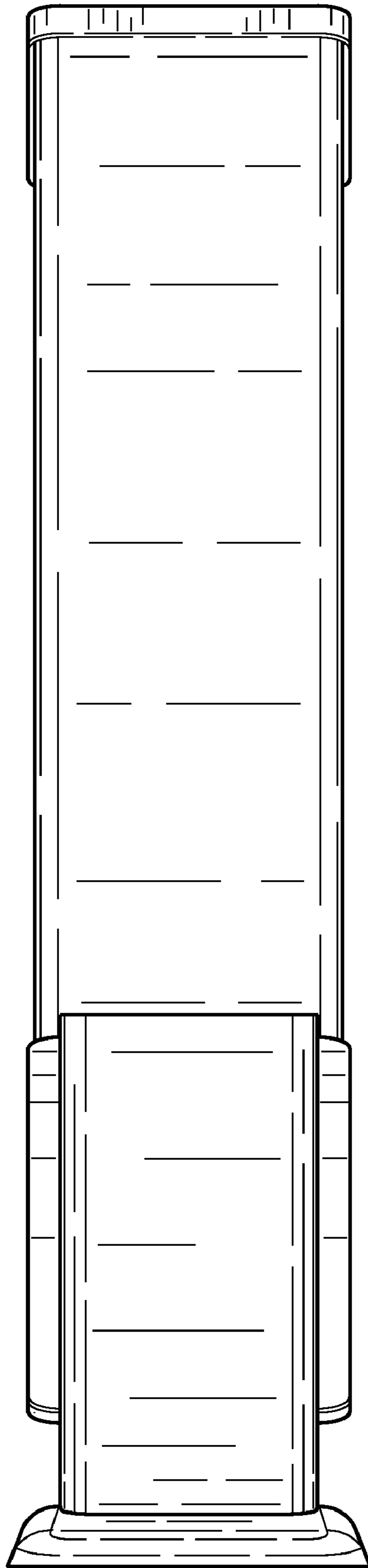

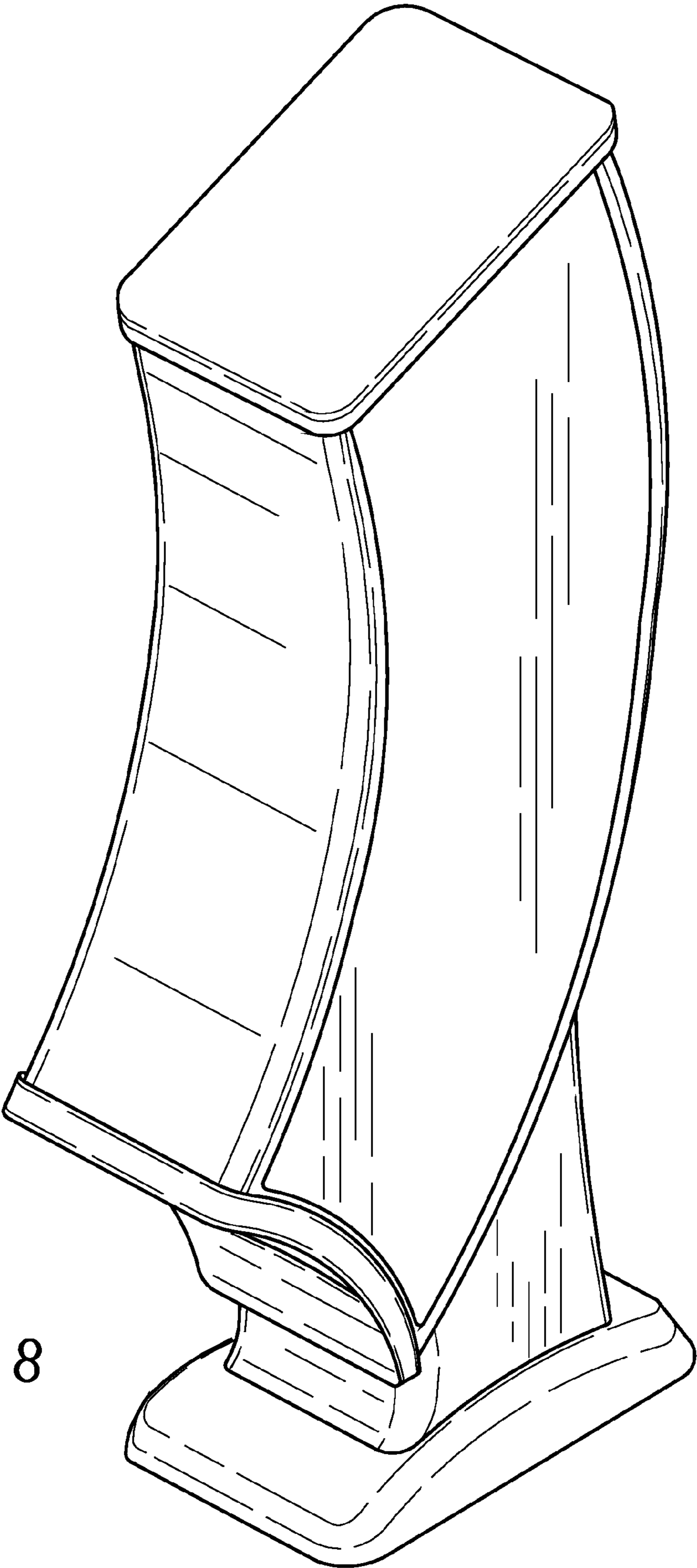

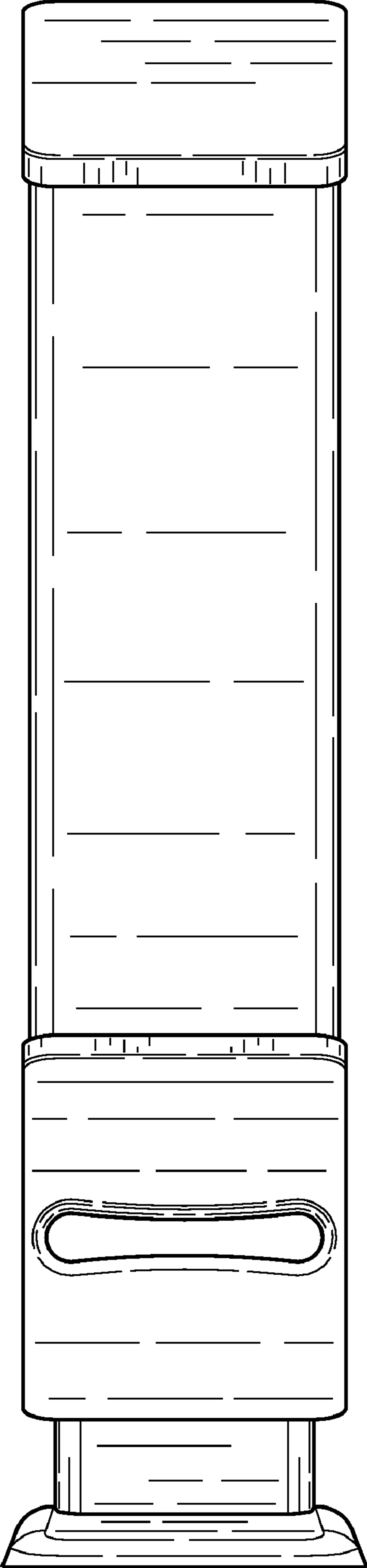

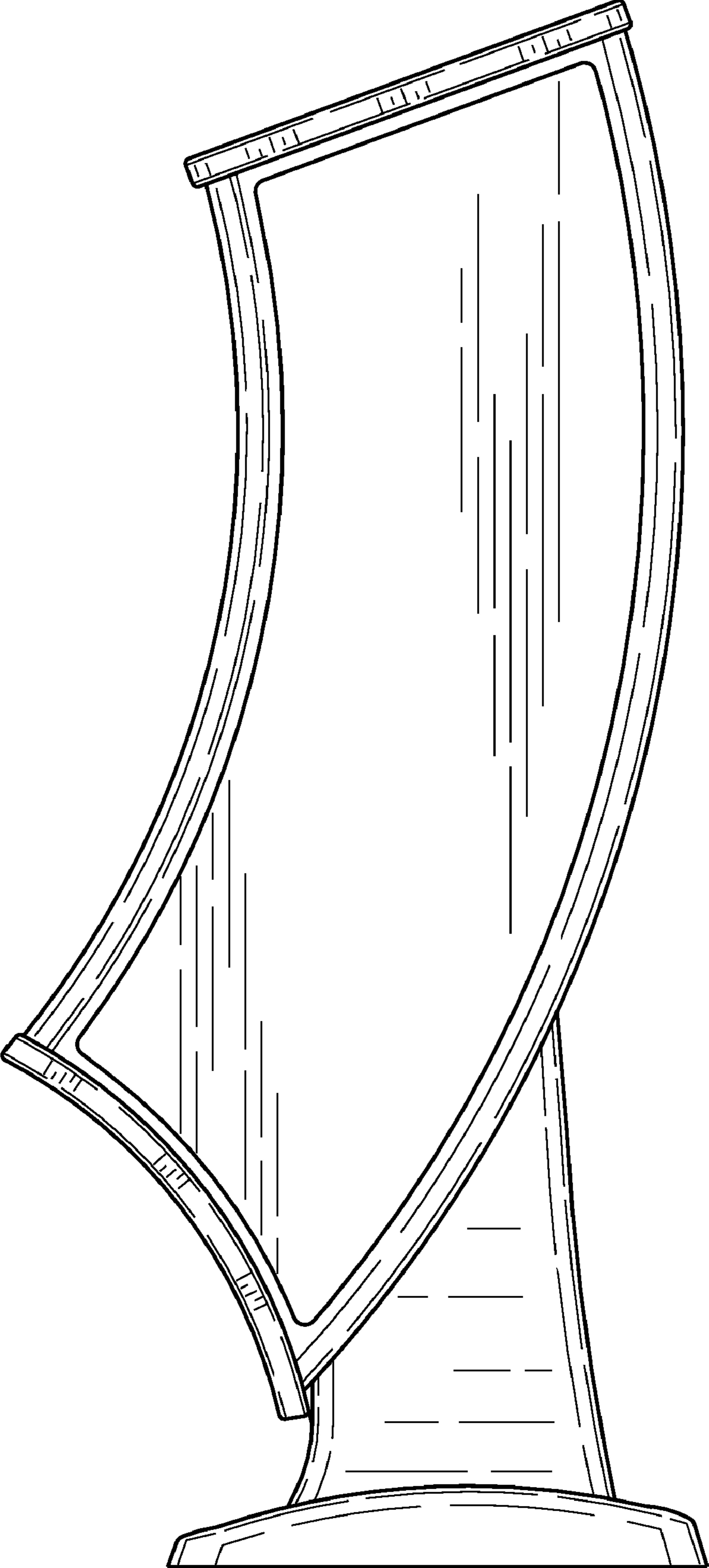

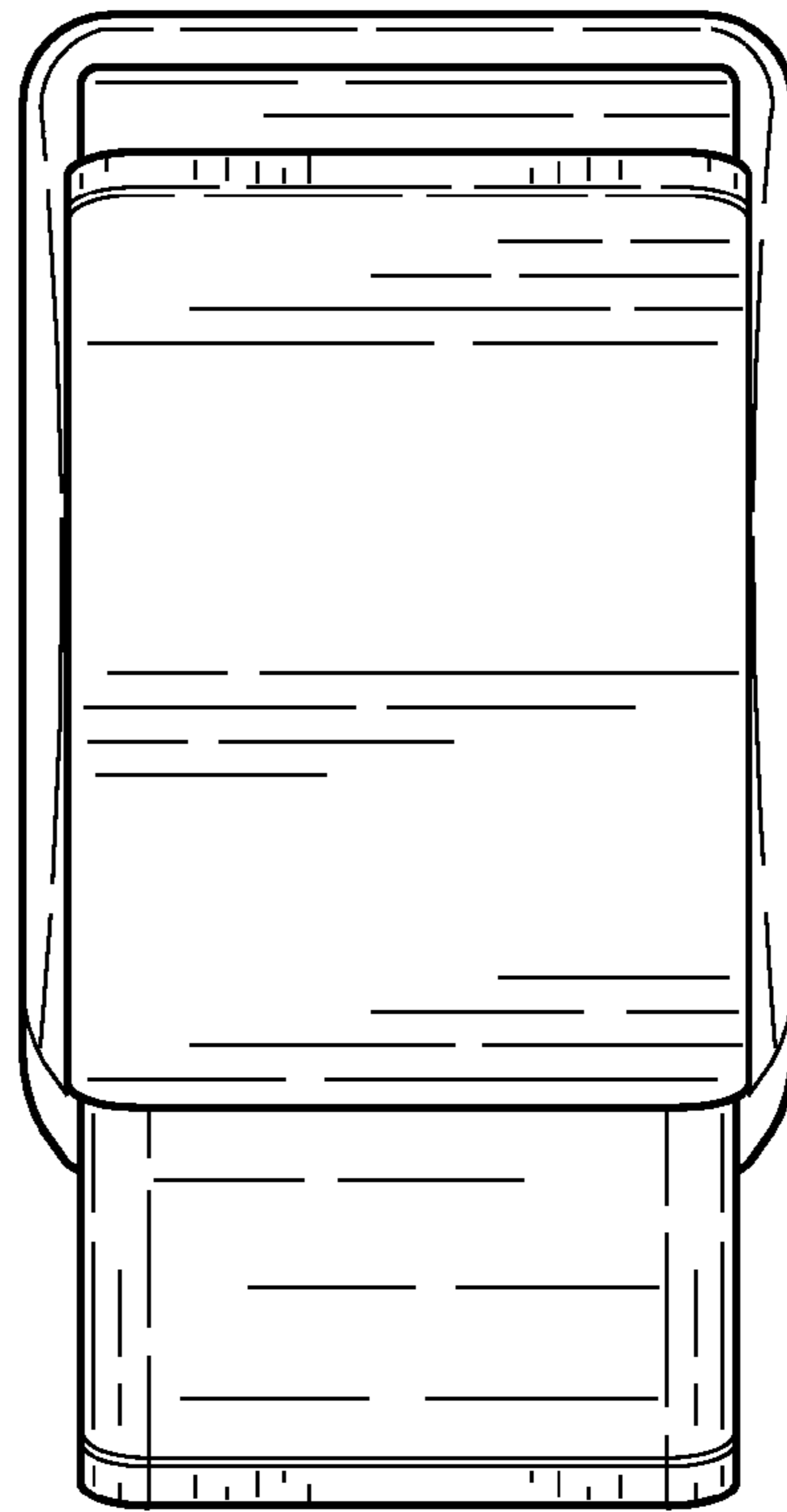

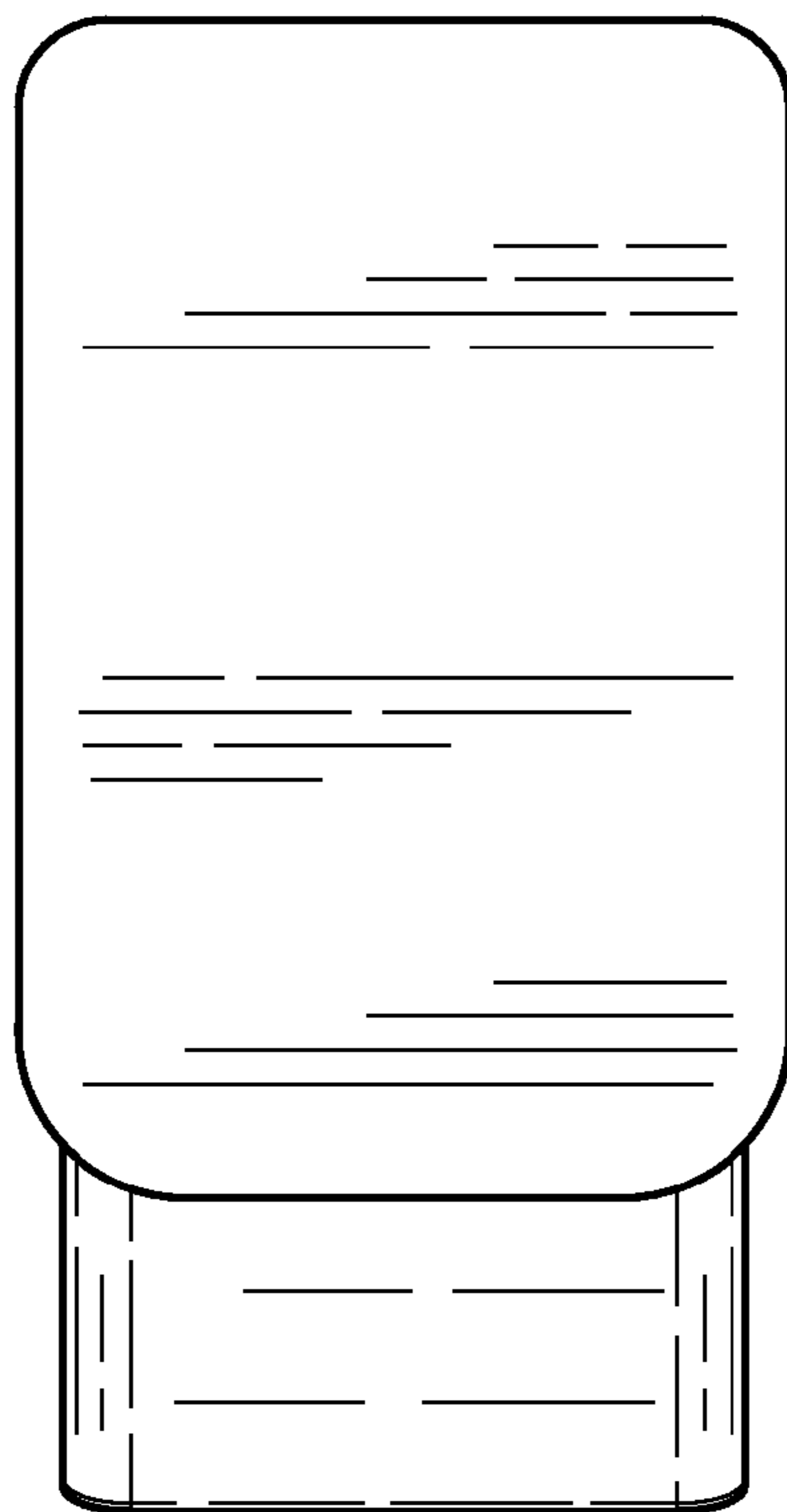

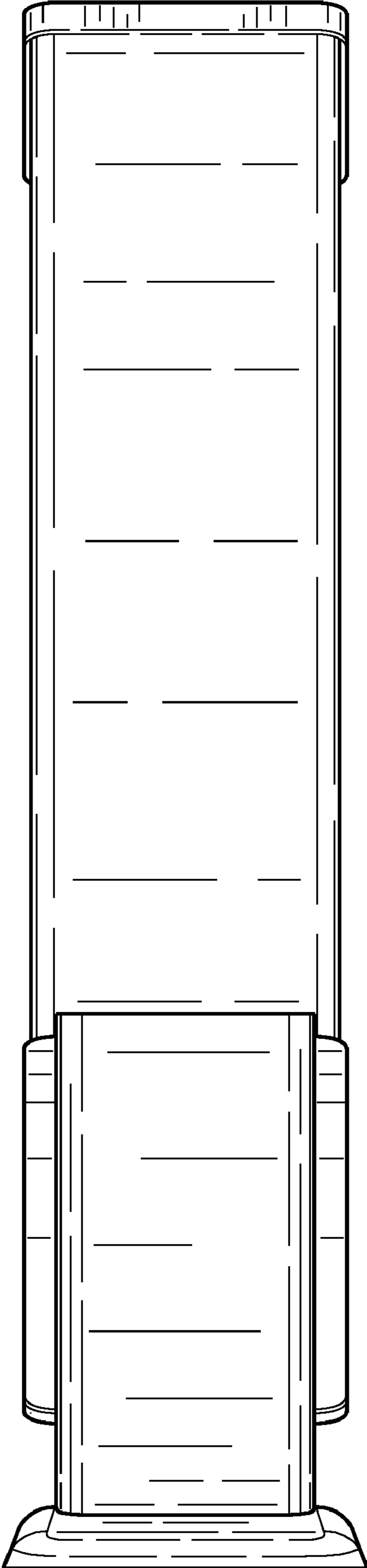

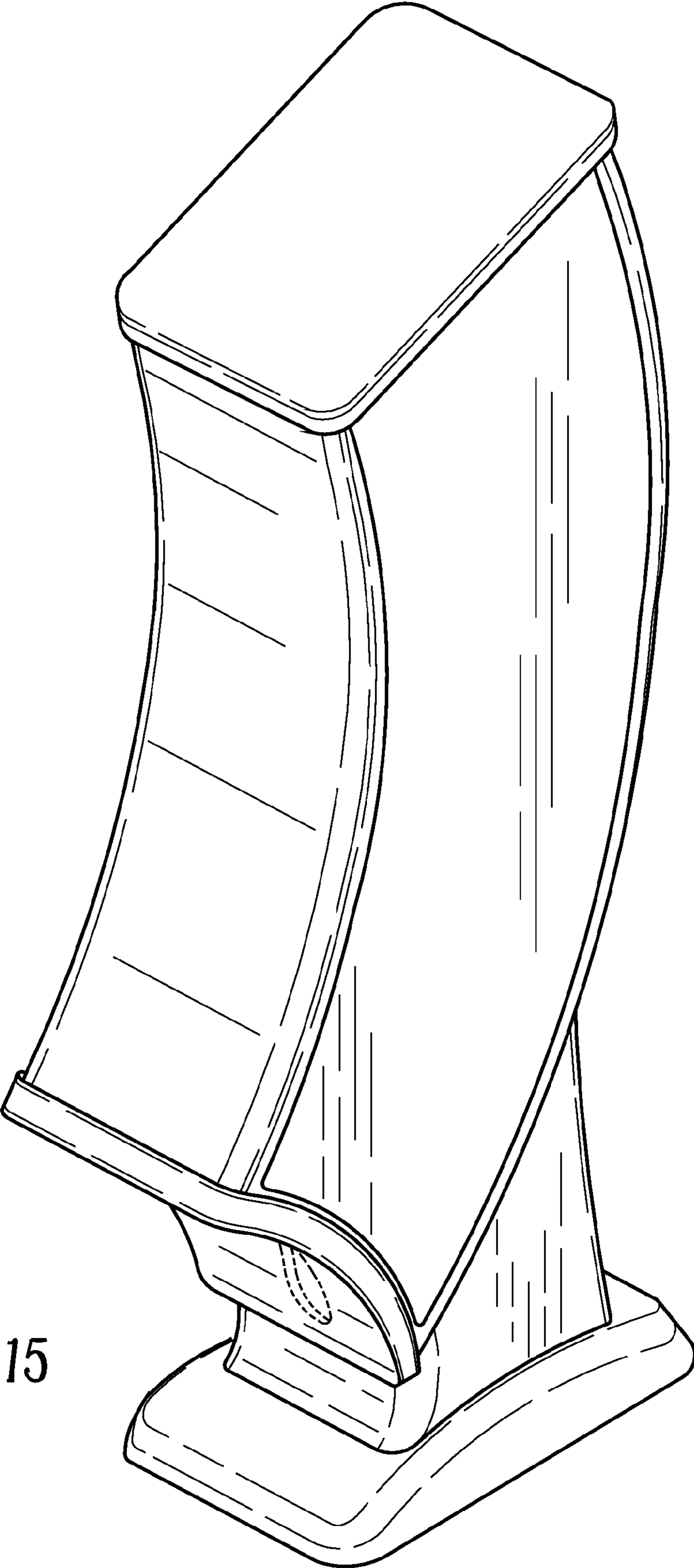

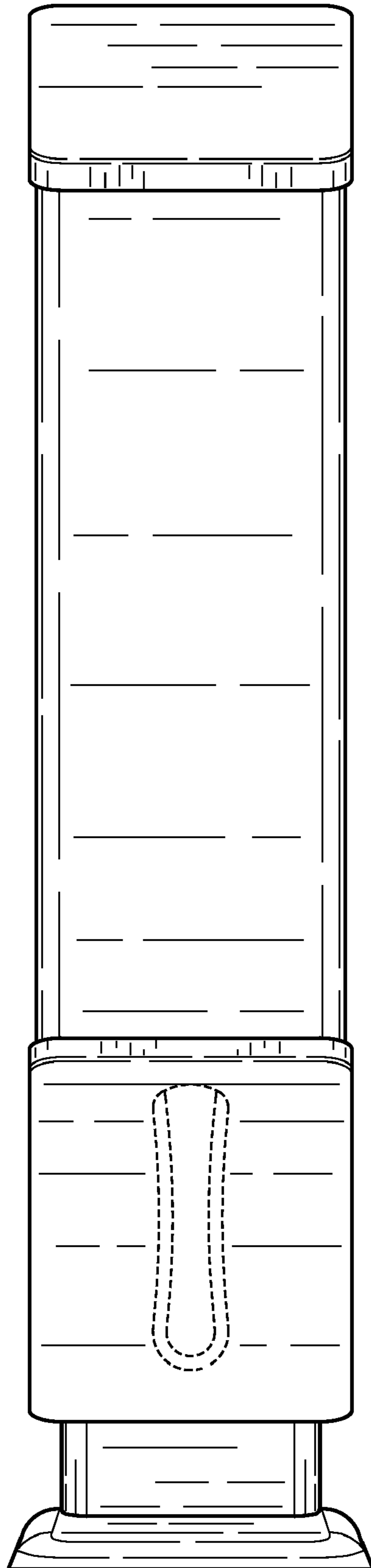

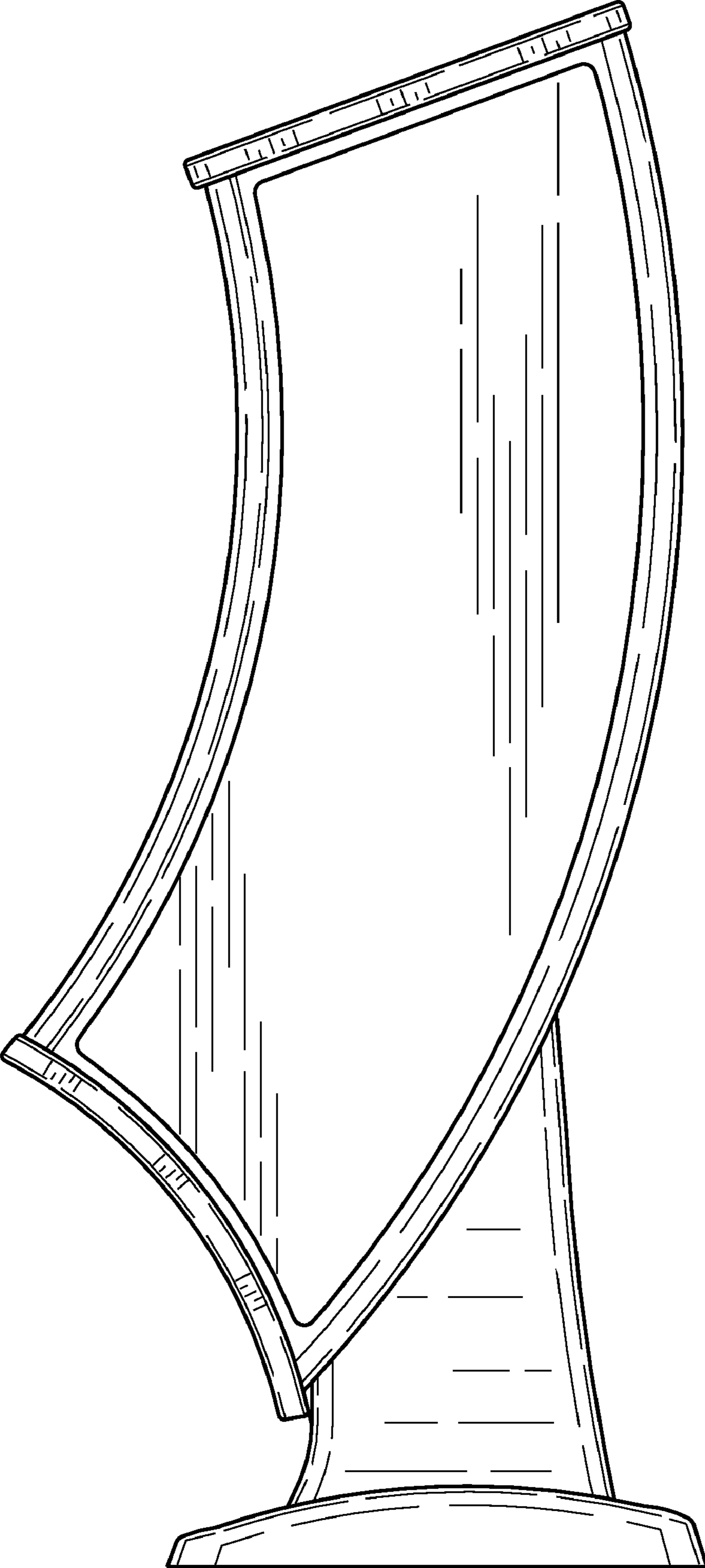

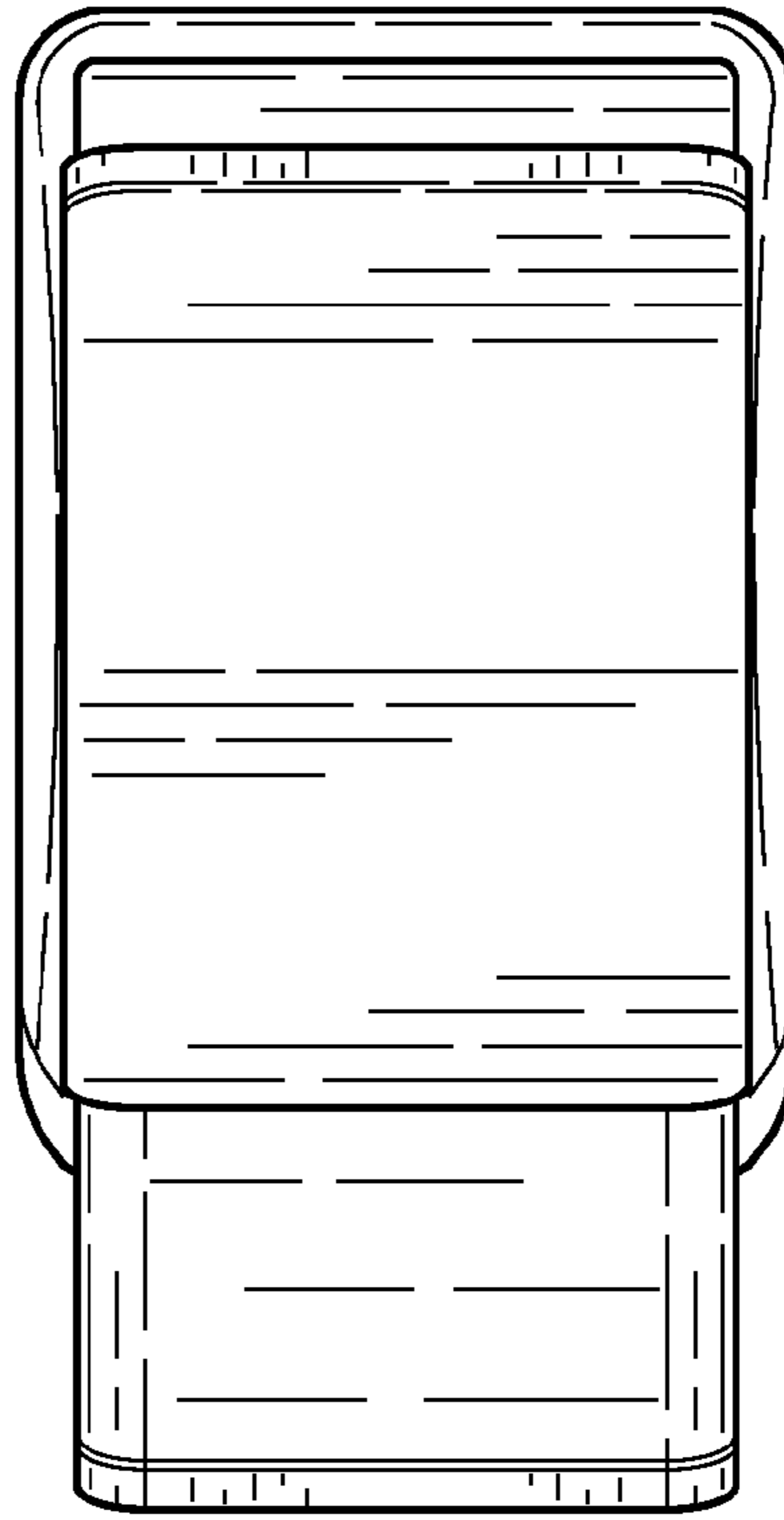

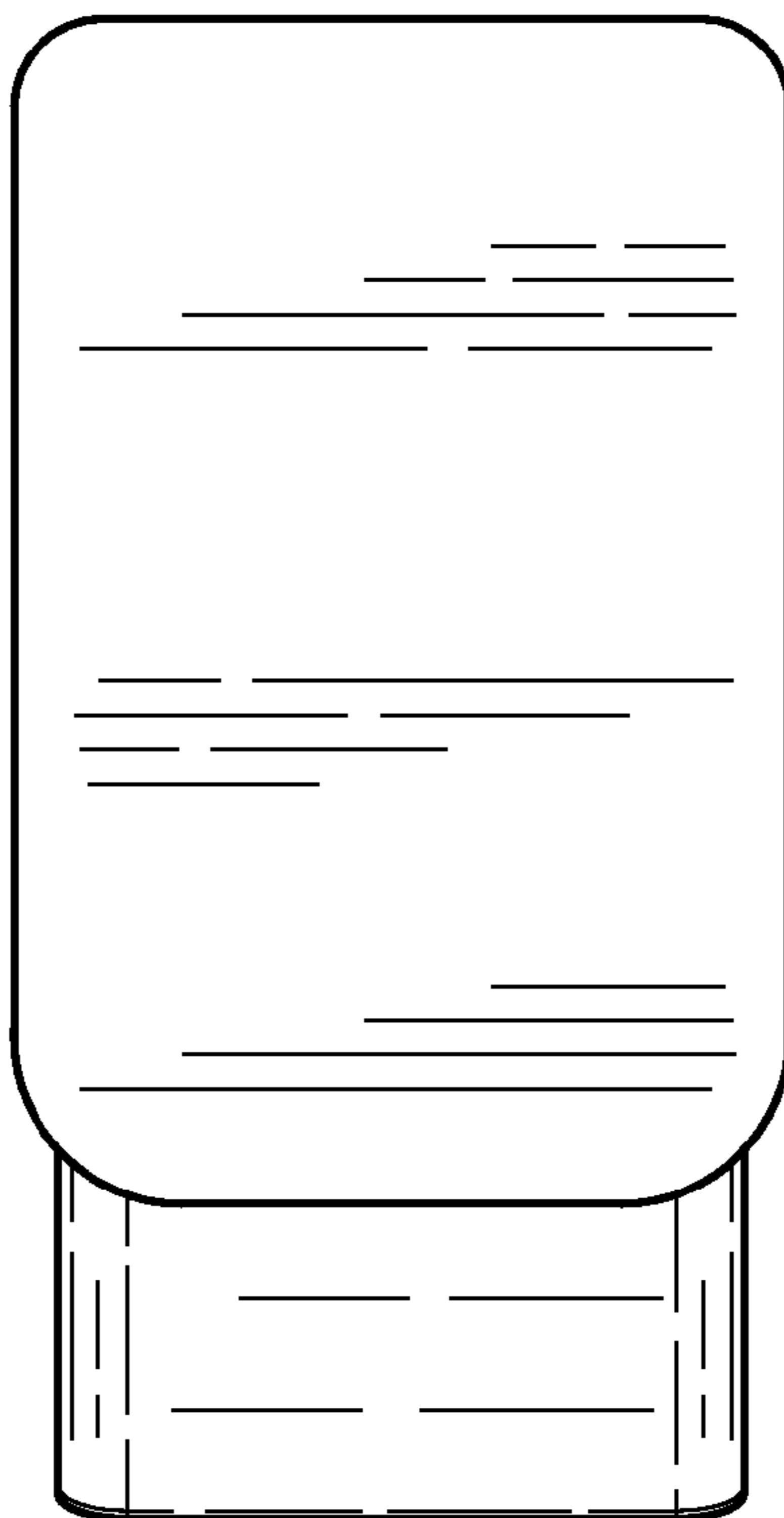

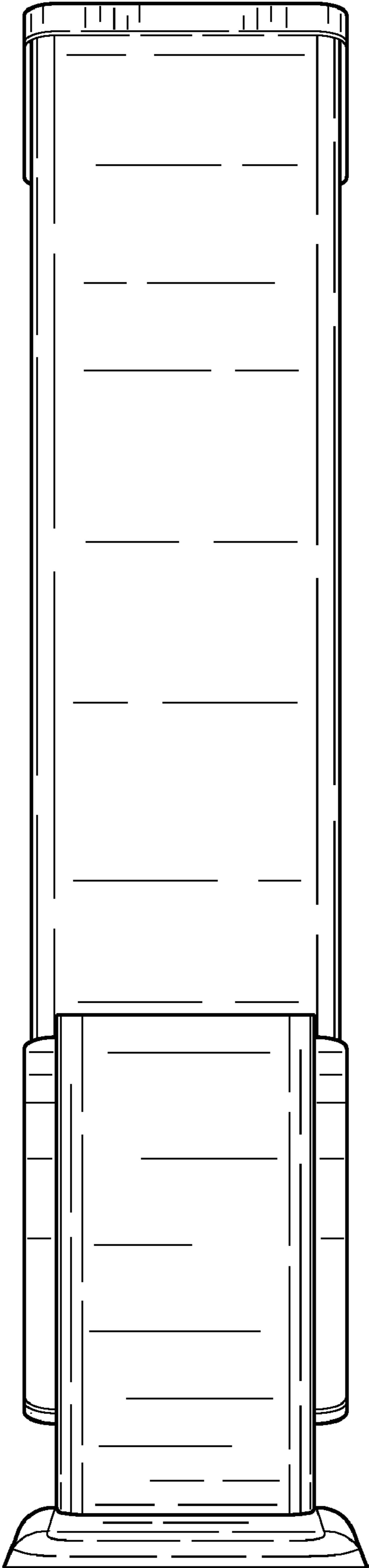
