(57) **CLAIM**

The ornamental design for a flexible handle for containers, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, right side and front perspective view of a flexible handle for containers showing my new design;

FIG. 2 is a bottom, left side and rear perspective view thereof;

FIG. 3 is front elevation view, the rear elevation being identical thereto;

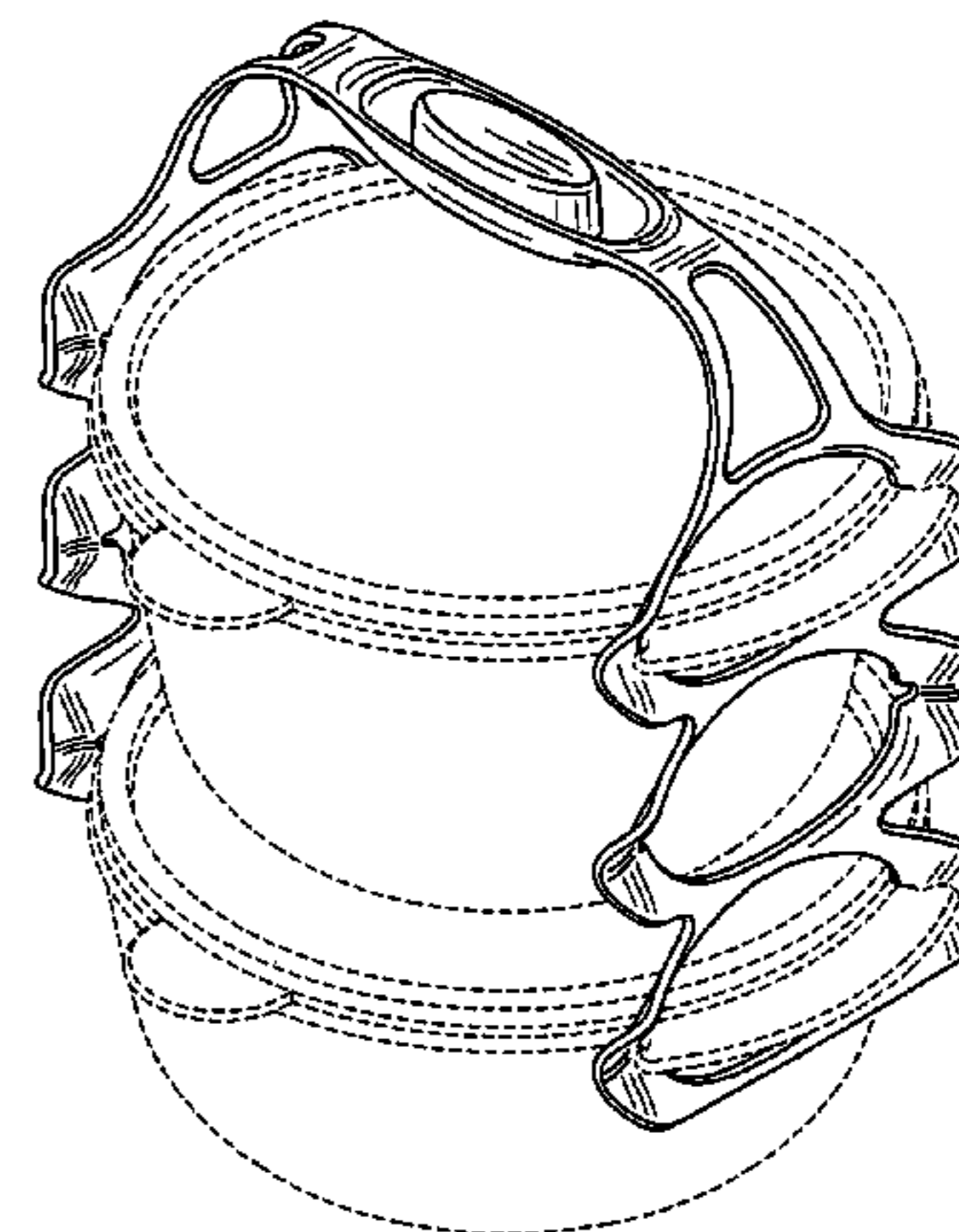
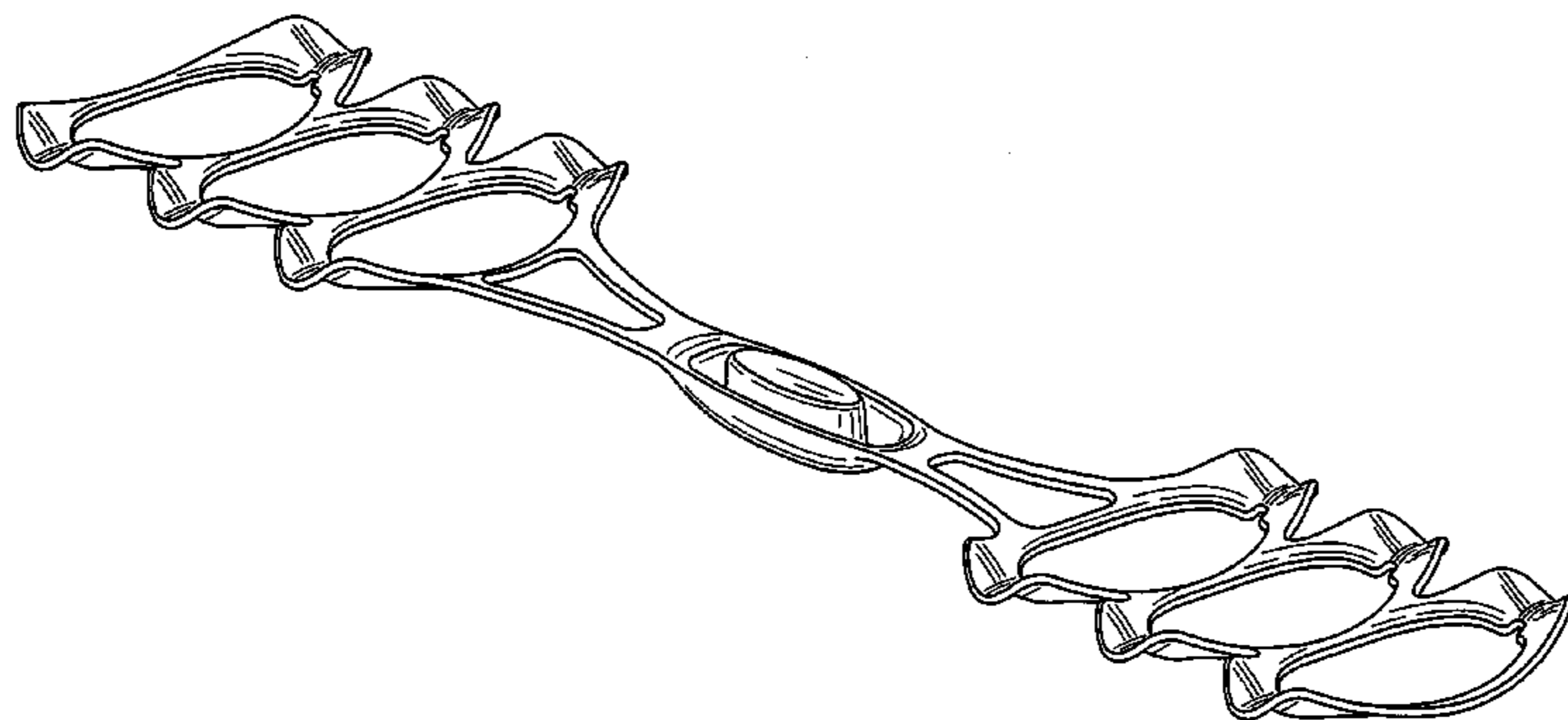
FIG. 4 is a right side elevation view, the left side elevation being identical thereto;

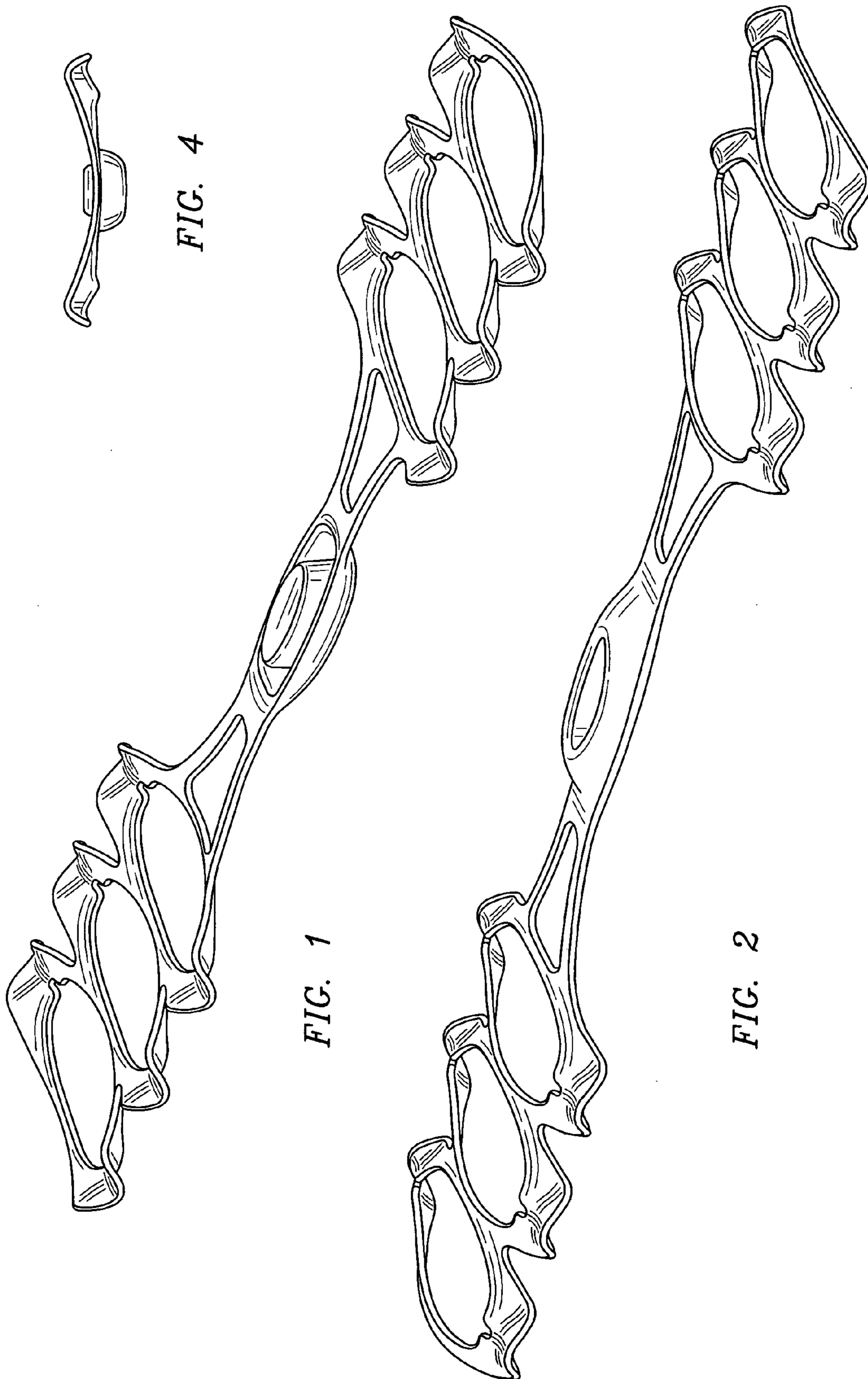
FIG. 5 is a top plan view thereof;

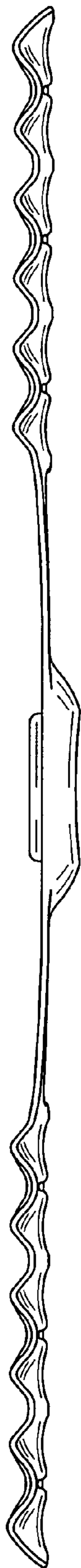

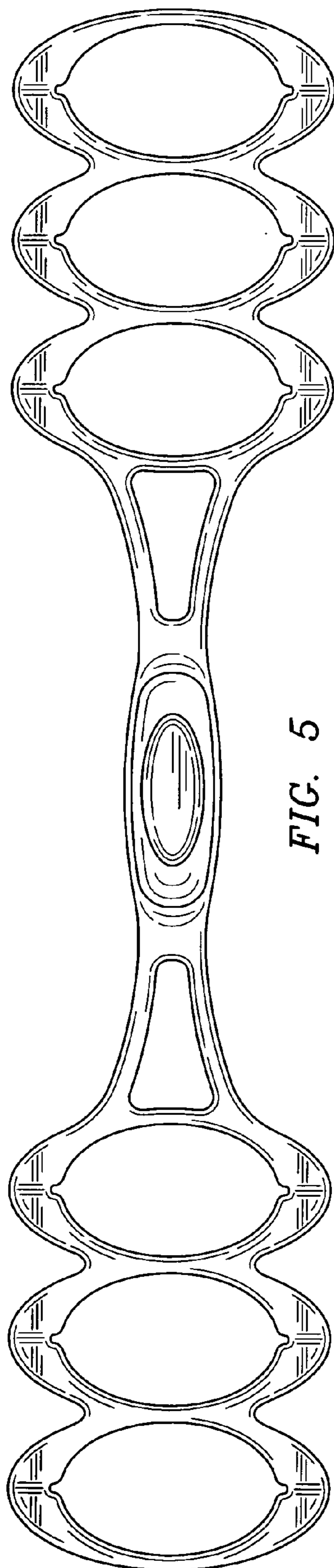

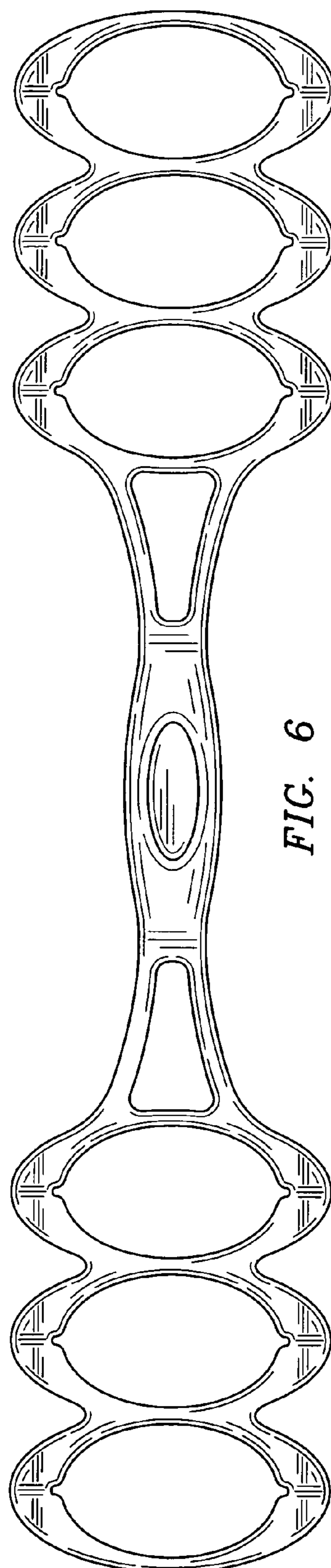
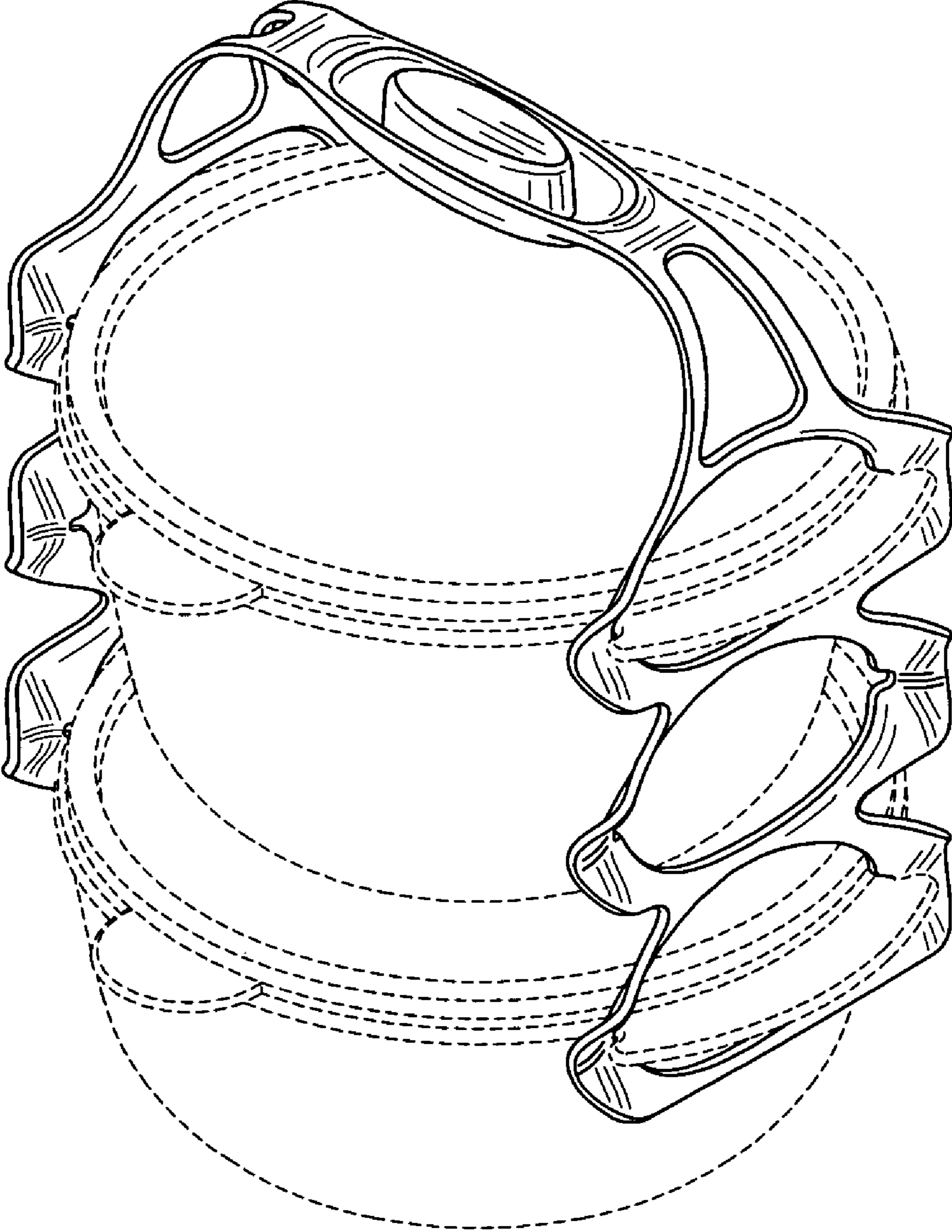
