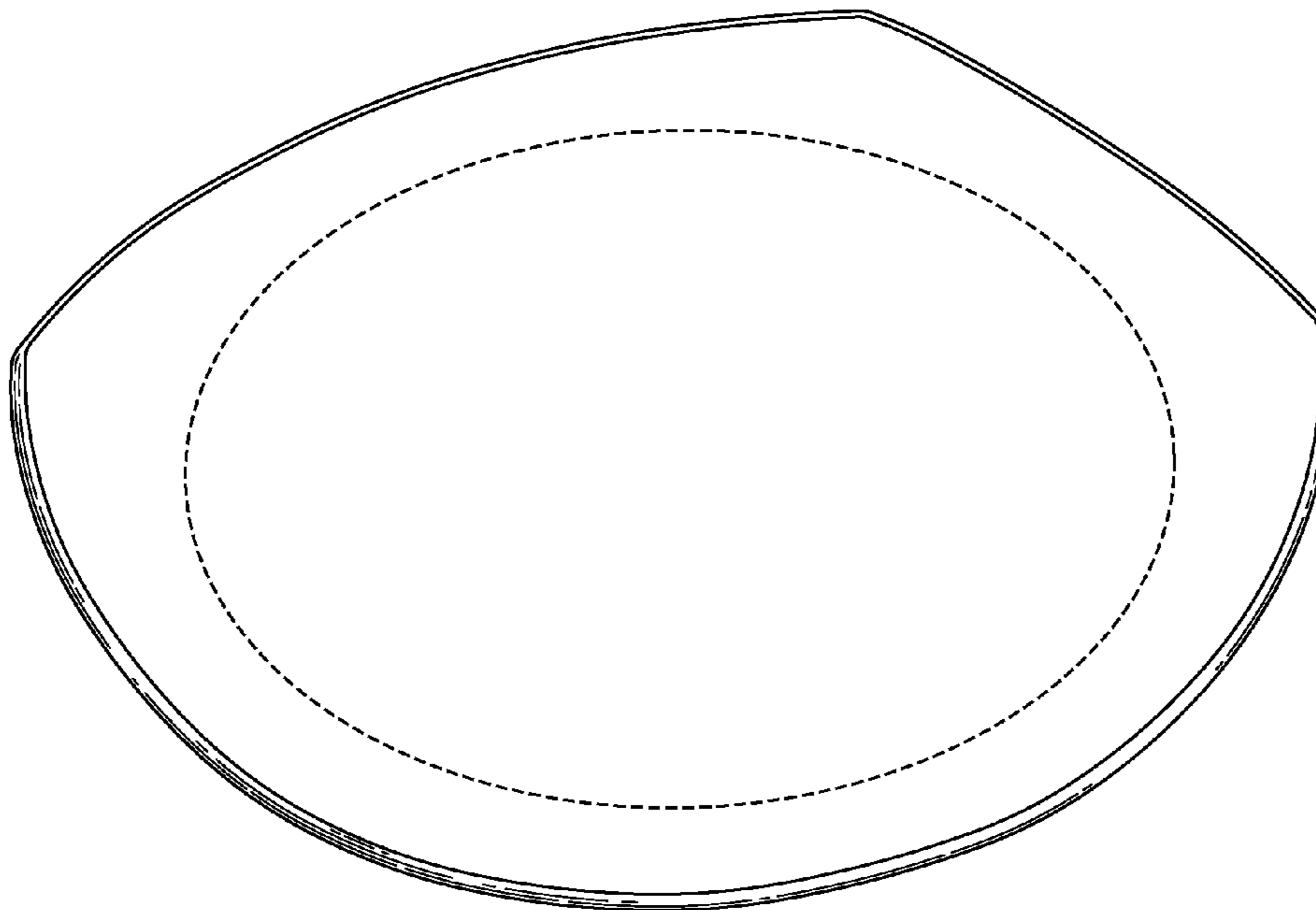
The ornamental design for a dishware rim, as shown and described.

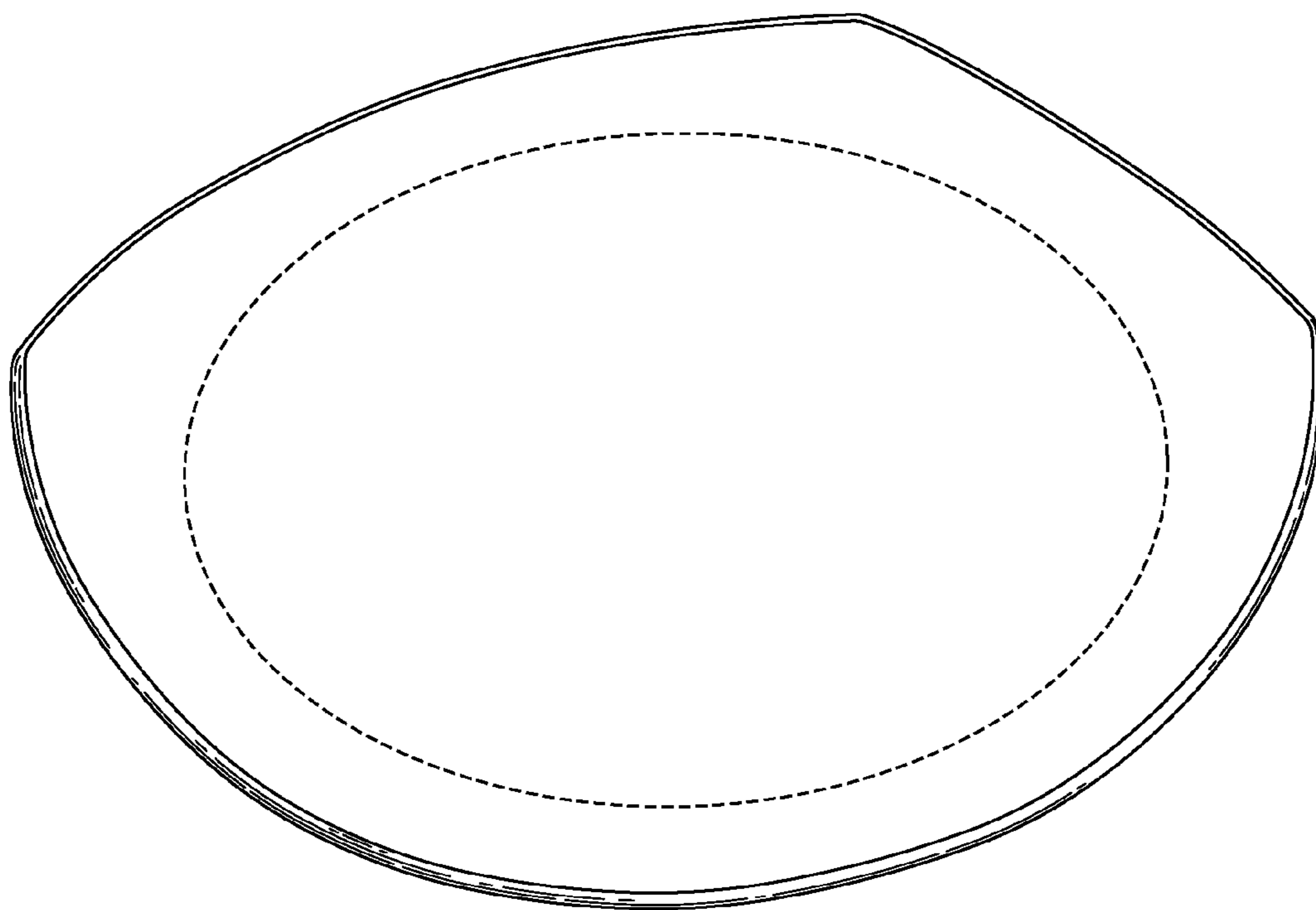

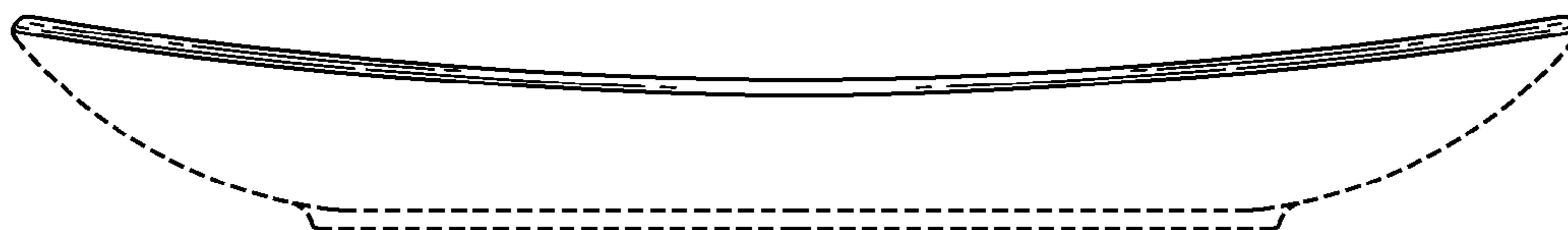

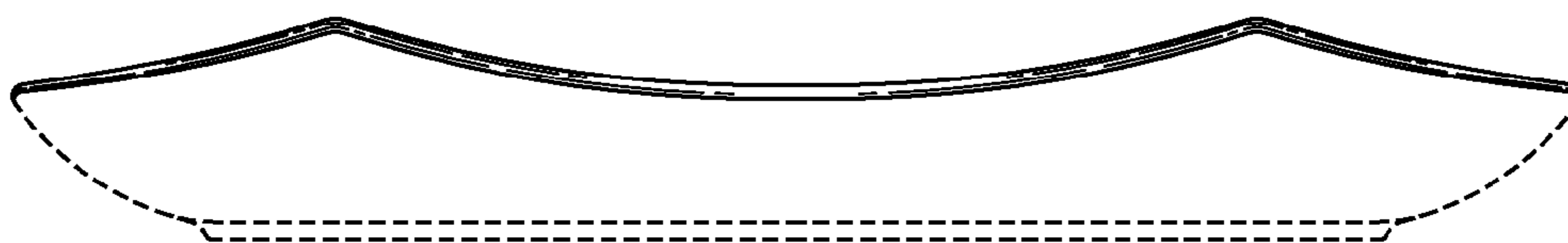

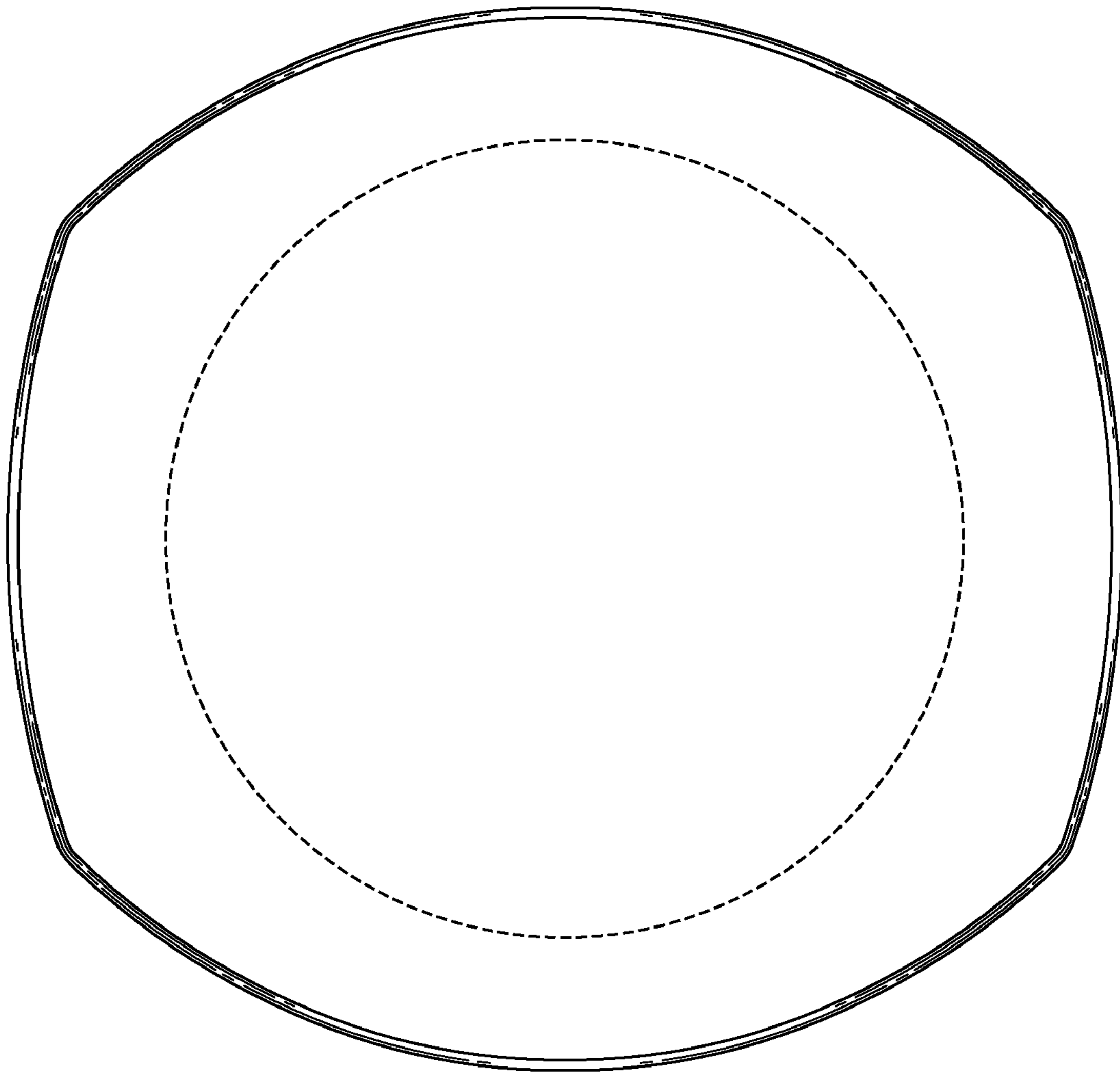

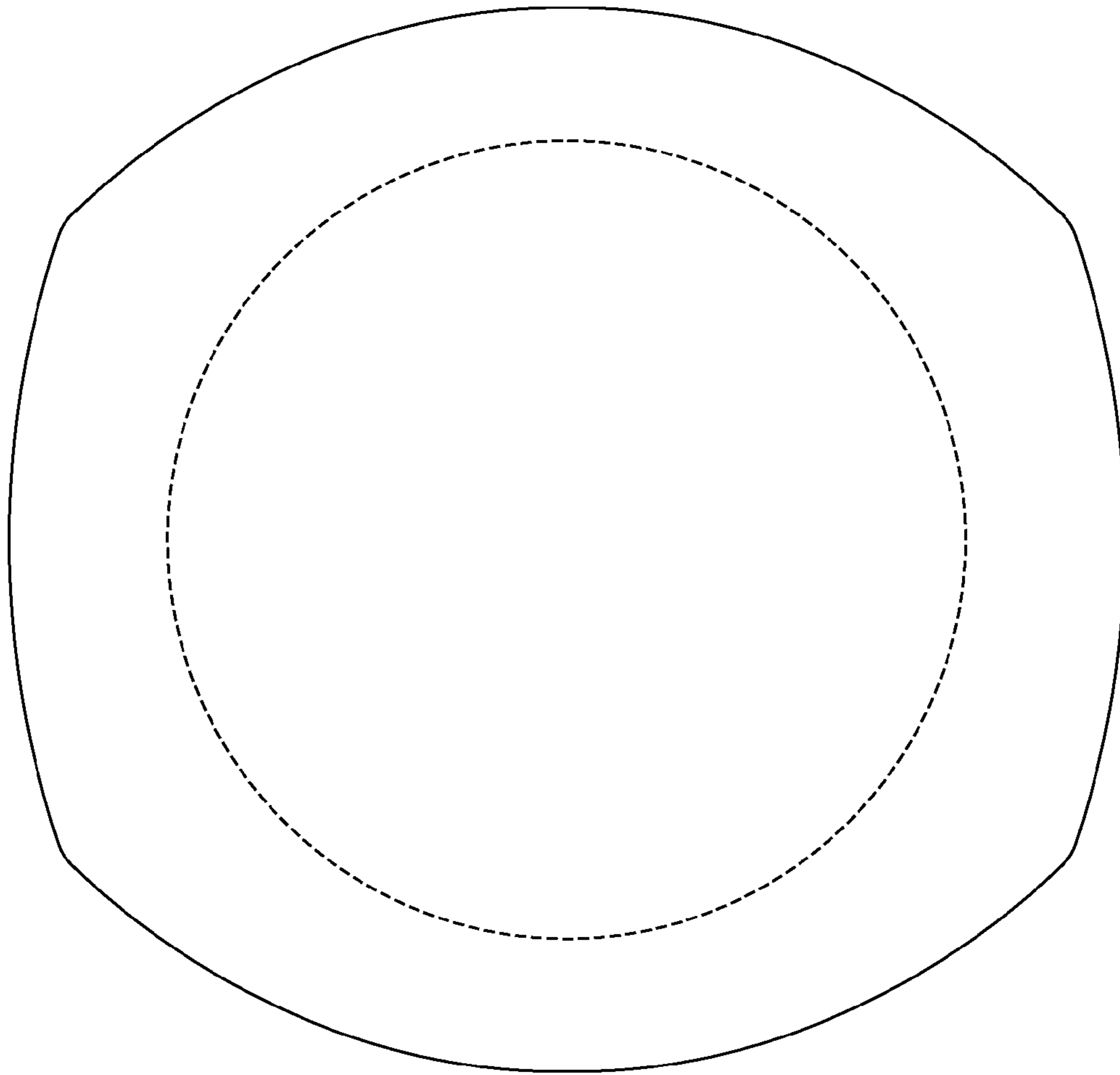
