FIG. 2 is a rear perspective view, from beneath, of the claimed design;

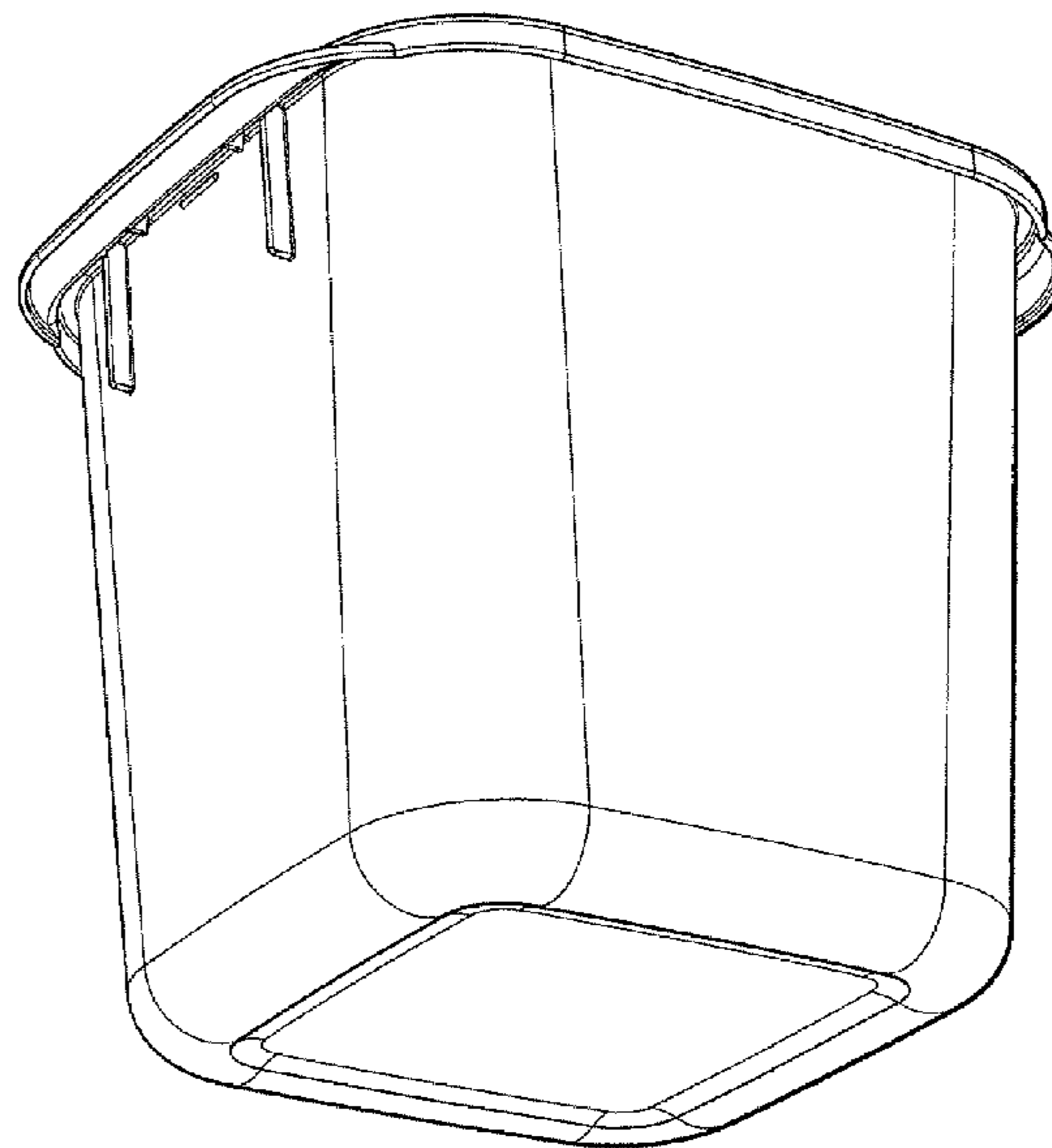
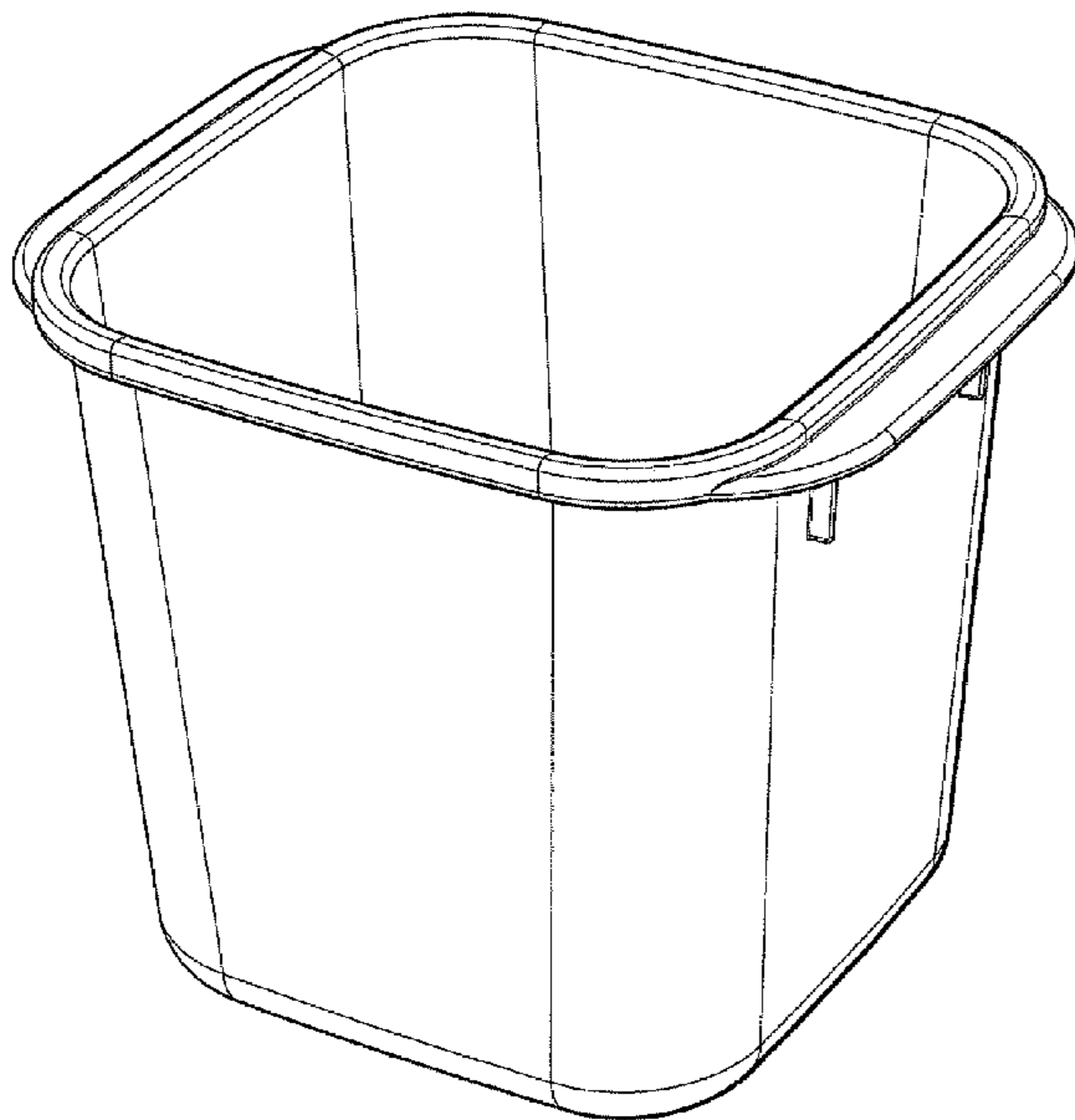
FIG. 3 is a top plan view of the claimed design;

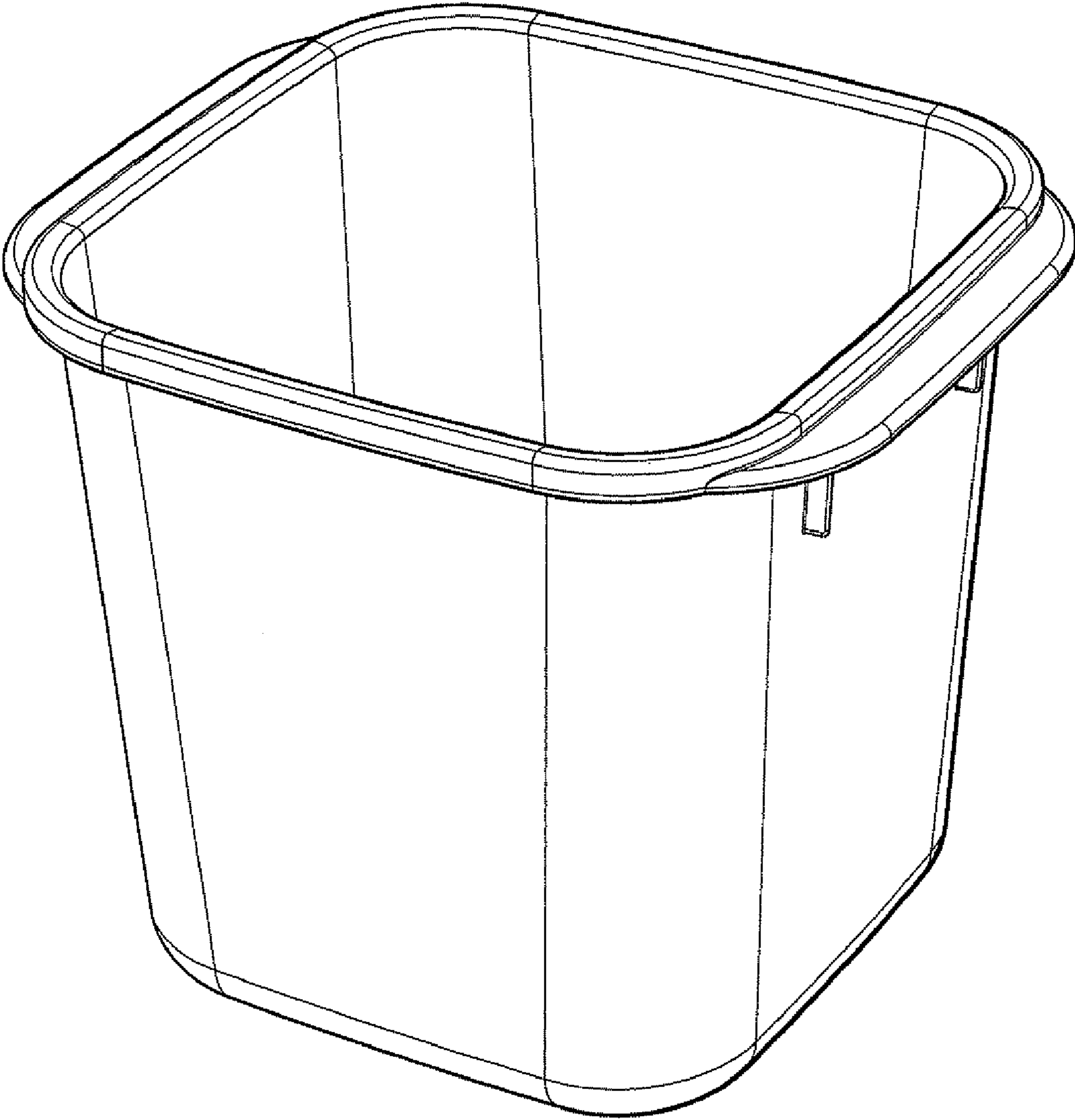

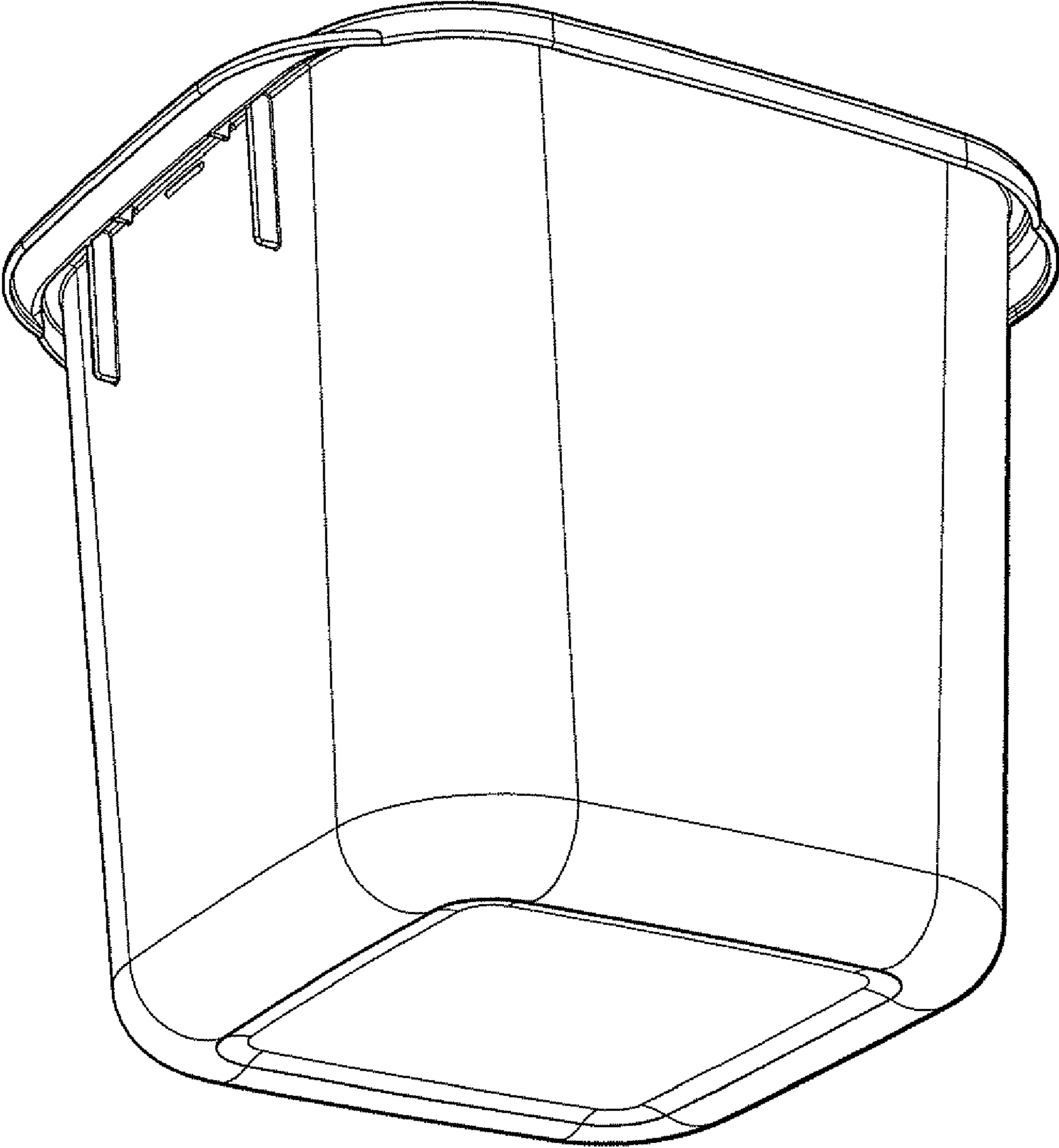

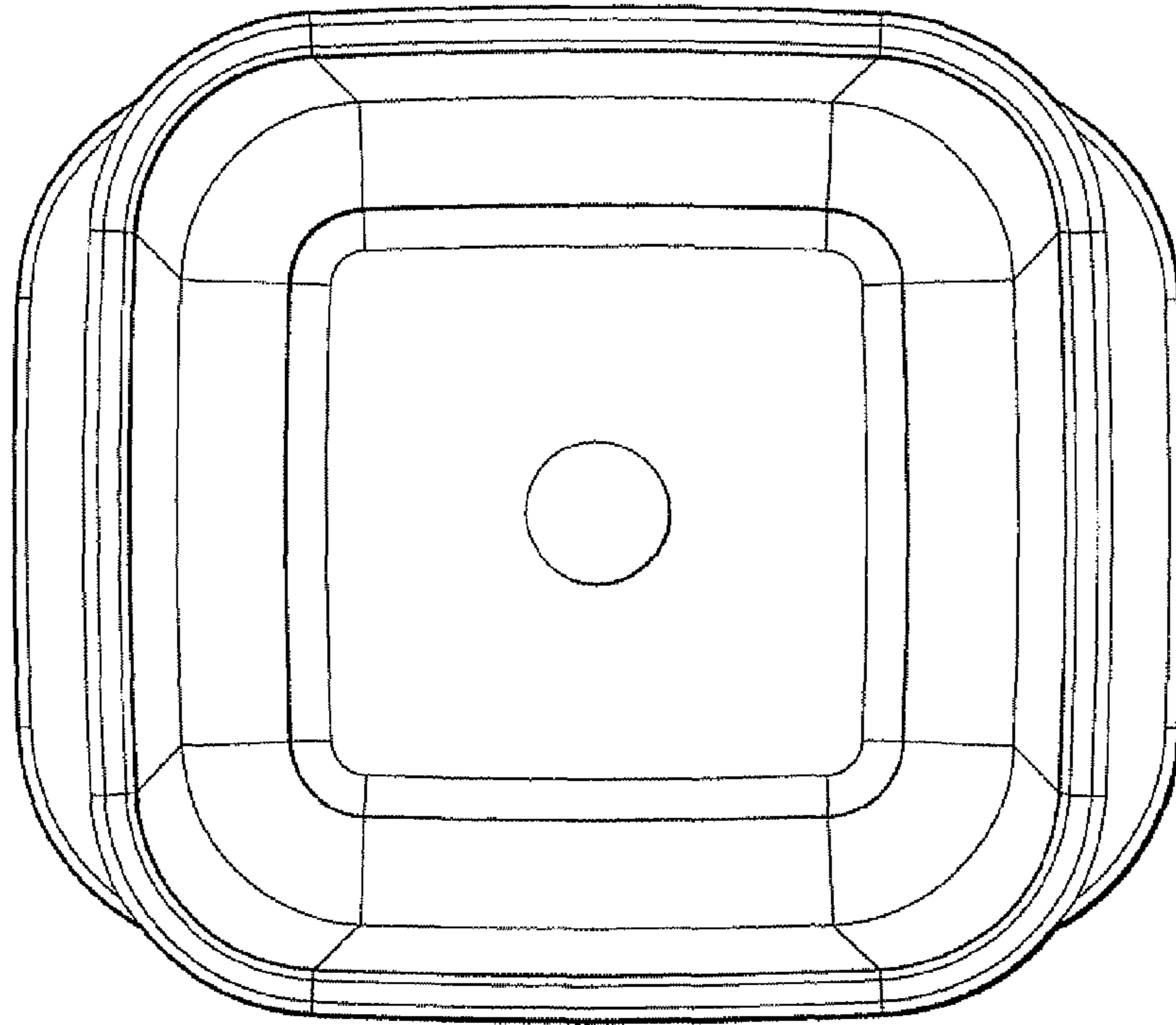

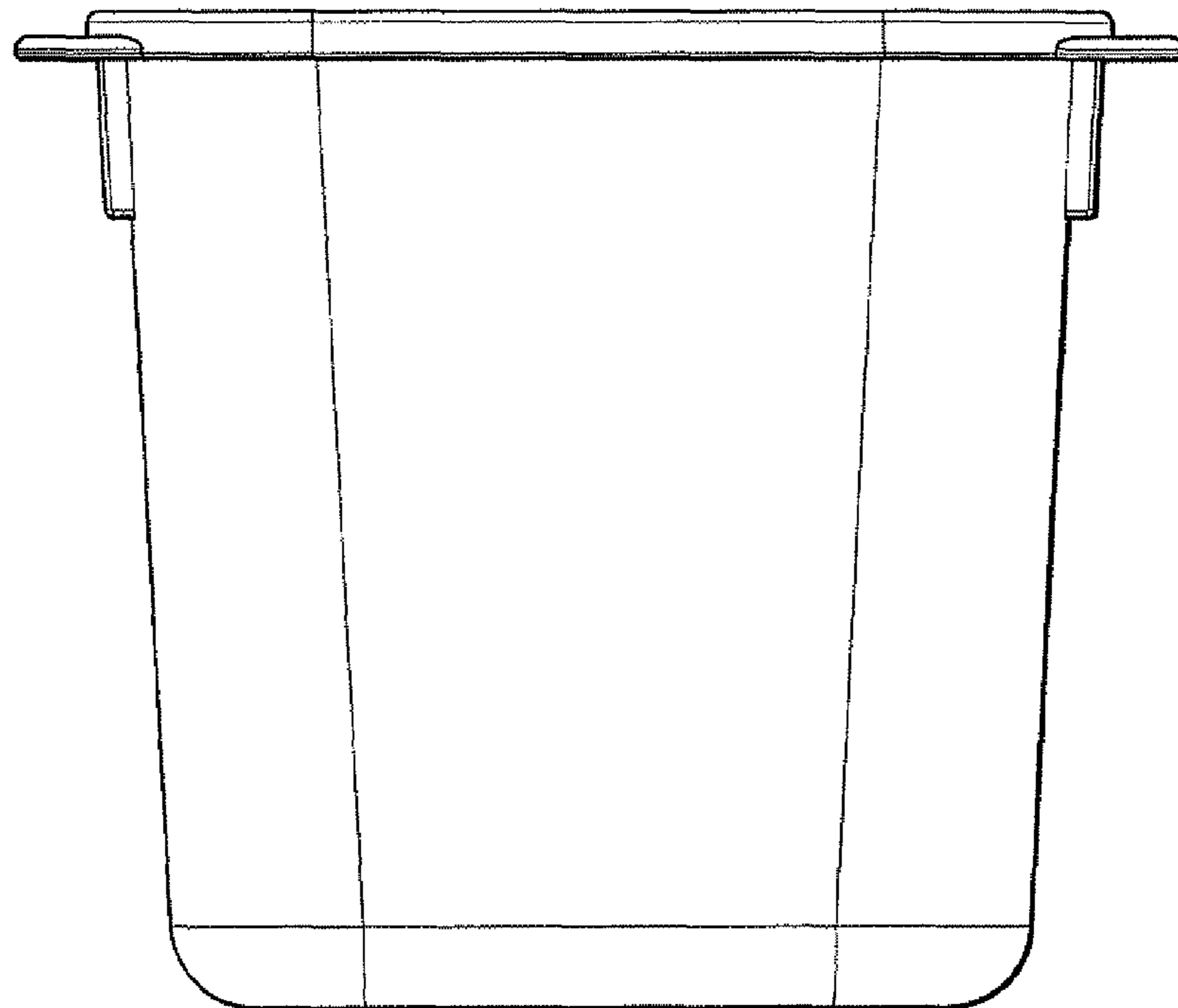

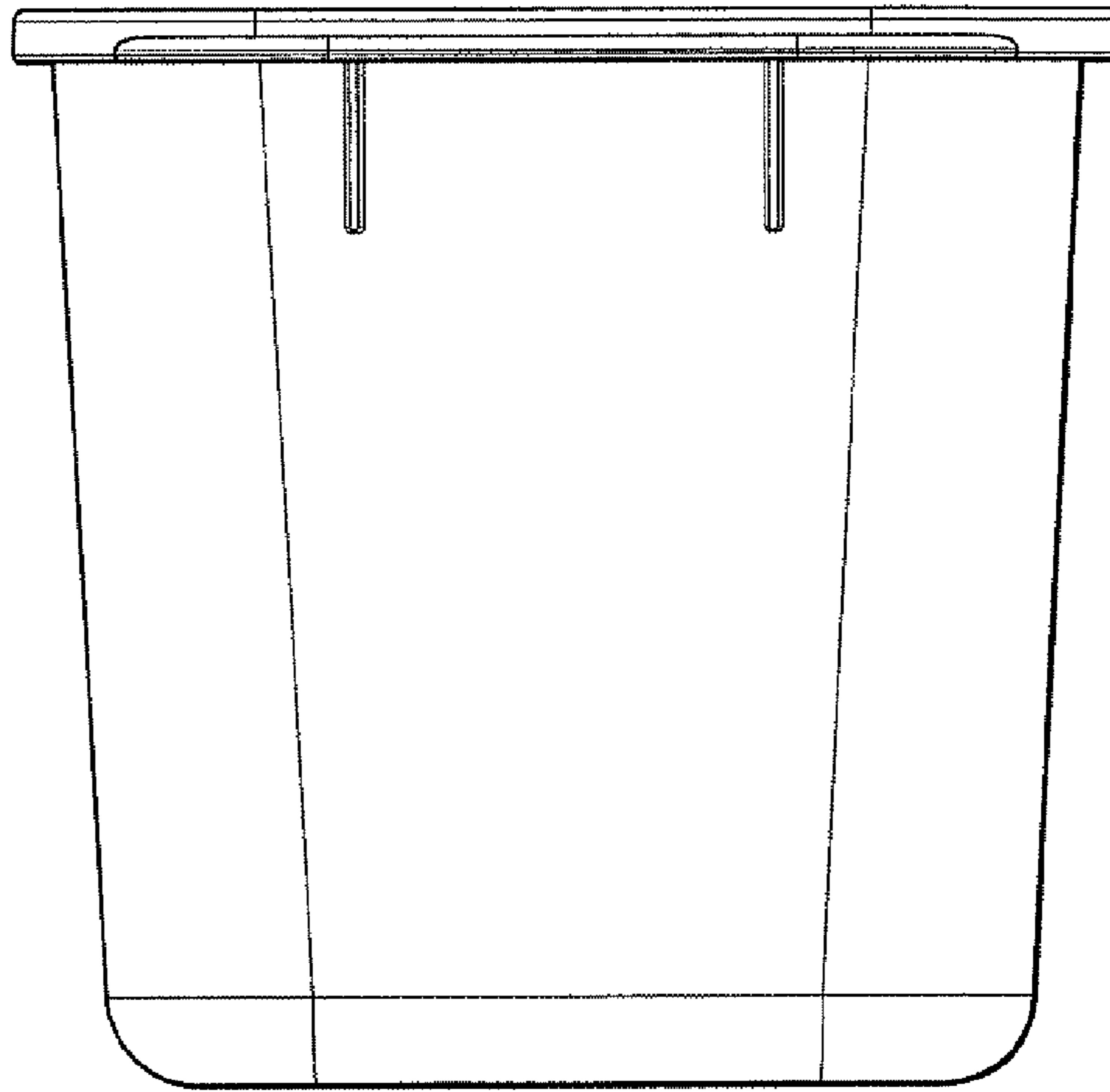

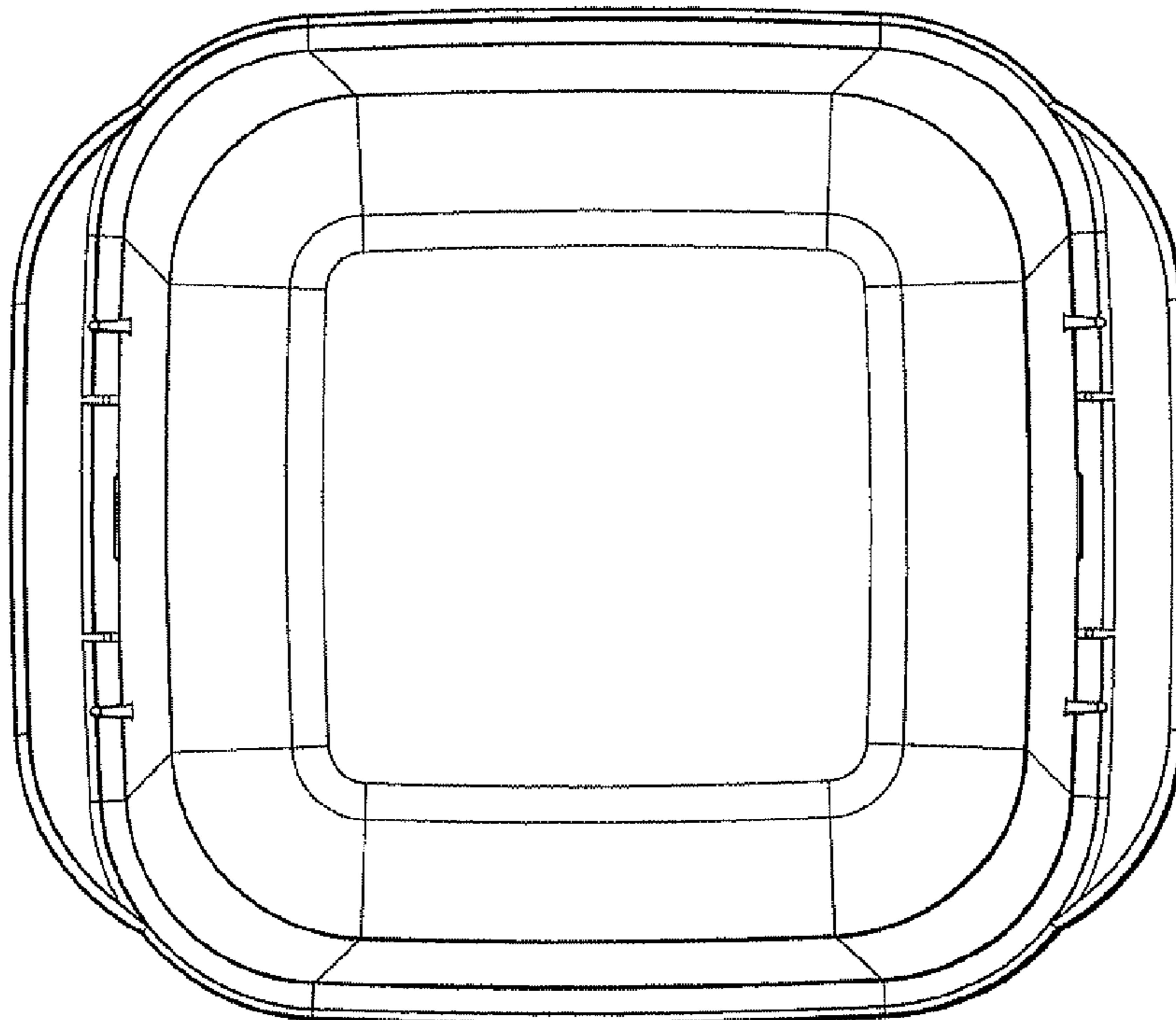
