**DESCRIPTION**

FIG. 1 is a perspective view of an anchor sleeve showing my new design.

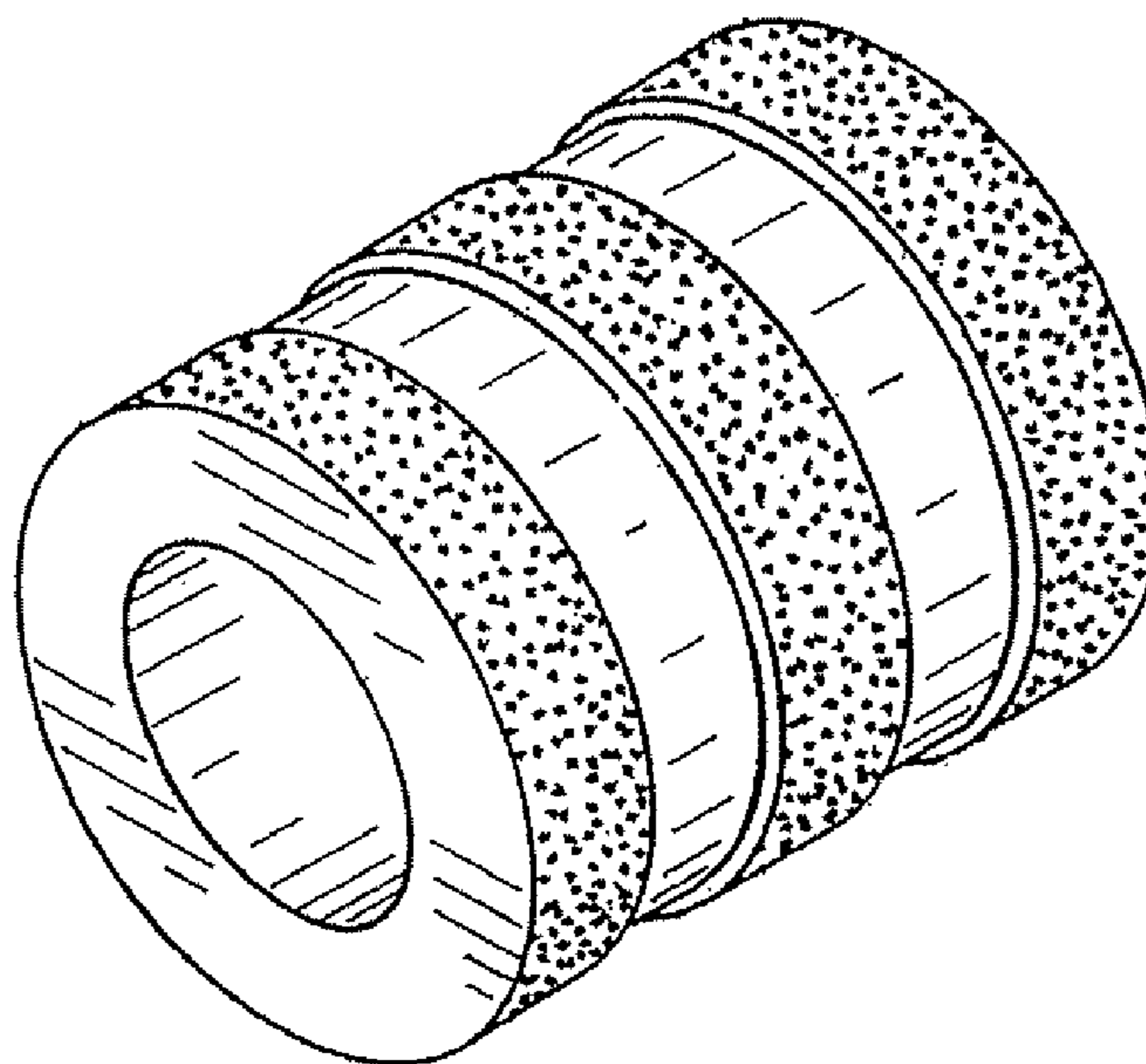
FIG. 2 is a side view of one side thereof, the opposite side being a mirror image.

FIG. 3 is a top view thereof, the bottom view being a mirror image; and,

FIG. 4 is a right end view thereof, the left end view being a mirror image.

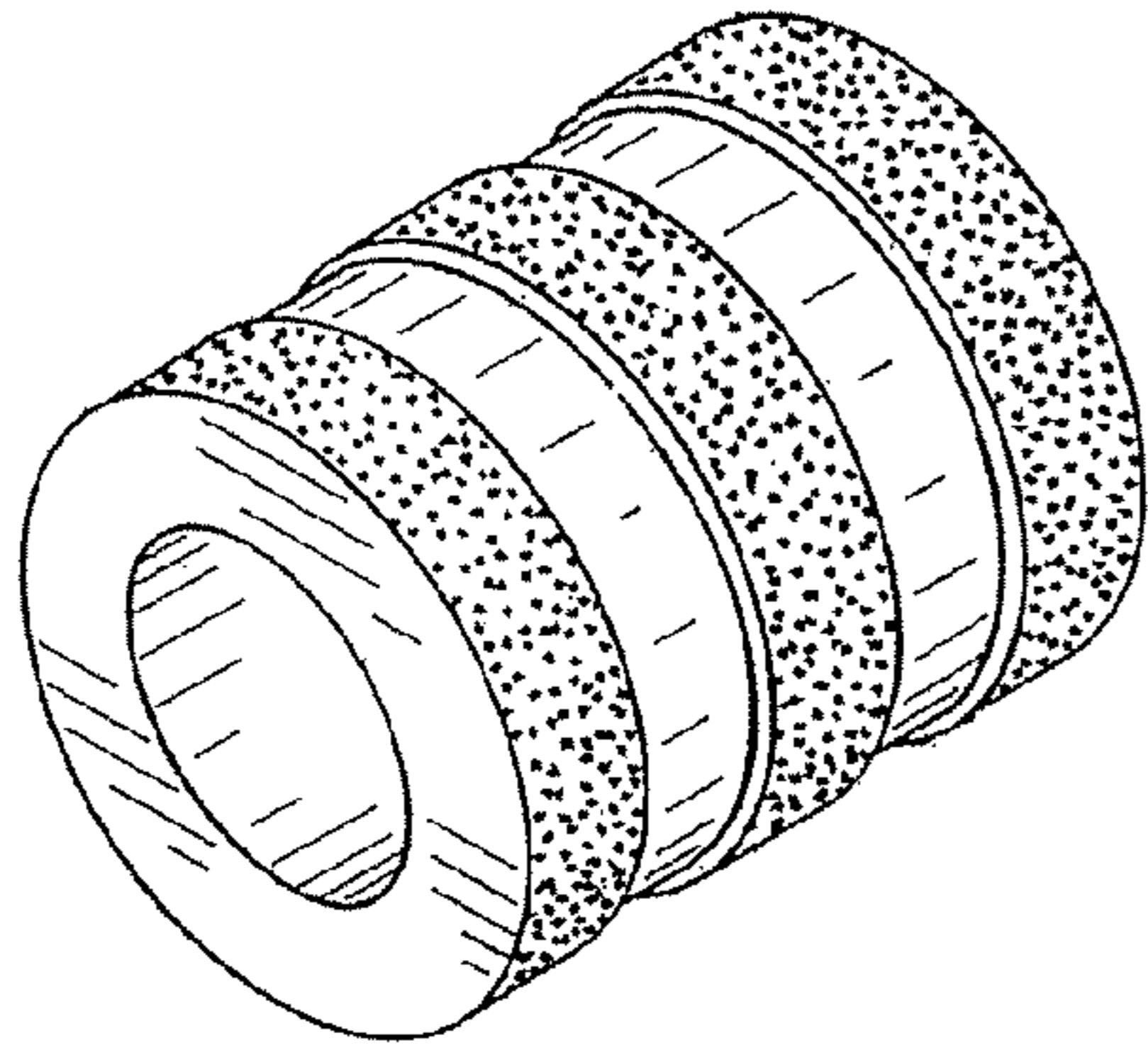

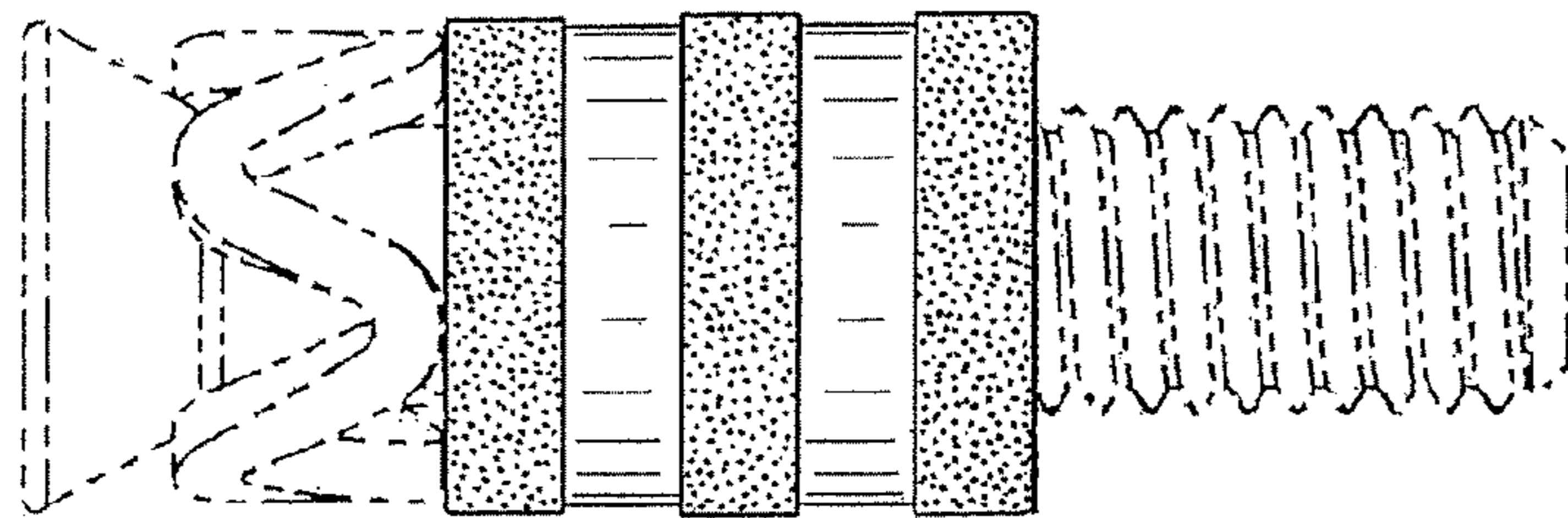

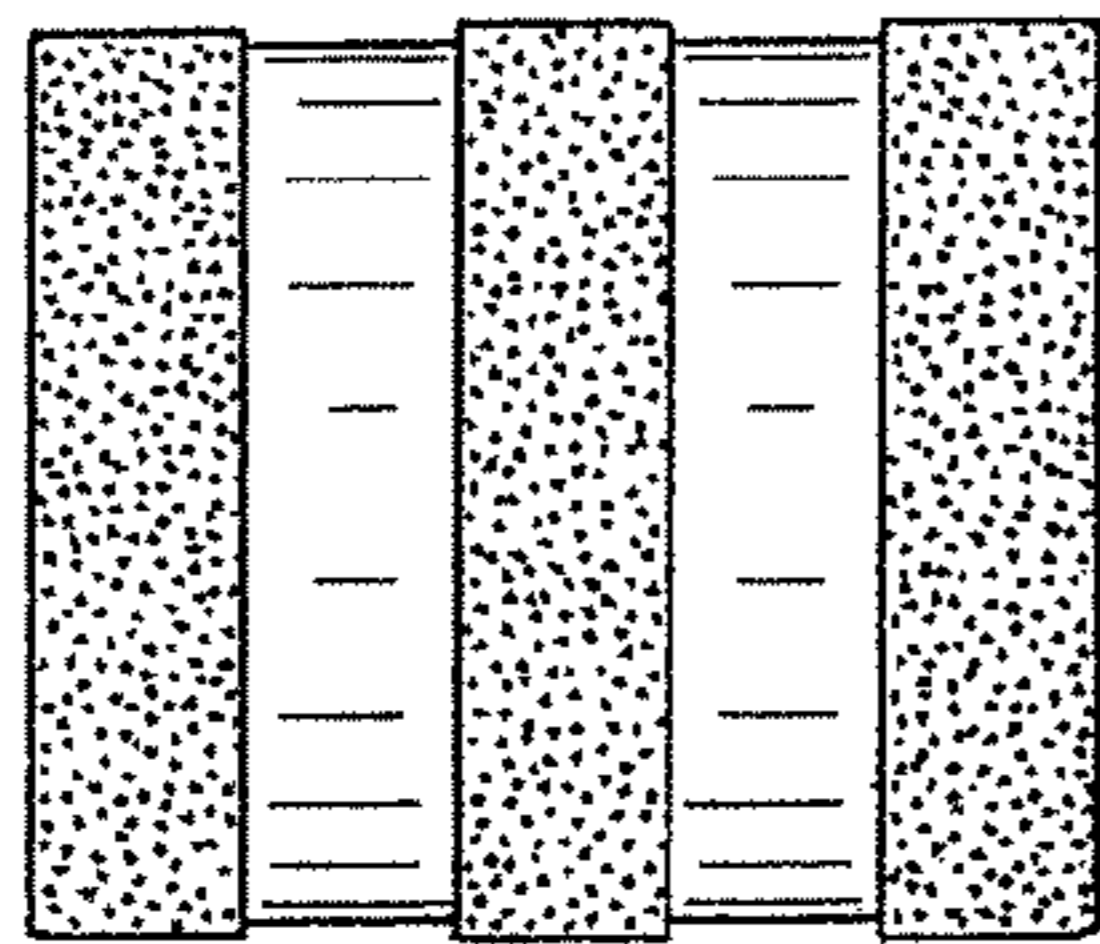

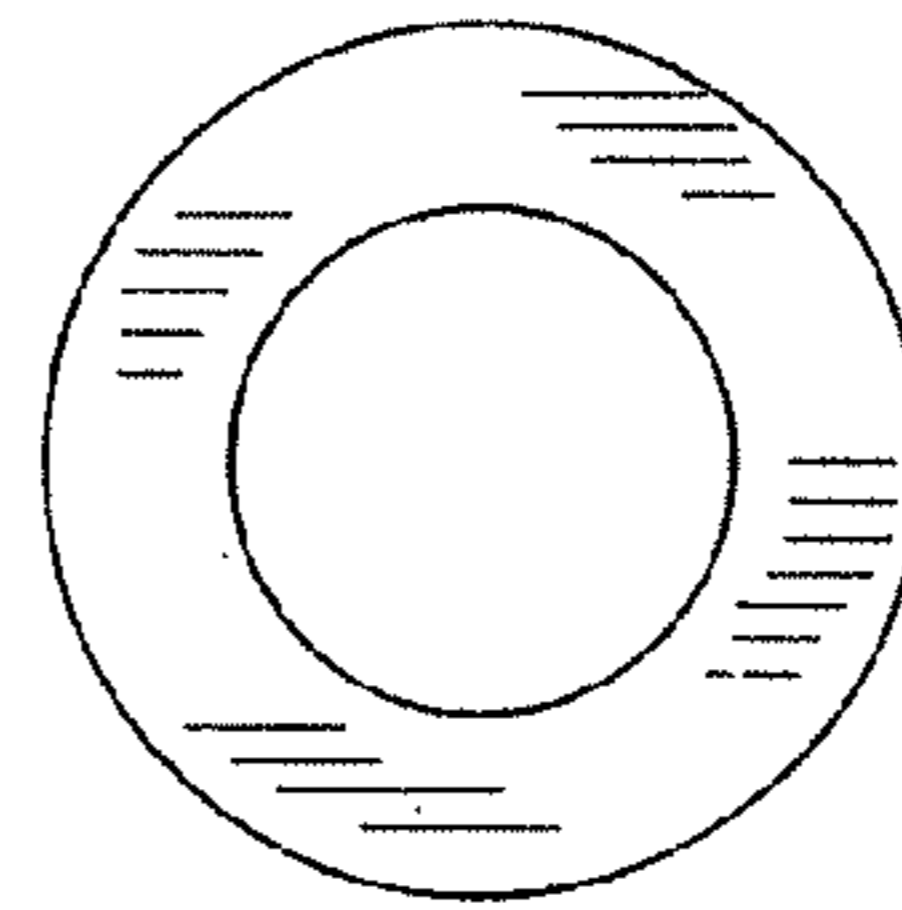
