(57) **CLAIM**

The ornamental design for an electronics equipment package,
as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of the
present invention showing our design for an electronics

equipment package; the broken line shown at the top edge of
the package defines the bounds of the claimed design and
forms no part thereof;

FIG. 2 is a top view of a first embodiment of the present
invention which is a minor image to a bottom view;

FIG. 3 is a front view of a first embodiment of the present
invention; the broken line shown at the top edge of the pack-
age defines the bounds of the claimed design and forms no
part thereof;

FIG. 4 is a right side view of a first embodiment of the present
invention which is a minor image to a left side view;

FIG. 5 is a back view of a first embodiment of the present
invention; the broken line shown at the top edge of the pack-
age defines the bounds of the claimed design and forms no
part thereof;

FIG. 6 is a front perspective view of a second embodiment of
the present invention showing our design for an electronics
equipment package; the broken line shown at the top edge of
the package defines the bounds of the claimed design and
forms no part thereof;

FIG. 7 is a top view of a second embodiment of the present
invention which is a minor image to a bottom view;

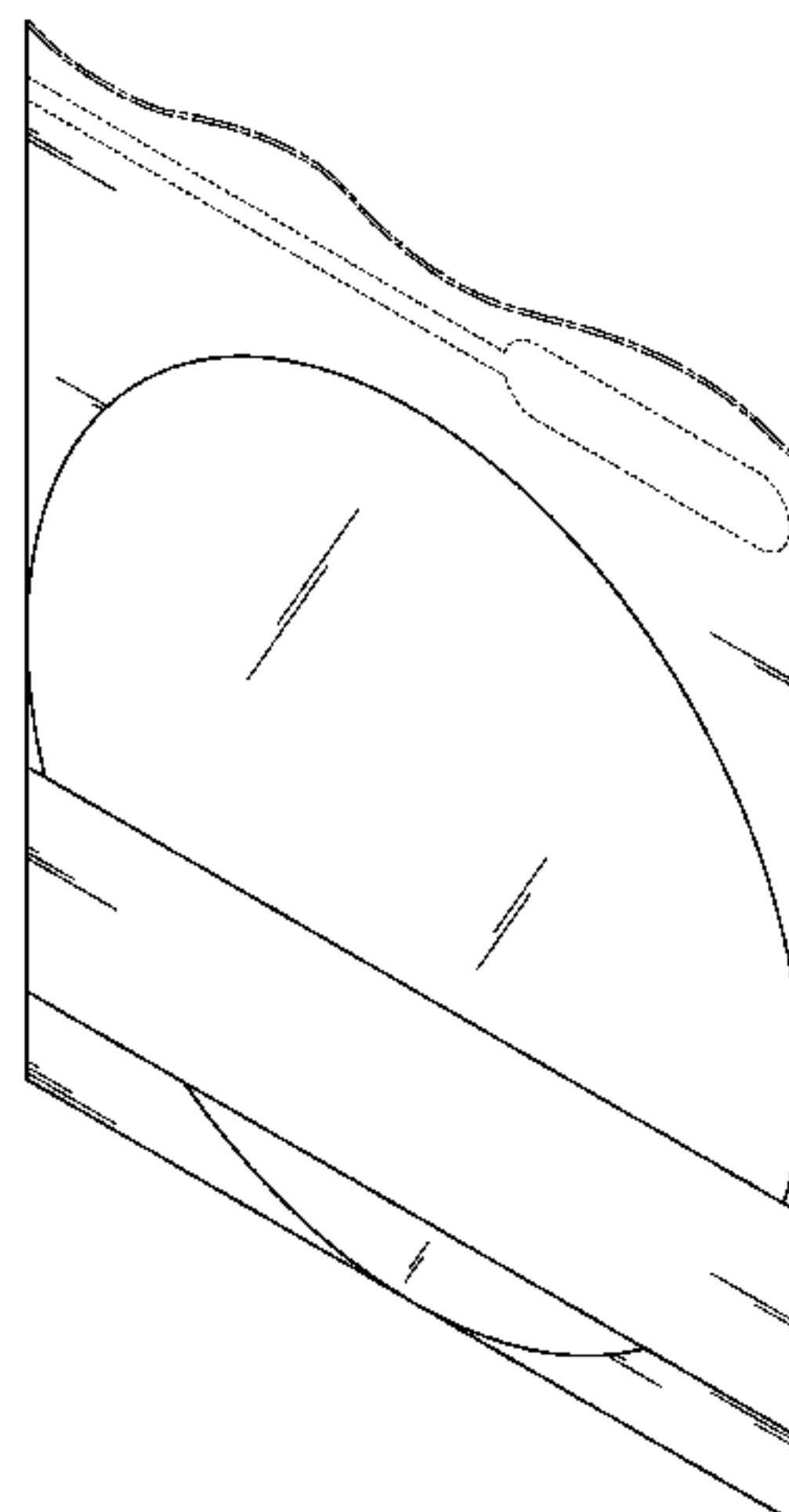
FIG. 8 is a front view of a second embodiment of the present

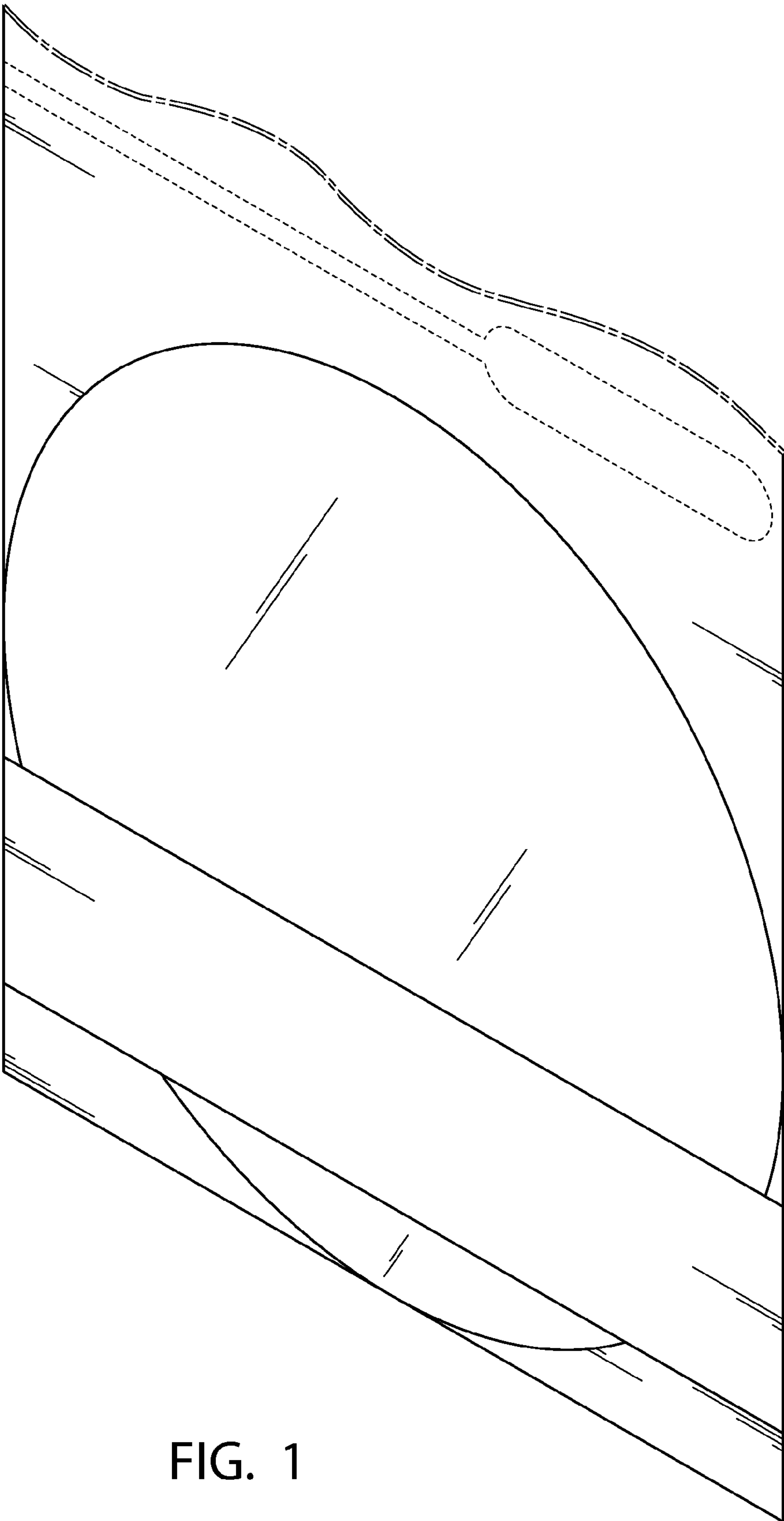

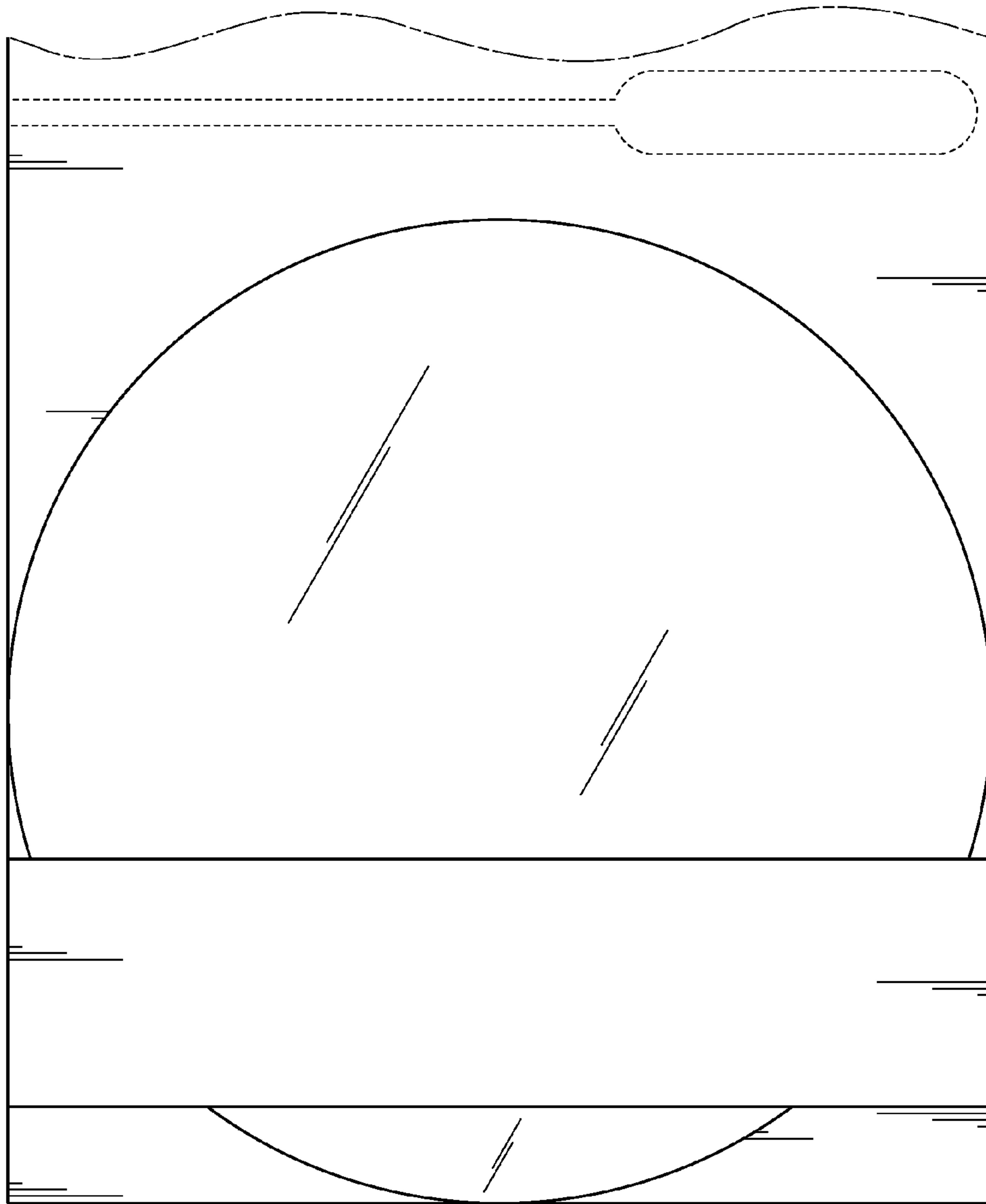

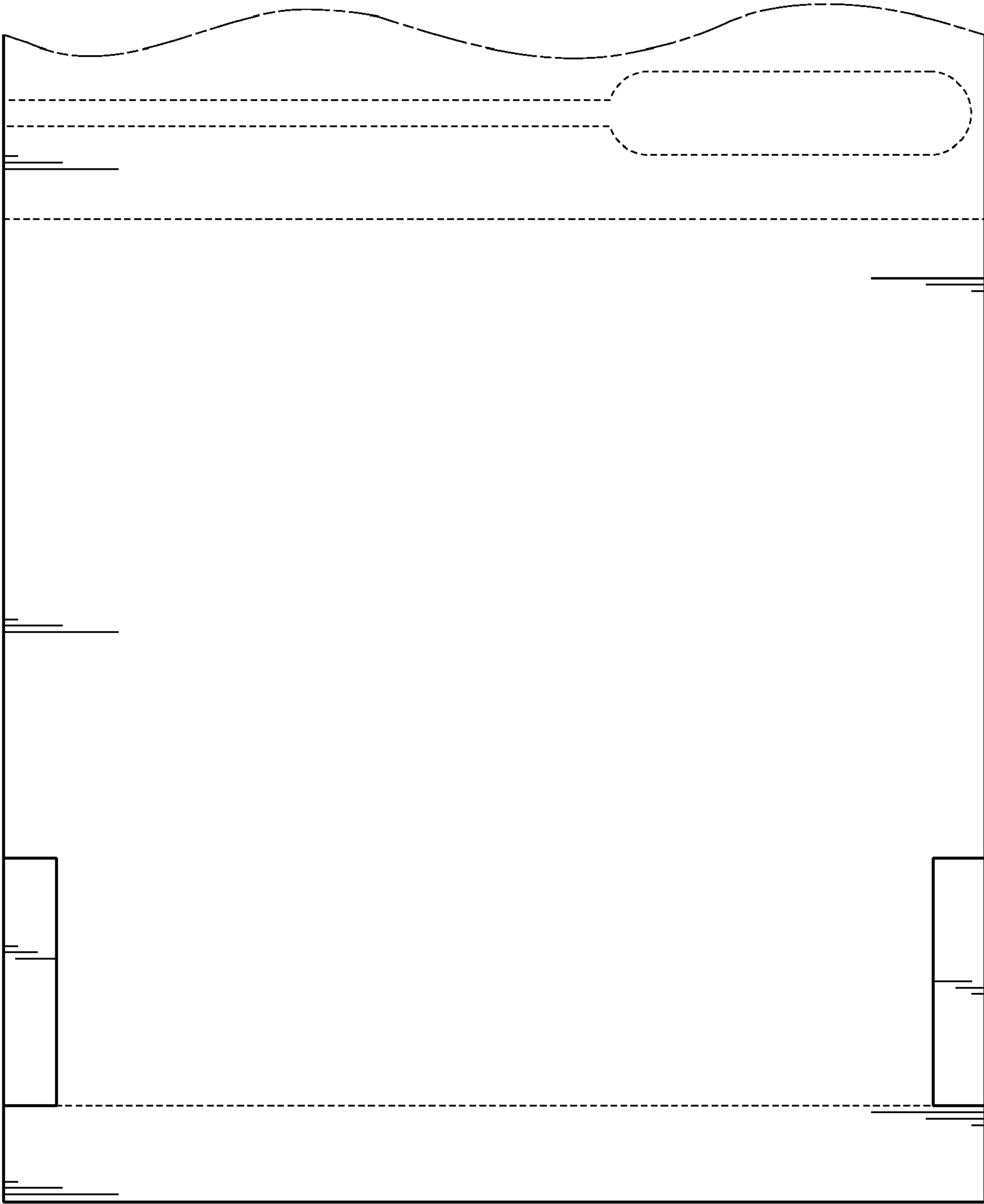

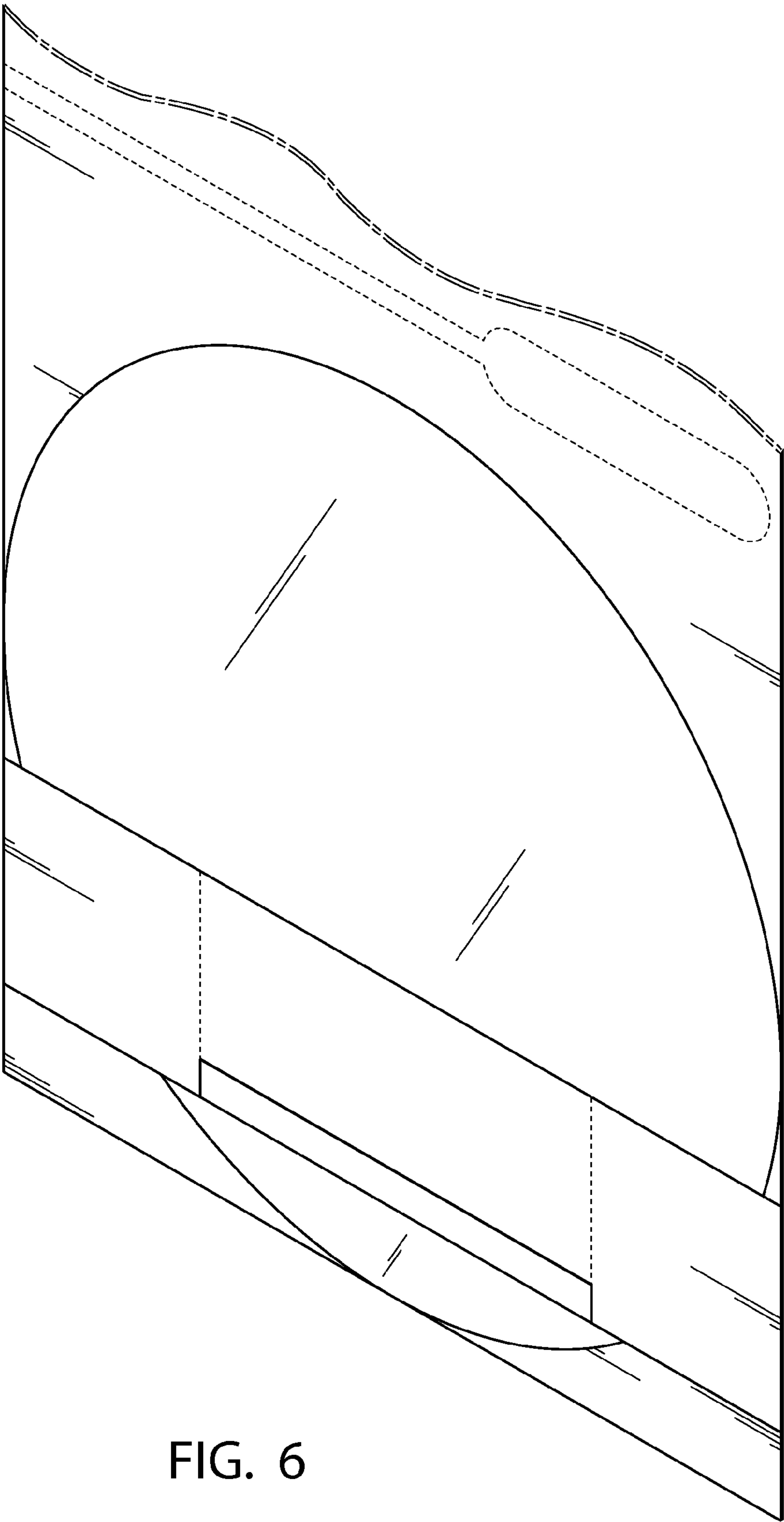

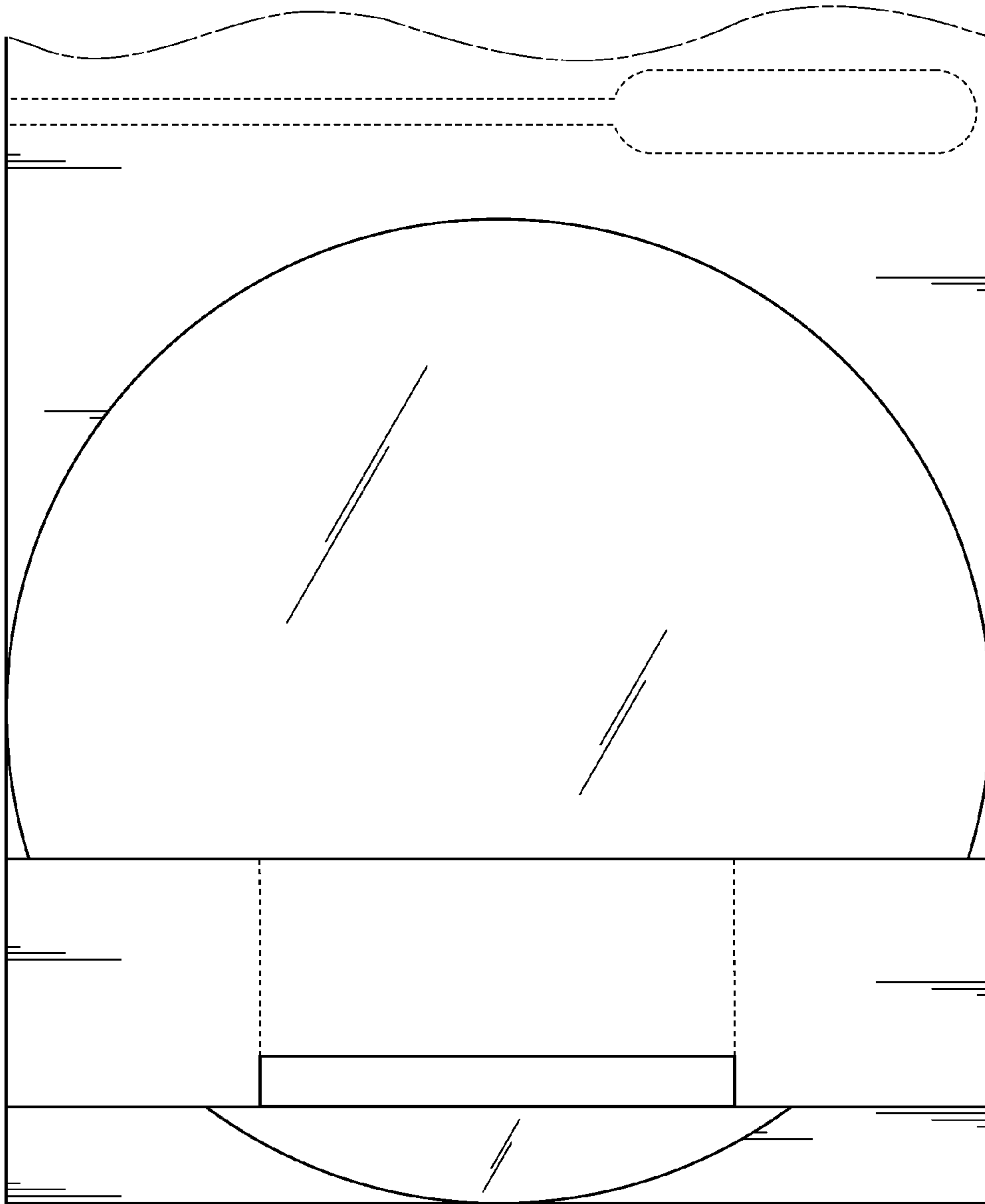

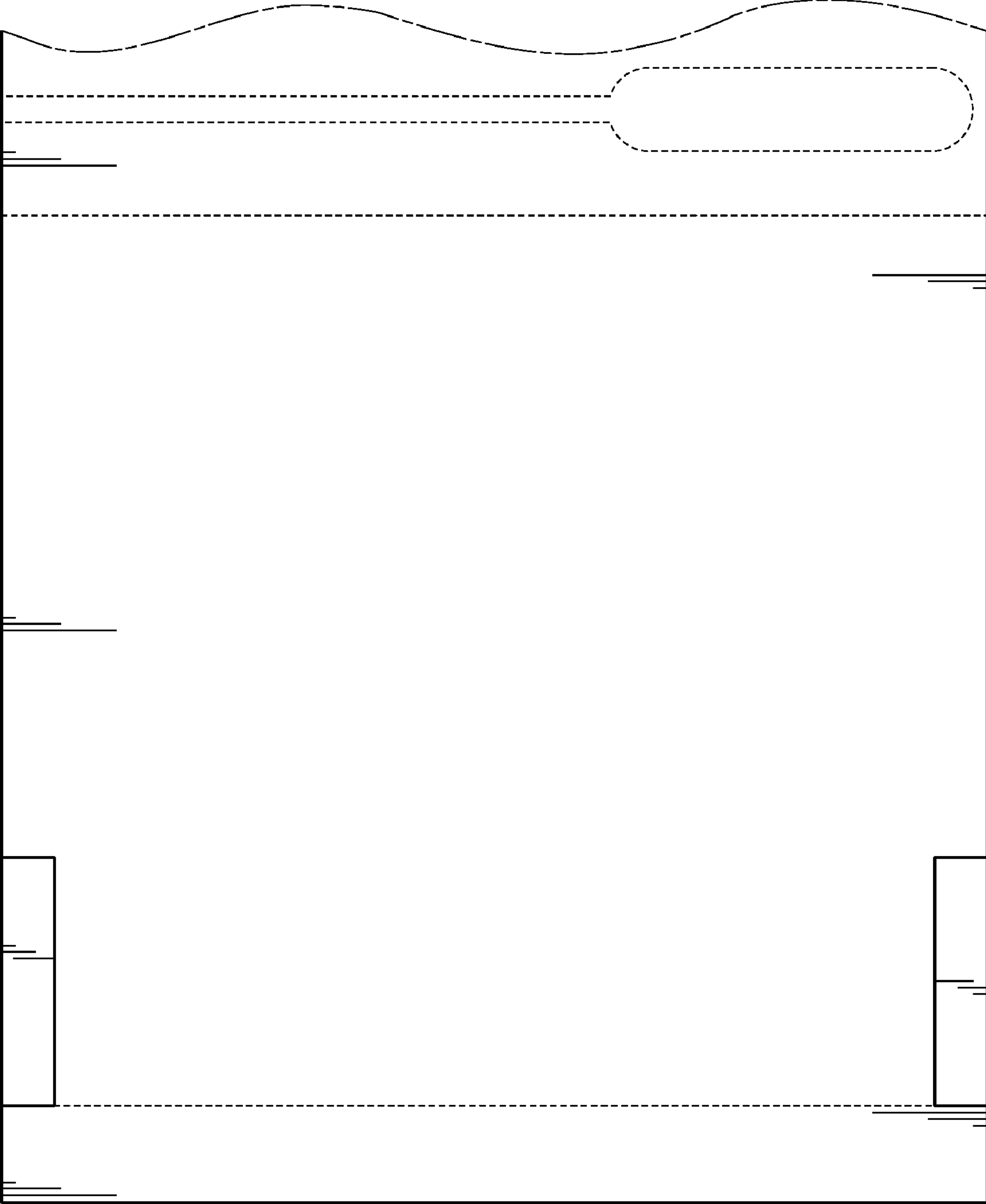
