FIG. 3 shows a bottom view of the ring;

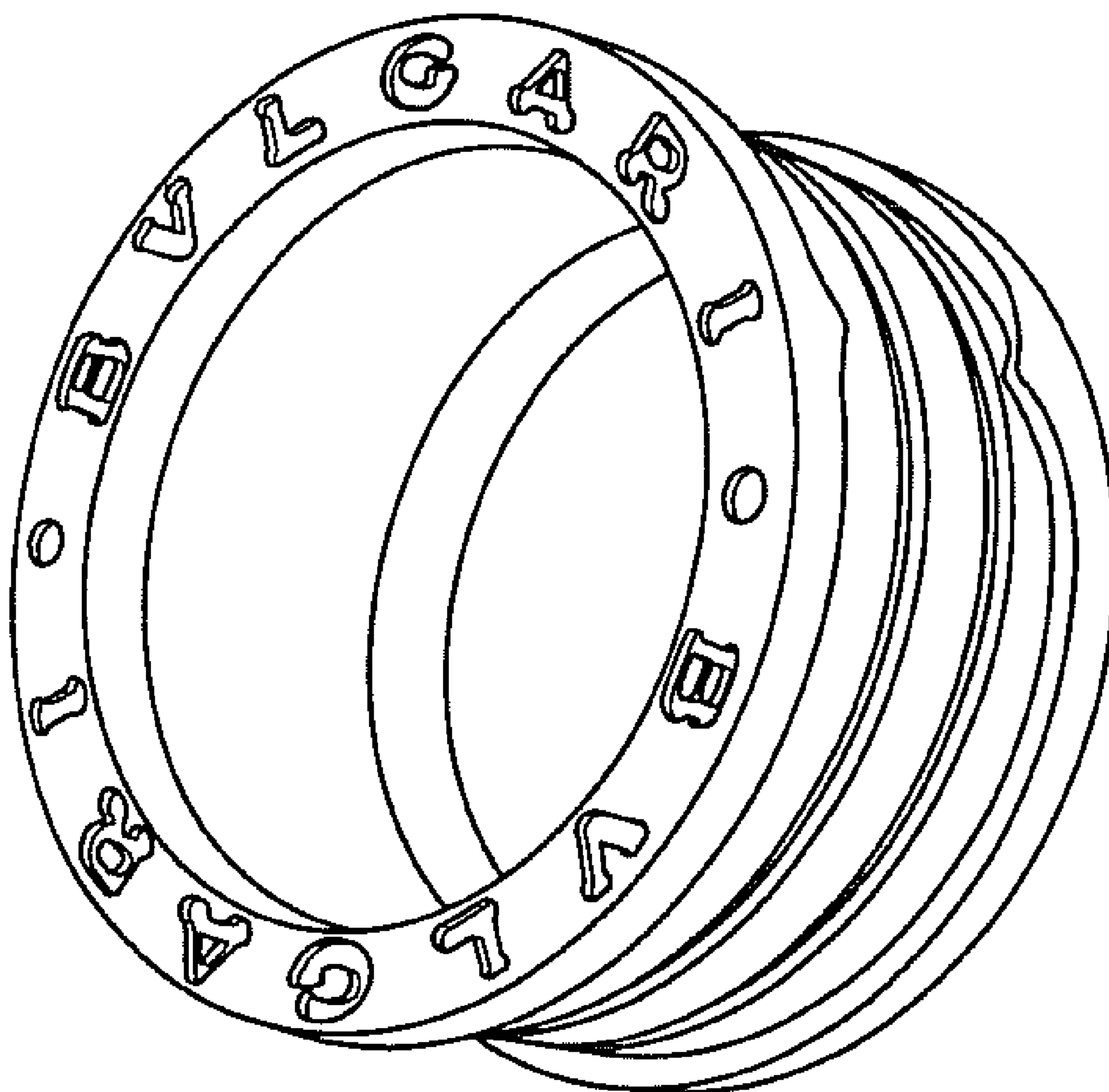
FIG. 4 shows a right side view of the ring;

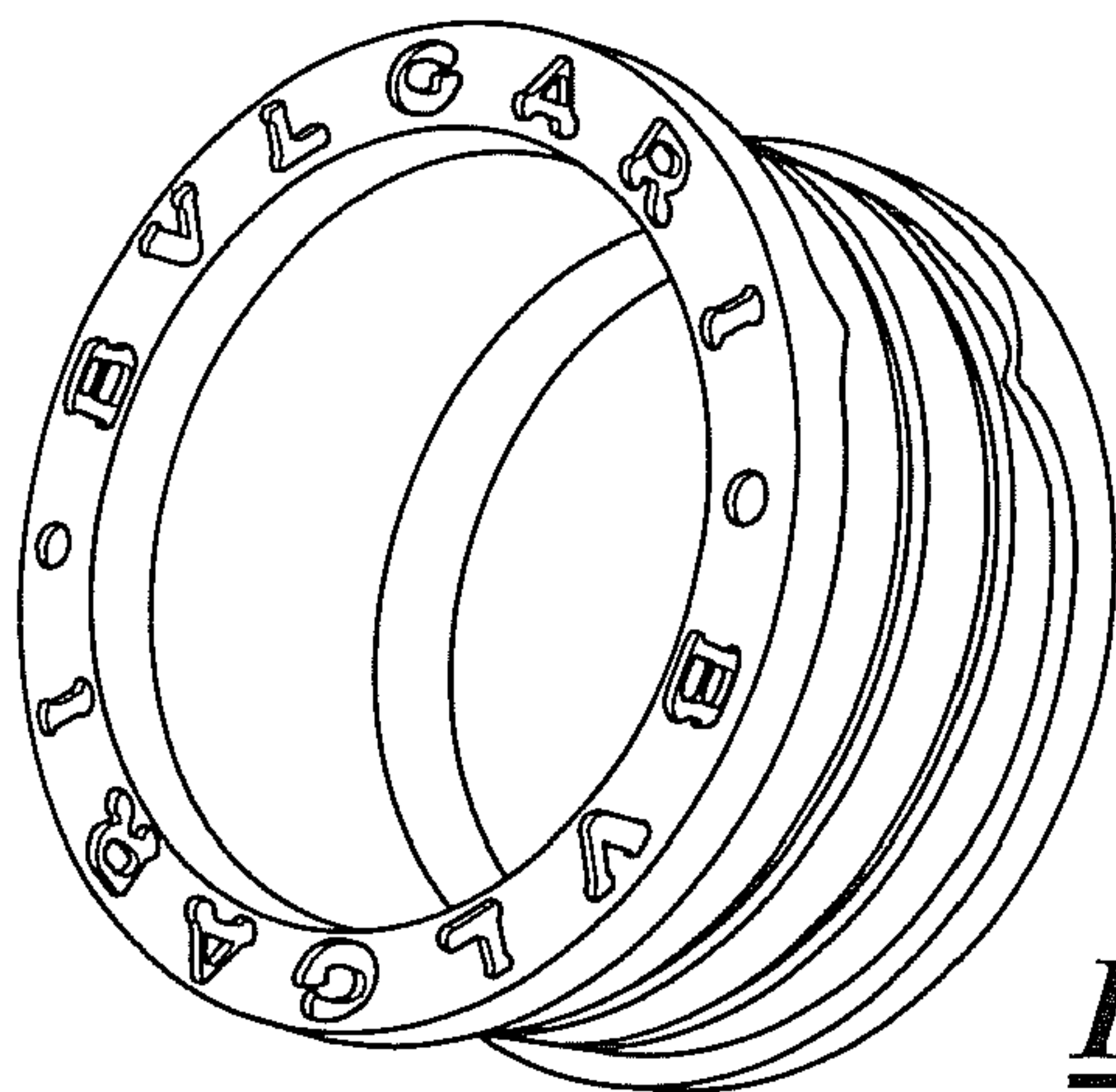

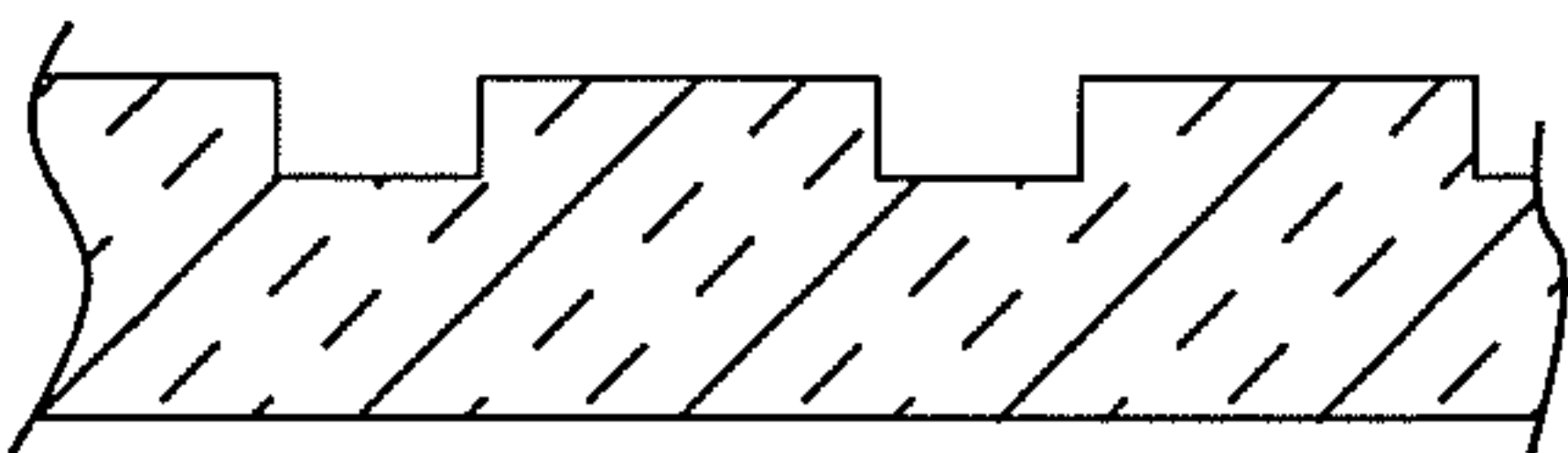

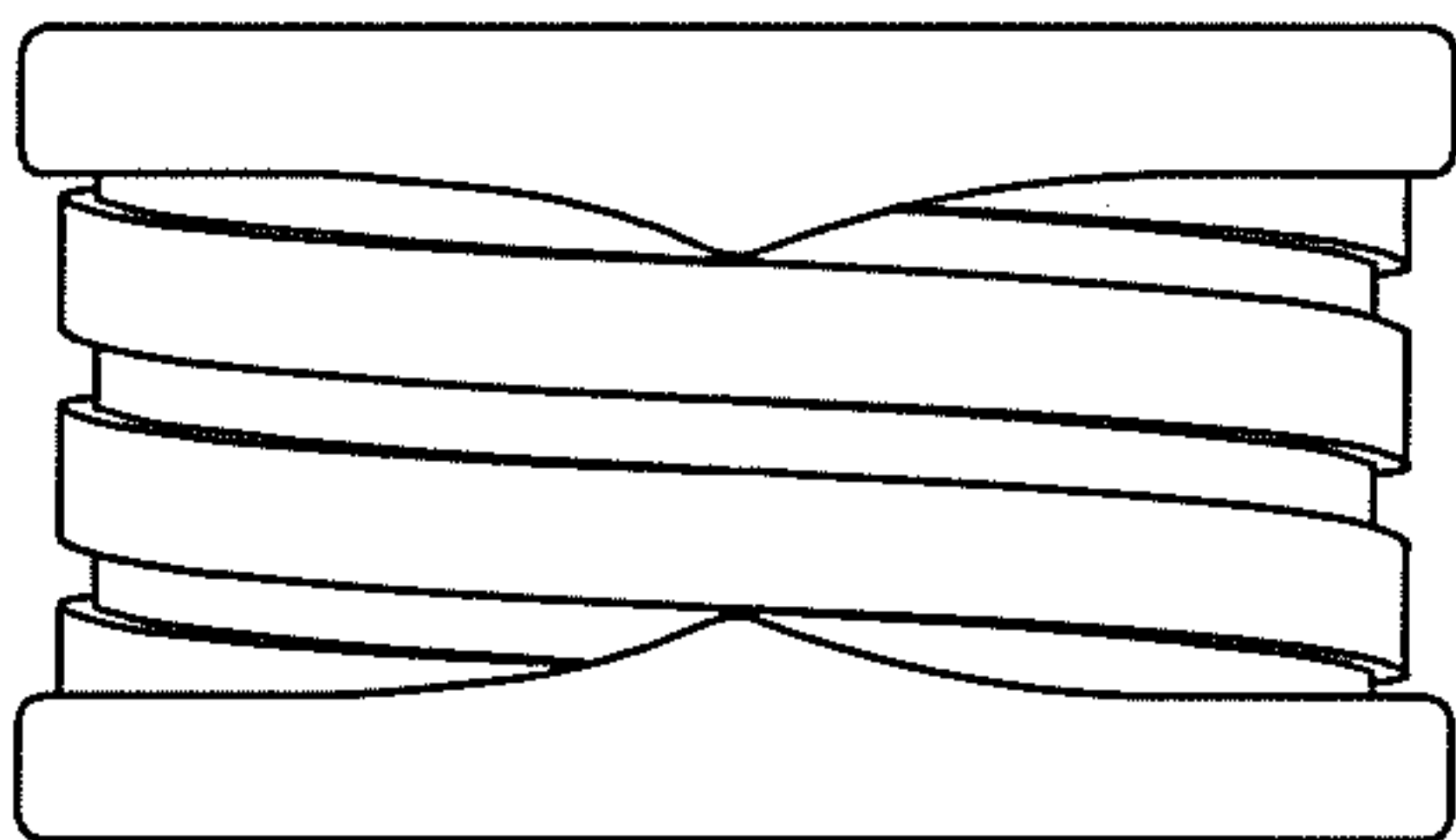

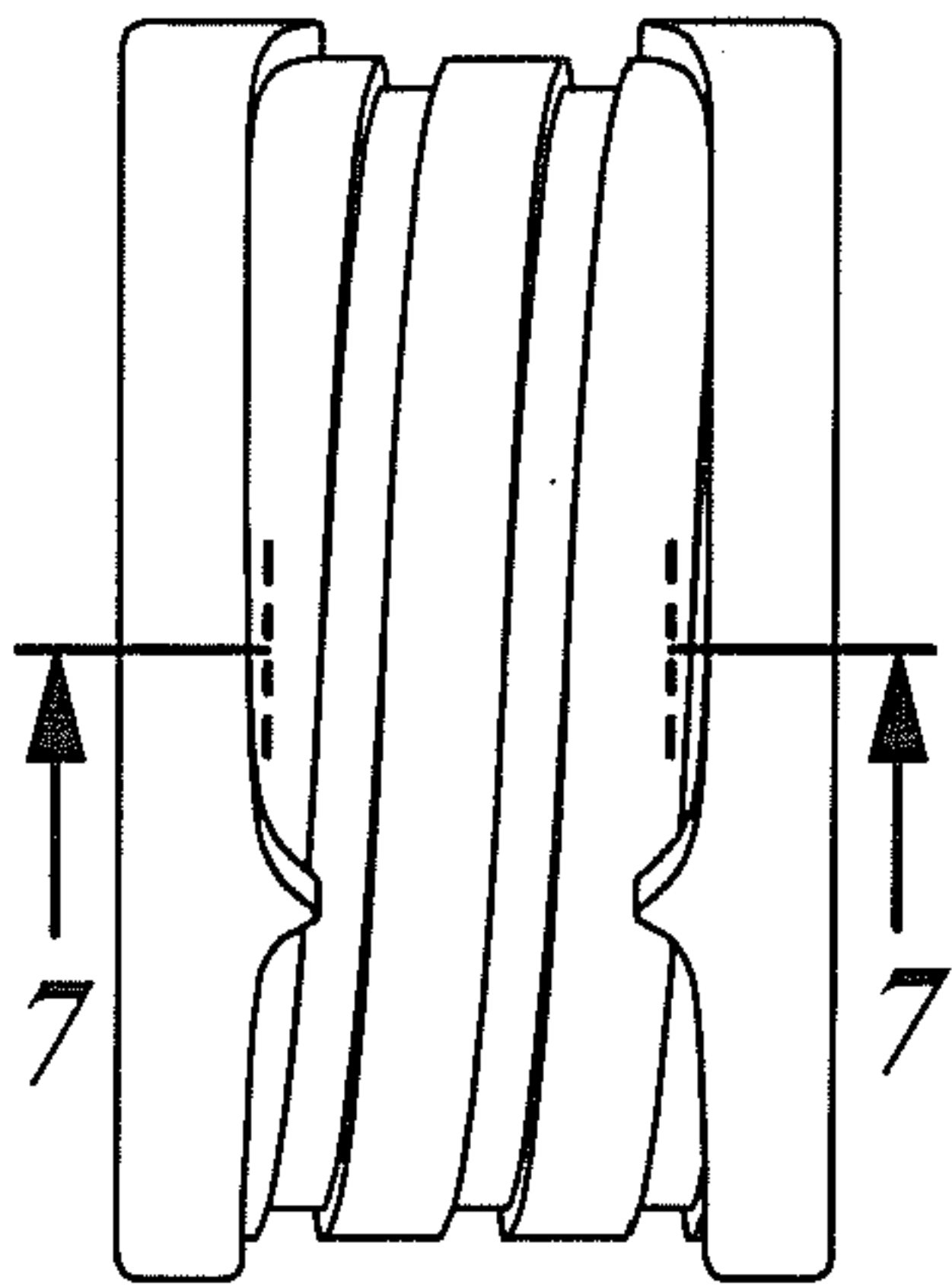

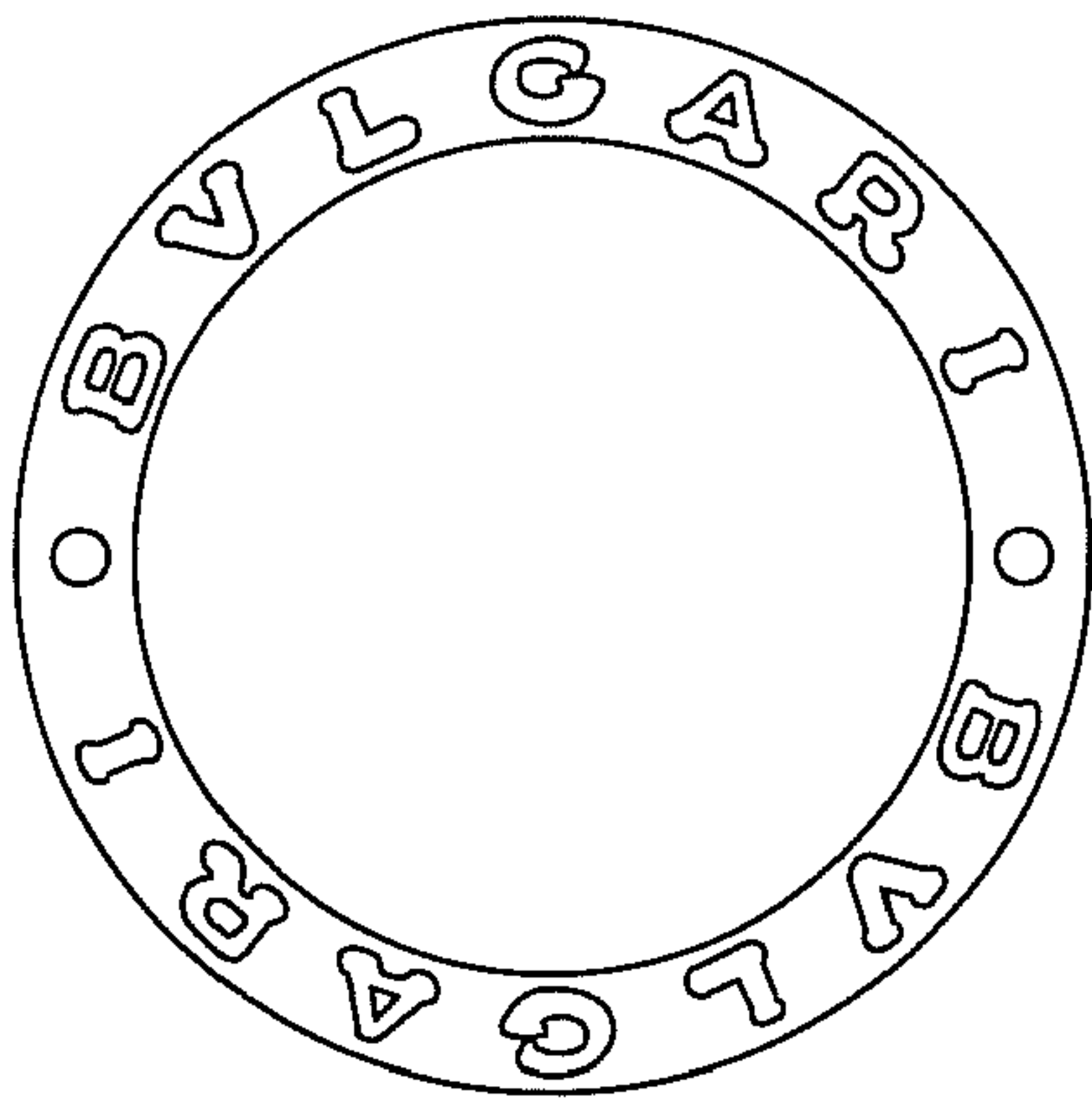

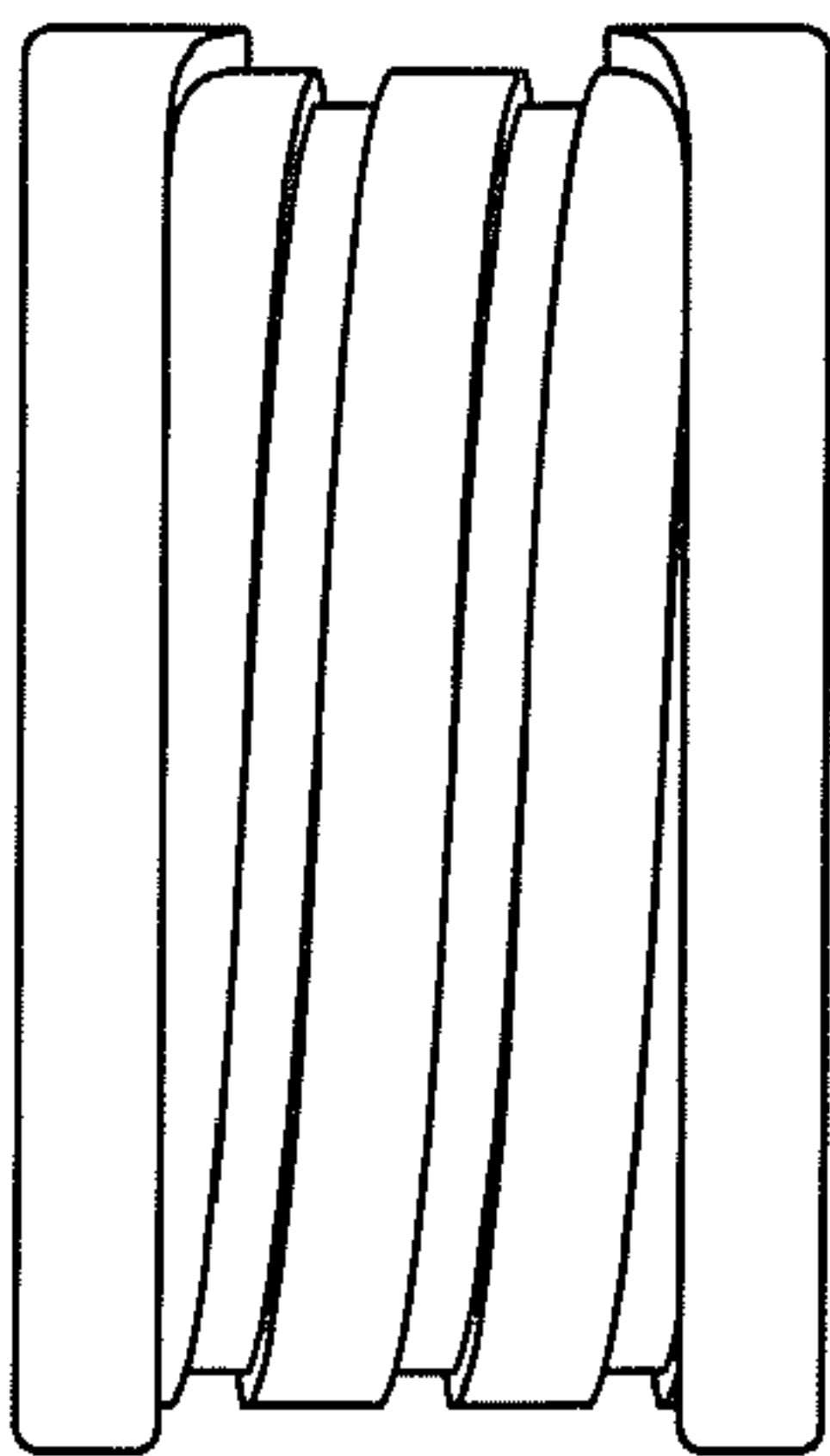

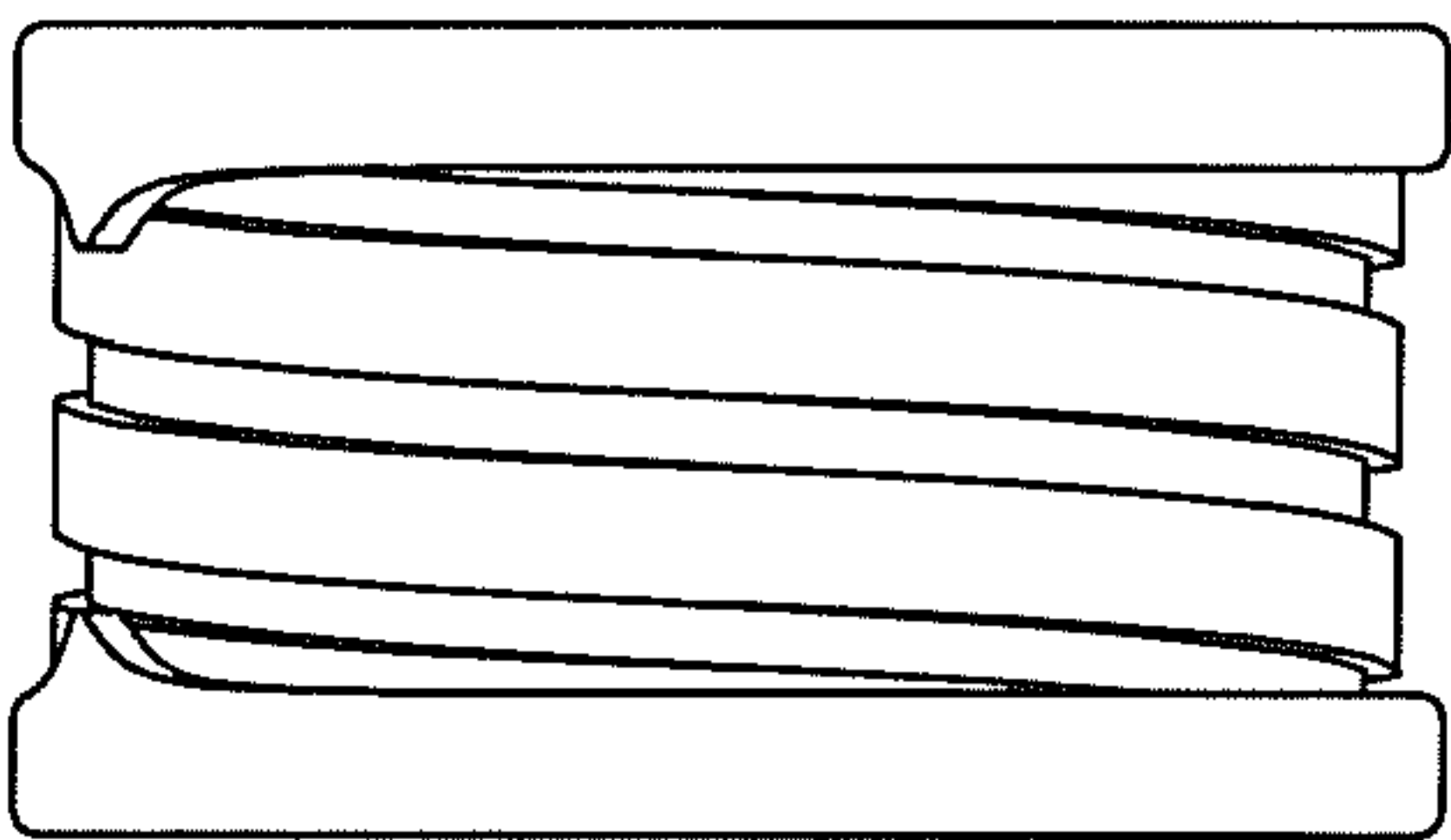
