FIG. 4 is a side view thereof

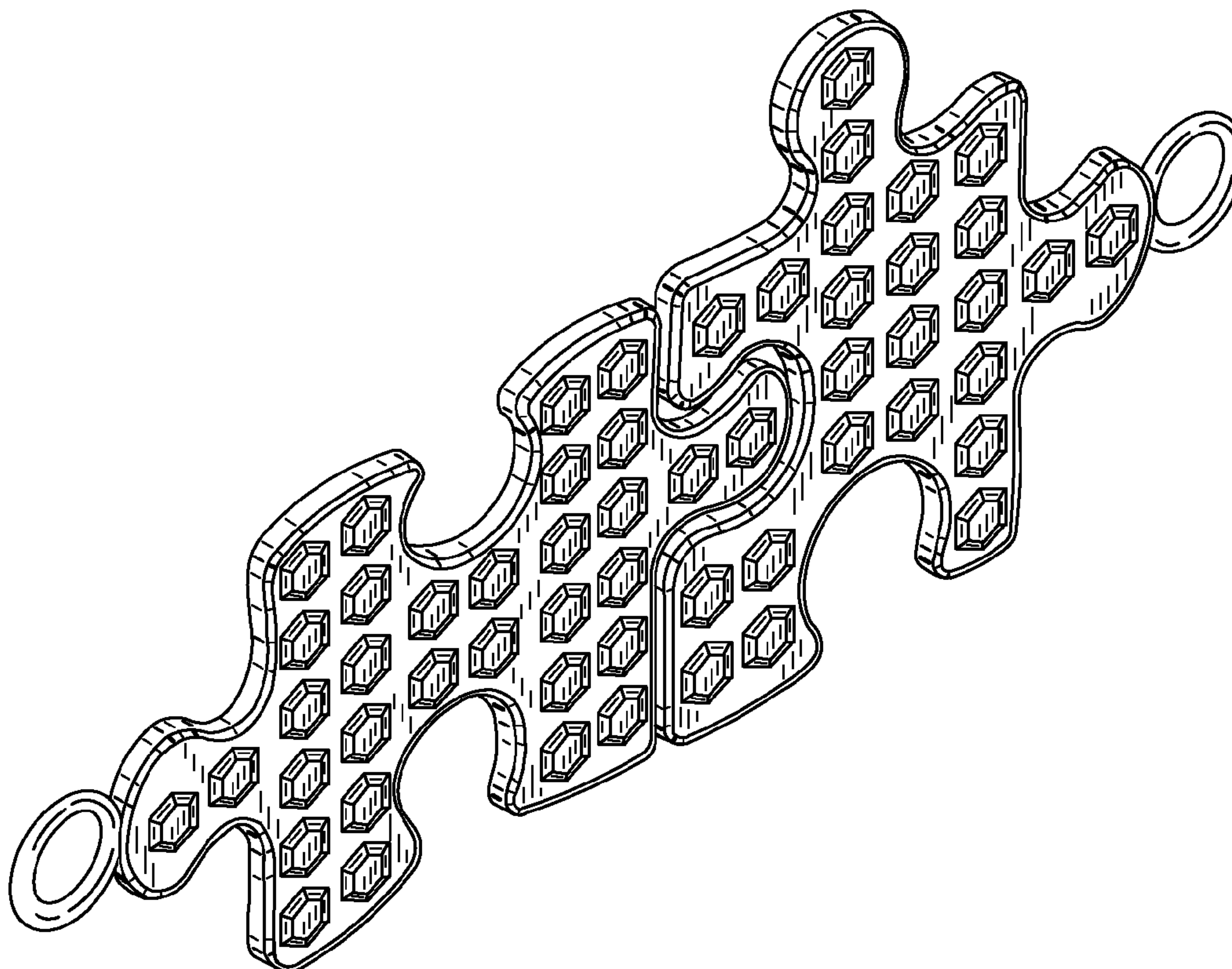
FIG. 5 is a profile view thereof;

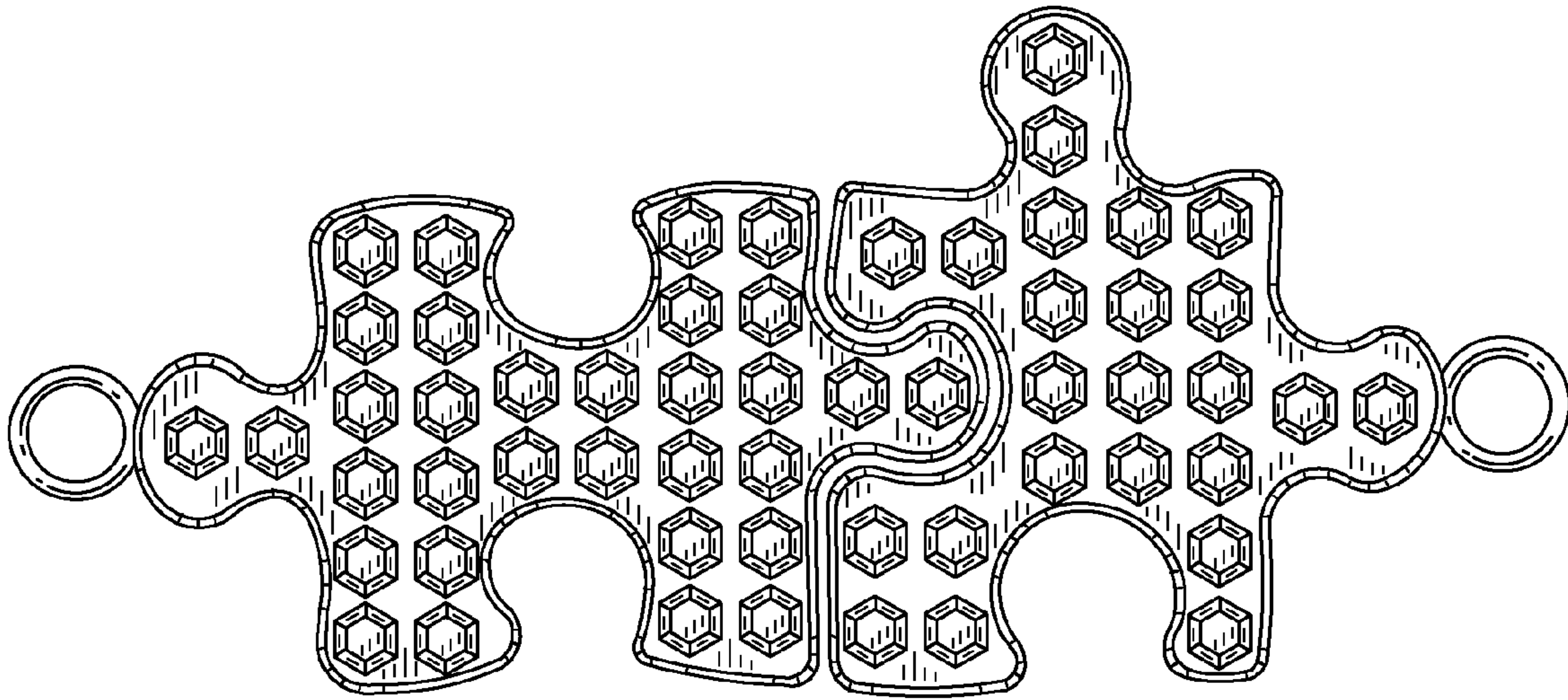

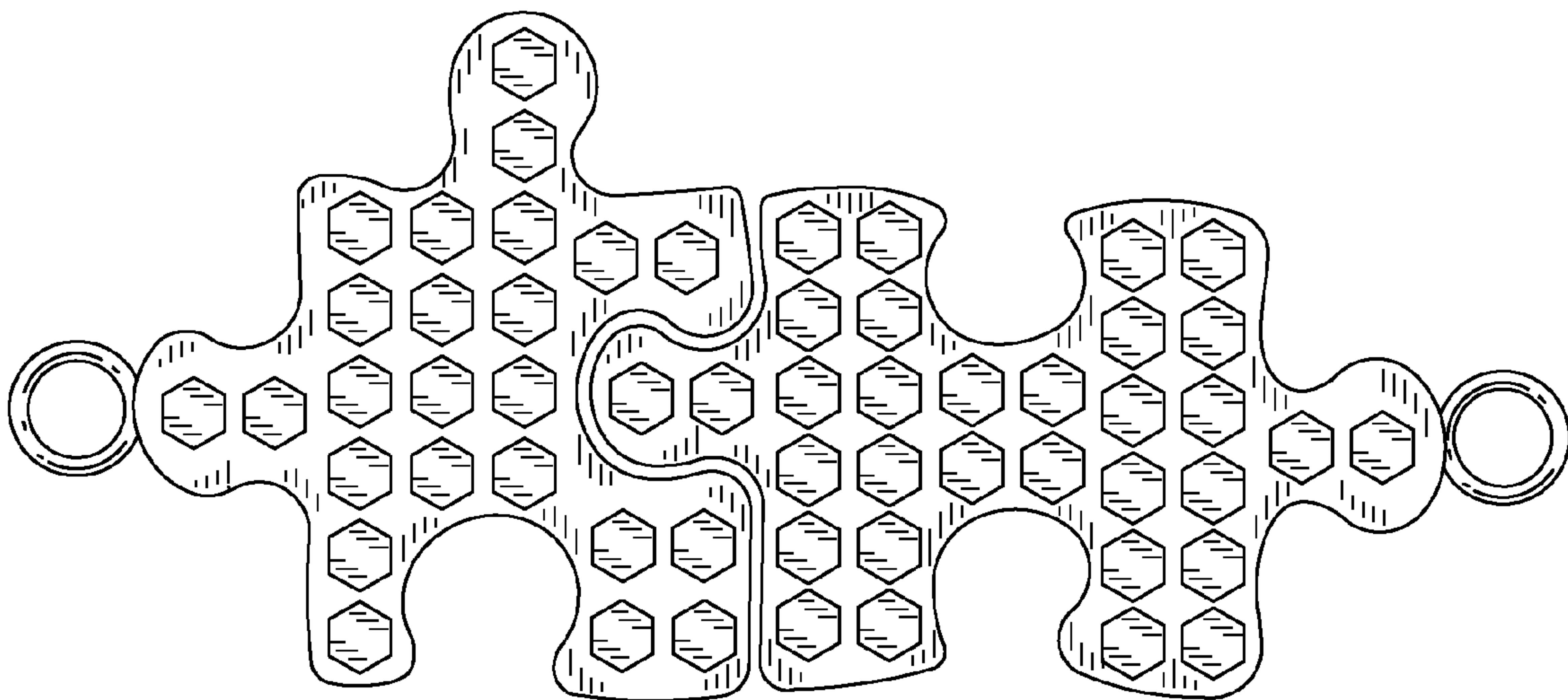

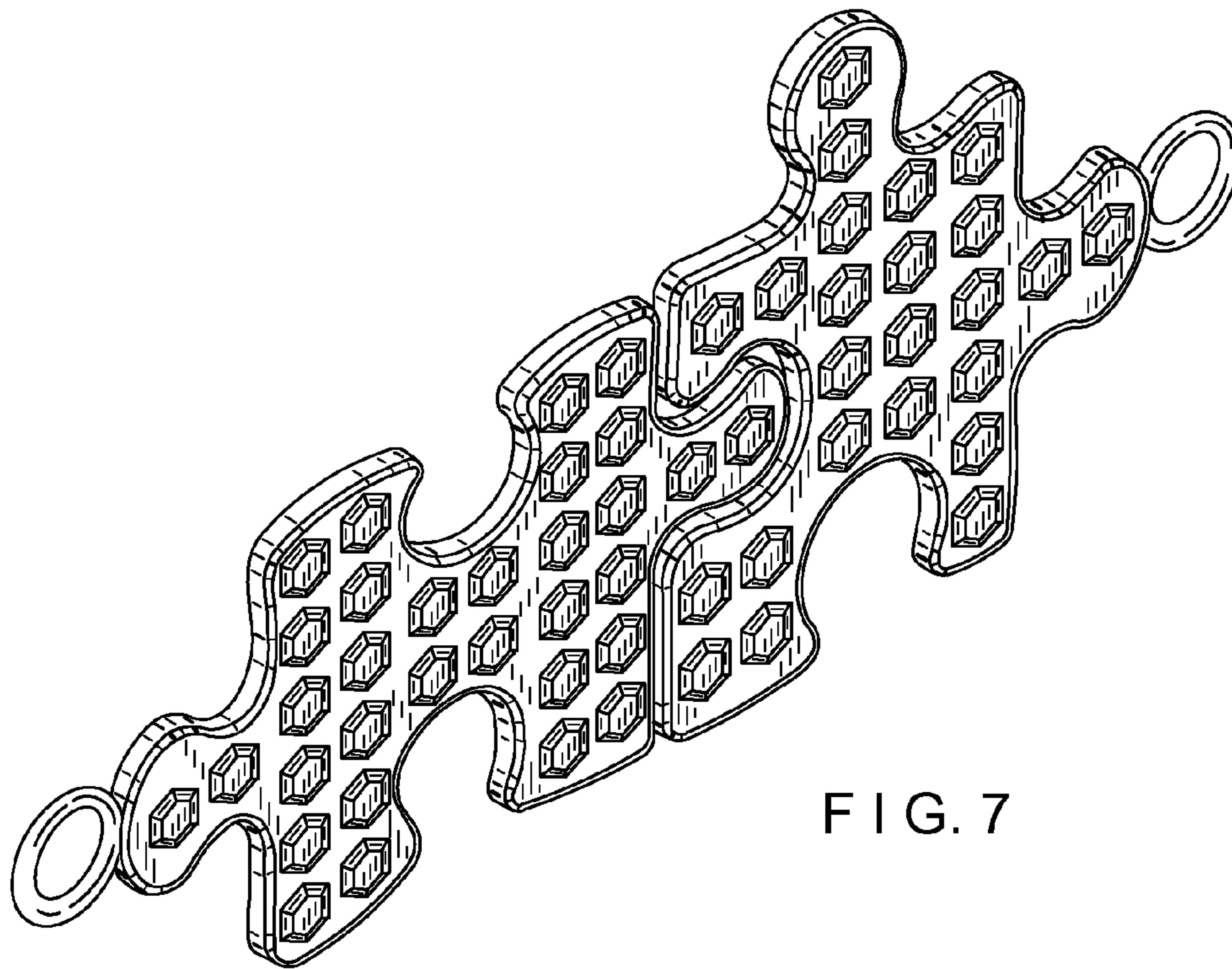

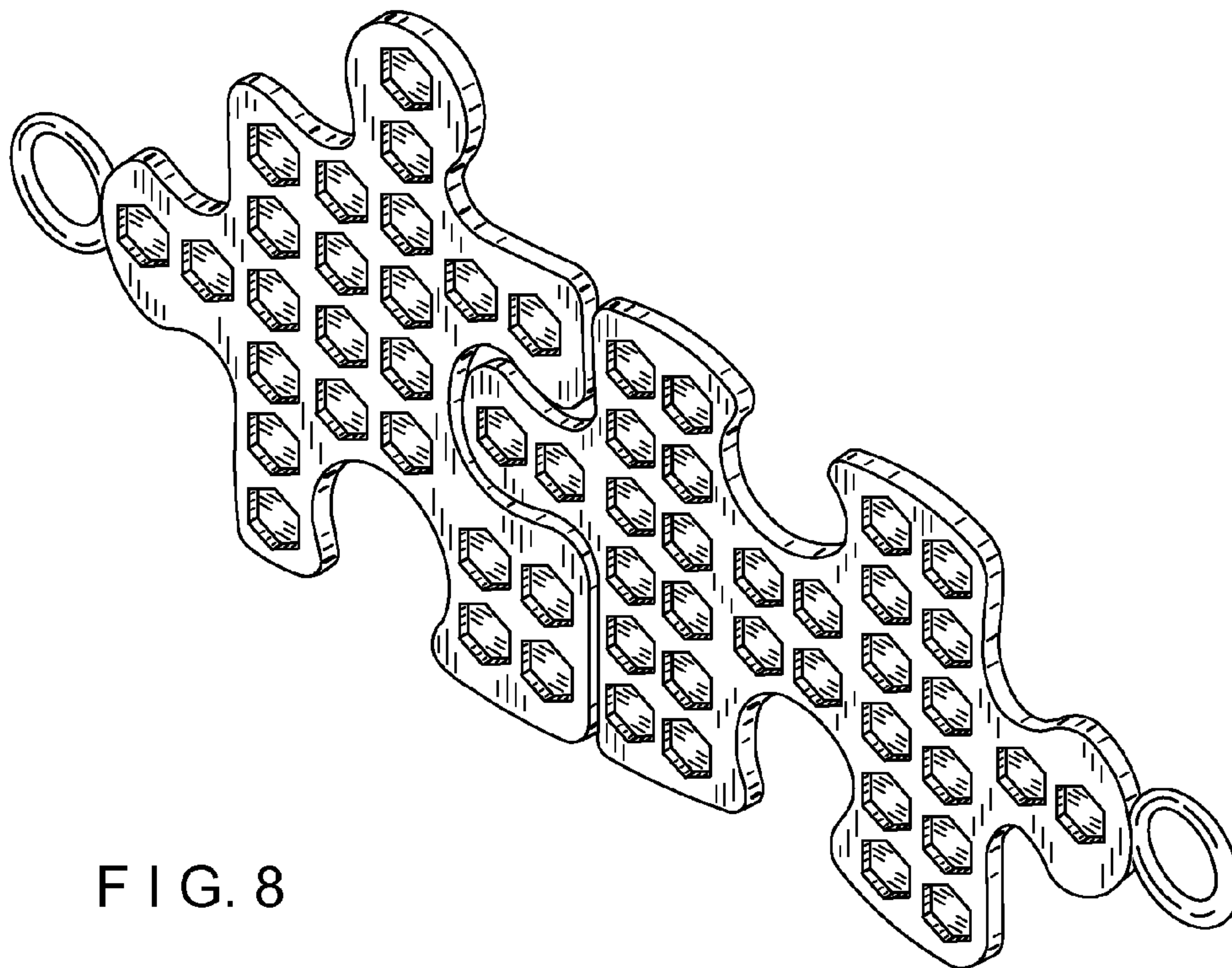
