FIG. 1 is a front perspective view of a front bumper for an automobile of our new design;

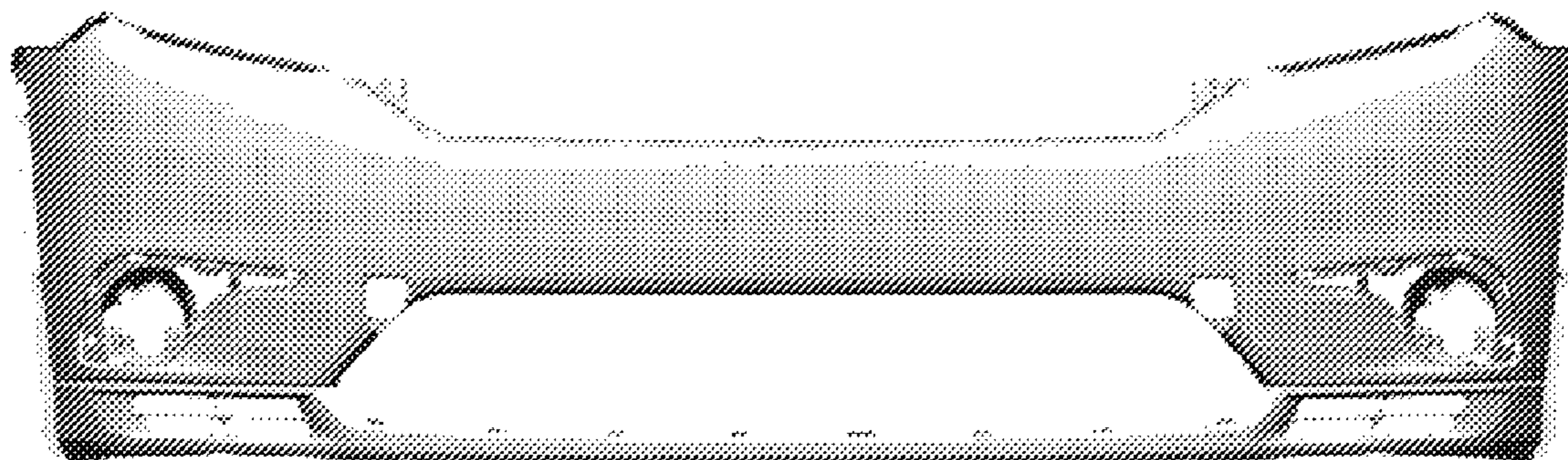
FIG. 2 is a front view thereof;

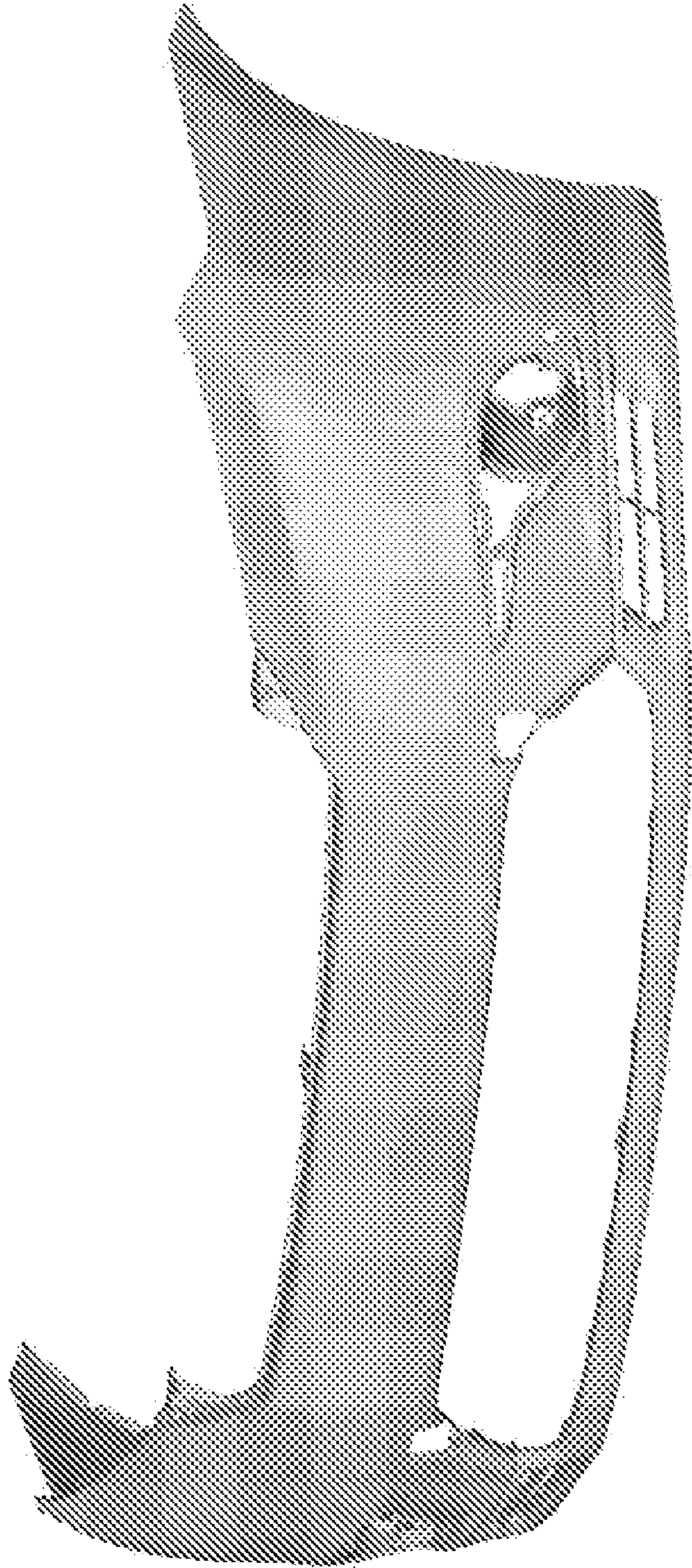

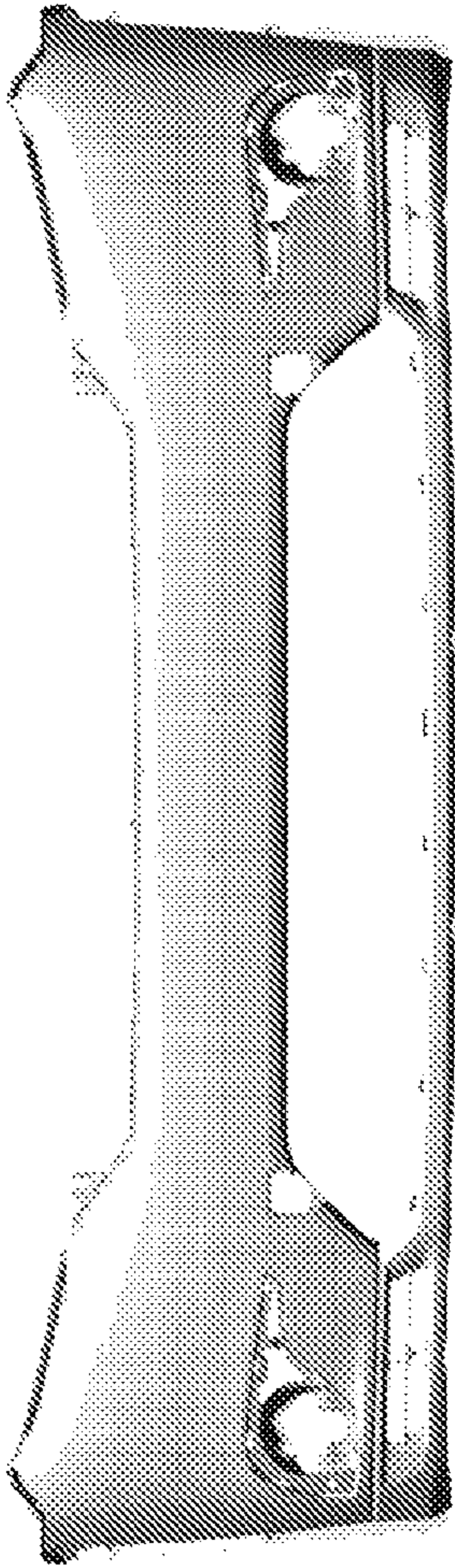

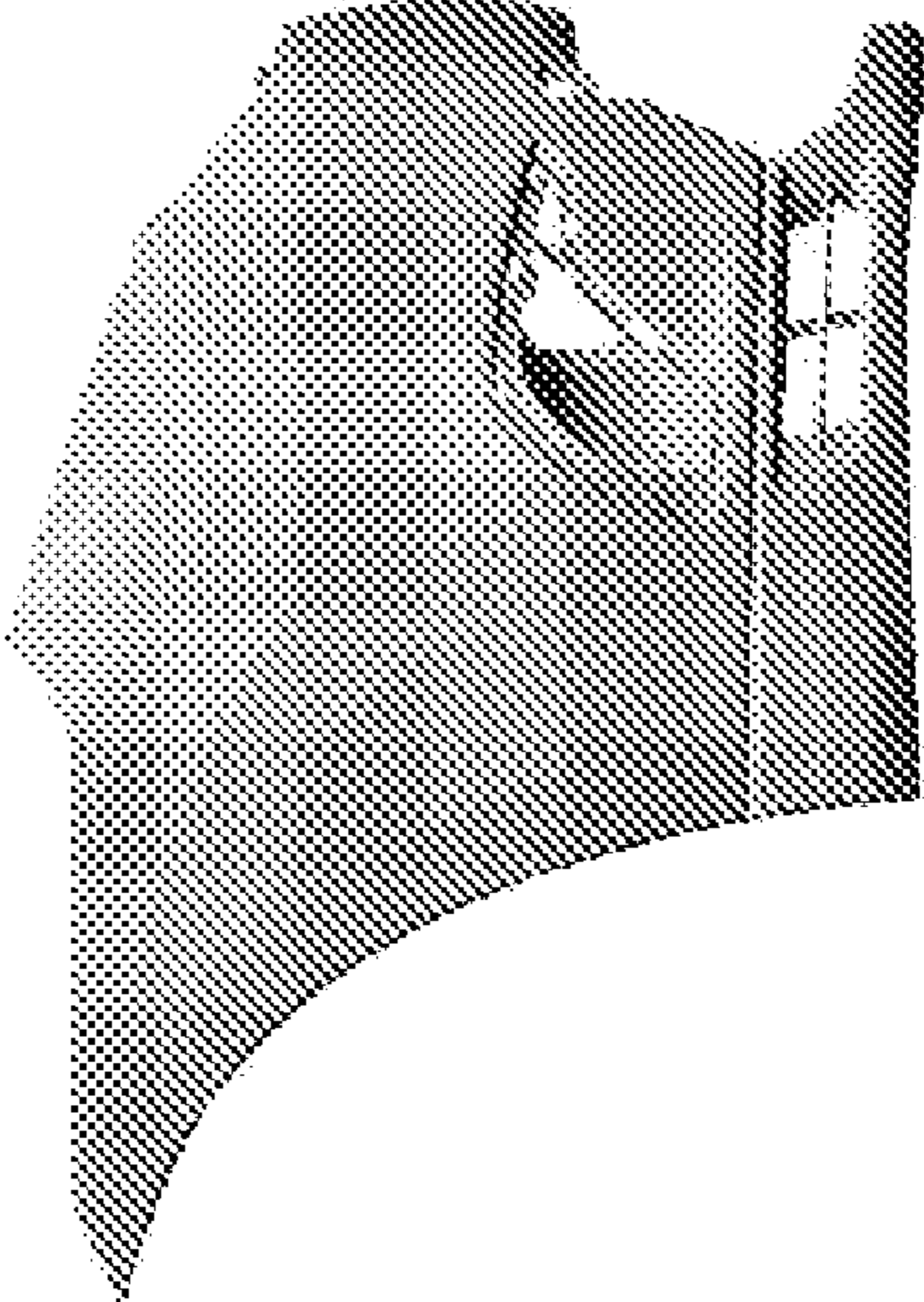

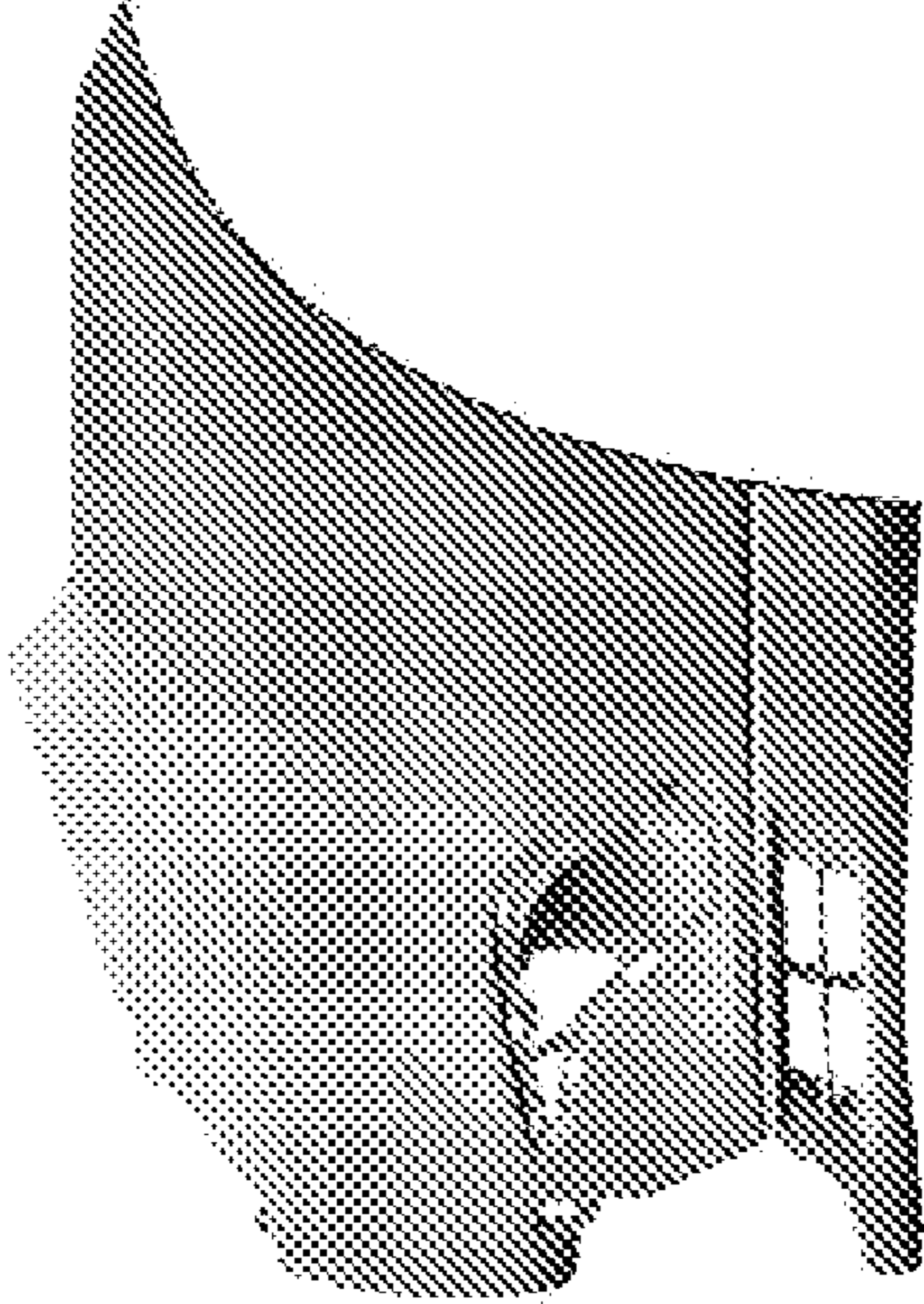
