(57) **CLAIM**

The ornamental design for a vehicle radiator cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view illustrating one embodiment of a vehicle radiator cover embodying my new design with broken lines forming no part of the claimed design;

FIG. 2 is a top plan view illustrating the embodiment shown in FIG. 1 of a vehicle radiator cover embodying my new design;

FIG. 3 is a bottom plan view illustrating the embodiment shown in FIG. 1 of a vehicle radiator cover embodying my new design;

FIG. 4 is a perspective view illustrating a left side portion the embodiment shown in FIG. 1 of a vehicle radiator cover embodying my new design;

FIG. 5 is a perspective view illustrating a right side portion the embodiment shown in FIG. 1 of a vehicle radiator cover embodying my new design;

FIG. 6 is a right side view illustrating the embodiment shown in FIG. 1 of a vehicle radiator cover embodying my new design;

FIG. 7 is a left side view illustrating the embodiment shown in FIG. 1 of a vehicle radiator cover embodying my new design;

FIG. 8 is a top plan view illustrating a second embodiment of a vehicle radiator cover embodying my new design;

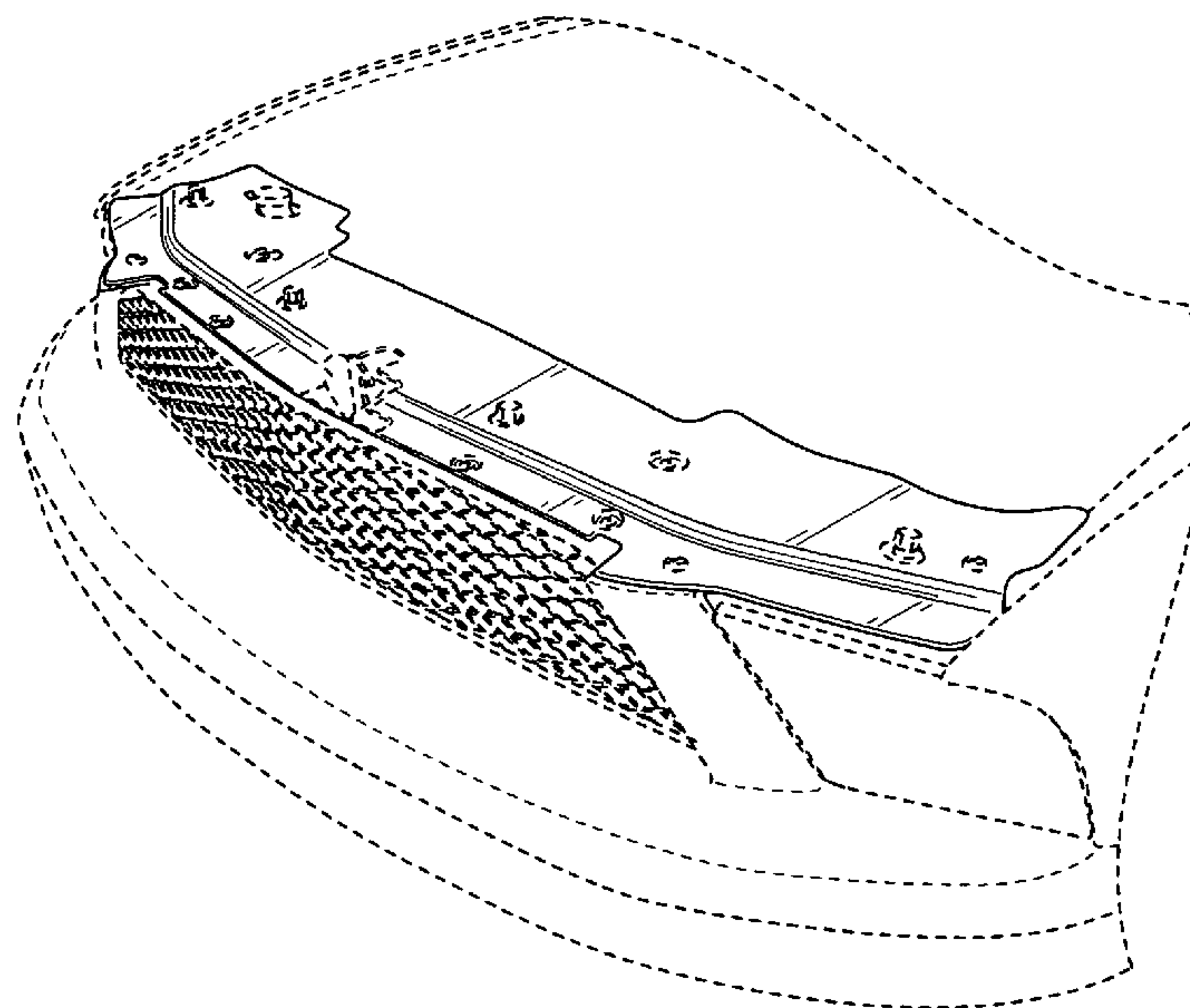
FIG. 9 is a perspective view illustrating a right side portion of the embodiment shown in FIG. 8 of a vehicle radiator cover embodying my new design; and,

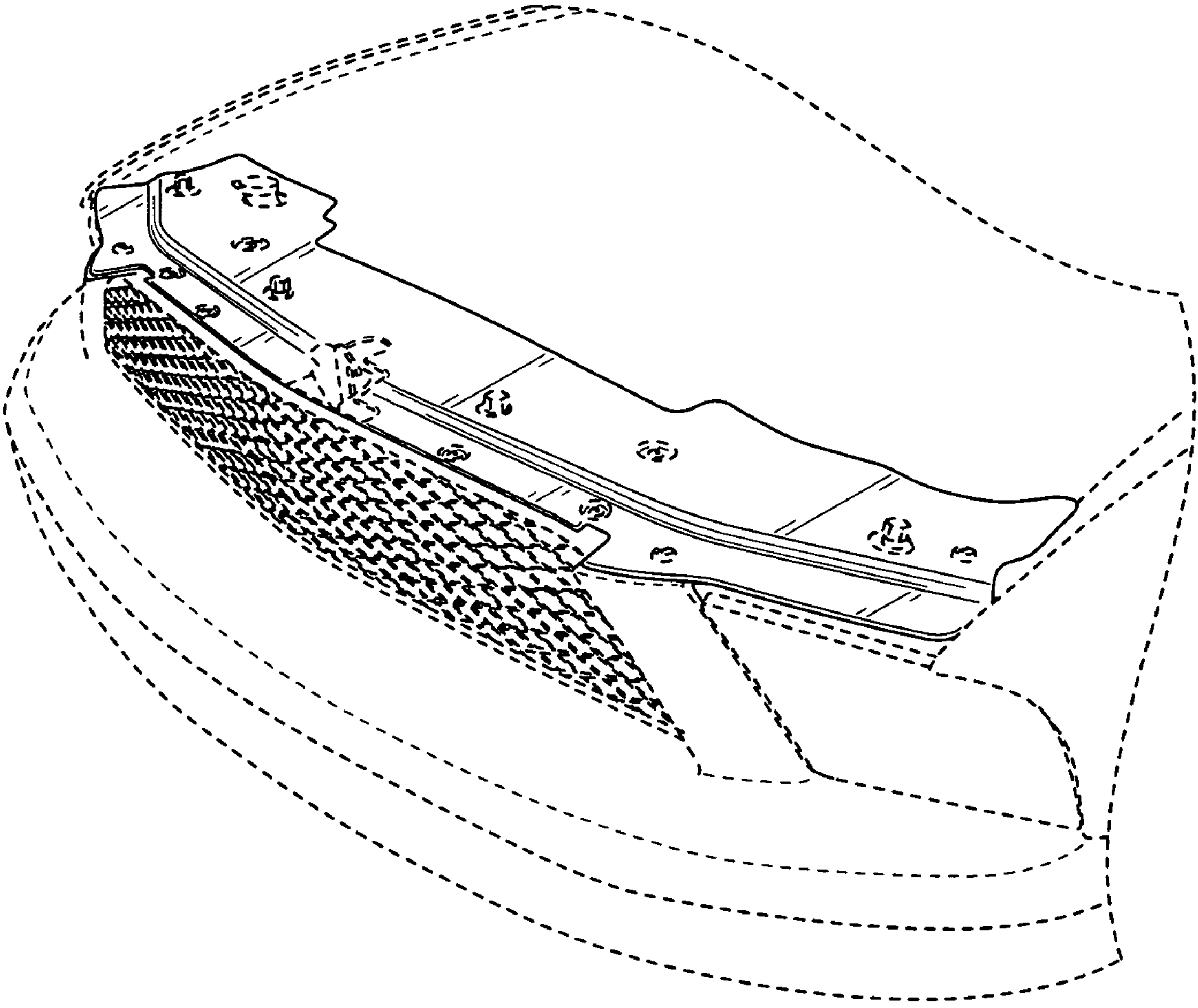

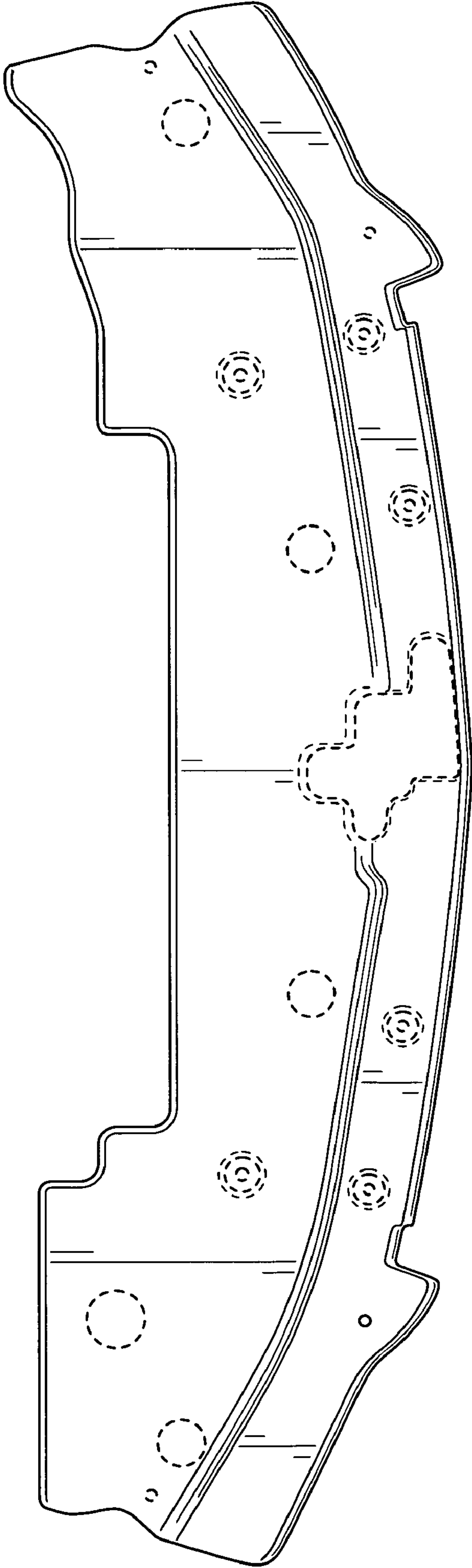

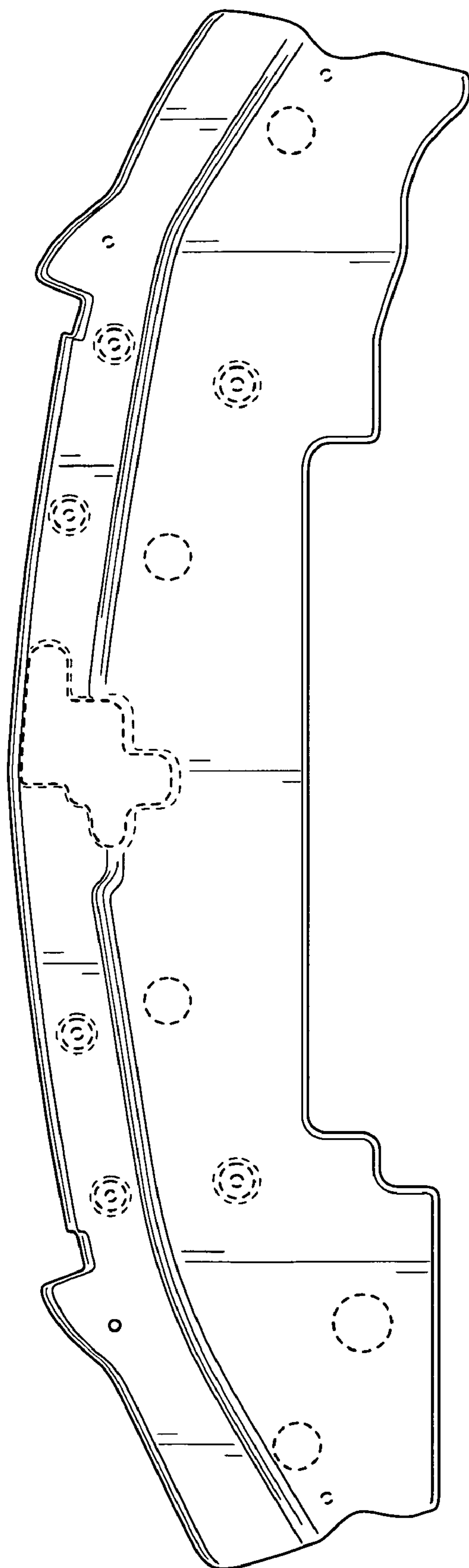

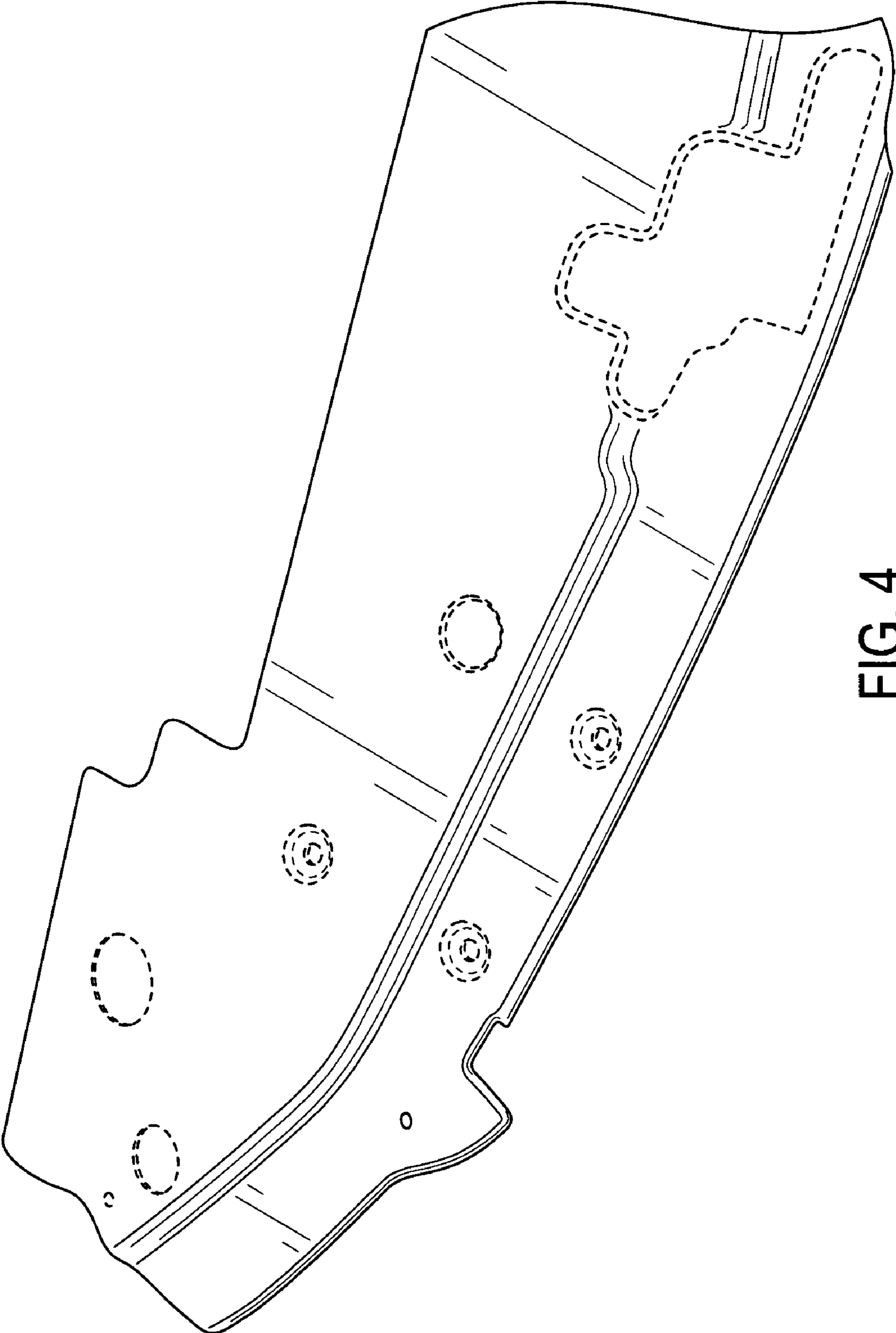

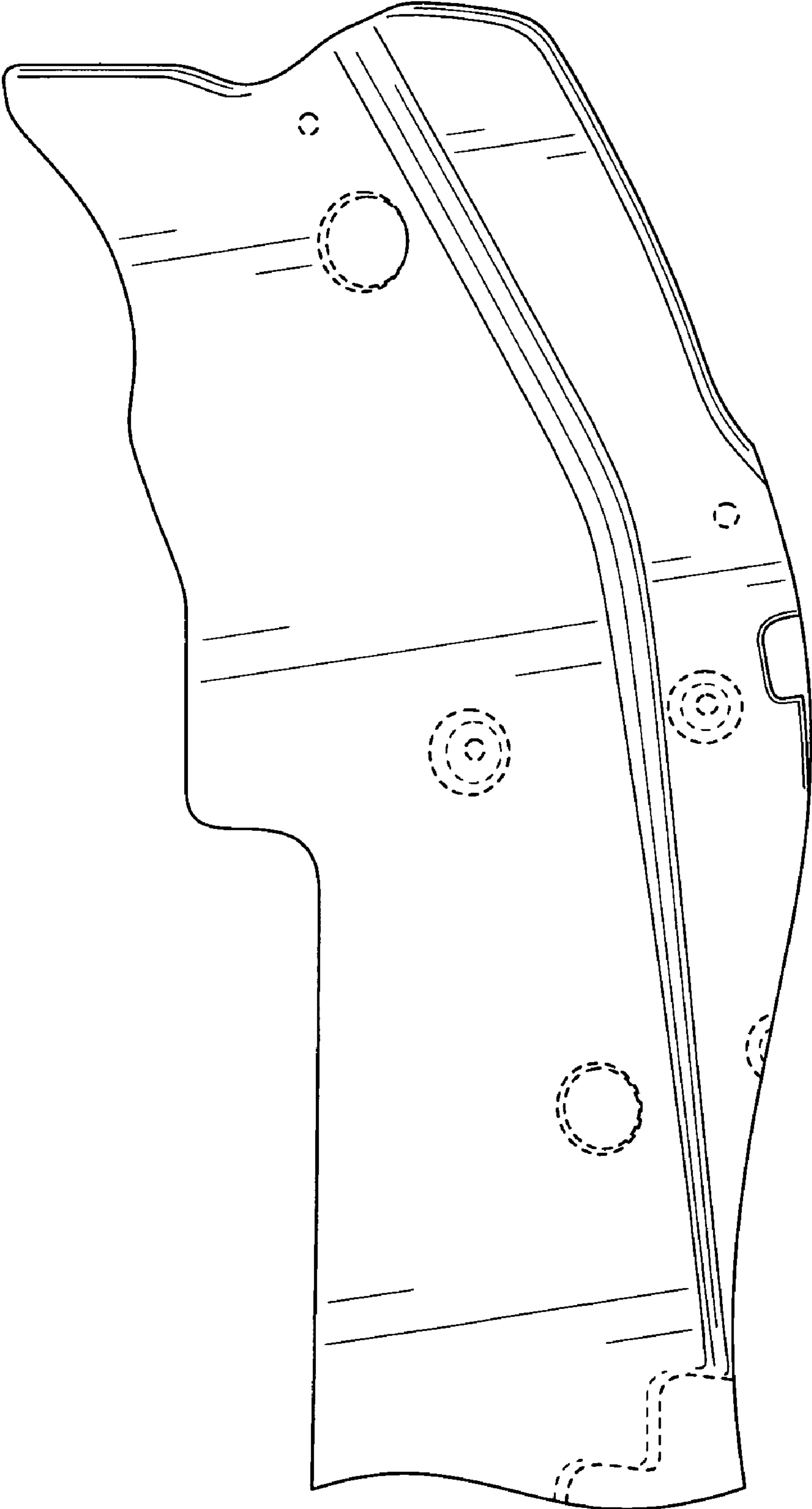

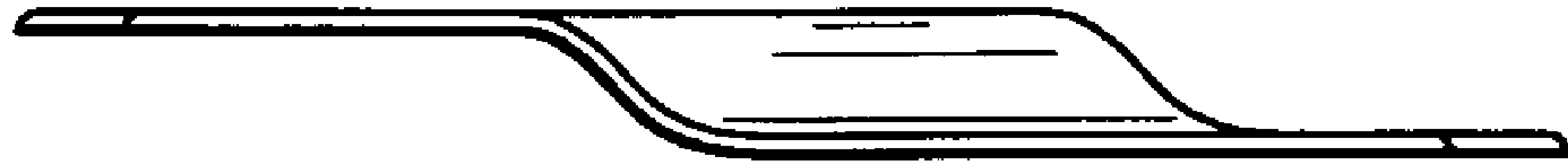

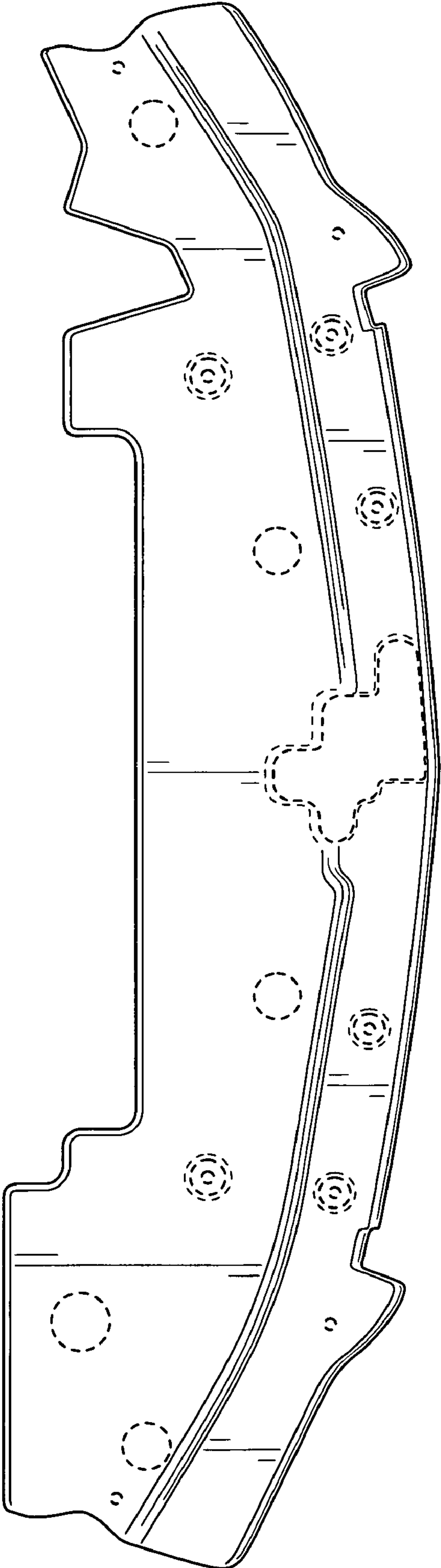

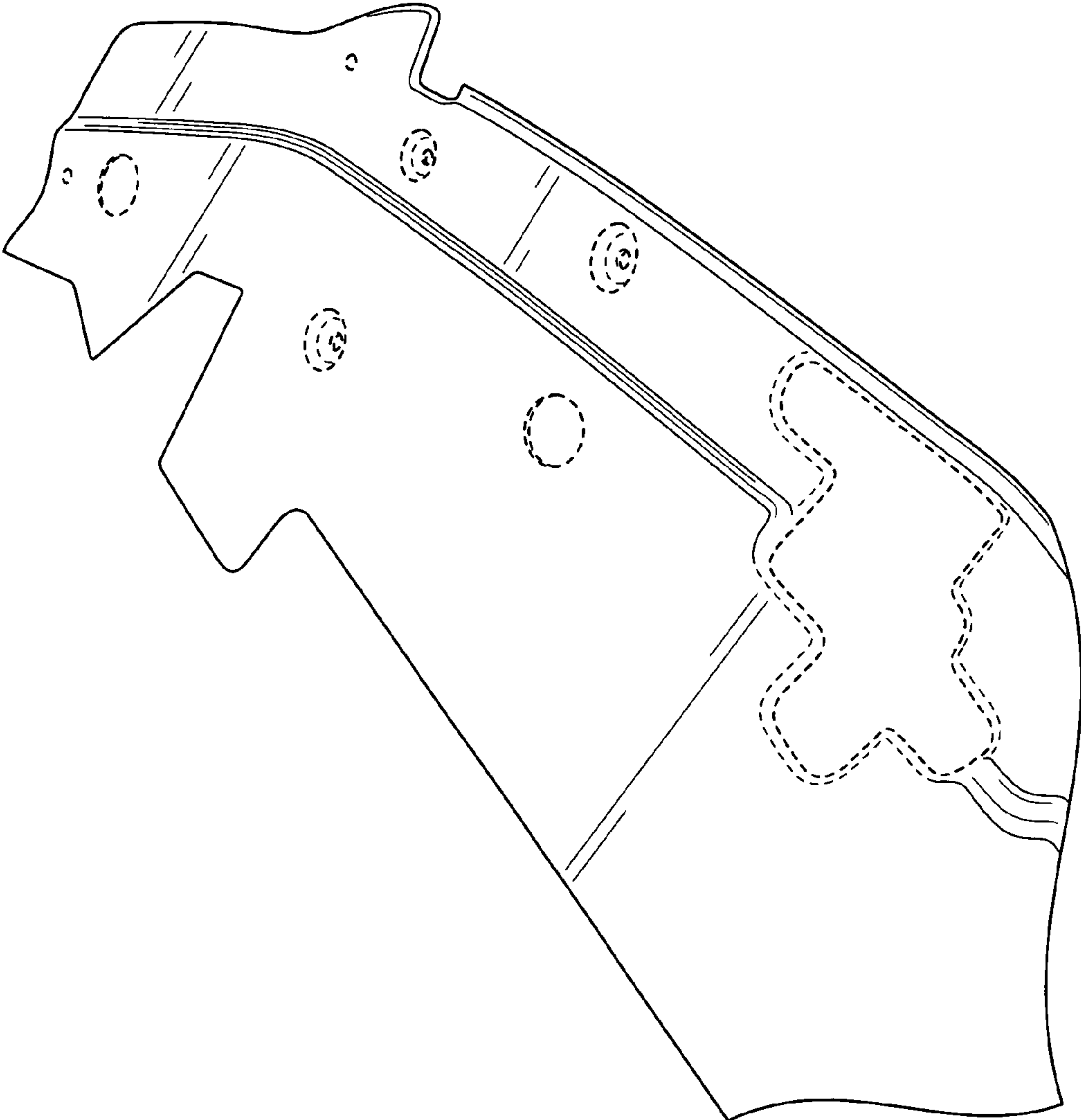

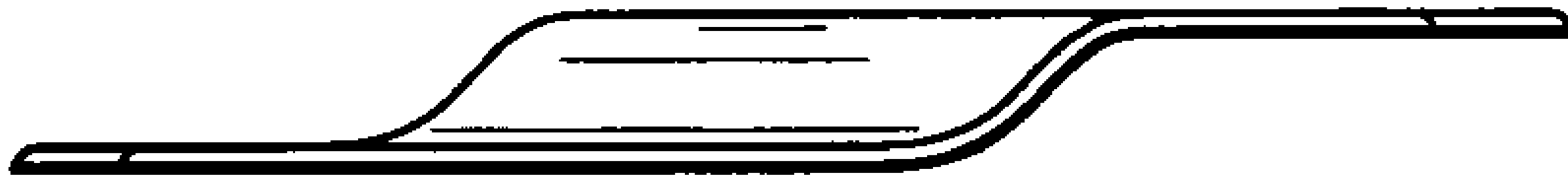
