(57) **CLAIM**

The ornamental design for a light emitting diode chip, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view 1 of a light emitting diode chip showing the new design;

FIG. 2 is a top perspective view 2 thereof;

FIG. 3 is a bottom perspective view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is a reference end view taken along line 8—8 in FIG. 6;

FIG. 9 is an enlarged view of a portion 9 in FIG. 8; and,

FIG. 10 is an enlarged view of a portion 10 in FIG. 8.

Since the rear view is identical to the front view, the rear view is omitted.

Since the left side view is identical to the right side view, the left side view is omitted.

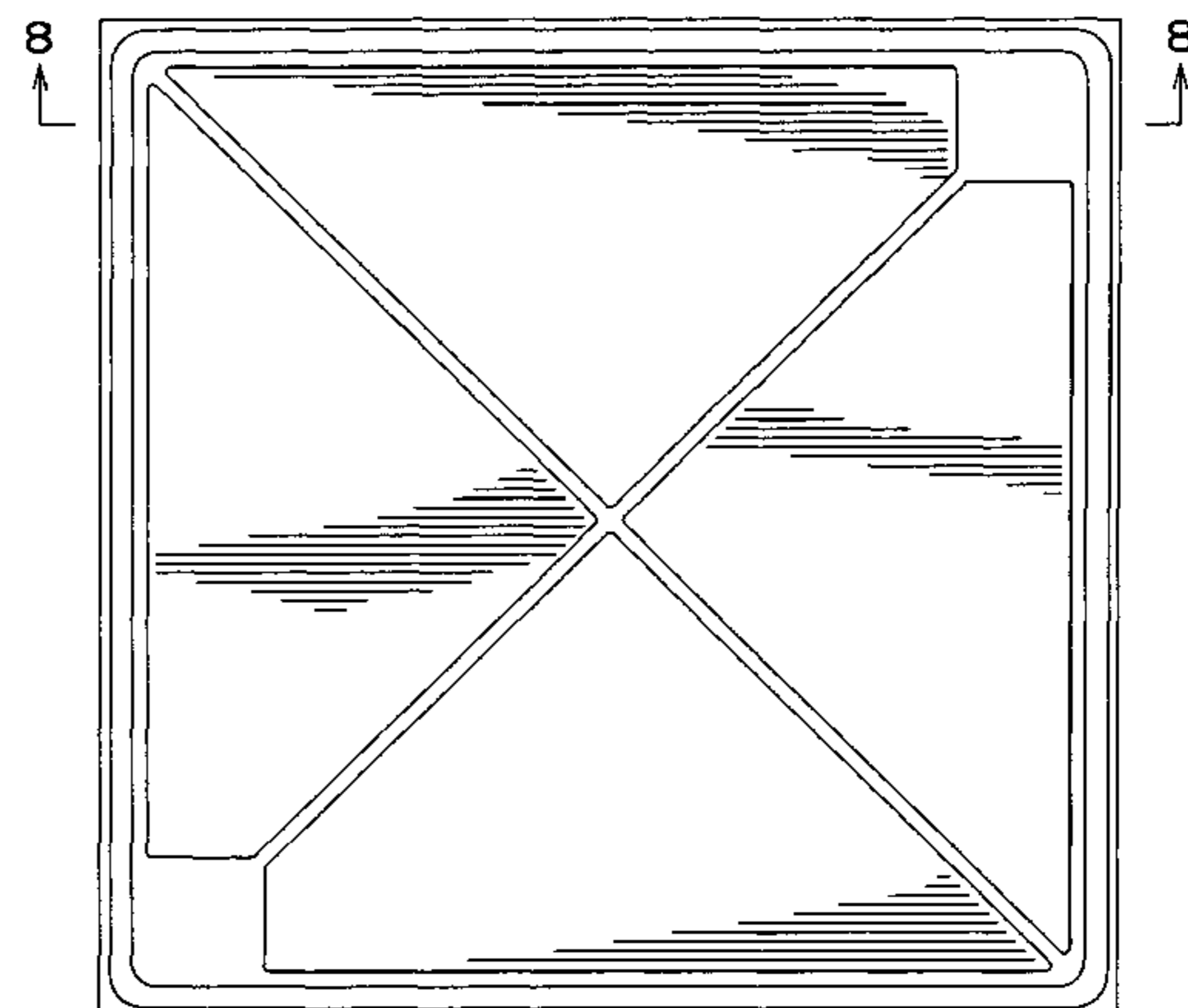
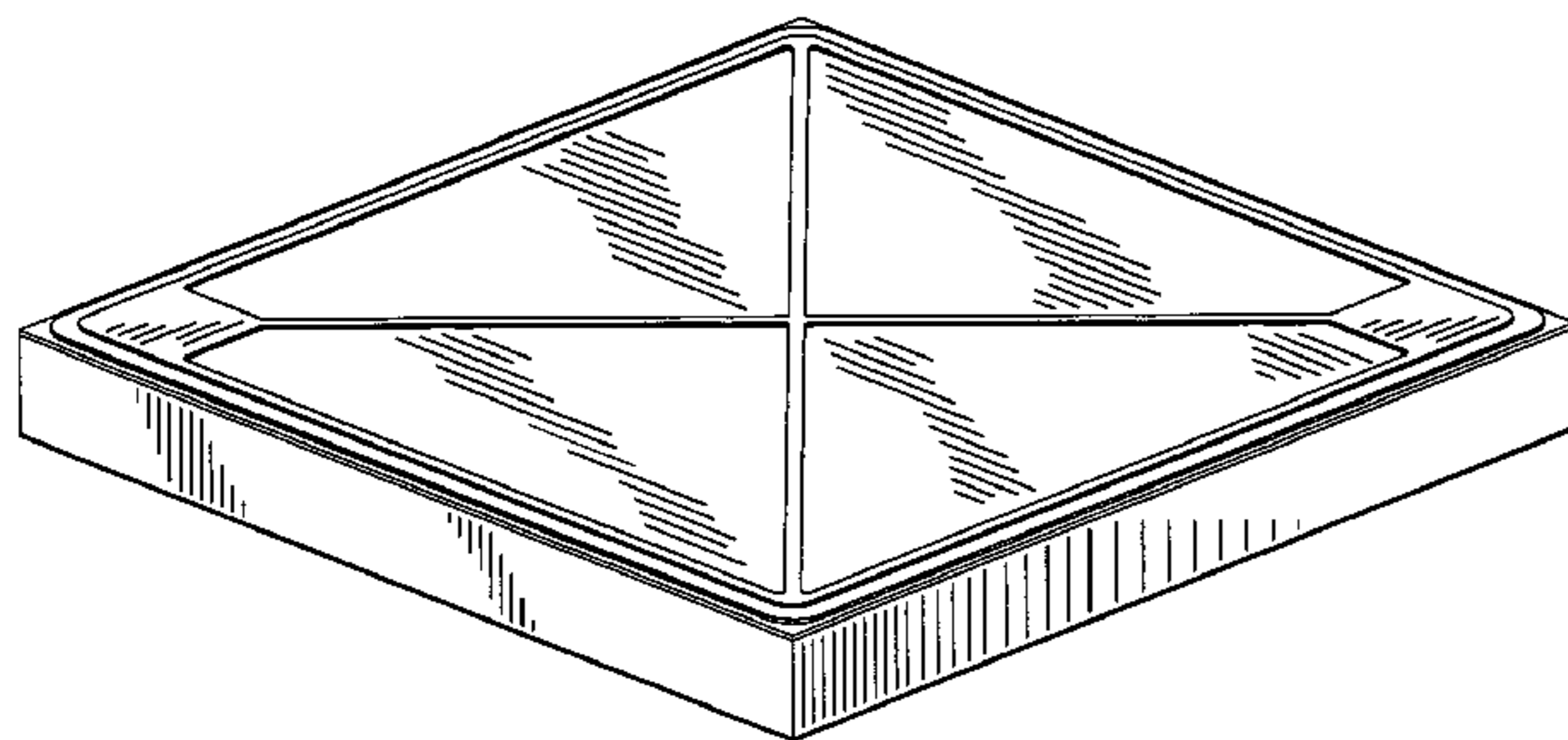

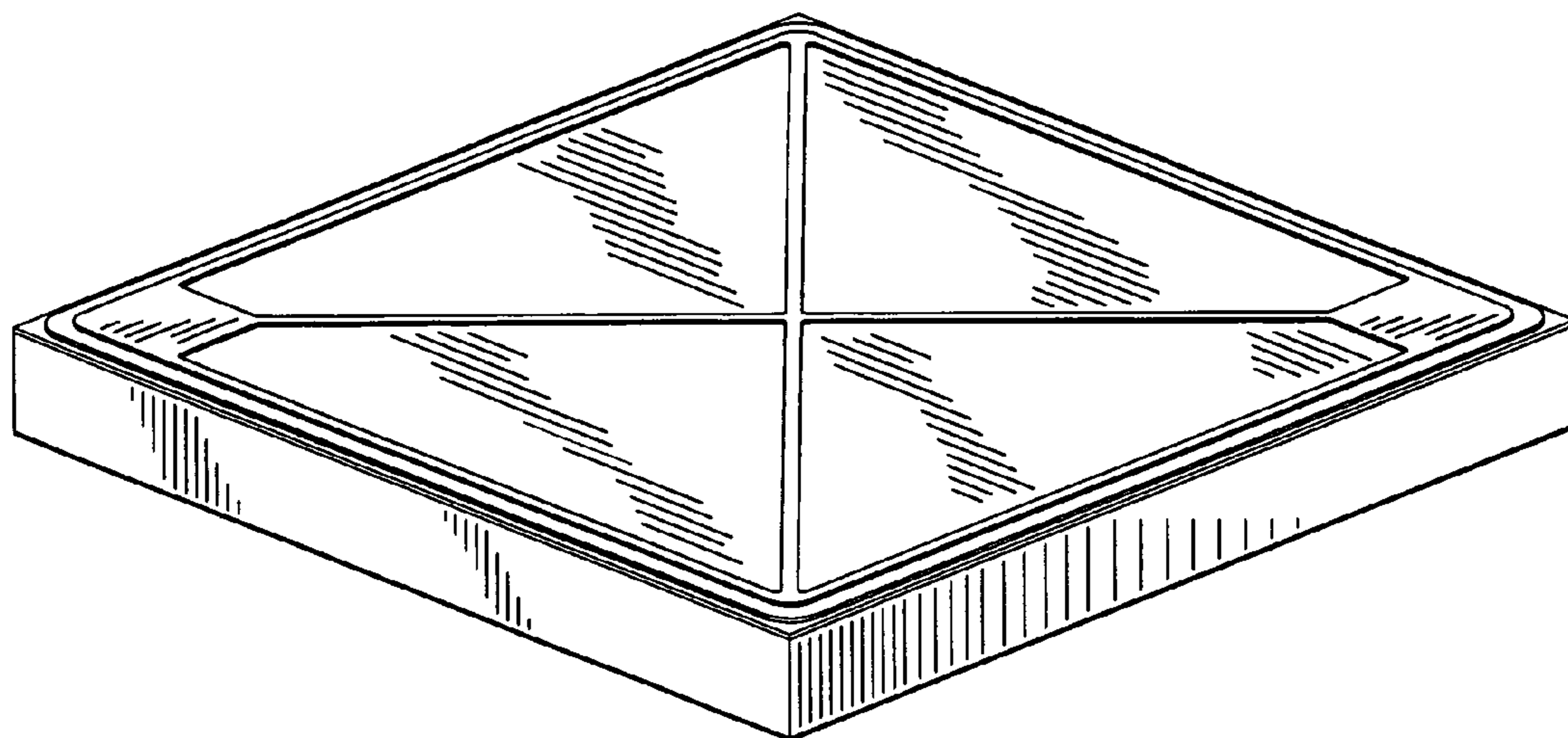

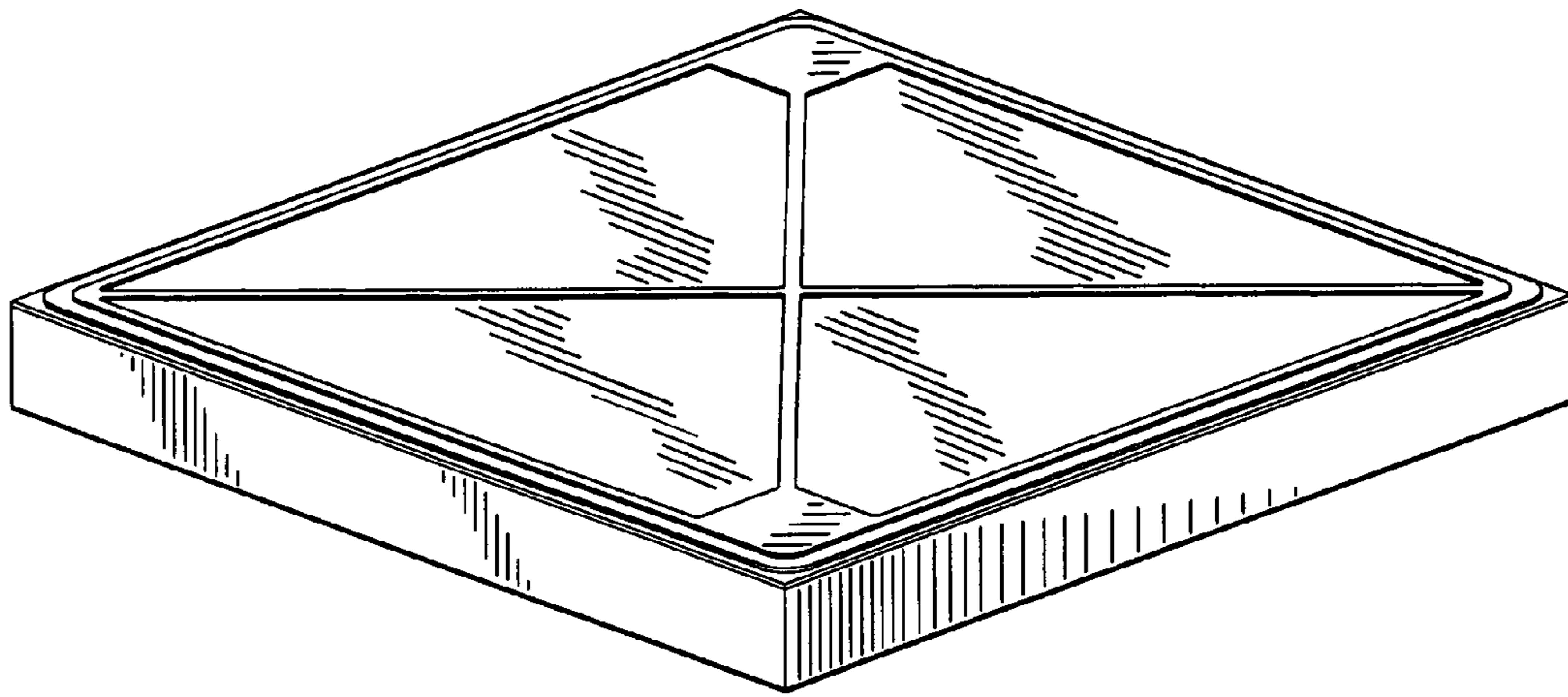

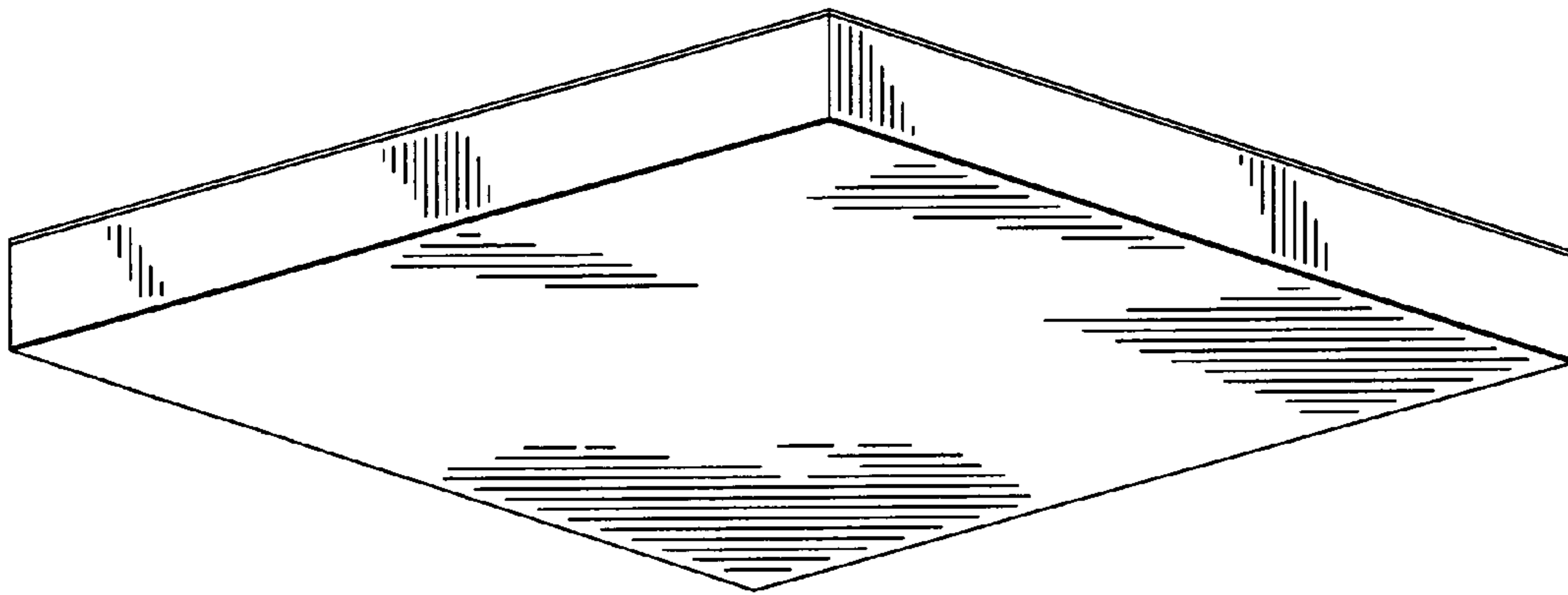

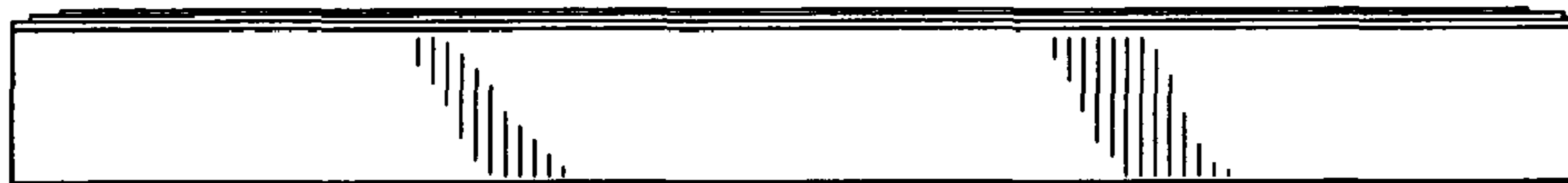

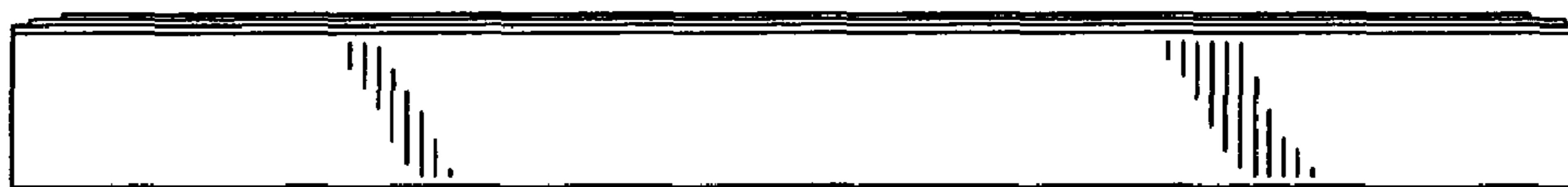

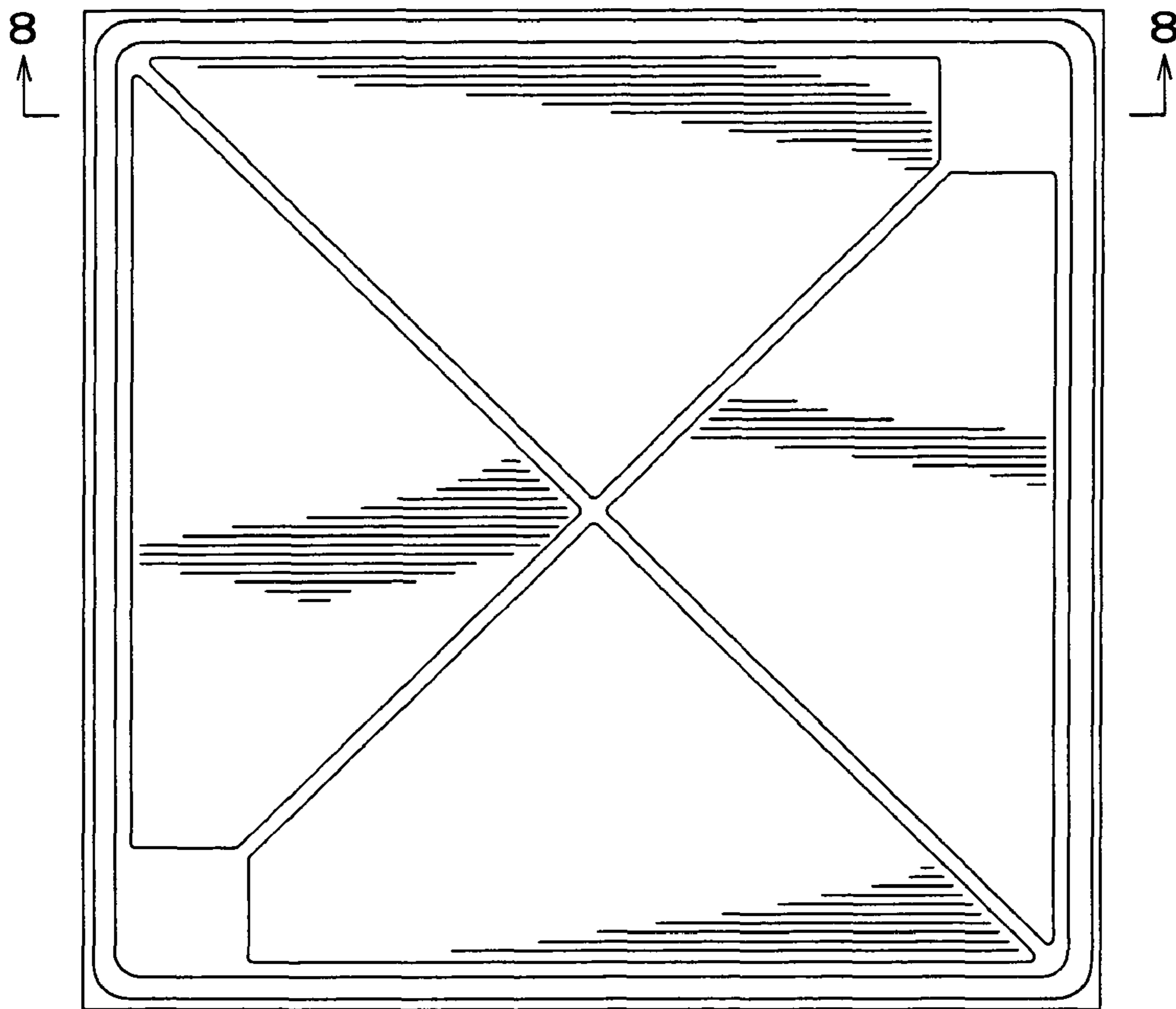

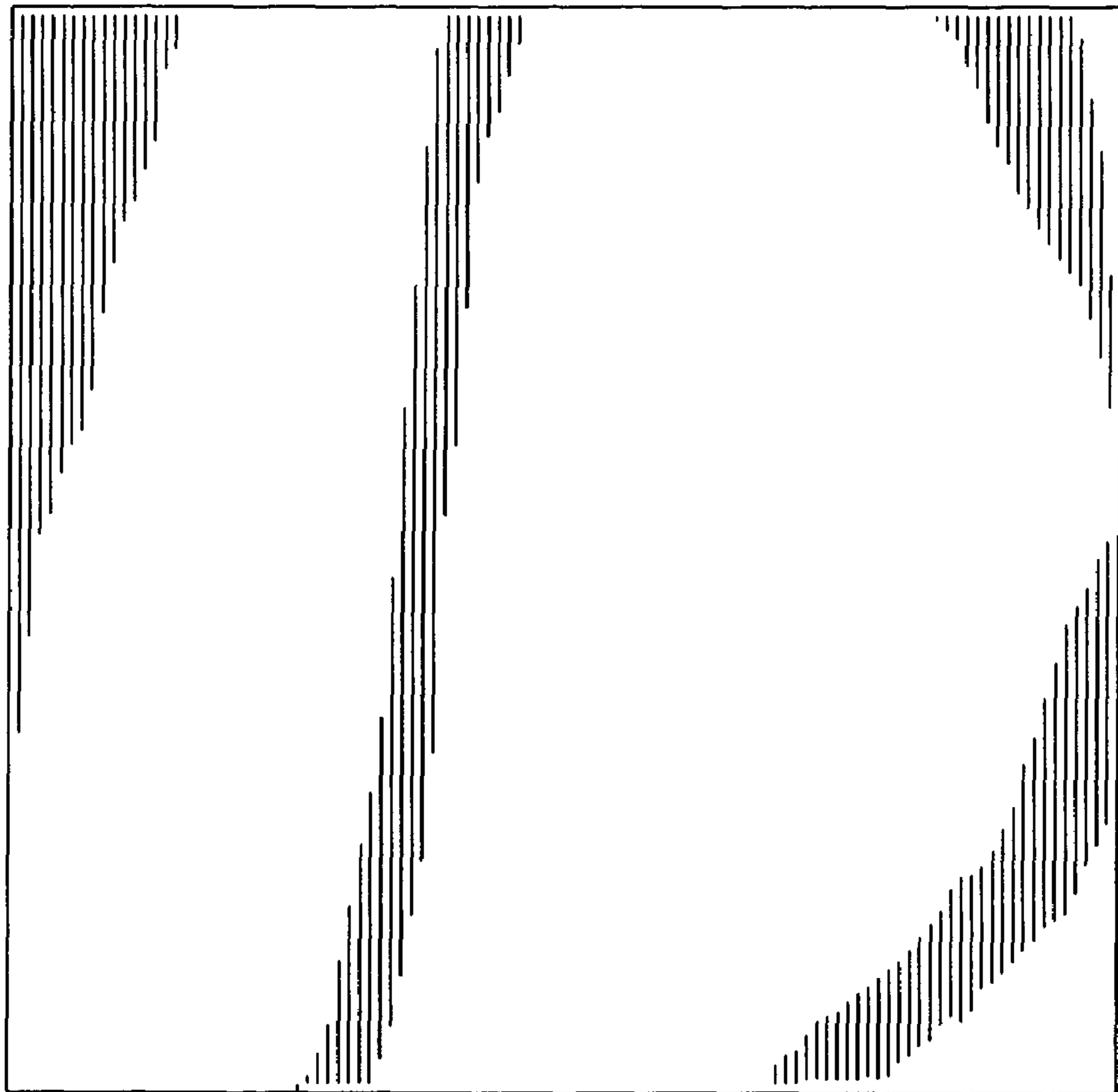

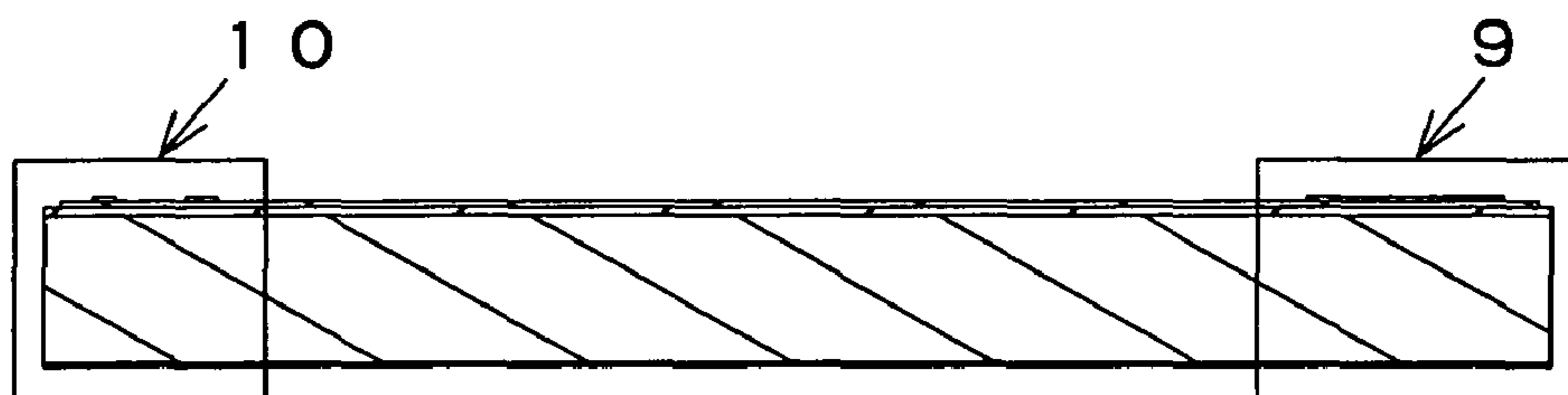

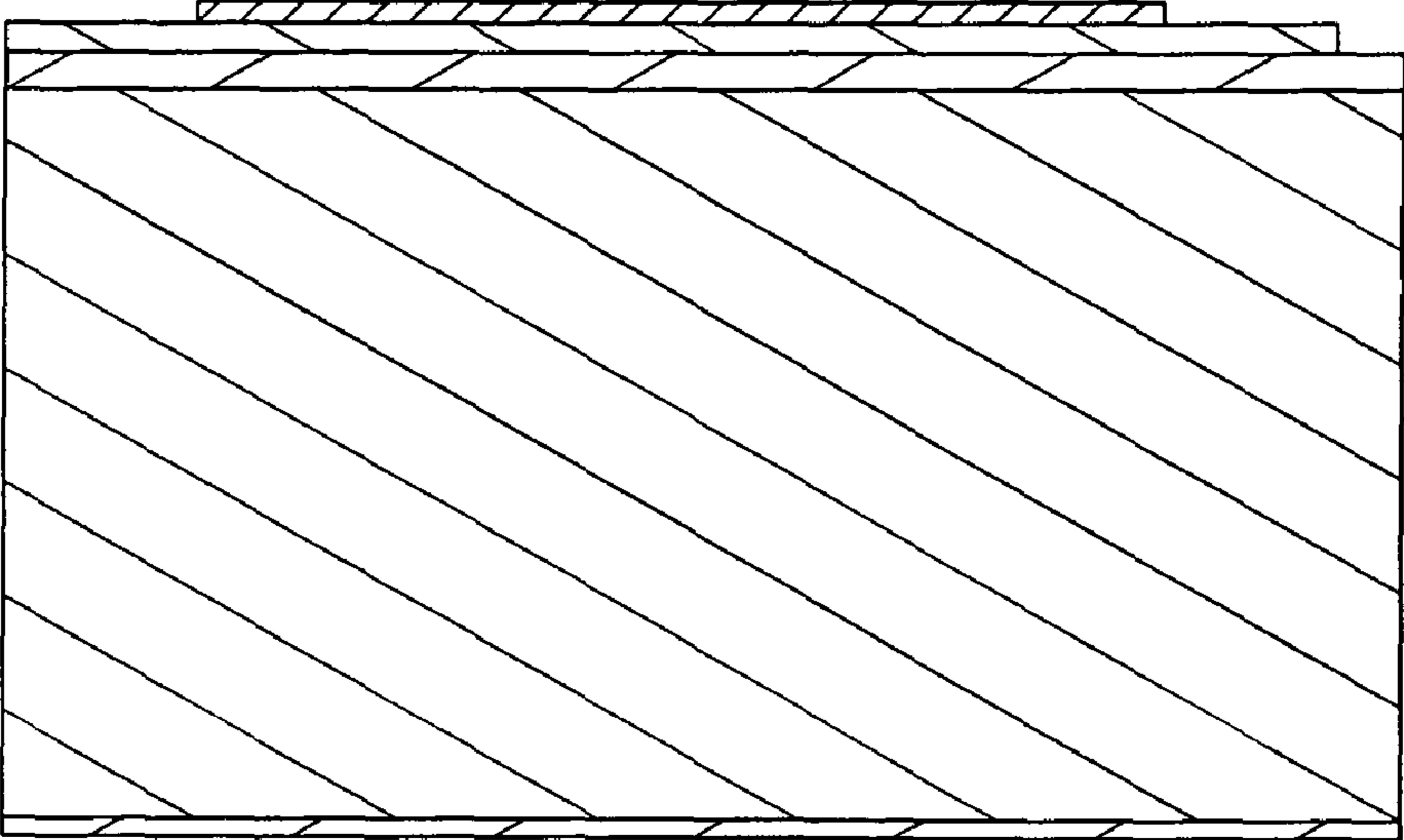
