**DESCRIPTION**

FIG. 1 is a perspective view of an earphone showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 8 is a perspective view of the earphone that shows additionally disclaimed illustrative features of a second earphone and jack plug.

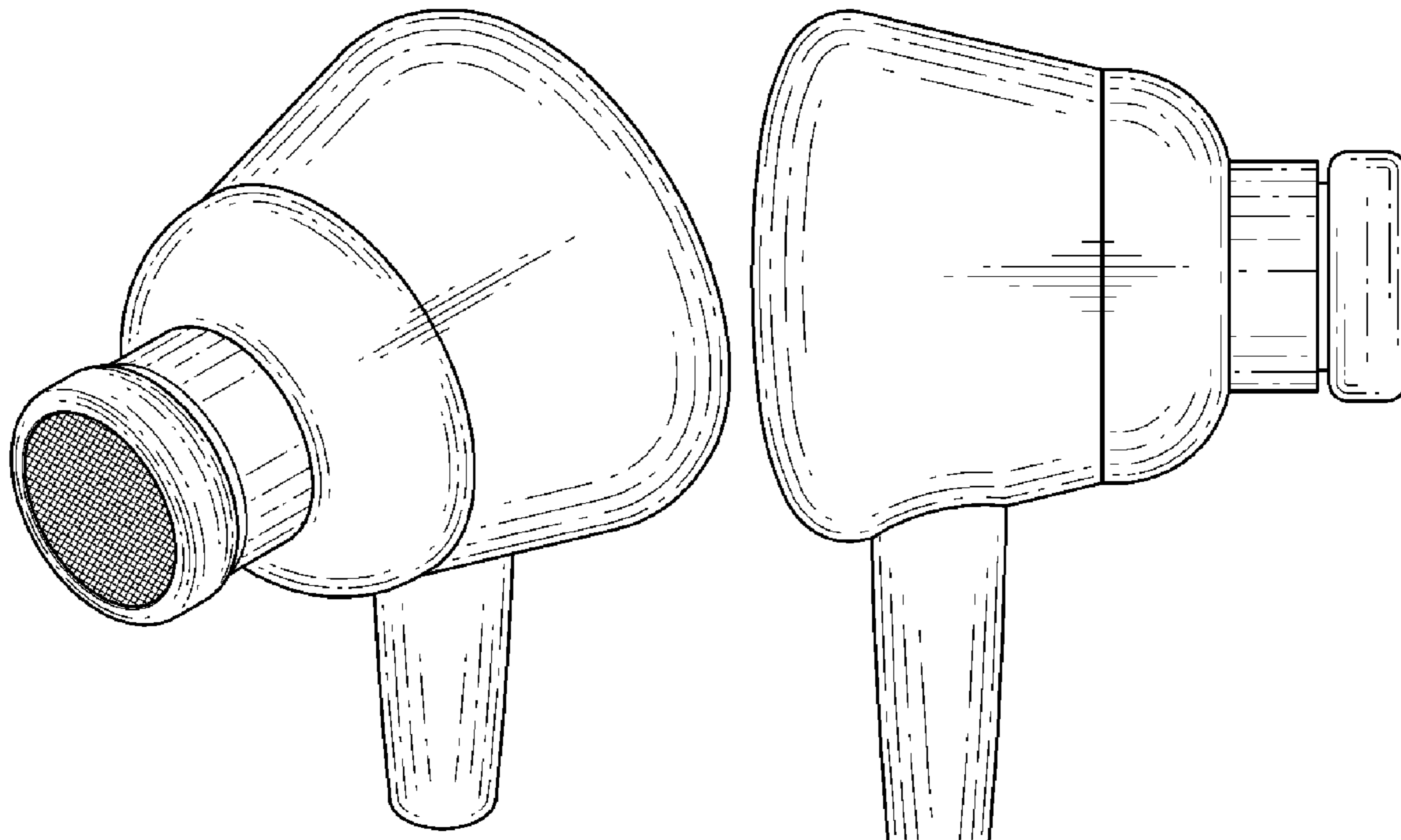

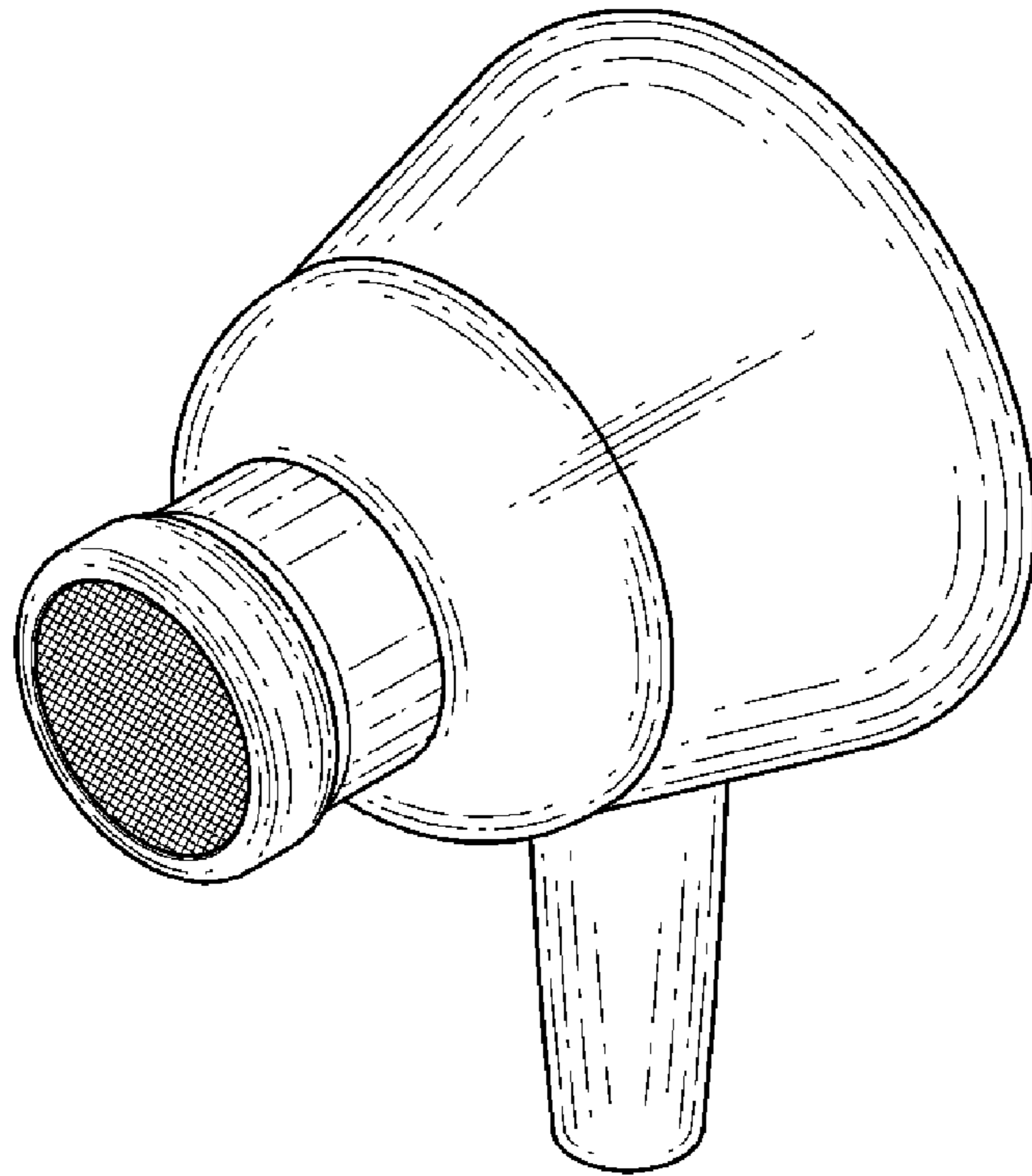

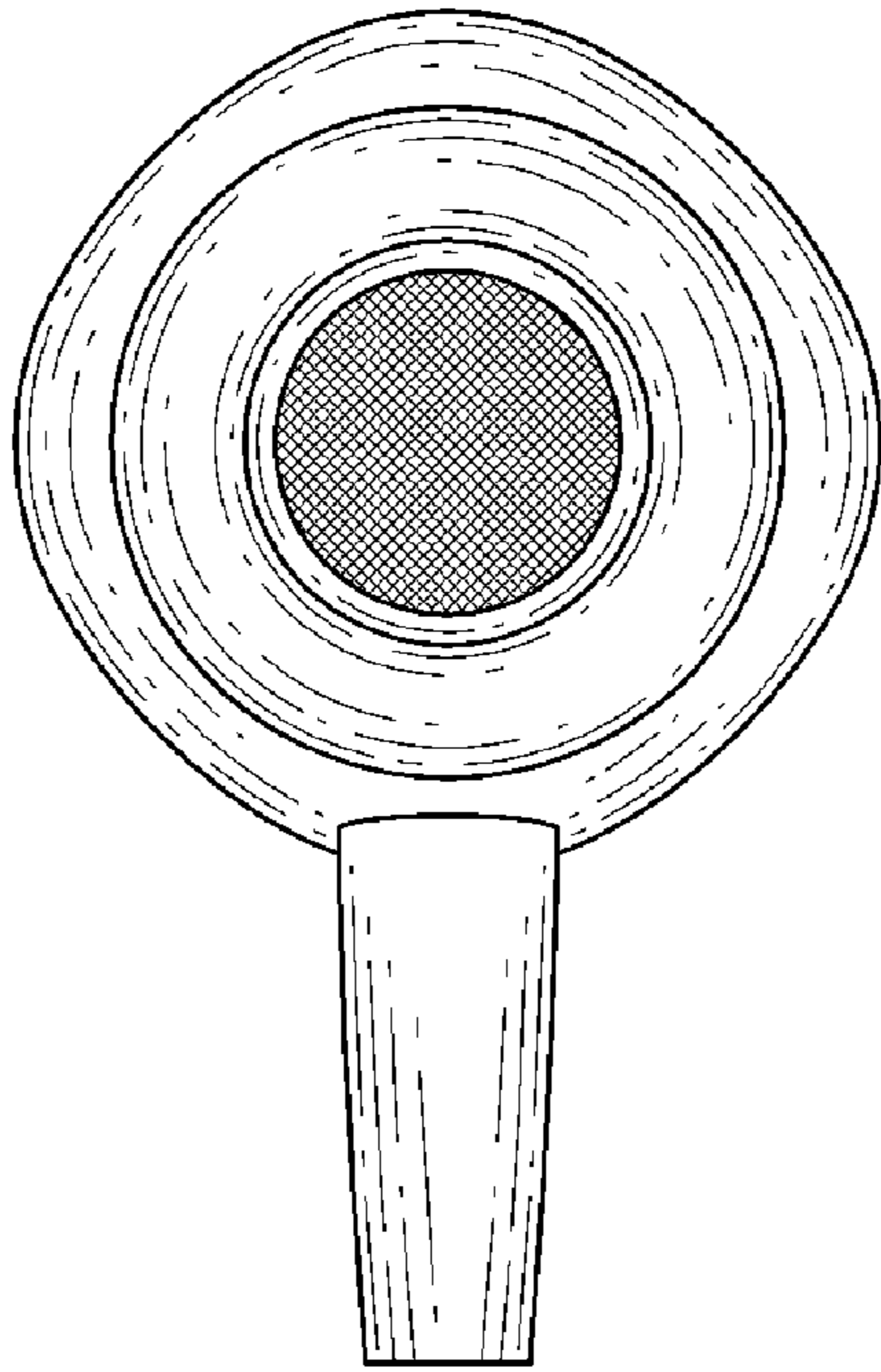

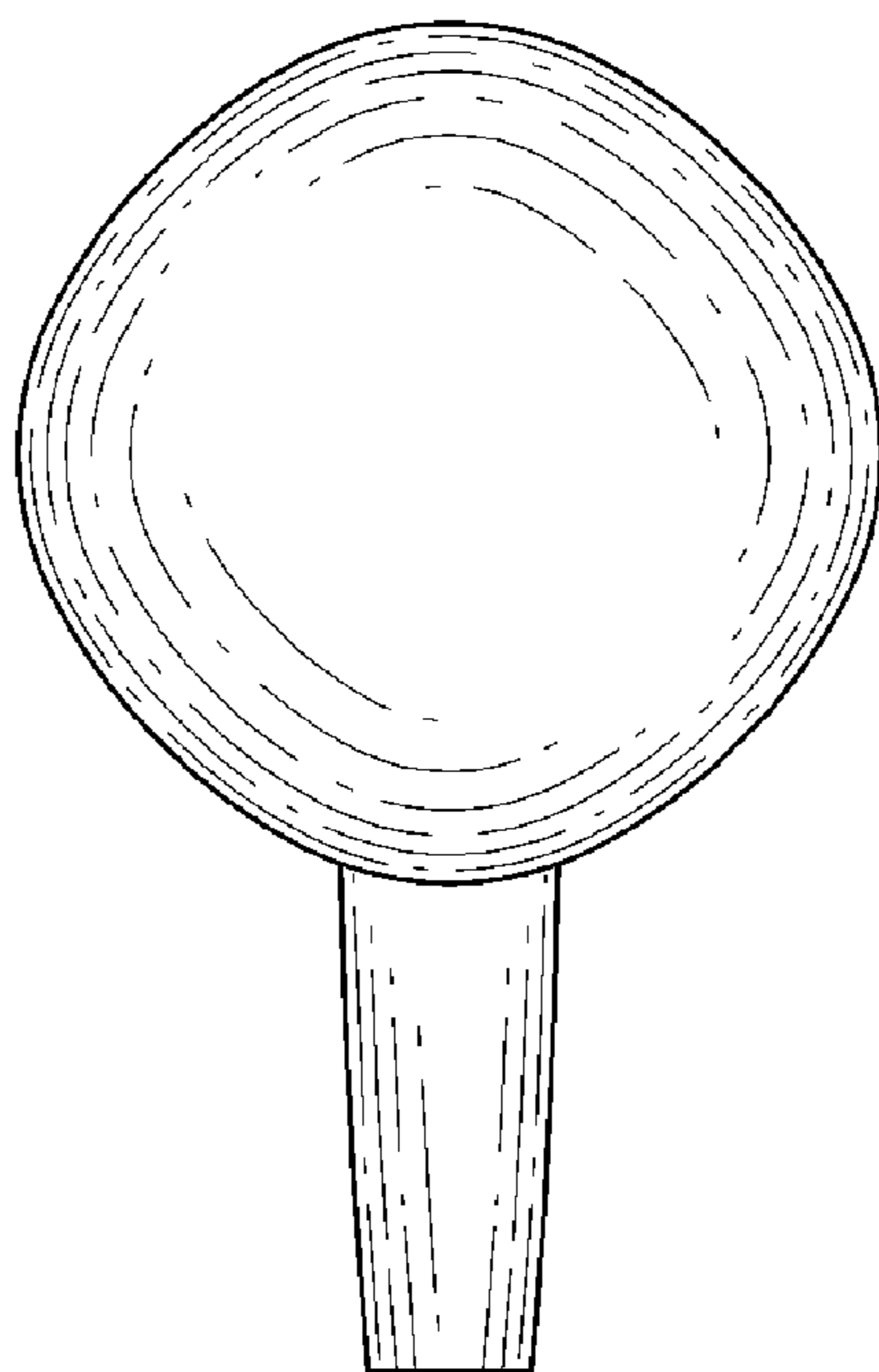

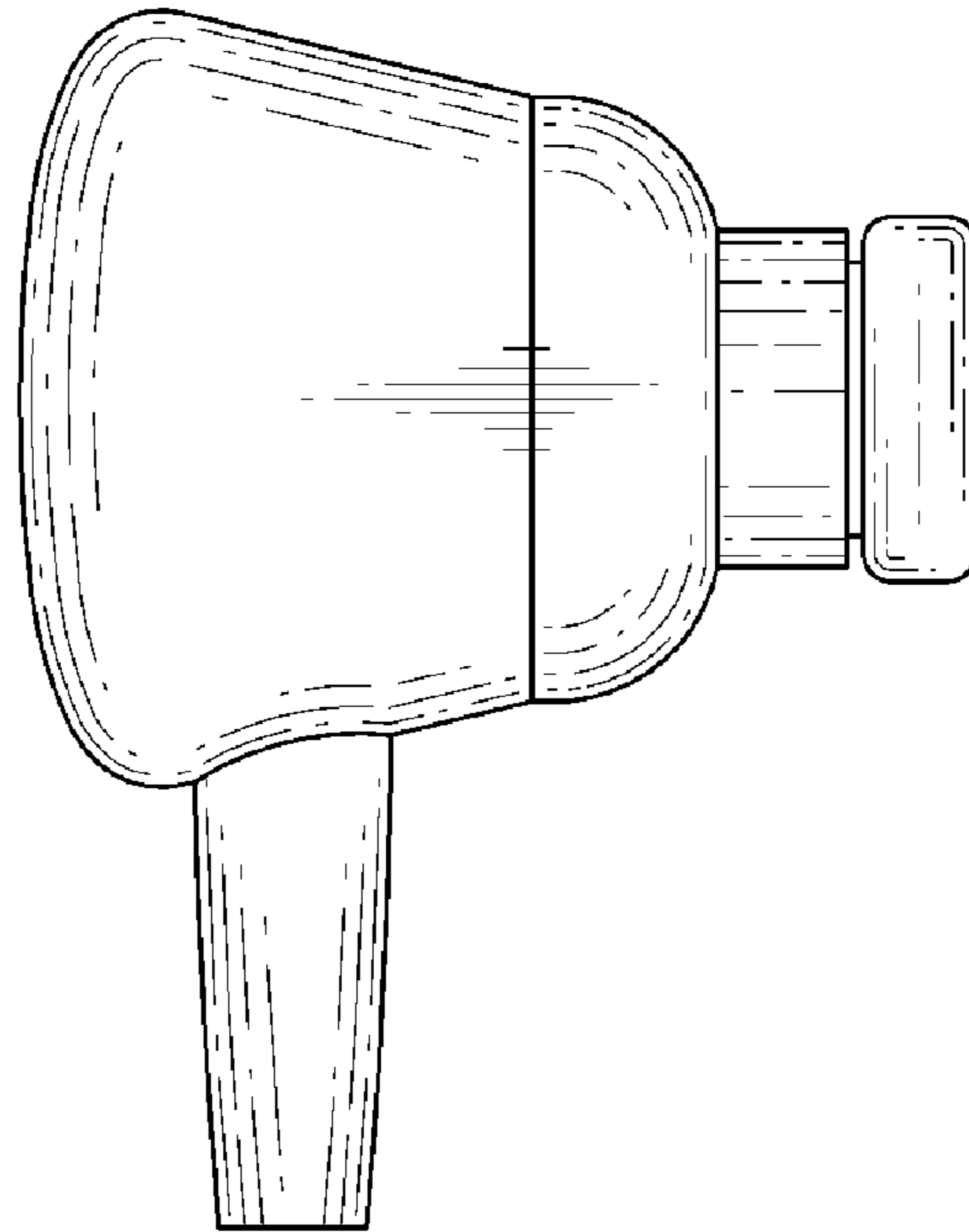

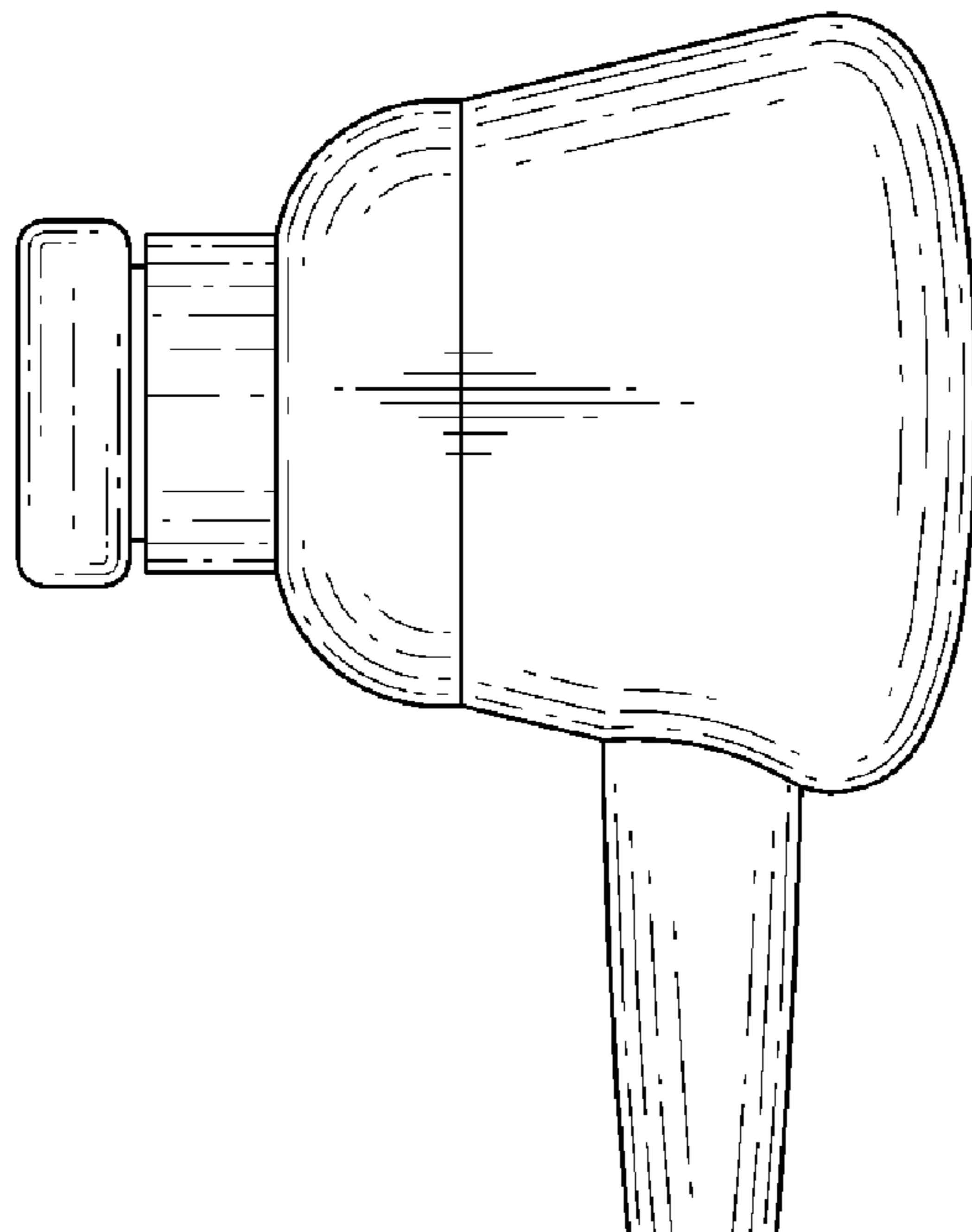

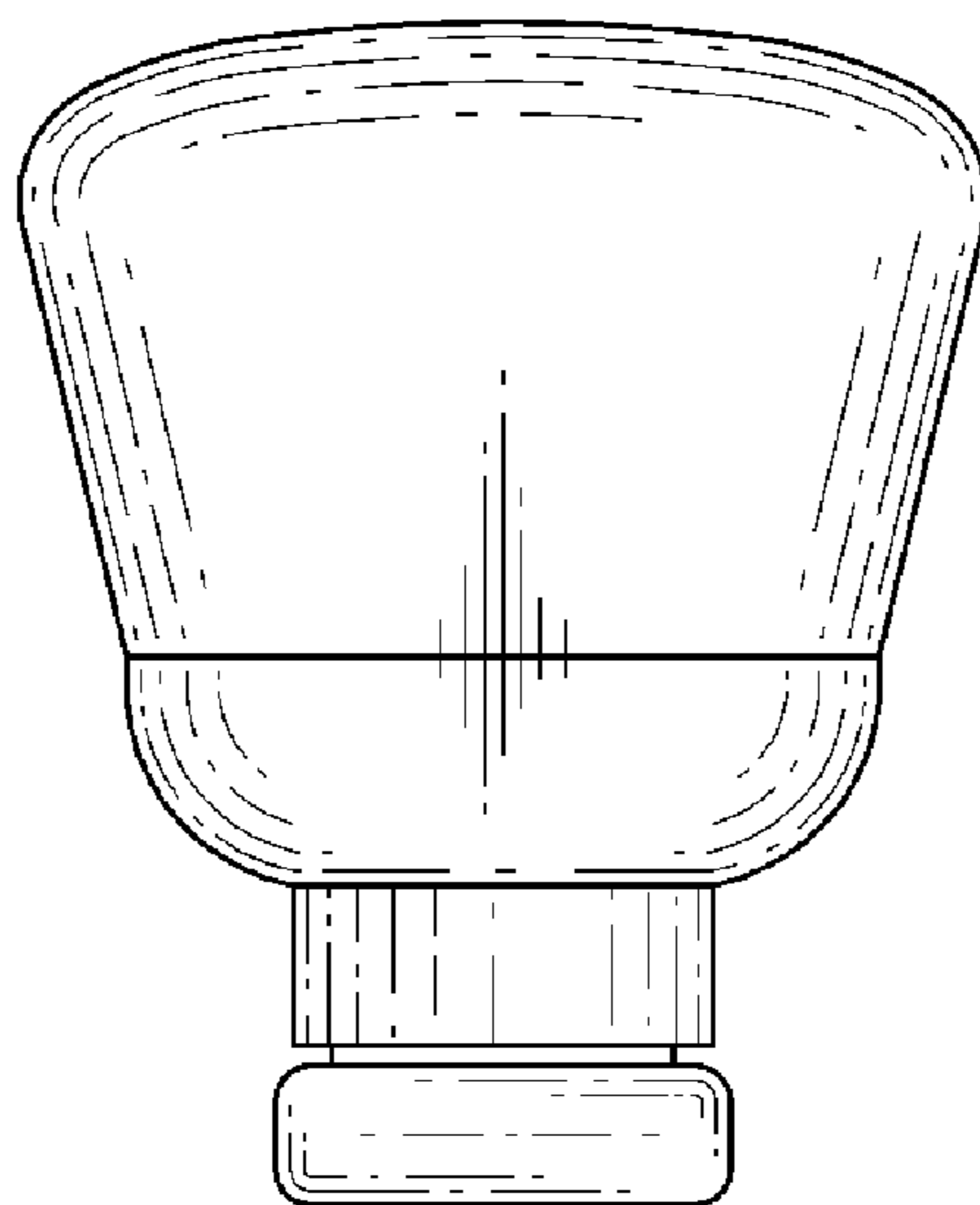

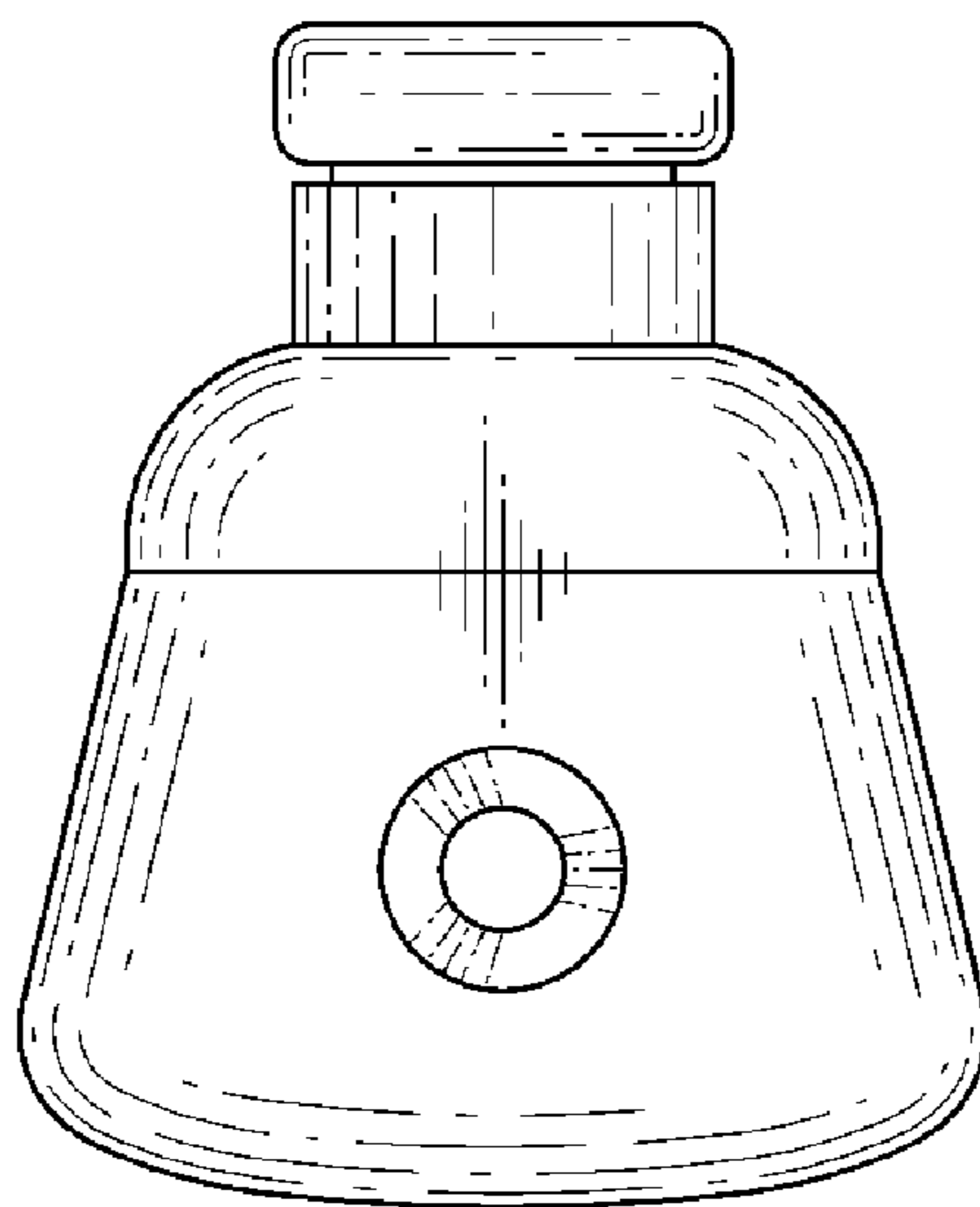
