FIG. 2: Top rear perspective view, cover shown separated;

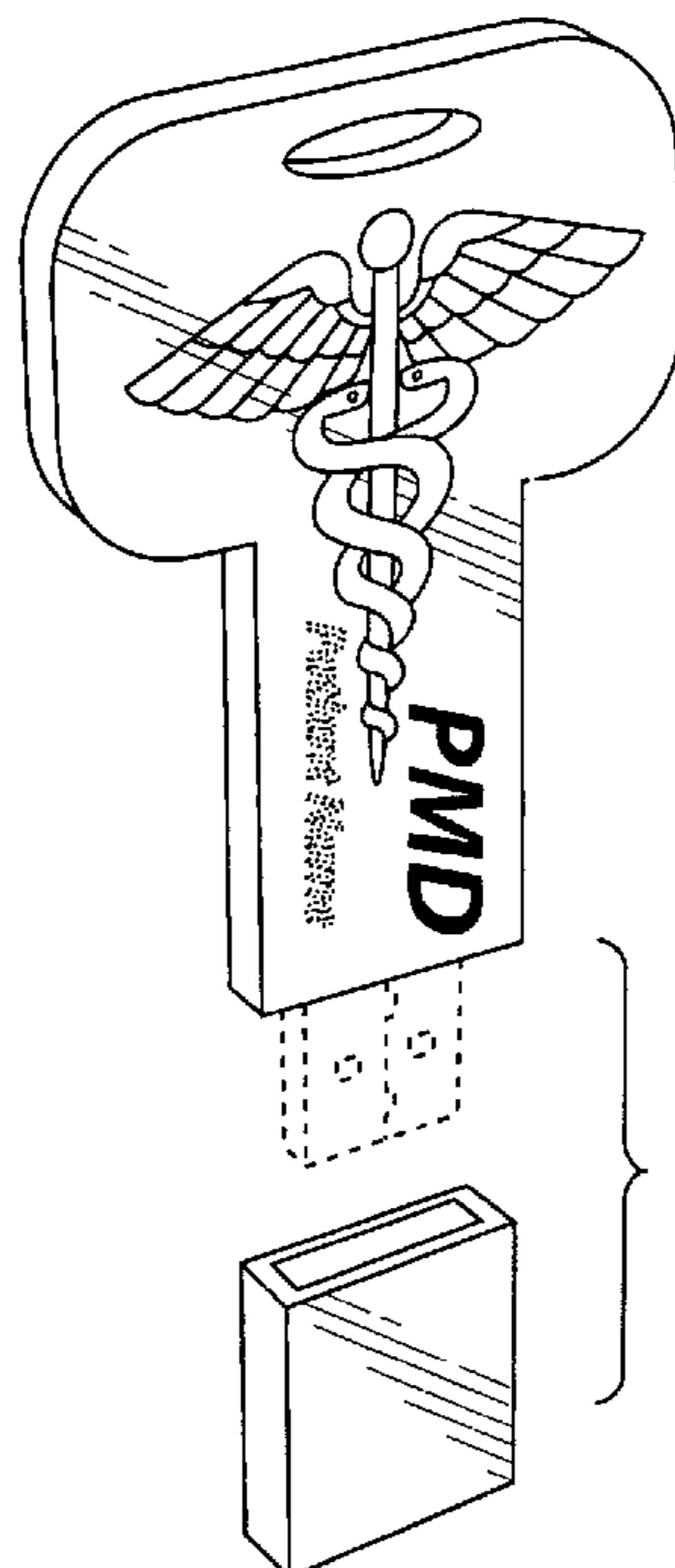
FIG. 3: Side elevation view, the opposite side elevation view being identical thereto, cover shown separated;

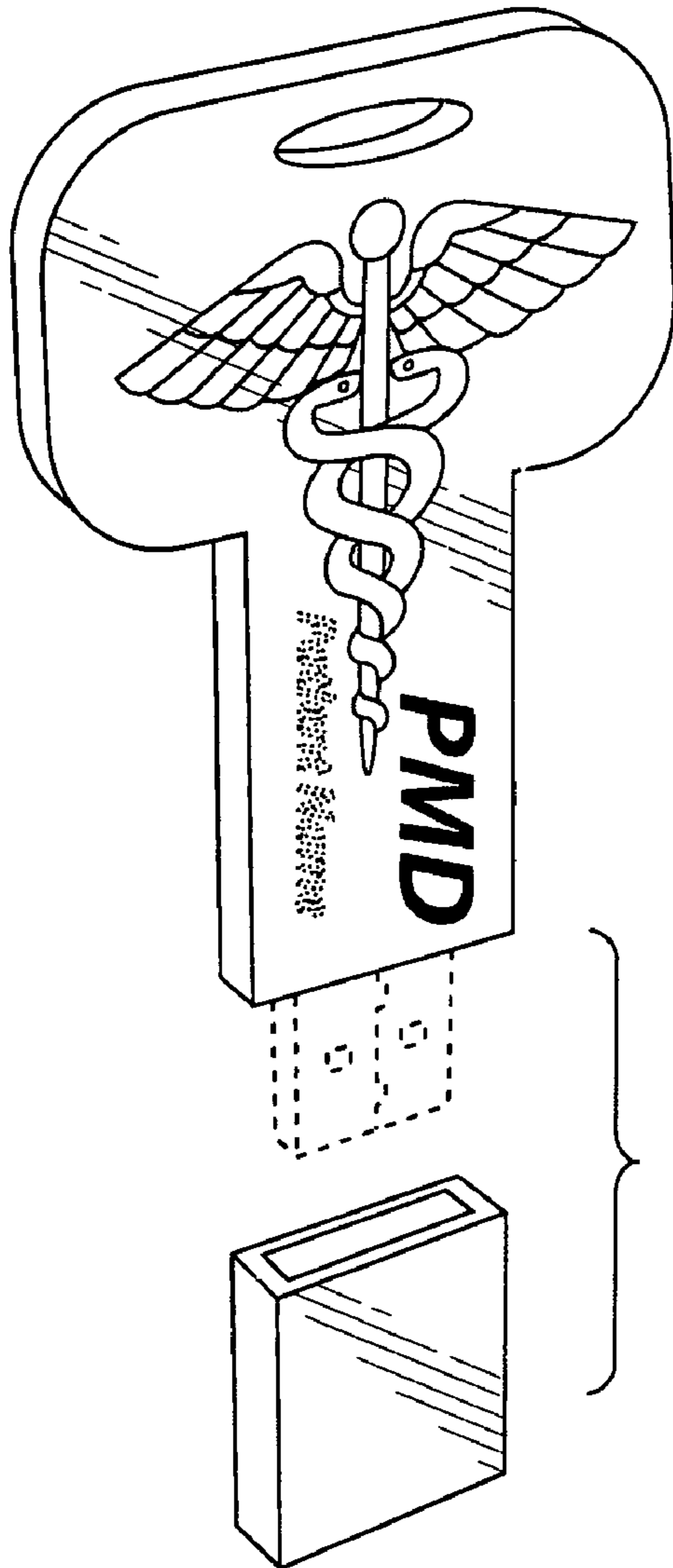
FIG. 4: Bottom plan view, cover removed; and,

FIG. 5: Top plan view.

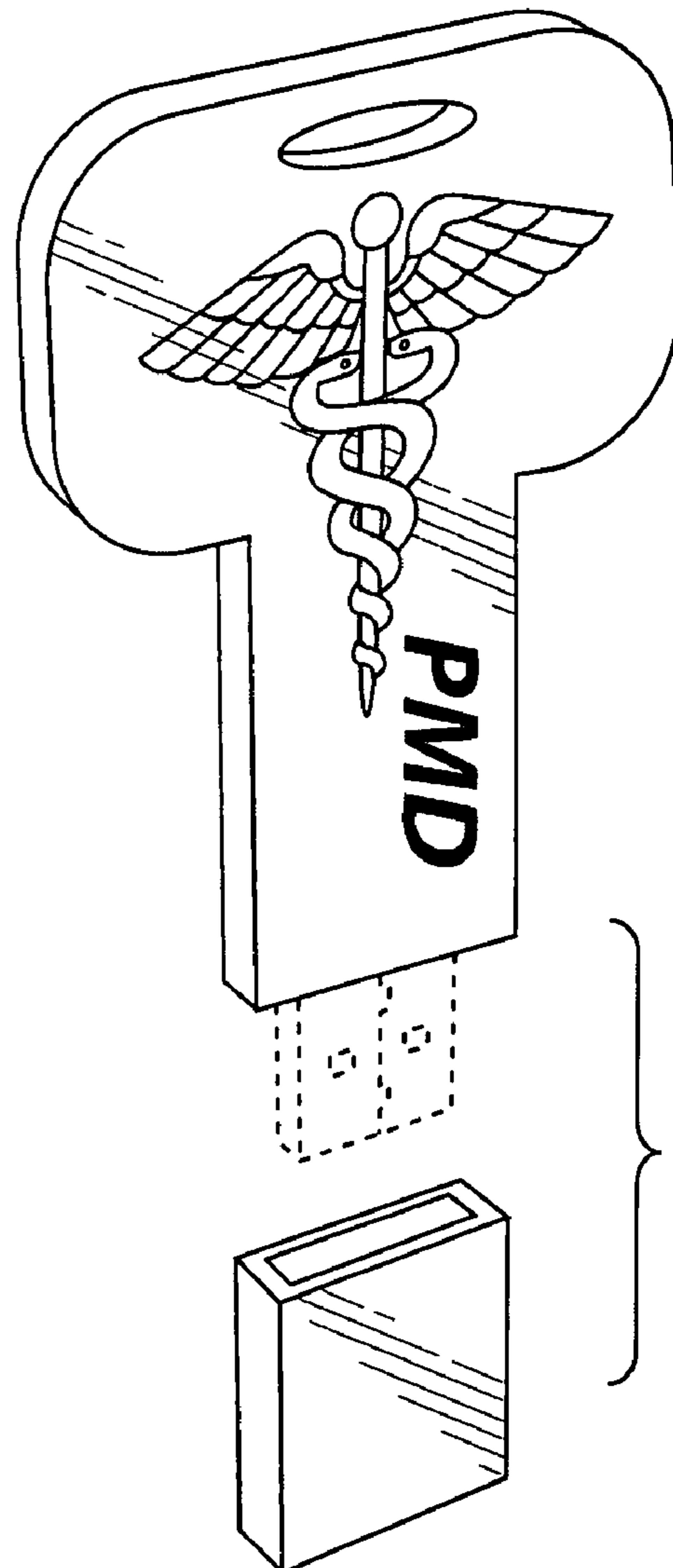
