FIG. 7 is a front, top, right side perspective view thereof;

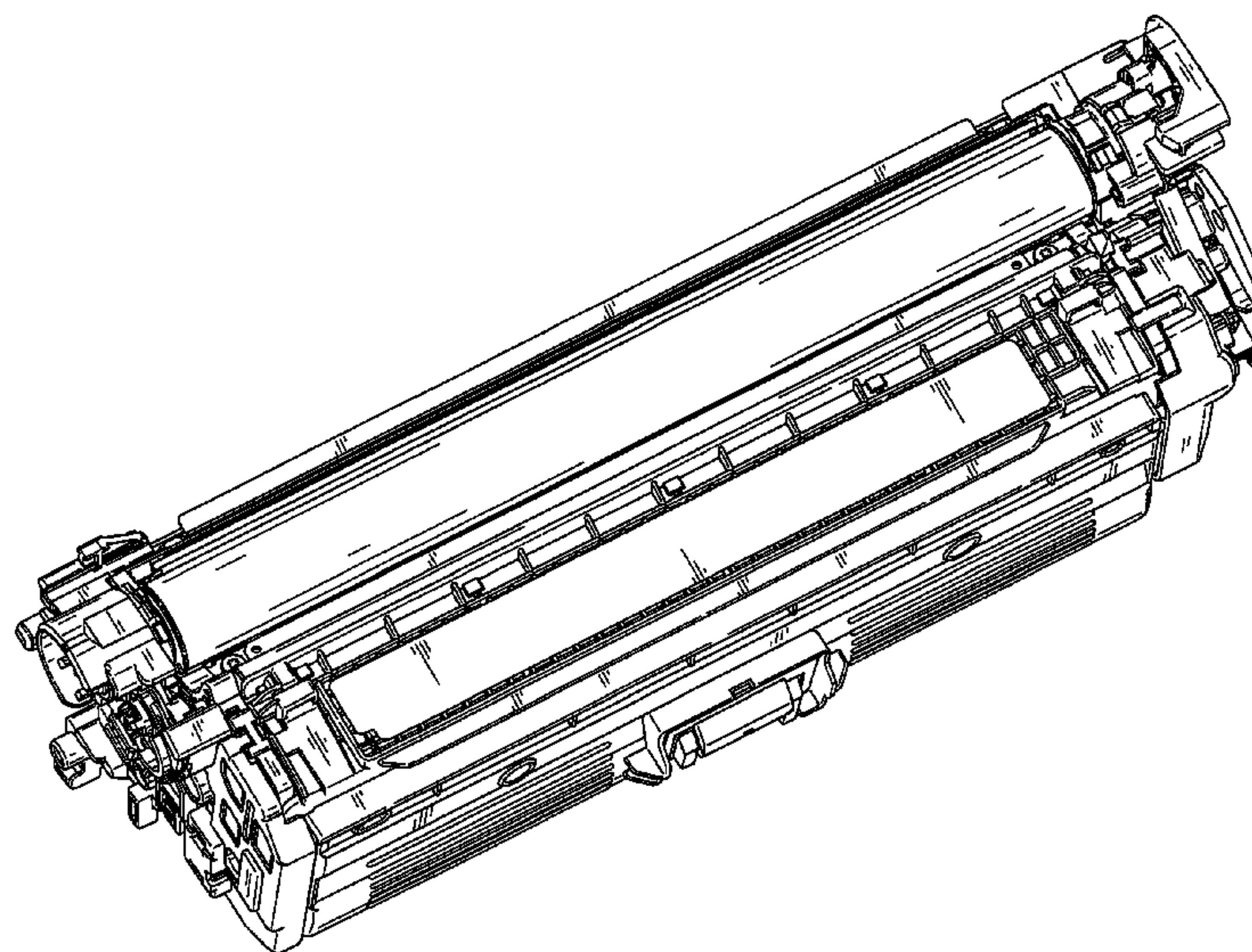
FIG. 8 is a front, top, left side perspective view thereof;

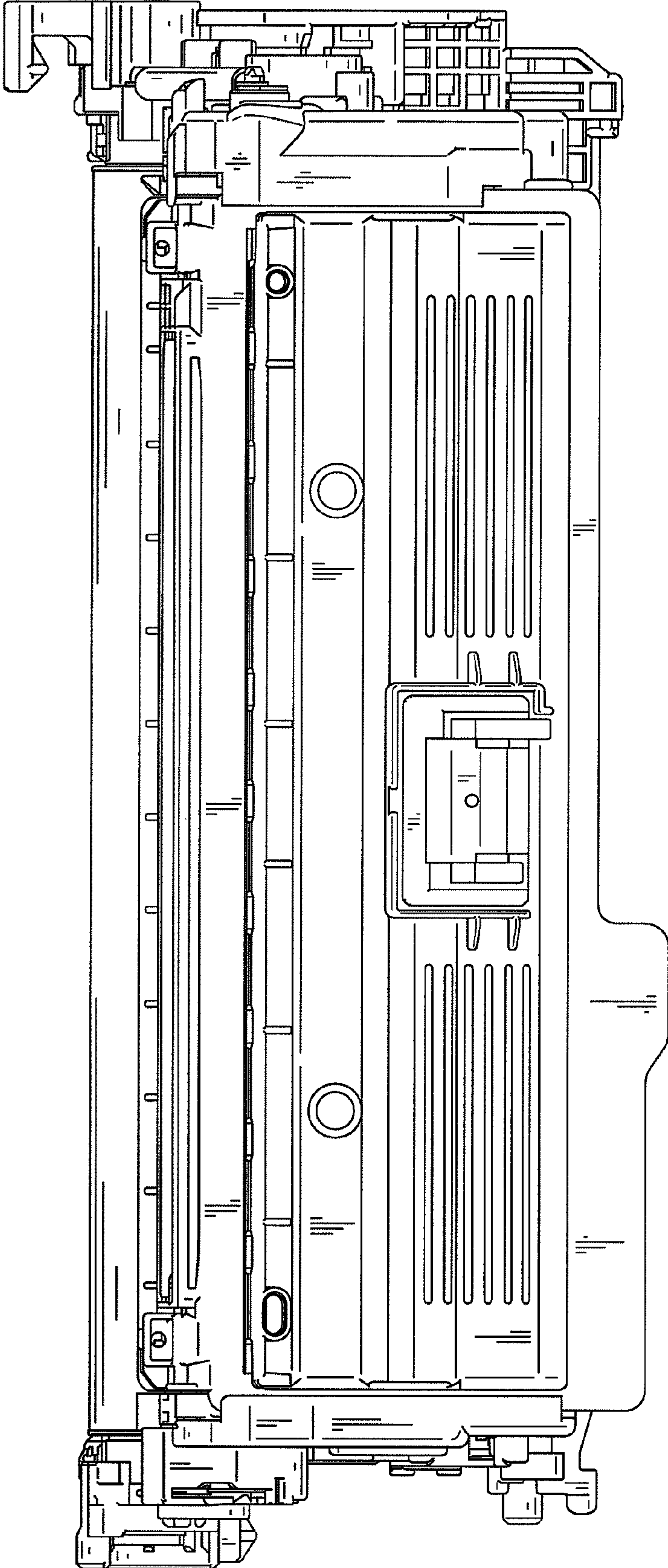

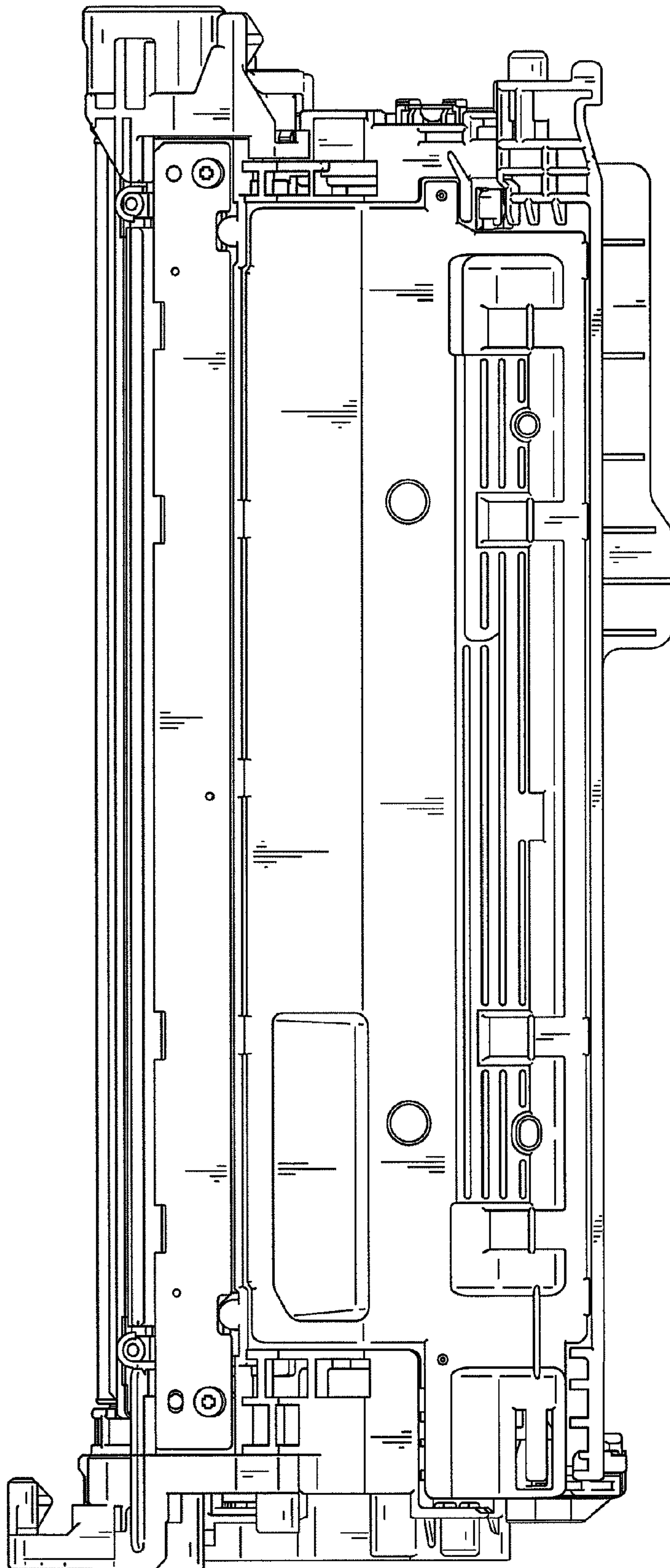

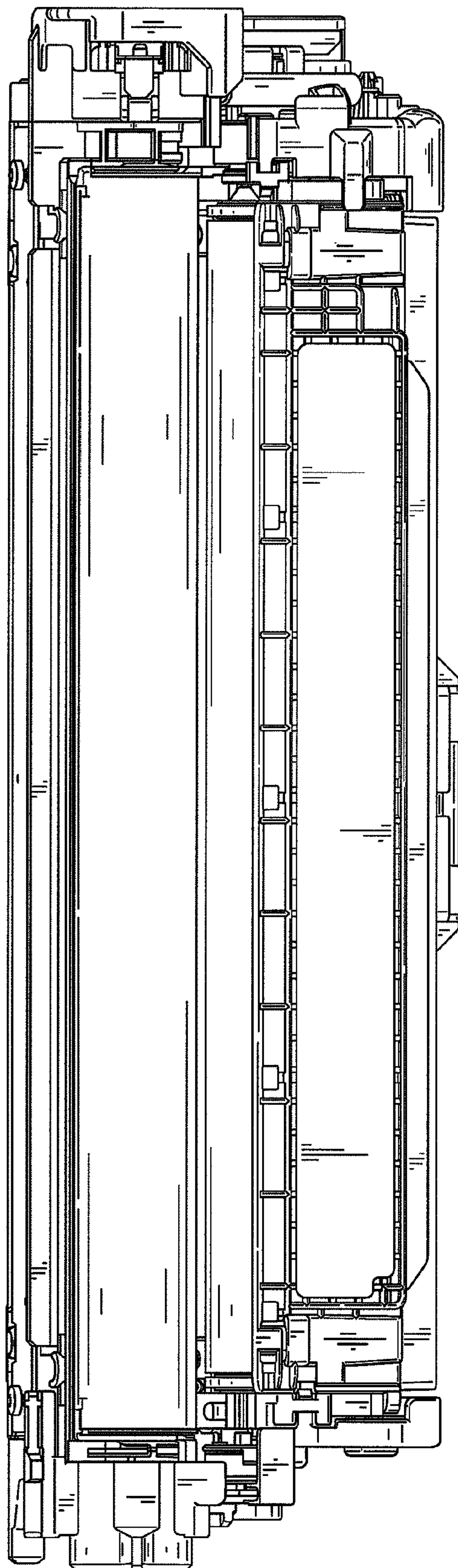

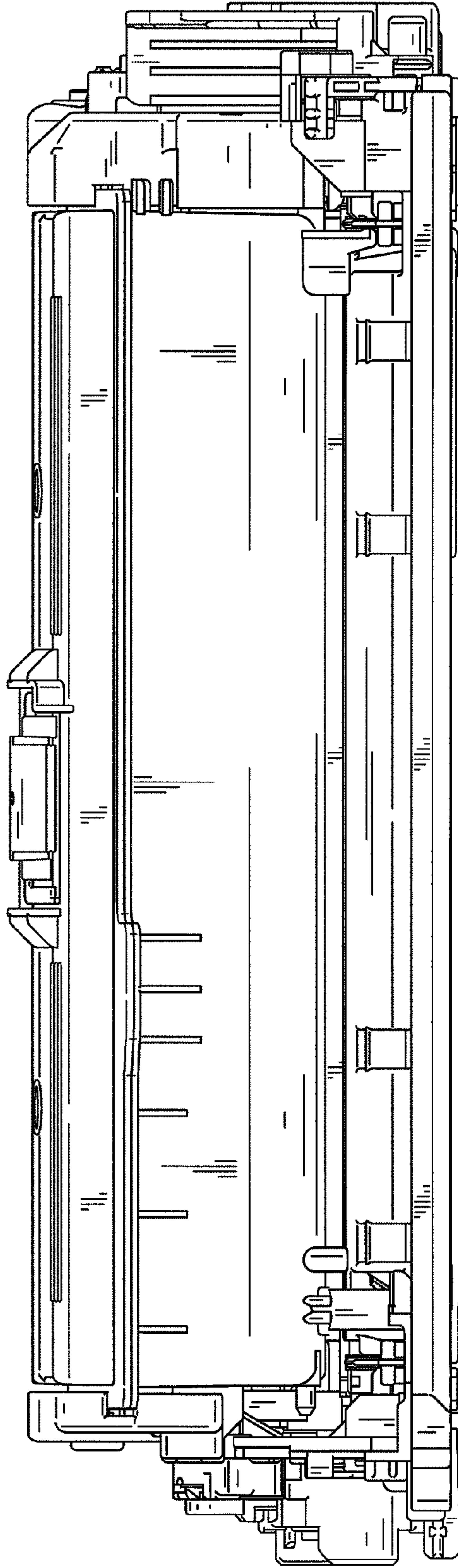

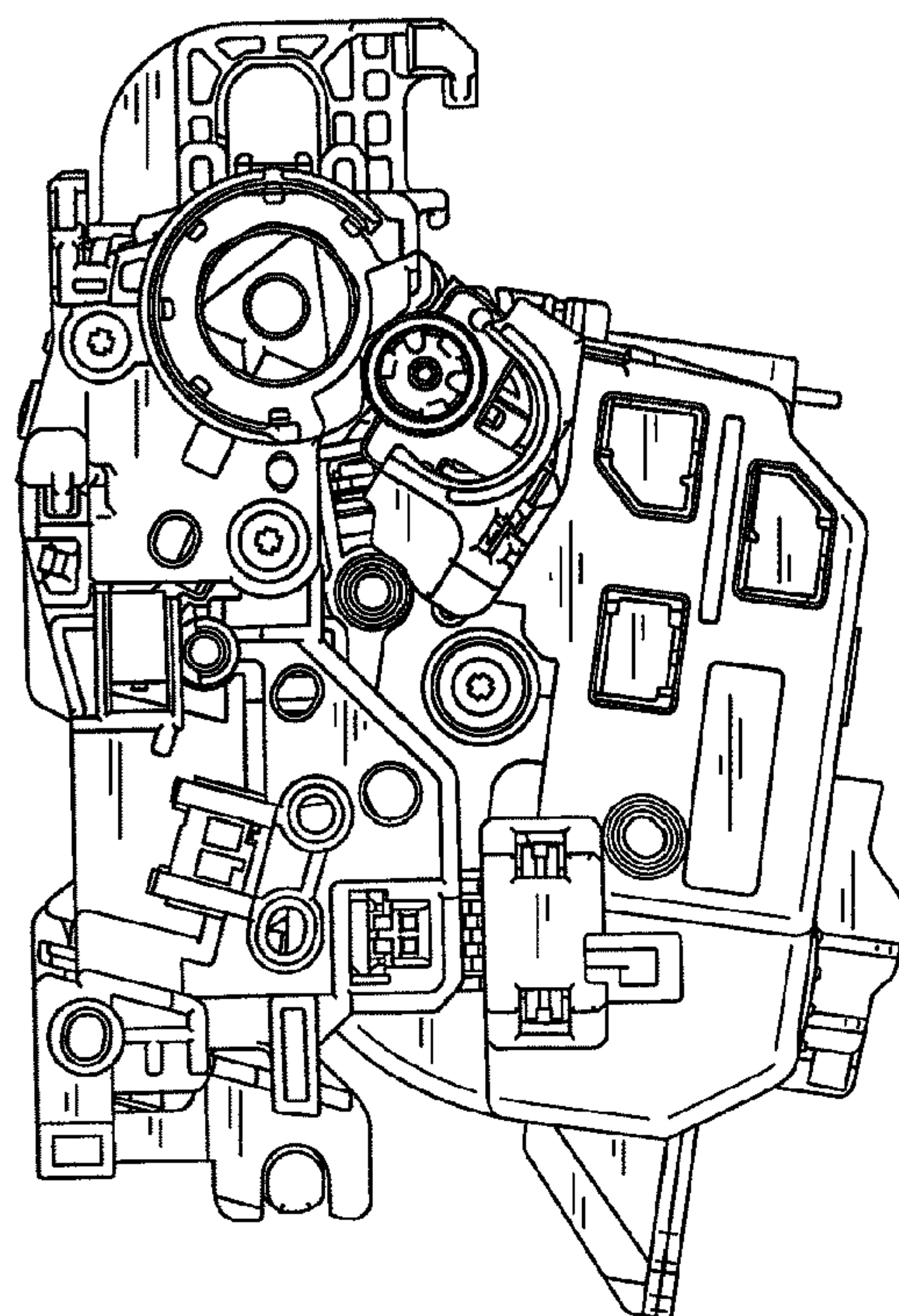

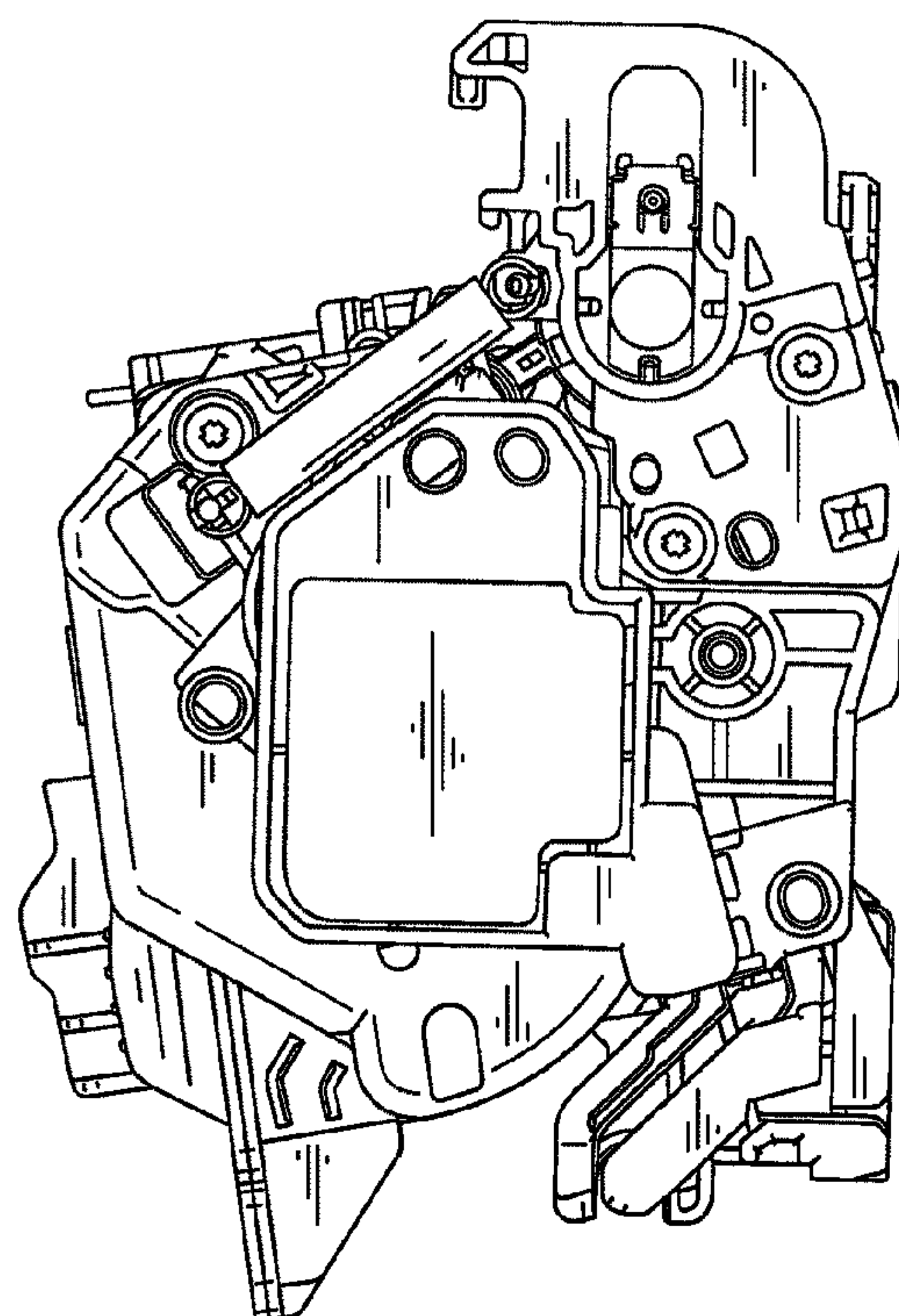

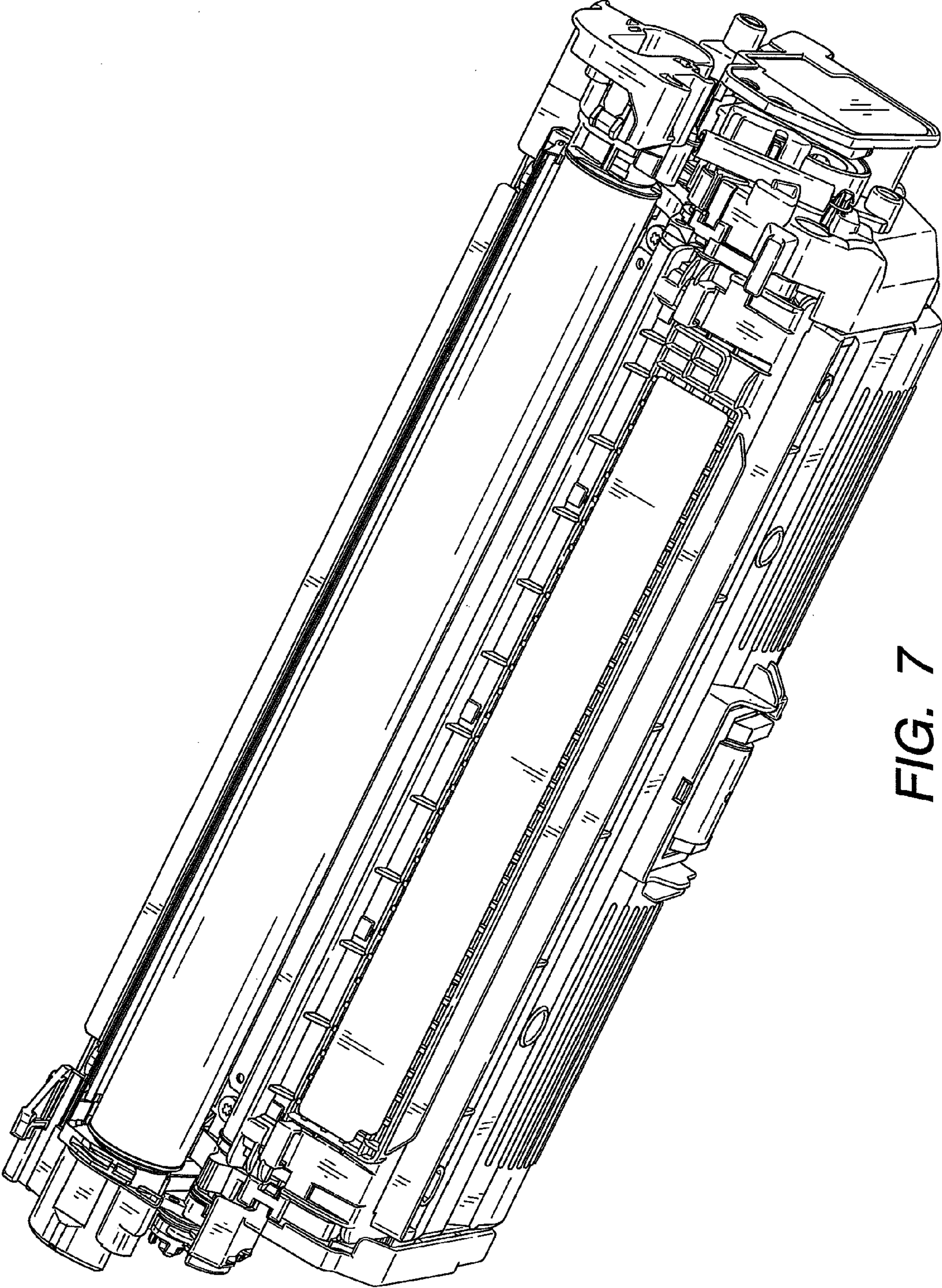

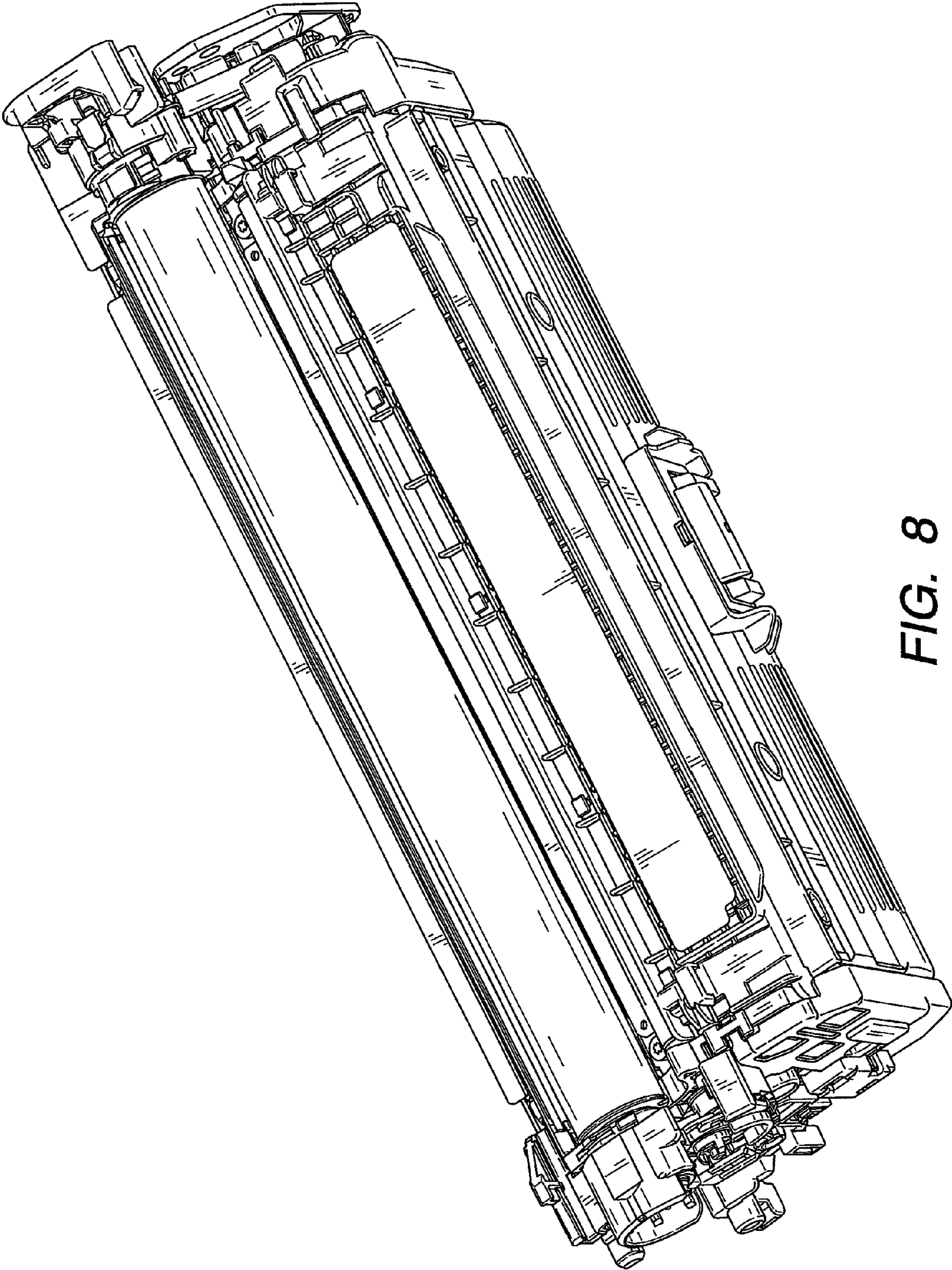

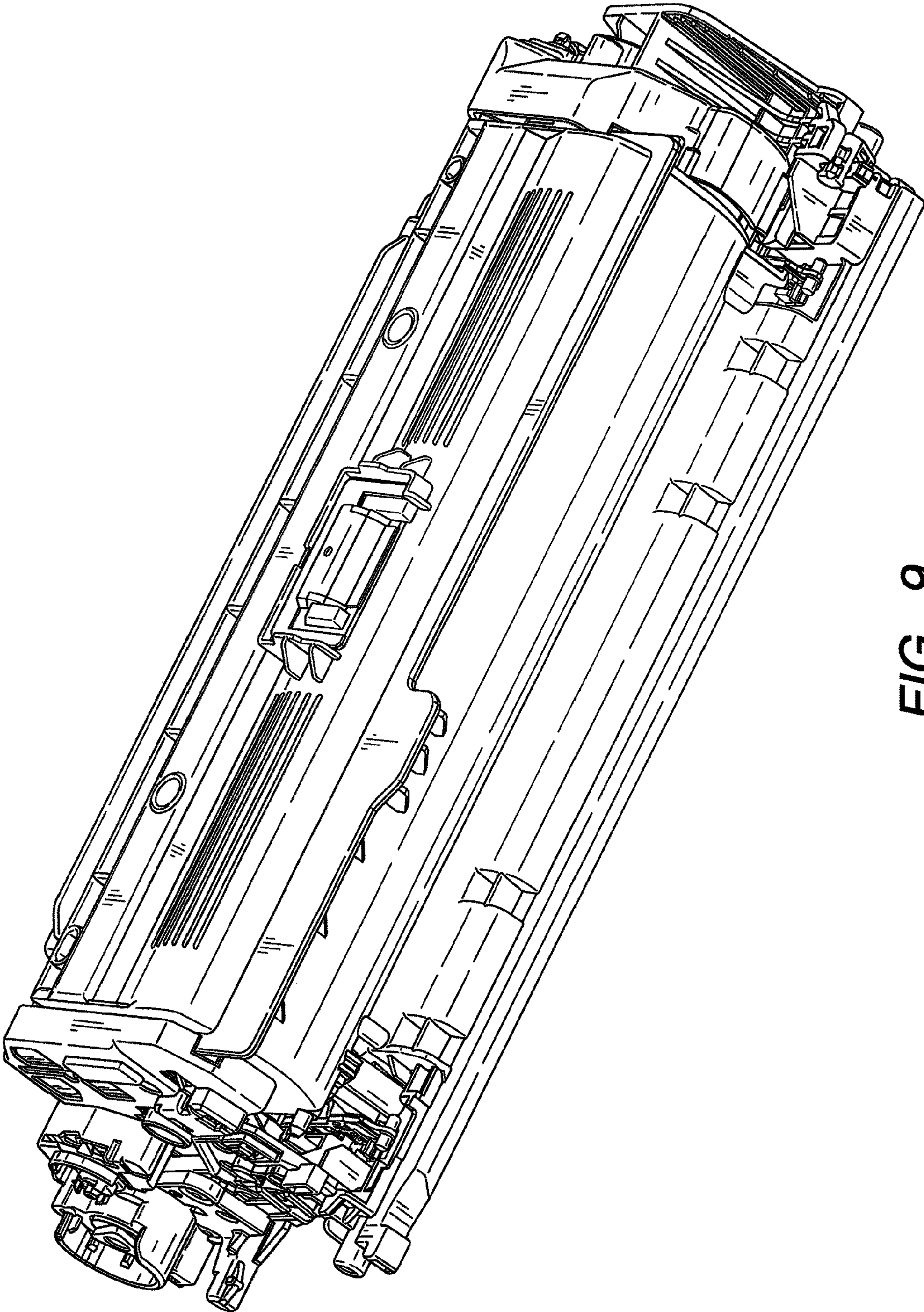

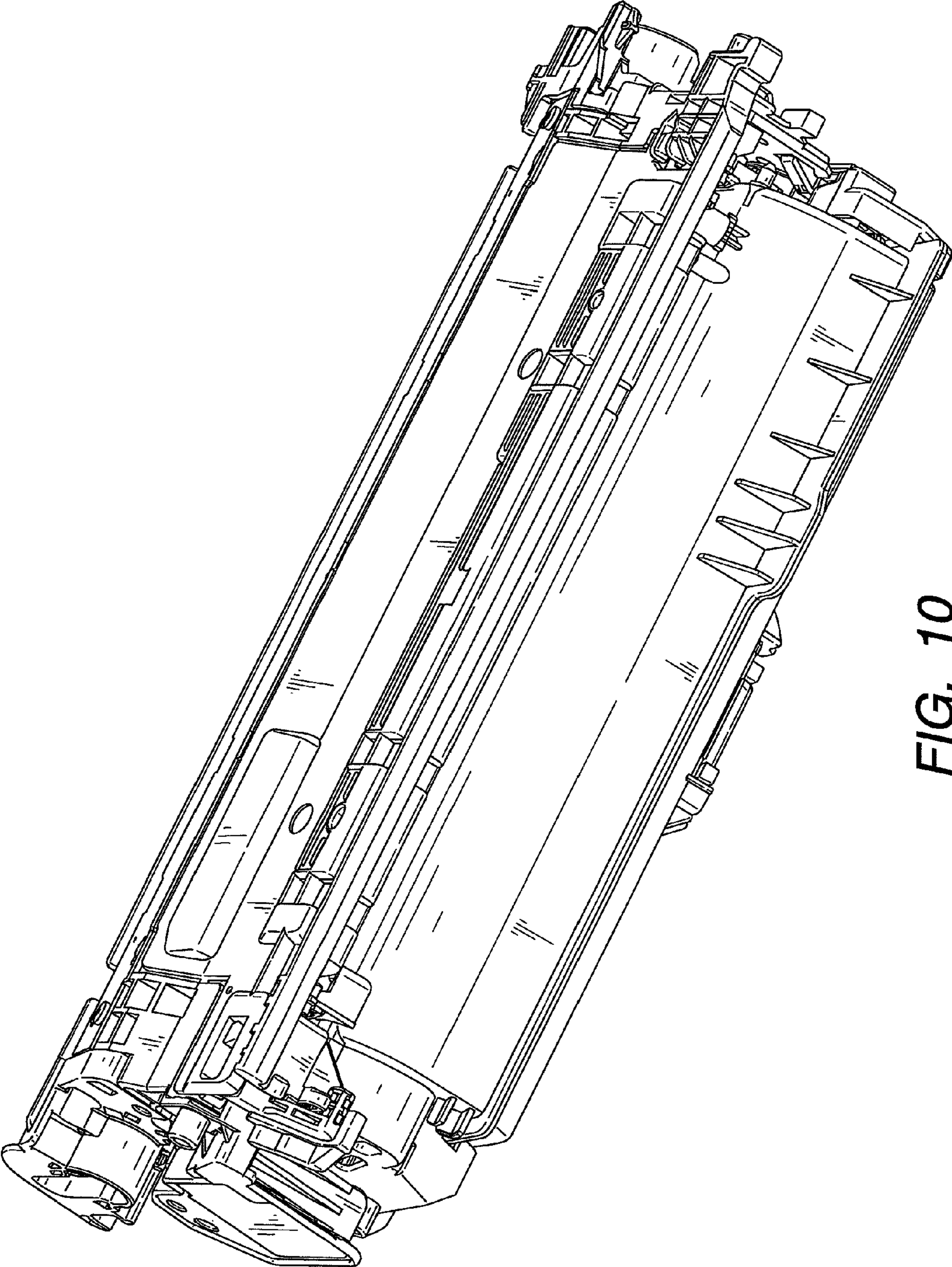
