(57) **CLAIM**

The ornamental design for toy construction module, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the toy construction module, the bottom view being a mirror image thereof;

FIG. 2 is a side view of the toy construction module of FIG. 1, the other sides being identical thereto;

FIG. 3 is a front left view of a corner the toy construction module of FIG. 1, the rear right view being identical thereto;

FIG. 4 is a top front right perspective view of the toy construction module of FIG. 1; and,

FIG. 5 is a top rear right perspective view of the toy construction module of FIG. 1

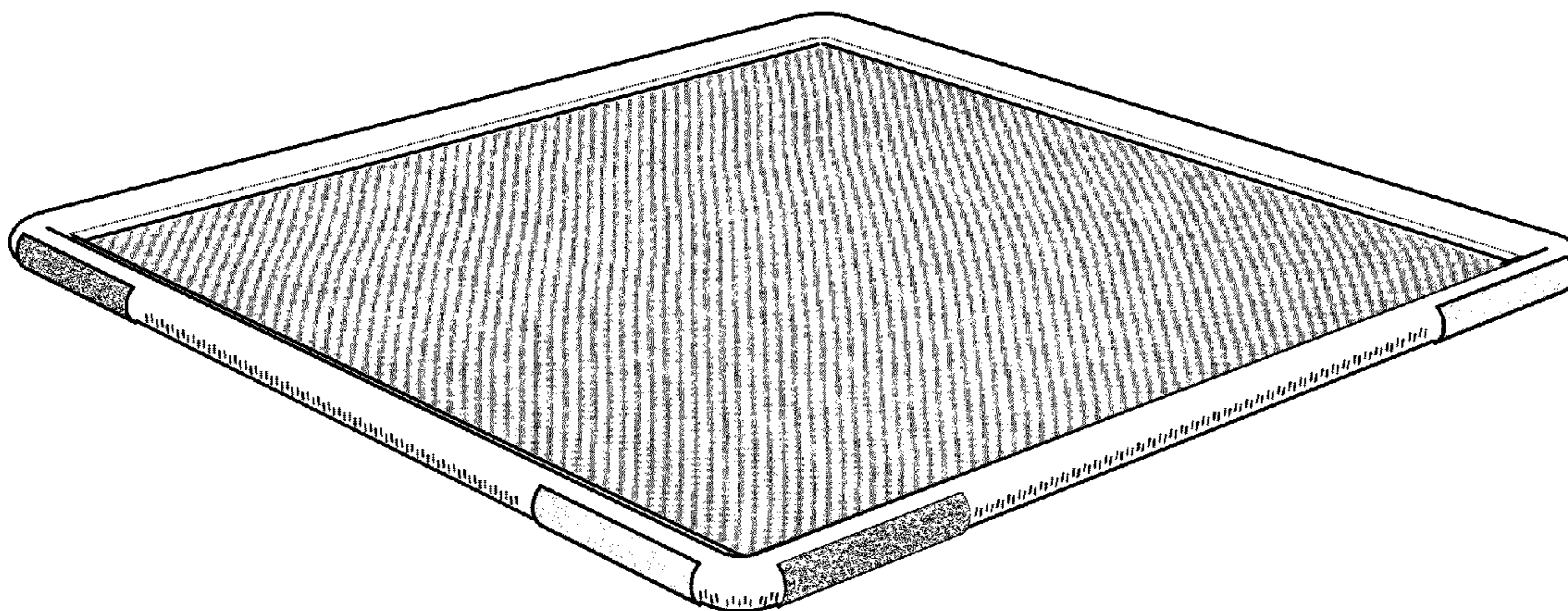

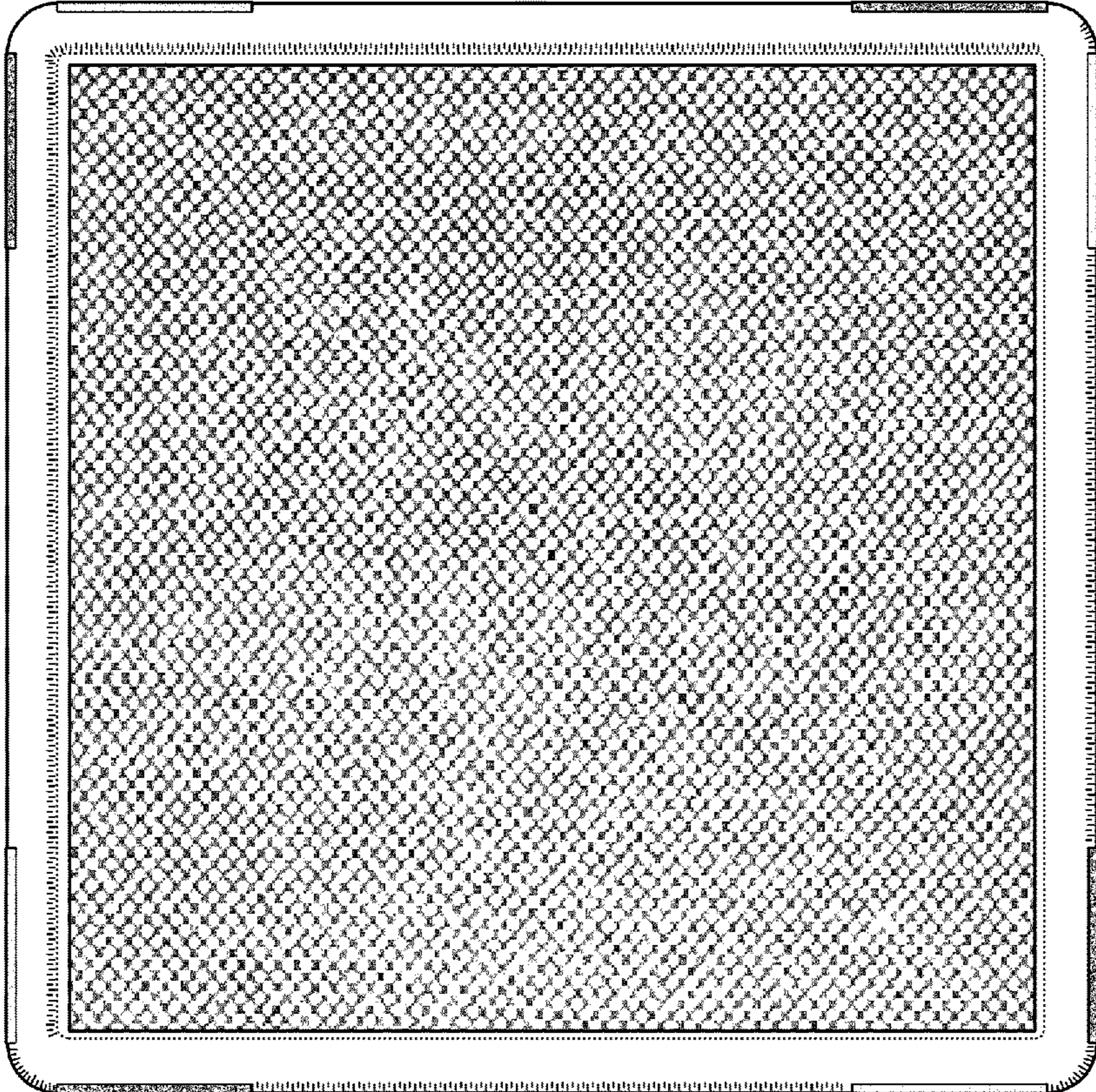

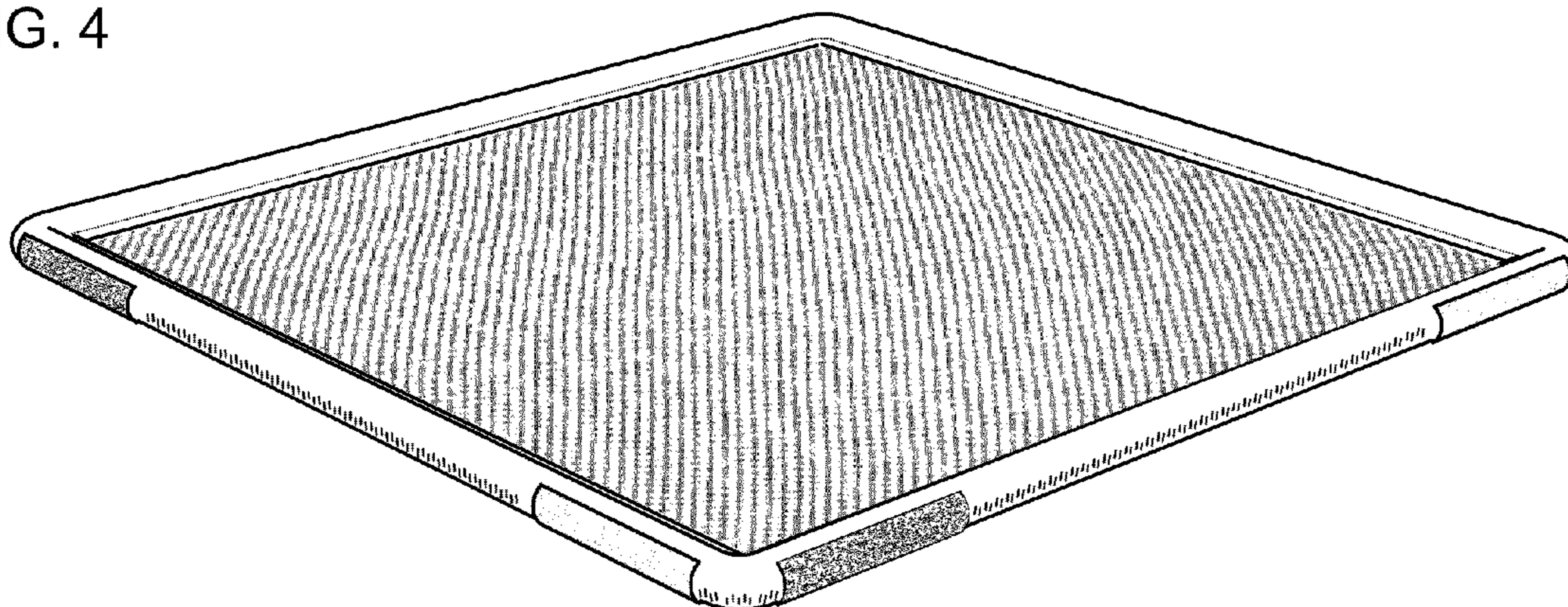
