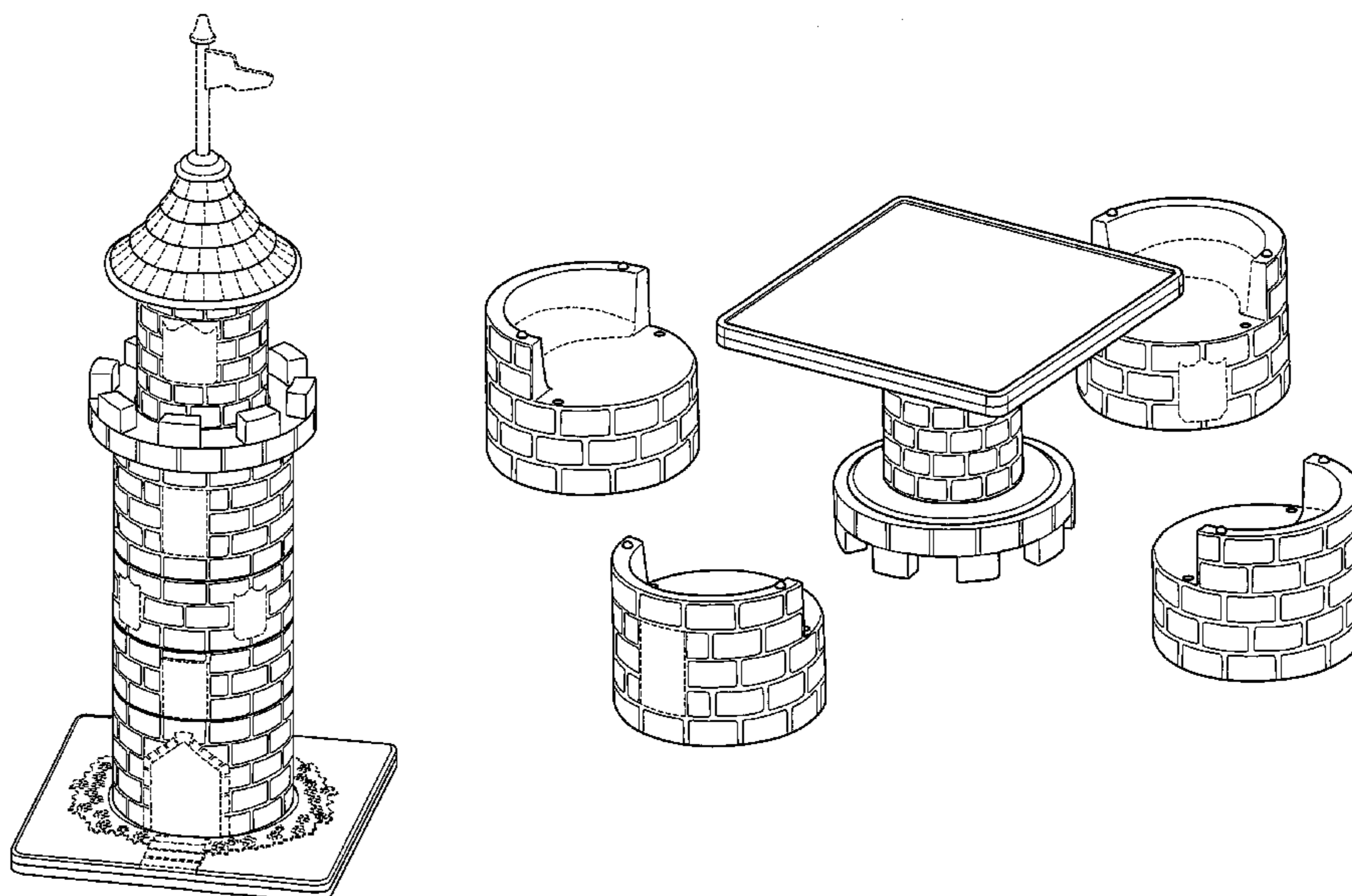
FIG. 9 is a top plan view of the table and chair set of this invention;

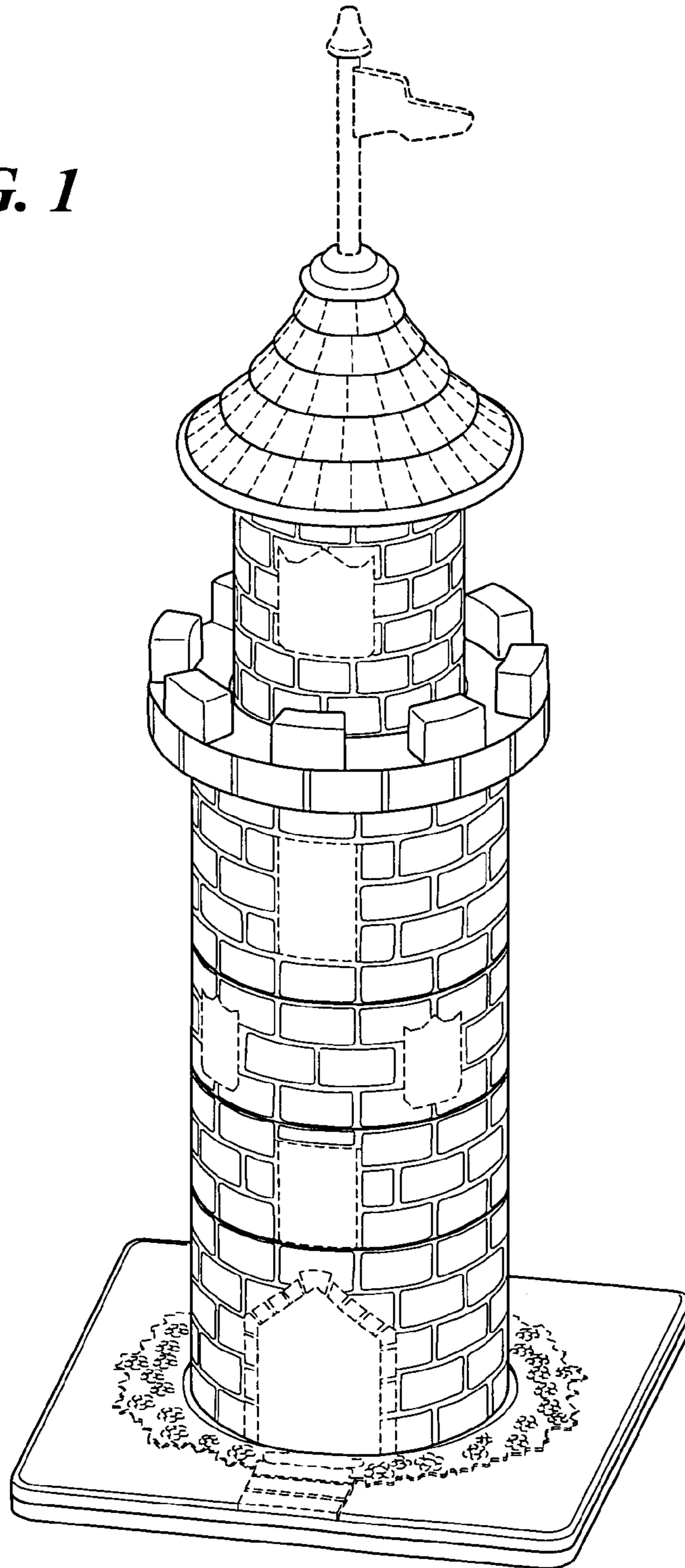

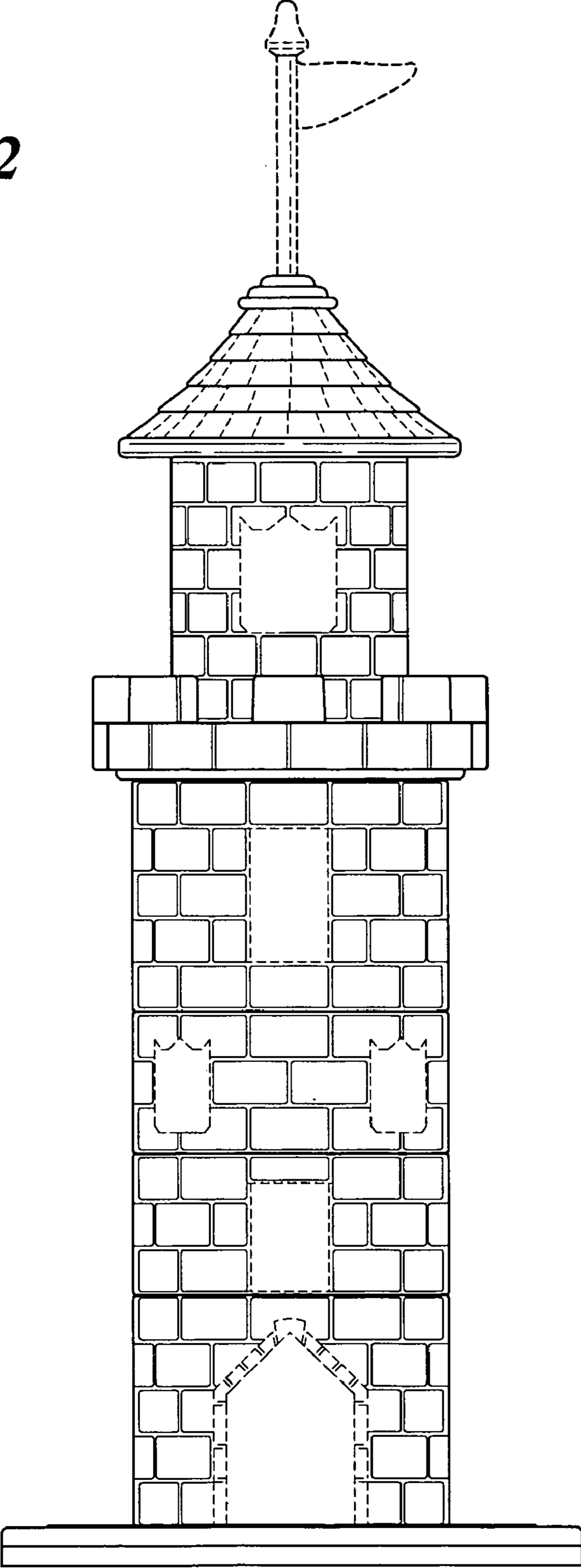

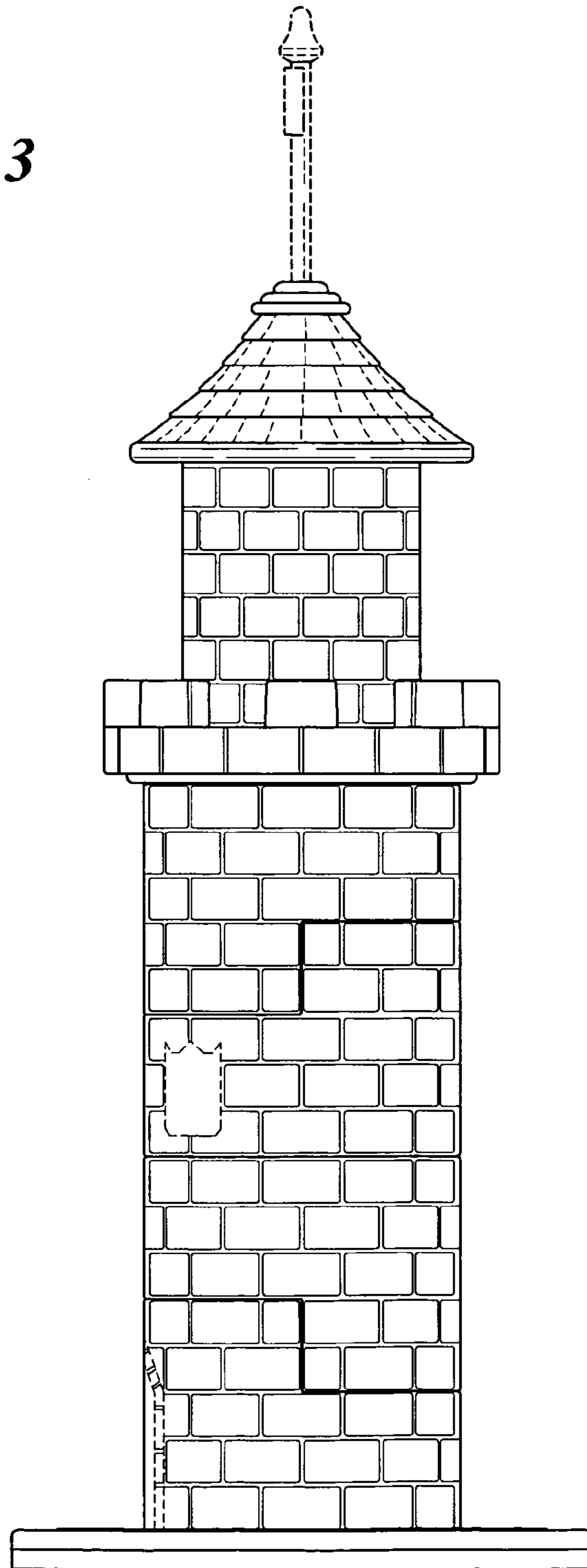

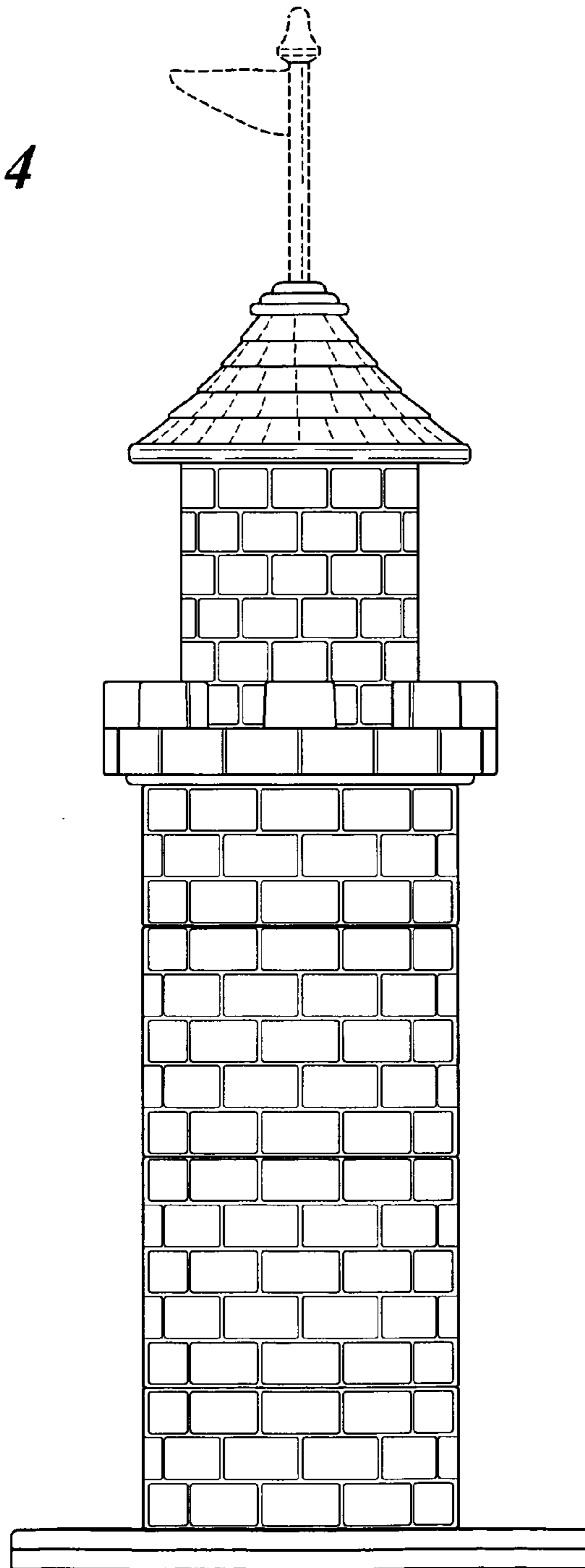

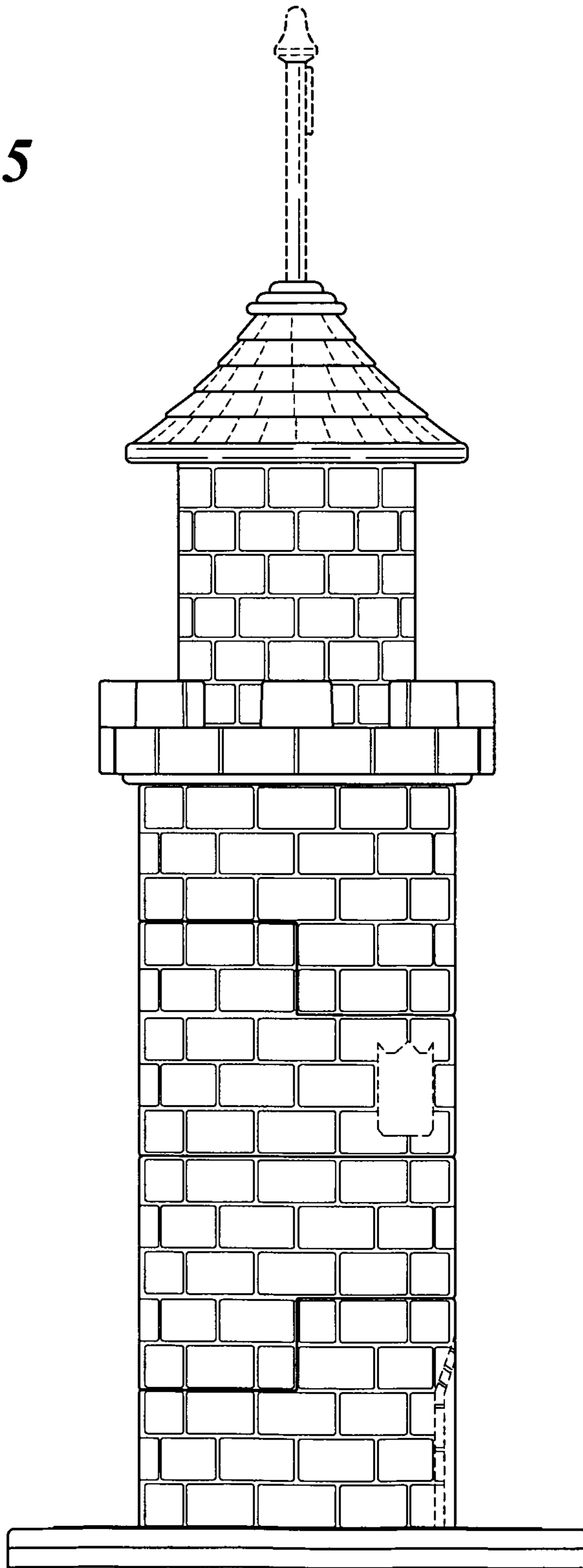

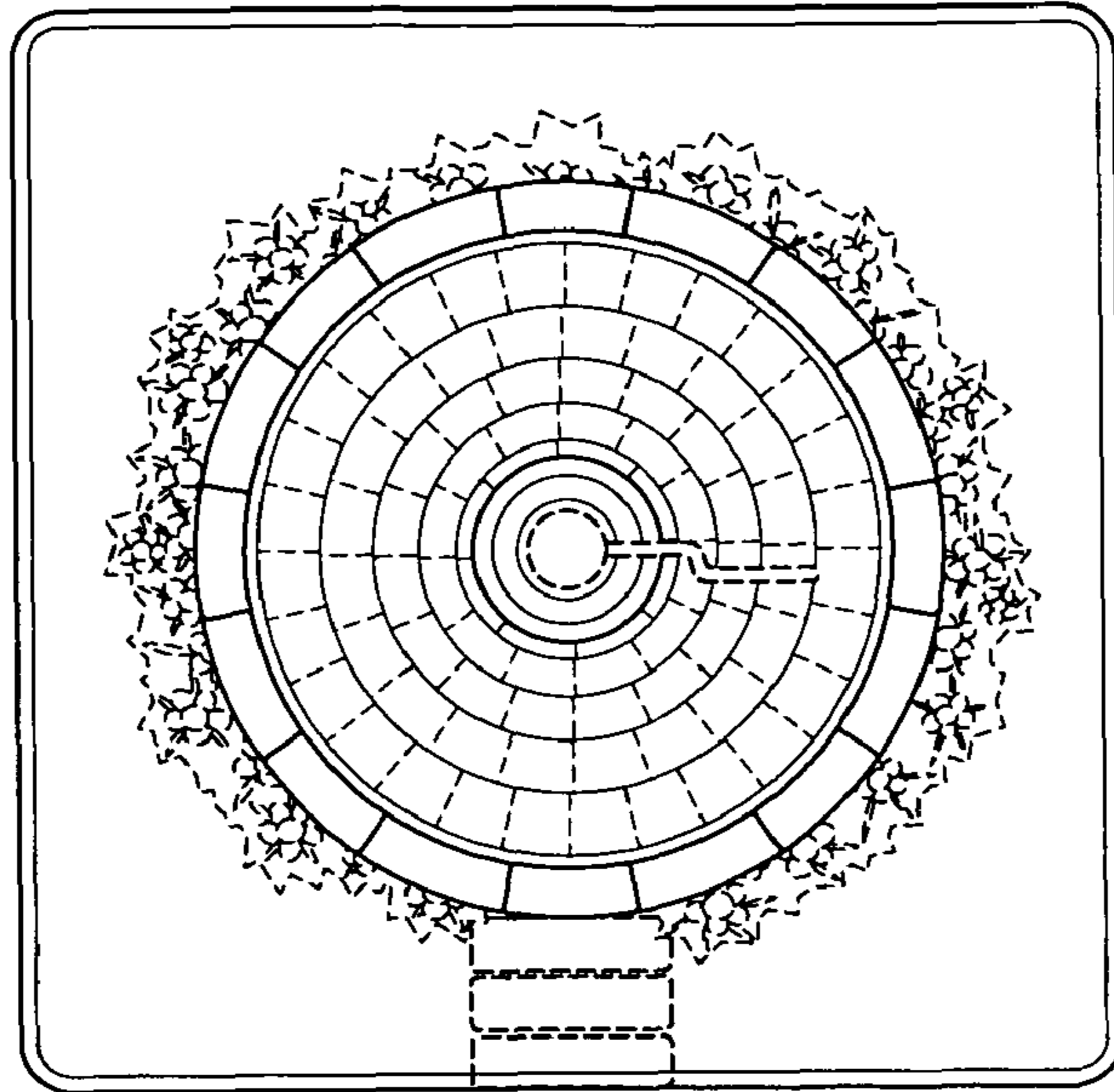

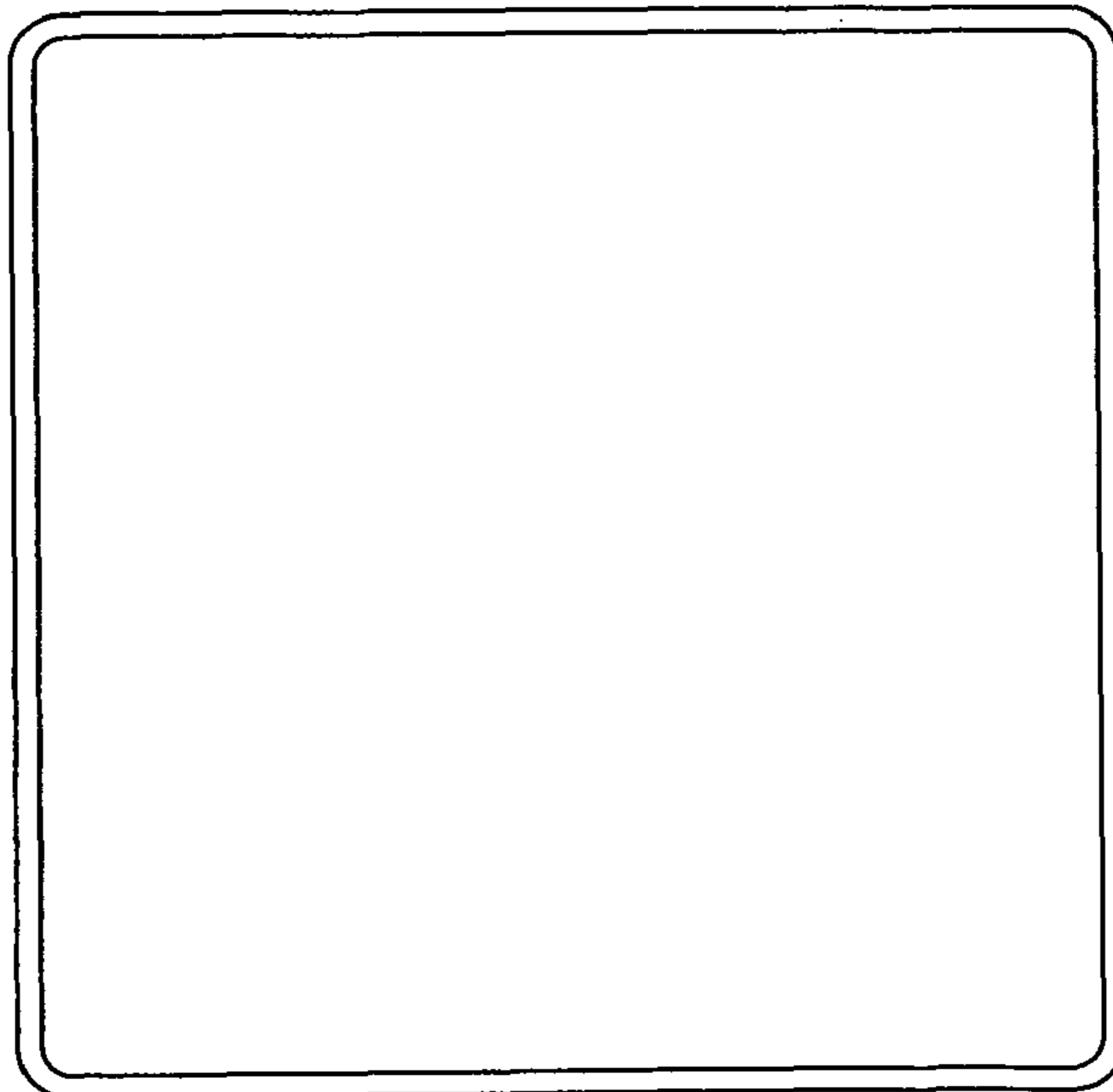

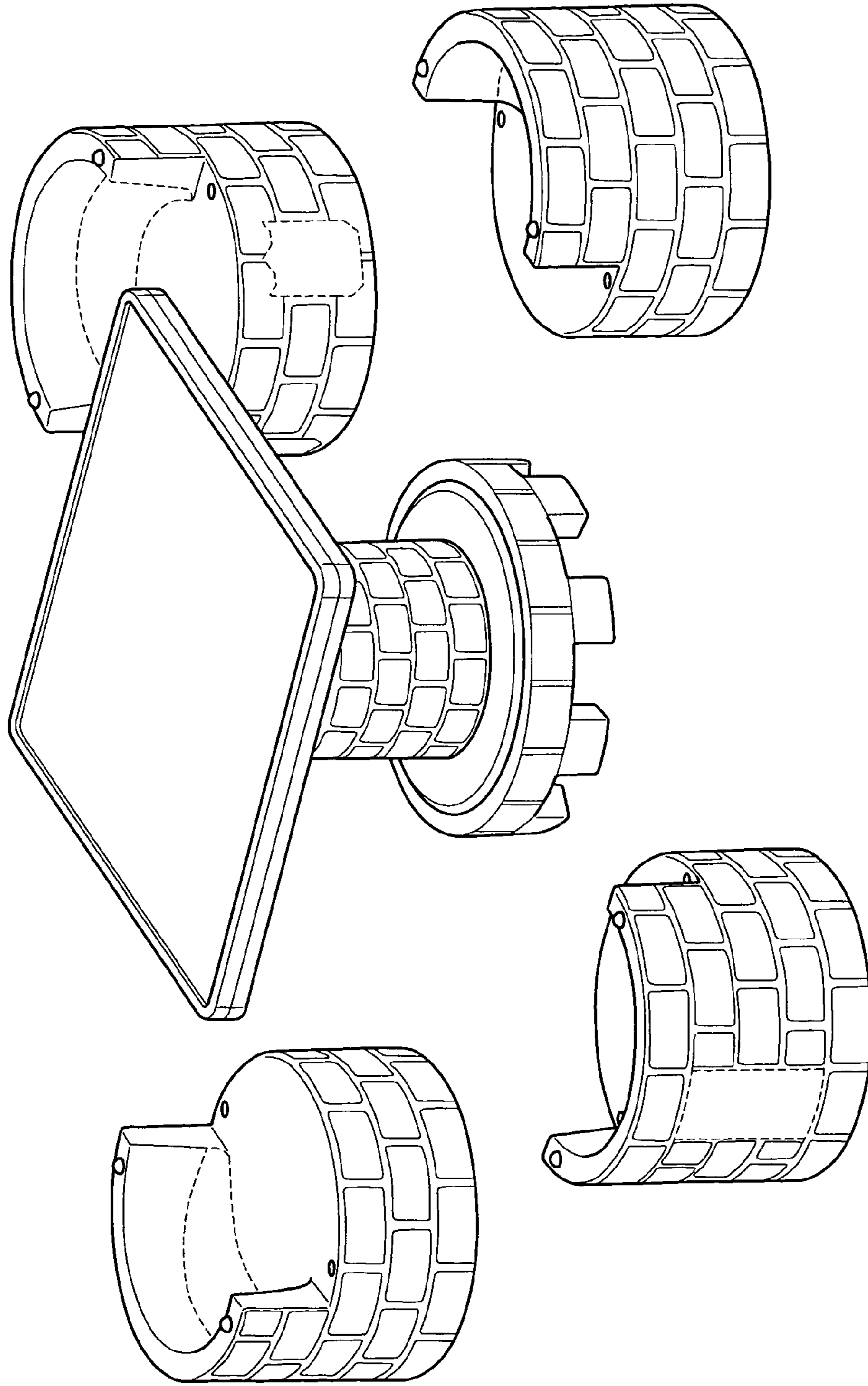

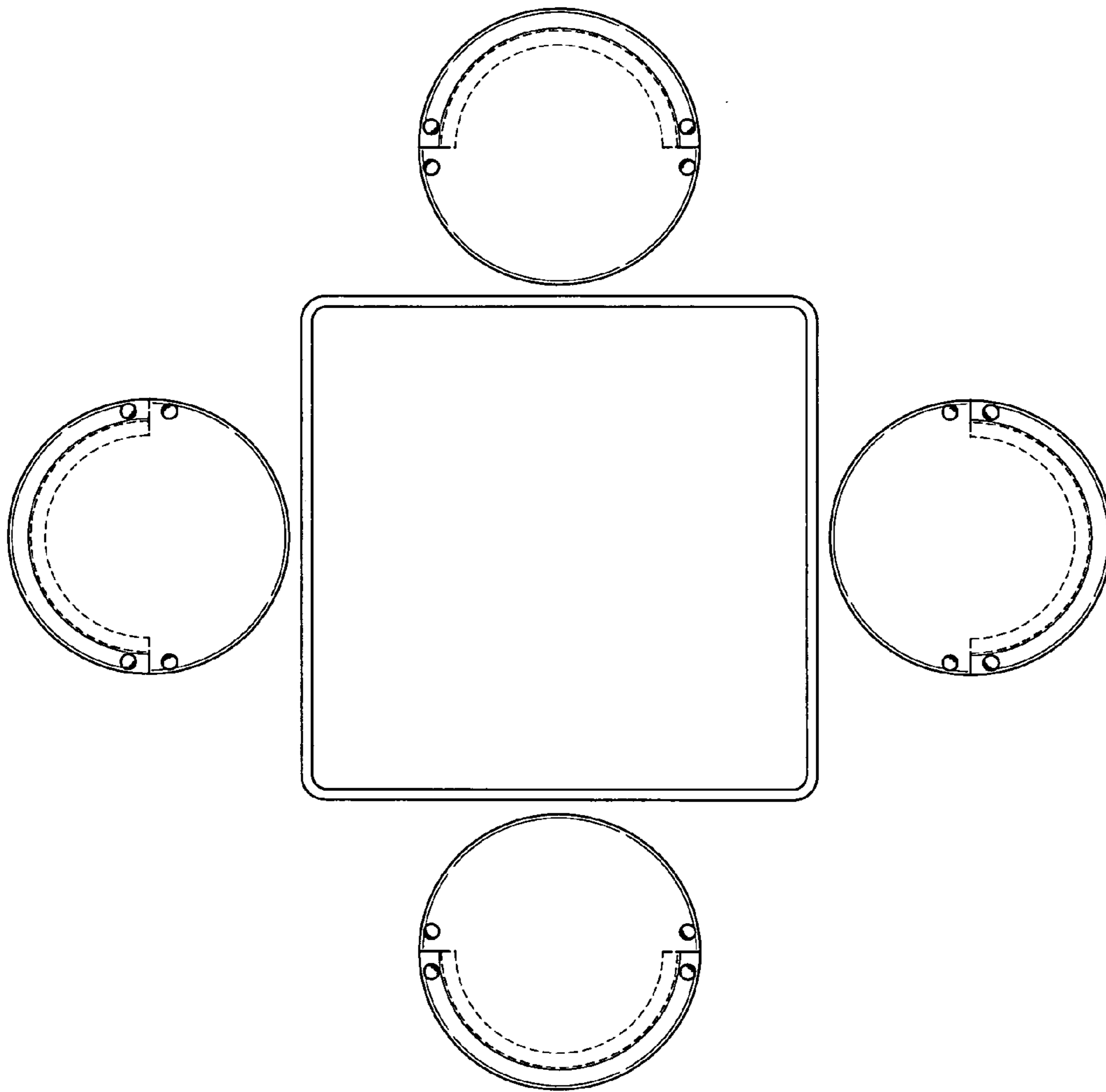

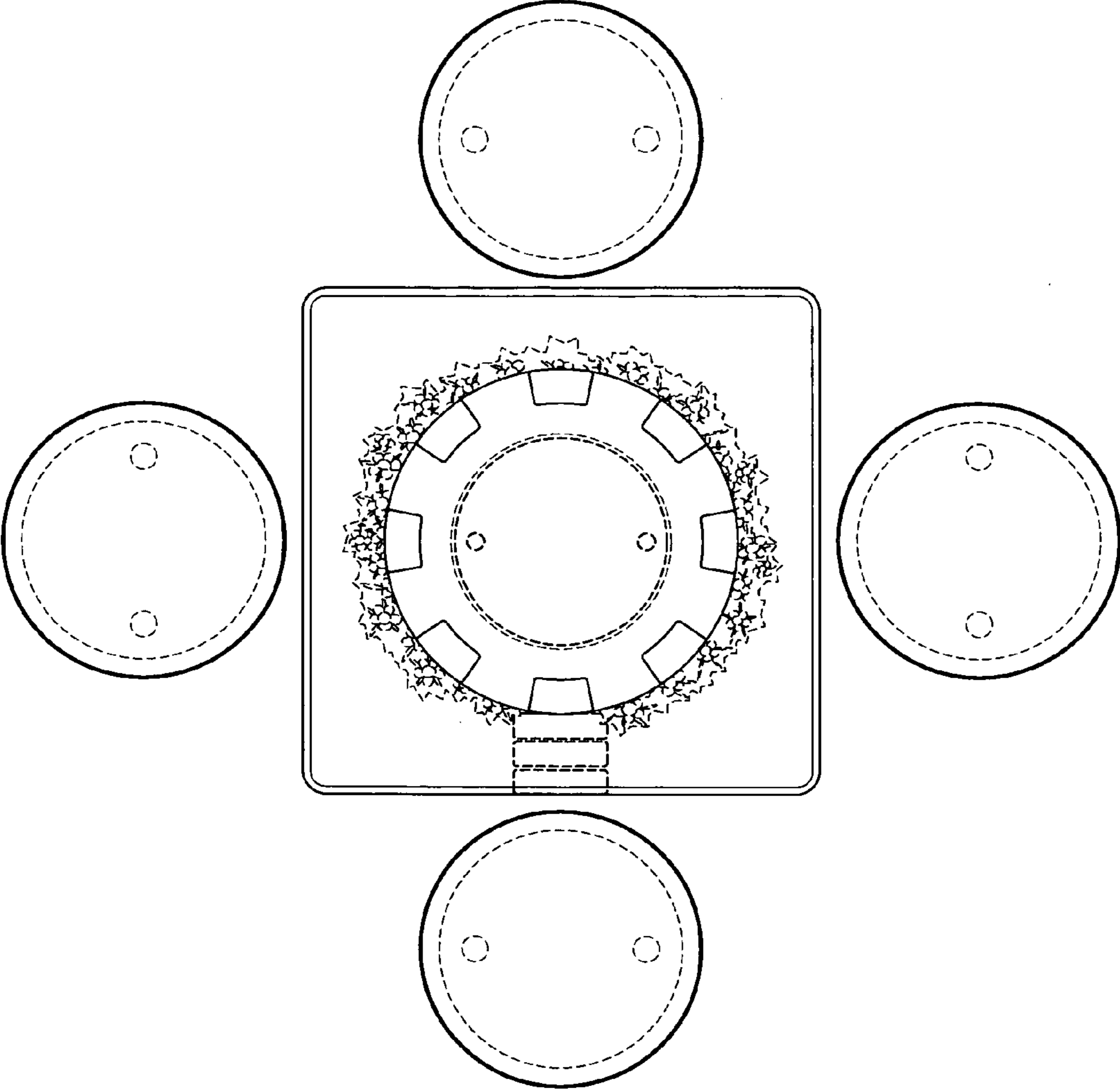




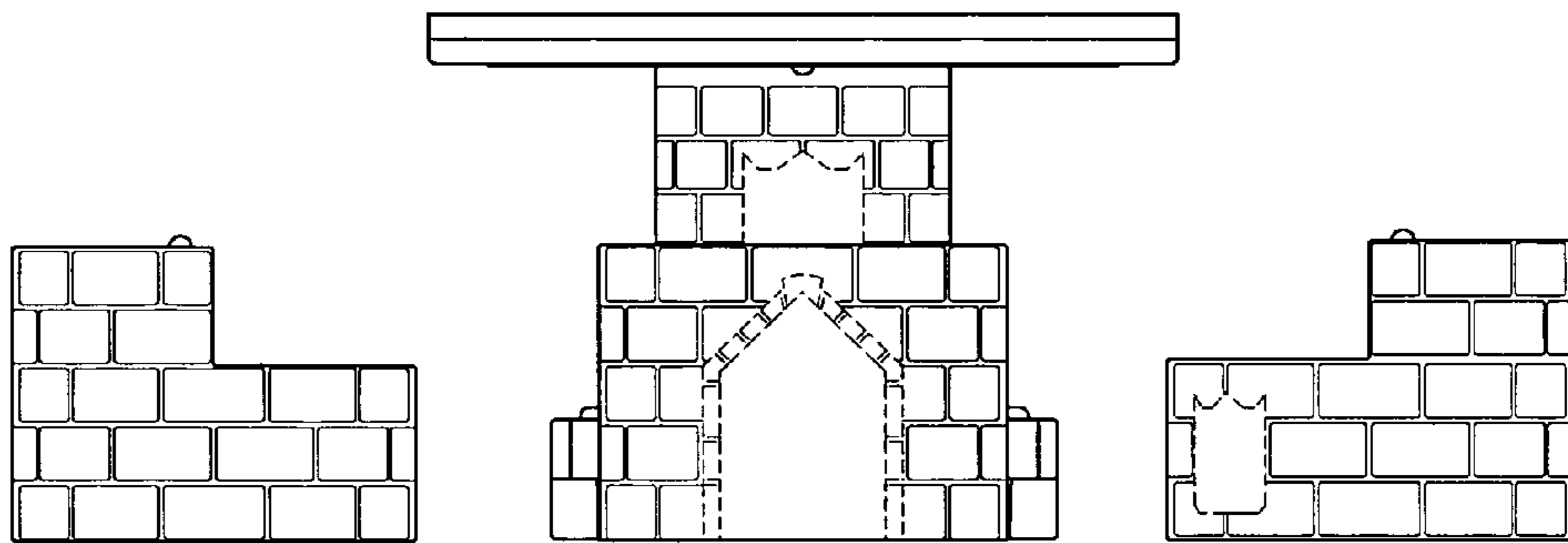
