(57) **CLAIM**

The ornamental design for a foot pad for tilting inversion exerciser, as shown and described.

**DESCRIPTION**

FIG. 5 is a bottom plan view thereof;

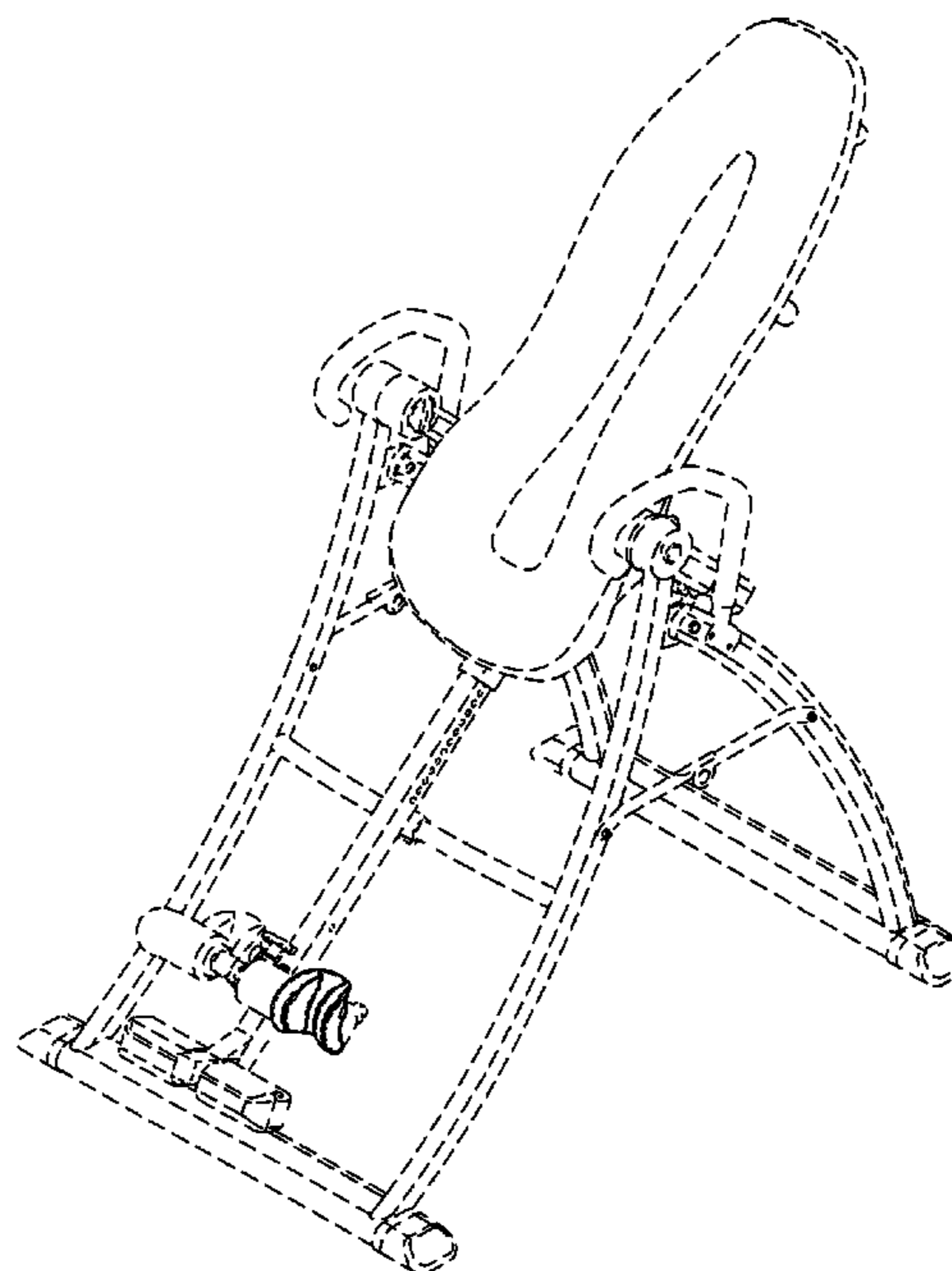
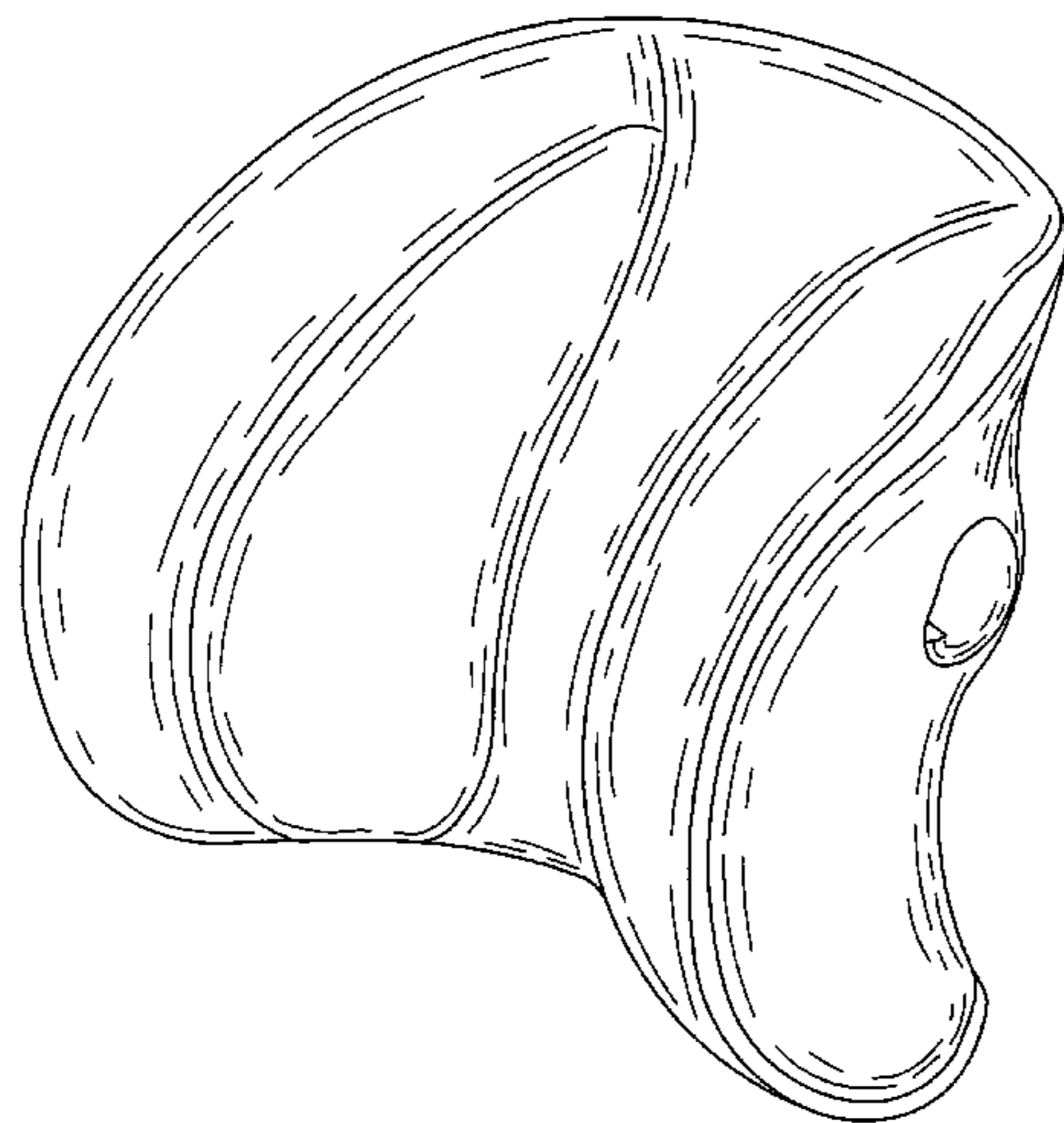
FIG. 6 is a left side elevational view thereof;

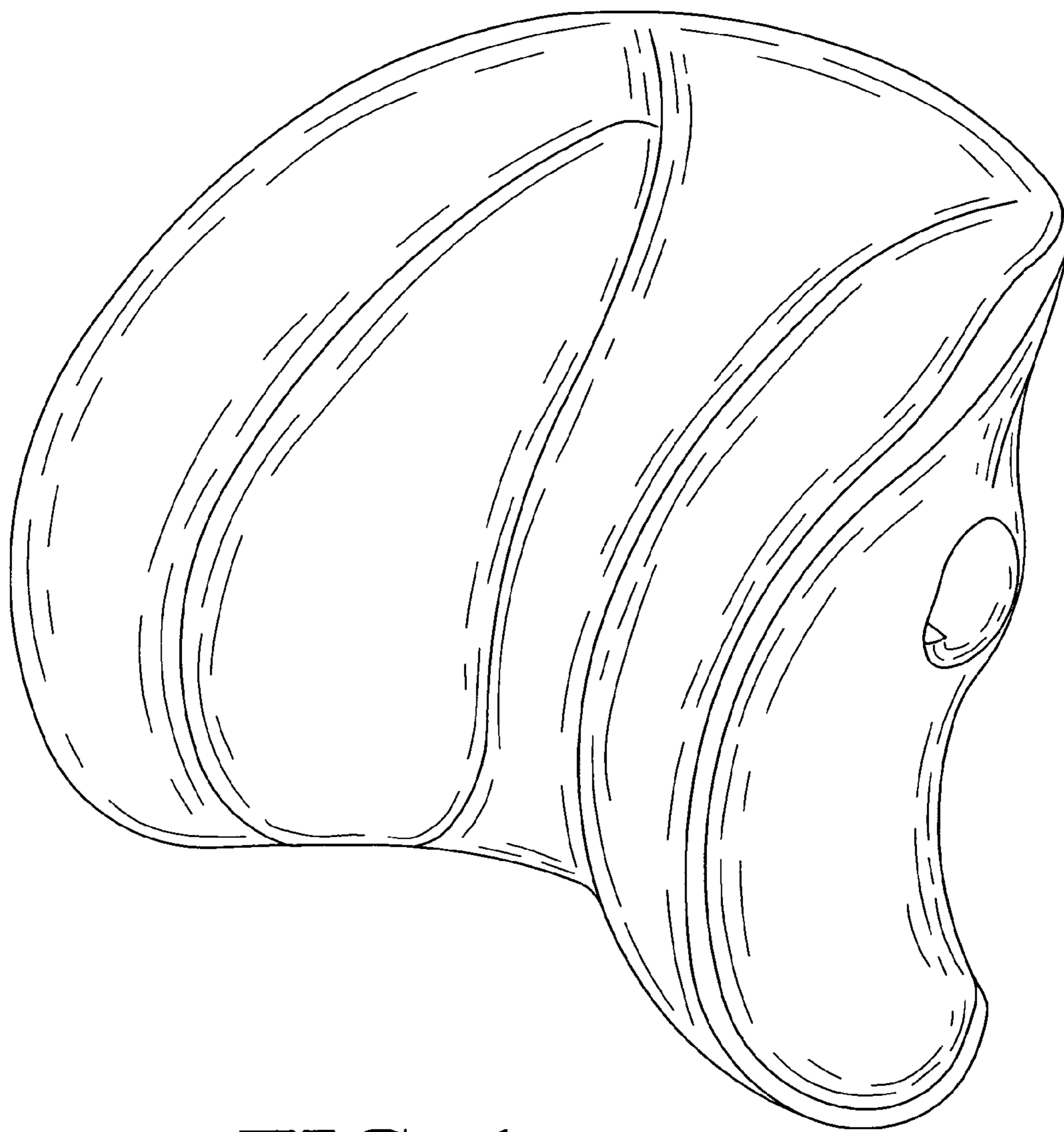

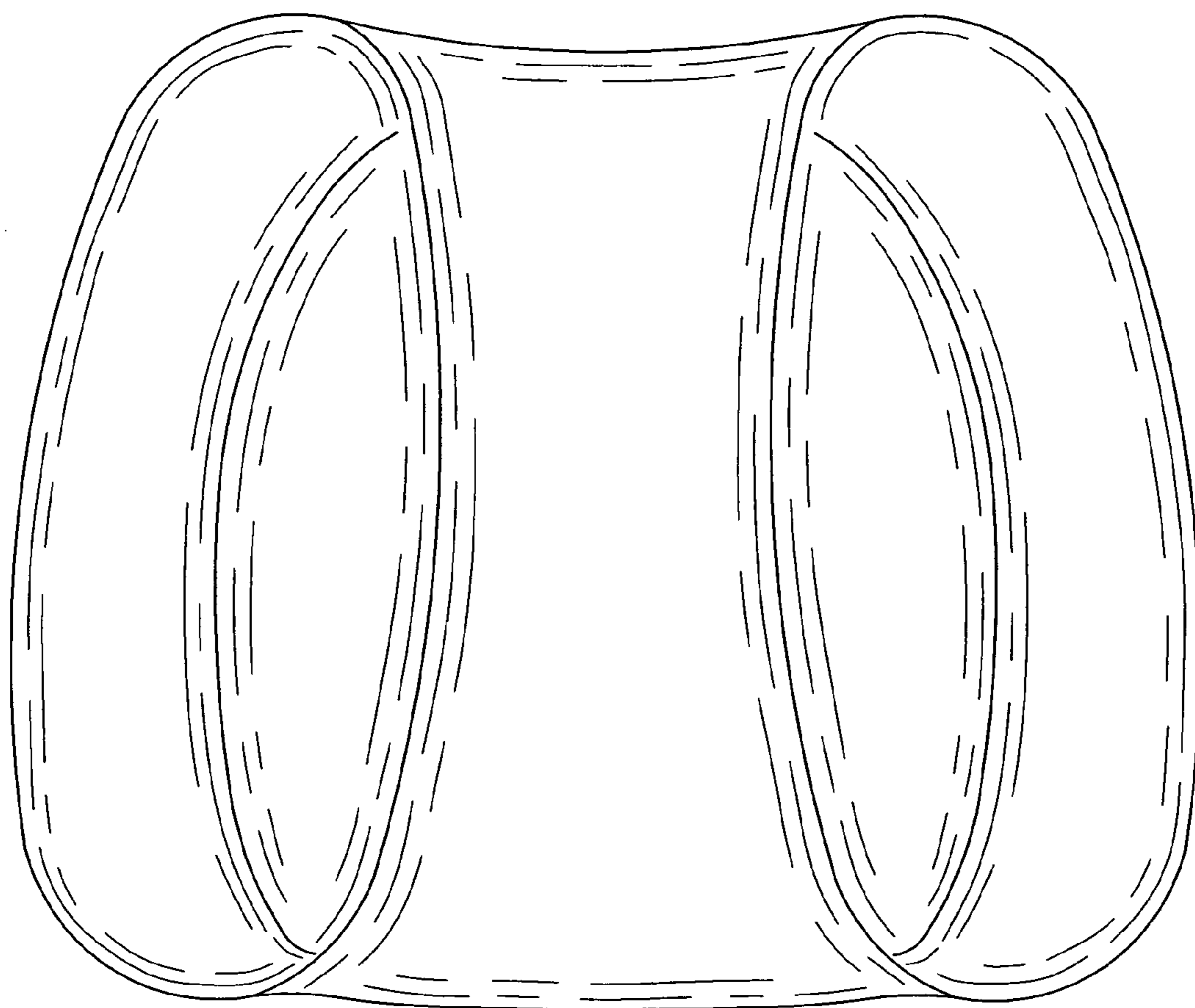

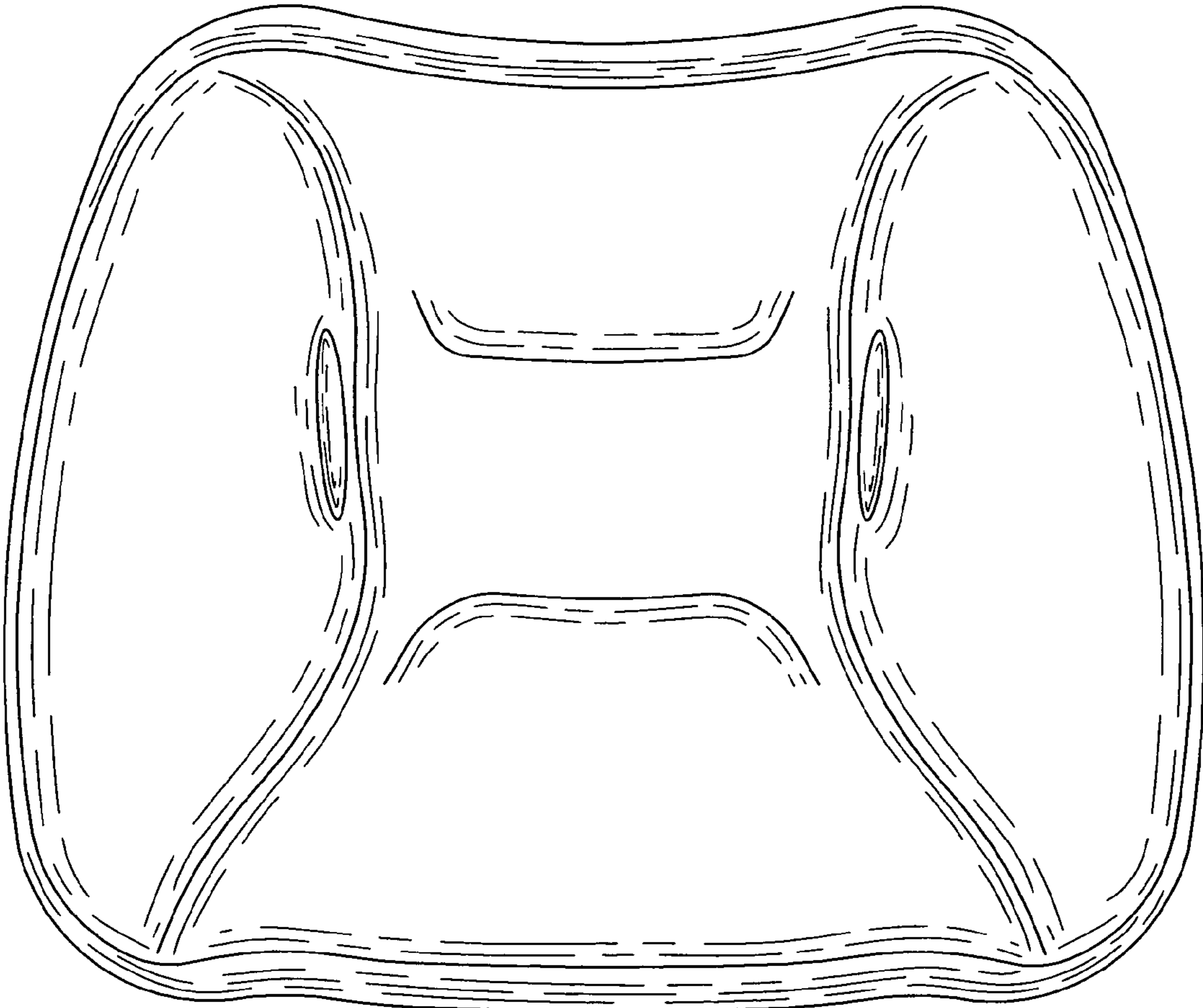

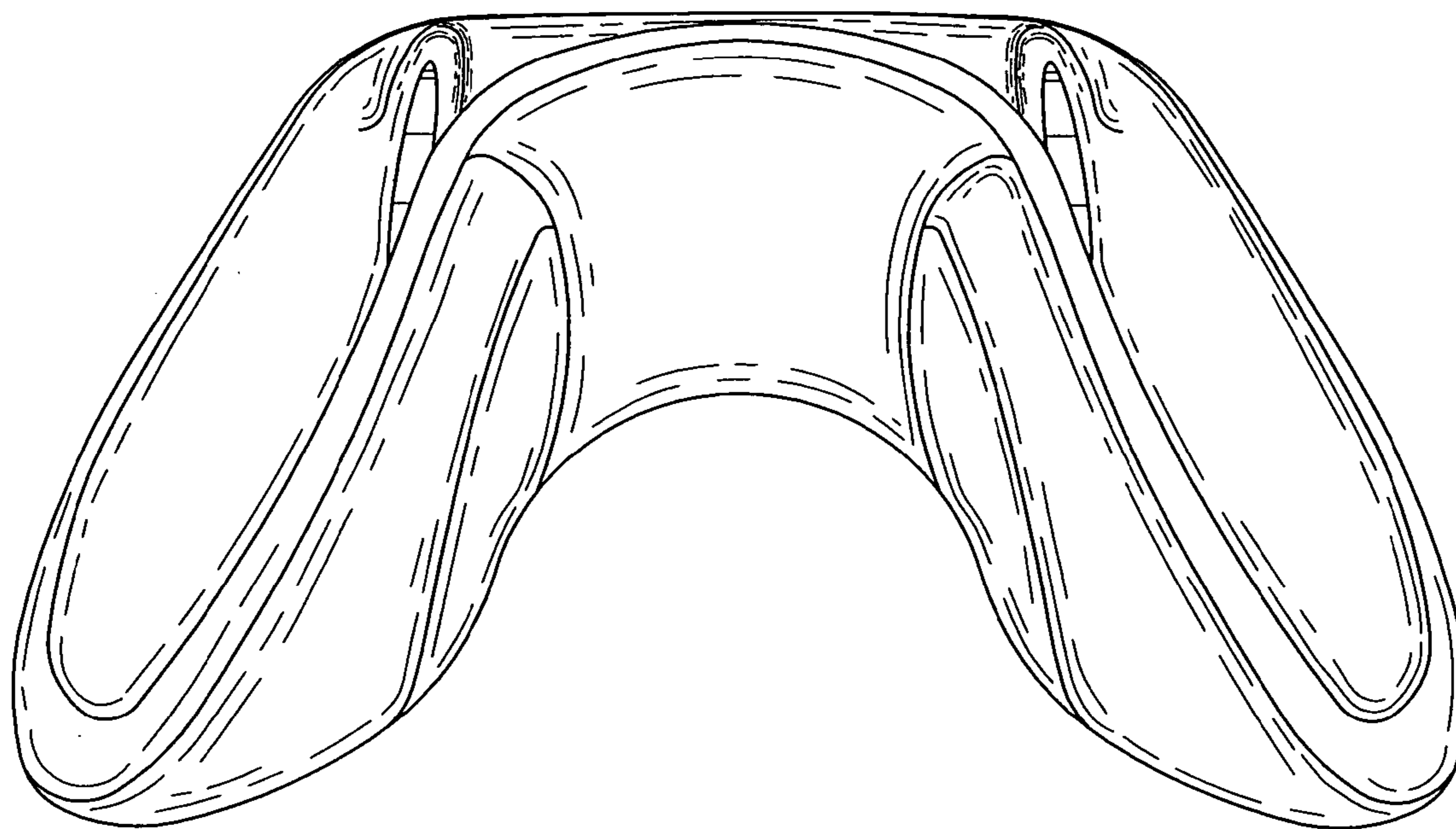

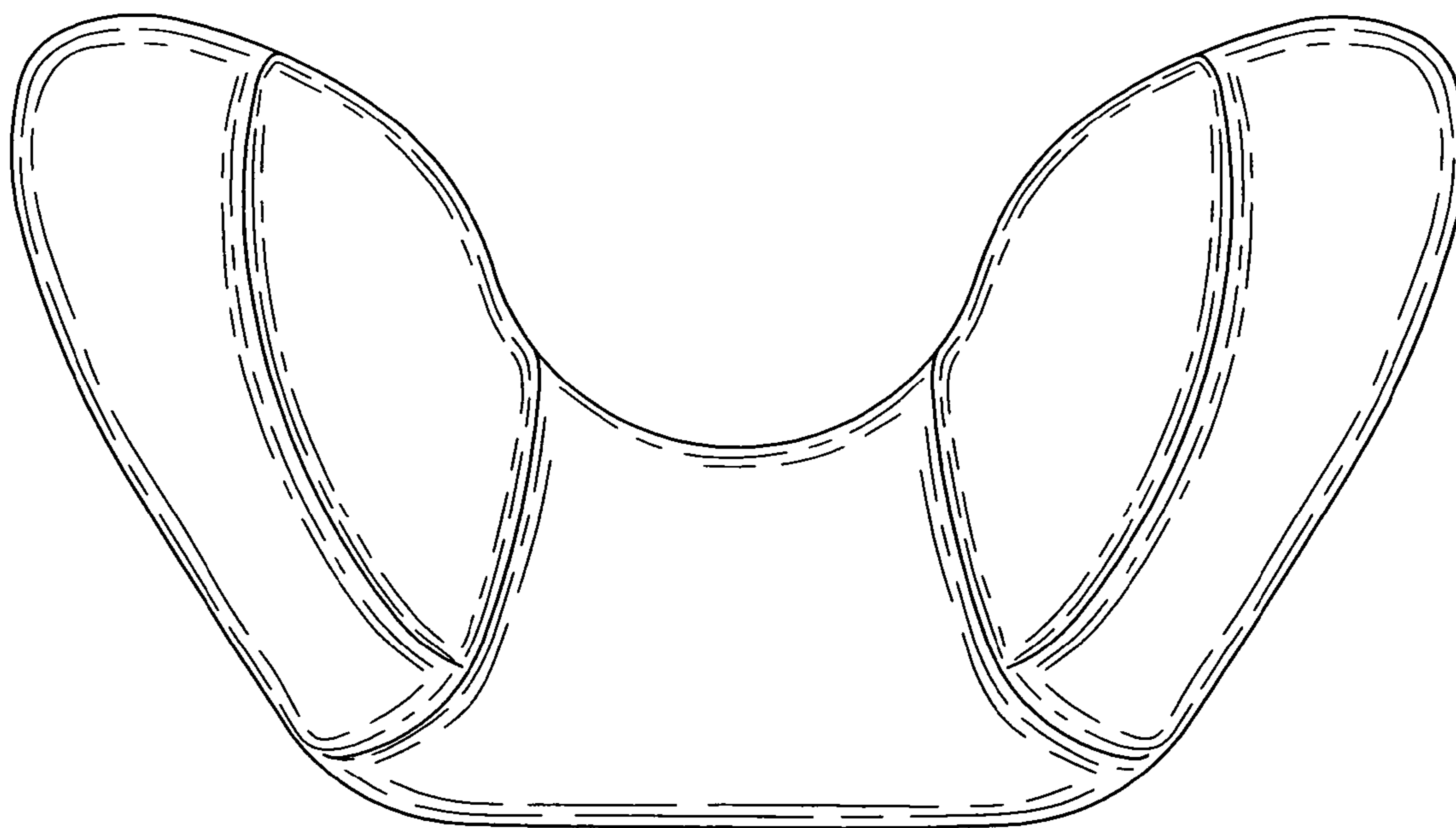
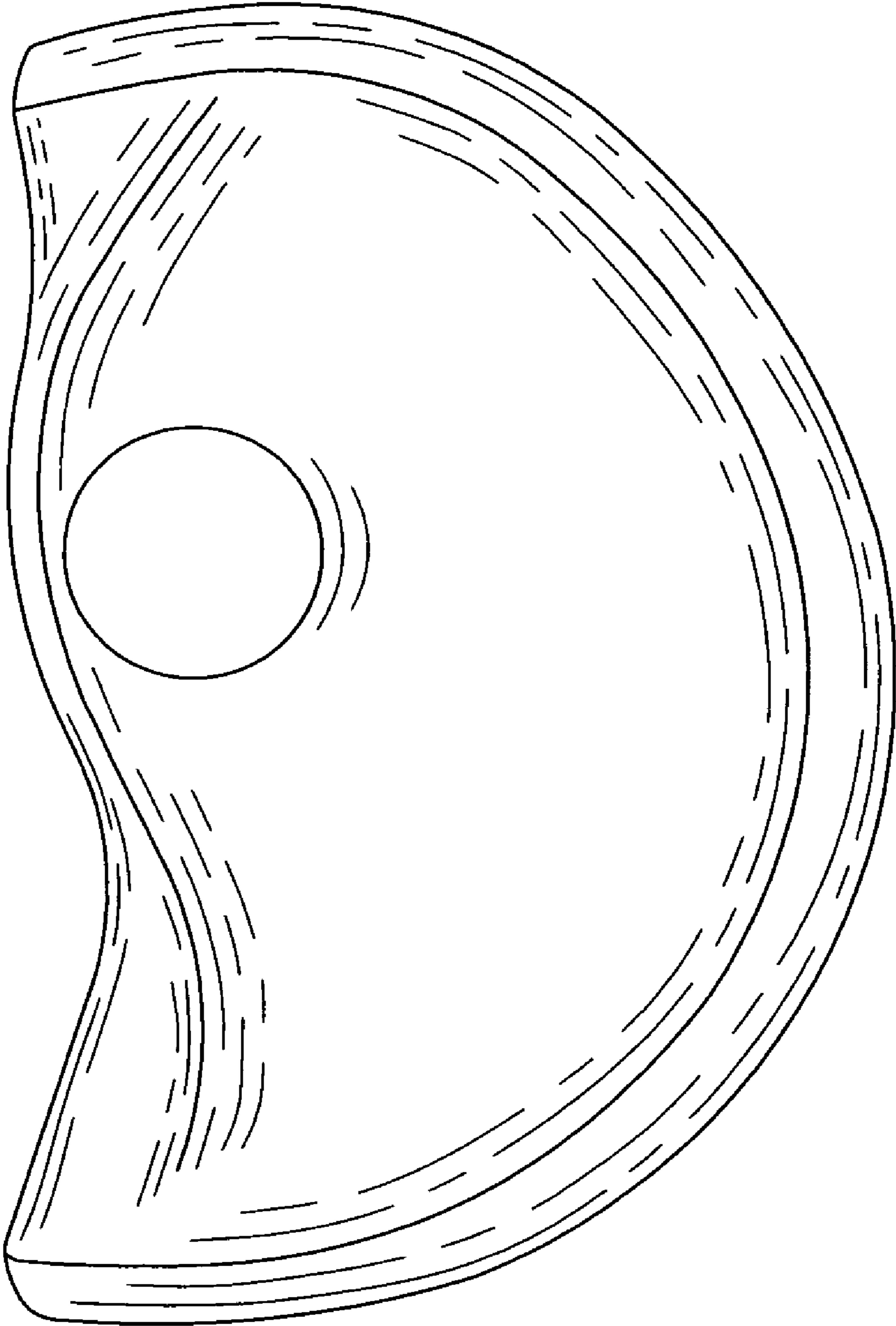
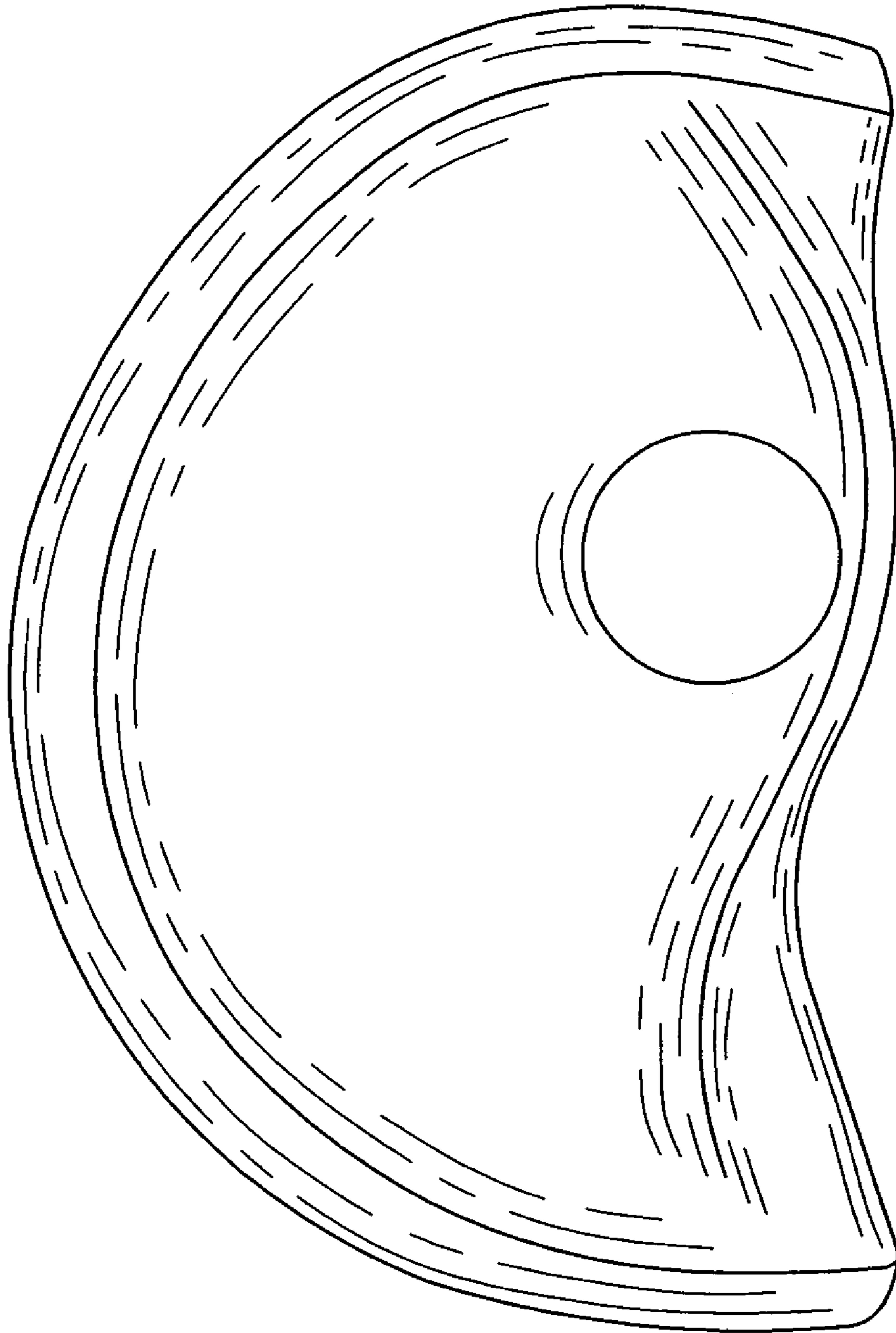

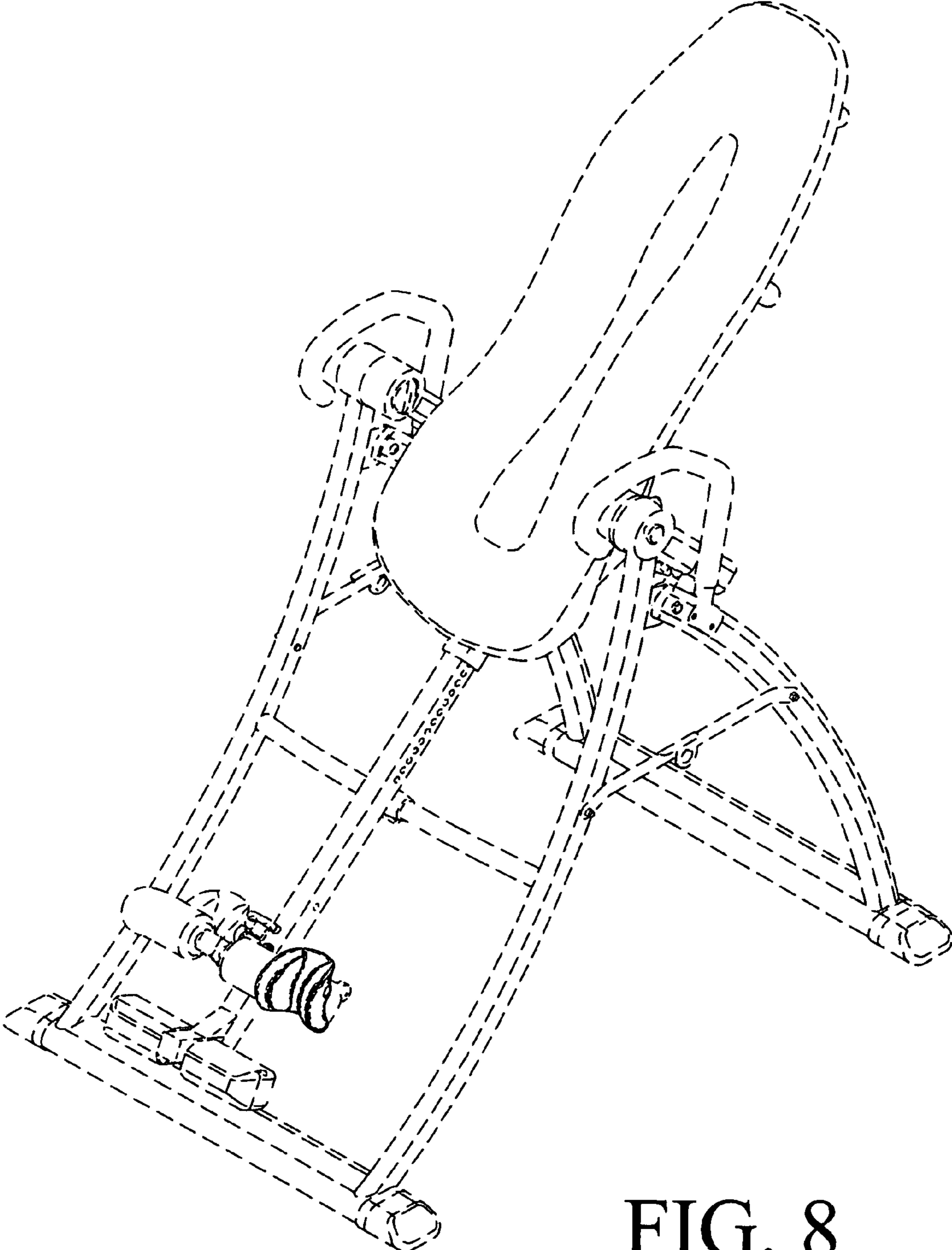
